THOUGHT FOR THE WEEK: On Being Swamped by Muslims: An Intellectual Defence of Pauline Hanson by Peter Ewer

The Third World, Left leaning, Globalist Pope Francis has been showing his true colour, red, in advocating that Europe should take in even more refugees. Welcoming refugees into one's home "is our greatest security against hateful acts of terrorism." But just think about that. What he is saying is that if we buy them off with acts of kindness then they won't resort to terrorism. He seems to be drawing a link between the migrants and the violent acts, although it could be argued that these are two distinct phenomena.

Remember, the migrants are by definition, desperate, vulnerable people. So the Pope could be interpreted to be making a quasi-politically incorrect statement, within his own paradigm. Maybe he needs another speech writer. Perhaps a migrant could help out?

By contrast, our own Pauline Hanson was full of vibes in her maiden speech to the Senate, saying that Australia is at risk of being "swamped" by Muslims. Twenty years ago in her previous maiden speech to the House of Representatives, she spoke of Australia being "swamped" by (East) Asians, but that process is now well underway. Now it seems, even the Asians are going to be swamped by Muslims, some of whom are also Asians. I know that this game of thrones of demographic displacement can be confusing.

Hanson called for our borders to be closed to immigrants and she even offered to drive problematic, non-assimilating migrants wanting to leave the country to the airport. Of course, she will get no offers, because it's a big going-out-of-existence-fire-sale-party here in Oz, and as we will see, most of the West.

The Greens walked out of the Senate, headed for their safe spaces, because they don't believe in democracy and the right of different points of view to be heard – which is also called diversity - but for them the only diversity worthwhile is that of the diversity of ethno-racial groups, whom they can defend, obtaining the glow of moral superiority. It is clear that any true deep green would be against immigration and anything else which threatened the environment. But the Greens today are red first, green second. Save nature or stop racism? Sorry, life on Earth just has to go, even if it means that everything has to go!

Hanson said: "Australia had a national identity before federation and it had nothing to do with diversity and everything to do with belonging." She launched a much-needed attack upon the cult of multiculturalism: "Indiscriminate and aggressive multiculturalism have caused crime to escalate and social cohesion to decline. Too many of us live in fear of terrorism. Muslims are prominent in organised crime, anti-social behaviour is rampant and...surveys find that in neighbourhoods of Muslim settlement...Australians, in general, are more fearful. Islam cannot have a significant presence in Australia if we are to live in an open, secular and cohesive society." She said it, not me; I'm just the messenger.

Strong words indeed. But shock, horror, before the I'm-eternally-offended -brigade jump up and down, consider Tony Abbott's remarks to the centre-right members of the European Parliament in Prague (*The Weekend Australian*, September 17-18, 2016, p. 2). He said: "In Europe's cities, Islamist fanatics are bent on carnage." And: "Why shouldn't each country have the final say over who can enter? After all, a country or a continent that can't control who enters its territory will eventually lose control of its future. Too many are coming, not with gratitude in their hearts, but with the conviction that Europe should make way for them." The same applies to Australia, although we have never been given a democratic say about immigration and the creation of multiculturalism.

The Colonisation of Europe

Hanson's speech was not only condemned by the chattering class, but also by those who across the West are responsible for the promotion of mass migration: Big Business. (*The Weekend Australian*, September 17-18, 2016, p. 8) Chief executives from over 120 companies rejected Hanson's position and gave out the standard multicultural rhetoric: "Australia's economic and social prosperity is founded on diversity. Tolerance and inclusiveness is a hallmark of our way of life."

Talk about begging the question! Surely, in economic terms this is sheer nonsense, as it is only the economic qualities of a population (e.g. skill levels, education etc.), not diversity itself, which creates economic value. China and Japan are prosperous, but not diverse; Africa, diverse, and in chaos. Putting that aside, immigration has certainly been good for Big Business, who have profited from increased sales, from the creation of a reserve army of the unemployed and the shocking real estate scarcity arising from out-of-control population expansion, making it impossible for young Aussies to own their own homes in a reasonable time. Entities which exist primarily for profit maximisation have no moral authority in my opinion. Big Business is part of the problem for almost all problems today. What a pity the Left no longer sees it as their mission to critique them, being now addicted to political correctness.

While the sentiments of Pauline Hanson are vilified by our decadent new class, in Europe and also the United States, there are considerable intellectual heavyweights basically saying what she is saying and more. For example, the highly respected book by Christopher Caldwell, *Reflections on the Revolution in Europe: Immigration, Islam and the West*, (Allen Lane, London, 2009), says that Islam is an "adversary culture," and that Muslim immigrants are "patiently conquering Europe's cities, street by street."

There are many books published by establishment publishers, which have advanced the same thesis as Christopher Caldwell, such as Bruce Bawer, *While Europe Slept: How Radical Islam is Destroying the West from Within*, (Broadway books, New York, 2006); Lee Harris, *The Suicide of Reason: Radical Islam's Threat to the West*, (Basic Books, New York, 2007); Ayaan Hirsi Ali, *Infidel*, (Atria Paperback, New York, 2007); Wafa Sultan, *A God Who Hates: The Courageous Woman Who Inflamed the Muslim World Speaks Out Against the Evils of Islam*, (St. Martin's Griffin, New York, 2011); Brigitte Gabriel, *They Must be Stopped: Why We Must Defeat Radical Islam and How We Can Do It*, (St Martin's Griffin, New York, 2009). As said, these books are from some of the largest, most respected publishers in the world, and the authors are authorities on Islam.

So, Pauline Hanson in any potential section 18 C case has a lot of material and expert witnesses to draw on, in a section 18 D defence.

There are, of course critical material from the European Right, with leading French intellectual, Guillaume Faye, having his book *La Colonisation de l'Europe*, published this year by Arktos, as *The Colonisation of Europe*. Faye is far more radical than Hanson because France is further down the multicultural rabbit hole than us, so far. Faye uses terms and expressions such as "demographic submersion," "unconscious Europe," "Islam conquering Europe," "ethnic civil war," "ethnomasochism," to describe Europe's plight. He sees urban guerrilla warfare across Europe at present, as represented by terrorist attacks and the creation of no-go zones, "areas of lawlessness," "that extend their reach like an oil spill." There are about 1,000 such areas in France alone, where the police are too afraid to go. Faye thus says that such areas have been "conquered and colonised." The path from ethnopluralism to ethnomasochism to ethnotreason, is a short one, he says.

A recent article about Sweden confirms Faye's position: "*Collapse of Europe: Migrants in Sweden Have Turned Suburbs into War Zones*," September 12, 2016. The key material is this:

"The migrant crisis in Europe has been an issue that has left entire countries in shambles; decaying shells of what they once were. Everywhere from Germany to France has been negatively impacted by this dangerously liberal belief.

It's clear now that there is a direct correlation between the open-border policies that these countries rallied behind and the increasing number of violent attacks that have occurred in recent months. Many of those who are migrating to other countries are bringing death and destruction with them.

Many of these migrants — especially the teenagers — now seem to be attempting to turn Sweden into a dystopian battleground. Between attacking Swedish citizens, throwing rocks and setting cars ablaze, the migrants have proven themselves to be a legitimate threat to the human decency displayed in that country.

Infowars reports that "Immigrant youths are leading the effort to transform Swedish suburbs into something reminiscent of dysfunctional civil war zones, where people are afraid to go out at night and immigrant gangs ravage." Like something out of a post-apocalyptic movie, the imagery is terrifying because it's all too real."

The philosophical problem here is that liberal and conservative intellectuals have forgotten about the reality of race, a problem which Australians have also stumbled over.

As Faye concludes:

“The denial of racial facts is the trait of Western intellectual elites who are confused about the world of the living and who, in part of a long Gnostic tradition...considered humans to be a unique species, one that stands above the animal kingdom and is exempt from obeying its laws.”

Biological laws include those of demography. In this context it is relevant to refer to Professor Adorján Kovács’ paper “*Wahrheiten zur Flüchtlingskrise*,” (“*Truths about the Refugee Crisis*”), The European Magazine, December, 2015. Examining the demographics, given that the majority of refugees are young, between 20 and 35 years of age or younger, the refugee influx into Germany will create a non-white majority in the 20 to 30-year-old group in only four years, and this population wedge will move through the German population over one generation resulting in a non-white majority in only one generation. The same situation applies across Europe. And what happens to all those nuclear weapons, when ethnic displacement is complete? Has anyone thought about that?

The End of Europe?

Australian sociobiologist Frank Salter, “*Germany’s Jeopardy: Could the Immigration Influx End European Civilization?*” January 15, 2016, quotes Tony Abbott who said that Europe needs to close its borders to avoid “catastrophic error,” to “prevent a tide of humanity surging through Europe and quite possibly changing it forever.” (P. Hudson, “*Europe Must follow Our Lead On Turnbacks: Abbott*,” *The Australian*, October 28, 2015, p. 2.)

Salter points out that diversity comes with a great cost, with the loss of social cohesion and rise of social conflict. For guerrilla and civil war, one fifth of the variation of collective violence was caused by the variable of the number of ethnic groups present, and conflict was intensified when different religions were involved: R. J. Rummel, “*Is Collective Violence Correlated with Social Pluralism?*” *Journal of Peace Research*, vol. 34, no. 3, 1997, pp. 163-176. Vanhanen found that from a study of 176 societies, ethnic diversity accounted for two thirds of the global variation in ethnic conflict: T. Vanhanen, *Ethnic Conflicts: Their Biological Roots in Ethnic Nepotism*, (Ulster Institute for Social Research, London, 2012). Diversity is not a strength, but a source of conflict.

This conflict is also expressed through crime, Salter notes, such as the 1997-2013 sexual slavery of white British girls in Rotherham and other British cities primarily by Muslim Pakistani men, with up to 1,400 girls as young as 12 being used as sexual slaves and subjected to torture.

As with rape across Europe, the authorities attempted to cover this up, so as to not stir up “racism,” to them the agenda is more important than the lives of white children. A recent article which evidentially supports Salter’s thesis, with horrifying accounts of rapes and torture throughout 2016 is Dr. Lasha Darkmoon, “*The Migrant Rape Epidemic in Germany and the Descent into Madness*” September 2, 2016.

Dr Darkmoon sums it up by saying:

“I don’t think Orwell foresaw this multicultural superstate. This is something new. All we can be sure of is that this Eurostan—the new European superstate now in the making—will be a multicultural dystopia rife with race wars, gang rapes, cheap foreign labor, widespread unemployment for the dispossessed White minority, bullying bosses, cowed workers, overflowing prisons, fatcat lawyers, psychotic politicians, police state surveillance, fabricated news items, false flag attacks, demoralized families, dysfunctional children, schools for morons, mass suicides, manufactured diseases, promoted perversions, drug addiction, gambling, prostitution, pornography, serial killers on the rampage, and nonstop mindless entertainment for the zombified masses.

It will be a dog-eat-dog world of unimaginable cruelty. A nightmare horrorshow that neither Dante nor Hieronymus Bosch ever anticipated in their wildest dreams. If you’re White and dispossessed in this New Dystopia, you’re a dead man walking. Get ready for the Abolition of the White race.”

The latest news, at the time of writing, is of the gang rape of a French woman by three migrants at the Champ-de-Mars garden, next to the Eiffel Tower.

Salter says that in Sweden, although migrants are 16 percent of the population they constitute the majority of those charged with murder, rape, and robbery.

Turning to Denmark, Salter notes that migrants, especially from the Middle East and Africa, have a higher crime rate than the ethnic Danes: “The greatest frequency of law-breaking was shown by the children of non-Western immigrants. Those ages 15-19 were overrepresented by 93 percent, those aged 20-29 by 130 percent and those aged 30-39 were overrepresented by 135 percent. Ethnic Danes were underrepresented for all these age categories.”

In Germany in 2011, asylum seekers committed 3.3 percent of all crimes, and by 2014, this figure was 7.7 percent, with the number of assaults in the same period more than doubling.

In conclusion, Pauline Hanson’s maiden speech to the Senate addressed one of the key issues of the time. The response by the Greens demonstrates the contempt of the Left about the on-going chaos of ethno-racial conflict that is engulfing the West. ***

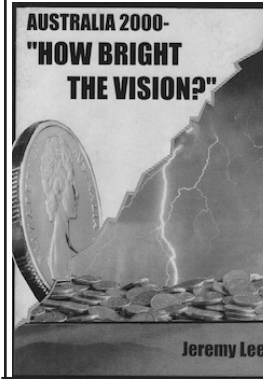
THE CULTURAL INHERITANCE OF SOCIAL CREDIT
