# LETTER TO THE SENATOR

**Peter Davis, Port Lincoln, SA**

Dear Senator Dastyari,  
I read, with much interest, in the *Australian Financial Review* 5-6th August of your intentions to campaign for Australia Post to be granted a banking licence.

I commend your lateral thinking and offer my wholehearted support in your endeavours. However, I suspect you may not know much about the privately controlled, fractional reserve, central banking system that now exists world wide and of which in Australia, the RBA is a part.

## USA

I presume you know that “the Fed” [Federal Reserve System] is the foundation of 12 banks across America that are privately owned and controlled? Atlanta, Boston, Chicago, Dallas, Philadelphia, are some of the banks.

The privately owned Federal Reserve System was approved by Congress and Senate 23rd Dec 1913. The Board of “the Fed” controls the American money supply. PROOF? Enclosed, a photostat of an American \$1-00 note... Note well the small print, “FEDERAL RESERVE NOTE” at the top of the note.... The note is a part of the American National Debt earning interest for the private bankers. And, incidentally, **America’s interest cost** on her National debt is now well over one trillion dollars annually.

## BRITAIN

The privately owned Bank of England was founded in 1694 to fund King William 4<sup>th</sup>’s activities.... Hamburg bankers provided 1,200,000 pounds... So began England’s National debt.

The debt had two conditions: That it NEVER BE REPAYED and annual interest cost of about 8%.

## AUSTRALIA

**Australia’s C.B.A. was effectively privatised commencing 1924 [following the sudden death of Sir Denison Miller].**

**The Bruce / Page conservative Government created a Board of Directors at arm’s length from the Federal Government. Under the control of Sir Robert Gibson, Australia suffered the Great Depression commencing 1929 at the behest of the Bank of England... You may know of the visit of Professor Copeland and Sir Otto Niemeyer who instructed The Board on financial policies that delivered the Great Depression?**

## WORLD

Effectively, today, there is world wide, a global financial system of fractional reserve Central banking.

At the apex sits the Bank for International Settlements. Several layers below exist banks like our big four.

Each year at Davos in Switzerland the world’s lead bankers, business identities and politicians meet behind closed doors to discuss the progress of what is now called “the global village”, introduced a decade or so ago as “The New World Order”.

## THE MINT

The people of Australia, [via the Commonwealth Parliament] still own the two mints in Canberra and Perth that produce our notes and coins. The total value of the money created by our mints is about 3% of the Nation’s “money” supply.... All the rest is “credit” created by the privately controlled central banking system.

## CASHLESS SOCIETY

Given your interest in banking I guess you know the private banks have commenced promoting a “cashless society” to be introduced by about 2020?

The [privately controlled] European Community Bank has advised it intends removing its highest denomination note with a view to moving to a cashless society in the near future.

## AUSTRALIAN SOVERIEGNTY

Whilst our Nation still owns the two mints AND AUSTRALIA POST, we have a slim chance of retaining our National FINANCIAL SOVERIEGNTY.

In Australia today there is a shortage of spending power, AVAILABLE CASH, within the community at large. Be it Government [at all 3 levels] or our national community, we are suffering a shortage of available CASH.

Note well the stalled and intractable economy.

## STORY OF THE COMMONWEALTH BANK

Probably, you do not know the story of the creation of the C.B.A. and what it delivered between 1912 to 1924, when it was strangled. Sufficient to say that starting with a grant of \$24,000 in 1912, and by 1924 it had:

- financed W.W.I,
- carried Australian farmers through the 1914 shocking drought,
- provided long term low interest home loans, and
- financed the Transcontinental railway line.  
ALL with NO NATIONAL DEBT.
