**Vol.43 No.11 November 1978:** Addressing the Annual "New Times" Dinner guests on September 22, 1978 Mr. Eric Butler said that on the eve of the Centenary of C. H. Douglas's birth, which took place in January, 1879, and a series of events planned for 1979 to commemorate the Douglas Centenary, "... it was inspiring and assuring that the 1978 Dinner should provide concrete evidence of a movement of continuing growth and vitality at a time when there was general disintegration". The 1978 Dinner was "a manifestation of continuity", said Mr. Butler, "linking the past with the present and providing evidence that the future was assured."

**Vol. 44, No. 11 NOVEMBER 1979:** In his splendid message to the Douglas Centenary Dinner, held in Melbourne on Friday, September 21, 1979 Dr. Geoffrey Dobbs, one of the small number of living social creditors who worked with Douglas, crystallised the central theme and spirit of the Dinner with his statement, "We are involved in an adventure vastly greater than we thought".

### Wallace Klinck Canada responded to article:

I should say that the contrasting of "communism/socialism" with "capitalism", *per se*, is a tactical error and a serious conceptual mistake. All nations that possess tools are "capitalist" and the communist regime of Soviet Russia was most intensely "capitalist". Its emphasis was on heavy industry to the gross neglect of the consumer. I was in the U.S.S.R. and Ukraine in 1981 and their economies were consumer wastelands. They did not even have refrigeration in Moscow, Leningrad and Kiev food stores which depended on ice-boxes, (continued on next page)

(continued from previous page) were dingy and ill-stocked and required about three time-consuming stops when exiting.

In Moscow there were only two book stores—both stocked almost entirely with communist literature. They imported some McGraw-Hill textbooks for the Universities.

If one searched Moscow in the evening for a restaurant a little sliding window would suddenly open and then rapidly slam shut. We stayed at a fairly decent hotel in Moscow, the Cosmos, but it had been built by the French for the Olympics. Entry and exit were supervised by the usual “key ladies”.

All nations need real capital or “tools”. The successful deployment of these tools depends upon decentralization of initiative that is applied to commercial and industrial activities. **Centralized planning expressing the production and consumption policies of a few self-proclaimed omniscients according to their view of how the world should be, and exercising punitive sanctions to force this concept on society from the top down via central planning, destroys creativity, initiative and sabotages, thereby, the whole process.**

As one young Russian, having married a Canadian girl after moving to Canada, said to me while shaking his head, “Hmm—I don’t know—we work but nothing seems to happen.” This is hardly a mystery to anyone who has a rudimentary understanding of the principles of human association. Dynamism—not stasis—is the key issue. This depends upon decentralization of administration, voluntary initiative and individual creativity.

When we advance black and white judgements and comparisons between “capitalism” and “communism/socialism”, per se, we misconstrue and misrepresent the whole scenario. We provide totalitarian ideologues a perfect opportunity to indoctrinate youth and others who are not favourably impressed with a “capitalism” that promotes increasing centralization of power and wealth, corrupts all levels of society and misdirects resources toward continuous waste and war—while abandoning increasing numbers of ordinary citizens to growing poverty and hardship consequent to technologically induced elimination of remunerative opportunity and inflation of prices—all in the context of an oscillating economy and an uncertain and insecure future, where the economy chokes on its own abundance due to a bottleneck in consumption occurring purely because of artificial and distorted financial-accountancy, only resort to increasingly onerous taxation to “spread the creeping poverty around” reduces or avoids absolute destitution in the context of a much more physically productive economy than existed in primitive times.

This continual apposition of “capitalism” and “communism/socialism” is a dialectical snare which detracts from the real problem with which we have to contend, but do not understand—primarily because

of a destructive and evil, guilt-inducing Puritanical philosophy that deceives us into thinking that an inability to access physical wealth, in the context of its actual and potential super-abundance, requires additional work and toil for humanity.

The bottle-neck is in ability to consume and this occurs because of a fundamental and increasing deficiency of financial consumer purchasing-power.

This single fatal flaw in our system of cost-accountancy and credit issue and cancellation is the primary cause of virtually all of our economic and social problems. The fault does not lie in the free society and the solution does not lie in the centralization of resource deployment and initiative.

Humans associate at many levels which requires both individual and joint participation. Youth and others can see this reality, so the whole argument for a free-for-all *laissez faire* economy is seen to be unrealistic in the essential nature of things.

Because of their natural desire for self-preservation people who view and experience the vagaries of the existing economic system are often and increasingly deceived by the lure of collective and centralized action as a guarantee of economic security. What else would one expect of those who find themselves increasingly marginalized and economically deprived, in circumstance of obvious material abundance, while observing a small seemingly favoured class living in extreme luxury?

If we continue to draw a false comparison between the fictitious, or fabricated, categories “capitalism” and “communism/socialism”, a dialectical dichotomous strategy of Marxism itself, while blandly and blindly ignoring the real cause of our problems, i.e., a defective and non-self-liquidating price-system which prevents us from accessing the consumer wealth emanating currently from the production system, except by means of an evermore burdensome financial mortgage upon the future, thereby to stop up the “Abundance of the Kingdom”, we will continue to fall victims to the advocates of tyranny while making only ineffective rear-guard efforts to oppose their enslaving policies. These malodorous policies are being taught in the universities where insecure, impressionable and naïve young people who have not experienced the abuses of direct administrative political and economic totalitarianism are often easily seduced by these enticing and seditious tactics. \*\*\*

## URSULA HAVERBECK, 89, SENTENCED TO 14 MONTHS IN JAIL FOR HERESY

The Cultural Marxist globalist elite who hold sway in much of Western politics and who have a hammerlock on the media and academe sneer at Christianity.

### ‘Nazi Grandma’ loses appeal case, sentenced to 14 months in prison for Holocaust denial

Ursula Haverbeck, often dubbed the “Nazi Grandma” in the German press, has been sentenced to 14 months in prison for incitement of racial hatred. Haverbeck has been handed several jail terms but has yet to be jailed.

A German court in Detmold has sentenced Holocaust denier Ursula Haverbeck to 14 months in prison, after the 89-year-old woman lost her appeal to a prior conviction on Tuesday. However, four months were shaved off her original conviction of 18 months. Prosecutors wanted the sentence upheld, Haverbeck’s lawyers were seeking exoneration.

The Detmold court had initially sentenced Haverbeck to eight months imprisonment in September 2016, after she sent a letter to the town’s mayor, Rainer Heller, claiming that Auschwitz was not a concentration camp.

Following the trial, the octogenarian handed out pamphlets to journalists, as well as the judge and prosecutor, entitled “Only the truth will set you free,” in which she once again denied the Nazi atrocities. Haverbeck was handed an additional 10-month sentence for the stunt.

Under German law, denying the Holocaust—in which 6 million Jews were murdered by the Nazis between 1941 and 1945—constitutes incitement of racial hatred and can carry a prison sentence of up to five years.

Haverbeck and her late husband Werner Georg Haverbeck, who was an active member of the Nazi party in the run-up to and during the Second World War, founded a right-wing education center called Collegium Humanum, which has been banned since 2008. She has also written for the right-wing magazine *Stimme des Reiches* (Voice of the Empire), which she also used to express her views that the Holocaust never took place.

### Time still to serve

Haverbeck, from the German town of Vlotho near Bielefeld, has been sentenced for similar charges on five other occasions. The most recent, in October, saw her sentenced to six months in prison by a district court in Berlin for incitement of racial hatred after she claimed at a public event that the gas chambers and Auschwitz concentration camp “were not real.”

In August she was handed a two-year sentence by a regional court in Lower Saxony.

Haverbeck has appealed the rulings passed down against her and proceedings in each other case remains ongoing. Haverbeck claims she has merely been repeating an opinion.

This Tuesday’s appeal verdict is not final, either. Haverbeck’s lawyers intend to take the case to the Higher Regional Court in the town of Hamm, their last chance to challenge the sentence. \*\*\*

## MEDICAL TOTALITARIANISM? By Mrs Vera West

The government has set up the Australian Digital Health Agency: <https://www.digitalhealth.gov.au> as a one-stop shop for medical records, or so they say.

The My Health record system will collect the following information:

- “Shared Health Summary – a clinically reviewed summary prepared by an individual’s key healthcare provider;
- Event Summary – to capture key information about a key healthcare event relevant to ongoing care;
- Discharge Summary – to support the transfer of a patient from a hospital back to the care of their nominated primary healthcare provider;
- Specialist Letter – to capture key information

about specialist visits;

- eReferral – currently from GPs to specialists;
- Prescription and Dispense Records.

The system also enables individuals to add Medicare information, and to create their own personal health summary and health notes.

It provides access for participating individuals (people to whom the record relates, including authorised or nominated representatives) and healthcare providers via the following services:

- Accessed via the National Consumer Portal and viewed through a compatible web browser;

• **Healthcare Provider:** Accessed via the National Provider Portal, an integrated clinical information system, or a patient administration system, with specialist clinical software in use to create these. Information in the system can be accessed as individual documents or through views which bring together clinical documents (such as prescription and dispense records) and displays them in a predictable way.”

Sure, that’s what they all say. Why would anyone with good intent want to put together such a body of information which could easily be abused? Rightly, privacy groups are outraged about this system which is going to have all of your health data, unless you choose to opt out.

The government, which has your money to burn, has spent \$ 1.7 billion on this system. It will record every public medical detail about you, such as prescribed medications, and whether you have had a sexually transmitted disease. The information, and this is the whole point of the endeavour, will be available via a court order for the ATO, police and other government agencies to use, almost always against you.

The really important thing here is the opting out issue; obviously we could go on about the need of Australian to fight for freedom etc. etc. Remember, the Australian public, 61 percenters, voted for same sex marriage without protection of religious freedom. The majority of Australians may well vote for this digital surveillance, if they are told by Big Sister that it is needed.

The minority of Australians who love freedom, should act against this example of medical totalitarianism. The information about the opt out period does not yet seem to be available, we do not know when it will start and end, but there will be three months to do this. The websites, as I read them give no hints. Of course the government, being slimy, rotten, evil, Satanic etc., will do nothing to help, and claims that it can’t publicise this information as it is already over budget.

Thus, we will keep chipping away at this one. Our noble editor Arnie will make a note on his super-computer to keep the search going. When we find out how to opt out, you will be one of the first to know.

“In a world first, medical data from an entire generation of Victorian babies will be pooled to fast-track research into diseases like autism, depression and obesity.

Parents of all children born in the state in 2020 and 2021 will be invited to join the “Gen V” project and help transform Victoria into a “living laboratory”.

The initiative’s architects say it will accumulate medical information at the scale needed to tackle big health issues, allowing researchers to analyse existing

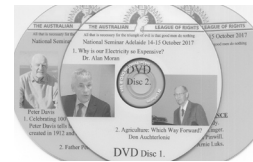
data rather than being forced to recruit medical trial participants from scratch. Up to 160,000 Victorian children will be included in the project, which will aim to keep imposts on parents to a minimum. “It’s basically business as usual for them,” said project leader Melissa Wake of the Murdoch Children’s Research Institute.

“It’s about working through existing services and data as much as possible, with some judicious additional data collected very infrequently, to get a better return on the huge investment that goes into services in Australia. This is the first time this kind of data has been brought together at a statewide level anywhere in the world.”

The problem as I see it, is that the babies and children cannot give their consent, yet their personal data is being collected.

What will be the future legal significance of this? \*\*\*
