SOCIAL CREDIT AND WAR By M. Oliver Heydorn, Ph.D

Social Crediters have repeatedly warned that there is a chronic economic cause, entirely artificial in nature and, therefore, unnecessary, which inexorably leads nations to take up arms against each other. Due to the underlying deficiency in consumer purchasing power that afflicts all industrial societies operating under standard banking and cost-accounting conventions, countries are frequently pressured to alleviate the lack of liquidity in the domestic economy by seeking to export more than they import. A so-called “favorable trade balance” (which is undoubtedly unfavorable in real terms because it implies a net loss of real wealth) helps an economy to fill the gap between the prices of consumer goods and the consumers’ income by getting rid of part of its surplus production, while, at the same time, increasing the flow of purchasing power to the consumer (through the jobs that are created and the profits that are obtained by the exporting companies). The problem is that it is mathematically impossible for all of the nations in the world to export more than they import; it is a zero-sum game. For every exporting champion, there must be a loser with a trade deficit. Countries that import more than they export are faced with a problem of a gap that has become even worse as a result of their commercial activities. Since every country is operating under the same internal deficit of purchasing power, the struggle for a favorable trade balance constitutes a struggle for survival. This leads, quite naturally, to economic conflict, or rather to economic warfare, in the form of commercial wars and ‘free trade’ alliances, and, all too often, it can force or at least induce a military conflict. A country that does not manage to compete successfully through ‘innovation’, hard work, and the achievement of lower prices in comparison with its rivals in the global struggle for an artificially scarce flow of purchasing power can choose to ensure its victory through war, i.e., by defeating his economic opponents on the battlefield. The real reason for the war will, of course, be more or less hidden from the public and a pretext will be found, but the war may allow the aggressor to destroy part of a rival’s productive capacity and/or, through the eventual signature of peace treaties, to insist on more favorable commercial conditions for itself (as part of due reparations).

The pressure placed on nations to compensate for their internal price-income gaps with favorable trade balances is intensified by the universally defended policy of full employment. If we madly insist, in direct opposition to the real physical potential of the modern industrial economy, that all (or almost all) must work in the formal economy in order to obtain purchasing power (or be supported by those who do), then we are demanding continued economic growth as an end in itself (as a means of distributing additional income as the population grows). The resulting production must find some outlet. If it can not be absorbed internally, a market must be secured for it abroad. It was for this reason that John Hargrave, leader of the Green Shirts (a paramilitary Social Credit group of the 1930s), courageously proclaimed on more than one occasion that “He who cries for full employment, cries for war”.

THE BRITISH NERVE GAS FALSE FLAG By Peter Ewer

“A 45-year-old Russian accountant and relative of the two Russians poisoned in a nerve agent attack in Britain last month said in an interview late Thursday that she was ‘scared’ for them, calling the British authorities untrustworthy and casting doubt on their version of events. In the interview in Yaroslavl, Russia, where she lives with her husband and her two children, the accountant, Viktoria Skripal, who has been thrust into an escalating confrontation between Russia and the West, also said that she doubted that Britain would grant her a visa that would allow her to see her relatives. The relatives, Sergei V. Skripal, a former Russian spy, and his daughter, Yulia, have been hospitalized in Salisbury, England, since the

attack on March 4. Ms. Skripal’s suspicions, which echo the accusations of Russian officials, have become the country’s latest riposte to British assertions that Moscow was responsible for the attack carried out with a rare class of military-grade nerve agents developed by the Soviet Union called Novichoks. “Wouldn’t you be scared?” she said. “While I don’t know the whole situation, they ask me to voice my opinion,” she said of the British authorities, who she said wanted her to denounce Russia. “If they tell me, ‘We’ll return Yulia to you if you say ‘Russia is filth,’ then I’ll stand up and say ‘Russia is filth’ and take Yulia back to that filth.”

“Stephen Bullivant, a professor of theology and the sociology of religion at St Mary’s University in London, recently published a report, ‘*Europe’s Young Adults and Religion*’ “Christianity as a default, as a norm, is gone, and probably gone for good – or at least for the next 100 years,” Bullivant said. According to Bullivant, many young Europeans “will have been baptised and then never darken the door of a church again. Cultural religious identities just aren’t being passed on from parents to children. It just washes straight off them... And we know the Muslim birthrate is higher than the general population, and they have much higher [religious] retention rates.” Richard Dawkins, an atheist and the author of *The God Delusion*, responded to the study’s release by tweeting

to his millions of Twitter followers. Before we rejoice at the death throes of the relatively benign Christian religion, let’s not forget Hilaire Belloc’s menacing rhyme. “Always keep a-hold of nurse, for fear of finding something worse.” Dawkins is apparently concerned that after the demise of Christianity in Europe, there will not be an atheistic utopia, but a rising Islam. That is the major point of what Philippe Bénéton in his book *The Moral Disorder of the West* (“Le dérèglement moral de l’Occident”): Islam is filling the cultural vacuum of a society with no children and which believes -- wrongly -- it has no enemies.”

White racial pathology though, is surely only part of the problem, even if the major part. There is always the problem of the enemies within the gates, who now control the entire security system, and lifeblood of society, a faceless group of elites, loyal only to abstract notions of money and power. “An Amazon patent, filed in June 12, 2017, reveals a massive conspiracy to spy on you using a ‘voice sniffer algorithm’. If approved by the U.S. Patent and Trademark Office, this artificial intelligence can be embedded inside Amazon devices, including the Amazon Alexa. The ‘voice sniffer algorithm’ would take advantage of the microphones already built into Amazon devices. The technology would permit Alexa and other Amazon devices to listen to your conversations in real-time to identify ‘trigger words’ that can give the tech giant insight into your personal life. The AI spy tech will learn about your personality, interests, purchasing habits, or glean any useful detail about your private life.

The ‘trigger words’ from your private conversations could then be sent to third parties so any organization can target market their products to you. The third parties could include political organizations that want

to motivate you to action or manipulate you otherwise. The data could even be used by law enforcement agencies to determine who might commit a crime in the future. The ‘voice sniffer algorithm’ will help law enforcement closely watch a perceived threat to society. Words from your private conversations could be used against you, leading to arrest or imprisonment. Law enforcement could use the data to identify ‘threats’, while abiding by red flag laws that are used to disarm citizens who are considered ‘mentally ill’ or a threat to family and friends. The technology could lead to the targeting of specific belief systems that are a threat to industries. The widespread analysis of private conversation could be used to suggest mental illness and force psychiatric drugs on people.”

GUN CONFISCATION BEGINS IN AMERICA By John Steele

“As the state promises gun rights activists they’re not coming for their guns, behind the scenes they’re pleading for it to happen. And now the feared gun grab is occurring. Residents in Deerfield, Illinois have 60 days to surrender their ‘assault weapons’ or face fines of \$1000 per day per gun. The gun ban ordinance was passed on April 2nd with residents left with few choices of how to dispose of their valuable ‘assault weapons’. Upon careful reading of the ordinance, residents will be left with revolvers, .22 caliber ‘plinking’ rifles, and double barrel shotguns to defend their homes and families from criminals who could care less about the law. Fines for not disposing of the weapons range from \$250 to \$1000 per day per gun for those who choose not to comply with the city’s ordinance. While a fine may seem reasonable to some, as TFTP has reported on multiple occasions, failure to pay fines always results in police action. It is not far-fetched to predict major turmoil and arrests in the event of non-compliance. One example of the so-called ‘assault weapon’ is the Ruger 10/22 which can accept magazines that hold more than 10 rounds. Even though the 10/22 is not listed in the list of guns the village wants to see banned, the gun cannot legally be possessed in the village.”

I imagine that if there is no registration and no state record of who owns or has what, the feared assault rifles

will simply ‘disappear’, being put into ‘cold storage’. I do not see gun owning Americans going down like the British and Australians. This story at least shows the world the real agenda of gun control, which is to take away all guns on the socialist road to total enslavement:

“The never-ending cycle of side effects and adverse reactions that come from pharmaceutical drugs adds nearly half a trillion dollars to U.S. health care costs annually. A team of researchers from the University of California San Diego computed the true costs of pharmaceutical drugs. The real reason health insurance and medical care is so expensive is because most of the ‘medicines’ doled out are actually costly poisons that cause more health problems. The side effects of pharmaceutical drugs only cause more doctor visits, more testing, more medical intervention, and a cycle of drug dependence. So many people today do not understand what it feels like to be healthy, to be functioning with energy, strength, stamina, cognition, and strong natural immunity because they have been lied to and abused by this pharmaceutical system. For example, the aluminum salts in an HPV vaccine can trigger seizures in a young girl, forcing her to need anti-seizure medication. This anti-seizure medication can cause insomnia, leading her to need a sleeping pill. The sleeping pill can cause attention deficit and memory recall issues, leading to more medication and more problems down the road.
