“A former Yazidi sex slave came face-to-face with her ISIS captor after escaping captivity to flee to Germany but was told that police could do nothing because he was a refugee, it has been claimed.

Ashwaq Ta’lo was kidnapped by ISIS in August 2014, aged 15, and was kept in captivity by the jihadist man for three months but escaped and made her way to

Europe. Speaking in a Facebook video, she said she had seen the man, Abu Humam, in 2016 and then again earlier this year in Schwäbisch Gmünd in south-western Germany. She told police and asylum officials about the encounter and although they identified the man from CCTV they said there was nothing they could do because the man was also registered as a refugee, *The Times* reports.”

“President Macron’s government has voted against having an age of consent in France, becoming the latest nation to give in to pressure from an international network of liberal activists determined to normalize pedophilia and decriminalize sex with children across the world. Federal law in France now has no legal age of consent, meaning adults who have sex with children of any age will not be prosecuted for

rape if the child victim is unable to prove “violence, threat, duress, or surprise.”

The draft bill against sexual and gender-based violence, known as the Schiappa law, was signed into law by the French Parliament on 3 August, sparking outrage in France as parents and children’s rights groups accuse Emmanuel Macron’s government of betraying the nation’s children. “Around 4,000 far-right supporters gathered on the grounds of a ruined castle last weekend to plot the downfall of the socialist ideas that have come to define their progressive country. Their views — anti-immigration, anti-establishment and often anti-Muslim — are not new amid the populist tsunami that’s crashed into much of the West.

But this is Sweden, where socialists have dominated every election for the past 101 years, making the Nordic nation something of a lodestar for leftists around the world. Some polls predict that the supporters’ favored party, the Sweden Democrats,

with roots in neo-Nazism and white nationalism, will win as much as 25 percent of the vote in an election scheduled for Sept. 9. Such a result would likely earn the Sweden Democrats more seats in Parliament than any other single party. At the party’s annual summer festival here, speeches were interspersed with heavy metal music as supporters gathered at Sölvesborg Castle for the headline act: an address by Jimmie Åkesson, the 39-year-old leader of the Sweden Democrats.

“He’s the only politician I can trust,” a retiree named Jan shouted above the din. “We need him for our country. I don’t have so many years left, but for my children and for my grandchildren.”

Again, we will have to watch and observe how they go. It is better than nothing. \*\*\*

“A new report from Gallup revealed that young people prefer socialism to capitalism. The Gallup report, which was published on August 13, details American attitudes on socialism and capitalism. The results specifically identified that positive attitude towards socialism amongst millennials. The majority of Americans, aged 18 to 29, now prefer socialism to capitalism. Americans aged 18 to 29 are as positive about socialism (51%) as they are about capitalism (45%). This represents a 12-point decline in young adults’ positive views of capitalism in just the past two years and a marked shift since 2010, when 68% viewed it positively. Meanwhile, young people’s views of socialism have fluctuated somewhat from year to year, but the 51% with a positive view today is the same as in 2010. A report from CNBC on the Gallup poll argued that many young Americans are struggling to get by in the current economy. For example, wages haven’t risen to match the rise in the cost-of-living. As a result, many young Americans are blaming the system for their struggles.

Despite today’s strong economy, many young Americans are struggling to make ends meet. That’s because wages are not keeping up as day-to-day costs continue to soar, author and executive director of the Economic Hardship Reporting Project Alissa Quart tells CNBC Make It: “Stop blaming yourself and start blaming the system, or start blaming the deeper causes of your economic fragility and instability. There are forces that are constructed against you, everything from your taxes to whether you can have job security.”

The Gallup poll revealed that older Americans have a much more negative view on socialism. This may be a consequence of the failures of socialist systems around the globe in the 20th century. Younger people, still, often point to the Scandinavian countries for their success with the Nordic model of socialism, which involves a welfare state and collective bargaining at the national level on top of free market capitalism.”

My take on this is that the present neo-liberalism system has indeed failed young people, because it has eroded the moral capital of the future, destroyed environments, and in the name of globalism, exported jobs. Yet socialism, as seen in places like Venezuela, has not done better, but indeed, much, much worse, reducing society to zombie apocalypse levels.

Clearly, this is the time to be putting to youth, who will be coming increasingly receptive, to the social credit message. The time, like in the 1930s is ripe again. \*\*\*

Q: With regard to strict liability failure to warn, did Roundup Pro or Ranger Pro have potential risks that were known or knowable in light of the scientific knowledge that was generally accepted in the scientific community, in the time of their manufacture, distribution or sale? A: Yes

Q: With regard to punitive damages, did you find by clear and convincing evidence that Monsanto acted with malice and oppression in their conduct upon which you base your finding of liability or loss? A: Yes

Q: Was the conduct constituting malice or oppression committed, ratified or authorised by one or more of directors, managers or officers acting on behalf of Monsanto? A: Yes

Now it is your choice, now is the time to tell the council not to spray the street in front of your house and ask your neighbours to do the same, maybe your street can become first in the district/suburb SPRAY Free Street. Maybe your council will stop using it and instead use friendlier products. Is it Australia's fate to become free of the poison. And the reason, you will ask, the effects are proven to be catastrophic to our health and the planet. You may even venture to ask your local Greens member to act.
