THOUGHT OF THE WEEK: “First of all, I wish to point out to you that the idea of world monopoly is not a new one, far from it, although it has taken many forms. Practically all the world's historical empires, beginning with the Roman Empire, although there were others before that, were attempts at world power. That was the first type of an attempt at world monopoly, the military idea. We had an attempt in that direction so late as in 1914. It was the hardly concealed objective of the German Empire to form a military world state which would be supreme. We know that failed.

Another attempt along administrative lines undoubtedly was launched immediately after that in the original idea of the League of Nations, which undoubtedly contemplated the formation of something of the nature of a superior state which should lay down the law for everyone else. That never got very far, because I think its objective was early realised, and imperceptibly it merged into something else, which is undoubtedly a matter for our closest concern to-day, namely, the financial world state, the financial hegemony of the world by a selected group of central banks, crowned by the Bank of International Settlements. That is simply the translation of the same idea into different methods, one after the other.” ***

THE COUDENHOVE-KALERGI PLAN: THE GENOCIDE OF EUROPE ON TRAINING WHEELS By Richard Miller

“Few people know that one of the main initiators of the process of European integration, was also the man who designed the genocide plan of the Peoples of Europe. It is a dark person, whose existence is unknown to the masses, but the elite considers him as the founder of the European Union. His name is Richard Coudenhove Kalergi. His father was an Austrian diplomat named Heinrich von Coudenhove-Kalergi (with connections to the Byzantine family of the Kallergis) and his mother the Japanese Mitsu Aoyama. Kalergi, thanks to his close contacts with all European aristocrats and politicians, due to the relationships of his nobleman-diplomat father, and by moving behind the scenes, away from the glare of publicity, has managed to attract the most important heads of state to his plan, making them supporters and collaborators for the "project of European integration". In 1922 he founded the "Pan-European" movement in Vienna, which aimed to create a New World Order, based on a federation of nations led by the United States. European integration would be the first step in creating a world government. Among the first supporters, including Czech politicians Tomáš Masaryk and Edvard Beneš was the banker Max Warburg, who invested the first 60,000 marks. The Austrian Chancellor Ignaz Seipel and the next president of Austria, Karl Renner, took the responsibility for leading the "Pan-European" movement. Later, French politicians, such as Léon Bloum, Aristide Briand, Alcide De Gasperi, etc will offer their help.

With the rise of Fascism in Europe, the project was abandoned and the "Pan-European" movement was forced to dissolve, but after the Second World War, Kalergi, thanks to frantic and tireless activity and the support of Winston Churchill ... and major newspapers like the *New York Times*, the plan manages to be accepted by the United States Government. The CIA later undertakes the completion of the project.” ***

GOLDMAN SACHS: CURING CANCER IS NOT A 'SUSTAINABLE BUSINESS MODEL' By Jay Greenberg

Global banking giant Goldman Sachs has declared that curing patients of terminal illnesses, such as cancer, is not a "sustainable business model."

The investment firm also urged investors to resist backing pioneering "gene therapy" treatments as cures are bad for business in the long term. In an April 10 report entitled *"The Genome Revolution,"* the world's 5th largest bank asks: "Is curing patients a sustainable business model?". Analyst Salveen Richter wrote in the note to clients that long-term treatments garner far more revenue than "one-shot cures," saying:

"The potential to deliver 'one-shot cures' is one of the most attractive aspects of gene therapy, genetically-engineered cell therapy, and gene editing.

"However, such treatments offer a very different outlook with regard to recurring revenue versus chronic therapies.

"While this proposition carries tremendous value for patients and society, it could represent a challenge for genome medicine developers looking for sustained cash flow." <https://neonnettle.com/news/4072-goldman-sachs-curing-cancer-is-not-a-sustainable-business-model-> ***

"Central bankers are now aggressively playing the stock market. To say they are buying up the planet may be an exaggeration, but they could. They can create money at will, and they have declared their "independence" from government. They have become rogue players in a game of their own.

Excluding institutions such as Blackrock and Vanguard, which are composed of multiple investors, the largest single players in global equity markets are now thought to be central banks themselves.

An estimated 30 to 40 central banks are investing in the stock market, either directly or through their investment vehicles (sovereign wealth funds).

According to David Haggith on *Zero Hedge*:

Central banks buying stocks are effectively nationalizing US corporations just to maintain the illusion that their "recovery" plan is working

At first, their novel entry into the stock market was only intended to rescue imperiled corporations, such as General Motors during the first plunge into the Great Recession, but recently their efforts have shifted to propping up the entire stock market via major purchases of the most healthy companies on the market.

The US Federal Reserve, which bailed out General Motors in a rescue operation in 2009, was prohibited from lending to individual companies under the Dodd-Frank Act of 2010; and it is legally barred from owning equities. It parks its reserves instead in bonds and other government-backed securities. But other countries have different rules, and today central banks are buying individual stocks as investments, with a preference for big tech stocks like Amazon, Apple,

Facebook and Microsoft. Those are the stocks that dominate the market, and central banks are bidding them up aggressively. Markets, including the US stock market, are thus literally being rigged by foreign central banks.

The result, as noted in a January 2017 article on *Zero Hedge*, is that central bankers, "who create fiat money out of thin air and for whom 'acquisition cost' is a meaningless term, are increasingly nationalizing the equity capital markets." At least they would be nationalizing equities, if they were actually "national" central banks. But the Swiss National Bank, the biggest single player in this game, is 48% privately owned; and most central banks have declared their independence from their governments. They march to the drums not of government but of big international banks."

As financial reformers have feared, we have thus reached the situation of complete global control of finance, and thus of the fate of nations. As was stated in *Tragedy and Hope* (1966) by Carroll Quigley; "The powers of financial capitalism had another far-reaching aim, nothing less than to create a world system of financial control in private hands able to dominate the political system of each country and the economy of the world as a whole. This system was to be controlled in a feudalist fashion by the central banks of the world acting in concert, by secret agreements arrived at in frequent private meetings and conferences. The apex of the system was to be the Bank for International Settlements in Basel, Switzerland, a private bank owned and controlled by the world's central banks which were themselves private corporations."

Fighting against this is going to be the hardest task that humanity faces. It would do well to familiarise yourself with *Douglas Social Credit*. ***

PRIME MINISTER - SCOTT MORRISON, CAN WE EXPECT A NEW ERA OR MORE OF THE SAME? By Ken Grundy

The revolving door for Prime Ministers from both parties has often delivered little or no change in important policies. Will this pattern change under Prime Minister Morrison? Mr Morrison and new Treasurer Mr Frydenberg have been prominent in all the recent Turnbull policies which in many cases have not pleased the community. Australia must regain its sovereignty. The first responsibility of a Member of Parliament must be to his electors. If he is not serving them, we must ask, who is he representing?

In Mr Morrison's acceptance speech, he stated that his government would be working for the community. He deserves credit for this point, providing he means he will respond to the community wishes, rather than simply decide policies that he thinks will be best for us. There is a web of control around Australia which often prevents government from delivering policies acceptable to the voters. This breeds resentment toward MP's. Australia has foolishly committed to Treaties and Agreements containing clauses not in our interest.

The Lima Agreement.

The Declaration from Lima, among other things, agreed for the developed world to transfer its

manufacturing to the developing world. There is the answer to people who wonder why most of our manufacturing has left our shores. However, no MP ever mentioned the detail of the Agreement.

The Paris Agreement.

Our leaders were persuaded that global warming was caused by man-made emissions. This led to the Paris Agreement, signed by our leaders offering some commitment to cut our emission. Australia demolished our coal generation plants to honour an Agreement which Australians did not want. Our electricity price is now the highest in the world. Meanwhile Professor Plimer's report that Australian grassland and forest areas sequester almost five times more carbon than we emit, meaning the problem did not exist within Australia.

Free Trade Agreements.

One cannot deny there is a benefit in FTA's but the fine print contains undesirable features. Some include Australian liability to huge damage costs awarded to any foreign company which can demonstrate a loss of income as a result of a new law affecting their profit. Presently our pork producers are facing difficult trading due largely to imported pork which cannot be denied entry to Australia.

These examples demonstrate the loss of control over our own affairs which is the root of our problems. So it matters not whether any Member of Parliament or Prime Minister, has charisma, or is a decent bloke; unless he is prepared to withdraw from unfavourable commitments and deliver us a nation which determines its own rules according to the wishes of its people, we can only expect more of the same. ***

U.S. CONFERENCE OF MAYORS:

"We Will Sue FCC If They Eliminate Local Control Over 5G Deployments" By B.N. Frank
