AUSTRALIAN IMMIGRATION: ALWAYS OUT OF CONTROL By James Reed

“Liberal senator Dean Smith says Australians have not been listened to on population policy development over the past two decades. Demands from a majority of Australians to put the brakes on immigration levels in 1994 were ignored by political leaders, who oversaw a 30 per cent blowout in population growth. Liberal senator Dean Smith is using figures from a 24-year-old parliamentary committee report to argue Australians have not been listened to on population policy development over the past two decades. The West Australian senator, who led the campaign last year to legalise same-sex marriage, called for the re-establishment of the now abolished long-term strategies committee and for a population inquiry to be prioritised.

Senator Smith’s proposal came as cabinet minister Christopher Pyne argued that Australia did not have a “too-high population”, despite Scott Morrison confirming there would be a reduction in the cap of the permanent migration intake. The long-term strategies committee was established in 1990 and abolished by the Howard government in 1996. It conducted an eight-month inquiry into Australia’s population levels in 1994, when the nation had fewer than 18 million people. Of the 300 submissions the committee received, 90 per cent advocated population stability or lower growth levels, while only 10 per cent argued for an increase in population levels. The committee called for a long-term population policy rather than a year-by-year approach. Senator Smith, who has long called for lower immigration levels, said it was a good thing

the federal government was devolving some of its migration powers and giving the states a greater say. He said a parliamentary inquiry would allow citizens to participate and give the community a say in a long-term population plan.

“It’s becoming more and more important the government gives expression to the various and sometimes competing community attitudes about future population growth,” Senator Smith said. “Population continues to be a top-line political issue because the public want to be listened to on this key political matter and have a direct input on future population policy.” Mr Pyne labelled the response to the Prime Minister’s floating of a 30,000-person cut to the yearly intake as an “overreaction”. The South Australian MP said the permanent migration intake had come in 30,000 below the 190,000 cap this year.”

This country has been immigrated to death, culturally and ecologically, since the end of World War II, destroying any chance of creating a national culture and identity, or a long-term sustainable society. All so Big Business can make profits in retail and housing, and in the end, just die and rot like the best and rest of us. “Yesterday the Victorian Andrews Labor Government unveiled a new Victoria Police unit, the Fixated Threat Assessment Centre which it claims is aimed at protecting Victorians from terrorism and lone actor attacks. It will be staffed by 13 specialist police officers and aims to process 300 people in its first year. It is based on similar centres that have opened up in New South Wales, Queensland, the Netherlands and the United Kingdom.

However a closer look at which types of people the centre aims to target reveals it has a disturbing political agenda. Assistant Police Commissioner Ross Guenther defined fixated persons as those who repeatedly write letters, email or call local councillors or politicians and those who display a fixation with an ideology or religion.

Police Minister Lisa Neville said the centre would look at ideologies on all sides, including far-right extremism which she claimed it would “help identify high-risk individuals and have the potential to stop violent incidents before they occur”. *Fairfax Media* in their report spoke of right-wing terrorists such as Norwegian mass murderer 'Anders Breivik', and the killer of UK MP Jo Cox 'Thomas Mair' as the type of person this centre was aimed at.

Of course everybody wants to explore ways to prevent terrorism, however we know from experience that the Andrews Government has a very broad definition of right wing extremist. It considers all patriot and nationalist activists in Victoria to be extremists, as demonstrated by putting on trial the Bendigo Three who were found guilty under the state’s Racial and Religious Tolerance Act of offending Muslims for a mock beheading.”

“Joseph Siracusa, Professor of Human Security and International Diplomacy at RMIT University, said the centre may reassure the public but it was unlikely to

prevent terrorist and lone actor attacks.

“It's kind of loopy really. It's illogical and not evidence-based,” he said. “There has been very little proof or evidence that there is a set of criteria for identifying lone attackers or terrorists. They do not fit any single profile.

“The default position is that there is always a mental defect here ... [but that is] quite a leap of faith. I think these guys are pretty conscious and rational of what they are doing.” He added: “It's not Tom Cruise's *Minority Report* — you can't arrest people for crimes they haven't committed.”

Clarke Jones, a criminologist at the Australian National University's Research School of Psychology, said the centre would have a better chance of success if it looked more broadly at youth issues. “I'd be very interested to see if they get 300 people. That suggests there's 300 radicalised people in the Victorian community — and that's really pushing it, in my view,” he said.

“When you spend time in certain suburbs in Melbourne or Sydney, kids are more likely to be involved in behaviours like drug-taking and domestic violence. Violent extremism may be one of these behaviours, but it's not the only one, so it doesn't make sense on the ground.

“If the program is focused solely on terrorism or extremism, it's way off the mark.” Having police at the forefront of the response could limit the centre's effectiveness, Dr Jones added.

“I would argue that there are social services in the Victorian community that could deal with this much better than a police unit,” he said.

“That said, in terms of accountability within our society, police have a role in keeping us safe and preventing acts of violence.”

Ok, nobody should be offended by anything, even if it means allowing rapists to rape for decades because feelings are the most important things in the universe. “The Chinese government has admitted that hundreds of thousands more doses of children's vaccines are faulty, bringing the total number of vaccines known to be defective there to nearly one million. The State Council of China announced that another batch of vaccines for diphtheria, pertussis and tetanus (DPT) that were produced by the firm Changchun Changsheng Biotechnology, were considered “substandard.” Most of the doses were sold to authorities in the Shandong province in northeastern China, and some have already been given to children. The latest batch of 247,200 vaccines joins the 253,338 defective DPT vaccines from the same company that were discovered last November, along with more than 400,000 produced by a different company.

According to the *South China Morning Post*, 76 percent of those children who were given injections from the first substandard batch have already been treated by doctors, and there are now plans in place to treat those who received injections from the second batch. Although the Chinese government has done its best to prevent people from talking about the crisis, Chinese social media is still full of conversation about the topic. There have also been reports that the company used expired ingredients and altered testing records.” ***

by the naked body scanners present at American and British airports. “Today's cellular and Wi-Fi networks rely on microwaves – a type of electromagnetic radiation utilizing frequencies up to 6 gigahertz (GHz) in order to wirelessly transmit voice or data,” explains the Environmental Health Trust (EHT) about the difference. “However, 5G applications will require unlocking of new spectrum bands in higher frequency ranges above 6 GHz to 100 GHz and beyond, utilizing submillimeter and millimeter waves – to allow ultra-high rates of data to be transmitted in the same amount of time as compared with previous deployments of microwave radiation.”
