THOUGHT OF THE WEEK: Something is happening to us today which has not happened for a very long time. We are waging a war of religion. Not a civil war between adherents of the same religion, but a life-and-death struggle between Christian and pagan. The Christians are, it must be confessed, not very good Christians, and the pagans do not officially proclaim themselves worshippers of *Mahound* or even of *Odin*, but the stark fact remains that Christendom and heathendom now stand face to face as they have not done in Europe since the days of Charlemagne. In spite of the various vague references in sermons and public speeches to the War as a 'crusade', I think we have scarcely begun to realize the full implications of this. It is a phenomenon of quite extraordinary importance. The people who say that this is a war of economics or of power-politics, are only dabbling about on the surface of things. Even those who say it is a war to preserve freedom and justice and faith have gone only half-way to the truth. The real question is what economics and politics are to be used for; whether freedom and justice and faith have any right to be considered at all; at bottom it is a violent and irreconcilable quarrel about the nature of God and the nature of man and the ultimate nature of the universe; it is a war of dogma.

POLAND FIGHTS BACK By Richard Miller

Unlike the rest of the West, the Eastern European countries are waking up to the problems of the NWO:

"LGBT campaigners' demands such as 'gender ideology' and the promotion of alternative sexual lifestyles to young children at school present a serious threat to Poland, the head of the nation's ruling party has said. Speaking at a conference organised by the group Catholic Action on Wednesday, Jaroslaw Kaczynski denounced "an attack on the family and children", following the signing of a 12-point 'LGBT + Declaration' by Warsaw's liberal mayor.

"We are dealing with a direct attack on the family and children... the sexualisation of children, that entire LGBT movement, gender," he said, denouncing 'gender theory' which claims that sex is a social construct and that people can 'choose' their own gender, and which the Warsaw Declaration says must be promoted in schools. "These ideologies, philosophies, all of this is imported, these are not internal Polish mechanisms," Kaczynski told the conference in Wloclawek.

"They are a threat to Polish identity, to our nation, to its existence and thus to the Polish state," he added.

"Communism was not defeated" when the Berlin Wall fell, the Law and Justice (PiS) party leader said, asserting that freedom of speech and religion are under attack from a post-1989 "formation" of pro-EU and media forces which have been deeply hostile to the Church and Polish patriotism. The Roman Catholic Church in Poland was among voices highly critical of the Warsaw Declaration, expressing "deep concern" over education plans declaring schools must adopt 'LGBT-inclusive' education guidelines, warning that the plan "contradicts the constitutional right of parents to raise their children according to their own belief".

Is it any wonder that the particular Soros Foundation wants the EU to accelerate its "war" on Poland?

Despite EU undermining of national sovereignty fueling widespread, growing anger at the bloc in Poland, lawyers at the foundation called on Brussels to step up its attacks on the central European nation, alleging that the fight for supposed judicial “independence” was vital for protecting “human rights” throughout the union.

“The battle for the rule of law in Poland... is effectively a battle for the survival of the EU,” proclaims the Soros-backed NGO, which has spent recent years working on projects to “prepare Polish society for refugees”, to “form positive attitudes towards” mass third world migration, and training tens of thousands of professionals and officials in various roles to fight “prejudice” as well as “hateful online comments”. Poland’s conservative Law and Justice (PiS) has repeatedly spoken out against EU moves to

encroach on member states’ sovereignty since the party was the first in the post-Communist era to gain enough seats to rule without a coalition when it swept to power in 2015 elections, with the promise of reversing the Europhile, globalist previous government’s vow to resettle huge numbers of migrants in the country. Jacek Czaputowicz, Polish foreign affairs minister, and his Hungarian counterpart, Péter Szijjártó, told a press conference in Budapest this week that the two countries would continue to defend a Christian, pro-sovereignty Europe in the face of attempts by the Brussels establishment to force mass migration “down nations’ throats.”

I wonder what the great philosopher Karl Popper (1902-1994), whom Soros allegedly borrows from, would have thought about this war on Poland, given Popper’s opposition to all forms of fascism, totalitarianism, and dominating centralised control in favour of an “open society”? ***

ELECTRIC CARS AND THE EXPLOITATION OF CHILD MINERS By James Reed

“Picking through a mountain of huge rocks with his tiny bare hands, the exhausted little boy makes a pitiful sight. His name is Dorsen and he is one of an army of children, some just four years old, working in the vast polluted mines of the Democratic Republic of Congo, where toxic red dust burns their eyes, and they run the risk of skin disease and a deadly lung condition. Here, for a wage of just 8p a day, the children are made to check the rocks for the tell-tale chocolate-brown streaks of cobalt – the prized ingredient essential for the batteries that power electric cars. And it’s feared that thousands more children could be about to be dragged into this hellish daily existence – after the historic pledge made by Britain to ban the sale of petrol and diesel cars from 2040 and switch to electric vehicles.

Dorsen, just eight, is one of 40,000 children working daily in the mines of the Democratic Republic of Congo (DRC). The terrible price they will pay for our clean air is ruined health and a likely early death. Almost every big motor manufacturer striving to produce millions of electric vehicles buys its cobalt from the impoverished central African state. It is the world’s biggest producer, with 60 per cent of the planet’s reserves. The cobalt is mined by unregulated labour and transported to Asia where battery manufacturers use it to make their products lighter, longer-lasting and rechargeable.

The planned switch to clean energy vehicles has led to an extraordinary surge in demand. While a smartphone battery uses no more than 10 grams of

refined cobalt, an electric car needs 15kg (33lb). Goldman Sachs, the merchant bank, calls cobalt ‘the new gasoline’ but there are no signs of new wealth in the DRC, where the children haul the rocks brought up from tunnels dug by hand. Adult miners dig up to 600ft below the surface using basic tools, without protective clothing or modern machinery. Sometimes the children are sent down into the narrow makeshift chambers where there is constant danger of collapse. Cobalt is such a health hazard that it has a respiratory disease named after it – cobalt lung, a form of pneumonia which causes coughing and leads to permanent incapacity and even death. Even simply eating vegetables grown in local soil can cause vomiting and diarrhoea, thyroid damage and fatal lung diseases, while birds and fish cannot survive in the area. No one knows quite how many children have died mining cobalt in the Katanga region in the south-east of the country. The UN estimates 80 a year, but many more deaths go unregistered, with the bodies buried in the rubble of collapsed tunnels. Others survive but with chronic diseases which destroy their young lives. Girls as young as ten in the mines are subjected to sexual attacks and many become pregnant.”

Shocking exploitation and racism, all so elite new classers can feel good about the environment, while driving to universities to destroy the world anyway. ***

“China admitted today that it sent 320,000 combat troops to Vietnam to fight against U.S. forces and their South Vietnamese allies. In a report monitored in Hong Kong, the semi-official China News Service said China sent the soldiers to Vietnam during the 1960s and spent over \$20 billion to support Hanoi’s regular North Vietnamese Army and Viet Cong guerrilla units. The disclosure was made a month after military officials in the Soviet Union admitted that a contingent of Soviet advisers in Vietnam took part in combat against U.S. forces and helped shoot down American planes. Moscow had previously denied its troops played a combat role in the war. The agency report cited “The History of the People’s Republic of China,” published by the official State Archives Publishing House, as saying more than 4,000 Chinese soldiers were killed during the war. Fighting finally ended when victorious North Vietnamese tanks battered their way into the grounds of Doc Lap Palace in Saigon on April 30, 1975.

During the war, U.S. intelligence reports said U.S. combat units had found soldiers dressed in Chinese combat gear and wearing Chinese insignia, but Beijing at the time repeatedly denied U.S. allegations that its soldiers were operating in Vietnam.”

from SMH 2017 : TERROR EXERCISE AT SYDNEY'S CENTRAL STATION By Lucy Cormack

As Sydney slept, two armed "offenders" descended on Central Station, where they were met by more than 160 personnel from the NSW Police Force and emergency services. The scene formed part of an exercise through the force's Active Armed Offender training program, conducted between 11pm and 4am overnight to test the co-ordination and response of emergency services to a terrorist incident. Police footage of the exercise, named Exercise Pantograph, showed the offenders clad in skeleton-print face masks and chequered head scarves. Carrying knives and semi-automatic weapons, the "offenders" arrived on the country train platform at Central Station. After boarding the train, they began attacking "commuters" who were positioned in the carriages as hostages throughout the exercise.

With their hands raised on the train windows, the "hostages" created scenes reminiscent of the 2014 Lindt cafe siege.

“While there was no specific threat to the transport sector, this site was chosen because it is a crowded place where numbers of people gather on a predictable basis,” said Commander of the Counter Terrorism and Special Tactics Command, Assistant Commissioner Mark Murdoch. “Recent incidents such as the attack on London Bridge and Borough Market, and the attacks at the Bataclan Theatre in Paris have shown us that armed terrorists can strike anywhere at any time.”

He added that the training exercise was “more dynamic and fluid than regular police firearms training”. During the exercise the “offenders” made a number of references to Islamic State, including carrying the terrorist group's black flag and presenting its one-fingered salute. Acknowledging the Islamist characterisation of the assailants, Assistant Commissioner Murdoch said it was not an attempt to stereotype any part of the community, but merely “reality”. “Domestically and certainly internationally there is no getting away from the fact the profile for terrorism is underpinned by an adherence to extremist Islamic ideology,” he said. “That is just reality, and we've tried to make the scenarios as real as we can

for our responders overnight.” Exercise Pantograph also included personnel from Transport for NSW, Fire & Rescue NSW and Ambulance NSW, and was conducted in and around the train station's tunnels and platforms. In one scene of the footage, a woman lies “bloodied” on the ground, assisted by a general duties police officer, whom Mr Murdoch said was the most likely first responder in such an incident.

“These things happen very, very quickly and largely without warning. The people who overwhelmingly will be those first to respond are our general duties or our transport command police and they need to be prepared.”

Assistant Commissioner Murdoch said the threat of terror in Australia was “probably greater now than it has ever been”, adding that ongoing training for high-risk incidents was vital for emergency services. ***
