## AUSTRALIA'S HYDRA - UNDECLARED, ONE-SIDED CIVIL WAR AGAINST ITSELF By Arnis Luks

I have recently re-read Ivor Benson's booklet "This Age of Conflict" (available in our online library), to assist my understanding of the current state of affairs in Australia. The closure of Holden Motorcar Showrooms signalled the ongoing domination of the New International Economic Order on Australia. The 1975 Lima declaration signed by the then Whitlam government, was implemented under different guise by successive governments - North-South Dialogue, Internationalising of our Economy, Becoming Part of Asia, and more recently the TPP, all an out-working of the same long-term strategy. While these are specifically economic perspectives there are counterparts in other cultural disciplines.

### Politicising of our Once Independent Scientific Institutions

*The 1982 Platform, Constitution and Rules of the ALP, put together under the guiding hands of Neville Wran and Bob McMullan just prior to Bob Hawke's ascent to the prime ministership, listed the following basic objective: "Commitment to and participation in the international democratic socialist movement as represented by the Socialist International..."*

The 1986 appointment, by the then (Labor) Minister for Science Barry Jones, of Mr Neville Wran as chairman of the new corporate-style board of the Commonwealth Scientific And industrial Research Organisation CSIRO marked an entirely new direction of this restructured organisation. Restructuring of our scientific organisation under a dominating CEO has been mirrored at all levels of government and education. Political parties, as a weapon against democracy, have circumvented our parliaments to make them of no effect. The party room decisions are simply ratified by Parliament, under the strong guidance of party-whips.

All government departments require the CSIRO to validate their scientific direction. The Local Government Act, the Climate Change and Greenhouse Emissions Reduction Act, as are all other government departments, provided significant guidance from the politicised CSIRO, pursuing, (as nifty Neville Wran committed the ALP towards the Socialist International) the New International Economic Order - World Government. Compounded on this, our political departments are riddled with activist appointments, including the High Court.

### Falsification of History

The long-standing campaign to denigrate our historical achievements, especially individual acts against our native aboriginal, is thoroughly documented by former communist-party-member Jeff MacDonald in his book "Red Over Black" and the sequel "The Evidence", which records the long-term Communist strategy to break up Australia and establish separate aboriginal nations.

Historical works by such writers as Keith Windshuttle and Prof Alan Frost show that, far from being brutal to an ancient people, historical records show one of widespread fair dealings. Isolated incidents of cruelty were exactly that, isolated.

### **Denigration of our Institutions and Traditions**

Recent media articles further separate us from our rich history of achievements. Well presented by Prof Alan Frost in his work "The First Fleet & Botany Bay", records show the logistical marvel of the preparation and execution of the First Fleet and colonising of Australia.

Upon the arrival of the first Fleet, came the rich cultural heritage of the British Peoples. Common law, habeas corpus, Magna Carta, Blackstone's law books, botanical and other sciences, limited government and the Christian faith all greeted that early colony. The pioneers were greeted with a barren, drought affected land and almost starved were it not for the second Fleet's arrival a year later with fresh supplies. They faced the adversity together, shoulder to shoulder, man and woman alongside each other against the elements to build a nation. Something to truly be proud of.

### **Mass-Media - The Handmaid of Finance**

The appointment of Ita Buttrose to the ABC chair by Conservative PM Morrison, with no change in political direction, is unfortunate. That 'think tanks' or policy institutes (*research institutes which perform research and advocacy concerning topics such as social policy, political strategy, economics, military, technology, and culture*) consistently provide an either/or option is also not helpful. That predatory neoliberalism (monopoly-capitalism), or the dominating socialism (communism going slowly), are the only options to resolve political issues is absurd - a choice of only either/or.

Free-enterprise-capitalism (that everyone can be a capitalist), and that individuals acting in community, (social beings working together) can be held in equilibrium - democratising the economy so all have access to a sufficiency (Douglas social credit), while minimising the totalitarian tendency of bureaucracy and government under a 'limited constitution' becomes an entirely different way of thinking and the correct approach to resolving political issues - both/and.

### **Answer The Call of Freedom**

Australia has lingered for too long at the crossroads of cultural revolution and desperately needs advocates and clear guidance to our rich cultural past. Shall we go back to the beginning, to barbarianism (revolve), or shall we seize our rich cultural heritage and build on from it? The totalitarian model - dominance hierarchy - is the antithesis of what should be.

Recognising that we are at war, Science, History, Religion, Economics, Mass-Media, Politics, Agitation, Culture, Private-Enterprise-Capitalism, are all areas under attack. Knowing that the attack is a hydra means that the response must also be comprehensive.

It goes further than just presenting alternative facts. Doing only these, places the dialectic as the only choices - an either/or option. We must concentrate on both/and resolution. ### **Government Policy and Structure**

Water, being a state jurisdictional matter, should be managed by local and state authorities only, with extra water allocation to be sought between states' initiatives as necessary. Handing power over to Canberra has been a disaster from the start and needs to be reversed.

We do not need a federal government to administer fire policy, but rather replacing those who interfered with the safe management of land clearing and fuel reduction.

The structure of councils needs to be reviewed away from a 'CEO with Mayor' and back to elected and representative 'open' community participation and guidance.

Science as a discipline needs to be removed from the politically active realm and placed back where it belongs - into independent research that is demonstratable.

Climate variability happens all day every day and is not something to be feared, but rather adapted to. The oceans are not rising. Whatever 'is' happening if it is appreciable at all, is at a rate that can be easily accommodated. The argument is all in our heads.

Devolution, placing power back at the feet of the individual to manage his own affairs, must be the long-term objective.

## THE GHOSTS OF ANCIENT HUMANS By Brian Simpson

‘Scientists have found evidence for a mysterious “ghost population” of ancient humans that lived in Africa about half a million years ago and whose genes live on in people today. Traces of the unknown ancestor emerged when researchers analysed genomes from west African populations and found that up to a fifth of their DNA appeared to have come from the missing relatives. Geneticists suspect that the ancestors of modern west Africans interbred with the yet-to-be-discovered archaic humans tens of thousands of years ago, much as ancient Europeans once mated with Neanderthals.

“In the west Africans we looked at, all have ancestry from this unknown archaic population,” said Sriram Sankararaman, a computational biologist who led the research at the University of California in Los Angeles. Unlike today, the world was once home to many related species or subspecies of human. And when they stumbled upon one another, mating was not out of the question. As a result, modern Europeans carry a smattering of Neanderthal genes, while indigenous Australians, Polynesians and Melanesians carry genes

from Denisovans, another group of archaic humans. Previous studies have hinted that other ancient humans once roamed Africa, but without any fossils or DNA to pore over, researchers have struggled to learn more about them... Brett Stevens at Amerika.org has this to say: “Race science has gone mainstream and human biodiversity has come along with it. Most importantly, this new data shatters two things: first, Out-of-Africa is dead, since apparently humans evolved independently in multiple locations. Second, it is clear that one group got ahead of the rest and spread its DNA to all of them, causing genetic backflow resulting in the high internal diversity of African DNA, among other areas. Finally, it seems likely that this group may have bred with proto-human groups, producing these variants in the first place. This suggests more of an Evolian Hyperborean race and its decay in various degrees than the simplistic linear history of humanity originally offered to us. Even more, it prompts people to see that the process of human evolution is still ongoing, with some groups producing high numbers but, being unable to support themselves, threatening to reverse evolution by migrating to areas where the prosperous have set up shop. Evolution works when the favoured escape from the rest and are able to evolve independently, and fails when we try to have one big human happy.’ \*\*\*

## WARMISTS PUT NORFOLK ISLAND ON RATION By Betty Luks

It was ten years ago that Australian journalist Andrew Bolt first warned his readers about ‘carbon rationing’ on Norfolk Island. Who has heard of Technocracy and the idea of a Carbon Currency to replace a Financial system?

The Network of European Technocrats was formed in 2005 as “an autonomous research and social movement that aims to explore and develop both the theory and design of technocracy”.

**The Modern Proposal:** Environment, Global Warming & Energy Certificates : Technocratic concept of Energy Certificates and a Carbon Currency. In 1995, Judith Hanna wrote in *New Scientist*, “Toward a single carbon currency”, “My proposal is to set a global quota for fossil fuel combustion every year, and to share it equally between all the adults in the world.”

In 2004, the prestigious *Harvard International Review* published “A New Currency” and stated: “For those keen to slow global warming, the most effective actions are in the creation of strong national carbon currencies... For scholars and policymakers, the key task is to mine history for guides that are more useful. Global warming is considered an environmental issue, but its best solutions are not to be found in the canon of environmental law. . .

**Carbon Becomes a New Currency**

In 2006, UK Environment Secretary David Miliband spoke to the Audit Commission Annual Lecture and flatly stated, “Imagine a country where carbon becomes a new currency. We carry bankcards that store both pounds and carbon points. When we buy electricity, gas and fuel, we use our carbon points, as well as pounds. To help reduce carbon emissions, the Government would set limits on the amount of carbon that could be used.”

In 2007, *New York Times* published “When Carbon Is Currency” by Hannah Fairfield. She pointedly stated “To build a carbon market, its originators must create a currency of carbon credits that participants can trade.” PointCarbon, a leading global consultancy, is partnered with Bank of New York 'Mellon' to assess rapidly growing carbon markets. In 2008 they published “Towards a Common Carbon Currency: Exploring the prospects for integrated global carbon markets.” This report discusses both environmental and economic efficiency in a similar context as originally seen with Hubbert in 1933.

Finally, on November 9 2009, the *Telegraph* (UK) presented an article “Everyone in Britain could be given a personal ‘carbon allowance.’” “... implementing individual carbon allowances for every person...(next page)

# UNIVERSAL INCOME IN SCOTLAND

“Scotland may adopt a universal basic income scheme that would guarantee a cash payment of up to £150 a week to its citizens for the rest of their lives, Nicola Sturgeon has said. The First Minister said she would fund research into the proposal that would “inform parliament’s thinking for the future”. The system has been championed as a method to do away with the UK’s welfare system, but critics complain that it is complicated and pointed out that many of the handouts overlap. It would see benefits payments such as the dole and housing all rolled into one lump sum. It would not be means-tested and would be given out whether the recipient has a job or not. Advocates say it frees up State workers from assessing individual cases for benefits - such as housing payments and the dole - and that it also eliminates poverty. But critics complain it pushes social policy “in the wrong direction” and the payments encourage people to work less and therefore contribute less in taxes to fund the scheme.”

The above is the standard establishment objection to the universal income schemes, but it is superficial. Social credit would see the “solution” as a mere temporary band aid, that does not deal with fundamental issues requiring financial reform. It would involve people being issued with a unique number which they would hand over when purchasing products that contribute to their carbon footprint, such as fuel, airline tickets and electricity. Like with a bank account, a statement would be sent out each month to help people keep track of what they are using. If their “carbon account” hits zero, they would have to pay to get more credits”.

**Carbon Currencies:** Matt Taibbi in the *Rolling Stone* magazine 5th April 2010 wrote a comprehensive report about Goldman Sachs’ involvement in the new scheme – reminding his readers – “From tech stocks to high gas prices, Goldman Sachs has engineered every major market manipulation since the Great depression – and they’re about to do it again...”
