...Australia's federal government has worked together with McKinsey & Company for two months on a top-secret engagement, remaining tight-lipped on the actual nature of the project...Earlier in 2021 analysis revealed that the federal government had spent \$1.2 billion on consultants in 2020 – the first time in history the annual spending surpassed the \$1 billion milestone, rising from just under \$980 million in 2019 – with the lion's share going to some of the world's biggest firms:

McKinsey, BCG, Accenture and the Big Four...

...The world's seven biggest and most prestigious consulting firms have cashed in on the federal government's economic recovery efforts, collectively scoring over \$1 billion in contracts last year.

Australian federal government spending on consulting services among generally the world's seven biggest firms – the so-called Big Four of Deloitte, PwC, EY and KPMG together with tech-minded professional services giant Accenture and global strategy kings McKinsey & *ON TARGET*

Company and Boston Consulting Group – last year easily eclipsed the \$1 billion dollar mark for the first time, rising from under \$980 million in 2019 to around \$1.2 billion in local tax-payer outlay for 2020.

All in all, the Big Four and Accenture have bagged federal contracts over the past 24 months worth in excess of \$1.4 billion across consulting and professional services, while both McKinsey and BCG have doubled their recent government revenues. This is keeping in mind that such figures relate to federal spending alone (with state consulting budgets also through the roof), and doesn't account for other large consulting firms or engineering and legal advisories such as AECOM and Clayton Utz...

The NATO led regime change in the Ukraine in 2014 triggered Russia to annex the Crimea and hold a referendum to legitimize this strategic manoeuvre. With the recent Russian recognition of the independent republics Donetsk and Lugansk, this became the trigger to circumvent the imminent Ukrainian invasion into the Donbass regions with intervention by Russian military. While this narrative plays out on the world stage the great reset moves further on.

The USA dollar as the single dominant reserve currency for the entire world has thus come to an end. The sanctions imposed on Russia and her oligarchs is not being felt by the average Russian consumer on the street. However, the reverberations are certainly being felt across the once-free West.

The deliberate collapse of Western economies is happening now as British people woke this morning to a 56% increase in the price of gas and electrical energy, with a further 40% increase due in October.

Financially imposed hardship of this level has not been seen since the central banker's created great depression of 1929 that lasted until the outbreak of war. This cost-push inflation will cause massive price-hikes across all basic necessities; food, clothing and shelter. Demand-pull inflation has been the policy of both local

council, state government planning authorities and builders, synchronised with the banks issuing never ending loans for young people to purchase property. Shorting the supply of available land and over-issuing loan funds simultaneously to produce never ending price increases, sometimes as high as 40% per annum in some locations. Alberta Leads The Way Back

In the book *The Alberta Experiment*, CH Douglas identified the party system as subversive against the popular (Douglas) Social Credit movement in the Canadian Province of Alberta. The Canadian Federal Government under Mackenzie King fought the Aberhart Provincial Government every step of the way to circumvent their efforts until Aberhart's untimely death. Ernest Manning took over from William Aberhart as

Premier and the political movement (centred around the party structure) was re-directed away from addressing the flaw in the financial system in favour of orthodox banker's created finance as debt. Manning's subversion of this freedom movement demonstrates the political party model as flawed. The Alberta experiment was not a failure as such, due to the revelation of the money-power dominating all governments and the saturation of corruption within the political party processes.

Freedom begins and ends with the individual, and in association with others (on an agreed policy outcome) can cause a movement to achieve effective expression without being taken over by subversives e.g. freedom of choice with the job.
