## UNRAVELLING TO REVEAL THE TRUTH By Arnis Luks

In an *IPA* article August 2022 'Undoing Australia' by Brianna McKee <https://ipa.org.au/ipa-today/undoing-australia> she records the policy of the University of Melbourne to 'unlearn our national culture' that would deconstruct the nation of Australia. To essentially erase from the public mind our cultural inheritance with all the marvellous feats which preceded the 1788 colonising and thereafter. In Brianna McKee's words 'The University of Melbourne's plan to 'Undo Australia' is a self-destructive, disingenuous and fails to recognise the great achievements of this country. Australia would be better served by its oldest and most prestigious institutions of higher learning if they focused on building up rather than tearing down this nation.'

Another important point of consideration is to realise that this Quick and Garran Annotation is not a legally binding document that can be brought before the courts. Government websites give you the most current version of Acts being placed under consideration in our courts. Quick and Garran recorded the procession of legislation, from the initial penal colonies ruled by a Governor, to the desire for devolution, the separation of the varying colonies into differing states. The desire for devolution

occurred before the desire for unifying under one Commonwealth. Western Australia was only Constituted as a State immediately prior to the 1890s Constitutional Conventions. This interesting phenomenon of devolution preceding in order to unify: 'WHEREAS the people of New South Wales, Victoria, South Australia, Queensland, and Tasmania, humbly relying on the blessing of Almighty God, have agreed to unite in one indissoluble Federal Commonwealth under the Crown of the United Kingdom of Great Britain and Ireland, and under the Constitution hereby established'. The Crown and the Constitution are inseparable.

Iain Davis has produced another timely article, this time on these privately owned corporations called central-banks. Most people would not believe that the issuing of each national currency is achieved from a private monopoly. Most could not fathom the implications of absolute power that this arrangement fosters. It is almost beyond belief, but is true, nonetheless.

Keynes, von Mises, Marx and Engels, the London School of Economics and Political Science will never discuss this matter of great import to the degree that the ramification of this centralised power is misunderstood. And yet each of these separate entities are held in significant esteem as a source of profound knowledge in their area of expertise. The power of central banks to control the creation of new money as 'irredeemable debt' is an untouchable area that must never be discussed, and yet it affects every single individual, every community and every nation-state.

This untouchable area was identified as the source of our many ills more than 100 years ago by CH Douglas. Creating money, in the form of an irredeemable debt, in the modern expression, has been enabled since the late 1600s, but in particular in the English form with the establishment of the 'Private Bank of England Corporation' 1694. ### **COMPARISONS ARE ODIIOUS - BUT NECESSARY By Jeremy Lee**

The spontaneous response of ordinary people to those affected by the tsunami has been magnificent, and goes some way to restoring one's faith in human nature. The tragedy was non-political and not embellished with 'spin'.

As the death toll has mounted from first reports to totals round 150,000, as the scenes of devastated towns and communities have impacted through the media, the human heart has opened with warmth and sympathy. Politicians have been left struggling in the wake of personal generosity. Helicopters, instead of dealing destruction, have delivered food and water. Battleships and destroyers have sailed in to help, not pulverize.

For one brief moment, swords have been turned into ploughshares. The peoples and nations of the world have come together to meet a natural disaster.

Yet the massive death toll is nowhere near that of the two wars and the intervening sanctions in Iraq -- let alone the inclusion of Afghanistan and the Palestinian territories. There, the same helicopters have destroyed homes, obliterated water and electricity systems and left the same corpses littering the streets. The civilian death toll in Iraq - the women and children - is estimated at over 100,000, although no-one bothers to count. The gulf between the attitudes of politicians and ordinary people has never been greater.

The last great expression of the feelings of ordinary people came when Bush, Blair and Howard decided that war in Iraq was the way to go. The biggest and most spontaneous demonstrations in favour of peace that the world had ever seen failed to prevent the holocaust that has unfolded since. \*\*\*
