Israeli officials believe Hamas did not have advanced knowledge of the Nova music festival

An Israeli military helicopter fired and "hit" attendees of the Nova music festival in southern Israel during the Hamas attack on October 7, *Haaretz* reported on Saturday, citing a police investigation of the incident.

The report reads: "According to a police source, the investigation also indicates that an IDF combat helicopter that arrived to the scene and fired at terrorists there apparently also hit some festival participants."

The police investigation also found that it's unlikely the Hamas fighters who attacked Israel had knowledge that the music festival was taking place and decided to attack it spontaneously. Bolstering the case is the fact that the festival was originally scheduled to take place on Thursday and Friday and was only approved to continue into Saturday, Oct 7, earlier that week.

## THE BALFOUR DECLARATION AND ITS CONSEQUENCES By Arnis Luks

In an age of universal deception, those things which are readily spoken are easily discounted and ignored. A man or woman's word is no longer their bond or responsibility. Emotions drive our thoughts instead of the facts on the ground. I look at the false flag that has occurred in Palestine as an example of the misuse of words to promote this emotion, rather than reason.

The Balfour Declaration imposed this invasion on the middle east and those in this area have suffered ever since. If this is ever to end then a solution must be sought out and implemented, including, a two state solution.

I don't believe in a chosen people, but rather those that obey and implement God's will on earth as in heaven. Some of the folk I know believe in the British-Israel (BI) line of thinking as the bedrock of their greater personal responsibility required from English speaking peoples. This bedrock is that we English speaking peoples must pursue the good, (being in front of the rest of the world to lead), that is by incarnating on earth as in heaven. I personally don't adhere to this BI point of view, but I certainly do acknowledge that *'he who has ears to hear, let him hear'*. The Holy Spirit has been my guide whenever I have allowed my ears to hear. Jeremy Lee personally wrote out my 'commission' some 20+ years ago, of which I still hold a copy from the original. This position of service has changed dynamics many times across the years but remains a position of service.

***He who would be greatest must be least of all.***

Wise words indeed, in fact even profound. Not surprising coming from the mouth of the Christ.

In my travels I meet all sorts of people of various political and a-political persuasions, apart from the vagaries of differing denominations and religions. In this cross pollination of points of view, I recognise that nearly all, certainly greater than 95% of all peoples find it difficult, or are indifferent, to deciphering what is going on in the world. It is to that portion of that remaining 5% who may have ears to hear that I direct my efforts. It is they, exercising their free will, who will bring about the necessary changes to the fate of the world. The barren fig tree will produce the necessary fruit in and out of season. In amongst that remaining 5%, of course is the enemy.

Our leaders, who hold no loyalty towards us nor Godly things, use emotions to manipulate the narrative - propaganda in order to control. In fact, many are 'marrona' – false marionettes actively working for the enemy. The Tavistock Institute was created for this purpose. Sigmund Freud and his nephew Edward

Bernays have been past masters of mind manipulation. Generally, the public don't even know what to believe or how to decipher truth from fabrication.

The political 'do gooder' is the master at manipulating the crowd through emotions. The 'ought to be' perspective is a denial of the nature of reality - the way things actually are. The seeker of Truth pursues the way things are in order to stand-under, understand them and obey those laws which are beyond human thinking. The greatest conceit a man can do is to think he is god and this is how things 'ought to be'.

The most practical people are those that must engage with the real world every day. The farmer 'observes' the ebb and flow of the seasons and adjusts his approach accordingly. Here we are the third week of November and Summer is hardly approaching. I've experienced the grain crops browning off as early as mid-October, some five weeks earlier than is occurring today. In confidence I can predict that we will experience another coolish below-average summer. The propaganda wing of the Bureau of Meteorology may say differently. Reality shows that I am closer to the mark.

Being away from the city-asphalt-and-concrete-jungles, I can see that the paddocks are still green and in most areas the growth is exceptional. I observe the nature of reality and adjust my thinking accordingly. Talking with city folk who spend a good deal of time in front of the box they may think differently.

Cherry harvest is imminent - now. We normally celebrate Christmas, being five weeks away, with a huge harvest of cherries. The river-red-gums' flowering has also begun. This is generally the most significant source of nectar for our bees and reinforces a plentiful harvest for this season.

Last season we achieved no harvest at all, which was the first in my limited bee-keeping experience. Fortunately, we listened to an 80-year-old experienced farmer-and-beekeeper who pre-warned us last season that there would be no harvest and therefore don't expose the bees to any duress. We accepted that advice and protected our swarms.

Entering into this new honey-harvest-season, nearly every swarm was in optimum condition. If we hadn't considered these observations of the natural world being interpreted by an experienced bee-keeper, the general bee-keeping rules would have dictated that we do harvest and therefore hurt our swarms. This demonstrates observable husbandry and stewardship of the natural world to be superior. Likewise, additions of NPK - Superphosphate, and high nitrogen Urea to the soil kills the worms. What does this tell you? This approach is a brutalising of land and creature-management for production of food that is definitely of reduced life-giving-nourishment.

In a telling moment one ALOR National Weekend, Jeremy Lee made the extraordinary but quite simple remark that we are to look at how the course of events affects the individual, in order to decipher most narratives. If a policy harms even-one-person, the policy must be reviewed. The policy, in fact all policies are to serve the individual. This is the foundation of Western Christian Thinking that has under-girded our Modern Civilisation.

Bureaucrats are called 'public servants' for the very reason they exist to serve the individual. They are not to be misnamed commi-czars, but public servants. As we move further into this dark ages it is this thinking that must be re-discovered and implemented by putting into practice every day. When we look at the CEO of local corporations (formerly regional councils), accompanied predominantly by the mayor, we must respect their position but insist that they remain public servants and not totalitarian masters. It is they whom we must first target in our efforts to restore order and Godly structure in our civic affairs. Being an advocate for every individual is far superior to the libertarian perspective of policy to serve the monopolists who get their way. This policy-objective ensures they are the only recipients.

The Palestinian people are given no voice in the West. Only two voices reign supreme, that of the Zionist-created-Hamas, and the administration of the Zionists may speak. The Jewish people, like the Palestinians are simply fodder for the overall policy. How does this affect

An absence of something can be infuriating. You know you need it and you can cope without it for a short time, but you usually put it on the shopping list.

Then there is a Void. Something that you didn't know was there or know may have been there, but you cannot realise the full impact of its disappearance until you need it to make sense of an outcome or an in-depth study.

Jon Turk put it very well in his travel/adventure book, *Cold Oceans (ISBN 0-06-095325-x)*. Jon is paddling a kayak through the Magellan Straights and is talking of the Yamuna Indians who once lived there.

“They left no permanent physical mark on the land, no bent grasses where they slept, no stick and leaf shelters, no paintings of naked bodies snuggling warmly together against the icy rain.”

“The only remnant is a void. Voids are hard to see at first. We are not trained to look for them, but once they appear they glare like neon.”

A fabulous book, I find this part particularly grabbed my attention, so much so that I wrote it down in my journal, along with some notes about the Voids I too might be missing. I pondered on it for quite a time as it was not just a physical absence he was talking about, but a

the individual? It destroys their homes, their meagre infrastructure, and their future. It is vital to think on these things to decipher the truth from fabrication.

Back to our own nation, it has been written many times about the manipulation of our Aboriginals for the furtherance of specific policy - to break up Australia. Our elites are pursuing an identical methodology as the Zionist-elites controlling Israel. Observing this phenomenon is not anti-Semitic nor anti-Aboriginal at all, but rather anti-totalitarian.

spiritual or conceptual absence also.

I recently went on a cave tour: Solomons Caves near Chudbury in Tasmania. It was here that I remembered Jon's words. Our excellent guide, Aaron, was lamenting the loss of the bones of animals that had fallen in via the original sink hole. They were cleared out in the very early years of the 1900s to make a more pleasant experience for visitors. There was no accurate record of where they went, or what they were. The disturbed dirt and rock that was moved aside, was also not categorised with any real detail. To sift through this detritus now would be interesting but would not provide a datable timeline. This absence was one of record keeping and could never be fully recovered. Only conjecture remained.

### Why am I rambling on about this?

The void of good decision making on a national basis is also hard to see, until such time as its effects are hard to miss. At that point it becomes, as Jon pointed out, like a neon glare.

In 1975, the government, under Whitlam, signed the United Nations Lima Declaration.

It was through this, that all governments moving forward, have sold out Australian Industries and workers, by specifically agreeing to transfer manufacturing to Third World countries, supposedly to help them develop.

Almost all trade agreements since then have been to the detriment of Australians, to the point now, where even the simple things we used to make are only manufactured overseas.

Global corporations have been the only real benefactors in this race to move offshore and we are still reeling from it. A policy, that I stress, all major parties have agreed on.

This Void of responsible management for our own nation's industries in favour of multinational industries and thereby no commitment to Australians, has become so obvious now we almost expect it. The argument that free-trade agreements would help boost economic and job growth in Australia, (its original claim) can clearly be seen to have had the opposite effect.

A friend spoke to me of a meeting with his local politician where he asked about the Lima Declaration and its existence, he was promptly called an anti- Semite. What prompted this outburst could only be seen in one of two ways. He had been told to squash any mention of it, or he knew of it and wished to deflect any discussion for fear of embarrassment.

Either way that illustrates to my mind he is unsuitable for the job as a representative.

Unlike the detritus from the cave, the poor, or shall I say purposely flawed decision making of the past, is indeed well documented. Parliamentary Hansard, the record of voting on all government decisions, will give an accurate record of who allowed these policies to be enacted. Other records, within the bureaucracy, are also available to be examined to help flesh out the details. We can recreate a timeline for this descent into scarcity amid plenty, where the mistakes were made and who was primarily responsible for it at the time.

On the odd occasion when we do get an answer to an enquiry into something suspicious, much is said, but little is done. Following through we find many of these mistakes are often repeated. The perpetrators, I often like to respell that word, Perpe-traitors, for that is in reality what many are, have sold our countries prosperity for a mess of pottage for themselves, leaving behind a trail of destruction while advancing themselves forward into the very groups that benefit from it.

As a nation we expect to advance, to move forward towards better lives and outcomes. Our knowledge of the world increases with each passing year, our understanding of the social condition, our ability to produce efficiently with less labour input, all moves us forward.

It is within our ability to make sure we all benefit from this advancement. So that our civilisation actually profits from it- not in a financial sense, but in more

realistic, material terms. Hunger, housing and health should show a definite improvement over time. Quite the opposite appears to be the case.

Our homeless, our poor, our underfed and our sick, waiting for a broken hospital system, are the light-bulbs by which we can measure the intensity of that glare.

We are going backward and if I sound sour, it is because I am.

Trust is something to be earned. The person who visits my workplace to shake my hand and campaign for election, with promises of a better outcome, must live up to their word before that trust is given. The voting outcomes for all parliamentary decisions should be listed in neon, on the windows of their campaign offices, nay, all town notice boards in their electorate. Maybe then accountability might be achieved.
