# Will Master War Criminals Be Overlooked?

# **War Atrocities Not Whole Story**

(A letter to the Editor from Bruce H. Brown.)

Sir, —One of the least recognised calamities of war is the inability of the great bulk of the people to be rational. Their feelings and attitudes are dictated and controlled, firstly by the closeness of their own personal connection with the actual fighting, and secondly, by carefully prepared statements circulated in a publicity field made exclusive by censorship and military controls.

Many of those who have, endeavoured to be realistic through all the vicissitudes of the war period have had difficulties placed in their way-although no one has yet found the means to deprive us of the secrecy of our own minds. Frequently it was necessary to withhold appropriate comment on current happenings, because to have done otherwise might have brought one into conflict with uninformed men temporarily clothed with power far beyond their personal worthiness.

Apart from these conditions, it is only to be expected that all of us have been terribly shocked by the newspaper reports of the atrocities inflicted upon our men and women by members of the Japanese armed forces. These reports have been substantiated to a large extent by the findings of the inquiry conducted by Mr. Justice Webb.

For floggings, death parades, and torture of all kinds suffered by our gallant men and nurses there can be no excuse, and any person properly convicted of such crimes should be brought fully to account in accordance with civilised standards.

That, I believe, is the intention of General MacArthur and Lord Louis Mountbatten, and in pursuing this course they are sure to have the support and approbation of all men and women who have not succumbed to war hysteria and journalistic mesmerism. As for the attitude that the only good Jap is a dead one, and that the whole Japanese race is a blot on the earth, that, of course, is not a new idea. It is very easy to speak that way of our military enemities and many persons generally do enemies, and many persons generally do so. The Italians were our gallant and heroic allies in the First World War; but this time they were, at best, merely poor weak things from the soft under-belly of Europe. In the first world-war the Japanese were our faithful allies, and were specially

thanked for the assistance they gave us; but in this war they have been described as a lot of arrogant mountebanks pretending to bring prosperity to the people of East Asia when all the time they were seeking world domination through unspeakable treachery and bestiality.

This sort of talk is invariably associated with military campaigns and is part of the plan to stir up our emotions and generate hatred—but not against the master crooks

Because of the frightful treatment to which some of our kith and kin have been subjected we are asked to regard all the Japanese people as individually responsible.

If all the Japanese people are to be held guilty for the war atrocities committed by individual members of their armed forces, then all the Australian people should be held guilty for the acts of misconduct on the part of a few members of our own

I do not accept any responsibility for conditions in certain Australian military camps, but strongly feel that if published reports be true those who were responsible should be brought speedily and effectively to ac-

As an Australian citizen I also decline to accept responsibility for the improper

arrest end mistreatment of certain persons allegedly connected with the Australia First Movement; but, although I have no interest in that Movement and know none of those connected with it, I strongly feel that the men who were guilty of such infamous conduct should be brought to public

In the same way, the people of England could hardly be held guilty for the arrest and imprisonment, without charge or trial, of a loyal member of the British House of Commons (he has since resumed his parliamentary duties!); but if they knew the facts they would probably demand the apprehension and punishment of those who were responsible for that infamous action.

This leads me to the pictures, which have recently appeared in the daily press showing members of the Allied Forces in a condition of appalling malnutrition, caused by neglect as well as insufficient food. Here again, for inexcusable neglect there should be appropriate disciplinary action, and for the deliberate withholding of food the responsible persons should be suitably dealt

But we must be careful not to allow our sentiments to be prostituted in the interests of the initiators of war, for the purpose of

diverting attention from themselves.

These fellows, it should be remembered, control the international press, and the similarity of the reports in the various newspapers suggest at least a co-ordinated

After the First World War there was a carefully organised campaign to engender and foster hatred against the German peo-

and toster hatred against the German people, and a British election was actually won on the "Hang the Kaiser" slogan.

While this was going on the master criminals escaped notice, and were thus permitted to go on with their nefarious work without the general public even suspecting the truth of what they were

A lot of attention is being focused on Hirohito and the sufferings imposed by his

men, but none at all on the fellows who brought about the conditions which put Hirohito and his war lords in the position, to launch the attack on Pearl Harbour.

On Tuesday, September 25, I listened to Air Vice-Marshal Jones giving a lunch-hour address at the Victoria Coffee Palace in Melbourne on the subject of his recent visit to Japan in connection with the signing of the Document of Surrender. He said ning of the Document of Surrender. He said clearly and definitely that in his judgment one of the main reasons for the unexpected collapse of the Japanese Empire was the fact that the POPULATION OF JAPAN was on the verge of actual starvation. He also said that he took the opportunity to visit some of the country areas in Japan, and that during his journaging the only and that during his journeying the only animal he saw was one goat. Not even a cat or a dog! He assumed they had all been eaten as food. That surely is a grim testimony to the effectiveness of our own blockade, and suggests to me that there is reason to be thankful that so many of our man own out of lapsage will as they did men came out of Japan as well as they did from the point of view of nourishment. It also suggests to me that more credit for the actual collapse should be given to the courageous and effective work of our naval men, especially those serving in submarines, and less credit to the atomic bomb.

War itself is a series of atrocities, and when we have punished the persons who actually did things, or authorised them to be done, contrary to the accented rules of warfare, we still have the more important duty of identifying and punishing the men actually responsible for bringing wars about, and on this question I hope to say more next week.

next week.

In the meantime, please give thought to the significance of the fact that strenuous efforts were made throughout the war period to prevent open discussion of two very important subjects—the financial system and World Jewry.

SICKNESS SNOOPERS: It is pleasing to note that some other weekly papers are publishing the Gestapo clauses of the so-called Sickness and Unemployment Benefits Act. "Smith's Weekly" for September 15 deals with this matter and points out that "under it a government clerk may be empowered to hale all and sundry before him and demand information—just as they used to do in Hitler Germany," The article then asks if this is the New Order for which Australians have fought and died. The same issue of "Smith's" also reminds us that a part of the Australian Gestapo known as "The Reporting Officers' Organisation," is still functioning although the war is over. The article then calls for the destroying of all files and dossiers compiled by these unpaid spies. It is worth noting that "Intelligence" headquarters loudly lamented the disclosure of this Gestapo.

RAPID RISES: During the recent 24-hours' railway strike the "capitalist" press allotted considerable space to the rapid rise of Mr. J. J. Brown, State Secretary and General President of the Australian Railways Union. Experience has shown that rapid rises in certain fields, including Unionism, are usually suspicious signs, especially if accompanied by press boost. An examination of Mr. Brown's career fails to disclose any performance of note, but it does disclose that he helped the Communist Party by addressing meetings on behalf of Communist candidates during the State Parliamentary elections. It seems odd that helping the workers' enemy—the Communist Party workers' enemy—the Communist Party—is the only explanation for his rapid rise. By the way, the 24-hours' strike was foisted on the workers by the Communist executive.

# THE CASE OF HARLEY MATTHEWS

By J. T. LANG, in Sydney "CENTURY," September 21.

Now that the blanket of wartime censorship has lifted, it is possible to tell the story of Harley Matthews. It proves It Can Happen Here. It is another angle on Communist methods. It shows how militarism acts. It is a damning indictment of the Government.

In 1915 Harley Matthews was an original Anzac. World-famous sculptor Epstein used him as his model for "The Spirit of Anzac." Soon after the war he gave up journalism and bought a vineyard at Moorebank, near Liverpool. There he made wine and wrote distinguished Australian poetry for 20 years.

Then in the early hours of the morning of March 10, 1942, the "Spirit of Anzac" was seized by Army Intelligence officers and interned at Liverpool. He was accused of belonging to the Australia First Movement. He denied it. He had never attended any meeting. He did not agree with its platform. All he had done was to write something for its paper, "The Publicist." Still, in he went, leaving his vineyard and his 74-year-old mother.

Later that day, in Canberra, Army Minister Forde told the world a melodramatic story of a plot by the Australia First Movement to assassinate him and other Ministers. Prime Minister Curtin refused to divulge the names of those arrested until charges had been laid.

But the Communists had all the inside information. They published the full list of names, including that of Matthews. Where did they get the information? Who were the informers?

Matthews immediately wrote to the Prime Minister demanding to know who had given the Communists his name, and reminding him of his promise. He again emphasised that he had a market that he had a mar that he had never at any time been a member of the Australia First Movement. He asked that charges be laid. He received

The only reason he could think of why he was being treated in such a manner was that he had always been a supporter of the Labor Party. He wrote to his local member, H. P. Lazzrrini: "A sister of my mother's has sent me word to say that she knew I would come to a bad end if I kept

on voting for the Labor Party. I used to think my Aunt had no political sense, but today I am not so sure."

Meanwhile his vineyard was going to rack and ruin. His stocks were looted. The crop rotted on the vine; 20 years' hard work. But still no charges. No one in the internment camp can tell him why he is in Letters to Ministers are ignored.

in. Letters to Ministers are ignored.

For six months the "Spirit of Anzac" languished in the internment camp. Meanwhile the shock had been too much for his aged mother. She died in August, and Matthews requested the Minister for the Army to permit him to attend the funeral

Two days later—on the morning of the funeral—the Camp Commandant still had no word that permission had been granted. Eventually, he was permitted to attend un-

Matthews refused to sign a document granting him provisional release. He repeatedly asked that charges be formulated. Eventually he was released without a trial. Then came the Royal Commission presided

over by Mr. Justice Clyne. His finding in the Harley Matthews case reads: "Intelligence officers committed a grave blunder in procuring Matthews' arrest and recommending his detention. He served with distinction in the last war and was a loyal subject. Was not a member of the Australia First Movement." The article in the. "Publicist" was not in any way prejudicial way way the control of the co dicial to Matthews, stated Mr. Justice Clyne. He also recommended that the Common-wealth pay Matthews the sum of £700 as

compensation.

But can there be adequate compensation in such a case? Nothing can compensate him for the mental anguish, the loss of his aged mother, the charge of subversion in

Nothing can exonerate the Commonwealth Government, which failed to make adequate inquiries into the evidence on which Mili-

tary Intelligence acted.

If it is possible for Mr. Justice Clyne to give direct finding that Matthews was never a member of the Australia First Move-ment why was that not admitted in 1942?

For three years Matthews had to live under a dark shadow. He was financially ruined. Now he is being offered a paltry £700 as compensation without a word of

regret from those responsible.

In another case, Martin Watts, the finding was that he was at all times a loyal subject, who had won the Military Medal.

He was released in August 1942, but died in July 1944. It is suggested that the Government should pay his widow £400.

It would be well, indeed, if future Australian history books told the story of what happened to the "Spirit of Anzac" in the war of 1939-45.

# UNDERMINING OF THE STATES' RIGHTS **Use of Canberra's External Affairs Power**

Use of Canberra's External Affairs Power Hereunder we continue publication of the Full text of the important speech by the Hon. R. J. Rudall, M.L.C., Minister of Lands, delivered in the South Australian Legislative Council on July 31, 1945, as reported by "Hansard": -

I do not think I exaggerate the position by saying that the High Court in its original attitude to the Constitution Act did not treat attitude to the Constitution Act did not treat it as an ordinary Parliamentary enactment, but brought to its interpretation a full consciousness of its position as the constitutional arbiter between the Commonwealth and the States, and deliberately refused to accept a position whereby the powers of the States should be merely that residue left after the fullest possible limits of interpretation had been given to the powers of the Commonwealth as set out more particularly in Sections 51 and 52 of the Constitution. the Constitution.

I may be pardoned the presumption of saying that I believe in this method of approach they were acting as it was believed they would act, not only by the framers of the Constitution, but by the voters in the States with whose approval the Constitu-

tion Act was passed.

It must have been obvious to everyone that, notwithstanding the tremendous efforts of the framers of the Constitution, grave questions must arise in its interpretation, and I have not the slightest doubt that it was felt that the High Court, in its interpretation, would pay full and proper attention to the federal nature of the Act, and would have due regard to what I may call the underlying purpose of the Act, apart from its strict legal interpretation.

This old method of approach was strongly attacked by Justice Isaacs, and with the death of the original members, the views of Justice Isaacs prevailed in the Engineers' Case in 1920.

In that case, the present method of ap-

In that case, the present method of approach received full judicial approval, and from that year these Sections, 51 and 52, which contain the powers of the Commonwealth, have been given their full meaning, limited only by the express provisions of the Constitution Act, but with the old principle of implied prohibition, or a prohibition implied by the federal nature of the Constitution, entirely discarded.

So far as the powers of the States are

So far as the powers of the States are concerned the effect has been disastrous. The powers of the Commonwealth have been given the fullest expression, not only to narrow the exclusive powers of the States within ever-shrinking boundaries, but even to destroy the States' powers of taxation without which the free exercise

of their other powers becomes impossible.

Let me sum up what I consider the general effect of the judgments in the Goya Henry case:

1. It is perfectly clear that the view of Professor Harrison Moore is wrong and that, although a subject matter may be in itself purely domestic and therefore within the exclusive powers of the States, it may nevertheless be brought within the legislating competence of the legislative competence of the Commonwealth Parliament under the external legislative affairs power.

2. That, subject only to the general limitations imposed in the Constitution itself, the external affairs power covers any subject matter indisputably international in character

That beyond this, the Chief Justice and Justice Starke and Justice Dixon did not venture, but were of opinion that it was impossible to lay down at present the exact limits of the power and that such limits could only be ascertained authoritatively by

could only be ascertained authoritatively by a course of decision.

4. That Justice Evatt and Justice McTiernan were quite definite in their opinion that, subject to the limitations mentioned above, immediately any subject matter becomes the subject of a treaty, etc., it automatically becomes a subject matter upon which the Commonwealth can legislate, Now all this has been extremely dull, but

Now all this has been extremely dull, but it is nevertheless vital because, if the view of Justice Evatt and Justice McTiernan ultimately prevails, the consequences so far as State powers are concerned may well be disastrous.

the opinions expressed in their judgment prevail, the possibility of some startling innovations present themselves and a tre-mendous potential danger so far as the powers of the States are concerned is im-mediately apparent.

We have all been interested in the recent conference at San Francisco and the cent conference at San Francisco and the enormous consequences, which their decisions mean for the world. I wish to draw your particular attention to Articles 55 and 56, which form part of Chapter 9 of the Charter of the United Nations under the heading, "International Economic and Social Cooperation." The Articles read as follow:

"Article 55.—With a view to the creation of the conditions of stability and well-being

of the conditions of stability and well-being necessary for peaceful and friendly relations among the nations, based on respect for the principles of equal rights and the self-determination of the peoples, the United Nations shall prosecute higher standards of living, full employment and conditions of economic and social progress, and the development of solutions of international economic, social, health, and related problems and international cultural and educational co-operation and universal respect for the observance of human rights and fundamen-

observance of numan rights and fundamental freedoms for all, without distinction of race, sex, language, or religion."

"Article 56.—All members pledge themselves to take joint and separate action, in construction with the construction of the service of the ser operation with the organisation, for the achievement of those purposes."

I understand from press comments that

I have read on the matter that Dr. Evatt was very much concerned with the drafting of Article 55, and that certain of the subject matters mentioned were inserted in the document by reason of his persistent argument. We have all read how jubilant he was with the insertion of the term "full employment.

It may, of course, be argued that the wider the solution that can be found with regard to these matters the better it will be for the future peace of the world, although it is difficult to understand how in its domestic policy any nation would not be concerned with these matters from the point of view of the happiness and pros-perity of their own people. The mere inclusion of these matters in

the Charter can in no way in itself secure their attainment, but at the same time it is obvious that it would be difficult to re-fuse their insertion even if they meant nothing more than a pious hope. In the light of the judgments which I have read their insertion may mean much more than a pious phrase so far as the States are concerned.

I have not the slightest doubt that the principles enunciated by Dr. Evatt as Justice Evatt have not been forgotten by Dr. Evatt as the Minister for External Affairs.

As the Attorney General he led the recent Referendum campaign on behalf of the Labor Party. He did this in various and devious ways at the expense of the tax-payer under the heading of "Post-war Education," to which the Auditor-General of the Commonwealth has very properly taken exception.

His attempt failed and the Referendum proposals were rejected. I do not forget, however, that Dr. Evatt himself regarded nowever, that Dr. Evatt nimself regarded the most important subject matter of the list submitted to the people to be "employment and unemployment"—a phrase so farreaching in its implications that it is almost impossible to define its boundaries. I do not, however, trust Dr. Evatt to be content with the verdict of the people of content with the verdict of the people of Australia. In spite of that verdict, I have little doubt that, having failed to introduce that subject matter into the Constitution of Australia by the front door, he is now endeavouring to introduce it by the back door. I ask Dr. Evatt this plain simple question: "If the Commonwealth binds itself by treaty to promote 'full employment,' does he not consider that the Commonwealth would have full power of legislation to carry out the treaty?"

I warn the members of this Parliament and the people of this State that we must be on our guard against any attempt by be on our guard against any attempt by the exercise of this treaty-making power and its subsequent implementation by Com-monwealth legislation to whittle away the legislative powers of this State, The amendment of our Commonwealth Consti-tution and the increased powers so often sought and so often refused would no longer rest under the sanction of the referendum provisions of the Constitution.

It would be accomplished under the guise of a convenient convention with another country to whom the particular paragraphs embodied in it may have little significance, but which could then be used to by-pass and destroy the protection of the referendum provisions and leave to the States only such dregs of power as this Commonwealth octopus does not desire to draw within itself.

draw within itself.

I can only hope that I have been able to make the position plain to Members, and that not only this State, but other States, will keep an ever-watchful eye on those developments which I believe only an unjustifiable optimism would not anticipate. I regret that speaking on this sub-ject has imposed a tremendous burden on the patience of Members, but I wanted to put before the Chamber as plainly as I could just what was involved. I make no apology for doing so, although I realise how much it must have wearied Members how much it must have wearied Members to listen. I beg them to study the matter I have dealt with at such length, because I am perfectly satisfied it is of extreme importance to the States and that we are facing a position that we must carefully watch. Unless it is watched and proper procedure is adopted at the psychological moment we may find that under this external affairs power an attempt will be made under which there will be a tremendous alteration which there will be a tremendous alteration in the State's powers, and what we think can only be done by Referendum will be done by means of the treaty-making powers of the Commonwealth.

# FALLACY OF AUTOMATIC PROGRESS

No fallacy is more dangerous or more widespread than the theory of automatic and continuous progress as the result of the mere lapse of time, and it is easy to see why the Powers behind Revolution seized upon Darwin and canonised him.

The truth, of course, is contained in the words, "Seek, and ye shall find; ask, and ye shall receive." During the nineteenth and twentieth centuries, we have been seeking a particular type of knowledge (machine-tool politics), which we dignify by the name of Science, to the exclusion of a much more important gift Wisdom; and a much more important gift, Wisdom; and we have received what we asked for, and we are where we have arrived by the aid of "Science" without Wisdom.

An excellent instance of the type of thinking to which this situation gives rise is contained in a review by Mr. Stuart Chase of Dr. von Hayek's book, "The Road to Serfdom."

as the writer of these notes would be to criticise a treatise on the Massoretic Points, but he has a not unearned reputation for popularising current economic ideas, and Dr. von Hayek is a dangerous menace to the kind of "progress" favoured by "The Nation" (New York), in which the review appears. For some reason, which is contained in the intentions of the Powers rather than in the rules of Logic, "progress," in these quarters, is always to the Left.

We are not concerned with Mr. Chase's arguments, which, without our in the least intending to be offensive, are more suited to a lunch-hour political meeting in a steel to a lunch-nour political meeting in a steel works than to a serious review. The point we wish to make is sufficiently explicit in the title. "Back to Grandfather," and the paragraph, "Technocracy, however, jumped us a century forward, while Vienna [Dr. von Hayek] jumps us a century back."

You see? Grandfather was a fool, and Vienna was vastly inferior to Pittsburg! The millennium starts tomorrow with the Managerial State!

Now the first consideration (which is Now the first consideration (which is nearly always ignored) in assessing the truth of this idea is that THE PROGRESS OF THE INDUSTRIAL ARTS CANNOT BE SEPARATED FROM THE SOCIAL UNREST WHICH HAS ACCOMPANIED IT. On the economic plane, it is producer-control, not consumer-demand, which has been dominant, and Mr. Chase, and the planners for whom he speaks, would make producer-

control absolute. (His line of country reminds us of the reason for Mr. Hartley Withers's serious investigation of the finanwithers's serious investigation of the financial proposals associated with Social Credit:
"I thought they were merely one more currency lunacy. But I read the criticism of the Editor of "The Times' Trade Supplement on them, and I thought that if that was the best case that could be made against them. I had better look into them.")

If this consideration he kent steadily in

If this consideration be kept steadily in mind, it is incontestable that, with the greater material available, we have failed far more egregiously than grandfather. The area of unrest is far greater than it has area of unrest is far greater than it has ever been in history, and it is in the relics of "grandfather" that the homeless are housed, while the heirs of the ages try to build a few tin-can shelters from the storm.

Mr. Chase's review, however, brings into relief the most vulnerable statement in Dr. von Hayek's book, and, at the same time, his own failure to grasp the position. Quoting "Whoever talks about potential plenty is either dishonest or does not know what he is talking about.... It is this false hope as much as anything else which drives us along the road to planning," he remarks (and so have we remarked in effect). "Frankly this shocks me." And then gives his whole case away by quoting the potential plenty in terms of billions of dollars worth of tanks and tractors!

If there is no other way of avoiding the increasing plenty of billions' worth of tanks and tractors except "Planning"—then the Planners win.

But if it be observed that "only in war

or under threat of war" will a sane people submit to large-scale planning, because they notice that instead of houses they get tanks and guns, while at the same time any common sense which remains assures them that grandfather had the money and wanted a house, he got a house without any trouble

whatever—then the Planners lose.

Both Mr. Chase and, to a less degree,
Dr. von' Hayek, ought to be able to see
where their intelligence fails them. It is in ignoring completely the primacy of the location of effective demand. It is perhaps superfluous to remark that Mr. Chase, like most Americans, believes that tool-power politics is the ultimate in human objectives. "The Social Crediter," 4/8/'45.

The revision of the nationality rule is contained in a Civil Service Commission regulation dated November 21, 1944, whereby permanent appointment to the British Civil Service is now open to "a naturalised British subject who has resided in His Majesty's Dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of his appointment." There is one proviso: that the appointment of a naturalised British subject to the Foreign Office and to the three Service Ministries shall be subject to the consent of the political heads of those Departments.

The implications of the new regulation deserve attention. The majority of the 40,000 German nationals, inter alia, now living in this country, have fulfilled the residential qualification, and have now only to apply for, and be granted, naturalisation to become eligible for permanent appointments in His Majesty's Civil Service. In the eight years covering the period January 1, 1933, to December 31, 1940, some 1630 Germans were admitted to British nationality. Since 1940 a further 60 Germans have been granted the same privilege. How many more may be applying for, and awaiting admission to, British nationality is not known. But it is clearly desirable that

not known. But it is clearly desirable that the British public should be informed of this latest innovation and be made aware

of a measure, which has been introduced, with such a singular lack of publicity.

The average Englishman is unlikely to feel anything but concern at the permanent infiltration of foreign influence into Brit-

infiltration of foreign influence into British administration in peacetime. The filling of key-posts in our public service by aliens, who have long enjoyed protection and immunity in this country, appears to be a peculiarly ill-timed and inappropriate project, when it is reflected that hundreds of thousands of our own fighting men are shortly to be demobilised and will be seeking full-time permanent employment. In what way can this measure be said to be

original Bolsheviks' Government, compiled by the late Victor Marsden, London "Morning Post" correspondent in Russia at the time of the revolution, of 545 principal officials ruling the country 454 were Jews."

Soviet Russia has been usually presented to the outside world by Jewish Ambassadors. Maisky's work in Great Britain right throughout World War 2 needs no comment here. The former Russian Charge d'Affaires in Bucharest, Roumania, M. Theodor Butenko, who fled to Italy because he feared that his return to Russia meant death, wrote in February 1938:

"In place of former capitalists a new bourgeoisie has been formed, composed of 100 per cent Jews. Only an insignificant number of former Jewish capitalists have left Russia after the storm of revolution. All the other Jews residing in Russia enjoy the special attention of Stalin's most intimate adviser—the Jew, Lazare Kagano-vitch."

Bearing in mind these facts, it is not sur-Bearing in mind these facts, it is not surprising to read in that remarkable book, "Report On The Russians," by W. L. White, that when Hitler's armies appeared to be on the verge of crushing Russia, angry Russians were shouting, "Down with the Jews!" Mr. White was a member of Mr. Eric Johnston's party, which toured Russia at Stalin's invitation. The pro-Soviet writers who protested against Mr. White's book did not challenge his facts; they said the facts could only "be understood in terms of change and historical perspective"!

Russia's foreign policy, right up until at-

Russia's foreign policy, right up until attacked by Nazi Germany, was based on the
hope that an "imperialist" war would leave
Europe and the democracies so exhausted
that the Soviet idea of control would easily
prevail. The Jew, Lozovsky, a former big
shot in the Profintern, wrote in his book,
"La Vie Ouvriere," that his main work was
the overthrow of order in the democracies.
His chief, Manouilski, commented on the
anticipated Second World War as follows:
"This war will be the most holy that has

"This war will be the most holy that has ever been fought in the history of mankind: a war that will necessarily stir up a whole series of revolutionary outbreaks within the enemy ranks, and which will

break up and demoralise the ranks of imperialism."

(Once again, consider the state of Europe! And take a brief look at the position of the pro-Russians in Australia.)

It must never be forgotten that Soviet Russia joined with Germany after World War I in attacking the Versailles Peace Treaty as too severe on Germany. She also helped Germany to hoodwink the Allies by allowing the German General Staff to conduct large-scale training in Russtall to conduct large-scale training in Russia. German aeroplane plants were also established in Russia. Soviet Russia's nonaggression pact with Nazi Germany in 1939 (after which Molotov and other Russian) diplomats attacked Britain as a warmonger) paved the way for the war, which it was hoped, would "break up the ranks of imperialism." Soviet Russia's economic assistance to Nazi Germany when Great Britain was fighting with her back to the wall should need no stressing. But we might consider the following statement:

consider the following statement:

Germany is now dependent for such oil supplies as she will receive (from Russia) on three Soviet Russian Jews."—London "Daily Sketch," November 2, 1939.

Hitler's policy was a Jewish policy! And the instigators of this policy aren't very interested in how many Russian, German or other nationals are killed as a result of their policies. Right throughout the Russo-German war the Soviet leaders claimed that they did not desire the destruction of Germany. The "Free German Movement" in Moscow contained some of the most power-

ful of the German General Staff. It is all too evident now that Germany is being brought more and more under the domination of Soviet Russia, which means the domination of International Jewry, and that the Germans are continuing to be used for purposes such as Hitler had in mind. The Russo-German coalition is growing stronger, and behind this coalition is Jewish control. Through revolution and war the Jewish influence has worked steadily towards the complete centralisation of contowards the complete centralisation of control in Europe and, ultimately, of the world. The British Empire was, and, in spite of World Wars 1 and 2, still is, the main obstacle to this plan for world tyranny.

But the "enemy within" is working away to bring about our downfall. Don't forget to bring about our downfall.
