Fifth Column in Anti-British Plot!

The British People Are Being **Purposely Starved!**

By ERIC D BUTLER

There is a great deal of definite evidence which shows that a group of international plotters—aided by fifth columnists—are deliberately using Food Control as a major weapon in their "post-war" attack upon the heart of the British Empire.

The latest news from Great Britain indicates that the British people —the housewives in particular—are putting up a brave fight against Socialist traitors in the House of Commons.

The people are learning in the hard way, that Socialists and Communists are prepared to sacrifice those they are supposed to represent —all in the cause of world sovietisation.

Canadians have had some bitter firsthand experience of these "internationalists. hand experience of these "internationalists."

A Jewish Communist Member of the Canadian Parliament and some kindred high officials were recently arrested and imprisoned because of their disclosures of vital military secrets to Russian spies. They had the effrontery to say in their "defence" that they had a greater loyalty (to totalitarian Russia!) than loyalty to British-Canadian sovereignty.

Canadian sovereignty.

The sooner we Britishers, the world over, realise that the rabble-rousing Communist who rants on street corners, or chalks his childish slogans on walls, is not the main danger to our way of life, but rather the Communist and Socialist "intellectuals" who have wormed their way into the big Government Departments and elsewhere, the sooner we will take action to defeat the dreadful threat confronting us.

OUR OWN FUTURE INVOLVED

"Some people may contend that what happens in Great Britain should not greatly concern Australians.

One of the leading international Socialists from this country, Dr. Evatt, who is notorious for his anti-British views, has

fostered this idea.

But—sentiment and so forth apart—surely it is obvious, to all realistic and loyal British-Australians that the preservation of our way of life depends upon the way of life depends upon the preservation of the British Empire as a If the people of Great Britain are brought to their knees, by food control imposed by local agents of the International Plotters,

OUR future will be very gloomy indeed.
For this and other reasons, let me once again bring forward some startling facts about international food control and how the British people are being sacrificed, as part of a deliberate plot.

THE ROLE OF U.N.R.R.A.

A major role in the international food racket has been played by U.N.R.R.A., which has been used to pour huge quantities of food into Communist-dominated parts of

The Canadian paper, "Toronto Globe and Mail," of April 18, reports an official of U.N.R.R.A. who resigned his job in Germany, declaring that displaced persons in Europe say they were better off under the Germans. He also says that large quantities of food are being wasted. He alleges that high officials, who hope to keep themselves for life in the job of controlling food, are living at the best hotels and are eating are living at the best hotels and are eating remarkably well.

In Italy he saw no signs of malnutrition. Meat and vegetables can be easily bought. He charges U.N.R.R.A. with having shipped 500,000 tons of coal to Italy from Great Britain last January, despite the fact that the British people were eking out their fuel and were half frozen. Italy has a warmer climate; also a good electricity supply system, largely hydro-electric (no fuel needed), which could have been used more extensively for heating.

IT'S HARD TO RECONCILE

A report in the Canadian "Toronto Star" of May 7 states that Swedish fishermen are unable to dispose of all their catches, and are throwing thousands and thousands of fish back into the sea.

Another report states that Holland has had to destroy large quantities of surplus vegetables. Food officials claimed that tomatoes and cucumbers in particular are considered luxury foods, and that there was no reasonable justification for their being sent to Germany.

Try and reconcile this latter information with the propaganda concerning the alleged starvation in Germany.

Can it be that the precious food denied to the British people in order that it may be sent to Germany is all right for the Germans, but that the appetites of the Germans. mans are so delicate that they couldn't eat surplus tomatoes and cucumbers from Holland?

PURPOSEFUL PROPAGANDA

Let us briefly refresh our memories with some of the lurid stories of starvation in Germany and elsewhere that we were told

late last year.

Mr. Victor Gollancz, the Jewish near-millionaire Socialist, whose publishing house produced most of the propaganda that put produced most of the propaganda that put the present Socialist Government into office in Great Britain, said on October 19 of last year that "12,000,000 people may die of starvation in Germany in the next few months." Other reports said that Germans were digging mass graves for themselves well in advance of the winter, because when from malnutrition to do the job.

In spite of this monstrous propaganda, there has been no evidence of Germans actually dying of starvation.

Mr. Gollancz also quoted Miss Ellen Wilkinson, a Socialist Member of the British House of Commons, as saying during last October: "There is no doubt that quite a number of German children will die before the winter ends, because food cannot be got to them."

There is no evidence of this dying of starvation. In fact, Mrs. Roosevelt, after her visit to Germany early this year, said

on February 14: —

"The Germans look as well fed as, or perhaps better fed than, the British. The children, especially, appear to be healthier in Germany."

FOOD AS POLITICAL WEAPON

There is not the slightest doubt that food is short in some parts of Europe—in fact, there is evidence that in Eastern Europe the Communist-dominated. Governments are

using food as a political weapon.

But why do the Communists' friends in Great Britain—Gollancz and his kind—distort these facts?

Can it be that they are deliberately trying to provoke revolution in Great Britain, or weaken the people in case of war with Russia, or are they "merely" trying to perpetuate control of the British through rationing?

These are serious suggestions to make, but let us recall two of many items of news, which are at least thought provoking:
An inconspicuous report in the Melbourne "Herald" of July 8 states that a member of the executive of the Irish live-

TOTALITARIAN TACTICS

The totalitarians at Canberra proceed from one outrage to further outrages. The "A".B.C. (Mr. Moses, general manager) is to have its own news gathering agency!

NOTES on the NEWS The Liberal Party has turned a smart political trick on its opponents by maneuvering Labor into rejecting payment for the first child under the child-endowment scheme. Now the Liberals have the battle cry that Labor voted against what they say was equivalent to an increase

in the basic wage. It will be remembered that the Liberals (alias U.A.P.) brought in childendowment, as a result of a strong hint from the Arbitration Court, as an alternative to an increase in the basic wage. Then Labor advocated including the first child, but have done nothing about it since they gained office. Now the Liberals have stolen a march with this election appeal.

Of course, John Citizen would really pay himself via the pay-roll tax, which would be increased, and, of course, included in the prices of goods. This incident is an illuminating example of putrid Party Politics.

PEACE PARLEY: The long-awaited peace parley has arrived at last. It has been proposed that "organisations of a Fascist type" shall be forbidden," but, so far, "Fascism" has not been defined; it most likely means any political set-up similar to that of pre-war Germany or Italy—for example, Soviet Russia. Military training to supply permitted armed forces will be allowed. Again, there is no condition insisting on a referendum in each country to decide whether or not the people concerned want their nation to go to war. Without minimum safeguards such as these the peace is a snare and a delusion.

COMMONS COMMOTION: British Labor Members are said to be very angry because of a poster dealing with bread rationing, issued by the Face The Facts Association. The poster announced an intention to publish the names of the Members of the House of Commons who voted for bread rationing, and described them as enemies and dicta-tors. From this it seems that the Face The tors. From this it seems that the Face The Facts organisation has scored a big hit in getting under the skin of these so-called workers' friends 'who evidently didn't want electors to know who voted to limit their bread. Since bread rationing is not wanted by the British people, it is beyond doubt that their political servants are emulating Hitler's tactics in imposing it; this being so, obviously they must be enemies of the people. Naming the individual Members responsible for unwanted measures is the correct procedure, which could be followed correct procedure, which could be followed to advantage in Australia.

THE TRUTH ABOUT THE REFERENDUM

All Your Ouestions Answered

By ERIC D BUTLER (Concluded from last issue.)

QUESTION: What is the exact wording of the power over industrial matters desired by the Federal Government?

ANSWER: It is proposed that the Federal Government shall have power over "Terms and conditions of employment in industry, but not so as to authorise any form of industrial conscription.'

Q: Of what value is the proviso, "But not so as to authorise any form of industrial conscription?"

A: It is of no value whatever. Once the bureaucratic power-lusters at Canberra have control of the terms and conditions of employment in industry, they can do all sorts of things to regiment employers and employees, but disclaim that it is industrial conscription. For example, in 1944 the present Government passed the Unemployment and Sickness Benefits Act. Any person needing the very paltry unemployment "benefits" provided under the Act has to submit to the conditions imposed by the officials administering the scheme. They can send an applicant for relief away to Alice Springs to work, if they so desire If he will not go, he can be refused relief What is this but industrial conscription?

RELIEF AND REGIMENTATION

Q: But surely the individual seeking unemployment relief should be prepared to submit to some control in exchange for the money the Government provides for

A: The point commonly overlooked is the fact that taxpayers seeking unemployment relief are merely requesting some of their own money back, money which the Government takes off them in not only direct, but also in indirect taxation. If people can only get access to a proportion of their money by accepting officially pre-scribed work anywhere in Australia and submitting to terms dictated by Government bureaucracy, then conscription is being introduced, irrespective of what words are used to describe this procedure.

THIN EDGE OF THE WEDGE

Q: Is there any direct evidence that the proposal to give the Federal Government control of all, industrial legislation is the thin edge of the National Socialist wedge?

thin edge of the National Socialist wedge?

A: Yes, but there is far too much to quote it all. Here are a few items:

Dr. Evatt has said: "Today, with the enormous development of industry and industrial organisation, corporate control and finance, there is no longer a full right in every person to choose his own vocation in life." (vide "Post-War Reconstruction in Australia.") Speaking at Canberra on February 11, 1944, Dr. Evatt said: "... Full employment cannot possibly be achieved unless some authority is empowered to exercise wide powers to determine how employment is to be expanded."

"Key" members of the bureaucratic army

"Key" members of the bureaucratic army of occupation at Canberra have indicated why they want greater powers. Dr. Coombs, principal economic advised at Canberra, has said: "What I said was that in the postwar world more decisions would be made by public authorities as to the allocation of resources than has been the case in the past..." (vide "Post-war Reconstruction in Australia.

Australia.")
Dr. Lloyd Ross, another economic adviser, said prior to the 1944 Referendum: "But we need also the recognition of the need for more State control, State guidance, and State ownership." In other words, we all need more regimenting by Dr. Ross and his fellow-totalitarians. The only answer to these totalitarians is a "No" vote on all three issues at the Referendum three issues at the Referendum.

INDUSTRIAL DISPUTES, Etc.

Q: It is suggested, then, that the States Q: It is suggested, then, that the States can, and should, look after their own industrial problems?

A: Yes. They understand those problems much better than the central Government at far-away Canberra.

Q: But what about industrial disputes which spread beyond one State?

A: The Federal Covernment ALREADY

A: The Federal Government ALREADY has power to help to settle any such dispute. Section 51 of the Federal Constitution makes particular provision for it.

That is a fact which Canberra power-lusters conveniently "forget" to explain to the unsuspecting electors who don't know, unfortunately, what is in the Constitution.

POINT FOR LABOR VOTERS

Q: Have not non-Labor Governments also asked for greater powers for Canberra and attacked the Constitution?
A: Yes. Labor voters should bear in mind the fact that the Bruce-Page Government in 1926 and the Lyons Government in 1937 asked for industrial powers identical with those being asked for by a Labor

Government today. As far back as 1933, Mr. R. G. Menzies said that he was in favour of amending Section 51 of the Constitution "by giving the Commonwealth power to legislate generally in respect of all industrial matters." all industrial matters.

Q: Why, that is exactly what Dr. Evatt

A: Exactly. Liberal Senator Leckie truthfully said at Canberra on April 12: "When a Liberal Party Government proposed an alteration of the Constitution to grant to the Commonwealth power to deal with arbitration and conciliation, the Labor Party strongly opposed it and the Referen-dum was defeated. Now, the Labor Party

supports a similar, proposal."

It is to be hoped that Labor voters grasp the significance of this admission.

A POINT FOR FARMERS

Q: Did not the Lyons Government also ask at the 1937 Referendum for power over Orderly Marketing?

A: Yes. In fact, the Federal Country Party, in Parliament this year, voted in favour of Dr. Evatt's "orderly marketing"

proposals.
Q: But don't they realise that these proposals, if carried at the Referendum, could, and undoubtedly would, pave the way for complete socialisation of primary production?

A: Yes. They tried to get Dr. Evatt to include, in the proposed Constitution amendinclude, in the proposed Constitution amendment on this matter, a guarantee that Federal control would not be used to introduce direct control of production; but even this was not permitted. One Country Party man, Mr. G. Bowden, speaking at Canberra on April 10, said: "It is held by many authorities that marketing cannot be successfully organised without control of production." And yet, Country Party Members voted for Dr. Evatt's proposals to give the Federal Government complete power over Federal Government complete power over the marketing of primary production!

NON-LABOR NO SAFEGUARD

Q: It would appear that genuine private ownership and free enterprise is being undermined by the very people who allegedly defend it?

A: All centralisation of power leads to A: All centralisation of power leads to Monopoly control of every aspect of the people's lives. "Anti-Labor" Governments have been just as keen on centralising power as have Labor Governments. One of the greatest blows against local government in Australia was the Federal Government's arrogant decision early this year to make Uniform Taxation permanent, thus destroying the right of the people in any one State to decide what taxation they desire and how it shall be spent.

Q: But weren't Liberal and Country Party Members opposed to the continuance of Uniform Taxation?

A: No. They were only opposed to the method of operating it. It should be pointed out to Liberal and Country Party supporters that not one of their so-called representatives at Canberra even recorded a vote of protest against the Labor Government's Bill to make Uniform Taxation permanent

MONOPOLY PRESS POLICY

Q: What policy has the Monopoly press of Australia pursued on this issue of increasing the powers of the Centralised Can-

creasing the powers of the Centralised Canberra Government?

A: Generally speaking, it has, as might well be expected, supported the policy of greater centralised control by Canberra. The Melbourne "Herald," one of the Murdoch chain of newspapers, has consistently advocated greater powers for Canberra. It only disagrees with Dr. Evatt and Co. on the best method of tricking the electors into granting the powers. On April 4, Labor Member Fuller said at Canberra: "In reply to the claim that State Governments should be permitted to deal with many matters of national character, I canof national character. not do better than cite an argument advanced by the Melbourne 'Herald' some years ago in a leading article, which pointed out that there was little logic in the conout that there was little logic in the contention that powers which are regarded as safe in the hands of one Government must be regarded as dangerous in the hands of another."

To Labour supporters it must seem very peculiar that "Labor representatives" quote the "Capitalist" press to support their arguments

guments.

COMMONSENSE AND HISTORY

Q: What is a concise answer to Mr. Fuller and the Melbourne "Herald" on the point raised?

A: Would it be agreed that powers regarded as safe in the hands of an Australian Government would be just as safe in the hands of an International Government? Obviously not. The further Government is taken away from the people, the less control the people have over the Government. The Canberra Government was established to look after genuinely national matters such as Defence, not to interfere in local Government matters. The electors of any one State, who understand their own probone State, who understand their own prob-lems, better than anyone else, should have the sovereign right to look after their own affairs. Local Governments are a necessary

safeguard against Monopoly Government. just as genuine competitive enterprise is a safeguard against Economic Monopoly.

Q: It is contended, then, that increasing individual security and individual liberty can only be obtained in local, decentralised Government?

A: History overwhelmingly supports this contention. The successful growth of the British Empire has been based on the idea of a group of self-governing units voluntarily associating for common chieve of a group of sen-governing units voluntarily associating for common objectives. The Australian Commonwealth can only become truly great if it is built on local, self-governing States voluntarily associating on matters of common interest.

"PROOF OF THE PUDDING..."

Q: What is the most damning indictment of complete Federal control?

A: The record of all Federal Governments since 1910 in the Northern Territory.

The Commonwealth has had complete control—ALL the powers—in the Northern Territory since the end of 1910, but it has not produced there the Utopia it promises to create in the other parts of Australia if it gets more powers.

At the very time when the Federal Government is asking for the increased powers, the citizens of the Northern Territory, who have had plenty of bitter experience of Canberra control, are so outraged that they are demanding local self-government.

THE ROAD TO FASCISM

Q: What will be the final result if increased powers are given to Canberra?

A: As previously pointed out, these increased powers will in reality be used by the Federal "army of occupation," the bureaucracy, the heads of which are rapidly becoming the real government at Canberra. Increased powers for the bureaucracy now will mean subsequently still more demands for further powers. Once the move towards for further powers. Once the move towards centralisation really starts, it is very difficult to resist it. Increasing government by bureaucracy will mean increasing control by domineering official upstarts, of every aspect of people's lives. High taxation will be maintained as one of the methods of control. The inevitable end will be open Fascism in Australia Fascism in Australia.

LABOR LEADERS' WARNING

Q: Surely the term Fascism is a little

Mr. Chifley, in expressing surprise that gas and electricity rationing had not been "tapered down" sooner, has apparently overlooked a factor which Mr. R. C. Evans, general manager of the Metropolitan Gas Co., Melbourne, has shown quite clearly renders any policy of genuine conservation quite unworkable.

quite unworkable.

The factor is simply that any surplus over immediate deliveries is promptly "diverted" — where is not disclosed.

Mr. Evans remarks: "... As a result of rationing and appeals for economy, the Metropolitan Gas Co. actually used 24,000 tons of coal less in the year ended June 30, 1946, than in the previous year, but stocks were not improved. We are still forced to operate from shipment to shipment...

"Our experience has been that if consumption is reduced by rationing or other means, then deliveries automatically shrink to match the saving, and no benefit results."

This experience is by no means confined to gas. Wherever arbitrary rationing has been imposed industry has been forced to restrict its output to a limited demand. THERE HAS BEEN NO SAVING. When

THERE HAS BEEN NO SAVING. When we are prevented, for example, from purchasing cream, no cream is "saved." The dairyman simply goes out of production.

The policy of arbitrary restriction of consumption leads inevitably to a forced restriction of production, a policy that can only be described as deliberate sabotage.

Mr. Calwell's own demais regarding his alleged preferences to Jewish migrants vary a great deal and contradict themselves.

There is, in fact, very strong evidence to support the belief that Jews, some of them obviously not persecuted, find a welcome to Australia, which is not, at present, extended to others. There is definite evidence of recent arrivals, from both Europe and Asia, and a ship is now on its way here from Denmark with a further contingent. Landing permits are constantly being granted to Jews abroad and seemingly, in spite of the Minister's statements to the contrary, they do arrive here ahead of other

anxious migrants.

The Jewish Unity Committee in Sydney is planning to transport 25,000 Jews to Australia this year, apparently with Ministerial sanction, and aims to acquire disused army huts from the Government for their transports. sitional accommodation.

Some months ago a Melbourne Jewish body convened a meeting to honour Mr. Calwell, and proposed to plant a grove of trees in Palestine and to name it after him. One is justified in asking if all these and other known facts add up to one par-ticular race of people receiving preference over our own British brothers and sisters in the matter of entry into Australia.

An important aspect is that those arriving receive privilege in the way of establishing themselves in business, denied our own men, who are still in the Services under the points system.

ATTEMPT TO FRIGHTEN AUSTRALIAN MOTHERS AND WIDOWS

(A letter to the Editor from BRUCE H. BROWN.)

Sir,-Of the three questions to be put to the people in the Referendum on the 28th September, the one relating to Social Services seems to me to be of reprehensible intent, being designed to obtain a "yes" vote from mothers and widows under the mistaken impression that if they do not vote "yes" they will lose maternity allowances, child endowment and

If they vote "yes" for this, it may be expected that a lot of them will vote "yes"

for the other two, as a matter of course.

The simple truth is that maternity allowances, child endowment and widows' pensions are being paid now under Federal law, and that this law will continue in force regardless of the result of the Referendum.

There are only two ways in which that law would cease to operate with Fither

law would cease to operate, viz.: Either by repeal through the Commonwealth Parliament or by declaration by the High Court of Australia that the relative Acts are un-

PAYMENTS NOT THREATENED

So far as I have been able to ascertain. no candidate for Parliament has ever suggested that these particular payments ought to be discontinued, and all political parties have declared unequivocally that they stand not only for a continuation of the benefits, but also for the extension of them.

No action to interfere in any way with

the payment of maternity allowances, child endowment and widows' pensions will therefore come from the Federal Parliament—or from any section of the community.

The only other possibility is that some individual person may challenge the validity of the legislation by an appeal to the High Court, and obtain a declaration that this particular legislation was beyond the power of the Federal Parliament. But even if that should happen, the payment of maternity allowances, child endowment and widows' pensions would be continued because no Federal Government would dare do otherwise.

LABOR AND LIBERAL MEN GIVE ASSURANCES

This particular aspect has already been mentioned in the Commonwealth Parlia-

On May 6th Senator Fraser, speaking of-ficially for the Commonwealth Government,

"If the Referendum fails, the Commonwealth will ask the States to carry out, under their health powers, an agreed plan which the Commonwealth will subsidise."

Mr. Harold Holt, a Liberal member of the Commonwealth Parliament, and a lawyer, also has said:
"The Commonwealth could still make

financial grants to the State Government for these social benefits."

It is therefore clearly beyond question that all social service benefits can be con-

tinued under existing powers, and that they will be continued regardless of anything the High Court "might" say. We thus come to the simple position that

the question is being put to the people os-tensibly because some members of the legal tensibly because some members of the legal fraternity have expressed "doubt" regarding the constitutional validity of the Commonwealth laws on the subject, but, as mentioned earlier, more probably because it may lead some of the electors to vote "yes" as a result of wholly unwarranted apprehension about the continuance of the payment of maternity allowances, child endowment and widows' pensions.

QUESTIONS FOR CANDIDATES

Anyone who feels doubtful on this issue can have that doubt satisfied by putting questions to every candidate at the forth-coming elections. It is suggested that every Labor candidate be asked to answer the following:

(i) in the event of a "no" vote at the referended on the 28th September, is it likely that the Government will take steps to repeal the existing social services legis

lation affecting maternity allowances, child endowment and widows' pensions?

(ii) If the answer to (i) is yes, would that be done before arrangements had been made with the State Governments for the payments to be continued?

(iii) If the answer to (i) is no, can you say definitely that the existing laws will be continued and payments made by the Commonwealth as at present?

(iv) Is it also correct to say that even an unfavourable decision by the High Court would not cause any break in the payments, but merely a transfer of the work to the State Government as the agent of the Commonwealth?

Similar questions, suitably modified, should also be put to every non-Labor

Electors should not be deceived. The Commonwealth has full power under the existing Constitution to arrange for any payments to be made as directed by Parliament, either through its own Departments or by asking the appropriate State Government to act as its agent. SOVIET SECRETS: Ex-Comrade Kraysoviet secrets: Ex-Comrade Kravchenko's book, "I Chose Freedom," in addition to dealing with certain unsavoury characteristics of Stalin, describes the book, "Mission To Moscow," as "a strange half literate book, more absurd than evil, a hash of ignorance and double talk, and in large part silly."
