A Drastic Reduction of All Taxes Needed

It Must Be Made a Maior Issue in the Election Campaign

By ERIC D. BUTLER

It is a well-known principle of political organisation, that the more centralised Government becomes, the less chance electors have of controlling the Government. An examination of the taxation policy being pursued in this country provides striking evidence of this fact.

In local Councils, the smallest political units in Australia, most ratepayers are well aware of what rates they are paying and how those rates are being spent. But how many taxpayers know how much taxation—including indirect taxation—they are paying to the Federal Taxation authorities, and how their taxes are being spent?

Even those electors who take an active interest in political and economic matters find it well-nigh impossible to discover all the facts about taxation.

During the war years the preparation of the Federal Budget was altered to such an extent that it is virtually impossible for anyone to ascertain in detail how all expenditure has taken place. It is proposed

expenditure has taken place. It is proposed that the war-time type of Budget be continued permanently. How can it be said that we have responsible Government when the people who pay the taxes find it difficult to discover how their taxes are being spent? Mr. Chifley told the Federal Parliament that he was not going to bring down a Federal Budget before the Federal Elections. He said that it wasn't "practicable." What a remarkable state of affairs when the Prime Minister tells the taxpayers just prior to an election that it is not practicable to give them a precise and detailed account of the actual and proposed expenditure of their money! monev!

"STATEMENT" AND TOKEN CUT

It is true, of course, that Mr. Chifley did present to Parliament what he called "a statement." But this statement merely gave "main heads" of revenue and expenditure, estimated and actual.

However, two very interesting set of figures can be ascertained from this statement. It will be recalled that when Mr. statement. It will be recalled that when Mr. Chifley made his first so-called income and sales-tax reductions for 1945-46, he said what a disastrous effect these "reductions" would have on revenue. And yet. on his own figures, sales-tax receipts, £34600,150, exceeded his estimates by £5,600,150, while income tax receipts, £214,593,577, exceeded estimates by £3,583,577, (Tax revenue from all sources, £360,151,012, was £17,151,012 more than estimated) thanestimated.)

In spite of these figures, Mr. Chifley offered what is merely a further token reduction in taxation as a pre-election gesture. This further "reduction" will not have the slightest effect in restoring incentive to the production system.

Nothing less than a 40 per cent, reduction, in all taxation will allow the production system to supply the goods so urgently required by Australian consumers.

ALTERNATIVES TO BE FACED

Of course, if the major Parties and the electors insist that financial rules are more important than production, we can look for-ward to increasing industrial chaos, this in turn leading to more controls, the controls necessitating an even greater army of bureaucrats to administer them. This is the way to serfdom, and, in view of the evi-dence confronting us, we can only con-clude that there are certain groups who de-

sire us to take the road to serfdom. Some electors will, of course, suggest that the only way to have taxation drastically reduced is to vote the present Government out and vote the Opposition in.

There is no evidence to suggest that a mere change of Government would have the slightest effect on major policies. Surely past history has proved to electors that what Members of Parliament say when they are in Opposition, and what they do when they become the Government, are two different things.

MENZIES' PLAN NOT ENOUGH

It is true that Mr. Menzies says that if he and his Party, aided by the Country Party, are elected to office, they will re-duce taxation by 40 per cent, over a period of three years. Even if carried out, this promised reduction would be of no use to meet the industrial crisis now confronting to meet the industrial crisis now confronting the nation. It is an IMMEDIATE reduction of taxation by at least 40 per cent.

WHY COAL-MINERS GO SLOW

WHY COAL-MINERS GO SLOW In a letter to the Sydney press, a coal miner put the issue very, bluntly. He said: "Do you and the Government and the general public think it fair that a man should have to cut and fill fifty tons of coal per day—or work three and a half days—for nothing? If you and the public saw fifty tons of coal stacked up in a heap and you had to fill it to pay your taxes, you would walk around it and go for your life. You or they would not fill it, let alone cut it. Well, sir, that is what I do —stay home three days—and will do so until the Government wakes up." Nothing is more certain than the fact that, if more coal is wanted, and it is urgently wanted, miners must be provided with suf-

wanted, miners must be provided with suf-ficient financial inducement to work to

All sections of the community must be provided with greater inducements if dis-aster is to be averted. This inducement can only be provided by immediate and drastic tax reductions.

WHAT ELECTORS MUST DO

Electors can and must make this a major issue at the elections. They should con-tact all candidates either personally or in writing, and insist that they are going to campaign against all candidates who will not give an assurance to work for an im-mediate reduction in all taxation by at least 40 per cent

40 per cent. Coupled with the demand for taxation reductions should be a demand for a re-duction of the bureaucracy to the 1938 level.

Members of Parliament should be the paid servants of their electors. But the electors must show very clearly that they are the masters. The coming elections should be used to do this.

rife answer is an off one, rower corrupts." "People too often think in abstract terms, When individuals fail in their social function or are oppressive in performing it, people are apt to say that the State will do it better, as if the State were a benign impersonal agency. But the State, in fact consists of persons too; to take power away from individuals and concentrate it in the hands of the State without institutional safe guards against its abuse is simply to give certain individuals a power so great that they are corrupted by the exercise of it. "Dictators are simply men who, profiting by such abstract thinking, and posing as saviours of society, while still supported by popular emotion, destroy the institutional safeguards and abuse the power. The corruption, the inefficiency, the loss of success and resort to naked power then automatically follow."

-Major H. R. Trevor-Roper, British officer who investigated the circumstances of Hitler's death, in an article in N.Y. "Time" Magazine.

The attempt to destroy institutional safeguards, which precedes outright dictatorships, is precisely what is happening in Australia. RUSSIAN FOOD POLICY

With an alleged world shortage of cereals receiving widespread publicity, it is inter-esting to speculate on the position of Russia, historically a grain-exporting country and controlling the chief food surplus-producing countries of Eastern Europe.

Europe. According to the Washington "Post," a prominent member in the U.S. Administration's food programme states that "Russia is playing hard power politics with food," and points out that Russia (1) is not contributing a ton of cereals to the pool needed to avert mass starvation in the immediate crisis; (2) has refused to inform other nations what stocks of cereals are available in the surplus-producing areas under her domination; (3) has declined to state what the wheat prospects are in these formerly rich grain areas; (4) has declined information as to what extent Russian military forces are living off the occupied countries and (5) has withheld information on how much food has been information on how much food has been removed from under Russian control.

GETS U.N.R.R.A. JOB Professor J. B. Brigden, financial counsellor to the Australian Legation at Washington, has been elected vice-president of the Council of U.N.R.R.A. at the conference at Geneva.

Australians may recall that Professor Brigden became prominent in upholding the Casey National Insurance Scheme, which was defeated by the electors. Since then his career has steadily progressed.

PETROL RATIONING FARCE

PETROL RATIONING FARCE The farce of petrol rationing has been further demonstrated by the deputy-president of the Australian Automobile Association, Mr. J. A. Paterson. In a check of twelve garages, members of his association had found eight of them selling petrol illegally, three at a black market price of 5/ without tickets and one at 4/ without tickets. 

ARGICULTURE TO-DAY AND **TO-MORROW**

(From "Country Life Stock & Station Journal," Sydney, 28/6/46.)

Edward Faulkner, practical American farmer, has discarded the traditional mouldboard plough for the disc. In his book, 'Plowman's Folly, he claims deep ploughing and burial of surface trash restrict bacterial action and plant decay. Distribution of soil moisture is also adversely affected.

Increases in fertility and productivity are claimed for discing-in green crops, stubbles, or surface trash. Surface run-off and erosion are also minimised by these processes.

Investigators in Iowa compared soy-bean yields after Faulkner's method of soil preparation against those obtained following mouldboard ploughing. They found Faulkner's method of soil preparation resulted in heavier crops; saved one-third to one-half of the man and machine power required by and machine power required by mouldboard ploughing, and reduced erosion

mouldboard ploughing, and reduced erosion by 7Oper cent. Recent research elsewhere has shown that traditional methods of farming have resulted in a steady decline of soil fertility in land observed over the last half-century; when mouldboard cultivation has been constant. Depletion of nitrogen and organic matter and loss of soil structure are the critical factors.

MORE HUMUS IS NEEDED

MORE HUMUS IS NEEDED Organic matter is the food of nitrogen-Fixing bacteria which live in the soil, and obtain oxygen and nitrogen from the air. When they die, nitrogen in their bodies is available to plants as food. Air moves most freely in the top few inches of the soil. The more organic matter in this region, the greater is the number of bacteria and the quality of nitrogen produced. However, mouldboard ploughing buries it too deeply. Organic matter is the source of

Discretized by the source of humus. Soils deficient in humus are poor in texture and structure. Water does not penetrate them readily, nor is it retained by them. When adequate humus is present texture and structure are satisfactory and the soil is permeable

are satisfactory, and the soil is permeable to water and retentive of it. Green crops, stubble residues and trash provide organic matter. Shallow discing of this material into the surface soil provides optimal conditions for nitrogen production and maintenance of organic matter. The incompletely buried material also checks surface run-off and evaporation.

Cereal crops sown on autumn cultivated clover land out yielded those sown on a carefully prepared fallow by up to 50 per cent., at a greatly reduced cost of soil preparation.

Cost of soil preparation. Unfortunately, the scope of clover rota-tional farming has climatic limits in Aus-tralia. But within them, greatly increased returns have already been obtained by pro-gressive farmers. Alternative rotations are under trial in dry areas. IMPORTANCE OF ANIMALS

Experiments in the Victorian Mallee in-clude the sowing of oats for winter grazing. After the crop is finally grazed down in the spring, the stubble is worked with a tyned implement and the land left in a ridged conimplement and the land left in a ridged con-dition during the summer. In the autumn it is sown to wheat. Wheat yields so far have been satisfactory and fat lambs, weaned off the winter oats have added appreciably to farm income. Australian methods of organic farming differ in practice from Faulkner's, but are alike in principle. Both have as their ob-inctive improvement of soil fartility and pro-

THE REFERENDUM AND INDUSTRIAL CONDITIONS

(A letter to the Editor from BRUCE H. BROWN.)

Sir,—Question No. 3 to be put to the people at the forthcoming Referendum is known as the "Industrial Employment" question, and is designed to give the Federal Parliament power to decree terms and con-ditions of employment in industry. This is a most important matter. The proposal refers to the wages that shall be paid and the conditions under which we may employ or be employed.

It is well-known that friction occurs Shorter hours mean more employees or less It is well-known that friction occurs between employers and employees, but it is not so well-known that this friction is the direct result of FINANCIAL conditions. The trouble does not come from unreasonableness on the part of either party, but from force of economic circumstances. A little honest thinking will show the truth of this. The employee naturally and quite

The employee naturally and quite properly desires to obtain progressive improvements, and these can only come to him under the present set-up in the form of higher wages, shorter hours, annual holidays, and better working conditions. He therefore expects his Union to demand them from the employer. On the basis of physical reality, all the current demands are perfectly reasonable and could be complied with. But these questions are not determined by physical realities. realities.

POSITION OF EMPLOYERS

POSITION OF EMPLOYEKS It would be true to say that most employers would gladly grant these things IF THEY COULD DO SO WITHOUT DETRIMENT TO THEMSELVES. It has to be remembered, however, that every business is successful or unsuccessful according to its FINANCIAL RESULTS and consequently every business is successful or unsuccessful according to its FINANCIAL RESULTS, and consequently every employer is obliged to consider a demand from the Union on the basis of its FINANCIAL effect on his business. If to grant the demand would make his financial position more difficult he must perforce resist it, just as any one of us would do in similar circumstances. But before we can consider the question

But before we can consider the question honestly we must clear our minds of all nonsense about the so-called fabulous profits made by employers. A few do seem to do better than moderation could support but these are not twiced of the support, but these are not typical of the great bulk of employers. The simple fact is that if all profits were distributed equally amongst employees it would make very little difference to the contents of the pay envelopes.

PRACTICAL CONSIDERATIONS So when an employer receives a demand for increased wages he has to face the position that he must either do with fewer employees, reduce the quality of goods, or accept an increase in the corse desire to maintain the standard they have established, and consequently they would be forced to seek additional financial accommodation at the bank, which, if granted, would in turn mean that more bank charges would have to be added to the extra wages cost. And so, in order to avoid insolvency, the employer would have to put his prices up sufficiently to recover not only the extra wages. But also the extra bank charges. That helps to explain why wages are always chasing prices. Exactly the same applies to the other

output, unless machinery is introduced to maintain or increase the volume. More employees mean more expenses. Less output means lower turnover and falling returns, unless the price for the diminished output is increased. More machinery means greater capital and maintenance costs.

Clearly, therefore, it is all a question of FINANCE, whereas the spokesmen for both employers and employees make it out to be a question of hostility or refusal to "share." The tragic joke is that the quantity of money usually available to the community is purposely kept so short that everyone is forced to struggle for an inadequate share of an insufficient supply. Even Governments, municipalities, churches, etc., have to join in the unseemly fight for MONEY, and as yet only a few people understand how power is being exercised through the manipulation of

the money supply. More annual holidays and all sorts of other amenities are governed by FINAN-CIAL CONSIDERATIONS.

A DANGEROUS POWER

It would therefore be most improper (apart from the direct centralisation of (apart from the direct centralisation of power) for the Commonwealth Parliament to decree industrial conditions which would seriously press business men financially (unless the financial system were first rearranged so that the employer could readily get the money required to meet the conditions imposed). The result could only be ruin for all the employers operating on a smaller scale, and the extension of MONO-POLY for those working on a larger scale with private financial institutions to support them. That is one of the purposes of Socialism, but unfortunately it is not yet widely understood. Actually, MONOPOLY is one of the world's greatest dangers.

RUSSIANS REGARDED AS GUINEA PIGS Attitude of "Friends of the Soviet Union"

The following is condensed from a recent New York "Times" letter by Eugene Lyons, formerly American United Press correspondent in Moscow for several years, author of the books, "Assignment in Utopia" and "The Red Debacle," and editor of the American "Mercury" in the last few years: -

In observing foreign opinion on the affairs of the Soviet Union for a good many years, I have been struck by a phenomenon so persistent that it might reasonably be formulated as a law of behaviour:

The greater the tolerance for the Soviet regime, the greater the contempt for the Soviet Soviet people.

It is obviously difficult, if not impossible, to be "friendly" towards a dictatorship and its subjects at the same time. The Soviet boosters accomplish this feat by convincing themselves that the feat by convincing themselves that the subjects in this case are a despicable lot, who neither know nor care about political liberties and actually like being terrorised. Thus it happens that fervid "friendship" for Soviet Russia in the official Moscow-sponsored sense has become equivalent to derogation of the Soviet population and high-minded approval of their martyrdom as noble "sacrifices" imposed on a sub-human species by its super-human masters. species by its super-human masters

That contempt shows up in the familiar assertion that Bolshevism, though self-evidently unacceptable to us, is neatly suited to the Russians.

It is manifest in the generous readiness of self-styled "friends of the Soviet Union" to sacrifice any number of millions of Russians as if they were less than guinea pigs in the interests of the "great experiment" over there.

from "reactionaries" and "crypto fascists" who suppose that Russians not only deserve freedom, but would recognise the thing and could take it without ill effective

without ill-effects. Presumably Soviet citizens, including the fifteen, million or so in forced labour colonies and isolators, enjoy the terror under which they exist and have no desire eliminate it?

Presumably they are content with prescribed thoughts, political liquidation, blood purges, mass deportations, the hostage system, espionage, universal mutual punishment without open regimented education, trial. coerced collectivisation and the rest of the totalitarian blessings?

Anyone acquainted with Russian history must be aware of the passion with which thousands of Russians fought and died for personal liberties.

We find it more explicit in most of the "pro-Soviet" books by foreigners. One of them asserted that Stalin's ruthless methods "were most fitted to the Russian character and folk-way in that they established Asiatic absolutism."

Another assured us that "without an ironbound dictatorship Russia could not survive, for it is the only thing the Russian people know and understand.

A third developed at length the thesis that Russians have neither a "genuine understanding" of nor a "desire" for freedom, and no interest at all in civil or political riahts.

The assumption is that Russians and other Soviet populations have no bothersome appetites for liberty and can be managed only with whips, concentration camps and whips, concentra execution squads!

Such methods might be hard on the refined sensibilities of other peoples, but they are relished, or at any rate not resented, by the strangely masochistic Russians!

The cream of the cruel jest is that those who hold such insulting opinions of the Russians consider themselves honestly with a touch of exaltation, authentic friends of Russia. And that by definition makes them "liberals" and progressives" as distinguished the Russians in resisting ruthlessness. The alleged "friends" whose friendship rests on contempt are doing a terrible disservice to the Russian people.

In effect they are loading the people of the U.S.S.R. with responsibility for a system and policies of which they are not the authors but the victims.
