Don't Give Bureaucrats Any More Powers!

They Will Get Them If You Vote "Yes" at the Referendum

By ERIC D BUTLER

Before electors are persuaded by high-pressure propaganda to give any more power to the Federal Government, they should carefully consider what such a step would mean.

In the first place, surely a few minutes' thought by any intelligent person should indicate that the granting of increased power to the Canberra Government really means that more powers will be delegated by the Government to an ever-increasing bureaucracy.

During the last Parliament, Bills were being rushed through Parliament in a never-ending stream. It is ridiculous to suggest that Federal Members of Parlia-ment already obviously over-worked and and an angle of the second state of the second and and should be handled by local Governments, should be asked to handle more legislative powers.

More power for Canberra can only lead to an increasing delegation of power to the bureaucracy. This bureaucracy then be-comes the real government.

President Calvin Coolidge, of the United States of America, replying in 1926 to a deputation, which urged the granting of greater powers to the Federal Government of U.S.A., summed up the case against centralised control when he said:

U.S. PRESIDENT WAS RIGHT

"No method of procedure has ever been devised by which liberty could be divorced from self government. No plan of cen-tralisation has ever been adopted which did not result in bureaucracy, tyranny, inflexi-bility, reaction and decline . . . The Fede-ral Government ought to insist the ten-dency to be loaded up with duties, which the States should perform. It does not fol-low that because something should be done the National Government should do it." the National Government should do it."

Why should the electors of any one State in Australia have to wait on what the in Australia have to wait on what the electors of another State think, before they do something about looking after their own affairs? If the idea is that no one should do anything until a majority is in favour of it, then we are heading for serfdom. The world planners want to extend the cen-tralisation idea on a world scale, so that no part of the world will be able to do anything unless the rest of the world agrees. This would mean that nothing would ever be done — except that which the world planners desired.

CENTRALISERS ANTI-CHRISTIAN

All progress has been the result of action by individuals — minorities. Those who sneer at minorities might bear in mind that our

Christian heritage is the result of action by a minority. Christ was at one time a minority of One. It can be truthfully said that centralisation is an attack upon Chris-tian ideas, because Christianity places em-phasis upon the importance of the indi-vidual. But the centralisers, the planners, regard their fellows as a mob to be con-trolled and governed

regard their fellows as a mob to be con-trolled and governed. It is no use people denying that the bureaucratic planners at Canberra want more power for the Federal Government because they know that this means more power for them to plan the Australian people. We have the words of the planners them-selves. For example, let us examine the fol-lowing remark by Dr. Lloyd Ross, made at Canberra early in 1944. He said: "But we need . . . the recognition of the need for more State control, State guidance, and State ownership." What is this thing called "The State," which this Canberra planner says should have more control? "The State" is, in reality, the bureaucracy. So what Dr. Ross means is that he and his

So what Dr. Ross means is that he and his friends should have more control, not only of the Australian people themselves, but also of the total resources of Australia.

THE PLANNERS' PROPAGANDA

THE PLANNERS' PROPAGANDA It is dreadful to hear some people, so mesmerised by propaganda that they re-peat political and economic slogans without the slightest idea of what they mean. The planners say that the making of "profit" is wicked and that a man who em-ploys a few dozen employees is an "ex-ploiting capitalist." But the same planners are asking the people to give them the power to command thousands of people un-der the guise of "State" control. Dr. Evatt no doubt had this idea in mind when he said on February 11, 1944, that "... full employment cannot possibly be achieved unless some authority is empowered to de-termine how employment is to be extermine how employment is to be expanded."

LESS weatth. At a time when the housing position is desperate and there is still a shortage of many goods and services, Mr. Ward, backed by Sir Harold Clapp and other people who visualise themselves as large-scale plan-ners, want to unify the Australian railway system!

What is urgently required is much more control by the electors, control over the spending of their own money, and much LESS control by the bureaucrats who are spending it for them.

WASHINGTON, 15/7/'46

MacKenzie King, Prime Minister of Can-ada, journeyed to Washington some months ago for the express purpose of giving our Government the names of certain Reds and pro-Communists on our Government pay-roll who had been co-operating with the agents of Stalin in Canada. Some of those pro-Communists named by King are still on our Federal navroll our Federal payroll.

The O.P.A. [Office of Price Administra-tion] is a "dead duck" regardless of any future legislation passed. Attempts will be made to revive it, but they will be unsuc-created cessful.

The atom bomb demonstration in the South Seas was somewhat of a disappoint-ment. It did not do the damage that had been anticipated.

A Nationalist Rally on June 28 was ad-dressed in St. Louis by Gerald L. K. Smith and the world-famed Christian Nationalist, Norman Jaquies [Social Credit], Member of the Canadian Parliament. Kenneth Goff, National Director of Christian Youth for America was serving on the reception com America, was serving on the reception com-mittee at the door. The head of the Com-munist Party for the City of St. Louis, whose name is John Rossen, struck Mr. Goff. The Red was immediately seized by the police and arrested. He comes up for trial July 10. Twenty other Communists, mostly Jews, were arrested the same night.

Ernest Bevin, Minister of Foreign Affairs for Great Britain, recently said that the reason the United States wants to open Palestine to 100,000 more Jews is because they don't want the Jews in New York they don't want the Jews in New York City. Because of this statement Bevin is now being accused of being anti-Semitic. The "Daily Worker," the official Communist daily newspaper published in New York City, said recently: "Bevin sounds like Gerald L. K. Smith."

Communist Civil Servants: The machinery Communist Civil Servants: The machinery for keeping Communists and other sub-versives off the Federal payroll has almost completely broken down. The gate is wide open for Communists to land Government jobs and keep Government jobs. There is almost nothing to prevent it. Congress-man Edward Rees, of Kansas, has been carrying on a fight attempting to introduce new legislation that would simplify the task of getting Stalin's friends off the paytask of getting Stalin's friends off the pay-roll of the United States Government. Thus far, the patriotic Congressman has failed in his efforts.

Randolph Churchill, son of Winston Randolph Churchill, son of Winston Churchill, said on Wednesday, June 26, in a feature article written in Paris, France: "A great many leading American and Brit-ish Jews have always opposed the estab-lishment of a Jewish State in Palestine. They have felt that if such a State existed, anti-Semitic forces in the United States might urge the desirability of American Jews settling there too. Ardent Zionists may deny this, but they know it to be the truth." truth.

Hitler, ary to the Socialist (Slave) State. Hitler, it will be remembered, retained the ballot box. It is not sufficiently realised that this mechanism provides only the most crude, unsatisfactory and imperfect form of de-mocracy, because it allows only for a mass decision, which must of necessity disfranchise, in that respect, the minority. Its application, therefore, should be strictly limited limited.

The greatest measure of genuine demo-cacy is provided by the money-vote, cracy which allows every individual a degree of freedom commensurate with his purchasing power. The fact that his purchasing power in the past has been arbitrarily and unduly limited is due to the activities of the manipulators who seek to undermine that freedom.

The attempt, which proceeds from the same source, to vest "full and unfettered" powers in a "national" Parliament is an attempt to disfranchise and enslave the individual by making him subservient to mass decisions arrived at by a misinstructed majority, who simply become the tools of majority, who simply become the tools of the controlling minority. It is only in this spurious form that "democracy" becomes compatible with Socialism.

THE NATURAL LAW OF SEGREGATION

(From "The Social Crediter.")

The Law of Segregation applies not only to physics as when oil and water are mixed and shaken together. Immediately the force of shaking is discontinued the oil and water begin to segregate until they are entirely separated, the oil on top of the water. Continued force is necessary to keep them mixed. The same applies to many medicines which when mixed are labelled "to be shaken before taking."

This physical aspect is more or less generally understood; but when applied to social matters this "natural law" seems to very much misunderstood and ignored. Hence arise all sorts of schemes for mixing people, on an equality basis, and even legislation is proposed, and taxation is im-posed, with the avowed object of reducing everybody to a common financial level.

Now this "Law of Segregation" can be observed as universal in human affairs in thousands of ways. Like all natural laws it is a benign law, and it is one of the reasons why in political measures decen-tralisation is advisable.

For many decades the European policy imposed on peoples has been centralisation under the names of Communism and Socialism, while the natural law of segregation is in universal unconscious operation striving after decentralisation. The malignant results of forced centra-

lisation are in evidence in Europe, Asia and America, and wars are the inevitable outcome. If history, ancient and modern, is studied from this point of view, the evi-dence should be sufficient to determine a reversal of the policy, but then the ques-tion arises, who makes the policy? The answer is not the purpose of this article, but quite a big literature exists on the sub-

It may be useful, however, to examine a few instances of the causes of segregation. Among animals differences of species and varieties thereof cause segregation.

Human beings segregate, or tend to do so, for a thousand and one reasons, such as colour of skin, difference of language, dif-ference of religion, even slight differences of habits and culture, differences of trades and professions. Government and civilian employees and the rich and the poor. Some segregation is temporary and some per-manent. Nationalities are very tenacious and permanent, because they include many minor and major differences, such as col-

Now all these segregations lead to variety in the world and an ever-changing variety, which may be called progress. Whereas controllication with concentration councility centralisation with concomitant equality leads to stagnation and the force which

must be used to maintain equality means slavery and death.

There are manifestations of segregation, which are not liked and are universally deprecated. That is where individuals of any particular group arrogate to themselves and behave to othere a theoreth they are and behave to others as though they are superior to all other groups. This, where wealth and poverty are concerned, is char-acterised as snobbishness. In nationalities and religions this arrogation is fatal to all peace and happiness in the world. The financial system and the Judaic policy

foster the aggressive spirit of this otherwise benign law of segregation, but the Douglas proposals would correct them. Probably, on account of this law of se-gregation, mankind has become gregarious.

That is, requires association with his fellows, and the first association he is born into is the family, and, in civilised com-munities, the family is founded as part of a nation. In this state of affairs where does the cherished desire of individualism come in? Individualism arises from the asserted right to join any group if willing to con-form to its habits, rules and customs, coupled with the right to secede from it without other loss than of being deprived of the transposition

of that association. The individual has spent thousands of years endeavouring to assert and sustain those rights. The tremendous issue involved is now at a critical stage, and the Douglas Social Credit organisation is the only seri-ous fighting body I know to assert and claim the rights of the individual.

The above thesis is probably capable of being extensively elaborated, but the writer's object is merely to call attention to it

The British Empire is almost a lone instance where secession has been often avoided by granting to integral parts greater local freedom, as for instance her colonies, towns and shires; but wherever large aggregations are attained by force and wher-ever force must be continued to sustain the aggregation, internal strife is perpetual until circumstances break up the aggregation.

- Headline in Melbourne "Herald" of August 31.

Lord Nathan is reported, under the above heading, as telling British women going to join their soldier husbands in Germany that: "You will have a good deal more food in Germany than you are accustomed to at home.'

Now, who won the war?

It appears that the international planners are not confident of maintaining the present scarcity policy indefinitely by the present methods.

The following report, from the "Daily Sketch" (England) of May 7 of this year, indicates that Mr. Isador Lubin and other international Jews are preparing for the future:

"An economics expert broke into the world-wide discussion on shortages yesterday when he told the Economic Employ-ment Commission of U.N.O. in New York that he envisaged a world surplus within the next few years. He is Mr. Isador Lubin, U.S. representative on the Commission. De-claring that such a crisis must be fore-stalled, he recommended that the secretariat begin investigations immediately to formu-late counter measures. Dr. Alexander Loveday (Great Britain) concurred, contending if no such measures were taken economic stability would be threatened."

A further dose of "planned economy" on a world scale is clearly indicated.

Mr. Norman Jaques, Social Credit M.P. in the Canadian Federal Parliament, said in a recent broadcast that he received the fol-lowing letter from a well-known farmer in his electorate:

"Many farmers are giving up their farms because they refuse to continue to work 365 days in the year and then if they happen to have a profitable year they must give away 30 per cent, or 40 per cent, of their profit in order to pay their taxes. I am telling you, and those in power at Ottawa, they have got to do something or there will not be any good farmers left in my district."

There is a "Liberal" Government in office at Ottawa. But it pursues the same de-structive taxation policy as the "Labor" Government at Canberra. There are some honest but naive people who believe that Mr. Menzies would do much better than Mr. Chifley. It may be that these people will have to learn the hard way. Chang-ing Governments without electors controlling their individual Members of Parlia-ment is of no avail.

The President of the World Bank estab-lished as a result of the Bretton Hoods Agreement is the Jew, Eugene Meyer. According to "Newsweek" (Canada) of June 17, Meyer is one of Bernard Baruch's disciples.

Meyer bought the bankrupt "Washington Post" for 825,000 dollars in the early days of the Roosevelt regime, and used this journal to support Roosevelt's New Deal (i.e., socialistic measures). The "Washington Post" supported the dollar loan to Great Britain.

There are many methods by which dissension can be caused, and they are all well known and fully employed by party politicians. Split into sec-tions, which are played off one against the other, the electors find themselves side-tracked and thwarted no matter what partytag their government bears. They find themselves diverted from the desired results to a bitter and futile discussion of methods. If each individual elector will decide what he wants (for himself—not the other fellow), it will soon become apparent that there are certain definite objectives, which are desired by all. These results should then be de-manded, and nothing else accepted in their stead. No party is more important than the

It does not matter which candidate is elected; what does matter is that both he and the electors recognise that he has been selected to represent their desires and exert pressure to obtain the results they want.

It is not the function of an elected repre-sentative to tell his constituents what he thinks they should have, or to force his own or anyone else's policy upon them. It is more important to get careerists and unsatisfactory men out of Parliament than to get so-called "good men" in; and no matter how clever or fluent he may be or how much publicity or fluent he may be, or how much publicity he receives, no Member can be regarded as satisfactory unless he has consistently fought for the liberty and security of all his consti-tuents, and guarded their sovereign rights. Each individual's well being is his own business, and if he will not mind his own business, he will find that there are people very anxious to mind it for him—to their own advantage

The elector requires to make full use of his own power and authority, and to this end it is necessary that the power of centralised government be progressively lessened not increased.

The Federal Constitution is the Australian people's last defence against tyranny, and must never be permitted to become the plaything of party politics. -Yours, etc. J. A. LANNEN.

BRETTON WOODS AGREEMENT AND U.S. LOAN

Mr. Abbott—"... Recently, in. answer to a question by the honourable Member for Moreton (Mr. Francis) the Prime Minister said that if the proposed loan to Great Bri-tain by the United States of America was not authorised, Australia would be faced with an acute "shortage of dollars. One of the essential features of the proposed loan to Great Britain is that that country must subscribe to the Bretton Woods Agreement, Under clause 11 of the agreement, a coun-try, which subscribes to it, is forbidden to trade with, or have economic relations with, any other country that is not a signatory to the agreement, if such country is not carrying out the terms of the agreement. The Commonwealth Government is afraid to affirm either its acceptance or rejection of the agreement before the forthcoming general elections. It knows well that eventually Australia must sign the agreement unless it is prepared to shatter its export trade by failing to share in the dollar pool which the authorising of the loan to Britain by the United States of America would create."

ELECTRICITY FAILURES IN PERTH

"On June 25, Perth experienced another power break, although this time a compara-tively short one of about half an hour

"The serious breakdown, which caused Perth to be practically without power and light for three weeks, ended on June 24, when the General Manager of the Electricity Supply reported that repairs to No. 5 turbo generator of 12,500 kilowatts capacity had been completed and the unit was back on load on June 22, thus enabling all industrial concerns to recommence and take their full power as from June 24.

"There have been a lot of repercussions as the result of this breakdown, and a lot of criticism through the press. The Nedlands Roads Board passed a resolution at one of the Board morting requesting the Govern the Board meetings requesting the Governthe Board meetings requesting the Govern-ment to appoint a Royal Commission to en-quire into the whole reason of the break-down and the set-up of the powerhouse generally. This request has been keenly supported by many other Roads Boards and public institutions, and has been favourably received by a large number of inductrialiste received by a large number of industrialists.

"The Deputy Premier and Minister for Industrial Development, the Hon. A. R. G-Hawke, was reported in the, daily press as having 'pooh poohed' the idea of any enquiry. He stated that the breakdown was due purely to an accident and was just bad luck. Naturally, Mr. Hawke is not likely to wel-come any criticism of the Government's lack of supervision or foresight in proper planning in respect to Perth's power supply station. Correspondents in the press, however, have pointed out that, notwithstanding war-time difficulties, an environment of company in difficulties, a privately owned company in South Australia supplying electricity to the City of Adelaide, and privately owned power stations in Queensland, have been able to-expand and develop and increase their output. Generally speaking, the whole occur-rence has raised a great deal of controversy."

"SMEARING" PRIVATE ENTERPRISE

(A letter to the Editor from Bruce H. Brown. Continued from last issue.)

Sir, -From what was written last week it is reasonable to conclude that "the press" is no criterion of what a man's conduct ought to be. It can be shown (and HAS been shown by the "New Times") that "the press" perverts news and prostitutes opinions, and that any so-called "exposures" are invariably of a nature to suit the policy of those who control news collection and news distribution.

News of benefit to the people, such as the progress in Alberta up to last year, is carefully excluded.

The young lady's contention that I should reconcile my attitude towards Private En-terprise with what she has been reading in "the press" must therefore be rejected. Apart from this, however, my correspondent made three particular points, as fol-

Whilst money and ownership are the basis for privilege and survival, men will fight for both money and ownership.
She could not see how the proposals

of Douglas would minimise the ultimate victory of lust and greed if these things are not stamped out from their very root. (3) The co-operative rather than the competitive order must be brought about.

OWNERSHIP AND INCOME

A man may own nothing but will have no anxiety about survival if his income of MONEY is adequate and assured. Own-ership in the sense apparently put forward by the young lady is NOT necessary to survival OR privilege. If he has the money he has an effective claim to food, clothes, shelter, and use of all services, as he desires them. I personally have no de-sire to be an owner, but I have the strongest desire to have regular and uninterrupted access to the necessities of life for myself and those depending on me. If we could personally contact the great

If we could personally contact the great bulk of the population we would find that almost all of them do not hanker after ownership beyond their home, but they would all admit that the struggle to get MONEY is continuous and hard. And so it is obvious, I think, that those who con-It is obvious, I think, that those who con-trol the stuff for which we all have to fight are the controllers of the conditions under which we live. They are also the controllers of what is called "co-operation," for that can take place only within the financial rules as we find them.

THE SCRAMBLE FOR MONEY

As to the second point, I confess that I have difficulty in understanding what is have difficulty in understanding what is meant by the words "the ultimate victory of lust and greed." The terms have not been defined, but presumably the lady has in mind the existing practices by which businessmen go after profits while the going is good and the rest of us scramble in other ways for what we can get. The truth is that under the existing FINANCIAL POLICY all of us are studiously and pur-posely warned to be constantly prenaring posely warned to be constantly preparing for the "rainy day." This rainy day is the evening time of life, the period of so-called economic depression, or the day when we are laid aside by illness. To meet the first, most of us fall into permanent debt to an insurance society and pay taxes for pen-sions; to meet the second, the businessman makes the most of his opportunities before financial rastrictions are imposed upon him financial restrictions are imposed upon him, and all of us are taxed to provide a dole for the poor old "worker" when he is thrown on the industrial scrap heap; and to meet the third, we have to "save," subscribe to a "benefit" society, pay taxes for social "security," or meet the FINANCIAL strain in some other way.

All these things are the product of the financial policy, which controls us. They are NOT the result of what is called lust and greed within the individual: they are the result of conditions IMPOSED by cer-tain persons. We must therefore identify these persons and remove the conditions.

SOCIAL CREDIT WAY OUT

Under the Social Credit proposals put forward by C. H. Douglas there will be no fear of a "rainy day." Every citizen will be entitled to an increasing share of the benefits of an expanding economy, and that share will be distributed in money. There will be no mental anxiety about financial provision for the evening time of financial provision for the evening time of life. There will be no periods of economic the result of an alien and artic Critician and greed will then be shown to have been the result of an alien and anti-Christian financial policy imposed on the WORLD by men actively working against Christianity. It will have been "stamped out from its very root," a root far different from that visualised by the lady who wrote to me. Social Credit is the only means by which this can be done this can be done.

CO-OPERATION AND COMPETITION

As to point 3, co-operation could not exist without enterprise, and I venture to believe that less enterprise is found in Governmental instrumentalities than in private businesses. It is true that Governments are enterprising enough in imposing restrictions and burdens, but enterprise in the realms of production, development, in-vention and industrial progress is found mostly in non-governmental activities.

mostly in non-governmental activities. A lot is said about cutthroat competition, and few would argue that it is not the product of Satan. But this "competitive order" is imposed upon the people of the WORLD by a group of men seeking world control. They do not PERMIT co-operation. They prescribe that all international rela-tionships shall be on the basis of buying and selling. The idea of one nation GIV-ING to another is unthinkable to them. Straight out EXCHANGES are forbidden, and everything that is done must be subject and everything that is done must be subject to the financial conditions imposed by the persons referred to. Talk of co-operation under present conditions is a waste of breath, but under Social Condit conditions it will

but under Social Credit conditions is a waste of ofearin, but under Social Credit conditions it will be the order of the day. The immediate task is to prevent the concentration of more power into the hands of the group of persons now controlling financial policy, and the immediate means for preventing it is an overwhelming "NO"

MR. LILLICO DEFENDS UPPER HOUSE

(From the Burnie "Advocate," 26/8/'46.)

The bitter and untrue criticism of the Legislative Council's so-called "Tory" Members by the Premier (Mr. Cosgrove) probably had its genesis in the failure of his persistent efforts to induce the Council to pass what was then known as the Cosgrove plan, said Mr. A. Lillico, M.L.C., at the weekend.

That was the reference by State Parlia-ments of most comprehensive constitutional ments of most comprehensive constitutional powers by means of a departure from the democratic provision so definitely laid down in the Constitution, he said. "We were not concerned about the authorship of this plan for the infringement of the democratic rights of the electors; we were not there to look after the rights of the privileged class, as the Premier says the function of the Council is, but rather to see that this State Parliament would not stultify itself by usurping the democratic rights of the electors, who by their yote had brought into being the National Parliament, and who had the unassailable right, clearly defined in the Constitution, to amend it if thought necessary," he said.

PRIVILEGED PERSONS: Hugh Chevins, Industrial Correspondent for the London "Daily Telegraph," writing on the Socialist, "classless" Soviet State, tells of members of a highly privileged class who "enjoy in-comes and standards of living on a scale of extraordinary affluence compared with the average wage-earner." He tells of a highly complicated method of payment, which even "the chief of the Soviet Trade which even "the chief of the Soviet Trade Unions (Vassili Kuznetsov) did not under-stand." Further, he says: "The average wage-earner's income will not buy basic rations for a family with a wife and two children." (Melbourne "Herald," August 9.) This is just one more testimony to dispel the inspired propaganda, which has fooled many trusting people into believing that Socialism had improved the people's living conditions

conditions.

INDUSTRIAL PROBLEMS: Willingness is expressed by employers' and employees' representatives to get together in an attempt to remove the causes of industrial friction. It is just possible that this move will lead them to realise that the fault does not lie with either section, but with the existing industrial and financial economics. If their deliberations bring about a realisation that they have a common enemy, and they de-cide to unite efforts to correcting the financial policy, which sets employer and em-ployee at each other's throats, then peace in industry may be achieved. If they rea-lise that industry does not distribute suf-ficient purchasing mounts to purchase its ficient purchasing power to purchase its production, it should not take them long to see that in order to overcome this fault, now money must be distributed to indi-viduals to bridge the gap between incomes and prices.

BRITAIN'S BUREAUCRACY: One year after the war for freedom, every British newborn baby must have an identity card. Although identity cards were introduced in emergency, this card is valid until 1962. Bread zoning for the first time in British bistory causes so much muddle and waste history causes so much muddle and waste that pigs are having a banquet on waste bread alone. Meanwhile, according to Mr. Justice Stable, "in intolerable jargon, the Board of Trade issues unintelligible orders

and then prosecutes poor wretches who can-not make sense of the senseless." The bureaucrats have practically destroyed Great Britain's soft fruit industry and made it un-economic to collect the plum harvest. Presumably this is Great Britain's reward for saving Europe from Hitler and then helping to feed Europe while the new Red Despot takes over.

NATIONAL DIVIDENDS

(Translated from a booklet by Louis Even, and published by "Vers Demain," Quebec.) A dividend is not a salary. The salary is tied to labour. The dividend is tied to a capital, earned or inherited. The national dividend, an amount of money given requerky to each man woman

money given regularly to each man, woman and child of the country, is an integral part of the Social Credit doctrine, because Social Credit proclaims: (1) The existence of a common capital;

(2) The right of each person to a vital minimum.

Science, applied, acquired and developed in the course of centuries, is a common capital, a common property. If each member of society does not receive from it a real ad-vantage, from birth to death, there is frus-tration, injustice, theft of inheritance. The national resources—such as our forests

The national resources—such as our forests, our water falls, so important in Canada—are common capital.

And many other things constitute common capital. The Social Credit dividend insures to every person a minimum income from this common capital, without cancelling the reward of individual labour, because money thus liberated will go to those producing and distributing goods.

Each person has a right to life. And since, in our modern world, it is impossible to exercise this right to life without rights on production, taking the form of money, a minimum of these rights on production must be, in some way, guaranteed to each person, from birth to death.

In a country that can produce more than the citizens can consume, it is tyrannical to refuse to each at least a vital minimum. The national dividend excludes this tyranny.
