Lower Living Standards Ahead

Government's "Drastic Remedies"

Speaking at a Country Party Conference in Brisbane on July 25, the Federal Treasurer, Sir Arthur Fadden, clearly indicated the "shape of things to come" when he said: "We do not claim we shall produce ideal solutions to Australia's problems, but we are confident we shall produce solutions that will work... We shall not hesitate to take bold and resolute action to deal with our problems. It will be like a strong dose of medicine — hard to take, but ultimately beneficial to the recipient. Drastic complaints need drastic remedies." Sir Arthur's statements are similar to those being made by other Government spokesmen, who are desperately attempting to create an atmosphere of panic in which the people can be high-pressured into accepting their "medicine" — more totalitarianism.

In spite of definite promises made before the 1949 Federal Elections, that he and his colleagues could and would deal with inflation, Mr. Menzies watched the inflation problem growing progressively worse and was apparently not going to take any action until the recent announcement of the 12/- increase in the basic wage forced him at least to give the impression that the Government was at last going to get to grips with the problem. But the proposals already suggested can only lead to even greater hardships for the majority of the people. We desire to go on the record now as saying so far from the Government's suggested policies producing "solutions that will work," they will strike a heavy blow against what little independence is left in this country.

It is true that at long last the Government has been compelled to admit that the Federal bureaucracy should be reduced and that the big immigration scheme has been contributing to inflation. But this belated admission means that the Menzies Government has been deliberately contributing to inflation over the past two years. It was prepared to continue doing so until pressure forced Mr. Menzies to make his dramatic announcement concerning reduction of the Federal bureaucracy. However, even this announcement does not impress us. It is largely "window dressing," as time will demonstrate. We venture to predict now that in six months' time the size of the Federal bureaucracy will be little less that it is today. The bureaucracy will strenuously resist any proposal to reduce their numbers. There is only one way in which a genuine reduction can be made, and that is by the Federal Government disgorging many of its powers and completely abolishing a number of Departments. The proposal to curtail immigration is welcome, but we would draw attention to the fact that already much actual and potential damage has been done to our community by the importation of a

large number of undesirables from Europe.

The central feature of the Government's proposals to deal with inflation is, of course, a deflationary financial policy — although we feel that this may only be temporary in order to control the people to submit to more instalments of the centrally planned State. We are amazed that any logical person can accept the proposition that increased taxation and a policy of credit restriction are a genuine solution of the inflation problem. The "economic experts" whose views the politicians merely parrot, claim that there is a "surplus" of purchasing power which must be "mopped up" by heavier taxation. This will prevent a continuation of "luxury spending" which is allegedly diverting valuable manpower and materials from "essential" production.

Now inflation has become so severe that the great majority of the people are finding it progressively harder to maintain their standards of living. They are short of adequate purchasing power. There are comparatively few people with a "surplus" of spending power, while most of the

"luxuries" being bought—washing machines and other labor saving devices for the housewife, are on the time-payment system. Surely it is obvious that heavier taxation must immediately reduce the already inadequate purchasing power of the people still further. All taxation imposed on industry must be costed into prices and thus paid by the consumer. Heavier taxation must therefore increase prices, not reduce them. But, again demonstrating his acceptance of Socialist propaganda, Mr. Menzies has inferred that industry can pay increased taxation out of profits without increasing prices; that industry has been profiteering.

U.S.A. Government Helped Communists Steal Atomic Bomb

In his book, "The Red Plot Against America," Robert E. Stripling, Chief Investigator of the House of Un-American Activities, 1938-1948, writes that "The Soviet Purchasing Commission flew more than half a ton of Lendlease uranium oxide and 25 pounds of uranium metal out of the U.S. over the protests of Gen. Leslie R. Groves, in the midst of our secret development of the A-bomb." Although Groves appeared before the Un-American Committee, he was unable to give a great amount of detailed information concerning Communist espionage in the American Government because of a Presidential direction.

The following article from the May issue of "The Canadian Intelligence Service" provides further evidence of how highly placed persons in the American Government made it possible for atom bomb information to be passed to Soviet Russia:

"The American Mercury" magazine (April) reveals, for the first time, how the American State and Justice Departments in 1943 actually helped Soviet agents steal our atomic secrets, refusing to let F.B.I, and Army Counter-intelligence officers arrest Red agents as they handed secret atomic formulas over to Soviet officials.

Mr. Bradford Huie, editor of "Mercury," brings out the following revealing points:

That the American Government first tried to deny that espionage crimes had been committed, and then, when this could be denied no longer, did everything possible to shield the criminals.

That there are two groups of guilty Americans: (1) the men who actually conspired to deliver information into Russian-employed hands, and (2) the officers of the U.S. government who knew that such deliveries were being made and who, nevertheless, prevented the arrest of the conspirators

That the Comintern is believed to have learned of our experiments in nuclear physics as early as 1939, and by 1940 had organized espionage cells to relay developments to Moscow.

That the head of the cell in the important Radiation Laboratory at the University of California was Steve Nelson, who was born Stefan Mesarosh in Yugo-

slavia, entered the U.S. illegally and under an assumed name, and went to Russia about 1931 to study treason at the Lenin Institute. "Nelson" went to Spain about 1937, under the name "Fleischinger," fighting as a Lieutenant Colonel with the Reds in the Spanish Civil War.

It is believed that one of the reasons Nelson was given this important atomic secrets assignment was because he was a friend of a woman named Katherine Harrison, whom he had first met in Spain in 1937. She was a biologist with pinkish leanings, who returning to America, transferred to the University of California and married Dr. J. Robert Oppenheimer, the man who was to direct the assembly of the

Dr. Oppenheimer has testified before the House Un-American Activities Committee that he was never a member of the Communist Party; his wife has not yet been called to testify; but his brother, Frank Oppenheimer, has admitted Party membership.

The "Mercury" article then discloses: That included in Nelson's cell were:

Giovanni Rossi Lomanitz, David Joseph Bohm, and Joseph Weinberg.

That agents of the F.B.I, and the Army's Counter-intelligence Corps, working together, knew the members of this cell and tailed them. "And the agents were not asleep on a dark night in March, 1943, when Dr. Weinberg made his way to 3720 Grove Street, Oakland, which was Nelson's home." He delivered to Nelson vital information on the atom bomb.

American security agencies, knowing the importance of this formula, were appalled. Hurried appeals were made to the State and Justice Departments to allow the arrest of Nelson, Weinberg, and the others. These appeals became even more frantic when the F.B.I, and A.C.I.C. officers a few hours later heard Nelson telephone the Soviet Consulate in San Francisco and make a date to meet the vice-consul, Peter Ivanov, that afternoon at the "usual place."

With perhaps the future of Western civilization at stake, both the State and Justice Departments refused to authorize an arrest, and the next afternoon the officers had to endure the ordeal of watching Nelson meet Ivanov on the grounds of the St. Francis Hospital in San Francisco and hand him the formula.

The F.B.I, and A.C.I.C. officers kept the Government informed day by day of the treason of these conspirators, but the pro-Communists in the State and Justice Departments refused to "interfere."

On July 1 1944, Dr. Martin David Kamen, a chemist at the Radiation Laboratory, was observed by Counter-intelligence Officers

passing secret information to Kremlin agents.

In August 1943, according to sworn testimony, a meeting was held in the home of Dr. Weinberg in Berkeley. In attendance were Bernadette Doyle, Nelson, Lomanitz, Irving David Fox, David Bohm, and Ken Max Manfred, formerly known as Max Bernard Friedman. All except Doyle and Nelson were then employed at the Radiation Laboratory and working on the atomic project, and all have been identified as members of the Communist Party.

No actions against any of this group were taken by the United States Government between 1943 and 1948. Nelson became chairman of the Communist Party in Western Pennsylvania. Weinberg found a safe haven as an assistant professor of physics at the University of Minnesota. Dr. Bohm stayed on at the Radiation Laboratory in Berkeley until 1946, then going to Princeton. Lomanitz batted around from California to Cornell until 1948, when he went to Fisk University in Nashville. A word raised against any of them, or against Frank Oppenheimer, was denounced as "persecution" by most of America's "free" press, including Time Magazine and the like.

A classic example of the kind of sloppy "tolerance" the Reds and left-wingers are pumping out today has been our failure to deal effectively with these traitors, these enemies of America.

In September 1948, the House Committee on Un-American Activities recommended that Nelson be prosecuted under the Espionage Act of 1917. The Department of Justice declined to act.

The House Committee recommended that Dr. Weinberg be prosecuted for perjury, but the Department of Justice has taken no action, and Weinberg continues to teach American youth.

Giovanni Rossi Lomanitz is still openly

promoting Communist activities.

In all the history of governments there is perhaps no parallel to this incredible treachery in high places. It is this same administration, which by secret agreement, sold out Poland and Eastern Europe to Russia, undermined and double-crossed Nationalist China, finally plunging us into Korea.

As informed observers in America now know, the hidden hand behind this treason is the Niles (Neyhus)—Lehman—Morgenthau—Frankfurter conspiracy. Until these elements are dismissed, treason will be the order of the day in America. The first step back toward the redemption of America is: Clean out the traitors and replace them with loyal, Christian Americans.

CREDIT POLICY

In their desperate efforts to try and placate an outraged public opinion, it appears that the politicians are prepared to accept the opinion, it appears that the politicians are prepared to accept the proposition that a policy of credit restriction is necessary to defeat inflation. It is now generally known, of course—even amongst politicians—that any policy of general credit restriction must result in deflation. One major result of a deflation policy is the intensification of the process of economic centralism taking place under inflation. Small and medium-sized businesses are immediately destroyed, or are compelled to amalgamate with sections of Big Business. Apart from its effect upon industry, a policy of general credit restriction, even if only maintained for a short period, must ruin hundreds of thousands of individuals who are attempting to buy homes, furniture, and household appliances who are attempting to buy homes, furniture, and household appliances

under various systems of time payment.

As we have demonstrated time and time again over the years, and surely events have confirmed what we have had to say, while present financial rules are maintained, the economic system can only function while the volume of financial credit is being progressively expanded. But this expansion automatically results in inflation and all that it means. All the talk about increased production and harder work does means. All the talk about increased production and harder work does not alter this fundamental fact. The alternative to growing disaster under a policy of credit expansion is not even worse disaster under a policy of credit restriction. We believe that those responsible for credit policy today, the economic planners like Dr. Coombs, are well aware that irrespective of whether credit is restricted or expanded under present financial rules, the independence of the individual is progressively undermined and the power of monopolistic organisations over the individual increased. Many of the politicians may be panic stricken, but their panic is being shrewdly exploited by the planners

over the individual increased. Many of the politicians may be panic stricken, but their panic is being shrewdly exploited by the planners who are calmly imposing their policy of monopoly.

We are well aware that there are many well-meaning people, including some politicians, who believe that the volume of credit has been "over-expanded" and that there can be a "moderate" policy of restriction, not sufficient to produce depression conditions. Those who have this conception of credit policy, something to be "managed" arbitrarily by planners, irrespective of whether they are bankers or bureaucrats, are supporting a policy of monopoly. A little thought should convince any reasonable person who supports the idea of individual sovereignty, that credit policy, which governs the entire economic life of a community, should not be the plaything of a few people. There is much talk about our "scientific age," but apparently credit policy is something to be decided arbitrarily. Thus the fantastic spectacle of a proposed credit restriction policy because of political panic. The volume of credit required by a community should be governed automatically by the facts of production, not by a few individuals. Credit policy should be decentralised in the hands of all the individuals who make up a comdecentralised in the hands of all the individuals who make up a community. They should decide how their credit is to be used. If over a given period the economic facts reveal that an expansion of credit is necessary to help the community purchase what it has produced, this credit should pass directly to the individual via a system of price subsidies, which would prevent inflation. As both inflation and deflation are the direct results of present financial rules, surely the first step towards stability is a critical examination of these rules with a view to suitably modifying them?

"United" Nations Fomenting War

Douglas MacArthur made it clear in his address to Congress that he had no faith in any United Nations scheme as a means to prevent war.

This writer often has pointed out that no world government could keep the peace unless it were an all-powerful world police (such as Stassen and Eisenhower call for) — which would suppress all liberties—and that even such a dictatorship would have to wage wars constantly in order to "enforce peace."

Here are some other reasons why the United Nations should be abolished or America should withdraw (and set up a committee of co-operating nations, with no world government designs).

Twenty-nine percent of all foreign U.N. officials are known Communist spies, under surveillance by U.S. Intelligence (as stated in a Fulton Lewis column, January 30, 1051)

The U.N. is freely claimed by leading Zionists as their invention. It is their power device. And it was the Communist Alger Hiss who presided as Secretary-General at the formative conference in San Francisco in 1945; and it was Hiss who principally steered the important committees, including that which established U.S. participation policies—as files in your public library will substantiate. Thus, the

U.N. was effectively shaped to suit the Kremlin and the Zionists, who worked closely with Hiss.

The article describes Feller as "a 45-year-old ex-New Deal lawyer" who "plays a central role in the doings themselves. Abe Feller . . . went to the founding and organizing conferences at San Francisco and London as an adviser to the United States delegation" (on the staff of Alger Hiss).

Another contributor to the Socialist policies is "David Weintraub (who) came to the U.N. by way of long and high-level services with the New Deal and then U.N.R.R.A. . . . Weintraub was director of procurement (for U.N.R.R.A.—Ed.), was snatched up by U.N. and has been running its division of economic stability and development ever since . . . Weintraub became a top government economist in the United States, directing research for Harry Hopkins' social welfare programmes.

"Today he is looked upon as the father of U.N.'s technical assistance programme, providing technical aid — personnel and know-how—to under developed countries . . . in industry, agriculture and social welfare "

This seems to be the planning body through which the international bankers and proletarian organizers have inspired President Truman's "Point Four" to develop "backward areas all over the world," using U.S. tax money to build jungle roads and otherwise pave the way for investments by international financiers who in turn will compete with bona fide American industry. Facilitating the various processes at the U.N. is Monsieur Georges Rabinovitch "who heads up the world organization's famous group of interpreters." M. Rabinovitch, the Jewish Exponent tells us, "fled from Czarist Russia," but it does not say why. 

Teeth and the Organic Method By J. I. Rodale

One of the first dividends our family received from the practising of the organic method and the eating of foods raised organically was a noticeable improvement in our teeth. There were less and less cavities every time we went to the dentist.

In the case of our youngest child, Nina, who is now thirteen, the condition of her teeth is perfect. She does not have a single cavity in any of her teeth. This was made possible in her case because she was only about three years old when we began to eat food raised organically. In my own case I have not had a cavity in five years. Hundreds of our readers have also noted a wonderful improvement in their teeth. Typical is the case of a family of three that came to see me recently, who told that where they used to have a yearly dental bill of about a hundred dollars, it is now reduced to about ten dollars, and consists only of routine cleaning. Only a few days ago a woman from Rhode Island told me that she stopped having cavities five years ago, after she began eating organically grown food. And, the peculiar thing is, far from their entire diet is organically produced. Usually the organic portion consists only of the vegetables that they raise in their own garden. Some purchase organically produced food through the mails. It is amazing what a small amount of organically produced food will do for the health of a person.

Permit me to quote an item from the "Field Magazine," published in England, dated January 6, 1945:

"I was interested in your letter from 'Dental Surgeon,' because my seven-year-old son and I have only just paid a routine visit to the dentist. He seemed quite unusually impressed by the excellence of my son's teeth and asked me if he had had any special diet. I told him: No. That he had eaten no meat (including eggs) up to the age of three years, but since then had eaten meat and exactly what he liked. I added, however, that we grew as much of our food as possible on compost soil and that for more than his lifetime we have never used an ounce of artificial fertilizers.

" 'You have given me the answer,' said the dentist. 'Now I understand why he has

teeth like that.'

"In my own case, my teeth used to collect huge quantities of tartar. Every year it had to be scraped off. We began using compost instead of artificials toward the end of 1936. When I went to my dentist in 1942, after a lapse (I am ashamed to say) of two-and-a-half years, I expected a terrific scraping to occur. There was no tartar to remove. Another two years elapsed before I went again, this last time. There was a very little tartar behind two teeth, and that was all

"We have used compost for just about eight years, and for the last five of those years my teeth have lost their unpleasant habit of collecting tartar. Is this a coincidence? It might be. But I was telling this story to someone else, and she has had exactly the same experience. Incidentally, I asked the dentist if wartime diet could have anything to do with it. He did not think it had, because he finds now just as much tartar collecting on his other patients' teeth as before the war."

out. 'Neither is it difficult to suspect that prolonged abscesses, pouring toxins into the blood stream, might well show up eventually in kidney disturbances, high blood pressure, or heart diseases.'

"Dr. Scarseth said that data collected by physicians, biochemists, agronomists and engineers working on the problem of soil deficiencies 'indicate there must be a close relationship between the fertility of the land and well-being of the animals that consume the crops.

In the March 1946, issue of the "Dental Magazine and Oral Topics," published in England, appears an article that shows the remarkable effect of organically produced food on the teeth of young boys and girls. I am going to quote the entire article. It was written by and represents the experience of E. Brodie Carpenter, a dentist:

"The effects of increased quantities of healthy food on the teeth of the children of the Royal Commercial Travellers' School.

"This school was founded one hundred years ago for the orphans of commercial travellers. The numbers vary from term to term, but in recent years there have been about 95 girls and 135 boys in two separate establishments in the same buildings. There is a good deal of land attached to the school, and from it in the years before the war the school was getting a certain amount of its vegetables. When war was obviously inevitable, the head gardener ploughed up a further five and a half acres, which used to be a paddock for the horses, and brought this under cultivation for vegetables also. Every year since then he has grown more and more vegetables until now the school buys none at all.

The system of agriculture would meet the approval of the most fastidious of the 'natural manure school.' Every ounce of waste is returned to the soil, and up to a hundred pigs are kept for their manure, which is composted with clippings from the playing fields and with straw. No artificial

manure is used at all. The vegetables grown are like the pictures on the seed packets.

'It is a curious fact that part of the fiveand-a-half-acre field is silt from the River Pin: this is in accordance with agriculture on the banks of the Nile. It is even more extraordinary that a smaller field was used by the L.M.S. for spreading the night earth from Hatch End Station in the days of earth closets: this is the method of the Chinaman, who has cultivated his own bit of land with his own and his animal's wastes for 4,000 years.

"The produce of the school's land has gone up by 33-1/3 percent since the war for nearly a hundred fewer children, the number now being 240-250, whereas before the war they numbered as many as 340.

'Now what is the effect on the teeth? I took up the appointment of dental officer at the school in 1939, and at the first examination was very perturbed at the state of affairs. I graded the boys and girls into 'A' for none to two cavities, 'B' for three to five, and 'C' for six and upwards. 'A's' were 50 percent, 'B's' 32 percent, and 'C's' 18 percent, and I found a number of cavities in 'fronts.'

"I settled down to an oral hygiene campaign and started with the 'fronts,' but the trouble was that all the children leaving had to be completed by the end of the Christmas term. I toiled on through that school year and the next, examining them every nine

"In September, 1941, things were no better: 'A's' were 56 percent, 'B's' 27 per cent, and 'C's' 17 percent. In 1943 and early 1944 there was a very obvious general improvement—cavities were fewer and the unhealthy, gluey sort of saliva so often seen in the adolescent age was decreasing. By 1945 the examination showed that 'A's' were 97 percent, and 'B's' 3 percent.

This was dramatic enough, but in September, 1945, there was an average of a quarter filling per child, and the boys were 100 percent. 'A'. Out of 230 girls examined in a period of nine months, the child (a girl) with the most cavities had four. (Grading of the girls: 'A's' 97 per

cent, 'B's' 3 percent.)

This simply astonishing change, I feel quite certain, is to the credit of the Board of Management and of the Gardener-not mine. How else could one account for the absence of incidence?

"I am well aware that there are other items of diet, but I am convinced that, provided that there are no excesses in the rest of the diet, fresh vegetables provided by a sound system of agriculture are the

corner-stone of dental health.

The bread at the school before the war was not white but a special bread 'Nevill's loaf. I consider 100 percent, wholemeal to be the ideal. The children nave always nad enough milk, and sweets (if these make any difference, which is doubtful) have always been regulated. The animal protein is restricted, as are fats. Eggs are new-laid on the premises. The diet, in short, is an ordinary all-round one, except that the 'vegetable protein is properly synthetised' and in abundance.'

Now let us compare this with what workers at the School of Dentistry of the University of Minnesota are discovering about the teeth of the students of that institution. There were three successive

studies that began twenty years ago which were written up in the April, 1951, issue of "The Journal of the American Dental Association." I quote a portion:

The 3,388 freshman students, both men and women, who entered the University of Minnesota in 1929 averaged 9.95 teeth affected by dental caries. The 4,348 students who entered ten years later, in 1939 had 11.8 teeth so affected. The 4,412 who came to the University in 1949 averaged 13.7 teeth affected by caries. All differences are

statistically significant.

"Though started only 20 years ago, these decennial reviews of the dental condition of university freshmen really cover a period of approximately 40 years. The young people who entered the University in 1929 at an average age of about 19 years were born in 1910 or thereabouts. The period since that time has produced more benefits for dental health than any other period in the world's history. Nutrition, particularly among the American people, has greatly improved. Dental hygiene has become an almost universal practice, at least by the majority of persons in the higher socio-economic levels to which university students belong. Dental health education has been carried on at a constantly accelerating rate since 1910, and its emphasis has been increasingly on the desirability of early and frequent dental care to prevent the deterioration and loss of teeth.

"Nor has all this good advice been dis-regarded by the public. The teeth of most of these university students had been given good care. These young people keep their teeth clean and they go to their dentists to obtain fillings and other repairs or replacements when these are needed. The point is that they are needed. Despite all the care and attention that has been and is being given to the teeth of university students, these teeth are now decaying to a greater degree than they were 10 years ago and a still greater degree than they were 20 years

In the 1929 group of university freshmen there were 3,388 individuals, of whom 61, or about 1.8 percent, had teeth entirely unaffected by caries. In the 1939 group,

consisting of 4,348 students, there were only 51 who showed no evidence of caries, about 1.15 per cent. In the 1949 group, consisting of 4,412 students, only 30 had perfect teeth, a percentage of 0.68."

It is stated in the above article that the nutrition of the public has improved since 1910. That positively is not so. The everincreasing amount of chemical fertilizers used in growing our food crops and the greater amounts and increasing potencies of the poison sprays is causing an alarming degeneratism in the nutritional quality of our food. This does not take into consideration the increasing amount of tampering with foods in the factories where it is processed. Our foods are becoming more and more devitalized and our teeth and general health will retrograde more and more as this tendency continues. Where will this all lead to? If the present method of food production continues for another fifty years, I see chaos in our mouths and in our bodies. Also, more cancer and polio will result, until there will be complete revolt by our bodies. The figures at the University of Minnesota are only one sign. There are many others.

That the health of the teeth depends on the fertility of the soil in which our foods are grown has been demonstrated in an experiment conducted at Tufts College Dental School of Boston, and the Massachusetts Institute of Technology. It was written in the March 8, 1951, issue of the "New England Journal of Medicine." The intention in this experiment was to compare the soil fertility of New England with that of Texas. Two groups of hamsters were used. One was fed on milk and corn that originated on a New England soil, the other from a North Texas soil. Both groups also received alfalfa that was purchased without regard to the place it was grown. It was found that the Texas-fed hamsters suffered 50 percent less cavities in the teeth. The article winds up with the statement that "a mechanism operated in

the New England foods that aided materially in production of dental decay. Investigations to determine whether this factor is organic or inorganic are contemplated."—"Organic Gardening" (U.S.A.), June 1951.

The ninth man named by the Jewish Exponent is "Dr. Leon Steinig, controlling illicit traffic in narcotic drugs ... a man who doggedly avoids the spotlight." The article unfortunately does not give us any reason why a man in such a worthy undertaking should avoid the light. Will you not get in touch with your Senator and Congressmen urging withdrawal from the United Nations?
