A SECOND ELIZABETHAN AGE?

It is perhaps natural that the Coronation of Her Majesty, Queen Elizabeth the Second, has resulted in much discussion about a second Elizabethan Age. There can be little doubt that the enthusiasm and deep loyalty shown by the Queen's subjects on the occasion of her Coronation indicates a hope that the future will be really happy and glorious; that the drabness, the controls and the stifling of individual initiative, all features of recent times, will become a thing of the past. The very fact that many ask if a new Elizabethan Age has been inaugurated indicates a yearning for a society in which the individual personality can expand and flower as it did so profusely in the first Elizabethan Age.

While it is interesting to contemplate the fact that the second Elizabeth, as did the first, has become Queen at a time when the British people's fortunes are at a low ebb, and that she has been crowned at the same age as the great "Virgin Queen", we must put aside the suggestion that this is a "good omen" indicating better times. If a second Elizabethan Age is to be made a reality, conscious effort will have to be made to implement policies which will result in a social environment in which individuals can be as enterprising as were their British forefathers. A second Elizabethan Age will not be introduced until sufficient individuals display the vigour, courage, and enterprise of the first Elizabethans. The second Elizabethans must refuse to bend the knee to financial, economic, and political policies, which progressively enslave the individual and pave the way for the eventual destruction of the British Crown itself. And they must insist upon a reckoning with all those who have aided and abetted policies designed to destroy British power and influence.

Although no loyal subject of the British Crown could fail to be moved by the Coronation ceremony, culminating in the acceptance of the Crown by a young and lovely Queen who pledged herself to serve her people, we could not help but ponder the sad fact that the power and authority of the Crown have been so progressively weakened that today it is no longer an effective part of the Constitution. Consider the pertinent point—only one of several—made by His Royal Highness, the Duke of Windsor, that his father, King George V, was worried by "the class strife that introduced new and unfamiliar violence into British life", and that although he sometimes bitterly opposed measures presented to him for Royal Assent, he would finish by saying, "But of course there is

nothing I can do about it." How different was the position when the first Elizabeth reigned! The British Crown then played an active role in politics, a fact that is "played down" by many who are talking about a second Elizabethan Age.

Although the Whig historians have created the legend of how the British Crown has evolved from being a "tyranny" to what they are pleased to call a "Constitutional Monarchy", the reverse is much nearer the truth of the matter. At one time the Crown was an effective part of the British Constitution, sharing power with the Lords and Commons, but it has been so shorn of its power that today it is expected to be the rubber stamp for Governments, which exercise tyrannical powers such as the "tyrant", Kings and Queens of the past never had. It is true that theoretically the Crown has still the power of veto, but it is a long time since this power was used. The suggestion has been skilfully made that should the Crown use this power, it would so discredit the whole institution that the people would turn against it. There is a school of thought that believes that the real reason for the Duke of Windsor's forced abdication was the fear that he might take an active part in political issues. He did take it upon himself to tell the unemployed miners that something would be done.

Queen Elizabeth has asked her subjects to pray for her. We suggest that they do more than that they also work towards a restoration of the Crown's authority in order that the Queen may be able to use her influence on behalf of her subjects. A second Elizabethan Age requires that the second Elizabeth possess the authority of the first and that consequently the modern totalitarian conception of all-powerful Governments be defeated.

She is the great-great-grandchild of Queen Victoria, and the grand-daughter and daughter of the beloved Sovereigns who symbolized Britain's resistance and victory in the two greatest wars of her history."

Even a superficial knowledge of the history of American-Russian relations is enough to convince an unbiased student that it is in the West, and not in the East that we must look for the headquarters of the initiators of effective world policies. The "news"-absorbing public of the western world are looking continuously towards the East for signs of coming danger and it is the main concern of the Western Press that they should never for a moment turn their fearful glances from Moscow and look in the opposite direction, to New York, lest they should begin to suspect that it is in this capital of World Jewry, World Zionism (Judaism) and World Government (UNO) that the world's mischief-makers have made their homes and from where they conduct their world-embracing "businesses".

It was not Moscow that financed an American Revolution and prepared it in every detail during the thirty years that

preceded its outbreak. It was not Moscow that housed the International financiers who have supplied the sinews of every major war of the present century and provided indirect but effective encouragement for every revolutionary movement in both hemispheres over the same period.¹ It was not the ambassadors of "Russia" who used the prestige of their High Office to panic the statesmen of Europe into another World Revolutionary War in 1939; the pressure came from the opposite direction. Count Potocki, Polish ambassador to Washington, wrote in a confidential report to his government on January 12, 1939, as follows:

"Roosevelt has been given the power to enable him to enliven American Foreign Policy and at the same time to create huge reserves in armaments for a future war which the Jews are deliberately heading for."

We have the authority of no less a personage than the late Mr. Neville Chamberlain for saying (to Mr. Kennedy, the then U.S. Ambassador to the 'United Kingdom) that "America and the world Jews had forced England into the war." "Neither the French nor the British," Mr. Kennedy told Mr. Forrestal, the U.S. Minister of Defence, "would have made Poland a case of war if it had not been for the constant needling from Washington."²

It was not on the initiative of "Moscow", but owing entirely to the peculiar developments of the "Washington"-desired (and increasingly "Washington"-directed) war that the Allied Statesmen were able to meet in Moscow in 1943 to found the or-

ganisation subsequently known as UNO: and it was on American, and not Russian soil, that a second visible instalment of a world revolutionary government was eventually set up. It is well known that all the key-positions in the secretariat of UNO are held by Jews, and Mr. Fulton Lewis, in his newspaper column of January 30, 1951, reported that according to the Federal Bureau of Investigation, 29 percent of UNO officials are known Communists. Many of the officials who have been dismissed from the U.S. State Department (Foreign Office) for their known Communist leanings, have been quietly placed in the UNO secretariat. Yet "anti-Communist" Washington extends extra-territorial rights to the Communist elements sheltering in the UNO skyscraper in New York. Very odd. Further, it was not the Kremlin administration but the U.S. Government which, during the closing years of the shooting war, monopolised the efforts of the leading atomic scientists of the world and then supervised the production of the most destructive weapon in history. It was U.S. and not Soviet politicians who gave the order to "drop the bomb" on the civilian Japanese populations after the Japanese Government had indicated its willingness to lay down its arms. (In passing we might note that the initial stages of atomic research were the work of individual Gentiles, whilst the perversion of the use of atomic knowledge was mainly the work of "government"-supported groups of scientists in which Jews predominated. Three of the five members of the U.S. Atomic Commission, which finally monopolised developments, were Jews. Most of the "Atom" spies who passed "know-how" secrets over to the Soviet belonged to the same race. It was Mr. Churchill, a leading Gentile architect of the Jewish Home in Palestine, who decided that the U.S. Government was the best repository for the atomic technical knowledge to which British scientists had contributed so much. His friend, Mr. Bernard Mannes Baruch, was U.S. adviser on Matters Atomic at . . . UNO).

It was not "Russian" astuteness that triumphed at the Conference tables at Cairo, Teheran and Yalta: the dying and semi-imbecile President (see "Stilwell Papers", and Chester Wilmot: "Struggle for Europe") was the pliable tool in the hands of his Jewish advisers (Benjamin Cohen, etc.) and their freemasonic ("Communist") accomplices (Hiss, etc.) who succeeded in advancing the frontiers of the World Revolutionary Fatherland to the shores of the Pacific. It was not "Russia" that conquered half of Europe in 1945; the pro-Soviet U.S. State Department ordered its military commanders (Captain Edward M. M. Warburg, connected with the Revolutionary Banking House of Kuhn, Loeb and Co., was Eisenhower's political adviser) to halt the Allied advance to enable the Soviet armies to occupy the ancient capitals of Europe.

It was on "American" and not "Russian" initiative that there were held, in the U.S. zone of Germany, those Nuremberg trials which showed the vanquished that the governments of the victors were now completely dominated by Asiatic ideas of Jus-

tice. Most of the eye-for-an-eye men who acted as instruments of Jehovah's Revenge over His Enemies on that memorable occasion, were freemasons and their assistants mostly Jews. The bulk of the so-called evidence had been collected by International Jewish organisations. Amongst the British prosecuting team, who professed belief in the now exploded myth that Hitler killed six million Jews and who laboured under the peculiar hallucination that the war criminals were all Germans, were Sir Hartley Shawcross, of the Labour Front Bench, and Sir David Maxwell Fyfe, his Conservative opposite number. There was a curious reluctance at Nuremberg to delve into the mystery of the mass-murder of Polish officers in the Katyn Forest. Certain sources maintain that Colonel Budenko, the Soviet prosecutor at Nuremberg, was the man actually responsible for carrying out this deed of unbelievable bestiality.³ Since Nuremberg, Sir Hartley and Sir David have done very well for themselves in Law and Politics, while their senior colleague, the leader of the British team, has been given a peerage.

From Law and Politics there is, as we know, but a step to International Finance, and as we are now supposed to have, to some extent at least, overcome our "dollar difficulties" we shall not be too severely rebuked for pointing out that they were not Russian financial interests which arranged for a European Aid Programme that furthered state-controlling ("Socialist") tendencies in all the receiving countries, and in none more than Great Britain. For this country was compelled to shoulder the responsibility for many of the U.S. "Loans" extended to the parts of the Empire since liquidated in conformity with the wishes and through the "good offices" of the U.S. government. It never occurred to a single front-bench member of His Majesty's Opposition to enquire what interest (quis beneficis?) Wall Street could have in supporting a government of self-confessed Empire-wreckers. The succession of U.S. loans and Sir Stafford Cripps' traitorous devaluation-measures had the full support of our Anglo-American "Conservative" leader, and his entire shadow-cabinet.

Nor has a single member of the British House of Commons asked why the straightforward method of filling the "dollar gap" adopted by the U.S. Government in the Soviet-liberated sector of Europe could not have been used in connection with the rehabilitation of the countries further west.

Why were only Soviet authorities allowed to borrow the dollar printing-plates of the U.S. Government and empowered to run off a sufficient number of dollar bills to satisfy their every need? Would such a query, perchance, have brought us too near that twilight zone where U.S. financiers consort with the emissaries of Soviet dictatorships?

Let us, before we return to the wider aspects of our subject, cast a glance at one such hush-hush encounter: Major G. R. Jordan, of the U.S. Air Force, was on air base duty at Great Falls, Montana, on March 11, 1944, when there arrived a very secret envoy from Moscow:

"The envoy asked for priority travel but stubbornly refused to say whom he was to see. He was introduced as Vlas A. Klensten. The Russian officer, Colonel Kotikov, who worked with Jordan (in shipping U.S. planes and other material to Russia) bowed low, showing Klensten unusual deference. He told Jordan that Klensten represented 'the great Jakov Ashberg, financial hero of the Soviet Union' . . . he said his visit was 'most confidential', he was to see a 'high American statesman'."⁴

After some prodding, Jordan elicited that the name of that "American" statesman was Herbert H. Lehmann, the Jewish International banker, ex-governor of New York State and then director-general of UNRRA in which capacity he delivered some \$400,000,000 worth of American goods earmarked for the starving Yugoslavs into the hands of Tito and a general of the Red Army.⁵ Of Mr. Lehmann's opposite number in Russia, Jakov Ashberg, we recall that in the spring of 1918 he guided, through the Swedish Nya Banken, the funds supplied by New York for the continuation of the "Russian" Revolution. For more than 30 years he has been the financial wizard of the Soviet Empire, and the trusted channel for transmission to the Kremlin of the "Soviet" policies designed by the Master Minds of the Judaic-Zionist Hierarchy of New York, London and Jerusalem, the men who moulded the events of the Second World Revolutionary War (Cairo, Teheran, Yalta, etc.) in such a manner as

to ensure its continuance at any moment favourable to their ultimate plans.

It was not Muscovite guile and force that consolidated the Communist victories at those notorious war-time Conferences: New York finance and Washington diplomacy had for more than a generation co-operated in furthering the Cause of Collectivism in the Far East. There is a straight line—or should we say a Red line?—running from Kuhn Loeb (Schiff-Cassel-Warburg) financing of Japan against Russia in 1905; of Chinese secret-society subversives against the Imperial Chinese Government (circa 1890-1913), and of Japan against Republican China from 1914 onwards, to the peculiar form of support -given by the U.S. Government to General Chiang Kai-shek's anti-Communist forces in China during the last decade. Washington's aid to the Chinese Nationalists bears, in fact, a striking resemblance to the kind of assistance the Allied armies received from the U.S. Government in 1918 (controlled then as now by Mr. Bernard Mannes Baruch and his co-racialists).⁶ Mr. Thomas Dewey relates in "Journey to the Pacific" (Odhams Press, 1952) his conversation in Formosa with a functionary of General Chiang:

"We did receive from America some guns, ammunition and aircraft. But, for some reason, we never got the right ammunition for the guns, or the right guns for the ammunition. Whatever was sent was always too late. We could never get parts for the aircraft we had, and the planes that were sent to us were always short of tails or some other essential part."

Senator J. McCarthy asked in the U.S. Congress in 1950 how it came to pass that Washington, since 1944, had "been seeking to foist Communist members upon the sole recognised and legitimate Government of China." And how did it come to pass, we might ask in our turn, that when, as a result of all this highly integrated U.S. diplomacy, China finally "fell to the Reds", the New Peoples Communist Government, headed by War Lord Mao (who, like War Lord Chiang, the "anti-Communist", had received part of his military-diplomatic training in Russia and most of his ammunition from America was given diplomatic recognition first by the pro-Soviet premier of the New Republican India, Pandit Nehru, and shortly afterwards by His Majesty's Government (Mr. Churchill supporting Mr. Attlee) ?

Did the pressure for this recognition—which must be admitted to be a handicap for a government whose troops for years have been fighting the forces supported by Communist China in its dealings with a partner who is equally involved in the fighting, but has so far hesitated to extend de jure recognition to its military foe, come from Moscow or New York? What was the exact wording of the secret memorandum sent by the U.S. State Department in the autumn of 1949 to Nehru advising that he recognise Communist China, and informing

him that Britain and then the U.S.A. would follow suit?

Perhaps Nehru's friend, Lord Mountbatten, who, as the last Viceroy of India, helped to precipitate the birth of Republican India—an event that caused the uprooting from their homes of some 20 million Indians—could help us to answer this question. In his complicated task of playing international policeman as Chief Allied Commander in South East Asia in the momentous years 1944-46, Lord Mountbatten employed his unique social talent for getting on with all the right people (often the wrong people, not to say the traitors, of a few years or months previously) and in his efforts to carry out the Roosevelt-Truman-Baruch policy of liquidating European Colonial Empires (7) in favour of New Peoples Republics controlled from Wall Street. Lord Mountbatten must have gained an insight into the Asiatic mentality which will stand him in good stead in the key position he now occupies in the Mediterranean Command: on an official visit last year to the State of Israel Lord and Lady Mountbatten declared that "they were delighted to be there". They extended their tour to Yugoslavia where Lady Mountbatten spent a pleasant afternoon as a member of a bathing-party arranged by Marshal Tito, alias Joseph Broz, the Communist partisan-leader. Some time later, Mr. Eden, of the British Foreign Office, arrived in Belgrade. Tito has now repaid the honours by a semi-official visit "on Mr. Churchill's invitation" to this country(8) and the U.S.A. has extended further "loans" to Mr. Churchill's Communist colleague. The decision to have the Communist usurper received by the Queen whose father, the late King George, acted as godfather to the first-born son of the young King of Jugo-

Moscow's need may be signalled by a "Russian" invasion that may set off the Big Shooting war itself. Unless, of course, New York-Moscow requirements can be achieved "by other means". For the origins of Titoism, see "Eastern Approaches", by Brigadier Maclean.

slavia, can without difficulty be traced to the "progressive" influence exercised at Court by Lady Mountbatten and her husband.

Lord Mountbatten, an initiate of Freemasonry and an idol of the intellectuals of the "British" Socialist movement, is the grandson of a German Grand Duke, and Lady Mountbatten, an ardent Zionist, is the grand-daughter and co-heiress of a German Jew. A highly significant combination. Lord Mountbatten's biographer, Mr. Murphy, points out that the Royal International, of which Lord Mountbatten is a member,

"are not a real aristocracy. They are not founded on great landed estates with feudal traditions. They are, rather, people in very high positions, trained intensively in the special social arts of tact and charm, but with few specific responsibilities."

They have seldom, if ever, an intimate connection with the soil and culture of the country in which they reside, and their German-bureaucratic ancestry and (often) upbringing make them effective tools in the hands of those influences that have a vested interest in the doctrine that the King shall Reign but not Rule and whose ideal king is one who conceives himself as the First Civil and Obedient Servant of an all-powerful Parliament secretly chosen by "the People". It is not here the place to trace the influence of German-descended princes advised and often financed by German-Jewish bankers, in the undermining of the British Trinitarian Constitution under which the King, the Lords and the Commons exercised distinct functions while forming one harmoniously balanced whole. It is sufficient to note that everything in Lord Mountbatten's restlessly "successful" career (including his social "knack" of ferreting out and remembering details of the private lives of his subordinates), reveals him as the person cast and trained for the role of Philippe Egalite in the developing "British" Revolution, the man whose usefulness will not be exhausted as long as a single part of what in better times was known as the British Empire remains loyal to the Crown and refuses to be turned into a Republic. While Lord Mountbatten (or Battenberg, or Hesse) is the obvious "U.S." nominee for the post of "British" Minister of Defence in the next big-scale shooting war, Lady Mountbatten (or Ashley, or Cassel) is the certain "International" choice for Commandant-in-Chief of whatever conscripted British women will be called in the planned Third World War.

It has been truly said that Socialism is the "peace" aspect of the War State. We know that Sir Ernest Cassel, Lady Mountbatten's grandfather, was one of the chief financiers of "British" Bureaucratic Socialism and one of the prime movers in the trustification of the world's arms industries. It is significant that one of the first efforts of the "British" Labour Government, consisting mainly of the theoretical pacifists, was to continue the Prussian institution of military conscription into peace-time and one of

their last was the passing of legislation which enabled Lady Mountbatten and her husband to gain full access to the millions Sir Ernest Cassel had amassed in his life-long partnership with Mr. Jacob Henry Schiff, German-born head of the leading Revolutionary Bank of America, and permanent adviser (circa 1890-1920) of U.S. Presidents. Can anyone doubt that that gallant Anglo-American, Mr. Churchill (political protégé of Mr. Bernard Mannes Baruch, permanent adviser to U.S. Presidents from 1920 onwards), would have done as much for so public-spirited a member of the weaker sex?

As both Mr. Churchill and Mr. Attlee share Lady Mountbatten's belief in Zionism, that is, "the natural and historic right of the Jewish people" to make themselves at home in Palestine, we can now pose our final question: Was it on the initiative of Moscow or New York that a Jewish State was set up in Palestine in 1948, and was it Washington that followed the lead of Moscow in extending recognition to the New State, or was it the other way about?

Professor Norman Bentwich, a former Attorney General of the "British" Mandatory Government, writes in his "Israel" (Ernest Benn, 1952, p. 48): "On the eve of the day when the last High Commissioner left Jerusalem the Executive of the Jewish Agency for Palestine and the Jewish National Council for Palestine met in joint session at the Art Museum of Tel-Aviv, David Ben-Gurion, the Chairman of the Executive, read a Declaration of Independence and named the Republic 'Israel'. It was the Sabbath Eve . . . Dr. Chaim Weizmann, who was in America negotiating with the State Department, was appointed President. . . . President Truman, of the United States, on that same Sabbath Day, announced de facto recognition of Israel and he was followed two days later by the Soviet Union." We know that the majority of the Jews who, by one means or another, have succeeded in reaching the Promised Land hail from that part of Russia which for centuries had housed the bulk of the world's Jews, and which Professor Bentwich refers to as "the heartland of the Jewish people". They are, mostly, the descendants of a non-semitic Turkish-Finnish people that came into Europe from Asia at the beginning of the Christian era and became known to history as the Khazars. After some centuries their "government" forced them to embrace Judaism, which, as we are now realizing, is essentially a State or Government religion. They have about as much "natural and historic right" to Palestine as the Eskimos to Timbuctoo. Yet the fundamental doctrine of Judaism and World Zionism (the terms are used synonymously by Professor Bentwich) of the Right-of-the-Jews-to-return-to-Jerusalem is also (Gentiles please notice) an obligatory article of "faith" with any politician who aspires to a position of power in the modern world. The workshops in which the political material is sifted, and the aspirants to power in the outside world conditioned and drilled into acceptance of the Big Idea (few men who do not possess an "Achilles'

heel" will be allowed very high up the ladder leading to fame and fortune), are the lodges of International Freemasonry. It is a fact (which even Freemasons themselves are not concerned to hide) that most, if not all their "work" in the Lodges is concerned with the construction of the Temple of Solomon. Some of us are beginning to get a fair idea of the dimensions of the "Temple" which the Judaic-Zionist hierarchy, assisted by the freemasonic "workmen" in the world's governments, are struggling to erect. We even seem to perceive the nature of the sacrifices to be offered on the altars of that Temple. A recent issue of the British Protestant monthly, "Theology", contained a very curious article by a Rabbinical scholar dealing with the Restoration of the Temple and its Sacrificial Rites.

The Pyramid of Power

"If any genuine attempt is made to extract a useful lesson from the history of human development, the conclusion is irresistible that the process is one long and, on the whole, continuously successful struggle to subdue environment to the end that individuality may have the utmost freedom. Now, by the operation, misunderstanding, and misuse of our financial and industrial system in its application to economics, we have created an economic position, which is such a formidable threat to the material existence of the individual that he is obliged to subordinate every consideration to an effort to cope with it. Partly by education and partly by what may be called instinct, it is increasingly understood that misdirected effort and unsound distributing arrangements, while operating to minister to the will-to-power, are entirely responsible for the position in which we find ourselves.

"The practical issue at this time, therefore, is not at all whether this condition is to continue . . . it is simply one regarding the number of experiments, all very probably involving great general discomfort, which we are to endure until the inevitable rearrangement in alignment with the purpose of evolution is satisfactorily accomplished. And the suppression and perversion of the facts, on which alone sound constructive effort can be based, can have but one result—to increase the number of these experiments and the discomfort of the process."

“Treasury Bill Finance”

“There are improved prospects of better tax cuts in the September Budget than were anticipated by us some months ago. While the Commonwealth has endorsed a State Governments' works programme of about £200,000,000 for 1953-54, the Commonwealth, however, will not provide anything from tax revenue for those works. The money will come from loan funds and treasury bills . . . As the Commonwealth considers it safe to issue up to £150 million new treasury bills a year, this means that it will be able to finance half of its own public works from those bills in 1953-54, instead of paying for its whole programme from tax revenue as it has done over the past two years”—Mr. Latham Withall, Director of the Associated Chambers of Manufactures of Australia, in “The Canberra Letter”.

We trust that the above information is noted by all those monetary reformers who claim that Social Credit means that the State should have a monopoly of all credit. It is true that the new money being created by the Commonwealth to finance public work, is not debt-free, but nevertheless the Government is using the National Credit as demanded by some monetary reformers. So far from this being Social Credit, it is the very opposite. It is an extension of the policy of credit monopoly, which deprives the individual of control of his own credit.

If the Government, and its economic “advisers”, decides to create and issue £150 millions of new credit for the purpose of financing public works, which will be of no benefit to the individual for many years, they are simply increasing the community's money supply without any corresponding immediate increase in consumer goods. One of the results of this policy is inflation. Any inflation is merely another, but more deadly, form of taxation. Expansion of the money supply under present financial rules must inevitably tend to increase prices. But it is easily possible to implement a financial policy, which will ensure that inflation does not follow necessary credit expansion.

Before suggesting such a policy, it is necessary to draw attention to the fact that any financial credit created by the Commonwealth should be controlled by the individual members of the community against whose real credit—productive capacity—it has been issued. The fundamental issue, which must be contested, is whether Governments and their planners should decide how the individual's credit is to be used, or whether the individual should be free to decide for himself. Once it is agreed that decentralised credit control is a basic necessity for a free society, it is easy to suggest ways and means of implementing this policy. If £150 millions of the people's credit can be arbitrarily applied to public works, why cannot this same credit be passed direct to the individual via consumer subsidies which would not only lower the price level and thus make a genuine increase to individual purchasing power, but which would prove that there is a way to expand credit without increasing prices?

20th Century Savagery

A committee of journalists, representing daily newspapers from small cities, recently returned from Palestine and other sections of the Near East. Editors of these papers joined in admitting that the suffering of the Arab refugees is the worst situation that they have ever viewed with their own eyes, or have even read about. Proud, refined Arabs, who have been driven out of Palestine by Jews carrying guns furnished by the United States, are sleeping on ragged blankets outdoors where they are dying of hunger, filth and tuberculosis. The reader should imagine the entire population of a city the size of St. Louis, Missouri, driven out into the sand dunes of Nevada and Arizona without being permitted to take anything with them while being forced to flee for their lives after living in warm houses and the environment of a big city. Only the stupid and uninformed think that the Arabs are merely horse-riding nomads. They have their cities, their school teachers, their clerks, their white collar people” just like we do here. The horse-riding nomad with his blanket is no more characteristic of the Near East than the American Indian is characteristic of America. Uninformed people in foreign countries think that everybody in America is a cowboy or an Indian, but, of course, we Americans know it is ridiculous. No body of people has ever been treated to such savagery than that which has been dealt out by the Jews to the Arabs. The whole filthy proposition should be investigated at once.

The Arbitration Court and Inflation

Whether or not the increase of costs of production is due to inefficiency in labour or management, the fact remains that an increase in wages produces an increase in costs and therefore in prices. Those in charge of the Arbitration Court must have enough intelligence to know this. Then why do they consistently increase wages when they know that this must increase prices and so force them to increase wages all over again ad nauseum?

When the Prime Minister was asked about this suicidal madness, he replied he had no power to intervene in the Arbitration Court's findings. The lack of a sense of responsibility of those in high office has had disastrous results on those with fixed incomes, and the thrifty have had to stand by helplessly, watching their savings disappear.

I don't think anybody could have done more damage to Australia than has the Arbitration Court in destroying people's security and depriving the skilled section of the community of the necessary incentives to increase production. If neither the Arbitration Court nor the Prime Minister has the power to alter this suicidal policy, then it is time we found who is imposing it. —James Guthrie, in “The Mercury”, Hobart.

The Church and the "Protocols"

The following is an extract from "The Realistic Position of the Church of England", by C. H. Douglas:

If there is one thing more than another which history teaches, it is that Governmental systems do not change human nature, but they can, and do, foster various aspects of it. Mediaeval systems may not have eliminated robbery and oppression; but it is certain that they did not legalise it. Had a fourteenth century English King seized land as our contemporary Government seizes land through Agricultural Committees, and otherwise, on any flimsy pretext, or extorted taxes without representation (our contemporary Parliament is neither representative nor possessed of authority), the country would have been aflame with revolution in much less time than the American Colonists required to organise their resistance.

Now, it is obvious that while the authority of "Parliament" (really, the Cabinet), may in one sense, as the mid-Victorian Liberal, Lord Courtney of Penwith, proclaimed it to be, "absolutely unqualified, embodying the supreme will of the State" to which "every partial authority must yield" ("Working Constitution of the United Kingdom, 1901"), it should be recognised just what that means. For all practical purposes, a man has "unqualified supremacy" to jump off Beachy Head; but he cannot avoid the consequences. A Cabinet can pass laws confiscating, under the name of taxation, the work of that man's lifetime or the land his family has dignified for centuries; but it cannot avoid the consequences. The crucial issue is, what will those consequences be? Or to put the matter slightly otherwise, is there a moral "law" connecting political transgression with national punishment? Contemporary Governments clearly think that there is not; that they are free to legislate in a moral vacuum. Can anyone point to a pronouncement of the Church of England, as such, which contests that idea? Assuming that so-called nationalisation of this or that has any virtues, which are far from self-evident, has the Church ever criticised the methods by which it has been achieved?

The reader will probably have by now suspected that we are coming to grips with the preamble to the "Protocols of the Learned Elders of Zion", "The political has nothing in common with the moral . . . Our

right lies in force. The world 'right' is an abstract thought, and proved by nothing . . . The result justifies the means."

Or, as Frederick of Prussia, the so-called Great, put it, slightly differently: "Above all, uphold the following maxim 'that to despoil your neighbours is to deprive them of the means of injuring you'." ("Political Testament," pp 8-9, Boston Edition, 1870.)

It is unnecessary to waste time on the "forgery" issue in regard to the Protocols. The Protocols have existed for at least forty years; and they are certainly one of two things—either a Plan or a Prophecy. Someone or some group either drew up the most able and cold-blooded scheme, which requires and has obtained worldwide and powerful co-operation; or someone or some group was and is gifted with a clear insight into what it is the fashion to call "trends", surpassing anything in history, and more precise and unequivocal than anything recorded and historically proved of the "old testament" prophets.

But at the moment, this issue is not vital. What is the philosophy, and, in consequence, the policy embodied in the Protocols, and in Frederick of Prussia's "Political Testament"?

Mission to Nation

FLUORIDE EXPERIMENTS MUST NOT BE PERMITTED

"The prime causes of tooth decay, as every dentist knows, are candy, soft drinks and refined foods. A courageous association would attack the consumption of these health-destroying foods, not just experiment with medicines to treat a symptom. Do we have to keep convincing our own dentists that sweets are the real culprit; that synthetic foods do inestimably more harm than fluorides, bromides, or chlorides in our water will undo in a thousand years?"

("The Argument Against Fluoridating City Water" by George A. Swendiman, D.D.S., in the U.S.A. paper "Oral" Hygiene, September 1951. This article won the \$100 award for the best feature published that month.)

The acceptance by the dentists' organisations of the U.S.A. of the principle of fluoridation was largely achieved, through the work of Oscar Ross Ewing, who, since September 27, has possessed full censorship powers over all official information handouts from 17 vital U.S. bureaus, including the Food & Drug, Health Service, and Federal Office of Education. This powerful bureaucrat is an ex-partner of the firm of attorneys, which handle the business of the Aluminium Company of America, and he was their Washington counsel. This company is the main source of fluorides for the world. Read all about Ewing in "Collier's", February 4, 1950; "Saturday Evening Post", July 8, 1950; The Sign, July, 1951; and issues in January, 1952, of "Fortune", "Pageant", and "U.S.A. Confidential".

The U.S. Public Health Service officers (who had been warning of fluoridation dangers less than 12 months previously) gave pro-fluoridation evidence before the Select Committee of Congress headed by Delaney. However, the Select Committee in their report presented July 10, 1952, found for the minority opinion of some scientists and the biochemists that gave evidence, that it was unsafe to proceed with fluoridation at that stage, until all the experiments were completed.

Thus beaten, the pro-fluoridators concentrated on local governments, but in most U.S.A. referendums they have been beaten. The hornets'-nest of public opinion had been stirred by courageous dentists, doctors, and propagandists, and several local governments have been forced to remove machinery they had installed to fluoridate the water. It is regretted by the Aluminium Company of America that it will be difficult to sell stocks of fluorides in the U.S.A.

The four main arguments that can be

advanced against fluoridation, which will convince most that this thing must not be foisted upon an unsuspecting public, are as follows:—Freedom, Results, Ingestion and Experiment.

Freedom and ethical considerations are of prime importance. It is obviously a breach of contract for an authority supposed to supply water, to put medicine into the pipes. To do this is to usurp the functions of the doctors and chemists, and also removes liberty to choose or refuse from individuals. To coerce the whole of the community into taking a drug that will only benefit children until they reach the age of 9 years, is not democracy; nor is it rendered necessary by reason of the dangerous implications of dental decay.

"If we are going to compel people to do anything they may not want to do, why not compel them to refrain from consuming candy, cakes, cookies, and soft drinks? Why not prohibit, by suitable laws, the manufacture of refined sugar, refined flour, and similar devitaminized atrocities?" ("Oral Hygiene," article, as above.)

"The topical application of fluorides to the teeth of children . . . will provide comparable protection for children's teeth." (U.S. Select Committee to Investigate the Use of Chemicals in Foods and Cosmetics—Report in Union Calendar No. 787, Report No. 2,500, presented July 10, 1952.)

Dental decay is not sufficiently dangerous to warrant the robbing of freedom, nor the removal of the patients' rights to choose their own professional practitioner.

The health experts have not always been right—". . . 25 years ago the Public Health Service (U.S.) recommended the universal use of iodine in the water. Later on it was discovered that iodine affected people with goiters, and it was discontinued." (Extract from speech of Hon. A. L. Miller, M.D., Representative from Nebraska, in the U.S. House of Representatives, March 24, 1952.)

Results of fluorides upon animals and humans give cause for misgiving. No pro-fluoridator will dispute the fact that sodium fluoride (the proposed fluoridator) is a toxic substance capable of causing death—they only argue that in small amounts it would have no effect.

"As in the case of most chemicals used or proposed for use in food, the hazard, if any, will result from the cumulative action of small quantities ingested over a relatively long period of time." (U.S. Select Committee, as above.)

" . . . Mr. Finlayson replied that it (fluorides) softened the bones by taking out the calcium; it had an effect on heart

cases and on the kidneys." ("Montrose Standard", October 16, 1952 (Scotland, giving report of speech of D. A. Finlayson, Chief Dental Officer of Dundee, Scotland.)

"... the fluoride ion inhibits the enzyme bone phosphatase in young rats and thereby retards calcification of the leg bones." (U.S. Department of Agriculture, 1950-51, Yearbook, page 722.)

"Fluorine was cumulative in bone, and had been known to produce osteomalacia (bone softening) and nephritis (inflamed kidneys; if chronic, Bright's disease)." ("Montrose Standard," as above.)

"The Department of Agriculture (U.S.) has recommended that no fluorides be fed to brood sows. Experimental work on rats and mice indicate a lessened mental reaction in rats and mice who have had fluorides." (Hon. A. L. Miller, as above.)

"While sodium fluoride does not cause cancer it definitely accelerates the growth of mammary cancer in female mice. Experiments will continue for at least two more years under conditions of rigid control before a definite and final announcement is made." ("Time Standard," San Angelo, Texas, U.S.A., May 7, 1951.)

It can be seen from the foregoing that the results on the bones and other tissues of the body may outweigh any benefit to the teeth—but read the following about the dental effects: —

"... children who drink water containing approximately one part per million of fluorine from birth until the age of 8 or 9, while the teeth are being formed, as a general rule will have fewer (tooth) cavities than children drinking water containing no fluorine... estimates range from one-third to two-thirds reduction." (U.S. Select Committee, as above.)

"In 1944 Dr. Weaver carried out investigations at North and South Shields (England)... Dr. Weaver's investigations showed that in every age those taking high fluorine content water had less dental caries than those taking the low, but the percentage difference between the high and low groups showed a steady decrease with age, and the number of new cavities per year was virtually the same in both groups." ("Montrose Standard", as above.)

So fluorine is not the cure-all for dental decay, but is merely an agency to lessen decay by roughly 50 percent, until the age of 8 or 9. But fluorides also disfigure the teeth by removing the calcium and leaving a white spotted effect.

"The testimony before the committee... indicate that some children will suffer some degree of discernible mottling of the teeth when fluorine in the amount of one part per million is added to drinking water." (U.S. Select Committee, as above.)

Ingestion of fluorides through drinking water cannot be properly controlled. Remembering that sodium fluoride is definitely a poison if taken in large enough doses, who will say what is supposed to be a safe dose while the experiments have not yet been completed? But who, having said or proved that a certain amount of fluorides

will be safe for most people, will say that it will be safe for all people, including fetuses, infants, and the chronically ill? And who will say, after a safe dose has been determined, that it can be administered through public water supplies, when it is known that different individuals drink greatly differing amounts of water? Those who eat boiled foods will get more fluorides than those eating fried or roasted foods.

"Yet every living doctor knows he can manage milligram dosage better than the water department can do it under traffic, and what is more important, he knows he can do what no water department would attempt; he can call it off when his patient is through needing the daily dose." (From "Federal Engineering of Consent", by Paul Manning, D.M.D., LL.B., writing in the Catholic Mirror, Springfield, Massachusetts, U.S.A.)

Experiment and testing are still proceeding — and the results will be compiled by scientists and interpreted by laymen who have been influenced by the propaganda of the pro-fluoridators, who have been preaching their doctrine since 1935 before one properly-conducted experiment had taken place.

In New South Wales the "virtues" of fluorine were being broadcast over the air during April 1953, and that month it was announced that Beaconsfield, Tasmania, would "experiment" with fluorine. In Victoria also, it is reported that interest is being shown — in fact, it appears that Melbourne is the headquarters of the move, with the so-called Dental Preventive Association in Melbourne (M. M. Sullivan) completely favouring fluoridating all city and country water supplies. (See West Australian, of April 18, 1953.) Pro-fluoridation is being reported from Great Britain, Canada, U.S.A., and Chile.)

American Opposition To Water Fluorination

Strong electoral pressure is being applied in the U.S.A. to persuade Members of Congress to support a Bill making it illegal for a policy of water fluorination to be introduced. The following is a letter, which is being widely circulated: —

"Dear Friends in the Senate and the House: I personally plead with you to get behind H.R. 2341, a Bill to protect the public health from the dangers of fluorination of water. This bill was introduced in the House on January 29, 1953, by Hon. Roy Weir of Minnesota. Understand it was referred to the Committee on Interstate and Foreign Commerce. Please use your influence to get such a bill passed in both the Senate and the House. Also, urge an investigation be made to ascertain how many tons of sodium (or any other) fluoride may be stored at the waterworks plant or plants that supply Washington, D.C., with water. As you know, it is being 'fluoridated' despite the adverse findings before the so-called Delaney Committee of the House, which issued its Report in July, 1952, warning communities 'to go slow' about injecting that deadly poison into water supplies. Since Edgar Hoover some time ago warned of the possibility of 'poisoning water supplies' as one of the procedures employed by saboteurs, not only should that investigation above suggested be made at Washington, D.C., but all cities should be warned about the danger of tons of fluorides being dumped into their water supplies. Since Dr. Otto W. Brandhorst, President of the American Dental Association, ten days ago claimed that 596 cities and towns (population more than 100 million residents) are drinking fluoridated water, there is nothing more important in Civilian Defence Programme than to act on above Bill, and publish above warning as quickly as possible. For Christ and Country (signed), Charles B. Hudson."

The following Bill was introduced in the California Legislature on January 17, 1953, by Assemblyman G. Delbert Morris:

ASSEMBLY BILL No. 3288. An act to add Section 4036 to the Health and Safety Code, relating to fluoridation of public water supplies... No person shall add fluorine or fluorine compounds to any pond, stream, reservoir, or any other source of water used or intended to be used for human consumption or for domestic purposes. A violation of this section is a misdemeanor and shall be punishable by a fine of five thousand dollars (\$5000), or by imprisonment in the county gaol for not more than one year, or by both such fine and imprisonment."

ANTIBIOTICS DISCUSSED IN BRITISH HOUSE OF COMMONS

Speaking on the Therapeutic Substances (Prevention of Misuse Bill) in the House of Commons on May 13, Dr. Barnett Stross said:

I think that this is a very important Bill in respect of both its two main Clauses. We entirely agree that, so far as the first Clause is concerned, the Minister has every right to ask that the community should entrust his Department with the care of public health in the way which the right hon. Gentleman suggested in his remarks; for it is certainly true that we have not seen the end of these new substances which will come on to the market, and which may be very potent to stave off disease, or to cure it and save life, and which are very dangerous if wrongly applied by people who do not understand either the quantities or the proper mode of application.

In addition, in the Bill, the Minister gives Parliament the safeguard of being able to object to the Statutory Instrument, which he must bring forward, and I think we are, therefore, doubly safeguarded. In the first place, we would have said, "You must take this power," and, in the second, it is quite right that we should have the right to have a look at the matter again.

The second Clause is very interesting and exciting for we are really treading into strange country. The Minister spoke only of pigs and pig-meal, but he should have said that the pig-meal, to be ideal, must not be intermittently fed but should be of the "creeping feed" type. The right hon. Gentleman forgot table poultry, which really come in as well, for we are satisfied that the same technique can be used for the more rapid putting-on of weight or fattening of table poultry.

This is not, indeed, what the late H. G. Wells would have termed the "food of the gods", for, although the animal grows more quickly there is no evidence that it will grow bigger than the normal size, and it is at a certain stage of the development of the animal that the best results are obtained. There is a tendency in the later stages of the animal's life for the benefits to be less apparent and the increase in weight from the utilisation of the food taken to be not so apparent as in the earlier stages. I hope that some, of our scientists will later do something even better than this. I do not know if we shall be using penicillin because we do not make enough aureomycin ourselves, but the figures for aureomycin are better than those for penicillin, and there is some evidence that the former will be very useful when we have it in sufficient quantities.

Something that the scientists might do to help the country is to find some method whereby all these humble animals like fowls and pigs could be induced to put on weight in the same way as hibernating animals, which can go to sleep and do nothing at all but yet grow fat on it. I have never known any hon. Member of this House putting on weight while resting. I am speaking of the hibernating animals, and I have in mind such creatures as the

squirrel. We know that they can change their metabolism because they give off less carbon dioxide while asleep and retain some of the carbon atoms. These they synthesise with water vapour and thus form glycogen, which they store in their livers or convert to fat. If we can find a method by which we can achieve this, we shall have solved our food problems, but a solution does not seem likely at the moment.

Both in the debate today and in another place much point has been made in reference to penicillin and resistant organisms as well as allergy in man. There cannot be any allergy in man if it is true that the animal excretes any penicillin out of its system through its kidneys. All that is needed is that the penicillin be not given in the last two days before slaughter.

As to the question of resistant bacteria, I am not so sure that the reports that have been made by the Medical Research Council are 100 percent correct, but one has in mind something like this. The mode by means of which these animals are able to utilise their food better and put on weight assumes that bacteria are active in the alimentary system.

Let us suppose, for the sake of argument, that one of the factors which gives us this beneficent result is that bacteria are enabled to synthesise Vitamin B.12, which is a growth factor. Or let us suppose that the bacteria, which normally destroy the growth factor, are themselves destroyed by penicillin. For example, some growth factors we know are amino acids like lysine or tryptophane, or Vitamin B.12. I hope I am making myself clear to hon. Members; it is not a difficult matter in reality. The alimentary system is full of bacteria of many types. Some of them synthesise and manufacture the growth factor. Others, on the other hand, have a putrefying and destructive influence and would destroy Vitamin B.12 or the amino acids, which we get from proteins. Thirdly, there are others, which produce toxins and make the animal ill.

It may be that penicillin works in one of three ways; either by curing the animal of an endemic illness and allowing it, therefore, to grow faster, which is, of course, one of the thoughts in the minds of those who know more about it than I do—the Agricultural Research Council; or it may be that the growth factor is in part synthesised through fermentation by other forms of bacteria; or thirdly, that organisms inimical

to the presence of growth factors are directly destroyed by the antibiotic. I am not sure that it would be fair to ask the Parliamentary Secretary to answer these technical details. I will acquit her if she does not.

But Aureomycin in sufficient quantities will give a sterile gut. That means that, sooner or later, if pigs are fed and rendered clean in this way new types of bacteria may evolve and thrive which are resistant to the penicillin, which the pigs are eating regularly in their food. That point is clear. Should that arise, it would mean, first that we should lose the benefits that we are now about to gain because in such cases the pigs would tend to cease to be able to make use of penicillin for improving their growth and the better utilisation of the food we give them. The other factor is that if there is migration of bacteria to humans we may find ourselves in trouble. I do not want to frighten anybody, but these are the matters we must look at. As the hon. Member for Putney (Mr. Linstead) said, we are treading on strange and new territory.

As I said earlier, we may also expect a better return of table poultry as a result of this Bill. It is estimated that the food saved in bringing the pig to the bacon stage by using penicillin amounts to 46 lb. and the amount saved by using Aureomycin to 68 lb. I can remember it more easily in this way, that, by and large, one can save 5 percent of the food needed to bring the animal to, say, 180 lb. weight. What is still more interesting and surprising one can save 10 percent of the time.

In the case of Aureomycin, 25 days can be saved, whereas in the case of penicillin only 12 days are saved. The cost of doing this is very little because antibiotics cost roughly, I believe, about 1s. 3d. a gram and, as we have heard, only two or three parts in a million of antibiotic is required in the food. This means only a few grams per ton. I see no danger of a black market in penicillin if it is properly prepared before being handed over to the farmer either as a mixture from which he will be unable to extract the penicillin, or mixed with the meal in cwt. bags, as suggested in another place. In any case, penicillin is very cheap and anyone who needs it can get it from his doctor. Its cost retail is about 2s. or 2s. 3d. for 100,000 or 250,000 units. Therefore, I cannot see that there is any purpose in thinking in terms of its irregular use.

With regard to the care that should be taken, we should remember an experiment made in America, which gave the lead in

so much of this work nowadays. They found that another chemical substance, an estrogen, a type of ovarian hormone, could be used to fatten table poultry. It produced birds with large breasts, which were very succulent, and they made a much greater delicacy on the table. What they did not know, of course, when they offered those birds to people in expensive restaurants, and no doubt to Senators and Congressmen, was that the estrogen remains in the breast of the chicken and causes, in men only, I am glad to say, sterility, which is a very serious matter. We may well laugh at it, but I think we are lucky that that particular experiment was not made in this country.

... I welcome this Bill wholeheartedly because it is one of the examples of science offering help to the community as a whole. I sincerely hope that we shall find richer and more varied ways by means of which food can be increased, not only for our own people, but, through our experiments, for people all over the world. It is certain that if we can conquer the problem of world hunger or of an insufficiency of food we shall have done something that will allow us, when time has gone by, to say that we have some reason to be proud of ourselves.

... Would it be fair to say that there is a specific benefit of a financial nature to the pig-breeder? Is it not true that, as a result of the saving of feedingstuffs, he gains about 10s. 6d in the penicillin-fed pigs and 18s. in the aureomycin-fed pigs?

The Price of Butter and Subsidies

Evidence placed before the authority investigating the dairying industry, showed that since the retail price of butter was increased nearly twelve months ago, butter consumption per head of the population has declined by approximately 10 per cent. This startling fact does not support Mr. Menzies' contention that the standard of living is increasing in Australia. Consumption of nearly all the protective foods is falling.

If the price of butter could be reduced by, say 1/- a lb., we have not the slightest doubt that the increased consumption would be such that the local dairying industry would have little need to be worrying about an uncertain export market. But if the price for butter during 1953-54 is based upon the dairymen's' increased financial costs, it will undoubtedly be higher than it is now. And this must inevitably result in a further decline in butter consumption. Present financial rules alone prevent the Australian consumers from buying an adequate quantity of butter. It is futile for Federal Government spokesmen to suggest that dairy farmers should be asked to do without an increase in price for their production over the next twelve months—as part of their contribution to the defeat of inflation. Unless dairy farmers receive an adequate price, they will soon switch to other forms of primary production and there will then develop a butter and cheese shortage.

Present financial rules can easily be modified to enable both consumers and butter producers to come together. Mrs. Gladys Hain, President of the Victorian Housewives' Association, has given a lead by urging that butter prices be subsidised instead of increased. As the only sane purpose of production is consumption, it is time that more thought was given to the necessity of financing consumption instead of expanding new credits for public capital works which are not urgently necessary. It is surely an act of madness—or perhaps it is deliberate sabotage—to be financing big water schemes for the growing of more food in ten or more years' time when consumers are now unable to food which is actually being produced.

Destroying America

The "Irish Times" has reviewed at length a book published last winter in Germany with a title, the English equivalent of which is "The Future Has Already Begun". The author, Robert Jungk, is a German journalist who has been working in America for the past five years. Circulation in Germany is said to have been advanced by a critical review by the "Neue Zuercher Zeitung". To judge from the Irish review, the work is the Teutonic equivalent, factual and 'documentary' of "Animal Farm", with, however, a special application to the economics and sociology of atomic energy. "Is America Destroying Herself in Her Atom-Age?" is the heading of the "Irish Times'" review. Herr Jungk has no faith in the human qualities of Americans, which he thinks are insufficient to enable them to stand up to the vast impersonal forces released by America's technical civilisation. "It can be done" is enough justification for doing anything, however disastrous the consequences. The writer is fascinated by atomic developments, the burial grounds for atomic waste, for instance. What will happen if the signs disappear that mark off these dangerous areas, and future generations forget the exact sites?

"At Hanford, an expert tells him that atomic waste with its deadly radiations is a bigger long term problem than the international control of atomic weapons. In future, mankind would have to live with the life-destroying forces it released when it interfered with Nature."

Limitations of Chemical Analysis

"Housewives Today," which supports the policy of the British Housewives' League, has published the following letter addressed to the Editor, Mrs. B. M. Palmer:

9th March 1953.

Dear Mrs. Palmer,

In the last issue of "Housewives Today", you commented on the limitations of chemical analysis when the analyst is dealing with unknown substances and does not know what he is looking for. I should like to enlarge on this because one of the arguments at present used to show the harmlessness of aigenised bread to human beings is that the poison has been isolated and identified as methionine sulphoximine and that the amount of this substance present in commercial bread is far too small to have any effect on consumers.

The toxic doses for various animals of methionine sulphoximine are:—

Rabbits—1-2 mgms. per kilogram of body weight.

Ferrets—2 mgms. per kilogram of body weight.

Dogs—3-5 mgms. per kilogram of body weight.

Mice—150-200 mgms. per kilogram of body weight.

Rats—250 mgms. per kilogram of body weight.

Monkeys—300-350 mgms. per kilogram of body weight.

The figures are quoted from Dr. T. Moran of the Research Association of British Flour Millers.

Dr. Moran gives the concentration of meth. sulphox. in commercial flour as 2 mgms. per kilo and so somewhat less in bread. He then points out that the amount of meth. sulphox. consumed by an average man in a year is only 2.5 mgms. per kilogram of body weight, a quantity obviously insufficient to produce any effect.

I quite agree with him. No substance could be so fantastically toxic. Mr. Moran's

figures, however, prove rather more than he thinks they do. Consider the dog. For a dog to be poisoned by eating bread it would have to consume at one meal between one and a half and two and a half times its body weight of the food. This is a manifest impossibility so it is evident that it is impossible to poison a dog with aigenised bread. Experiment, however, has shown that dogs can be poisoned quite easily by commercial aigenised bread. On the figures given, the animals could not have died of meth. sulphox. poisoning. The conclusion follows that their deaths were due to some other substance and that the principal poison in aigenised bread has not yet been either isolated or identified.

May I quote a few further sentences from Dr. Moran:

"With an improver such as agene, many of the constituents of flour will compete for its attention and it is reasonable to assume that a wide variety of end products will be formed. The attempt to trace these substances is not an easy research because they are submerged in rather an intractable medium." It is also interesting to note that the animals with high resistance are all bread eating animals at least in captivity and suggests that the tolerance to meth. sulphox. is an acquired one as my experiments showed that the human tolerance to aigenised bread to be.
