THE MENACE OF THE "UNITED" NATIONS

Mr. Calwell's Dangerous Proposal

A Recent Talk by Eric D. Butler over 3NE Wangaratta

I have no doubt that Mr. Arthur Calwell, Deputy Leader of the Australian Labor Party, is genuinely concerned about the military defence of Australia. He has in recent times made strong appeals for greater military defence of Australia's North. But his statement made last week, that the British Government should grant Malaya complete self-governing powers and that Malaya should then be defended by the United Nations, brands Mr. Calwell as a political adolescent. Every thinking Australian must be concerned about what is happening in Malaya, because if this part of Asia comes under Communist domination, the Communists will then be in a powerful position to intensify their conspiracy in Indonesia.

Now the suggestion that the granting of political independence to Malaya will help stem the Communist challenge is so obviously false that it is astonishing that any thinking person can support it. Those supporting this idea, which the Communists have helped foster over a long period, speak airily about the benefits which have flowed from the British granting independence to India and other countries. It is astonishing how many people believe that by giving simple, native peoples a political vote, these peoples then automatically become much stauncher allies in the struggle against Communism. The overwhelming majority of these people have no background of tradition essential for democratic government, and it is not surprising that the results of insisting that these people vote have been disastrous — and in many cases, fantastic. For example, one tribe in Africa, when required to vote for the first time, promptly ate the voting papers! The right to mark a piece of paper has not benefited the people of India. But it has benefited Mr. Nehru and his associates. And so far from being an ally against Communism, Mr. Nehru has demonstrated time and time again that he is a Communist appearer. Since Burma was granted what is called selfgovernment, there has been chaos and dozens of civil wars in that unfortunate country. Siam has a very powerful Communist movement, a fact that is governing the policies of the Government in this country. Coming much nearer to home, we

have only to look at what has happened in Indonesia to realise what dangerous rubbish Mr. Calwell is talking when he argues that Malaya will be better defended if its native peoples are given selfgoverning powers.

"United" Nations influences were partly responsible for the Dutch being driven out of Indonesia, with the result that the economy has been undermined, there is no political stability and the Communists are in the Government and are becoming more firmly entrenched every day. And, as part of the long-range offensive against this country, the very United Nations which Mr. Calwell suggests should defend Malaya that is after the British have been forced out — is being used to help the controllers of Indonesia obtain a foothold in New Guinea. The importance of the campaign against Dutch New Guinea has been overlooked by many people and Australians should take heed of the recent warning by the famous American military correspondent, Hanson Baldwin, who points out that control of Dutch New Guinea would be a major strategical success for the Communists.

The issue of Dutch New Guinea could be a life or death one for this country, but the issue is being decided, not by Australia or by Holland, but by the "United" Nations, an organisation which the Communists played a leading role in creating and which they have been skilfully using to further their own policies. When the issue was

recently first debated in the "United" Nations, those favouring the Indonesian viewpoint carried the day with a substantial majority. It is significant that every Communist and pro-Communist Govern-

OUR POLICY

WHAT IS FREEDOM?

We suggest that all readers should carefully study the following article by Mr. John Mitchell, Director of the Christian Campaign for Freedom, in which some very good points are made, and reference made to the progress of a campaign, which is of tremendous importance:

If the Christian Campaign for Freedom has done nothing else, it has made plainer than it was, clearer and more intelligible, however deplorable, some features of the prevailing mental "climate". It has brought to light direct evidence, for example, that the Clergy (of several "denominations" at least) live, think and act with complete regard for the same mental "climate" as the laity, and not only the professedly Christian laity, but practically the whole of that section of the population which expresses what it deems to be its opinions at all. We hope that we may still do something to mitigate this effect.

Mr. Malcolm Muggeridge, the distinguished editor of "Punch", broadcasting from Toronto on August 11 last, said it had given him great satisfaction some eighteen months before to have the opportunity of trying to revive the nineteenth century reputation for untrammelled criticism of "an allegedly humorous weekly magazine." He said: "The result was electric. Angry letters poured in accusing me, among other things, of being a Fascist, a Communist, an atheist, a bigot, an Americanophile a republican, an anarchist, yes, and even a Bevanite. Even when the possible truth, or at any rate the plausibility, of a particular comment was admitted, it was condemned as being in the worst

possible taste. . . . "Voice" is not even an "allegedly" humorous journal, but we felt sympathetic towards Mr. Muggeridge in his complaint, and still more sympathetic when he went on to say: "Do you see what I am getting at? The exercise of a free, independent judgment is so out of keeping with the contemporary climate that it requires some explanation. Like a tumour or cancerous growth, it can exist at all only as a result of some abnormal condition capable of a simple diagnosis. . . . In this passion for thinking in terms of categories, I detect the clearest and most ominous symptom of the subordination of the individual to the collectivity. A voluntary uniformity, no less than an imposed one, prepares the way for servitude." Mr. Muggeridge thought people were never enslaved unless they had become slaves already. They swam into the mouth of the Great Leviathan: he did not need to chase them.

Despite the great trouble we have taken continuously in these pages to emphasise that true freedom is a product of a practical binding-back of social policies to natural Law, and the practice of integrity and responsibility of action, a "voluntary uniformity" determines apparently that, even extending to the Bench of Bishops, what we say, the real nature of the questions we ask, simply does not "register". What does it mean that, after two thousand years of Christian teaching, a clergyman, one who has the care of souls, can say: "In this

question of freedom I am interested: but I am bewildered'? What can one think of a Bishop who says, in the face of the New Testament itself; "If we all did what we liked, we should have anarchy"? We have not said we should all "do what we like". We have said that a State cannot continue to exist which is not bound back to Law. Does the "climate" of totalitarianism wash out the plain meaning of words?

In any case, we propose again and at length to answer the question: "What is freedom?'

Freedom may be hard to come by (there is an organised, consciously evil force in the world determined to destroy it), but it is, as the late C. H. Douglas said, "really a simple thing; it is the ability to choose or refuse one thing at a time." We are talking about what freedom is; not what people do with their freedom that is a separate thing. As the American evangelist, Billy Graham, has written:

'Freedom to choose or reject, freedom to obey God's commands or to go contrary to them, freedom to make himself happy or miserable. For it is not the mere possession of freedom that makes life satisfying-it is what we choose to do with our freedom, which determines whether or not we shall find peace with God."

The prerequisite of being able to do anything with freedom is to have it. It is with the obtaining and preserving of freedom that we are concerned here, for the simple reason that freedom for the individual person is disappearing and is threatened with extinction. Despite the protestation of one clergyman, who wrote to us that he experienced true freedom shut up in a Japanese prison cell, we assert that the basis of a Christian society is destroyed exactly in proportion as individual freedom is destroyed. Any other conception of Christianity than that it is bound up with an expansion of individuality is either pure delusion or conscious perversion. Again, quoting Douglas:

The 'mass' is unsavable, just as a mob is insane ('without health'); the object of Anti-Christ is to keep mankind in ever larger mobs, thus defeating the object of Christ, to permit the emergence of selfgoverning, self-conscious individuals, exercising free will, and choosing good because it is good. The energising factor is attraction, inducement."*

As the sacredness of human personality and the need for free expansion of individuality is one of the major premises of Christianity, no true Christian can say that the interests of the individual over the group are not paramount. This being so, the rights and wishes of minorities, whether they consist of two people or forty-nine percent, of the population, are every whit as important in principle as the rights and wishes of majorities. Any person who denies this or abandons it under

pressure is denying or abandoning a Christian basis for society. This is an assertion and Christianity recognises the primary and formative nature of ideas, and that this is the primary idea, which should shape society; an idea, which in fact makes of society an organism and not an organis-

But this, like all ideas, is useless if it is not practically applied by Christians. Are the clergy going to give, in default of the bishops, a practical authoritative lead in this? If not, our situation is indeed grave. And what are the practical implications of the acceptance of these ideas?

One of our clerical correspondents asks, 'doesn't life in society depend entirely on a voluntary surrender of freedom by the individual?" Yes, of course it depends on a surrender of some measure of freedom. But people don't voluntarily associate in any form of society unless they expect or intend to gain an advantage by doing so, i.e., a greater freedom. They cannot voluntarily surrender a freedom unless in the first place they have freedom to contract in or out of the association, i.e., unless they

On the other hand Welfare Statism and socialism not only destroy freedom of association, either by destroying private ownership and enterprise or by controlling it, but also impose ideation on the individual by collective methods.

In the Christian conception the ideation proceeds from each individual, and is controlled by each individual through a know-ledge and acceptance of Christian principles, the sole concession to Caesar being a minimum of social law and tribute such as is practically found necessary to protect individuals in society from the harmful acts of sinful persons or groups of sinful persons. All education is regarded necessarily as part of religion, and is ultra vires of the State. There is recognition of imminent sovereignty "The Kingdom of God is within you." Power is constrained, restricted and distributed.

In the Satanic conception, the ideation is imposed on the individual from without, and his obedience is constrained by a maximum of social law and tribute. If, instead of aiding and abetting the official Full Employment policy, the Church had aided the community to see that the true object of production is consumption, and that the displacement of human labour by the machine could be a blessing in the provision of creative leisure, in the place of mass production, mass opinion and mass amusement, we could have had individual choice, craftsmanship and quality. May the bishops and clergy even now, at this late hour, say with Miss Dorothy Sayers: "If we conclude that creative mind is in fact the very grain of the universe . . . We shall have to ask ourselves whether the same pattern is not also exhibited in the spiritual structure of every man and woman. And, if it is, whether, by confining the average man and woman to uncreative activities and an uncreative outlook, we are not doing violence to the very structure of our being.

We come back, therefore, to our definition of what freedom is: "The ability to choose or refuse one thing at a time." This

postulates at least: (1) That the products (not the administration) of the production system are controlled by the consumer, which can only happen if there are independent producers competing to cater for his needs. These producers must be free of government interference with either their administrative arrangements or the pricing of their products.

(2) That the employee is able to ensure reasonable conditions of work by having the freedom to move from one employer to another, no monopolies, State or otherwise.

- (3) A recognition that the proper object of technological advance and labour-saving machinery is to release men and women from labour. Full Employment as a policy is false. In its place there should be a steady pursuit of a policy of paid leisure, endowment, with an education system adapted to prepare people for creative leisure—an education system free from State interference.
- (4) A recognition that the power derived from the monopoly of credit creation and the misuse of that power has been the chief source of the evils from which we suffer: that this power must be broken, together with the debt system which it has fostered, and made subservient to the needs of producers and consumers as exhibited in a national balance sheet, prepared by long established and well-tried principles practised by all business accountancy.

(5) A recognition that "The business of the Church in politics is to be the Authority of the Mills of God, which are of course, inter alia, Political Principles which can be checked like any other genuine Laws, by their observed operation over a sufficient period of time.'

(6) A recognition that secret, anonymous

THE HISTORICAL BLACKOUT

Suppressed Facts About Monetary History By Noel Stock

Alexander Del Mar, a respected American civil servant and one of the world's great monetary historians, was at the height of his fame in the eighteen nineties. A dense man-made fog descended over his name and his books about the year 1900 and has remained there ever since.

The 1899 edition of his work, "A History of Monetary Crimes" (published again recently in the Square Dollar Series by Kasper Horton of New York), shows in its opening pages why the Congregation of High Finance acted immediately to obliterate the name Del Mar. Here is the opening sentence: "The insidious crime of secretly or surreptitiously altering the monetary laws of a State—than which no more dastardly or fatal blow can be dealt at its liberties—is not a new one.'

Del Mar shows that the gang, with headquarters in London, which was responsible for the depressions which racked the American colonies, was also responsible for the monetary laws which burdened the Republic almost from the time of its founding right through to the publication of his book in 1899.

The special significance of Del Mar is this: he was a scholar, historian and scientist of worldwide fame who wrote many books on monetary history and the history of precious metals. He cannot be labelled "crank" or "anti-Semite". Indeed, in March 1890, he even lectured to a special meeting of the London Chamber of Commerce to correct statements by Thorold Rogers!

Yet, Del Mar, pursuing facts, found himself always face to face with the same gang. He says: "Originally the financiers consisted of 215 monopolists under the title of the East India Company: now they comprise the entire world of money-changers and bankers. This cosmopolitan band threatens the peace of mankind." (Italics mine.)

Not only did Del Mar wage war against their Gold Standard ("neither silver nor gold are indispensable for the purposes of money or commerce"), but long before the menace of communism he saw the dark shadow of world government. He saw that the monetary system in Britain and the United States was aimed at "the elevation of this sordid and cynical class to the ownership and government of the earth."

Del Mar was able to show that American political parties were already under the domination of the international bankers. He tells us "on the 13th of March, 1868, Baron James Rothschild, of Paris, wrote to Mr. Belmont (chairman of the Democratic Party) a letter—which concluded with warnings of ruin for those who might oppose the payment of bonds in coin, or who might advocate their liquidation in greenbacks".

Needless to say, the American Congress obeyed the banker in Paris. Del Mar points out that the Baron and others of his "sordid and cynical class", reaped a profit of 275-million dollars from this one crime— "perhaps the greatest reward which ever tempted men to conspire and betray."

It is easy to see why Del Mar's name had

to be removed quickly from the minds of men. About a year after the publication of "A History of Monetary Crimes" an evil fog descended over the name and books of Alexander Del Mar. Due to the constant hammering of men like the famous American poet Ezra Pound, and to the good work of publishers Kasper and Horton, Del Mar is now required reading in a number of major colleges and universities in America.

Another recent Kasper and Horton publication which needs wide circulation is Eustace Mullins' book on the United States Federal Reserve—a book which continues, from where Del Mar left off, the history of the international bankers' penetration of America. In Del Mar's heyday the headquarters of the gang was in London, the branch offices in Europe and the United States. However, the changeover began about 1903 when a young man, Paul Moritz Warburg, left his family banking house of M. M. Warburg in Hamburg and sailed to New York to join the, of Kuhn, Loeb Company. It is interesting to note that M. M. Warburg was a representative of the Rothschilds in Hamburg and

Paul Warburg, according to Mullins, took no part in the humdrum of everyday banking, but concentrated like the good European liberal he was, upon the promotion of "monetary reform". In 1913 President Wilson (financed into the presidency by up-andcoming Bernard Baruch) put through Congress the Federal Reserve Act. This placed in the hands of the international bankers the control of all America's money and credit. The Federal Reserve Boards are out of the hands of Congress; their members are appointed by the Executive Government.

And so, after barely ten years residence in America, Paul Warburg had transferred the World's power centre from the Rothschilds in London to New York. Warburg was appointed first Chairman of the Federal Reserve Board, just in time to finance the Allies in their war against Germany. When the war was over Paul presided over the Debt and Reparations meetings, thrashing out part of the "sordid" business with the German representative, his own brother, another member of the Warburg banking house!

Mullins, like Del Mar, is not just another "crank". He wrote his book on the Federal Reserve while employed in the United States Library of Congress. He is now economist with the American Petroleum Institute.

He demonstrates carefully how the infamous J. P. Morgan, so dear to the hearts of communists and socialists, was in the end hardly more than a tool of the Rothschilds and Warburgs. In 1901 Kuhn, Loeb

It was the evidence of ex-Communist secret agent, Whittaker Chambers, before the House Committee on Un-American Activities, which caused top Communist espionage agent in the U.S.A., Alger Hiss, to be indicted and convicted on a charge of periury. Not only the American people but many people in other countries were startled by the disclosure that the official who advised President Roosevelt, helped draft the disastrous Yalta Agreement in 1945, and who was the first Secretary-General of the United Nations Organisation, was a Com-

munist agent.

Before being finally convicted, Alger Hiss, aided by some of the most influential people in America, fought back against Chambers, who was subjected to a whispering campaign described by one prominent American writer as "one of the most repellent in modern history". Chambers replies to this campaign in one of the most important autobiographies of our times. Not only does this book deal exhaustively with the Hiss-Chambers battle before the Committee on Un-American Activities and the Courts; it is a moving human document which explains how Chambers first became a Communist, his work in the secret Communist apparatus, how he met Alger Hiss and worked with him, and how eventually he came to repudiate Communism.

Near the conclusion of his book, Chambers makes one of the most important observations yet made on the Hiss-Chambers case: "No feature of the Hiss case is more obvious, or more troubling as history, than the jagged fissure, which it did not so much open as reveal, between the plain men and women of the nation, and those who affected to act, think and speak for them. It was, not invariably, but in general, the 'best people' who were for Alger Hiss and who were prepared to go to almost any length to protect and defend him. It was the enlightened and the powerful, the clamorous proponents of the open-mind and the common man, who kept their minds shut in a pro-Hiss psychosis, of a kind which, in an individual patient, means the simple failure of the ability to distinguish between reality and unreality, and, in a nation, is a warning of the end."

"Witness" must be read and studied by those who want to know the truth about Alger Hiss and his part in the Communist conspiracy in the U.S.A. Every student of Communism and international affairs must have this work on his shelves. No one with an unbiassed mind can read it without realising that Hiss was undoubtedly guilty of the charges made against

Since the pedigree of a policy is derived from a philosophy, it may be helpful to recall two propositions which, if not comprehensive, are essential to any Social Credit philosophy:

Just as a maniac is irresponsible, so an irresponsible voter is a political maniac, and would know it if he were not. Power without responsibility is the broad way, which leadeth to destruction and the World of Nightmare.

"INFLATIONARY FORCES"

In its editorial of November 25, the Melbourne "Age" deals with the "inflationary forces" which have "reappeared", inflation is inherent in present financial rules and all the talk in the world about greater efficiency and harder work will not alter this fact. When will the newspaper pundits face the truth of the situation instead

of making themselves ridiculous?

The Melbourne "Age" editorial referred to stresses the urgent necessity for a reduction in labour costs. It instances how a motor vehicle firm, "after rearranging the method of one assembly operation, found that seven men could do what had previously occupied 20". Excellent. But if this could be repeated throughout the whole of the production system—and probably it could with labour-saving machinery -and approximately one-third of present employees were dispensed with, would this not result in a serious reduction in the volume of purchasing power distributed to buy what is being produced? And what happens to the one-third of the employees dismissed? It will be pointed out by the "full employment" advocates that these employees will be employed on further private and public capital expansion. But this expansion, financed under present financial rules, must automatically help increase prices. The capital costs incurred must be recovered through the price system.

While greater real efficiency in industry helps to prevent prices from rising, the insistence that the deficiency of purchasing power can only be overcome by credit expansion for capital production, makes progressive price rises as certain as sunrise. This has been demonstrated beyond all

argument in the U.S.A.

CREDIT POLICY

We are back again to the 1951 deflation and credit restriction policy. Dr. Coombs has issued another directive, although on this occasion the technique is not to formulate it in specific terms. Instead, the trading banks have been told that they must retain 25 percent, of their deposits on hand in liquid form. With the 25 percent deposited with the Central Bank, that means that their advances are reduced, and they are unable to meet legitimate needs both of industry and of private industry.....

So bank credit policy is again directed along selective lines. That means the weak are forced to the wall, while the strong become stronger. When a small firm is denied overdraft accommodation, it must reduce its output, and either stagger employment or dismiss men and women. That happened in 1951. It is happening again. It is the same thing happening again today, and the instrument is precisely the same—control of bank credit.

Ironically enough, this weapon is Socialised control of credit. It depends upon a banking monopoly. It is State control of private enterprise. It is not surprising to find the leaders of the bank officers' organisation protesting against this new outburst of Socialisation. But the real victims are not the bank officers. The people who will suffer in the long run will be those who must lose their jobs.

Sir, —A recent visit to Devonport led me to recall how in the 'nineties I served as "mate" to an elderly shipwright. Then I learned that a warship was simply built by the two of us, plus a labour squad with drillers, riveters and caulkers and with the use of simple machines.

Later in life my work for merchant ships helped me to realise that some 34 trades were engaged, and that to prevent "poaching" a large book of rules, needing a lifetime of study, was laid down as rigidly as the Iron Curtain. This "demarcation" meant to keep certain jobs for certain men, adds approximately 50 percent, to the cost of a ship. — From a letter by Sir Westcott Abel, in "The Daily Telegraph" (England).

THE ROAD AHEAD

The road ahead, which we must travel in 1955, is a continuation of the road we have travelled for the past twenty years. Although the road has been rough and narrow, and there is every evidence that it will become much harder to follow for some time yet, experience and events confirm our view that there can be no deviation from this road if we are to reach our ultimate objective — a society in which every individual will be firmly established in his own God-given rights. We are well aware, of course, that some have dropped by the wayside over the years, either because they felt that the road was too difficult or that there was some short cut, which would save time and effort. Others have lost faith and resigned themselves cynically to make the best of what they consider a hopeless situation. But a small band of men and women of courage and integrity have steadfastly adhered to the course, which the founder of the Social Credit Movement, C. H. Douglas, insisted would have to be followed if success were to be obtained. This journal exists primarily to help such people of integrity in our community, and we renew the special appeal which we made late last year: that present readers make every endeavour to have "The New Times" introduced to those people in the community likely to be interested in the ideas for which it stands.

Douglas said that events would be mainly responsible for the introduction of policies, which will save us from complete tyranny. But it is essential that there be sufficient people with adequate knowledge and understanding to ensure that the right action is taken to deal with events. As we look back over the road we have followed so far, one thing stands out crystal clear: Douglas's advice has always been proved sound. The great tragedy has been that on far too many occasions his advice was not heeded until it was then too late. There are still many who call themselves Social Crediters but who refuse to see the wisdom of Douglas's advice. Many of these people think that the enemies of individual freedom can be defeated attempting to compete with the enemy in the manipulation of mere numbers. For our part we have become progressively convinced over the years that appropriate action by a small number of men and women of integrity will alone avail against the enemy of Christendom. The type of action we have in mind is that being taken by the directors of the Christian Campaign for Freedom, launched in England early last year. While this high-level activity, more concerned with quality than with quantity, cannot, in the nature of things, produce immediate results, it does eventually have a fundamental impact. There must be a time lag with such activity. Loyal supporters of this journal over the years have undoubtedly had an impact, which could well prove decisive before we reach the end of our road. Let us all endeavour to increase this impact during 1955

There is much for all to do. It is probable that there will be major crises during the year. The "United" Nations Charter comes up for ratification and this should enable us to intensify the campaign against the threatened World Police State. Even the threat of war cannot avert the growing economic crisis as the international trade struggle becomes fiercer. Internally we will have to fight against various Communistic measures in order that we do not lose ground in the struggle to create the free society. Let us press forward afresh and ensure that the end of 1955 finds us much further along the road we must tread to reach salvation.

REV. NORMAN HILL TAKES FURTHER ACTION AGAINST WATER FLUORIDATION

In our issue of December 3, 1954, we printed the public statement issued by the Rev. Norman Hill, Vicar of St. Mark's, Fitzroy, Victoria, in which the proposal to fluoridate Melbourne's water supply was attacked, primarily on moral grounds. Mr. Hill has since had roneoed a further statement, which he has forwarded to selected Anglican Ministers in Melbourne, including the Archbishop of Melbourne. We will report on reactions, if any, to this move at a later date.

Japan's Economic Problems

The Japanese Prime Minister, Mr. Yoshida, has been in the U.S.A. urging that the Washington policy makers do something to help the Japanese overcome their growing economic problems. But he has not been very successful. Since the end of the Pacific War Japan has become little more than an economic satellite of the U.S.A. Japanese industry was rebuilt and modernised by American dollars. The Korean War also helped the Japanese economy considerably. But now the Japanese are finding it increasingly difficult to export their manufactured goods in order to pay for the importing of necessary raw material and to provide "full employment". There is a grave threat of serious unemployment in Japan, which will be suitably exploited by the Communists. Unless Japan can sell to countries like Australia in order to obtain credits for imports, not only will the Communists in Japan be assisted, but there will be a great risk that Japan will accept the trade offers being made by China and Russia.

The major reason why Western countries will not take Japanese exports is that this would, under present financial rules, cause local unemployment. And all the "experts" are insistent that the rules cannot possibly be changed. But until they are changed it is certain that the Communists will go from victory to victory.

PARTY POLITICS

That something more has got to be done than support one or other of the existing political parties is evident. The citizen, who wishes to preserve some measure of personal and national independence, and the means to retain it, has got to do something about it. To form a new party would probably be useless. A political party tends to work for the interests of the party rather than the interests of those who elected it. And it is opposed for the simple reason that it is a party and stands in the way of the acquirement of power by others. The issue ceases to be the interests of the party.

(Continued from page 4) and J. P. Morgan formed an alliance known as Northern Securities Company which was the consolidation of the Rothschild Empire in the U.S. Actually Morgan had been acting for N. M. Rothschild Company of London since 1869 when Morgan and Anthony Drexel journeyed to London to conclude an agreement which enabled the Rothschilds to operate in America under a less-known name.

Paul Warburg gradually gathered up the loose ends in America until a select little band of bankers controlled the stock market and Federal Reserve System. Apart from his interest in "monetary reform" Paul Warburg, operating through Kuhn, Loeb Company, became a partner or director in Western Union, Westinghouse, Wells Fargo, Union Pacific Railroad, American I.G. Chemical Company (I. G. Farben), Agfa Ansco Corp., National Railways of Mexico, International Acceptance Bank (of which he was chairman of the board), Warburg Co. of Amsterdam, Westinghouse Acceptance Co. and numerous other banks, railways and corporations.

Mullins shows that years later during the Great Depression, the gang moved in and bought up all the cheap stock, consolidating further!

It is interesting to note that two other wicked "capitalists" dear to the Reds and Pinks, namely Rockefeller and the International Harvester Company, were both "connected" with that able agent of the Rothschilds, J. P. Morgan. In 1902 Morgan formed International Harvester, selling ten million dollars' worth of stock to the Rockefellers.

Mullins' book traces this vast conspiracy through the various wars and depressions of this Century, right up to the founding of the International Monetary Fund, brainchild of communist spy Harry Dexter White. The first chairman of the Fund was international banker Eugene Meyer Jnr. who is at present owner of the left-wing "Washington Post".

The Iron Curtain Over America

How much further, one wonders, can the world be taken along the road of ever more drastic interference with natural processes, with the fundamental laws of the universe, God's law— under guidance of experts controlled by politicians in the widest and most sinister sense of that word, before it will pay the penalty for its ignorance, its non-awareness of the deadly struggle being waged today between the Powers of Light and the Powers of Compulsion and Darkness? The world is you and me. What side are you on? Are you aware of the threat to your very life and the life of your children contained in this proposal to fluoridate the water supplies of our State? Have you joined our crusade for our fundamental right of access of a supply of an unmedicated and un-chemicalized water supply? Have you informed your M.L.A. and M.L.C. of your reactions to this unethical and unconstitutional and dangerous proposal? We have informed ours. The reply was that our salaried representative in Parliament "knew nothing about the problem you mention". There may be others like him, and it is obvious to us that the Fluoridationists are banking on the present wide-spread ignorance of the electorate and their representatives for putting over on us a scheme as dangerous to our health and well-being as any our worst enemy could devise. We have further taken the step of informing by wire and letter the Premier, Mr. Cain, and the Minister of Health, Mr. Barry, of our reasons for op-

posing this measure, and we have received from the Premier the reply that "the views which you have expressed in this matter have been noted, and will receive consideration". But we know what value can be placed on ministerial statements and we know also something of the technique that must be employed to hold politicians to their word

It is a significant fact that in many places of the world it is the women who have taken the lead in the fight against the water poisoners. From one of the prime movers against fluoridation in Western Canada we have had a letter containing this shrewd, may we say truly feminine observation: "At last I have tried to make the Research Council Chairman see something beyond just the chemical angle I thank Lord Douglas of Barloch for this for it was his speech which impressed him . . . people are silly to be herd-minded and afraid, and M.L.A.'s have about as little spine as swaying willows." Some of them, perhaps most of them, feel, like the late President Roosevelt, that it is the job of a politician to yield to pressure, to be willows swaying in the wind that blows from on high.

It is possible that no individuals have put more pressure on politicians, put a greater "fear of the Lord" into them in this matter of water poisoning than Mrs. Elizabeth Patullo, of Kirriemuir, Scotland, and her courageous colleagues in the British, and Scottish, Housewives' Associations. It was as a direct result of the efforts made by Mrs Patullo in putting the facts about fluoridation to the Council members of

Liverpool Town Council that brought defeat to the Fluoridationists in that important British key city. In a letter she circularised on August 11, 1954, Mrs. Patullo warned all councillors that they would "be well advised, before they take the responsibility— and the responsibility is theirs, for after the Minister of Health has made his recommendations his responsibility ceases— to wait and accumulate further knowledge and advice."

Mrs. Patullo reminds us that this is not the first attempt to mass-medicate communities through the water tap. "You will recall that once there was an attempt to (Continued on page 9.)

put iodine in the water and that failed when in was proved, quite late in the proceedings, that it would definitely be harmful to certain members of the community. The iodisation project, like fluoridation today (and penicilliation tomorrow?—Ed.) had its ardent supporters and cocksure pronouncements. . . . Incidentally, does it not strike you as rather odd that our Food Standards Committee, acting on a report by its Metallic Contamination Sub-Committee, revised the 1947 Fluorine in Food Order, and laid down that whereas they had allowed a fluorine content of 300 p.p.m. in acid phosphates used in the manufacture of food and of baking powders and self-raising flour, that the limit shall now be 30 p.p.m. (quoting from the report of the Committee).

"In May, 1946, the Inter-Departmental Committee on Food Standards published a report on the question of prescribing limits to the fluorine content of acid phosphates used for food purposes. The Medical Research Council, who were consulted by the Committee, pointed out that the effects of fluorine are cumulative, and that fluorine absorbed in small quantities over a sufficient period of time can produce pathological changes in the kidneys and gross lesions of hone"

In another letter written to the Medical Officer of Health for Watford (W. Alcock, M.D., etc.) Mrs. Patullo writes that she is not impressed with the fact that a list of learned bodies could be quoted in favour of fluoridation, and points out that "strangely enough the British Medical Association is not included in such a list. I know that when the Royal College of Physicians were approached for a guarantee that fluoridation of water supplies would not injure the body now, or at a later date, they declined to do so."

We are further informed that Professor Stones, who led the British Mission on Fluoridation to the U.S.A., admitted, in an article in the "British Medical Journal", that cryolite workers may ingest a daily dose of 25-30 mgms of fluorine per day, and this "may lead to decreased mobility of the spine".

Finally we quote a letter Mrs. Patullo wrote to the Chairman of Watford Public Health Committee (Mr. L. C. Johnson) in which she contrasts the general ignorance of those who, like Dr. Nisbet, of Kilmarnock, and Dr. Greenwood Wilson, of Cardiff, recommended fluoridation without having undertaken any independent research into the matter whatever, with Dr. Dillon who, "at his own personal expense (there is never any Government support for investigations directly concerned with matters of real importance to the people's health-Ed.), has acquired the technique of fluorine analysis and furnished a laboratory for his experiments, again at his own expense" and who has had the temerity to suggest that if the Government withdrew "from circulation" the highly toxic agenised National Loaf which it subsidized, the dental decay rate in children could be reduced by at least as much as that now claimed for the fluoridation project. To suggest that "Governments" create problems which they then

set about to solve along pseudo scientific lines is, of course, the height of heresy. The introduction of State medicine in Great Britain has ensured that there shall be fewer and fewer Dr. Dillons to point to root causes, and more and more to toe the official line of suppressing symptoms, a line acceptable to State Health Services everywhere. Mrs. Patullo writes:

"I must remind the Minister of Health that it is a tradition of the medical profession not to administer any drug to man or beast the dose of which cannot be fixed or determined or controlled. In the course of our study we have found certain anomalies and misstatements. When attention has been drawn to these erroneous statements we have received nothing but evasion."

Once again, we must ask: What is the mechanism used by the "Stealthy Ones" to make the rank and file of professional organizations "toe the official line"? Who are "the Stealthy Ones"? They are connected, if not entirely identifiable, with the power groups who control the advertisements of the big daily newspapers. Dr. Royal Lee, writing on fluoridation in the "Milwaukee Sentinel", April 5, 1954, in an article inserted and paid for by himself, states:

"Among those who advocate the fluoridation programme are groups who have historically profited as a result of the adulteration of our staple foods through promotion of chemical preservatives that destroy important vitamin and mineral factors, and unquestionably result in promoting tooth decay. Those who have the duty to dispense information to the public are notoriously susceptible to boycott by powerful advertising syndicates."

Few people realize the extent to which fear rules the world. Fifty years of continuous wars or threat of wars, and increasing bureaucratization of every country in the world, has brought about a situation characterized by almost universal acceptance ("what can we do about it?) of conditions which our fathers and mothers would not have tolerated for five minutes. The crying need of the modern world is for individuals of integrity and fearlessness. We are still looking for the reason why professional men, doctors, dentists and lawyers, and others, can always be relied upon to lead the general scuttle to submit to further encroachments on our rights. A leading protagonist of the right to choose what kind of milk the people of Victoria should be allowed to drink, told an audience recently that in her fight against pasteurization she had been astounded by the way she had been let down by all the professional men who had promised to back her up. At the critical moment they asked to have themselves excused, following the example of the people in the Gospel story. The men, she said, who had promised to be behind her, were found to be so far behind as to be out of sight! In an open letter to readers, the Adelaide naturopath, Madame Mira Louise (in a recently published pamphlet: "Fluoridation the Poisoner") asks:

"Why are so many doctors and dentists (in the U.S.A.—Ed.) favouring fluorine. It seems to be a matter of association

control. Medical and dental colleges, as well as State health departments, receive large grants of money from the U.S. Public Health Service, which is promoting fluoridation. These money grants are given on the condition that the programmes of the U.S. Public Health Service are fostered. Furthermore, it is considered unethical for an individual doctor or dentist to publicly oppose a programme which his association has endorsed."

There it is: the fear of standing out, of being unorthodox, of separating yourself from your "gang" whether this be professional association, political party, social class or what have you. The herd, the mass, is always right. Madame Mira Louise quotes Dr. E. F. Exner, of Seattle:

"The dentists can be excused on two counts — they are not versed in medicine and they are being blackmailed. They are told that if they oppose fluoridation they will be accused of protecting a vested interest in tooth decay. Neither excuse

applies to the doctors.'

There is no reason for thinking that doctors, as a class, are any more immune from the blackmailing tactics of the "minority lobbies" than the dentists, and therefore no reason why we should not excuse the majority of them — forgive them for they know not what they do — as well as the dentists, or other professional men whose services are continuously invoked and needed for the further bureaucratization of our society. Our medicos suffer, moreover, from the severe handicap of a training in symptom suppression which, it would appear, makes them amenable to much of the political reason which consists in patching up the ravages caused in society by following and enforcing rules and regulations of an essentially antihuman nature, most of which tend to foster the mass mind dominated by mass fear which is the scourge of our age; yes, indeed let us forgive them but let us also stop looking to them for any guidance in vital and public (including health) matters. A profession which—with a few honourable exceptions — has not only failed to warn us, but even to protest against, the doctoring of our food supplies, the destruction of our milk via pasteurization — and now the poisoning of our water supplies can no longer be regarded as professing the truth of the matter in which it claims proficiency; in fact the collective moral debacle of the medical profession can only be explained by nothing but fear of blackmail. Miss Charlotte Wettrick, of Seattle, Washington,

"We deplore the low level to which the medical profession fell under the Hitler regime. It did not come suddenly in Germany. It was a gradual process until the Government had the doctors in fear unless they did what the Government demanded. After a time they were adjusted to the idea (of being State doctors, or civil servants) and looked upon it as a patriotic duty to the country. Shall we let it happen here? There are many dentists in our city who are opposed to fluoridation but fear to speak out against it unless the citizenry decide to support them. Some did speak out

against it when the discussion first opened but not a word of opposition comes from them now."

Those who have studied the behind-thescenes of International politics are well aware of the decisive part played by political refugees from Central and Eastern Europe, in the gradual subjection of individual doctors who control the state apparatus. It is no accident that the father of Mr. Bernard M. Baruch, the most powerful and most sinister figure of U.S. politics who has secretly advised every President since Wilson, came from East Prussia to the U.S.A. and soon advanced in the State Health Services. He can be said to have blazed a trail for a long trek of doctors from the same part of the world, mostly, like him, in favour of extending the power of the State over the individual all in the interest of "Public Health". We wonder how many of them shared the preference of Baruch Senior for occult politics. (He was a member of the Ku Klux Klan.) Note now the name of the Health Officer of the City of Long Beach, California: Dr. Irwin D. Litwack, who formally recommended his city council to fluoridate their water supplies in 1954. But Dr. Litwack reckoned without the individual initiative, the true Christian feelings which animated one of his prospective victims. Fanchon Battelle, of Long Beach, wrote to him (the letter is published in a pamphlet entitled "Fluoridation Unmasked", in November 1954:

"Fluoridation has been used in countries taken over by dictators to immobilize the people's will and ability to think. It has been used for this purpose in Russia Fluorine is a known desensitizing agent Fluorine produced nerve paralysis causing a slow up of brain and body function. The action of fluorides in paralysing nerve cells in the brain, referred to as chemical lobotomy, is similar to that produced by surgical lobotomy which is the severing of certain nerves in the front portion of the brain.

"Dr. Nicholas Nyarradi, former Minister of Finance in Hungary's post-war Government, an escapee to America, states that Comrade Zhhchovitsky, legal advisor of the Soviet Ministry of Foreign Trade in the United States, told him of the plan to poison the water reservoirs of this country. Dr. Zdenek V. Moudry, former advisor to the Czechoslovak Ministry of Public Health, another escapee to America, stated that the Russians conducted a mass biological warfare experiment on six villages near Prague by injecting poison into the water supplies, which resulted in numerous deaths. Dr. Moudry stated a Russian Colonel Unkrov ordered the human guinea pig experiment on the PRETEXT of stamping out illness."

But not all the political doctor-refugees from Central Europe play in with the planners of other peoples' lives. Dr. E. H. Bronner, Research Chemist, Los Angeles, wrote in "The Catholic Mirror", Springfield, U.S.A., in January 1952:

"There is a sinister network of subversive agents, Godless 'intellectual' parasites, working in our country whose ramifications grow more extensive, more successful, and more alarming, each new year and whose true objective is to demoralize, paralyse and destroy our Great Republic — from within if they can, according to their plan — these same public health officials (who advocate fluoridation) will drink only fluoride-free bottled spring water in their own offices and homes — fluoridation of water supplies can be slow national suicide or quick national 'liquidation'. It is criminal insanity — treason!"

These are strong words, but consider, women, those of you who are the mothers, and those of you who are about to be mothers, these final statements:

"Pregnancy is another variable. The Department of Agriculture recommends that no fluorides be fed to brood sows. It is known that fluorides pile up in the placenta of pregnant women, but what they do to the unborn child is not known."

—Johnathan Foreman, M.O., "Fluorine on Tap", in "The Land", Spring. 1953.

Compare that with Madame Mira Louise's compilation "Fluoridation, the Poisoner", page 7.

"Dr. Carl Neuport, Wisconsin Health Officer, pioneer fluoridation, recently admitted that premature births are increasing in his State, where much of the water has been fluoridated at his instigation. Army doctors in Colorado Springs advise pregnant wives of Army personnel to drink non-fluorine bottled water.

"Dr. C. T. Betts, of Toledo, Ohio, states: 'Fluorine was classed with ergot many years ago as an abortion drug.'

"In Newburgh, New York, the facts are coming out now that the poor women are having dry-birth babies, so many in fact, that the doctors of the town are frantically examining everything to learn the truth. They found that these mothers had almost three times as much fluorine in the placenta as found in mothers where fluorine is not used. They admit that the placenta (after birth) was not able to prevent the poison from getting into the child, and that they do not know the amount it took to kill the child."

And consider then, in conclusion, what a specialist on Fluorine wrote to Mrs. Patullo, of the Scottish Housewives:

"I received recently a letter from a famous German hospital. An eight months' old child of a mother who was taking tablets containing small amounts of sodium fluoride during pregnancy, presumably to prevent dental decay, was brought into hospital suffering from what was diagnosed as tetany. Examination revealed the alternative possibility that the child may be suffering from damage to the brain caused by the fluorine which the mother took."

Life from the Soil

By Col. H. F. White and Sir C. Stanton Hicks

This is the first Australian book on organic faming and associated subjects. Written by two distinguished Australians, Col. H. F. He immediately switched to a system of ley farming and noticed an almost immediate improvement in his soil structure, his pastures and the health of his stock. Col. White's practical experience with organic farming methods under Australian conditions should be studied by every genuinely progressive farmer.

Sir Stanton Hicks is a recognised world authority on nutrition, and when he warns that there is a direct relationship between the increasing incidence of degenerative diseases and man's exploitive farming methods, every sensible person should take heed. As Sir Stanton points out, the subject of the quality of food concerns every individual, not only farmers.

In his chapter on Ecology, the author makes the penetrating observation that the "excessive uprooting of man from his true relation to his natural environment, focuses his attention to an increasing extent on a highly artificial feature of his ecology, namely sociology. This preoccupation finds expression in a much abused term, "standard of living", and since government is based upon numbers, urbanisation which follows industrialisation, concentrates political attention upon the towns."

probably the major one is that a large number of Americans uncritically accept all the propaganda they hear about the evils of "brutal colonialism". Earp Thomas Municipal Composting in Sydney From A.N.Z. Bank, Quarterly Survey, 1954

A project, which employs bacterial inoculation in a modern plant to make fertiliser from garbage, is operated in the Sydney metropolitan area by the Canterbury municipality—one of the largest in New South Wales. This area has a population of 118,000 people, from which about 300 tons of garbage is collected weekly. The municipality faced the alternatives of tipping outside its area or incineration—both expensive. But a composting plant has now been erected at a cost of some £110,000, which will require a labour force of about ten to twelve. Costs will be offset by revenue from the sale of salvaged paper, rags, glass and metals, while the fertiliser is expected to realise some additional revenue, whereas disposal of refuse by controlled tipping used to cost about 15/- a

In this scheme the garbage is tipped from the collecting trucks into a large concrete bin of 400 cubic yards capacity, over the floor of which move chains, which convey the material to an agitator. This breaks up wrapped parcels, etc., so that when the material is dropped on to a moving belt, fabrics may be hand-picked and paper is removed by exhaust fans to a paper-baling shed. A magnetic extractor removes all ferrous metals, while the nonferrous metals, glass, rubber and other inorganic substances are picked off by hand.

A breaker next reduces such items as bread, fruit, etc., to a convenient size, before a spiral conveyor carries the refuse up to a second level of the plant. Here another conveyor belt enables the material to be fed into any one of six digesters. These digesters contain four levels. the compost spending a day at each level. As the charge is moved down each day, a fresh charge is placed in the top level. This is inoculated with bacteria, and during the four days in the digester decomposed into good compost.

The bacteria are cultivated continuously in kindling bins. From these a certain quantity of inoculated material is transferred to the digesters with each fresh charge. A thermometer in these kindling bins shows that the temperature reaches 130 deg. to 140 deg. F. in this material, and similar temperatures are reached in the digesters themselves. On leaving the digesters, the product is almost odourless. It is further dried, then milled to a grade required by distributors, who take delivery in bulk from a storage bin. The humus is used for market gardens, in growing fruit, flowers, lawns, etc., and is quite free from harmful components because any temperature in the drier, removing excess moisture, is sufficient to destroy any harmful bacteria. Difficulties will, no doubt, be encountered in extending this process in other areas, but one may expect that in a matter of such growing necessity, the technical problems will be overcome, as they are being overcome at Canterbury.

balloting by an ignorant, propagandised and irresponsible electorate is no basis on which to found responsible government and that in its place a system of responsible voting must be substituted.

- (7) All property taxes, including estate duty, to be abolished; and any taxation that is necessary to be levied directly on income.
- (8) All the professions and productive enterprises to be freed from Governmental control and interference.

Other measures are necessary, but the above will serve to indicate the direction in which we must go.

In our issue of October 9, we stated the Declaration which is enclosed with this issue in reverse in the form of eleven separate points: and we invited several thousand clergymen, if they disagreed with the Declaration, to put their signature against each point with which they disagreed. Not one of the clergy would deny the truth of even one of these points.

Point No. 10 of the Denial said:

A Christian is acting responsibly if he gives his electoral power to a politician, without binding him not to support any policy which destroys freedom to choose, other than specially provided for, e.g., Defence of the Realm.

Although none of the clergy would sign this point, several of them wrote to say that at the next election they would vote for what they considered the better of the parties, notwithstanding whether their policies produced evil results and foes of freedom.

Among these were some who expressed agreement with everything else in the Declaration except this question of exemplary action. In the words of one of them it constituted "the evasion of responsibility and the consent by agreement to the least desirable candidates in an election being given the mandate." These corres-

pendents have not taken account of the positive aspect of the exemplary action recommended. By giving support to "the lesser evil", but nevertheless evil policy. you are making yourself responsible for evil. By going to Hell at walking pace, instead of running, you are nonetheless going, and encouraging others, to go to Hell. It is the direction in which you are going which is all-important. By publicly withdrawing your support and at the same time giving an undertaking that you will return it when you have an absolute assurance that your support will only be used to form policy which goes in the right direction, you are not evading responsibility, but agreeing to be responsible only for a Christian policy. Thus do you provide sanctions for the politician who wants to rebel against evil policies? There is really much more significance to the action than that: To quote the Dean of St. Paul's: "It may be that the final testing question for the Church is this: Does it through its members so manifest Christ that the sign of Jona is there for all to see?" It is exemplary action in politics, which is required.

Point 3 said: It is not the responsibility of the Church to declare the truth in regard to policies, which affect the power of the individual to choose.

We have to ask, if the clergy are not prepared to make this denial, then what are they going to do about it?
