DOLLAR CONQUEST OF AFRICA

WELL UNDER WAY

Coloured People Backed Against Europeans

The following article from "The South African Observer" for February shows how the dollar diplomats are now intensifying their campaign to conquer Africa and how they are using the coloured peoples to do this:

For too long has it been assumed, against all facts that the American State Department has somehow, "despite differences", always been basically "on the side of" Europe and the white man. Vice-President Nixon let the cat out of the bag when he announced America's break with Britain and France. He hailed this break as a 'declaration of independence that has had an electrifying effect throughout the coloured world." He also said:

"Because we took the position we did (against British-French intervention in Egypt), the peoples of Africa and Asia know now that we walk with them as moral equals, that we do not have one standard of law for the West and one for the East. They know, too, that the United States has no illusions about the 'white man's burden' or 'white supremacy'."

"The Suez affair marked a turning point in history because the United States deliberately deserted the colonial powers which had been its traditional friends.... We pledged our support to nations formerly held as colonies by the major powers."

Now that America is supplanting Britain and France in another sphere of influence, the U.S. State Department has apparently decided to ignore Europe and to bid in the open market for the African (and Asian) peoples — at the expense of the white man in Africa and in Europe.

That the new American policy can have far-reaching repercussions in Africa was indicated in a warning given by Mr. Eric Louw while he was in New York. He said: "I am not informed in regard to the probable changes in United States policy, and I will therefore say not more than that the Western nations run the risk

of being sadly disillusioned if, in this matter, they are relying on support from the East, either in their own national interest or for the purpose of resisting Communist expansion." Mr. Louw added: "If support is given, it will be at a price—and the price may be Africa."

There are many indications that the price — and prize — will be Africa, and that Russian imperialism and American dollar imperialism are now locking with one another in a struggle for the African continent with both ostensibly prepared to offer it to Asia as a hinterland for its surplus population, in exchange for Asian support, and both prepared to jettison the interests of Western Europe in the process. Europe should realise that the American, Russian and Indian attacks on the European in South Africa are merely an aspect of their general attempt to oust Europe and European interests from Africa. In this purpose Communism and Dollarism are at one.

That Africa is coming well within the sphere of U.S. power and dollar calculations is indicated in a staff report prepared for the Foreign Relations Committee of the U.S. Senate, which observed that Africa is coming "well within the sphere of contemporary international relations and into the forefront of great power strategic calculations."

What is American policy in Africa? There are many pointers.

The U.S. representative on the U.N. Trusteeship Council, Mr. Mason Sears, asserted in a speech in Washington "Africa has become the key-continent of the world." Then with surprising candour for an official American spokesman, he said: "South Africa is a beautiful country and produces enormous wealth against a

background of plentiful and cheap African labour."

"The Afrikaners hold absolute political power through their Nationalist Party which attempts to erect higher and higher barriers between the races."

"With the African majority denied a proportionate share of the good things of life the country produces, the Government's segregation program seems to be in for increasing trouble."

Mr. Sears went on to say there were two great conflicting forces in Africa, namely

(1) the emergence of new independent nations all over North and West Africa, and (2) "the struggle of European settlers in East and South Africa to retain their present position of supremacy in the face of huge African majorities." Warned Sears: "These two opposing forces are gradually closing in on each other which means something has got to give way or be crushed in the process.'

Sears singled out South Africa, Kenya and the Rhodesias as the problem areas around which the future of race relations in Africa will revolve.

In outlining American policy for these areas, Mr. Sears said that America should make it known that she will always stand on the principle of "government by consent", and that America must urgently develop new points of contact between the African and American peoples.

We can infer from all this that the U.S. State Department will set about wooing the African peoples — at the expense of the white man. We may also reasonably infer that South Africa, Kenya and the Rhodesias are "problem areas" in American eyes for no reason other than that the whites in these areas do not accept Washington's (and Moscow's) doctrine of equality.

We have further guides to U.S. policy. Both Eisenhower and Nixon are firmly declared integrationists and have stopped at nothing to win Negro votes.

Attempting to justify integrations in the United States, LIFE Magazine reflected the American press and 'big business' standpoint. LIFE Magazine said: "Integration means increased stature for the U.S. in the eyes of non-whites the world over — peoples whom the Communists are trying desperately to win over to their side.'

We also have the statement of Vice-President Nixon who told a Hershey, Pennsylvania, audience that "for the first time in history we have shown independence of Anglo-French policies toward Asia and Africa which seem to us to reflect the colonial tradition.'

On November 4, 1956, the President's top aide, Sherman Adams, told a national audience on the radio-TV show "Meet the Press" that the United States can do in the world today what she may never have had the chance to do since the Declaration of Independence, namely –

"to commence to get these people (nations of Africa and Asia) to understand that they have their right in the sun and it is not power politics that the West is playing. This is the mission of freedom with justice in the world, and that is the basic foundation of the American policy." What Sherman Adams, of course, omitted to say was that America is playing power dollar—politics in Africa, and that in the guise of her mission of freedom, "anticolonialism" and "saving Africa from Communism", she is opening the way for her own imperialism in Africa.

The U.S. Senate Foreign Relations Sub-Committee staff report dealing chiefly with African economics made the point that American assistance to under-developed areas "does not stem from precisely the same considerations as those prominent in the African development program of the European powers". "European powers", the report noted, "tended to design their colonial development programs with a view to improving their own economic welfare.'

What the report did not tackle was the fear of the European countries over what will happen to their precarious economics "when" they lose control over Africa, which many American observers feel they surely will. What the report also did not tackle was the

fate of white men in Africa.

In fact, the U.S. State Department shows no practical concern about the whites. It ignores them. It is primarily concerned with developing contacts with African majorities. It knows that by wooing the black majorities in Africa it can conveniently take short cuts to penetration and dollar control of Africa. American propaganda will naturally emphasise its mission of freedom with justice, while carefully concealing its own political and financial imperialism.

America is at present glowing with fervour for the U.N. Organisation, for "anticolonialism", and for the Eisenhower doctrine, which is meant to create conditions in the Middle East to make it impervious to Russian penetration. What her propagandists conceal, however, is that America has no solutions for any basic Middle East problems!

The Eisenhower doctrine will be an undoubted factor in halting Russian penetration. But we in Africa will make a great mistake if we do not realise that while America is about to save the Middle East (and American oil interests)—and quite incidentally ourselves—from Russian penetration, there is apparently nothing to save us from American dollar penetration and imperialism. Indeed, there is no one except ourselves — to save us from the Uno, Unesco and World Bank doctrines that the U.S. State Department is busily forcing on the American people, and which it will no doubt try to force on the rest of the

Too few people in Europe and Africa realise that the U.S. State Department today is a citadel not of Americanism but of International Socialism.

Notes on the News

JEWISH PROPAGANDIST IN AUSTRALIA

A Mr. Julius Hollander, from Israel, is at present touring Australia. Like most Jewish propagandists, Mr. Hollander is an expert exponent of what C. H. Douglas described as "the double standard". That is, one standard of behaviour for the Jew while insisting upon another standard for the non-Jew.

Mr. Hollander claims, "rising the living standards of the Arab countries was the only solution of the Middle East problem". He also states "backward areas are natural breeding grounds for Communism". This is not true in the case of the Arab countries. Communist penetration made little progress in Arab countries — the religious barrier being too strong — until the Zionist irritant in the form of Israel was introduced. There will be neither peace nor stability until this irritant is removed. The "United" Nations is determined that it shall not be removed thus demonstrating that this organisation is being wed by both the Zionists and the Communists.

REFUGEES FROM BRITAIN

If Mr. Harold Macmillan persists with his Communistic policies in Britain, it is certain that the flood of refugees from that unfortunate country will grow. A recent survey in Britain revealed that 38 percent of students at the University of Cambridge were seriously thinking of leaving their own country, or had definitely decided to leave when they finished their courses. It. is clear that a growing number of the most enterprising of the British people have decided that they cannot tolerate present British Governments.

If Mr. Macmillan continues with his policies, he will most certainly produce conditions in which the Communists could come to power. When people flee from the results of the policies of their own Government, there can be no doubt that that Government is oppressive and dictatorial.

"ANTI-SEMITISM" IN HUNGARY

A close study of the world's Jewish press since the Hungarian revolt against Communism reveals that Jewish spokesmen have been far more concerned about the plight of the Jew in Hungary than they Have been in helping the Hungarians in their struggle for freedom.

"The Australian Jewish News" of March 1 reports that the World Jewish Congress has provided detailed evidence of wide-spread "anti-Semitism" in Hungary during the anti-Communist uprising. Needless to say, the World Jewish Congress has offered no reasons why the Hungarians in their epic struggle for freedom

from Moscow should have specially attacked the Jews. The truth of the matter is, of course, that the Hungarians did not attack the Jews because they were Jews, but because they closely associated with the hated Communist regime.

In recent years there has been a lot of talk about the alleged anti-Semitism of the Communist leaders. The Hungarian revolt demonstrated that so far from being persecuted by the Communists, Jews dominated the secret police and generally supported the Communist Government. Many of these Jews are now in Australia and other British countries. They will be of no value in the fight against totalitarianism.

BANKING IGNORANCE

In all the welter of recent discussion on banking we have not seen one reference by politicians, newspaper writers or economic "experts" to the basic facts concerning the banking system. The jargon about "liquidity" and the "special accounts system" help obscure the fact that (a) the banking system creates the bulk of the community's finance in the form of bank credit and that the real cost of this creation is the pens, ink, paper and manpower used; and (b) that because of the manner in which this bank credit is issued the total indebtedness of the community must progressively increase.

The creation and lending of new credit is governed primarily by what is termed the "liquidity" of the banks. This means the amount of cash they hold. Apart from notes and coins, the trading banks treat central bank credit as cash. As the central bank governs the volume of both notes and coins as well as central bank credit, it therefore governs the rate of credit expansion by the trading banks.

No politician, or anyone else, can make a genuine attack upon central planning unless he also attacks the present system of centralised credit control and the manner in which credit is issued and withdrawn. There can be no genuine decentralisation without decentralised credit control. We suggest that every person who talks about decentralisation should have his attention drawn to this fact.

EUROPEAN

"INTEGRATION"

Following the signing by six West European nations of draft treaties establishing a common market and an atomic energy pool, the American State Department hailed the move as "A new landmark of the road toward European integration". The fact that the American State Department, dominated by Socialists and internationalists, is strongly supporting the "integration" of Europe should be sufficient to make intelligent people suspicious.

An Introduction To Social Credit

By Bryan W. Monahan

This excellent book is specially recommended to those who desire a clearly written, but authoritative introduction to the subject of Social Credit. Dr. Bryan Monahan is Chairman of the Social Credit Secretariat, a body established by the late Major C. H. Douglas.

Social Credit concerns much more than monetary reform, which was one of the reasons why Major Douglas established the Social Credit Secretariat. Dr. Monahan writes: "Social Credit is a way of looking at things, a point of view that seems to bring every branch of knowledge into a new and more clear perspective. Equally, all knowledge is relevant to Social Credit."

"An Introduction To Social Credit" is divided into four parts: Physics, Economics, Politics and Metaphysics. The chapter on physics shows how increasing leisure and security for every individual are physically possible. The author writes: "Clearly, only either leisure, or 'unemployment' outside production can dispose of the 'unemployment problem'. The problems of economics and politics are absolutely conditioned by the physical realities described: short of sabotage or cataclysm, the progress of the situation is inexorable..."

After dealing simply but comprehensively with the Social Credit A — B theorem in the chapter on Economics, Dr. Monahan points out that the emphasis in Social Credit has passed from purely technical considerations to the subject of credit control and policy. This leads naturally to an examination of the policy of Social Credit and the Christian philosophy from which it stems, as compared with the various totalitarian policies based upon an anti-Christian philosophy

upon an anti-Christian philosophy.

Dr. Monahan's book is well produced, has a comprehensive index, and contains two appendices: one giving Douglas's analysis of the financing of a long-term production cycle in order to present a simple and convenient formal proof of the Social Credit theorem, and the other outlining the reasons for the establishment of the Social Credit Secretariat.

The Question of Housing

By his fantastic statement that the housing problem was the result primarily of a lack of materials and manpower, the Prime Minister, Mr. Menzies, handed his political opponents a weapon with which they have been vigorously attacking him ever since. Food, clothing and shelter are the basic requirements of the human being. Unless he can readily and easily obtain these requirements, he cannot live as a civilised person. Now there is no real problem whatever about producing an abundance of food, clothing and shelter. Anyone who says there is can only be regarded as

an economic ignoramus.

Like most problems, that of housing is confused by a general refusal to look at basic principles, and, of course, arguments of the politicians, who are more concerned about debating victories than in discovering truth. Labor politicians generally, and we include the two anti-Communist Labor Senators, claim that the problem of building sufficient houses for the people can only be solved by some more central planning. One of the most futile and misleading aspects of the political controversy on housing has been the references to the migrants. Judging by some of the comments of Government supporters at Canberra, they appear to believe that if there had been no migration programme the housing problem would have been much worse. They point to the large numbers of migrants engaged in building housing. But this proves nothing because before the war Australians housed themselves without any assistance from migrants. The housing problem then, as now, was governed entirely by financial policy. And there can be no genuine solution to the housing problem unless there is a financial policy, which enables the individual to obtain from the production system, in order of preference, the results he desires.

The claim that costs of house building are too high, and that this is one of the basic causes of insufficient homes, is merely another way of saying that the individual has insufficient financial credit to get a builder to build him the type of home he desires. The real cost of building is, of course, no higher than it was before the war. It is true that one of the effects of the present economic and financial system is the go-slow tactics, which are evident in all industries. But to make a major issue out of effects while ignoring causes is dangerously misleading. And the basic cause of the housing problem is the fact that the individual cannot obtain sufficient financial credit to enable him to build. In their desperate efforts to obtain sufficient finance, young couples both go to work and are unable to have children when they should be having them. The social results

are disastrous.

It is true that up until recently all builders have been fully engaged upon using building materials. But much of this building has been of little benefit to the individual. It has been related to what is termed developing the nation's resources. Central control of credit has enabled this type of development to take place at the expense of the individual. There has been sufficient development in this country to provide for the genuine requirements of the people and it is time that sufficient long-term credits, issued at the bare cost of administration, probably about one percent or less, were made available to all individuals desirous of building new homes. All that prevents the implementation of this policy is the current totalitarian conception concerning the issue and control of financial credit.

HIRE-PURCHASE CRITICS MISLEAD

Most of the critical comment on hire-purchase schemes deals with effects and ignores causes. The rate of interest being charged is relatively unimportant compared with the question of why is it necessary for the individual to mortgage tomorrow's income in order to buy goods, which have already been produced. The rapid growth of hire-purchase schemes should prove to all but those who have been completely brainwashed, that production does not automatically distribute sufficient purchasing power in wages, salaries and dividends to meet prices.

Even if present hire-purchase interest rates were reduced by 50 percent, it would not affect the fact that the public and private indebtedness of the individual must be progressively increased to enable goods to be sold. We suggest that the critics of hire purchase examine this question and face the fact that new financial credits are required to finance consumption as well as production. Those advocating that finance now being used for hirepurchase schemes should be used for further capital production, supporting a policy which would produce economic chaos under present financial

The Credit Monopoly in the U.S.A.

The largest two percent of the banks in the country now control over fifty-eight percent of all bank deposits. Over 800 commercial banks have been eliminated since 1950 through mergers.

During the 1920's, when the economic expansion of the country was confined to big business the way it is today, the need to meet the demand for big business credit also stimulated banking mergers.

Increased concentration of control over the country's financial resources has always meant a loss of economic freedom for farmers and small businessmen.

From 30,000 banks in the early thirties, we now have 14,000. We must encourage the independent bank serving local people and prevent too much concentration in banking.

(Continued from page 3) sation of power takes place, it inevitably produces the same disastrous results for the individual. Any person, who accepts the propaganda claiming that the American policy makers support the European Common Market Scheme because it will result in more efficient production, is obviously very simple. So far from freeing Europe from dollar domination, the centralisation of control and power in Europe will make the task of the dollar diplomats easier. And irrespective of what they may say, the Communists welcome all centralisation of power because centralised power is much easier to take over than decentralised power.

COMMUNISTS ATTACK WHITE AUSTRALIA POLICY

In reviewing the recent A.L.P. Conference in Brisbane, Communist leader Lance Sharkey supports the foreign and economic policy decisions, but strongly criticises the support of the White Australia policy. Support for this policy, claims Mr. Sharkey, is out of keeping with "progressive" thought. The Communists, of course, understand the long-range implications of race "integration". But woolly-minded idealists, particularly many Church spokesmen, are so divorced from reality that they cannot understand the significance of what they suggest. If it is anti-Christian to prefer to have a certain type of migrant come into Australia, then presumably it is anti-Christian to prefer certain types of people to come into one's home. The individual has a natural right to decide with whom he wishes to associate. The Communists violently attack that right. And they have a large number of allies who have the audacity to call themselves anti-Communists.

THE "DEMOCRATIC" LABOR PARTY

Nothing is more confusing in these days of political decadence than the manner in which the term "democratic" is used. Democracy now one of those omnibus terms which mean all things to all men. But this has not deterred the supporters of the new Labor Party in N.S.W. from using the term democratic. Feverish moves are now taking place to form this new Party on a national basis. The Anticommunist Labor Party in Victoria is considering amalgamation with the Democratic Labor Party.

After an examination of some of the proposed policies of this new party, we have no hesitation in saying that most of them have little relationship to genuine democracy, which means genuine freedom of choice for the individual. N.S.W. spokesman for the party claim that they are anti-Communist, and no doubt genuinely believe that they are. But then they support the basic Communist principle of the centralisation of power. For example, they want a Commonwealth—State planning authority for housing. They even feel that the Commonwealth should have a say in education.

New Light on Senator Knowland

The following letter to Senator Knowland gives some indication of the calibre of the man who is regarded as a strong contender for the American Presidency in 1960:

Honorable William F. Knowland, United States Senate, Senate Office Building Washington, D.C. Dear Bill,

For the past month or so you have been making noises like a man who might have his eye on the White House in 1960. Nothing would please us more down here in the Deep South than to see a real American Democrat and a real American Republican have a real "stomp down" political battle for the Presidency. Most informed Southerners are sick and tired of a "canned program" like the recent comic opera of the past presidential election. The one hundred and thirty-seven million white Christian citizens of the United States will not be fooled again; Suez or no Suez.

Doubtless you remember our conversation back in Washington in 1949. Then we discussed my grave concern over the systematically planned destruction of the offensive potential of the Armed Forces of the United States and the unwarranted concentration of power in the hands of a very few people with the resultant elimination of the civilian and congressional checks and balances as provided in the Constitution for the military establishment. Of course, you remember that one year later the so-called police action in Korea, a national disgrace, well justified my apprehensions.

Therefore, imagine my dismay (for I know that you fully understand and appreciate the character of the "Hidden Force" or "Invisible Government") when the local newspaper of February 4, 1957 carried the following headline and article:

TARGET DATE IN SENATE FIXED ON CIVIL RIGHTS.

Washington, Feb. 3, (AP)—Sen. Knowland (R-Calif) today put a March 1 target date on efforts to get President Eisenhower's civil rights program before the Senate for debate.... By whatever means the end is accomplished, he said he is confident that civil rights legislation will be enacted in this session of Congress.

"I hope we can get a bill reported to the Senate by the Judiciary Committee by the end of the month", he said. "As soon as the Middle East resolution is out of the way, then we ought to turn our attention to civil rights".

Now, Bill, I just cannot believe that a man of your integrity could possibly have succumbed to the un-American pressure of the A.D.A., the N.A.A.C.P., and the Anti-Defamation League. If you really wish to do something for your country why not initiate a Senate investigation and expose the A.D.L., the A.D.A., and the N.A.A.C.P. for what they really are?

Although the A.D.L. has issued orders

"BRAIN-WASHING"

Secret Communist Textbook

(4/3 post free)

This synthesis of the Communist manual on brainwashing is one of the most shocking documents ever made available on the worldwide conspiracy against Christianity. The manual is used to train secretly chosen Communists in psycho-politics, which is defined as "the art and science of asserting and maintaining dominion over the thoughts and loyalties of individuals, officers, bureaus, and masses, and the effecting of the conquest of enemy nations through 'mental healing'." In other words, the aim of psycho-politics is TOTAL DE-GRADATION of all people, except the "Chosen Few" of the world bureaucracy who will rule over the rest.

The lectures instruct Communists in the corruption of youth and the exploitation of immorality; they explain to "operators" how to hold sane people in insane asylums without civil rights; how to use the frightful electric shock treatment and brain operations for Communist ends. And an introductory chapter to this book, written by Mr. Eric D. Butler, shows that all these vile arts and sciences are being used, HERE AND NOW, and that a certain type of psychiatry is nothing more than a disguised agency for World Communism.

This terrifying document, whose authenticity has been tested by enquiries in many parts of the world, displays an almost superhuman and devilish insight into the foibles and weaknesses of human beings. It boasts of how income tax was slipped into capitalist countries many years ago as a means towards their ultimate destruction; it shows "operators" how capitalist countries, given over to materialism, will co-operate eagerly in their own downfall.

to its "gigolos of the fourth estate" to give me the "quarantine treatment", within the past month I have made talks in Fairfax, Virginia, in the embattled courthouse at Clinton, Tennessee, in Prattville, Alabama and before the Daughters of the American Revolution at Pensacola, Florida. The subject of these open-forum discussions has been "The Hidden Force", and I carefully explained just what it is. Whether you Westerners realize it or not we Southerners are beginning to know what domestic Communism really is and how it operates; this despite the fact that, from fear of political reprisal, not a single United States Senator nor Representative has the guts to stand on his feet and tell the American people the truth about Communism and the United Nations.

Bill, when you were an Army officer you took practically the same oath I did when I was a Navy officer—"to uphold and defend the Constitution of the United States against all enemies, foreign and domestic". The Double-Crosser

President Eisenhower did not reach his present position without the aid of very powerful friends. Mr. Bernard Baruch was one of these. These friends took Eisenhower as a comparatively obscure military officer and made him Supreme Commander of Allied Military Forces during the war. It was here that Eisenhower first showed himself as an exponent of the double-cross. He was opposed to the British conception of invading Europe through South Europe and thus preventing the Communists from obtaining post-war control of Eastern Europe.

It was the same Eisenhower who held back allied troops in order that the Russians could advance still further into Europe. He then became chummy with Red Army General Zhukov and personally ordered that Russian refugees in Europe be forced back to Europe either to death or to the slave camps.

We are reliably informed that when Prime Minister Menzies went to Cairo he made it clear to Nasser that he was playing a dangerous game in defying the major powers. Nasser showed signs of cooperation. But several hours later came President Eisenhower's public statement that under no circumstances would force be used. Nasser immediately became arrogant and truculent.

When the British and French decided they had to take action to defend the source of their oil supplies, Eisenhower lost no time in drastic action. And no sooner had he and Prime Minister Macmillan issued their statement at Bermuda which inferred that Eisenhower had given the British another chance, that his right hand man John Foster Dulles comes out and makes it clear that there is still no agreement concerning the Middle East.

In view of this record of double-crossing we were not surprised to learn how General Eisenhower had aided and abetted the Jewish campaign to break the British attempt to hold Palestine and to protect the Arabs in the post-war years. A Jewish writer in England now reveals how Ben Gurion was assisted by Eisenhower, even with an American ship to break the British naval blockade, at the very time when Eisenhower was supposed to be a military ally of the British. This man cannot be trusted. Not only the British, but genuine Republican members of his own party like Senators Jenner and McCarthy have discovered this.

Primary Production and Farmers' Incomes

Campbell, Reader in Agricultural Economics at the University of Sydney, recently quoted figures to show that Australian farmers' incomes for 1955-56 fell for the fourth year in succession, and that in money terms, incomes for the year were lower than any since 1948-49. The Iron Curtain Over America

By Colonel John Beaty.

"The Iron Curtain Over America" proves conclusively that not only was the second world war organised, but that it was deliberately prolonged, and only concluded when the controllers of the Zionist-Communist conspiracy had achieved their major objectives. Detailed evidence is provided of the manner in which the truth about this conspiracy has been kept from the American people.

Colonel Beaty's conclusion is that America, and other Western nations, can only survive by first defeating "the enemy within." A STATEMENT ON FLUORIDATION

By Granville F. KNIGHT, M.D., F.A.C.A., F.I.A.A.

(Read before the 20th Annual Convention of the American Academy of Nutrition, Los Angeles, May 18, 1956)

Although those living in large metropolitan areas are often exposed to toxic amounts of fluorides in the air (in the form of by-products from steel, aluminium and fertiliser plants), certain interests are strongly advocating the addition of sodium fluoride, or similar compounds, in a dilution of one part per million, to domestic water supplies. This campaign is based on the questionable premise that the result will be less tooth decay in children without harm to consumers.

In my opinion—and I want it clearly understood that I am not reflecting the views of any medical or dental organization, but the ideas of an increasing number of thoughtful citizens and professional men (of whom only a few are willing to express themselves)—such fluoridation is not only illogical, but is an invasion of personal rights and is fraught with grave danger to the health of the whole population. Let me enumerate some objections: —

- 1. It is mass medication without precedent.
- 2. Sodium fluoride is a very toxic chemical acting as an enzyme poison, direct irritant and calcium inactivator. In a dilution of 1.15 million it reduces the activity of pancreatic lipase by 50 percent. It is also an inhibitor of cytochrome oxidase, catalase, alkaline phosphatese and others. It reacts with growing tooth enamel and with bones to produce irreversible damage. It may injure the kidneys nervous system, other tissues of susceptible individuals.
- 3. Fluoride is not a necessary trace element even for dental health.
- 4. The therapeutic dose (arbitrarily set at 1 ppm in drinking water) is equivalent to the toxic dose and yet the public is expected to consume this dangerous drug in uncontrolled quantities as a humanitarian gesture. How gullible are we? Even proponents admit that 15-20 percent of children drinking such water will show chalk patches in their teeth. Drugs of such potency, in the past, have only been administered individually and under close supervision. There is no reason to drop these safeguards.
- 5. Uniform dosage of any drug dissolved in the water supply is obviously impossible. Some individuals may drink ten times as much as others. Thirst has many variables.
- 6. Fluoridation is completely illogical and expensive to boot. Why treat all users of a domestic water supply when only one-tenth of one percent of the water will be consumed by the 12 percent who might possibly benefit? And why

- expose all citizens to a potentially serious hazard by forcing them to drink medicated water? In addition, it is admitted that children in rural areas will not receive the doubtful benefits. How much more logical it would be for those wishing to use this toxic chemical to add a known daily dose of chemically pure sodium fluoride to milk or water by means of a tablet or drops on the prescription of a physician or dentist—and how much cheaper!
- 7. Moreover, statistics cited to prove a marked reduction in dental caries in those children consuming artificially fluoridated water are both contradictory and unconvincing.
- 8. No satisfactory studies are available to prove lack of toxicity for the aged, and chronically ill, the malnourished, and the allergic members of the population.
- 9. Cases of serious illness resulting from consumption of water fluoridated at the recommended concentration are being reported. Allergic individuals, as might be expected, seem particularly susceptible. Two marked exhibiting fatal cases generalized fluorosis have been carefully studied and reported. They drank naturally fluoridated water not far above the advocated level.
- 10. The fact that those opposed to fluoridation not only have great difficulty in reporting their observations, but in addition are subjected to unfair assaults upon their personal integrity and professional standing, should be enough to make every physician and dentist resolve to learn all the facts and to question the motives and tactics of those advocating fluoridation.

Finally, citizens of every community should seriously question the advisability of permitting themselves and their children to serve as human guinea pigs for an experiment of dubious value and safety — particularly when avoidance of sugar and highly processed bread and cereals plus the consumption of an optimum diet will control dental caries in most instances and vastly improve the general health as well!
