## Zionist Front Dominates American Policies President Eisenhower's Real Masters

**As we have pointed out on a number of occasions since the Middle East situation started to make world headlines, it is essential for a genuine understanding of what is happening to realise that the State of Israel is merely an instrument of the International Zionists, and that the directors of International Zionism are closely associated with international banking. Because President Eisenhower and the American Secretary of State, Mr. John Foster Dulles, have appeared to be mildly critical of Israel's military action against Nasser's Egypt, many people have suggested that President Eisenhower and Mr. Dulles are now opposing the Zionists. There is no real evidence to support this view.**

But Major Robert Williams, former American Counter Intelligence Officer, has produced evidence which leaves no doubt that Eisenhower is strongly influenced by the most important Zionist front organisation in the U.S.A., the Council on Foreign Relations. Before examining the facts made available by Major Williams, we record the following item from the authoritative American publication, "Human Events", of April 20:

One press authority, whose knowledge of the White House commands respect, gives us the names of five who hold no public office, but who can get in to see Ike without clearing through the Appointments Secretary or through Assistant Sherman Adams. They are, as follows: Milton Eisenhower; "Jack" McCloy, Chairman of the Board of the Manhattan Bank, of New York; Paul Hoffman, General Lucius Clay, Chairman of the Continental Can Company; and Sidney Weinberg, of Goldman-Sachs Company of New York, investment bankers.

All of the five mentioned by "Human Events" are prominent members of the Council on Foreign Relations. The Council of Foreign Relations was established in 1919, leading Zionists playing a prominent role. A study of this organisation provides further evidence of how the Zionist financiers and their associates are prepared to assist in the furtherance of the Communist conspiracy. Although the Council of Foreign Relations is often termed "Rockefeller's Council on Foreign Relations", Major Williams states that its masters have used "the stupid, spoon-fed Rockefeller boys", who "have adopted Jewish internationalism in both politics and finance".

The Council of Foreign Relations plays a decisive role in helping to fashion American foreign policies and it is therefore important that not only the American people, but also the people of all countries, should know something about the identity of the members of this organisation. The following are some of those listed by Major Williams: Mr. John McCloy is chairman of the Board of CFR. McCloy was appointed president of the World Bank in February 1947. He is now head of the Chase National Bank; a property of the Rockefellers and the Jewish banking firms, including Kuhn, Loeb and Co. Eugene Black is President of the International Bank of Reconstruction and Development. Herbert Lehman, former Senator, is influential Zionist financier and closely associated with revolutionary activities in the U.S.A. Mr. W. Averell Harriman, international financier, is generally regarded as a front for the Kuhn, Loeb and Co. interests. Harriman is a Gentile functionary for Jewish interests. He was near the heart of the Yalta betrayal and was the instrument used to deprive the British of their Persian oil assets. David Sarnoff is a Minsk-born Jew who, through his control in radio, has fed Marxist ideas into American homes.

One of the most influential of Eisenhower's advisers amongst members of the CFR is Benjamin J. Bottenweiser, who resigned as head of the Kuhn, Loeb and Co. banking house in order to become Assistant High Commissioner to Germany. It is important to note that this influential member of the Zionist financial groups had the Communist agent, Alger Hiss, stay in his home during his second trial. He still condemns those who criticise Hiss. Another

important member of CFR is Arthur J. Goldsmith, one of the leading financial "fixers" for the Anti-Defamation League of B'nai B'rith. Major Williams reports that Smith and another Zionist "discovered" Eisenhower early in or before the war and helped provide the long-term propaganda build up which enabled them to put Eisenhower into the White House. The famous American reporter, Pegler, has stated that he caught two of Eisenhower's brothers sneaking out of Goldsmith's apartment just

### OUR POLICY

1. The support of all policies rooted in the Christian philosophy of freedom and based upon the Moral Law.
2. The preservation of Australia's sovereignty as a part of the British Empire, and the exposure of all internal and external groups, which attack that sovereignty.

## MOUNTING JEWISH PRESSURE ON CHURCH

**There is much "good fellowship" of a poisonous kind, in both the Catholic and secular press, in Australia and the United States, over the trip to America of Dublin's Lord Mayor, the Jew, Robert Briscoe.**

This man Briscoe is not a simple smiling comedian, a kindly Jew with a touch of blarney; he is an international Jew with a murky past, and has had connections with international bankers in New York.

According to the Irish paper "Fiat" (No. 40, published at 11 Lower Abbey Street, Dublin), Briscoe was elected Lord Mayor on June 25, 1956. "In the assembly of town councillors at which he was elected, Catholics predominated . . ." Some reports say that Briscoe is an important member of B'nai B'rith, the Jewish Masonic organisation.

Mary Elizabeth Joyce, writing in the "Brooklyn Tablet" of March 9, says that Briscoe toured the Middle East with an Irish Trade Mission in 1947. "Many of his Catholic friends . . . aided the Jewish underground in Palestine on more than one occasion," says the "Tablet" writer.

An article published by Francois Coty in "L'Ami Du Peuple", April 20, 1932, and reprinted in English by Col. Sanctuary in New York in 1940, says that the Jewish banking house of Kuhn, Loeb and Co. was behind Mr. de Valera.

"The agent concerned," says Francois Coty "is a Zionist Jew from Lithuania, called Robert Briscoe. Brought up in the ghetto in Dublin . . . he took an early part in the most advanced movements of Irish Nationalism. Familiar with banking he became a sort of treasurer for the Valera party. Soon he was depended upon for procuring the resources of agitation . . .

" . . . the great abundance and regularity of these contributions coincided with the time when the Lithuanian Jew entered into relations with his co-religionists in America and their banks. Thanks to the money of Kuhn, Loeb and Co., an important arrangement for contraband arms and munitions was organised by Briscoe in Germany . . ."

Coty quotes from the Montreal Jewish paper "Canadian Eagle" (October 6, 1931):

"Briscoe is an Irish Jew for whom the Irish government is not Irish enough. But Briscoe is a good Jew. He is a member of one of our orthodox synagogues; occasionally assists at services; and is concerned with the Zionist movement . . ."

### WHO WANTS ALGERIAN OIL?

The revolt of the Algerians against the French is being financed by the internationalists; of this there was no doubt even before big oil strikes were made in this French territory. The importance of the Sahara, and the reason why the internationalists are trying to wrest it from France are clear from the following item

Briscoe, especially during his American trip, has been making clever use of the partition of Ireland.

And now, following upon the appointment of a Zionist Jew as Lord Mayor of Dublin, a wealthy Zionist Jew, James Zellerbach, has been appointed American ambassador at Rome.

The previous U.S. representative at Rome, and virtual U.S. representative at the Vatican, was Clare Booth Luce, a staunch defender of Bernard Baruch. But this new appointment is something far worse. Zellerbach is a member of the United World Federalists and is connected with other left-wing and pro-Communist enterprises such as the Fund for the Republic and Committee for an Effective Congress.

Fifty years have now passed since the Zionist Jew, Theodore Herzl, went to see Pope Pius X about the Zionist plan for Palestine. Herzl says in his "Diaries" that Pius X answered sternly:

"We are unable to favour this movement . . . The ground of Jerusalem, if it were not always sacred, has been sanctified by the life of Jesus Christ." (Quoted in the monthly pamphlet "The Point", published by Saint Benedict Centre, 12 Bow Street, Cambridge, Mass., U.S.A., issue of April, 1957.)

The Jews are now in Palestine and are determined to take over the entire city of Jerusalem as their capital. According to "The Point", the Vatican has charged the Jews with ravaging Church property in the Holy Land at the rate of two million dollars worth a year.

"The Point" says that targets of Jewish attack in Jerusalem "have included the Cenacle, where Our Lord celebrated His Last Supper; the Convent of Mary Reparatrix, which was dynamited during the night while six nuns were known to be still inside".

Another famous shrine, the Church of the Dormition, has, according to "The Point", been turned into a dance hall for the Jewish army.

There may or may not be a conscious design in these events, but there is certainly and undeniably a common element.

in the "U.S. News and World Report" (25/1/57):

"A huge new oil strike in the Sahara Desert south of Algiers is being described by American oilmen as 'bigger than Texas'. Vast oil resources, comparable to those of the Middle East, are beginning to be seen for this desert area in French territory. Access to this oil is becoming a big stake in the Algerian war."

*Murder in the Cathedral*, by T. S. Eliot (13/9). This verse-play, written by one of the two or three most important poets of the 20th Century, was first performed at the Canterbury Festival of 1935.

*The Cocktail Party*, by T. S. Eliot This is probably Eliot's most successful play. It was first produced at the Edinburgh Festival in 1949.

*The Confidential Clerk*, by T. S. Eliot (18/3). Written in the same kind of verse as "The Cocktail Party", this play was produced at the Edinburgh Festival in 1953 with successful results.

*Predilections*, by Marianne Moore (30/9). Marianne Moore is a minor poet but one of the most distinguished minor poets of our time. This book of Miss Moore's essays throws interesting light on modern literature.

*What Is a Classic?*, by T. S. Eliot (9/-) Text of the first Annual Address to the Virgil Society, of which Mr. Eliot was the first President, 1943-44.

*The Use of Poetry and the Use of Criticism*, by T. S. Eliot (18/3). These studies in the relation of Criticism to Poetry in England were delivered at Harvard University during the Winter of 1932-33 when Mr. Eliot was the Charles Eliot Norton Professor of Poetry.

*Collected Poems, 1909-1935*, by T. S. Eliot (20/9). Contains some of the key poetry of our time.

*Four Quartets*, by T. S. Eliot (13/-) Contains some of the poet's most important work, most of it written after the appearance of the "Collected Poems".

# Notes on the News

## PASSING OF TWO BRITISH FIGHTERS

Many readers of the "New Times", especially those who followed world affairs during the thirties, will have been saddened by the passing of two great fighters — the poet-soldier Roy Campbell and the writer-painter Percy Wyndham Lewis. Campbell and Lewis fought together, against the general flabby "trend" towards the Left, and their "popularity" during the thirties suffered accordingly.

## THE MONEY POWER AND ATOM CONTROL

The International Money Power is seeking worldwide control of atomic power. The following points, taken from the U.S. paper "Common Sense" (March 15, 1957), indicate the stranglehold, which the usurers have over atomic power in the United States:

"Who's Who in America", 1951, says that Dr. Alexander Sachs, an employee of the great banking house, Lehman Brothers of New York, "originated the atomic project in conference with President Roosevelt in 1939" and served as the President's representative in organising the Manhattan Atomic Project.

After the war, the U.S. representative on the United Nations Atomic Energy Commission was Bernard Baruch; and the alternate delegate was John Hancock, a partner in the Lehman Brothers' bank.

David Lilienthal, international banker, now consultant with the Lazard international bank, was appointed by Truman as first chairman of the U.S. Atomic Energy Commission.

Later Mr. Gordon Dean was made chairman, and when he stepped down, he became a "consultant" to the Lehman Brothers' bank. Thomas A. Morgan, who played an important part in the Oppenheimer case, was a director of the Lehman Brothers' holding company, known as the Lehman Corporation.

The next chairman of the U.S. Atomic Energy Commission, after Gordon Dean, was Mr. Lewis Strauss, partner in the international banking house of Kuhn, Loeb Co. Another member of the Commission when it was formed in 1946 was W. Waymack, a director of the Federal Reserve bank of Chicago.

Henry L. Stimson, Roosevelt's Secretary of War, claimed in his autobiography "On Active Duty in Peace and War", that the ultimate responsibility for the recommendation to President Truman that the atomic bomb be used against Japan, without warning, rested on himself. Stimson, lawyer for Kuhn, Loeb and Co., law partner of Justice Felix Frankfurter, was assisted on his atomic work by George L. Harrison, Governor of the Federal Reserve Bank of

New York. Another of Stimson's law partners, Bronson Winthrop, was a director of the International Acceptance Bank and the Bank of Manhattan.

The U.S. atomic submarine programme was placed in the hands of Hyman Rickover, formerly a personal aide to Lewis Strauss.

## CATHOLIC COMMENTATOR ON SENATOR MCCARTHY

In a long comment on the death of Senator McCarthy, Mr. D. G. Jackson, in the Catholic "Advocate" of May 9, proves himself quite incompetent to discuss subversion in the United States. Mr. Jackson is a victim of "brain-washing", and repeats filth fed into the propaganda system by Reds and pro-Reds. If Mr. Jackson is not a fool, then what is he up to?

## INFLATION IN U.S.A.

Inflation is the inevitable result of fraudulent financial and economic policies, which rob the individual of real independence. It is true that more efficient production methods tend to slow down the rate of inflation, but increased production by itself cannot stop prices rising. There are still "experts" in Australia who deny this, and who ask Australians to look at America. We have been looking, and we find that in spite of record production figures, inflation is now one of the greatest problems worrying the American people today. This fact has even got a mention at last in the Australian press, as witnessed by the following report from the Melbourne "Herald" of April 26:

Newspapers all over America are expressing anxiety at the continuance of "creeping inflation" in the United States. The cost-of-living figures have risen for the seventh successive month.

Workers who are members of powerful unions automatically have their wages raised, but millions without this protection, are finding they can buy less and less.

The Baltimore Sun points out that even those who have been getting increases are merely holding their own, "like the squirrel in the cage who stays just where he is no matter how fast he runs."

The paper adds that three-quarters of America's workers have suffered a cut in real purchasing power "fully comparable to the impact of a severe and prolonged depression."

It warns against mistaking inflation for prosperity.

The dollar is now worth only 81 percent of the dollar of 1949, itself worth probably only half of the pre-war dollar.

## POETRY AND CRITICISM

*The Literary Essays of Ezra Pound* (51/-). This book includes in its pages the most important literary criticism of our time. Pound does not talk about "literature", or chatter just for the sake of writing essays, but draws attention to specific poems or prose.

*ABC of Reading, by Ezra Pound* (15/-). First published in 1934, this book provides a sound guide to the best in English literature and includes substantial quotations from key poems. Written by a man who believes literature has important work to do such as the protection of the language from corruption, propaganda, etc.

*Translations of Ezra Pound* (51/-). Poems translated include sonnets by the medieval Italian poet, Guido Cavalcanti; the Anglo-Saxon poem, "The Seafarer"; work by the Chinese poet, Li Po; and songs of the Troubadours of Provence. In some cases the poet recreates the original in English verse of a high order; in others he aims merely at giving the reader some idea of excellences of rhyme or sound or feeling, which cannot be brought over into English.

*The Struggle For Europe, by Chester Wilmot* (36/3). Masterful work which shows how the Americans, towards the end of the Second World War, accepted Russian predominance in Europe and Asia. Wilmot claims that this anti-British attitude of the Americans provided Russia with the greatest of her victories.

## *Federal Treasurer's Dismal Report*

*A study of the white paper, "1957 and Beyond", presented to the Federal Parliament by the Federal Treasurer. Sir Arthur Fadden, on May 9, contains not one ray of hope for the harassed taxpayer. As far as the economic "experts" are concerned, high taxation is to continue permanently. It is clear that as far as Sir Arthur Fadden is concerned, he considers all his brave words about tax reductions uttered during the Chifley regime as belonging to the past. He and his colleagues now find that economic "forces" make permanent high taxation "inevitable". Only a person who has been successfully brainwashed can fail to see that high taxation is an instrument of a policy. And that policy is to ensure that the individual is permanently enslaved by the State. It is Socialism in practice.*

*Not only have Sir Arthur Fadden and his colleagues submitted to the doctrines of the economic planners on taxation; they are now also openly turning their backs on their famous promise to "put shillings back into the pound". Although the report read by the Treasurer makes the fatuous claim that "inflationary pressures have for the moment abated"—consumers faced with a progressive increase in prices have not noticed this abatement—it quickly points out that the dragon of inflation has not been killed, but is still awaiting his chance to spring upon his victims once again. It is clear that the Government now accepts the economists' official policy of "controlled inflation". This admission of defeat provides further evidence of the impossibility of any Government reducing either taxation or the price level without first challenging the economic and financial "axioms" which appear to make the economic planners' policies appear inevitable.*

*If people are prepared to accept the view that the true purpose of the production system is not to supply the individual, in order of preference, with the goods and services he requires, but is to enable the country's resources to be "fully developed", they cannot logically complain when the central Government uses the credit and taxation system to force the individual to fit in with its policies. If permitted to spend his own money, the individual would certainly demand, in order of preference from the production system, adequate food, clothing and houses. The production system, operated by a handful of individuals, could easily produce these basic requirements. And it could also provide other genuine requirements with a very small number of producers. But the totalitarian policy of "full employment" and "full development" simply means that the majority of the community is forced to engage in activities, which are a subtle form of economic sabotage. Inflation is one of the inevitable reflections of this sabotage. Those people who desire the life more abundant should apply themselves to understanding why, in spite of physical potentialities, life is one long struggle with no prospect of genuine independence. They will not be helped by the Federal Treasurer's latest dismal report.*

## NEW SECRET PLOT BY INTERNATIONALISTS

The U.S. Federal Reserve Bank, a key weapon in the hands of the international Money Power, was planned at a secret meeting at Jekyll Island, off the coast of Georgia, in 1908. This meeting and how it was presided over by brilliant Jewish banker Paul Warburg is described in great detail in "A Study of the Federal Reserve" by Eustace Mullins.

In February this year, a similar HIGHLY SECRET meeting of 67 bankers, economists, planners, etc., was held at St. Simon Island, also off the coast of Georgia. A. K. Chesterton ("Candour," 3/5/57) says that among those present were two British representatives Lord Kilmuir and Sir David Maxwell Fyfe.

The fighting American columnist Westbrook Pegler (Baltimore "News Post", 10/4/57) says that among those present were Thomas Dewey and Gabriel Hauge. This latter delegate was described by the "Wall Street Journal" as Eisenhower's economic adviser who "helped teach Ike what to think". Pegler has since stated that he believes the meeting was attended by Felix Frankfurter. Correspondents in the United States are compiling a list of delegates to the secret conference, and it is hoped the "New Times" will be able to publish a list of leading delegates later, together with an indication of the specific evil decided on.

### U.S. ADMIRAL WARNS ON "HIDDEN FORCE"

On April 5, the "New Times" published Admiral Crommelin's letter to Senator Knowland on the "Hidden Force" which guides so many U.S. policies. A correspondent in New York has sent us a further letter from the Admiral to Senator Knowland, from which we quote the following extracts:

March 8, 1957.

Dear Senator: For your information, within the past few years very complete and extensive so-called National Guard armories have been constructed with 75 percent federal funds and located at control points on the arterial highways leading to the major communication and population centres of Alabama. Local citizens see the distinct possibility in the event of forced racial integration that these armories may be used to house and provide headquarters for the Federal Police Force included in your Civil Rights Bill. Also informed citizens view with serious misgivings any effort on the part of Federal Forces to absorb the functions of the National Guards of the several states . . . Now, Senator, let us reduce this discussion to its lowest denominator; politics. It would appear that the financially powerful American Jewish Committee and its affiliate, the Anti-Defamation League, coupled with Mrs. Eleanor Roosevelt's so-called Americans for Democratic Action have used the promise of the White House as bait, and directly or indirectly influenced you, wittingly or unwittingly, to sponsor this infamous Civil Rights Bill.

Was the same bait, the promise of the White House, used by the "Hidden Force" to trap the late Honorable James Forrestal into sponsoring unification of the Armed Forces on July 17, 1947? Mr. Forrestal, a patriot, was discovered a pulverized corpse on the roof of the third floor of the Naval Medical Centre, Bethesda, Maryland, on May 22, 1949.

Was the same bait, the promise of the White House, used by the "Hidden Force" to trap Mr. Louis Johnson, another Secretary of Defence, into sponsoring, on April 23, 1949, cancellation of construction of super aircraft carriers, vital cogs in national defence? The United States Navy now has five super-carriers, but "WHERE IS LOUIS JOHNSON"?

Was the same bait, the promise of the White House (Vice-President for 1952) used by the "Hidden Force" to trap Senator Millard Tydings into sponsoring the second unification act of August 2, 1949, which established a supreme chief-of-staff over the Armed Forces? This act was opposed by Ex-President Herbert Hoover, for I heard him voice his opposition. "WHERE IS MILLARD TYDINGS?"

Let us not say in 1960, "WHERE IS WILLIAM F. KNOWLAND?"

For, if William F. Knowland will stand on the floor of the United States Senate and tell the American people the character and extent of the "Hidden Force" or "In-

visible Government" and name names and describe the Zionist Conspiracy and the use of the Anti-Defamation League in the World Communist Offensive and blow the lid off the Communist infested fraud called The United Nations, then he can be assured of the undying gratitude of the one hundred and thirty-seven million White Christian Citizens of the United States.

If William F. Knowland persists in his sponsorship of the infamous Civil Rights Bill, it is my firm belief that the best he can hope for is a position alongside Louis Johnson, Millard Tydings, and oblivion.

It must be said again, "It is not too late". Senator, let us remember the oath you and I took as officers in the military service of our country, "To uphold and defend the Constitution of the United States against all enemies, foreign and domestic".

after Eisenhower's election. Eisenhower was himself a member of the Council at one time.

Three members of the famous Warburg family, Eric, Frederick and James, are members. The Warburgs were associated with the financing of the Communist revolution in Russia. James Warburg openly advocates World Government. John Schiff, grandson of the late Jacob Schiff, who also played a prominent role in the financing of the Russian Revolution, is also active. Dr. Evatt's friend, the notorious Justice Felix Frankfurter, of the American Supreme Court, is listed, as is Mr. R. G. Casey's "good friend", Mr. Dean Acheson, the American Secretary of State, who would not turn his back on the Communist agent, Alger Hiss.

We have not space to list all the members of the Council on Foreign Relations, but a close examination reveals that the overwhelming majority are promoters of world government. They are the driving force behind the campaign for bigger and better American "foreign aid" schemes, all designed to further the world control of the Zionist international financiers. They claim that they are primarily concerned about halting Communism, but do nothing practical about the matter while at the same time they are feverishly pushing on with their programme to drive the British, French, Belgians and the Portuguese from their remaining spheres of influence. They clearly dominate their puppet, Eisenhower, and any suggestion that Eisenhower is taking an anti-Zionist stand has yet to be demonstrated to those interested only in facts and not in wishful thinking.

It is encouraging, however, that Eisenhower and his backers are starting to meet effective resistance from American patriots who are not afraid to call a Jew a Jew, and who realise that there is a close rela-

tionship between Zionist financiers and numerous Marxist revolutionary and subversive movements.

## The Iron Curtain Over America

By Colonel John Beaty.

This book is a "must" for every student of international affairs. It is one of the most important books published since World War II, but, like similar books which have been appearing in America over the past few years, it has received no mention whatever in Australia by leftist book reviewers for the "Capitalist" press.

The author of "The Iron Curtain Over America" is not only an outstanding American scholar; his work with the American Military Intelligence Service during the last war enabled him to learn at first hand of the manner in which the Zionist-Communist conspiracy was being furthered under cover of war.

Colonel Beaty deals objectively with the history of the Jews, with particular reference to the fact that the ancestors of most Jews of today were Khazars, originally a people from Central Asia, and had never seen the Holy Land. He writes most penetratingly on the Jewish invasion of the U.S.A. and the subsequent Jewish impact on America's foreign and internal policies.

After outlining the treacherous, pro-Communist activities of Jews in the U.S.A., Colonel Beaty asks — and answers — the question: "Does the high ratio of appointed persons of Eastern European or contacts in United States strategic positions reflect the will of the U.S. people? If not, what controlling will does it reflect?"

"The Iron Curtain Over America" proves conclusively that not only was the second world war organised, but that it was deliberately prolonged, and only concluded when the controllers of the Zionist-Communist conspiracy had achieved their major objectives. Detailed evidence is provided of the manner in which the truth about this conspiracy has been kept from the American people.

Colonel Beaty's conclusion is that America, and other Western nations, can only survive by first defeating "the enemy within." He points out that this first step is essential before a more realistic foreign policy can be implemented, one which would obtain the friendship of all anti-Communist nations and which would seek to widen the gulf which already exists between the Moscow gangsters and their unhappy victims.

It is not surprising that Zionist organisations in the U.S.A. have been campaigning vigorously against Colonel Beaty's exposure and that pressure has been applied to the press to prevent any reference to the book. Even Church "leaders" have been used to smear Beaty. But his book continues to contribute to the general awakening in the U.S.A., an awakening that Australians unfortunately know little about.

## THE CASE AGAINST FLUORIDATION

### Outstanding New Book Now Available in Australia

**"The American Fluoridation Experiment," by two outstanding American doctors—F. B. Exner, M.D., and G. L. Waldbott, M.D.—is a brilliant and up-to-date account of the efforts by a variety of people with a variety of motives, to put fluoride in drinking water \*.**

Published by the Devin-Adair Company of New York earlier this year, "The American Fluoridation Experiment" is essential reading for anyone who wants a comprehensive scientific attack on fluoridation. In his introduction, Mr. James Rorty says "This is the first time that the United States Public Health Service has ventured to use public water systems as a vehicle for the random treatment of whole populations with a dangerous drug, known to be cumulatively poisonous even when consumed in minute quantities."

Rorty shows that in at least four respects the fluoridation programme is experimental and without precedent:

1. It represents an unprecedented enlargement of the responsibility and authority of the Public Health Service.
2. It subjects the entire urban population to a dangerous drug designed to benefit only a comparative few.
3. The programme provides no real control of dosage, so that the sick, the healthy, the young and the old, all get the same recipe.
4. The results of the treatment cannot be predicted. By its own admission the Public Health Service has conducted no adequate preliminary studies of the effects of artificially fluoridated water on children, and none whatever as to its effects on adults.

Rorty then goes on to point out that "This is the first time that the official sponsors of a public-health measure have censored, intimidated, and regimented the interested health professions. It is the first time that public-health officials have de-

liberately falsified, distorted and suppressed scientific evidence tending to impugn the safety of a public-health measure."

The book gives a summary of the chemical and medical history of fluorine and then follows with a somewhat more detailed study of the various articles and reports which led up to the fantastic proposal that people be "medicated in the mass", with or without their own consent. Rorty outlines the part played by the various groups, the American Dental Association, Public Health Service, etc.

The main part of the book consists of two separate studies by Exner and Waldbott. Step by step, point-by-point, they go through the "arguments" and "facts" in favour of fluoridation. Dr. Exner not only deals with scientific aspects of the matter, he also deals brilliantly with the Welfare State and Police State aspects of fluoridation. His attack upon the so-called "figures" and "percentages" brought forward by fluoridation proponents is devastating.

Dr. Waldbott deals with the sheer unscientific nonsense put forward by fluoridation enthusiasts, and shows that genuine scientific research has been both misrepresented and suppressed. Dr. Waldbott is recognised in America as an expert on allergies. His contributions to medical literature include the first complete fungus survey in the U.S. and the first report of a death from penicillin. He has done an enormous amount of original research on fluoride poisoning from drinking water, and it is this aspect of the matter he points up so clearly in this book.

We recommend "The American Fluoridation Experiment" to all readers interested in this problem. It is a calm survey containing all relevant facts available on this question up to the beginning of this year. All evidence has been sifted and labelled accordingly. In many cases these doctors are able to speak of their own original research, whereas most proponents of fluoridation are merely parroting what others have told them.

## "Protection from Polio"

A most illuminating summary of the causation of Polio and an expose of the failure of orthodox drug methods to solve this problem is contained in a new book under this title by Australia's well-known Health writer, Mira Louise of Adelaide.

We are reminded that during the past 2 or 3 years, while the newspapers have been concentrating upon a build-up for vaccine, not a single paragraph has been published concerning the cause of this much-dreaded complaint. Indeed Organised Medicine, whilst admitting that it did not know the cause, has gone as far as to say that there is no known cure for Poliomyelitis.

In striking contrast to this "don't-know-don't-want-to-know" attitude that typifies orthodoxy in this country, comes the welcome news of the outstanding results obtained by the well-organised chiropractic associations overseas. Men, we are told, who have worked unceasingly without endowment or subsidy for an ideal until their reward came in the remarkable results in such methods as the "Dunn Five-Day Polio Cure" which makes it possible for the worst cases of crippling polio to be completely recovered in a week or less. The same cures are being made in the Mills Chiropractic Clinic in Burlington, Kansas; in the Spears Hospital in Denver and elsewhere.

Dr. Mills has discovered that the cause is generally faulty nutrition, and adds as contributing causes, fatigue, falls, tonsil surgery and D.D.T. sprays while Dr. McClosky of Melbourne Children's Hospital who investigated 375 cases of polio in 1949, disclosed a definite relationship with injections against whooping cough and diphtheria.

A personal friend of Madame Louise's, on a recent tour of U.S.A. writes. "I am having a wonderful time here, investigating the chiropractic five-day polio cure . . . have already been to 3 clinics and seen acute victims restored to complete, normal health, with no paralysis or distortion, in three to five days."

### PLANNERS' CHICKENS HOME TO ROOST?

"What has happened to Kiewa?" asks the Melbourne "Herald" writer, Robert Clark, on May 7. And he goes on to point out that in 1947 the Victorian State Electricity Commission predicted that by 1956 the Kiewa power scheme would be adding 289 megawatts to the State's power resources. Whereas, in fact, today, in 1957, it is producing only 88 megawatts, less than one-third predicted by the S.E.C. As for costs, Clarke says that in 1947, when the S.E.C. was so confident about the capacity of its brainchild, the estimated cost of the entire scheme was £25,270,000. However, up to the present it has swallowed £30 million. Clarke claims that the Kiewa project is now low on the S.E.C.'s main works priorities, and that its No. 2 power station (originally planned as the scheme's crowning glory) has been pigeonholed "for future consideration".

### POISONING THE FRENCH

There is still no sign in the French press of any awareness of the monetary factor in our problems. However, on the question of poisoning the eating public, the paper "RIVAROL" for the 21st of February 1957, showed certain alertness. A correspondent, Marcel Justinien noted that the desire to save time in baking has polluted French bread. Yeast was nourishing, but it took time, the workmen bakers had to wait for natural process. Naturally this waiting riled the followers of the late Blum, and of Pinaud, Mendes-France & Co., so chemical expanders and exploders have taken the sanity out of French bakeries.

A mild fight is being waged at present by the "Association française pour la recherche de l'alimentation normale" which seeks a return to that bread and other food, delicious and nourishing, for which France in years gone by was famous.

## NEW YORK REPORT

A friend who has just been through rural Pennsylvania reports that it is still possible for people to preserve sane ways, despite the propaganda fog and the destructive tendencies of Big Government. He says German peasants there have preserved the sanities of co-operation (as in barn-raising) without giving up the sanity of private ownership and responsibility. Perhaps intelligent city folk and reasonable countrymen, such as these peasants, might find common ground in a party, which used "Wheat in Bread" as its main slogan. In fact, I venture to suggest that in the U.S. at the present time, "Wheat in Bread" is probably the only party slogan capable of uniting both lowbrow and high.
