## World Plotters Intensify Pressure On British Government

The "Grand Design" for a United Europe is the bombastic title of the latest brain-wave emanating from the British Foreign Office, attributed to the Foreign Secretary, Mr. Selwyn Lloyd; its alleged purpose to tie up in one bunch all the various organisations in Europe working for European Unity. These are, chiefly, N.A.T.O., Western European Union, the Council of Europe, the proposed Common Market, the Coal and Steel Community, Euratom, and, of course, the coordinating body, O.E.E.C.

Each of these has at present its separate constitution and assembly; the "Grand Design" is to unite them all under one roof, as it were. The combined organisations will then be divided into sections—military, political, social, cultural and so forth — all to be governed by a supra-national body that will supersede national governments.

In an interview on the B.B.C. Sir David Ormsby Gore, President of the Board of Trade, obligingly explained its meaning as he had recently expounded it at Strasbourg. From his somewhat vague statements it would seem that the Plan is not yet set in its final mould, as it may be going a bit too far for the other European nations, since it is proposed to invite Canada and the United States to "come in and join us".

"America", as we know, has had her finger in the European Integration pie all the time; has indeed been urging it on (as she herself has doubtless been pressed by the unseen forces); but, as anyone can see, the inclusion of Canada and America would make nonsense of a "United Europe". What, then, is the little game of the internationalists?

Perhaps the most debated component part of the "Grand Design" is the Common Market. Divergent opinions regarding this Treaty — which is now published in detail — are appearing in the newspapers.

### ROCKS AHEAD:

According to a report from Geneva — the annual report of the Economic Commission for Europe, issued on April 15th — all is not beer and skittles in the working out of the Plan. "If a free trade area includes all the present members of the Organisation for Economic Co-operation", says the report, "about 40 percent of world trade will take place within preferential arrangements (including the existing ones), while about 25 percent will suffer from the arrangements. Countries outside Europe might then draw together in preferential areas of their own. . . . If this tendency developed, and if the various trading blocs became highly protectionist, the potential benefits of the Western European arrangements might be significantly reduced."

So there we come back again full circle to the old trade war!

Various commercial and trade bodies also have their doubts about the plan—chambers of commerce, of manufacturers, the Federation of British Industries, the woollen and textile trades, some of the trade unions and, particularly, the small manufacturers. The Commercial Editor of "The Glasgow Herald" says, "the scheme proves to be of unbelievable complexity".

Writing in the same newspaper, an advocate of European Unity blithely admits, "Of course, there may be the strangulation of the lesser, 'non-economic' industries . . . and the direction of labour to wherever it may be required in Europe."

How refreshing it was to read then from Canberra the unequivocal pronouncement of Sir Latham Withall, Federal Director of the Associated Chamber of Manufacturers in Australia, that the European free trade plan was fraught with menace to Britain, Australia and New Zealand; that "It will destroy progressively and quickly the chief economic, financial and trade ties existing between the British Dominions and the Mother Country. Britain and her Crown Colonies will be fiscally divorced from the rest of the Commonwealth nations."

### OUR POLICY

1. The support of all policies rooted in the Christian philosophy of freedom and based upon the Moral Law.

# MAGNA CARTA AND THE SUPREME LAW

It will clarify the vital issue which confronts us today if we consider it in its proper perspective and remind ourselves of the circumstances which lead up to Magna Carta, which is of such great importance not because it marked a victory of one power bloc against another, but because it established a principle of OBJECTIVE RIGHT in English politics. The pursuit of this principle by honest men through all the clashes for power can be traced through the centuries as decisively moulding our laws until recent times.

It has been written of the Great Charter, "Those positive laws and institutions of later times, which secure our rights and liberties, all have their root in this charter." Yet the singular characteristic of the Charter is that its clauses are negative. They inhibit the Chief Executive in the nation, at that time the King, from doing something. It recognises that each individual has inviolable natural rights both in the liberty of his person and in the possession of property.

The chief cause of the Charter was a king who misused the power of his position to impose flagitious taxation, and used arbitrary power to achieve his ends in other ways. But it is essential to note that even had that arbitrary power been covered by laws imposed on the nation by the Executive, although the acts would have been "legalised", they would still have been lawless by the great conception which formed a background to political thinking and political action in England for centuries. This was a conception that there is in fact a kingdom of God to which we mortals are subject while on earth, that even if we ignore it we are subject to it and by breaking its laws suffer the penalties. Call it Truth, call it objective Reality or call it natural law, it is there.

It was this conception that the Church in England, headed by Stephen Langton, Archbishop of Canterbury, at that time stood for. The army, which the barons gathered and with which they marched against John, was called "the army of God and the Church". The army was composed of virtually the whole nobility of England with their retainers. In 1213 they had held a great council at St. Albans and formulated their complaints. On August 25 of the same year the Archbishop, Stephen Langton, had called a second council of the barons and read to them the provisions of the charter granted by Henry I on his accession, and followed it by delivering an address advocating the principles of liberty and justice. It was because, guided by the Archbishop, the barons based their cause on the principles of liberty and justice,

that both the Church and the freemen of the cities aligned themselves with it. So that when after repeated attempts to bring the king to reason he at last had to bow the knee, it was not only the barons who met him on June 15th, 1215 at Runnymede. They were attended by representatives of the Church, headed by Stephen Langton, and a "vast multitude", representing all classes of the population. The King was attended only by the Grand Master of the Templars and twenty-three others.

The event at Runnymede was only temporarily decisive, because John soon after broke all his promises. But, nevertheless, the Charter itself became the basis for political action in the cause of liberty and justice down through the centuries, being confirmed more than thirty times by English kings. In 1689 its principles were embodied in the Bill of Rights.

There is a circumstance underlying the events leading up to Runnymede and the ability with which John afterwards, despite having virtually the whole nation opposed to him, was able to recruit and land mercenary troops from the Continent with which he ravaged the land, that is only briefly referred to in history, but which is of the greatest consequence. That circumstance is the existence of a secret society under the mask of Templarism, with a sinister purpose. There is no other explanation of how a monarch of feeble and pusillanimous character could so long have carried out tyrannous acts against the whole community. It was in the stronghold of the Templars that John took refuge from the barons, and it was in the Templar Church in Dover that he committed the disgraceful act of handing to Pandulph, the Papal Legate, the document surrendering to Pope Innocent and his successors, the kingdom of England "for ever". It should be remembered in this connection that the election of John's nominee as Archbishop of Canterbury was ruled out by Pope Innocent as unconstitutional, and he had instructed the Canterbury monks present in Rome at the time to elect someone, and they chose Stephen Langton.

Whether or not Pandulph, the Papal Legate, was a Templar, it should be noted that Archbishop Langton insisted that in taking the stand that he did against John, whom Pandulph supported, he was carrying out the Pope's real wishes.

This question of the Executive in the State endeavouring to have the determining voice in choosing who should fill high appointments in the Church is one encountered again and again in English history. So far as Magna Carta was concerned the outcome was vital. And it should be noted that it was not until a century later, when Edward I banished the Order of the Templars from England, that we find the beginning of those permanent laws which have come down to us as Common Law.

Today we have the sinister purpose for which the Order of the Templars was a vehicle of disguise housed in other secret societies, the true aim of which is suspected by only a few and properly appreciated by still less. In key positions of Church and State the influence is decisive and disastrous. It is a big subject that cannot be developed here, but as it is a key factor in the subject matter of this article it has been necessary to refer to it. Anyone who has taken the trouble to study what the Popes of this century have had to say publicly on Christianity in relation to the policies of governments and noticed how the Catholic Press fails not only to project this but actually advocates exactly opposite policies and philosophical viewpoints, can hardly fail to recognise that it is not wholly accounted for by the influence of money through advertising. The newspapers of the other Churches, including those of the Church of England, are no better. But in their case the proprietors and editors could plead that the policies, which they espouse, do not in principle differ from those supported by state appointed bishops and other leaders.

In the midst of the great crises and terrible catastrophes of this century the clergy, with very few exceptions, have stubbornly maintained that the great need is "a change of heart", and that if this came about our troubles, financial, economic and otherwise would dissolve. They have refused to acknowledge that bad systems corrupt men and put men to the top; that the system needed changing. The title of Mr. Cameron Hawley's address to the Pennsylvania Bar Association, which was so widely acclaimed, was "Our Tax Laws Make Us Dishonest". The evidence proves that the clergy have been wrong. And that is so further corroborated by a series of striking articles which have appeared in the "Sunday Times" in which the leading Hungarian Intellectual leader, Paloczi-Horvath, portrays some of the

well-known Communist leaders. So terrible are the facts exposed that it was found desirable to publish an epilogue to the sixth article, which says: "These profiles of some of the scum of humanity should not make anyone despair of mankind . . . it was an evil system which turned their monstrous potentialities into horrible reality. Society can cope with men of criminal tendencies if it remains faithful to common sense and common decency."

Precisely, but men and women of common sense and common decency have not, a small minority excepted, espoused the cause of sense and decency as did the champions of Magna Carta and the Bill of Rights.

Will they do so before it is too late?

## THE ISRAEL MYTH

The myth about Israel as "bastion of democracy in the Middle East" has been severely punctured by the anti-Zionist Jew Alfred Lilienthal in a recent article in the "American Mercury". Here are some of his facts on Israel's finances:

"While Europe was receiving in 1952 \$7.22 per capita in U.S. governmental aid, South East Asia 59 cents and the Orient 16 cents, Israel was receiving \$48 per capita. When Secretary Dulles temporarily suspended American aid in 1953 because Israel was defying the decree of the United Nations relative to the hydroelectric dam on the Jordan River, Israel's governmental machinery virtually came to a halt and an emergency was declared until domestic U.S. political pressures helped restore the funds. Twenty percent, of Israel's 1954 imports were financed by U.S. Government grants.

"Private contributions to the United Jewish Appeal and the sale of Israeli bonds has swelled the total flow of private and governmental dollars to Zionists in Palestine since 1920 to well over ten billion dollars. According to an editorial in the Jerusalem Post of February 7, 1956, over 70 percent of Israeli imports (almost a quarter of the national consumption) are paid for by exactions from Germany and by other unrequited income with no requirement for repayment. The Israeli newspaper noted significantly that the gap in the trade balance had increased in the previous year and that over a quarter of the German exactions had been already spent."

"Intelligence Survey" for May (4/- a copy posted) contains a full report on Lilienthal's article, including information on Israel's close relationship with the Soviet.

The same issue of the "Survey" includes a further report on the Norman case; information on Red penetration of the White House during Roosevelt's reign; and facts about new evidence discovered in Washington on the Communist spy Harry Dexter White.

## THE NAMELESS WAR

*The Nameless War*, by Captain A. H. M. Ramsay (8/- post free). Captain Ramsay, who died last year, was the British patriot and Member of Parliament who almost succeeded in getting to Mr. Neville Chamberlain information which might very well have changed the course of history. Captain Ramsay enjoyed the confidence of Mr. Chamberlain during the critical months between Munich and September 1939. They discussed the trans-Atlantic power group, which was trying to force England to get the Second World War started. Captain Ramsay was to have provided Mr. Chamberlain with certain information — but the War Party intervened. Before he could get to Mr. Chamberlain with this information, Captain Ramsay was thrown into prison, without trial, and was kept there until September 1944. After his release he was still bound not to reveal certain facts regarding documents, which passed between President Roosevelt and Mr. Churchill, BEFORE Mr. Churchill became Prime Minister.

"The Nameless War" contains a great number of important quotations, many of which are not easily accessible elsewhere. One of the main virtues of this book is that one can disagree with some of Captain Ramsay's forthright opinions, but at the same time thank him heartily for an abundance of factual material of first-rate importance.

## Canadian Elections

### Upset Internationalists

*As yet we are not able to report comprehensively upon the recent Canadian election results. But judging by the comment in the world's press, particularly those sections that blatantly support internationalism, the victory of the Progressive Conservatives and the defeat of the Liberals, who had governed for 22 years, was regarded as a major disaster for the internationalists. Writing before the election, one Canadian patriot whose opinions we value, said that the defeat of the Liberals would be an excellent thing for one reason alone: such a defeat would end the career of Mr. Pearson, Canada's dangerous Minister for External Affairs. It is significant that since the Canadian elections all the internationalists have been stressing the great loss of Mr. Pearson in the field of international diplomacy. But no doubt Mr. Pearson will be rewarded.*

*It may prove that the Canadian Progressive Conservatives, like the Australian Liberals, will not be successful in implementing their promises to reduce taxation — unless continuous electoral pressure is maintained against individual Members — but the election results do give some indication of what the electors want. They also certainly indicate that a big section of the Canadian people are vitally concerned about American economic penetration. We gather from the statements of Progressive Conservative speakers that they favour stronger Empire links and less reliance upon Washington. The Liberals also lost many votes because of their handling of the Norman case. Mr. Pearson was forced to admit eventually under cross-examination in the Canadian Parliament that there were very good reasons to suspect Norman of being strongly pro-Communist.*

*Readers of this journal will, of course, be most interested in the vote for candidates terming themselves Social Crediters. While we have no details, we can report that the vote for the Social Credit Party candidates was only increased sufficiently to elect a total of nineteen members. This was a slight increase in strength compared with the previous elections. However, the importance of Mr. Low and his associates has been dramatically magnified by the fact that the Progressive Conservatives have not a clear majority in the new Parliament, and may have to rely to some extent upon the Social Crediters and some of the Independents. For our own part we wish we had more confidence in the ability of Mr. Solon Low to make the best of the situation. Mr. Low's handling of the election campaign, with his compromise on principles in an attempt to get votes, and his foolish public attack upon the powerful French-Canadian Social Credit Movement, provided distressing evidence of the deadly effect of party politics — even upon Social Crediters. However, Canadian Social Crediters are now a decisive factor in the Canadian political scene and we can anticipate a major effort by the internationalists to try and further that perversion in the Canadian Social Credit Movement, which has unfortunately been evident for some time. How Canadian Social Crediters handle the situation may play a decisive role in world history.*

### THE DIE IS CAST

On the 25th March the six nations of the Customs Union — France, Germany, Italy, Holland, Belgium and Luxembourg — nucleus of the Free Trade Area, signed draft treaties to establish a Common Market of 160,000,000 people, its stated basic aims being "to allow free movement of goods, manpower and money and abolish customs tariffs among the six nations." These are only the basic aims, but any or all of them could wreck the economic stability of any member nation.

Take, for example, the "free movement of money", which presumably means the open door to foreign investment, — the happy-hunting-ground for speculators and money-grubbers from abroad. Already, even before the treaties are ratified, United States firms are preparing to invade this Country industrially. It is reported, 17/4/57, that U.S. firms are seeking factory sites in Scotland to establish branches; — "manufacturing units" in engineering and metal-using industries, electronics, precision engineering and some of the heavier forms of mechanical engineering.

To quote a "special correspondent", "American interest in the proposed European Common Market promises to give industrial development in Scotland the greatest boost it has had for years." In other words, America (and Canada) mean to cash in on the European Free Trade Area quick and lively by wholesale investment in this Country.

Believe it or not, the Chairman of the Scottish Council (Development and Industry), Lord Polwarth, welcomes the move, saying, "It will provide a wider range of employment (full employment again!) and will allow the American firms to take full advantage of the opportunity which the 'free trade' plan would present." (He had by then—17th April—within ten days met representatives of five American companies).

Further, the Scottish Council condones this industrial invasion since "American and Canadian interest arose automatically from the large size of the prospective market; a free trade Europe would be an area of the size to which their present operations were attuned." Who would doubt it?

### "BRITONS NEVER, NEVER SHALL

And so, Britain will become a handy springboard for U.S. large-scale trading operations! Their branch factories will turn this fair land into one huge labour camp, the workers toiling, not to supply the needs of their homeland, but as a "labour force" for the aggrandisement of American big business.

No pretence here that the motive of the investors is other than self-interest; no humbug about the supposed benefits of foreign investment to this poor, benighted Country; nor any doubt in the minds of the welcoming party as to whether foreign investors, while providing employment, may not at the same time be parasitic, all the while acquiring the assets and draining the resources of the country they exploit. Since no one thinks of economics except in terms of money gain, everything must be all right.

It is natural, yet deplorable, that each section of the community sees only its own narrow point of view;—the manufacturers, the traders, the politicians, the One-Worlders. None so far seems to have realised the overwhelming threat to the British Commonwealth and Empire. Not one voice has been raised in press or public against this attempted piecemeal demolition of our traditional inheritance, this surreptitious purloining of our native rights.

To most people a United, Integrated Europe means nothing—as yet. If they do read of it, is it not given out that it will be a "democratic assembly of European nations? So that's all right, isn't it?

To that large body of deluded M.P.'s who pin their political faith to a chimera called World Government, a United Europe is a seven-league-boots leap towards their goal; to our Foreign Secretary it is a dream palace on which he delightedly lays the cope-stone—his "Grand Design" for a centralised, collectivised Europe—and to hang with the British Crown, the British Navy and all such impediments!

Is it not ironical that our Conservative leaders who, if Conservative means anything, ought to be the guardians and custodians of our British institutions, are actually out-doing the internationalists in tossing away, like irresponsible children, precious things men have fought and died for? We may well ask, what ails them? Is it poverty of intellect that they know no better? Is it a wanton urge to destroy what they can never replace?

Or, most fearful thought of all, are they under some dread compulsion to act in this way? Are they, in short, in the hands of a malign power, subtle as the serpent that has declared our destruction with that of Christendom, and is using them as agents to encompass our ruin?

He attended many high level international conferences. Suddenly, in 1940, he was thrown into Brixton prison without trial because he had dared to speak out against the Jewish-Masonic conspiracy. This is Sir Barry's story.

## MORE NEWS ON FLUORIDATION

The following report on the fluoridation fight in New York is taken from the May issue of "Housewives Today" and shows how conscientious patriots can, by constant effort, interfere with well financed Welfare and Police State proposals:

The New York City hearing on fluoridation took place in the City Hall, March 6th, before the Mayor and members of the Board of Estimates. It started at 10 a.m. and lasted until 2 a.m. the next morning. Several hundred people signed up to speak, but many left without speaking due to the lateness of the hour.

Even before the opposition side was heard, several members of the Board of Estimates showed clearly by their questioning of the proponents (who spoke first) that they had serious doubts and fears concerning fluoridation. After the hearing, all New York City papers agreed that there was very little chance of fluoridation being accepted by this Board. They all advised caution. It is the opinion now that no decision will be made until next year—and even then the outlook is extremely doubtful for fluoridation.

Commissioner Ford of the Water Department was one of the highlights of the hearing. He opened the talks by the opposers and after his very fine speech one of the members of the Board of Estimates complimented him and said that his talk made a lot more sense than some of the previous talks — which were all pro talks. Commissioner Ford told the Mayor and the Board that it would be absolutely impossible to have an even dosage in all pipes of the huge water system of New York City. His honesty and sincerity impressed everyone.

The New York "Herald Tribune", on March 7, carried the following story:

Dr. Jonathan Forman national chairman of the Medical Dental Ad Hoc Committee on Evaluation of Fluoridation: (Speaking for a group of 300 doctors and others). 'We are opposed to fluoridation in public water supplies because: no positive proofs of the safety of fluoridation

have been offered; the suggested concentration of fluoride in drinking water is in the toxic (poisonous) range: fluoridation is compulsory medication without precedent; the function of a public water supply system is to provide pure, safe water for everybody, not to serve as a vehicle for drugs; the role and efficiency of fluoride in dental caries reduction is a matter of active controversy; there are more efficient and less hazardous ways of obtaining such benefits . . .'

"Dr. F. B. Exner, Seattle physician and medical writer: When the public-healthers are given power to make us take whatever drugs they wish when our desire not to take the drug is harming no one but ourselves, our situation will be no different than in Hitler's Germany or in Russia today—and the American way of life will be all over but the shouting . . ."

On March 8, the New York "Daily News" reported:

"Fluoridation of New York's drinking water appeared doomed yesterday on the basis of comments by the eight Board of Estimate members who sat through a heated 14 hour public hearing on the proposal. The hearing ended at 2 a.m. yesterday.

"A majority of the board expressed serious doubts and one, Queens Borough President James A. Lundy, said, 'I am ready to vote now — and vote no. The hearing strengthened my original conviction.'"

"Only Mayor Wagner and Bronx Borough President James Lyons took a cautious tack, saying they wanted more time for study. Consensus around City Hall was that the proposal will be knifed without being submitted to a referendum, but that nothing will happen until after the fall election."

### FALSIFICATION OF STATISTICS

The following report from the June issue of the "American Mercury" shows how some of the proponents of fluoridation are falsifying disease statistics:

"Grand Rapids, Michigan, was the first city fluoridated — in 1945. In the first four years, deaths from Cancer increased 40 percent, while the population increased less than 8 percent. At the same time, deaths from kidney disease increased 50 percent, and heart disease, 100 percent. However, these increases were also caused by cancer. As the Bureau of Vital Statistics happens to be a part of the United States Public Health Service, which is also in charge of the nation's Vital Statistics, and it is concealing cancer deaths in Grand Rapids by placing them in these other classifications. Right here in these Committee hearings, the U.S. Public Health Service doctors, Dr. Nicholas Leone, Dr. Isadore Zipkin, and Dr. Knutson, admitted that a number of cancer deaths have been classified as intracranial lesions instead of being shown as cancer. It seems that they have now switched to an anatomical classification in which cancer of the stomach, for instance, is grouped with other stomach diseases and not shown as cancer at all. Exactly what they are placing in the cancer classification, no one knows. As long as the U.S. Public Health Service, with its Russian-born doctors, is in control of our nation's vital statistics records and is 'falsifying' them, we will never be able to find out the exact number of persons killed by fluoridation."

## Will They Ever Learn?

## Struggle Over Yalta Papers

Patriots in the United States are still fighting to force the State Department to publish the full story of the Yalta betrayal.

One of the leading figures in the fight is Mr. Bryton Barren who was forced to retire from the State Department because he insisted upon publication of all Yalta papers. Baron says these papers include several loose files of notes by Alger Hiss, the Communist spy who played a major role at Yalta as Roosevelt's right-hand man.

A hearing on this question was held in Washington recently by the House Appropriations Sub-committee on the State Department. A departmental memorandum, made public at this hearing and dated March 3, 1950, said that material, which should be kept from the published Yalta papers, included "remarks by Roosevelt concerning the Jews in the United States, Churchill's unflattering remarks concerning certain personalities and derogatory remarks by Roosevelt and Stalin concerning certain foreign politics and politicians."
