COMMUNISM AND THE CONTROL OF CREDIT

The Melbourne "Herald" of November 18 published on its financial page the following report from New York: "Business analysts were in wide agreement that increased defence spending to meet the Soviet missile challenge and last week's lowering of the bank discount rate meant that the present mild slump in the U.S. economy would probably last less than a year."

The report went on to say that before the Russians had launched their earth satellites, there had been widespread demands for cuts in Government spending and a substantial reduction in taxation. But now it was anticipated that at least another 1,000 million dollars (about £446 million) would be spent on defence this year. There would also be a "freeing of money for industrial and other expansion".

The significance of the above report should be pondered on by those concerned with the present plight of the world and the threatened collapse of what remains of Western Civilization. If Western economic and financial policies are governed by the actions of the Communists, then it is clear that World Communism is inevitable. But the truth is, of course, that the real policy makers in the West, as distinct from their public relations officers, the politicians, are exploiting the Communist menace to frighten the Western world into accepting the same totalitarian policies being imposed upon the victims of Communism.

There is no real reason why the controllers of monetary policy in the U.S.A., the financiers who run the Federal Reserve Banks, should not have expanded the volume of money in the U.S.A. before the launching of an earth satellite by the Communists.

But those who determine the rate at which financial credit shall be created also determine the purposes for which it shall be used. Control of financial credit means control of real credit, which is productive capacity. Under Communism those calling themselves the State determine how real credit shall be used. One report, which may not be very accurate, states that the Communists spent £500 million to launch their first earth satellite. If the Russian people had been able to decide freely on how to use the

productive capacity necessary to launch an earth satellite, they would undoubtedly have preferred that it be applied to producing more consumer goods. But they have no freedom of choice concerning the use of their own credit.

Genuine defence against Communism is impossible without some understanding of the real nature of the Communist menace. To compete with the Communists in imposing a policy of Sputniks before individual freedom and independence, is in reality a major surrender to the Communist philosophy. And this is what the Western policy makers now blatantly propose. President Eisenhower has followed Prime Minister Macmillan's call for greater sacrifices, the further surrendering of national sovereignties and the centralisation of power. Financial credit will be made available to ensure that the programme goes forward. The individual in the West will, unless there is a breakdown in the programme, progressively find that unless he serves the programme he will be unable to get access to a monetary income. And inflation and taxation will ensure that even the income he does obtain will not enable him to build up any financial reserves and thus the basis of any independence.

This programme of enslavement can be defeated only by exposing and opposing the international groups who are promoting it while ensuring that no action is taken to destroy the Communist menace by (1) pursuing a foreign policy designed to encourage and help the victims of Communism, the greatest allies the West has, and by (2) implementing domestic financial and economic policies which would remove the cause of class-warfare such as inflation.

Second Thoughts on Bank "Reform": In our first reference to the Federal Government's proposed banking legislation, we contented ourselves with a brief reference to the fact that there was no indication that the Monopoly of Credit was to be weakened. Further examination of the Bills confirms the view of some observers that Dr. Coombs and his fellow-planners have cleverly brought forward "reforms" which will enable them to maintain and extend control of the economy.

The most important aspect of the Government's amending legislation is that which proposes the creation of a Development Bank. This Bank will take over the present Mortgage Bank and the Industrial Finance Department of the Commonwealth Bank. Clause 72 of the Commonwealth Banks Bill reads:

"In determining whether or not finance shall be provided for a person, the Development Bank shall have regard primarily to the prospects of the operation of that person becoming, or continuing to be, successful and shall not necessarily have regard to the value of the security available in respect of that finance."

Here is the perfect instrument for furthering the Socialisation of industry. We have recently drawn attention to the Fabian Socialists' new technique of obtaining control of industry without direct nationalisation schemes, which arouse public opposition. This technique is for the Government to acquire shares in selected industries. In this way the Government could control these industries either through their Boards or through their overdrafts.

The powers of the Development Bank will be such that it will be able to create and lend credit like any other bank while at the same time enjoy all the immunities of a Central Bank. It is not surprising that the private banks are reported to be now concerned about the long-term implications of legislation, which they thought was destined to protect them against nationalisation.

Financial Policies Undermine Constitution:

The undermining of the Federal Constitution has proceeded at a faster rate under the Menzies-Fadden Governments than under any previous Governments of the past. In a recent demand for a new financial deal between the States and the Commonwealth, Sir Wilfrid Kent Hughes drew attention to the fact that instrumentalities created under State laws and under State constitutional jurisdiction are becoming progressively more dependent financially on the Commonwealth for their existence.

At one time education, health, social welfare and power supply were the sole concern of the States. But centralised control of financial policies, including taxation, has enabled the Commonwealth to invade the States and progressively undermine their powers and responsibilities. The Commonwealth is, of course, using its financial powers to impose its own conditions upon all those instrumentalities to which it is providing finance.

The complete destruction of the Federal system is only a matter of time if present developments continue. Numbers of back-bench Government Members at Canberra are disturbed about what is happening and would undoubtedly give Mr. Bolte, Victorian Premier, strong support if he should make another effort to review his financial relations with Canberra.

Soviet Russia's Link with Israel: Although the Communist leaders are outwardly displaying hostility towards Israel — primarily to try and give reality to their claim that they are championing Arab nationalism — they are maintaining some contact. There has been little publicity of the Soviet policy of allowing a steady stream of Jews to leave Poland and Russia in order to go to Israel. A report in the Melbourne Herald of November 15 states "This wave from Eastern Europe is expected to result in more than 100,000 Jews reaching Israel this year for the first time since 1951. Last year, the overall emigration figure was 55,000, in 1955 it was 36.000, and in 1953 only 10,000."

Communism And "Independence" In Malaya:

We confidently anticipated that once the British had retreated from Malaya, the Communists would change their tactics in order to exploit the situation. The Communist leader, Chin Peng, has contacted Tumku Abdul Rahman, Malaya's Prime Minister, stating that the Communist terrorists now desire to surrender. The Communists are well aware of what will happen as the result of the British withdrawal. And yet there were some who said that the British withdrawal from Malaya was a major "defeat" for the Communists.

High Taxation Fosters Economic Centralism:

Mr. John A. Bushnell, an American Fulbright scholar, in a recent paper on "Australian Company Mergers 1946 to 1956" claims that the major cause of company mergers in Australia is taxation. Mr. Bushnell makes the following points:

* A higher level of progressive personal income tax is a strong incentive to switch from taxable income to tax-free gains. A merger often makes this possible. Personal income tax has influenced nearly 50 per cent of company mergers since 1946.

- * In some circumstances selling to another company is the best way of escaping undistributed profits tax on private companies. This tax has strengthened the bargaining position of a public company trying to take over a private company.
- * Estate and death duties are often important causes of mergers in Australia.
- * Accumulated taxation losses provide an incentive for one company to take over another, as the loss is an asset that can be deducted from taxable income. Also, a buyer of an unsuccessful company may get other assets. When the Myer Emporium acquired W. E. Bird Ltd., this bought for Myer's valuable import licences as well as a large loss.

It is clear from Mr. Bushnell's survey that the progressive development of economic centralism and monopoly must inevitably continue while a high taxation policy is continued. This is one of the major reasons why Socialists support high taxation policies.

World Health Official Advocates Fluoridation:

Dr. Carl S. Sebelius, Dental Health Officer for the World Health Organisation, arrived in Australia last week. Although "officially" in Australia to pave the way for a seminar on dental health to be held in Adelaide in February, 1959, Dr. Sebelius also did "a little private plugging" for one of his "pet schemes" —water fluoridation. He brought with him twelve copies of the report of an "expert" committee called in Geneva last August. This report said "the effectiveness, safety and practicability of fluoridation as means of preventing decay was now established".

Dr. Sebelius mentioned the number of Americans drinking fluoridated water but made no reference to the number of communities, which had abandoned fluoridation schemes. We know nothing at the moment about this Jewish gentleman's background. But it is certain that he and the organisation he helps control support collectivist policies. Australian taxpayers help subsidise the attack on their own freedom.

Inflation And "Savings": The following gem of commonsense appears in the October issue of *Housewives Today*, a monthly journal supporting the policy of The British Housewives' League:

"Everyone is talking about the problem of inflation, and politicians tell us there is no simple cure. Meanwhile, as prices continue to rise, most people suffer from the consequences, especially old age pensioners.

"First we must liquidate the nonsense published in the general press. These articles create confusion of mind in their readers. They confuse symbols with the things those symbols are supposed to represent.

"Any woman who has kept a fruit and vegetable garden or managed a pantry knows full well that it is impossible to save perishable goods for any length of time. Strawberries will only last a few hours when

once they are ripe. But strawberries can be made to last many months if made into jam or bottled. Potatoes and other crops gathered in the autumn can be stored through the winter months till fresh supplies are available in the following year. The period of storage is limited.

"We all know that a young man or woman setting out in life cannot save up a store of food which they can eat when they have retired. Yet the experts tell us that one of the cures for inflation is more savings. They want us to take the small amount of cash which we now have and pay it into a post office account, buy Savings Certificates, Premium Bonds, insure our lives, etc., etc. In return we are given bits of paper on which are ink marks or symbols.

"The store of food in the pantry is something quite different from the symbols on those bits of paper.

"What does our store of money in the bank represent when the perishable goods produced today cannot be stored for long periods.

"In years to come we may all have bank books with figures therein which at present prices would make us appear to be very wealthy people. But however big those figures are, we shall eat no strawberries if at the time we want to spend the money there are no people willing to grow them. There will be no strawberries if the plants are all diseased, the land has lost its fertility, and the farmer forgotten the 'know-how'. The jam we make today will not feed us in ten or twenty years time.

"Does your member of Parliament understand this difference? What guarantee can he give that the money we save today will buy at least the same quantity of goods at present-day prices in ten years time: in our old age. If he cannot give us this guarantee, is he honest in asking us to save our money? We should ask him.

"If prices continue to rise, in what plight shall we be? Is everyone in their old age to be dependent either on the charity of the younger generation, or on their own labour?

"The church leaders who are so concerned about the condition of the poor — what have they to say about the National Savings Movement?

"Some years ago the British Housewives' League said that there should be no request for National Savings from the Government unless they could give a guaranteed value replacement.

"Things are no better today."

ZIONIST BLUEPRINT FOR WORLD DOMINATION FOUND IN THE U.S.A.

BOOK REVIEW

Major Robert Williams, American news analyst, lecturer and former Counter Intelligence Officer, has made a vital contribution to an understanding of the forces of subversion during the post-war years. All his work is carefully documented. Major Williams has recently published what he considers to be his most important work.

Most of this book consists of quotations from a Jewish publication entitled *The Jewish Utopia*. Major Williams writes as follows concerning this publication: "Some time ago I discovered in the library of the University of Texas, an unlisted book called *The Jewish Utopia*, tucked away in a Jewish collection. This book, written in English but quite obviously not for general circulation, is the complete plan of the Zionists for world domination. There is no possibility of mistaking this fact.

"It was given to the Jewish collection of the University library by the Kalla of Texas Rabbis - showing the high regard in which those rabbis hold the book. The author, whose other books are all in Hebrew, does not create this book and this dream of conquest; he only interprets and summarises and brings down to date, the designs and objectives expressed by the leading rabbis, teachers and militant tribal leaders of the Talmudic Jews over a very long period.

"Published in 1932 (in Baltimore, Md.), this small book brings the plan for conquest up to date and looks ahead hundreds, perhaps thousands of years, revealing the ultimate order — the new world order — as the Jewish political strategists hope to bring it about. It goes far beyond Communism and the goal of the Communists, showing them to be suckers. This is by far the most important book I have ever found in studying the revolution in which the world is caught."

The following are several extracts from Major Williams's Introduction to his book:

"Of the hundreds of documents I have collected on activities of the Marxist revolutionaries—including originals or Photostats of official government reports, Intelligence releases, Communist papers, Zionist organisational reports to their members, Jewish histories of revolutions, biographies of their revolutionary leaders, etc. — I have never seen anything comparable."

"If the book is not marked secret, if it is in plain English, it is nevertheless almost safe, for it is largely couched in the esoteric language which all Jewish revolutionaries have used throughout known history, language found even in their Torah (the books of Moses) and which Jewish leaders imparted to Communist literature. Their use of words which you and I take to mean one thing but which their followers understand as meaning something else, a system which our people little suspect, almost guarantees the security of the document. Here at last is the complete plan of the Zionists, in their own words, for world domination."

Major Williams has called his book *The Ultimate World Order* — *As Pictured by "The Jewish Utopia"*. It is anticipated that a small parcel of this book will arrive from the U.S.A. shortly. ISRAEL AND THE COMMUNIST ADVANCE IN THE MIDDLE EAST

When Rabbi Elmer Berger, the Executive Director of the American Council for Judaism, an anti-Zionist organisation, toured the Middle East in 1955, he reported that responsible Arabs assured him that they were prepared to accept Israel and come to terms with the new State if it were not for the fact that Israel was not a sovereign entity but the instrument of a worldwide Zionist organisation. Comparatively few people understand the Middle East crisis because, as Rabbi Berger points out in his first-hand report on the Middle East — now available in booklet form and under the title He Who Knows Better Must Say So — worldwide Zionist propaganda has obscured the realities of the situation.

Unless Western politicians are prepared to face up to these realities instead of parroting the claim of Dr. Evatt and others that Israel is the "bastion of democracy" in the Middle East, it is certain that Communist influence in the Arab world must continue to expand. Events have demonstrated the truth of the warning by the American Jew, Mr. Benjamin Freedman who told the American people that support for the Zionist objective in the Middle East would also mean support for Communist strategy in an area which, because of its oil deposits, is vital to Western Europe. If Middle East oil supplies to Western Europe - and Australia — could be stopped, no matter what the alleged cause, for a few months, there could be such a disastrous economic breakdown that the organised forces of subversion, ever-ready to exploit a crisis, could take control of every Western European country. At the moment, what happens in the Middle East is of far greater importance to the Western nations than the launching of a dozen Sputniks by the Communists.

The present apparent conflict between Soviet Russia and Israel has resulted in many people forgetting that the Communists played a key role in the establishment

of the Zionist State. At the conclusion of the war they co-operated with the Zionists by allowing large numbers of Jews to leave Communist-dominated parts of Europe. As the well-known American Jew, Mr. Alfred Lilienthal, formerly associated with the American State Department, shows in his book, What Price Israel? Zionist leaders in the U.S.A. deliberately used Jewish refugees in Europe as troops in their terror-campaign to force the British to give up their Mandate in Palestine. Zionist reaction to Lilienthal's authenticated charges was to run a high-pressure smear campaign against him all over America. As a number of anti-Zionist Jews have pointed out, the Communists have nothing to learn from the Zionists in the technique of propaganda of all types.

The Communists also collaborated with the Zionists by supplying vital military equipment which was used to help drive the Arabs from Palestine, and by using all their influence in the United Nations to have Israel recognised and seated as a member. It will, of course, be argued that the past is past and that the Arabs should face the fact that it is folly to try and destroy Israel. But this argument ignores the fact that there are still approximately one million Arab refugees in the Middle East who were driven from their homes and properties in Palestine by the Zionists. The methods used to force these Arabs out equalled in barbarity any of the methods used by the Communists against their victims. The Arab refugees demand that their homes and properties be returned to them. And they hold the Western nations partly responsible for their present dreadful position. So long as the West tries to ignore this refugee question and refuses to demand that the Zionist aggressors grant some justice to their victims, even the most pro-Western of the Arab leaders can do little to hold back the growth of anti-Western feeling and the penetration of Communism.

Even if the West believes that it is not "practical" for the Arab refugees to be allowed to regain control

of their own homes and properties, it cannot ignore the basic justice of the Arab demand. The late Count Bernadotte, who was appointed by the United Nations General Assembly in 1948 to "promote a peaceful adjustment of the future of Palestine", reported on the question of the refugees:

"It is . . . undeniable that no settlement can be just and complete if recognition is not accorded to the right of the Arab refugee to return to the home from which he has been dislodged by the hazards and strategy of the armed conflict between Arabs and Jews in Palestine. It would be an offence against the principle of elementary justice if these innocent victims of the conflict were denied the right of return to their homes while Jewish immigrants flow into Palestine, and indeed, at least offer the threat of permanent replacement of the Arab refugees who have been rooted in the land for centuries.

"There have been numerous reports from reliable sources of large-scale looting, pillaging and plundering, and of instances of destruction of villages without apparent military necessity. The liability of the Provisional Government of Israel to restore private property to its Arab owners and to indemnify those owners for property wantonly destroyed is clear But in any case their unconditional right to make a free choice should be fully respected."

There is little doubt that the Zionists realised that if Count Bernadotte continued to work for a peaceful settlement along the lines he indicated, their plans for conquest would be hampered. Count Bernadotte was murdered on the night he submitted his report and his murderers have never been brought to justice.

Zionist propaganda is based upon the Hitler technique of the "big lie". At the moment it conveys a picture of a small, freedom-loving Israel fighting gallantly to protect itself against aggressors. As the big Arab refugee problem cannot be argued away, the Zionists have disseminated the story of how the Arab states refuse to resettle the refugees and "have preferred to see the refugees remain in camps on Israel's border in order to keep enmity against the new State alive and to have ready recruits for guerrilla warfare against it."

Responsible, impartial authorities have pointed out how there is not one single Arab refugee camp near the Israel border. The charge that the Arab States are deliberately exploiting the refugees for political purposes can easily be disposed of by reference to the official reports on the question by Mr. Henry Labouisse, Director of U.N.R.W.A., who has repeatedly told the United Nations that "the outstanding factor which continues to condition refugee attitudes and to influence the policies of Near East Governments in this matter is the strong desire of the refugees to return to their homeland. This feeling has not diminished during the year, and its strength should not be underestimated."

Rabbi Berger, in his tour of the Middle East, personally visited the Arab refugee camps, was greatly shocked by what he saw, and also said that the refugees, many of them cultured, well educated and Christians, were dominated by a desire to return to their own homes or to obtain adequate compensation. Refugees also point out that they hope that eventually the United Nations may do something about the resolutions, which have been passed every year since 1948, calling upon Israel either to repatriate the Arab refugees or to compensate them. If they allow themselves to be resettled now they fear they may forfeit their claims to adequate compensation.

The Arab attitude to Israel is also influenced by the manner in which the Arab minority still existing in Israel is being treated. Western politicians who visit Israel come back with reports, which are as far removed from reality as those which useful innocents bring back from Communist countries. There are still approximately 180,000 Arabs, Christians as well as Moslems, living in Israel, and they are one of the most oppressed minorities in the world. Numerous Jews, some of them supporters of Zionism, have criticised the outrageous treatment of the Arab minority by the Israeli Government. In the "bastion of democracy", Arabs are denied both political and human rights. Rabbi Berger saw for himself what was happening. Judge Sparrow, an American, reports on the situation in his book, The Sphinx Awakes. He tells how he took up with an American politician the question of how the Zionists were persecuting the Arabs. And the politician replied: "Yes, we know, but the truth is dynamite. The press here would tear one to bits if one told it." With exceptions, Western politicians are the same everywhere when it comes to criticising Zionist policies.

Under the official policy of the Israeli Government, Arabs are "Class-B" citizens. The Arabs live under military rule, have practically no civil rights. Army authorities can remove Arabs from any area and confiscate their property. Arabs must get permission to move from one village to another, even to see a doctor. Arabs are discriminated against in numerous other ways. It is to the credit of some Jews in Israel that they have protested against official policy. But the steady persecution continues, one of the reasons no doubt being, as Rabbi Berger claims, to impress upon the Arab refugees that it would be unwise for them to try and resettle in Israel.

"It seems grotesque," writes Judge Sparrow in his book, "that the Jews, so recently released from race persecution and the whole vile machinery of the Gestapo by British, American and Russian Armies, should, almost within a decade, be practising the very same odious doctrines themselves. There is not a single malpractice of the Jewish Government today that had not its counterpart and inspiration in Nazi Germany."

In some ways Israel is worse than Nazi Germany or any Communist country. Little or no official action is taken concerning the numerous murders of Arabs by Jewish terrorists. During his visit to Israel Rabbi Berger relates how, when he saw dozens of youths running around with automatic rifles, he asked why and was told that they were there for "guarding purposes", although the area he was in was nowhere near the border. The Rabbi commented: "But it is easy to understand why people here shoot first and ask later. These young men are regarded as paragons of the State". Rabbi Berger continues: "The State . . . can be seen in reflection in the image of these armed kids who have rifles as their sign of authority and superiority. So have the People of the Book become the people of the Bren gun and the hand grenade, and the place of Zion, from whence shall go forth the law, is an armoury whence goeth forth, at the discretion of an adolescent, hot lead and smell of

Rabbi Berger reports on his discussion in Tel-Aviv with a young Jew who had staged a hunger strike to demonstrate his opposition to the law, which prohibits Jews from marrying Christians. "The young man told me the school system teaches the children Arabs are inferior people. Then, from school both boys and girls must serve in the army, where the

whole purpose for a large military establishment is explained in terms of Arab threats. By the time the youths are twenty years old the pattern is set".

In his history of the Russian Revolution, *The Origins of the Russian Jewish Labor Movement*, A. L. Patkin, a member of the Moscow City Council in 1917 and a vice-president of the Jewish Volkspartei, writes that "The social code of Zionism and the newly-emerged Socialism were almost the same They both joined and merged in time." A graphic example of the application of this "social code" is the much-publicised Kibbutz or socialised farms in Israel. Rabbi Berger gives his impressions of this Zionist "social code" in practice:

"... Here at last I expected to see the pride of Israel. It was a dismal, dirty place, with the field littered with tin cans, and with skeletons of junked motorcars. We entered the communal eating hall, which was incredibly filthy. The Kibbutz is quite a phenomenon, and it is a little mystifying how American Jews become so ecstatic about them. They are entirely, and no one owns a single piece of property or has a smidge of personal possession. Even the matter clothing is handled on a co-operative basis

"Three hundred thousand people now live in the Kibbutz ... a system entirely devoid of individual initiative. All of your wants are supplied. You are required to work and to have children. The children are also raised on a communal basis. Parents spend a few minutes with them in the evening and on Saturday"

Israel is a Socialist and totalitarian State. Mr. Ben-Gurion's party is the Mapai party, which is: "A Zionist Socialist party aiming at the gathering in of the Jewish people . . . the up-building of the State of Israel, and a Socialist regime.

economy." The overwhelming majority of the Israeli Cabinet is declared Socialists and favour unlimited Jewish immigration. This open advocacy of unlimited Jewish immigration is causing widespread apprehension amongst the Arab peoples, who realise that this policy will lead to further Zionist attempts of expansion at the expense of the Arabs. There is no doubt that the Communists also understand the position clearly, which explains why they are at present quietly permitting a large exodus of Jews from Communist-dominated countries in order that they may go to Israel.

It is only necessary to make a brief study of the figures made available by the Israeli Government itself, to realise that the State of Israel is almost completely dependent upon the enormous flow of financial support organised by the Zionists all over the world. The much-publicised developmental projects in Israel, which Rabbi Berger points out have been much exaggerated, have only been made possible because of the financial support of a worldwide Zionist Movement. A Zionist spokesman has stated "No distinction is made between the Jews of the world and Israel".

The Jewish people everywhere are being continu-

ally subjected to Zionist propaganda and, in many cases, virtually compelled to provide a flow of funds for Israel. Zionism is a worldwide power deliberately creating false fears amongst the Jewish people in order to serve its own purposes. It is not Israel, which the responsible Arabs fear. They recognise it as merely an instrument with which it is impossible to negotiate.

If the West continues to try and deal with the situations in the Middle East without taking steps to ensure that Israel becomes a normal State and not a Zionist irritant, it will be conceding one more major victory to International Communism.
