# **EDITORIAL** DOLLAR DIPLOMACY PAVES WAY FOR COMMUNIST EXPANSE IN AFRICA

We have never underestimated the capacity of the Communist conspirators to subvert any country from within. The Communist conspiracy, and the diabolical techniques used to advance this conspiracy, has been dealt with exhaustively in our columns. But the story of how the conspiracy has made such rapid progress in such a short time is incomplete, and dangerously misleading, unless the part played by dollar diplomacy is also recorded. Africa is at present one of the great strategical prizes in the battle for the world. The prize is rapidly passing to Communism, but only because dollar diplomacy has prepared the way for the Communist advance and is actively assisting the Communists to consolidate.

Left to their own devices, the Communists had little chance of shaking the Western colonial powers in Africa. The Communists' big successes in other colonial areas were obtained primarily as a result of the war. But in Africa it has been the anti-colonial pressure of the dollar diplomats, and the financing of subversive activities amongst the native peoples, which has been decisive in producing the present situation. A study of the Congo situation, which has now appeared to have developed beyond the point of no return as far as the West is concerned, leaves no doubt whatever that dollar diplomacy, using the American Administration, has consistently worked to hand the Congo over to the Communists. It is the very consistency of the policies pursued by the American Administration which leaves no doubt about the results deliberately intended.

When the above facts are pointed out to some people, they immediately make loose comments about "anti-Americanism", ignoring the fact that the Americans are but instruments of a policy which will finally enslave them along with all other peoples. The truth is that an increasing number of Americans are also beginning to realise that dollar diplomacy is aiding and abetting Communism. Others, who do not as yet grasp the fact that the International Money Power is one of the most decisive in human affairs, do see, however, that their Government is handing the Congo over to International Communism. We quote, for example, from an appeal

made to Adlai Stevenson, America's representative at the "United" Nations, by the President of the University of Dallas, Robert Morris, one of the best informed men on the Communist conspiracy in the U.S.A. In a recent letter to Mr. Stevenson, Mr. Morris wrote: ----

May 19, 1961

"Because we as a Nation learned the enormity of the Communist conspiracy too late in the case of Poland, of Yugoslavia, of China, and more recently of Cuba, I am writing to you . . . asking you not to let our Nation be hoodwinked once again . . .

"If the Soviets can capture the Congo thus adding to what they have in West Africa, North Africa, and with their progress in East Africa, they will become the dominant force in a strategic continent that commands an important sector of the Atlantic and Indian Oceans, as well as Antarctic's.

"Today the Communists in the Congo, without outside assistance, are a retreating force.

"They are what the Chinese Communists were in 1935 when they were being driven to the Northwest by the free Chinese. They probably represent in substance the same bedraggled force that Fidel Castro commanded in 1956 when he led 80 bearded insurrectionaries onto Cuba. They are, relatively speaking, on their own, resourceless.'

The educator recalled that after World War II "we salvaged the cause of the Chinese Communists by our imposed truces, by our efforts to create a 'coalition government' and then by an embargo against the free Chinese when they were provoked into breaking off negotiations. Despite this tragic lesson we did substantially the same thing in Cuba 13 years later, and now give evidence of doing the same thing in the Congo in 1961.

"The United Nations command under the Indian, Rajeshwar Dayal, has been favoring the Lumumba forces and preserving them from destruction. It has been doing this despite the fact that they represent armed insurrection against the established Congolese government and have been guilty of widespread murders and acts of terrorism.

## AUSTRALIA AND THE **INTERNATIONAL MONETARY FUND**

The obtaining of the recent loan by the Australian Government from the International Monetary Fund, and Mr. Holt's statement concerning the assurances given to the I.M.F. concerning Australia's domestic policies, are of such vital importance that in our next issue we will be devoting a special article to showing how the policies set in motion by the Bretton Woods agreements are being used to create the World State.

Adequate supplies of our special article will be available for distribution.

"The Charter of the U.N. nowhere authorises the bolstering of insurrectionary tyrants. Yet that is what Mr. Dayal has been doing on the basis of all the evidence from the Congo.

"The U.A.R. Resolution, which you supported, now goes further," Mr. Morris stated. "It authorises the use of force by Mr. Dayal and his command, which is made up of preponderantly pro-Soviet representations, against the established Congolese government.

"This is a dangerous precedent and makes meaningless the guarantees of the U.N. Charter against interferences in the internal affairs of the member U.N. nations.

### ENCOURAGING START TO LEAFLET CAMPAIGN

The first League of Rights leaflet, "It Is Later Than You Think!" has been well received and the first edition is now exhausted. A second edition is now available, with a list of League publications on the back. The suggestion to use the leaflet to publicise League publications is one of the several excellent ideas advanced by supporters. Any further ideas will be welcomed. What is most important now is to evolve machinery for the effective distribution of leaflets on a nationwide basis at regular intervals—each leaflet making one telling point. The League of Rights requests supporters to forward suggestions. These suggestions can then be pooled and made available to all. The following are some of the distribution methods, which have been used with the first leaflet: A country traveller has taken a large supply for distribution on his trips. Several supporters in business have posted the leaflets on public notice boards, where they have attracted considerable attention. One businessman has taken a supply to place on his counter and to include in all accounts to customers. The best results have been obtained by handing leaflets personally to other people.

Already the League has received enquiries as a result of the leaflet campaign. But to have the type of impact needed, it is desired to effectively distribute hundreds of thousands of each leaflet as it is issued. The League would like to hear from supporters about this. Any desired supply of leaflets will be supplied at no cost, although donations towards this special activity will be welcomed.

### "THE AUSTRALIAN JEWISH NEWS" APOLOGISES

As a result of Mr. A. K. Chesterton's visit to Australia early last year, when he was the guest of the League of Rights, *The Australian Jewish News* of March 25, 1960, carried an attack upon Mr. Chesterton and, by inference, upon Mr. Butler. The heading of the report read, "Butler Welcomes Lord Haw-Haw's Partner". Then followed a vicious attack upon Mr. Chesterton in which it was claimed that Mr. Chesterton was a former colleague of the British traitor, William Joyce (Lord Haw-Haw) and had founded "the notorious anti-Semitic body, the National Socialistic League".

Legal action by Mr. Chesterton resulted in *The Australian Jewish News*, in its issue of April 21, 1961, publishing an apology, and agreeing to pay Mr. Chesterton's costs and a further sum as damages.

The apology read: —

The Australian Jewish News further acknowledges that it has ascertained that Mr. Chesterton was not, as stated in the above passage, a founder of the National Socialistic League.

Mr. A. K. Chesterton has a distinguished record as a soldier in both world wars. During the First World War he served in the South African and Imperial Armies from the age of 16 and was awarded the Military Cross for his part in the attack on the Hindenburg Line. He joined the British Army Officers' Emergency Reserve prior to the outbreak of the Second World War and thereafter served in the campaign in Abyssinia and Somaliland, being invalided out in 1943.

The Australian Jewish News tenders to Mr. A. K. Chesterton a full and unreserved apology for any damage and embarrassment publication of the offending report may have caused him.

The Australian Jewish News acknowledges that the use of the phrase "Lord Haw-Haw's Partner" in the above report is a grave reflection on the loyalty of Mr. Chesterton, for which there is not the slightest justification.

It acknowledges that the sentence in the above report commencing with the word "According" and concluding with the words "World War II" is capable of conveying the meaning that Mr. Chesterton was associated with William Joyce in treasonable activities and states that there is no justification in fact for any such meaning. supplying Jew responsible for The The Australian Jewish News with the false story concerning Mr. Chesterton was the man who was actively associated with the smear campaign launched against Mr. Butler in 1958. Nation, the Sydney journal responsible for the article, "The Secret Life of Eric Butler", also published references to Mr. Chesterton similar to those in The Australian Jewish News. ### **Mr. MENZIES RETREATS**

The Australian Government's change of policy on South Africa in the "United" Nations provides further evidence of how a spurious "world opinion" is being used to force Western Governments to support policies leading to complete disaster. In his recent Parliamentary statement on the last Prime Ministers' Conference, Mr. Menzies sought to explain why he felt that there was no contradiction between the stand he took in London and the support for the motion condemning South Africa at the "United" Nations. But in a nationwide television programme on April 30, Mr. Menzies made the significant admission that, following the switch in the United Kingdom's position in the "United" Nations on South Africa; his Government was not going to be the only Commonwealth country voting with South Africa.

Mr. Menzies said, "What would have happened to Australia if we had been the only Commonwealth country standing out? We would have been misrepresented all over Asia about our attitude, and we are not going to be misrepresented. We had had enough. So we voted with the United Kingdom." As Mr. Menzies had already been "misrepresented all over Asia" as a result of his stand in London, it is clear that it was the application of pressure after Mr. Menzies returned home which forced him to retreat. "We had had enough." Those words remind us of the wrestler who is tapping the mat, indicating that he has had enough punishment On his own admission, Mr. Menzies has by his retreat now given the enemies of this country the all clear to start condemning our domestic policies. We are prepared to accept the report that Mr. Menzies is genuinely concerned by the manner in which "world opinion" has compelled him to retreat, but this leaves us with the question of how far he and his colleagues will continue retreating before they make a real stand. Australian public opinion must be better informed and strengthened for the battle for survival.

"But it is worse than that. It authorises force on the part of a command that is on the record, demonstrably pro-Soviet, against the established and recognised Congolese government. And it comes at a time when Congolese Communists are on the run. It is China, Poland and Cuba all over again.

"It is not surprising that Ambassador Zorin did not veto this resolution. It is obviously what the Soviets have been working for, disguising their motives by meaningless attacks on the Secretary-General, thus creating a great hoax," Mr. Morris declared.

"But for the United States to make itself a part to this legal and political outrage, bodes ill for the cause of freedom in Africa."

The cause of freedom is being menaced not only in the U.S.A., but all over the world by the policies of the dollar diplomats. The Communists do not need to send troops to the Congo when they have the "United" Nations troops preparing the way for them. Adlai Stevenson's association with Wall Street has been long and intimate. He leads the anti-colonial campaign against the Europeans in Africa, while co-operating with the Communists in not raising in any way the brutal colonial policies of the Communists in Hungary and other Eastern European countries.

It is imperative that the relationship between dollar diplomacy and Communism be well publicised in order that there is less nonsense about Washington being the only alternative to Moscow. Australia's future is not guaranteed by being subservient to Washington policies. These policies have consistently led to the destruction of national sovereignties and the centralization of power on an international scale.

# KENNEDY'S FOREIGN POLICY EXPERTS

Excerpts from Human Events, Washington, D.C., U.S.A.

KENNEDY'S naming of Rusk, Stevenson and Bowles to steer American foreign policy during the next four years, brings up the haunting ghost of Achesonian appeasement in the Far East during the immediate post war years. The "Tinker to Evers to Chance" combination, who lavished extravagant praise on each other's appointments (Rusk went so far as to claim that Stevenson was "one of our greatest American statesmen"), may talk tough about the Reds at times, but their raw ideas invariably boil down to using a soft stick on the Red Chinese.

Their policies call for a weakening or scuttling of military pacts in the Far East, meeting the Communist threat by pouring out increased economic (but not military) aid, neutralization of Formosa, and in one form or another, the recognition of Red China.

#### **DEAN RUSK**

Stevenson's and Bowles' policies are generally well known, but just who is Rusk and where might he push American foreign policy? A lifelong Democrat, Rusk was a member of the American Council of the Institute of Pacific Relations (IPR) when that organisation peddled the line that the U.S. should withdraw support from Chiang Kai-shek and back the Chinese Communists. The IPR was labelled as a transmission belt for Communist propaganda by the Senate Internal Security Sub-committee.

Rusk was a strong supporter of the IPR. As late as 1950 he asked the Rockefeller Foundation to donate funds to the organisation, although evidence of Communist infiltration of the Institute dates back to 1944. At one time Rusk recommended that IPR publications, pro-Communist in flavor, be used by the Chief of Military Intelligence. An example of his views appeared in a 1950 speech to the World Affairs Council at the University of Pennsylvania. The Washington *Post*, reporting the speech on January 13 1950, said Rusk told the Council that the Chinese "Revolution" is "not Russian in essence" and "does not aim at dictatorship".

The same year, 1950, Rusk was promoted to Assistant Secretary of State for Far Eastern Affairs by Dean Acheson, whose "soft" views on the Far East haven't seemed to change much. (See Human Events of December 15, 1960.) As Assistant Secretary, Rusk firmly supported Truman's recall of Mac Arthur from the Korean War, claiming MacArthur's plan to achieve military victory in Korea would "lead to disaster."
