EDITORIAL.

AUSTRALIA'S IMMIGRATION POLICY IS ELECTION ISSUE

Subversive individuals within Australia have made it clear that Australia's immigration policy is a major issue at the coming Federal Elections. We have repeatedly warned in recent years that the mounting attack against the present Australian immigration policy was part of a worldwide revolutionary movement directed against Western Civilization. The proposed student demonstrations against Australia's immigration policy during the Federal Elections indicate that the revolutionaries are now determined to intensify their activities.

We are not suggesting that every University student participating in election demonstrations is conscious of the evil purposes he is serving. But it is significant that during recent years University students in all parts of the world have played a prominent role in revolutionary activities. The most significant portion of the report that a meeting of Melbourne University students had decided to stage demonstrations on the immigration issue during the Federal Elections, was the statement that if the demonstrations were held, it was certain that they would receive widespread publicity overseas, and that this would assist in having international pressure brought to bear upon Australia to force a modification of the present immigration policy. This statement indicates that woolly-minded University students are not responsible for initiating the election campaign; they are being used by others who have been carefully planning this campaign for some time.

The future of this nation as a part of European Civilization depends basically upon a retention of an immigration policy designed to build up a homogeneous European population and to prevent racial frictions from being introduced into Australia. This policy does not insult any other peoples. Those who claim that it does, people like Mr. Neuman Rosenthal, director of visual aids at the Melbourne University, and a strong opponent of the present restrictive immigration policy, are misrepresenting the policy. Mr. Rosenthal recently returned from a trip to Asia and claimed that Australia's immigration policy was causing a lot of ill feeling in Asia towards Australia. Any ill feeling which does exist, and there Chinese. We have not the slightest doubt that the election campaign by University students is part of the general strategy for ending European Civilization in Australia. And we predict that the numerous tactics for advancing this general strategy are going to be intensified. Spokesmen for the world revolutionaries have recently boasted that they will soon have the Portuguese, the last of the European colonial powers in Africa to make any genuine stand, on the run with the rest of the European nations, that South Africa's position will become impossible, and that Australia cannot be allowed to continue alone to defy the "winds of change" with its restrictive immigration programme.

GALLUP POLL AVAILABLE

Although Gallup Poll figures have been produced to show that a small majority of Australians now favour a modification of Australia's present immigration policy, we are of the opinion that these figures have been produced for propaganda purposes and are not a true reflection of public opinion. Those who may consider this a sweeping statement should recall that Gallup Poll figures were produced to show that a majority of Australians favoured fluoridation of the public water supplies. But as we pointed out in our editorial in our last issue, the two referendums held in Australia on fluoridation showed conclusively that the Gallup Poll figures were worthless. As one of those engaged in the Gallup Poll organisation has pointed out to us, the type of answers given by people questioned depends to a great extent upon how the questions are asked. While there is no doubt that there is a vocal minority opposed to the present immigration policy, the overwhelming majority of Australians support the policy. We suggest that the opponents of the policy should carry out their suggestion to stand Senate candidates at the Federal elections on the issue. The results would show just how little support there is for any breaking-down process.

COMMUNIST STRATEGY FOR AUSTRALIA

During his recent visit to Melbourne, Dr. W. G. D.L.P. Gives Lead on Death Duties: Death duties of all kinds are a direct attack on the principle of inheritance. They are completely immoral and Communistic. Anyone doubting the Communistic aspect should examine the Communist Manifesto with particular reference to Karl Marx's ten points for communising a State. Probate duty has become so onerous in Australia that there are some signs of revolt.

The Victorian Wheat and Wool Growers' Association has recently approached the Victorian Government seeking relief, and the Chief Secretary, Mr. Rylah, has promised to consider the submissions made. The Democratic Labor Party State Secretary, Mr. F. Dowling, has publicly stated that the D.L.P. favours a reduction of probate duty. As far as we are aware, this is the first definite lead by a political party on this issue.

All death duties are a technique whereby the State prevents the individual from passing a material heritage to his heirs, thus providing him with a basis for growing independence.

Prince Philip Ignores Basic Issues: Prince Philip has on occasions made some refreshingly frank comments on public questions. In his recent address to British industrialists, during which he used a descriptive statement not usually heard in polite society, Prince Philip dealt with an aspect of a disease which has become so deeplyrooted in Britain that even the most loyal supporters of the British link are disheartened by the Britain of today.

Prince Philip said "A nation is judged by its reliability in commerce, prompt delivery of goods and the satisfactory completion of contracts. Just at this moment we are suffering a national defeat comparable to any lost military campaign and what is more it is selfinflicted." All this is excellent as far as it goes. But it does not touch the basic causes of the self-inflicted defeats. Neither did Prince Philip's observation that "If we want to be more prosperous we've simply got to get down to it and work for it." The basic cause of the British disease, a disease that has unfortunately resulted in many Australians regarding most British migrants as people who have a perpetual grouch, is the Welfare State and the methods used to finance it.

Britain is to become great again, then the inherent character and abilities of the British peoples must be freed from the crippling of initiative caused basically by heavy taxation and the Welfare State with its "free" this and its "free" that. Perhaps Prince Philip could devote a future talk to this subject!

Is Mr. S. Cohen Really on an Extermination List?:

The first issue of *Fact*, a new fortnightly publication issued by the Australian Labor Party, carries a dramatic story on its front page concerning an alleged threat to kill Mr. Sam Cohen, number two on the A.L.P. Senate list in Victoria. Mr. Cohen is President of the Communist-front organisation known as the Jewish Council against Fascism and Anti-Semitism. Others on the extermination list are Mr. Neuman Rosenthal, Melbourne University. Judal Feiglin, president of the Mezriche organisation, and Ralph Samuel, president of the Temple Beth Israel.

Fact reports that an "Australian Fascist organisation" is responsible for the extermination threats, which are to be carried out if Adolph Eichmann dies. *Fact* comments, "The threat coincides with a D.L.P.-inspired attack on Mr. Cohen, in an effort to draw votes away from the A.L.P. Senate team and attract them to Senator McManus, whose position in the Senate is in peril. The Jewish community sees the latest moves on Cohen and other leading Jews as disturbing evidence of an upsurge of anti-Semitism. It is the worst case since the resumption of swastika daubing two years ago."

We are of the opinion that no real threats have been made against the life of Mr. Cohen or anyone else. It is significant that the *Fact* report mentions the swastika daubing of early 1960. As shown beyond all argument in the booklet, *The Bigots Behind the Swastika Spree*, this worldwide campaign was instigated by powerful Jewish groups for the purpose of terrorising the rank and file of Jews and for the advancement of International Communism. The present "threat" to Mr. Cohen comes at a most opportune time for him when he is under heavy attack because of his association with a Communistfront organisation. *Fact* reports, "The Melbourne Jewish community has rallied behind Cohen and the other threatened men." This could be one of the main pur-

British initiative, industrial know-how, and craftsmanship once made Britain the world's foremost industrial nation. This is the country, which it is proposed to allow into the "United" Nations. Questions have been asked about how Lattimore got into Mongolia, as America has no relations with Mongolia. American passports do not hold there.

Needless to say, no one is likely to apologise for falsely smearing McCarthy.

Exporting to "The Devil": The logical result of the export-or-perish madness is to send production to any country in the world: so long as it enables monetary incomes to be distributed to help purchase production not exported. We have observed in the past that the opponents of exporting to Communist countries must advance some positive programme for disposing of production. We have no hesitation in saying that there would be few, if any, Communists amongst Australian wheatgrowers. But these primary producers must get a monetary return for their production—or go bankrupt. And so if Red China is prepared to take their wheat, which they are finding hard to sell, they accept the proposition.

The experiences of the wheatgrowers have no doubt helped stimulate the interest of the woolgrowers' representatives. Mr. William Vines, the new managing director of the International Wool Secretariat, has lost no time in making it clear that he looks for big wool sales in Communist China. He said that he would be prepared to sell to the devil if the devil could pay the price. Mr. Vines clearly accepts the orthodox view that a nation becomes wealthy through its exports. As supporters of realistic economics, we believe that the true purpose of exports is to purchase necessary imports-not to distribute monetary incomes internally in order to try to make the economy work. Which brings us to the question of what price is the devil -- Communist China -- going to pay for Australian wheat, wool, or any other production? Australia has no necessity of any imports from China.

Perhaps Dr. Coombs has visited China to prepare the way for the financing of both wheat and wool sales to China on long-term credits? Already a start has been made with credits for wheat exports. The devil must be having a good, hearty laugh as he sees his potential victims actively engaged in helping him at their own expense. But, of course, it is all being done under the slogan of "export-for-prosperity". expense of the producer and retailer. They have, in fact, been attempting to subsidise prices out of their profits. There is, of course, a limit to this type of subsidising, as witnessed by the large number of smaller business organisations, which have been forced either to close their doors or to merge with other organisations in an attempt to survive. Every time the Government imposes restrictive credit and taxation policies, it intensifies the growth of economic centralism and strikes another blow at the foundations of the free-enterprise economy.

There has been a slight improvement in economic conditions as more credit has been made available. But we will predict that Mr. Menzies' optimism concerning the alleged defeat of inflation will be shown in the future to be without foundation. Official economic policy, as taught in most universities, and applied by government economists, is "controlled inflation". This policy, immoral in both intention and practice, is designed to ensure that the greatest potential of a genuine free economy, financial dividends for all and more free time for self-development, never reach the individual. The progressive expansion of new financial credits for "full employment" is basically the same type of policy imposed by the Communists. It inevitably produces inflation. This is no doubt one of the reasons why the Communists are so confident about "capitalism" possessing the seeds of its own destruction.

There is nothing very difficult about implementing a policy designed to prevent inflation without dislocating the economy. If new credits can be made available to inflate prices, then the same new credits could be applied to reducing prices. It is basically a question of purpose. Until this question is clarified, discussions on technique are largely academic.

lia, and the idealists they are exploiting, would present no real challenge if it were not for the fact that these people serve an international revolutionary movement. Every conceivable weapon is being used by the revolutionaries: political, economic, financial, propaganda and various forms of perversion. This question was raised with the economist, Mr. Colin Clark, when he was recently in Australia, and he readily admitted that if Australia joined a South-East Asian Common Market, this would eventually mean the free entry of non-Europeans into Australia. CANDIDATES MUST GIVE FIRM ASSURANCES

There are many important issues, which responsible Australian electors must bear in mind before casting their votes on December 9. But those who understand the long-range implications of any modification of the present immigration policy must demand unequivocal assurances from candidates that they support the present policy before voting for them. This is a life or death question for the peoples of this country. Only by being true to themselves and to their heritage can the Australian people make a real contribution towards assisting the peoples of Asia to fulfill their genuine aspirations.

The European peoples still offer the greatest resistance to the programme of centralising economic power on a world scale. The powerful international financial groups driving for complete world power have no real interest in the African or Asian peoples, except as instruments to be used against European Civilization. The principal figures in these groups think basically like the Communist leaders, which explains why they work together everywhere in the subverting of European Civilization. Australians can voice their protest against this subversion during the coming Federal Elections.

INTERNATIONAL FINANCE AND THE COMMON MARKET

The October issue of *Credit Notes* (England) states: "The Common Market is still the old debt system under another name. There are constant references to 'compulsion', 'directives', 'issuing of regulations' and 'taking decisions' in the Treaty of Rome. The peoples of the countries supporting the 'Market' will be firmly saddled with the heavy additional expense of maintaining a hugely swollen bureaucracy charged with the administration of a European totalitarianism which would turn the ghosts of Hitler and Stalin green with envy . . .
