## WHY SUBSIDISE THE ENEMY?

When war started in 1939, Australian sheep went on growing wool. But although the war badly disrupted Australia's wool markets, no Australian publicly suggested during the war years that Hitler's Germany provided a tremendous export market to which Australian wool could be sent. No one said how Germany could make use of enormous quantities of wool to clothe her armies for the Russian campaign. No economist urged that such a policy was a "realistic" one, that it would help "strengthen the Australian economy," and that this policy would make for better relations with Hitler. Anyone, irrespective of his status, who had spoken like this would have been immediately thrown into a concentration camp and publicly branded as a traitor.

Those advocating similar policies today in dealing with a far worse and more dangerous enemy than Hitler's Germany, International Communism are described as statesmen!

The promoters of International Communism have declared war on Civilisation. They have made it clear that all their energies, all their policies, are directed towards the winning of that war in as short a time as possible. They have even outlined how they are going to win. Lenin predicted in 1920 that the time would come when the Western capitalists would not only compete with one another to gain the markets of the Communist world, but would also provide the credits in order that they could send their exports to the Communists. Current events are confirming Lenin's prediction.

#### **Behind de Gaulle's Chinese Policy**

Although General de Gaulle's decision to recognise Communist China has been generally regarded as one of tremendous historic significance, one that could tip decisively the whole balance of world power, comparatively few have grasped the deeper significance of de Gaulle's move. In order to grasp this deeper significance it is essential to recall that the author of Social Credit, C. H. Douglas, warned time and time again that while basic defects in the economic and financial rules of the freeenterprise economy remained unconnected, one of the inevitable results would be that the more highly industrialised nations became, the more they would have to seek export markets in an attempt to make their internal economies work. Anyone sufficiently interested in Douglas's examination of this and associated questions, can study what Douglas had to say in his own works. And he will then realise the truth of the statement made by one observer: "Events appear to be in the pay of Douglas."

While there is little doubt that General de Gaulle is obsessed with dreams of grandeur, there is also little doubt that behind his dramatic recognition of Red China, and his diplomatic initiative in the Latin-American nations, is the urge to find an outlet for France's growing "surplus" production. We have no doubt that de Gaulle's Rothschild adviser, Pompidou, has explained the necessity of France gaining a "favourable balance of trade." And no doubt the Rothschilds could explain how credits could be arranged to enable France to gain entry into the vast Chinese market. We do not discount the French claim

that de Gaulle's sudden recognition of Red China was to gain an early start on the Americans, whom the French believe propose to move towards recognition of Red China if the Democrats can win this year's Presidential Elections. The truth is that there has been tremendous pressure building up in the U.S.A. for some time, urging recognition of Red China in order that American exports could be sent to China. In spite of the fact that the Americans could run an almost completely self-contained economy, they are told by their economic "experts" that they cannot make their economy work internally without an enormous export drive in various forms — including what is called "foreign aid."

### **Phony Argument Concerning Common Market**

When the campaign was on to force Britain into the European Economic Community, one of the claims was that the Economic Community was urgently necessary to contain and to defeat Communism. This was a completely phony argument, as can now be seen quite clearly by de Gaulle's policy of subsidising the Communists by exporting them valuable production on credit. But even before this, as we exposed, the very rock of Western opposition to Communism, Western Germany, was rapidly increasing its export drive into Soviet Russia and other Communist nations.

The truth is that with every day that passes now, the West's whole strategy of attempting to deal with International Communism is collapsing. It is foundering on the inherent fallacies of the Western nation's financial and economic policies, which are producing growing conflict between the non-Communist countries. An outraged American public opinion forces even the traitors in that country to speak with indignation when the British, or other nations, export to Castro's Cuba. But it is not only the British who are exporting to Cuba, desperately striving for an export trade which will assist their internal economy; that strong anti-Communist Franco is also exporting to Cuba! He no doubt also has his "experts" who urge him to be "realistic". While the Americans are criticising the British for exporting to Cuba, or the French for exporting to Continued on Page 4

## INTENSIFIED CAMPAIGN OF VIOLENCE AGAINST CANADIAN CHRISTIAN ACTION MOVEMENT

## **Eric Butler Threatened By University Students**

Further to our recent report concerning the campaign against the Canadian Christian Action Movement, at present conducting a three months' national educational and organisational programme under the direction of Mr. Eric Butler, assisted by Mr. Pat Walsh, Research Director for the C.A.M., and former undercover-agent for the Royal Canadian Mounted Police, we have received further news from Canada which indicates that an all-out campaign is under way to destroy the C.A.M. before it becomes too firmly established. Mob violence was incited at two meetings in Saskatchewan, with University students and Professors leading the opposition to Mr. Butler and Mr. Walsh, while in Edmonton, Alberta, a C.B.C. representative and C.B.C. cameramen led an attempt by a mob to force entry into the hall where a Seminar was being held.

Although the Christian Action Movement has been falsely charged with fostering "anti-Semitism" and "fascism" Mr. Pat Walsh, a man with a vast first-hand knowledge of the forces directing and promoting world revolution, has been able to demonstrate that the "hate" and "anti-semitic" campaign launched in Canada soon after the Christian Action Movement's programme was under way in Vancouver, is in fact a campaign set in motion by the revolutionaries. By taking a leading part in furthering this campaign, the Canadian Jewish Congress has in fact left itself open to the charge that it is prepared to join with the Communists in opposing the Christian Action Movement.

#### **Jewish Authors Recommended**

Commenting on the allegations that the Christian Action Movement was circulating "hate" and "antisemitic" literature, Mr. Eric Butler writes: "Immediately the first allegation was made, following our Calgary Seminar, that the C.A.M. was spreading "anti-semitic" literature, I made a close survey of the literature being handled by the C.A.M. at both Seminars and meetings. It was true that it was selling the booklet, The Bigots Behind The Swastika Spree, but this excellent booklet is a thoroughly documented exposure of the use of swastika daubing of synagogues by the Anti-Defamation League and its dupes. It is written by the American Jew, Mr. Joseph Kamp, who charges that this type of 'anti-Semitism' was being promoted by Jews. Subsequent developments have confirmed Kamp's allegations. I discovered as I looked through the books being sold by the Christian Action Movement that a very big percentage were actually written by Jews or part-Jews. But as even a distinguished American Jew like Lilienthal, well-known for his book, What Price Israel?, is also charged with being anti-Semitic, it is clear that those using the 'antisemitic' smear are not interested in truth. And they certainly fear free, open discussion."

### **Albertan Government Assists Smear**

When it was demonstrated in Calgary, where the first major attack was launched against the C.A.M., that Mr. Butler was not only more than holding his own, but was scoring heavily off the opposition, it was obviously decided to try different tactics in Edmonton. The local C.B.C. ran a vicious campaign warning against the arrival of the "hate-mongers", a local Jewish lawyer being invited

to make a special contribution to the campaign. At the last moment the hotel in which the C.A.M. supporters were to have their first meeting, was cancelled under pressure. The Albertan Social Credit Board was brought into line with a formal resolution publicly dissociating itself from the Christian Action Movement, stating that it feared the fostering of "anti-Semitism and fascism." Asked for an interview by the C.B.C., the Albertan Premier, Mr. Ernest Manning, admirer of the Zionist State of Israel, said that he would not "dignify" the C.A.M. by making any comment about it. This attitude has provoked a wave of indignation amongst many Social Crediters throughout Alberta, and the C.A.M. Seminar, attended by 65 people, carried a strongly worded resolution of protest concerning the attitude of the Social Credit Board. A copy of the resolution was sent to the Premier.

## **Attempt To Wreck Seminar**

After speaking to Edmonton C.A.M. supporters gathered together at short notice, Mr. Butler and Mr. Walsh then travelled north followed by the C.B.C. smear campaign, and upon arrival back in Edmonton the following week found that heavy pressure was being applied to have their hall for the Seminar cancelled. C.B.C. viewers were treated to the spectacle of a C.B.C. commentator standing outside the hall stating that this was where the "hate mongers are going to meet in secret next Saturday." He also said that local Jewish spokesmen had stated that they would not picket the Seminar. But on the Saturday afternoon, at least an hour before the start of the Seminar, a big picket line was in action, carrying highly offensive signs, and attempting to intimidate C.A.M. people wanting to attend the Seminar. At least 35 Edmonton University students took part at one stage, while the C.B.C. representatives were also present early. At one stage Mr. Butler and Mr. Walsh had to hold back the C.B.C. representatives as they attempted to lead a number of the students into the hall. Every effort was made to provoke an incident, which could be filmed and used to demonstrate the methods of the "Nazis." But with police assistance order was maintained and the Seminar proceeded with a background of demonstrations outside. During the evening session one University student gained access to the Seminar by trickery and during the discussion period suddenly seized the book containing the list of those registered, immediately rushed out was picked up by a waiting car before he could be stopped.

The C.A.M. is preparing a detailed report on the role of the C.B.C. at Edmonton in smearing and attempting to lead a rioting mob into a private meeting, and this report will be presented to Members of Parliament at Ottawa.

## **Professors Lead Students At Regina**

Shortly after their arrival in Saskatchewan, Mr. Butler and Mr. Walsh realised that they faced more opposition similar to that experienced in Alberta. Interjectors and trick questions were successfully dealt with at Saskatoon, but at Regina, the capital, a picket line of university students, members of the Communist Party, and a Professor, made it clear that there could be serious trouble. Photographers and press had been told that there would be trouble, and were on hand to record it. There were several incidents before the meeting started, but these were kept under control without the major riot clearly planned. Uproar broke out immediately the meeting started, with Mr. Pat Walsh being abused by a big percentage of the audience as he attempted to speak. But he made it clear that the Christian Action Movement across Canada was not going to be halted. "We will not be intimidated," he said.

Mr. Butler had to attempt to speak through a barrage of howls, jeers and abuse. He eventually got some order, forcing the opposition either to agree to hearing him speak without insults, or to start with question time immediately. The opposition had to agree to hear Mr. Butler for 30 minutes. Leaders of the opposition immediately retired from the hall to plan their next strategy. Question period was a near riot. It was significant that Professors were leaders right throughout. One Jew threatened Mr. Butler at the conclusion of the meeting. He claimed to have been born in a concentration camp, but when Mr. Butler pointed out that Mr. Walsh had taken part in the Normandy campaign, the final part of the campaign to destroy the Nazis, the young Jew a student — burst into a torrent of abuse. The high platform, which could not be mounted readily from the hall, provided the speakers with some protection at the close of the meeting, while the authorities insisted on clearing the hall.

Press, radio and T.V. reports merely resulted in the C.A.M. being further widely publicised across Canada. While it was true that the opposition had partly wrecked the Regina meeting, they had not achieved their objective. They immediately planned the next offensive.

### Violence Threatened At Moose Jaw

Two nights after the Regina meeting, Mr. Butler and Mr. Walsh arrived from a country area to speak at a public meeting in Moose Jaw, about 40 miles from Regina. Not anticipating any trouble in this small provincial city, they were astonished when shortly before the meeting chartered buses from Regina pulled up and out spilled approximately 150 students. At least two Professors were present again, one with a miniature tape recorder which he attempted to use at the conclusion of the meeting.

Also a representative of the Anti-Defamation League was present with a special tape recorder set up in his seat. The students were marshalled into the hall by their leaders and specially seated. Local police warned Mr. Walsh and Mr. Butler that a large number of empty beer bottles were near the buses and that it was clear the students had been drinking on the way down.

Uproar broke out as soon as the meeting started, whereupon Mr. Butler immediately seized the initiative and said that as the meeting for Moose Jaw citizens had been invaded by students and their Professors, who were clearly a majority of the audience, the invaders would now have to take full responsibility for the meeting. Neither he nor Mr. Walsh were going to attempt to speak unless they were assured by a spokesman for the invaders that they would have at least one and a half hours without interruption for their addresses. If this assurance was not forthcoming, he would close the meeting immediately and the local people could see who was responsible for depriving them of freedom of speech. This caused a panic amongst those responsible for organising the students. They eventually decided that they would accept the terms in preference to closing the meeting and going all the way back to Regina without achieving anything.

However, while Mr. Butler was speaking, offensive signs were held up throughout the audience. And the old Communist technique of intimidation was tried by thug looking like young men walking constantly from the back of the hall straight up towards the speaker while flexing their muscles. During question time there was a planned assault upon both speakers, with numerous loaded questions designed to trap the speakers into the type of statements required for further smearing. The Jew who tried to threaten Mr. Butler at Regina tried desperately to produce hysteria by waving, while he shouted about "blackshirts" — what he claimed was "anti-semitic" literature. But this was an exposure of "anti-Semitism" by Mr. Walsh, in which he quoted how even the California Jewish Voice of November 8, 1963, had admitted that five Jews had been arrested for painting swastikas on the front of the Israeli Consulate-General building!

Concerned by the fact that some of the students present were carrying articles in their pockets, that an attempt had been made to lock the back doors of the hall, thus preventing people from leaving if rioting broke out, and that every effort was being made to create a riot, Mr. Butler suddenly closed the meeting by calling for the Queen. But he was not in time to prevent the first egg, which spattered on to Mr. Walsh as he stood to the attention. Immediately a number of students rushed the platform and Mr. Butler and Mr. Walsh were forced to the back of the stage. An ugly situation was avoided when they managed to slip out the back of the hall via the fire escape. The rush onto the platform took place just when one group of police went off duty and before they were replaced. Press and radio reporting of the meeting

Red China, they are now starting to increase their exports to the Soviet Union, while they also pour vast exports into Yugoslavia, Poland and Indonesia. And the Japanese, keen for some time to increase their exports to Red China, are making it clear that the de Gaulle initiative is not going to find them lagging in the campaign to capture the Chinese market. For the sake of the record we recall that immediately following the signing of the peace treaty with the Japanese, we predicted that the question of whether Japan could be kept out of the Communist orbit would depend upon whether the non-Communist world would provide Japan with an adequate outlet for her exports.

#### **Conflict Must Increase**

No matter how fierce the pressure to drive the non-Communist world into highly centralised regional blocs like the European Economic Community, and to "rationalise" their production in both primary and secondaryindustries in order to prevent "over production." a continuation of present financial and economic policies must drive these blocs into growing conflict as they attempt to solve their internal problems by exporting them. The Communists are determined to exploit this situation. They are scoring victory after victory, while the Western policy makers insist that it is "realistic" — in fact "inevitable" to intensify the export drive to the Communist bloc under the guise of "expanding trade." But true trade is an exchange of true surpluses between nations to their mutual advantage. What does Australia, Canada, Britain, America, or any other non-Communist nation want from the Communist nations? Not only do they want little or nothing; imports corresponding with their flow of exports would be disastrous because it would upset their "favourable balance of trade."

Without going into the mechanics of the matter, the basic economic reality is that the non-Communists are now progressively subsidising the Communists; they are in fact receiving no real payment in exchange for their exported production. The fact that credits are being created and made available in the exporting nations to the producers merely masks the reality of sheer economic loss. A British report states that a group of London banks are making long-term credits available in order that Russians can purchase British production. These credits are created in Britain and can only be spent in Britain on British production. But when this is mentioned, someone says, "But isn't it true that the Communists are paying in gold?" A recent press item states that the Soviet put £250 million worth of gold on to the world market last year. The economic "experts" claim that this gold "strengthens" the non-Communist economies. Those who accept this dangerous nonsense are saying in effect that unless they obtain a comparatively useless yellow metal, dug out of the ground by slave labor in Soviet Russia, they cannot make use of their own local production. Acceptance of this nonsense and the jargon used to disguise

the truth — "gold imports improve our liquidity" — places the non-Communist world completely at the mercy of the Communist strategists.

## **Stop Subsidising The Enemy**

The non-Communists are now subsidising their enemies. They are not only subsidising the Communists' economies, enabling the Communists to shackle their victims even tighter, but they are rapidly placing their own economies at the mercy of the Communists, while in the process of competing to export they are destroying the very foundations of the free economy. The time has come to call the policy of subsidising our enemies by the correct name: treachery. Survival depends upon a halt being called, and a different type of policy being pursued in the non-Communist world before it is too late. Britain was saved from the Common Market threat by the efforts of the dedicated few. The British Commonwealth of Nations can now take the lead in demonstrating how to exchange genuine surpluses amongst themselves, and to strengthen their free economies without seeking Communist markets. To suggest that such a policy is impossible is to submit to the very philosophy of determinism taught by the Communists. This means death. Those opposing death must oppose present policies of treachery.
