EDITORIAL

A NEW PHASE IN THE WORLD CONSPIRACY

Lenin is quoted as having said that international socialism was impossible without an international economic system. This international economic system is in process of being brought into being. And an international financial system is the main mechanism being used to further this process. We recently observed that growing "trade" between the non-Communist and Communist nations was in fact mainly a policy of subsidizing the Communists by the non-Communists, the realities of the situation being obscured by financial orthodoxy. Now comes President Johnson's dramatic announcement that there is an open shift in American policy towards the Eastern Europe members of the Communist bloc. This is an intensification of the drive towards World Government.

One of our more unpleasant, self-imposed duties is a careful reading of Walter Lippman, the American oracle whose articles are syndicated throughout the world. Lippman often reveals in advance what is likely to happen on the international scene. It is not only that Lippman's sources of information enable him to indicate future developments; he in fact agrees with these developments and uses his standing to make them appear both "progressive" and "inevitable". It is not widely known that Walter Lippman was one of the earliest Fabian Socialists in the U.S.A., and that since his student days at Harvard University, where he rubbed shoulders with well-known revolutionaries like Felix Frankfurther, he has persistently supported the Fabian technique of gradualness. It is the Fabian technique, which at the moment is even more dangerous to the Western world than open Communism. It is in fact masking the real Communist advance.

"The Opening of Eastern Europe"

In recent articles Lippman prepared his readers for what President Johnson has now formally announced. He described his visit to European capitals and wrote of "the opening of Eastern Europe to the West and of Western Europe to the East; in short, the breaking of holes through the iron curtain". Now President Johnson announces that U.S.A. policy is to "build bridges across the gulf that has divided us from Eastern Europe". These would be "bridges of increased trade, ideas, visitors and humanitarian aid". President Johnson did not, of course, point out that these bridges would be mainly carrying a one-way traffic. For example, it has already been made clear that the big increase in "trade" with Rumania will consist mainly of American exports of synthetic rubber plants and similar items, financed by American credits. The kind of ideas coming across the "bridge" to the U.S.A. will be similar to those which the Communists have been exporting for some time: that increased "trade" between the Communists and non-Communists will "ease world tensions". And the Fabian Socialists everywhere are skilfully furthering the idea that the Communists are now becoming more "moderate", and that as it is "inevitable" that the non-Communist economies must become progressively more Government planned, it is therefore possible for the two blocs to merge in creating a

worldwide system. Starry-eyed idealists are also extremely useful to keep people from realizing that what is happening is the progressive concentration of all power on a world scale.

In order to make the new shift in American policy more palatable, not only to the Americans, but also to other peoples, President Johnson did state that the United Nations remained "unalterably committed" to the defence of its Western Allies. But he then went on to say that this objective could be obtained more quickly "by the wise and skilful development of relations with the nations of Eastern Europe". This is dangerous double-talk. It ignores the truth that ever since Khrushchev came to power, Communist strategists have successfully applied the principle that the West's resistance to the Communist advance could be more quickly eroded by presenting the Communist bloc, not as a monolithic unity under rigid centralized direction, but as a group of nations all pursuing "different" roads towards their common objective. This strategy has paid enormous dividends in siphoning off American and other Western economic aid for "different" Communism in Yugoslavia and Poland. Large dollar credits have been created and loaned for this purpose. Now President Johnson says that other Communist nations "are beginning to assert their identity". And this will therefore qualify them for the type of aid being given to Poland and Yugoslavia. It also helps to "soften up" Americans and others to applaud more exports to Khrushchev, who has also been changing to a "different" type of Communist.

First Essential is Defeat

The new phase in the world conspiracy prompts us to observe once more, as we have done increasingly in recent years, that while reform of the economic and financial systems is essential for the salvation of Civilization, and that while we will continue to make available the information showing the type of reforms necessary, and how they could be effected, there is no realistic prospect whatever of bringing in any reforms in the face of the juggernaut of centralized power threatening the world. This bid for centralized power has first got to be defeated. And this is primarily a political and military problem, with increasing Continued on page 4.

JAPAN BEING DRAWN TOWARDS RED CHINA

We have often stressed the important truth that politics are determined by economics just so long as most current economic and financial dogmas are accepted without question. The Communists understand this clearly. They must therefore be delighted with developing relations between Japan and Red China. In a parallel move to the Chinese Trade Fair, which opened in Tokyo on April 10, the Japanese sent a powerful trade mission to Communist China to help expand Japanese exports. Until recently Japan has been exporting only about £25 million per year to China, but it is anticipated that this figure will be at least tripled before long.

Also of significance is the recent report that tourist, cultural and educational exchanges between Japan and Communist China are increasing. Chinese-language classes in Japan are crowded. Japan is not confining its export drive to Communist China, but is also increasing exports to Communist North Korea and to Communist North Vietnam.

BRITISH TRIAL EXPOSES JEWISH NOVELISTS' LIE

A recent British trial highlighted once again the question of what is the truth about Jewish casualties in the last war. We have repeatedly pointed out that the number of Jewish casualties has been grossly exaggerated to serve political and other objectives. Students of history have pointed out that the famous book, *Exodus*, later filmed, by the Jewish novelist Leon Uris, is full of errors of fact and exaggerations. But it was not until Dr. Wladislaw Dering took legal action against Uris and the British publishers of the book, that it was revealed just how bad at least one exaggeration was.

Dr. Dering, now practising in London, was awarded the Order of the British Empire in 1960 in recognition of ten years service with the British Colonial Office. His action was based upon one paragraph in *Exodus*, which depicted him as a monster. It said that Dering had performed 17,000 surgical experiments on Auschwitz prisoners without anesthetic. In his summing up the judge, Sir Frederick Lawton, told the jury that "there was not a shred of evidence" to support the statement. During the trial it was clearly brought out that Dering had only been responsible for a little over 100 of the type of operations mentioned. Dering maintained that he had no reason to believe that anesthetics had not been used and he saw nothing untoward at any of the operations.

The jury found in favour of Dr. Dering, but the Judge ordered that both sides pay their own costs up until mid-March, and that Dering pay all court costs incurred by the defendants after that time. If there was "not a shred of evidence" to support a Jewish writer's statement, made in a book which has received such worldwide publicity, how

much evidence is there to support similar statements? What, for example, of the constant claim that millions of Jews were murdered in gas chambers in Auschwitz? Is it not true that Dr. Benedict Kautsky, a Jew, wrote in his book, *Teufel und Verdammte (Devils and Damned)*, published in Switzerland in 1946: "I was in the big concentration camps in Germany. However, I must establish the truth that in no camp at any time did I come across such an installation as a gas chamber."? Dr. Kautsky spent seven years in concentration camps, three of them in Auschwitz. Has anyone exposed this Jew as a fake? Then what is the explanation of his claim?

What about a statement made in the February 1956, issue of *Commentary*, official organ of the American Jewish Committee, describing Dachau as a "place of horror"? It reads: "The little box that had been the death chamber could not have held very many prisoners at once. There were only two openings, each admitting but a single corpse at a time to the oven of the crematorium." How could tens of thousands of Jews be cremated when the crematorium was only of normal size? Jewish exaggerations, such as that exposed in the *Exodus* trial, do not help, but hamper the Jews' own best interests.

COMMUNIST "MORALITY"

One of the most difficult aspects of persuading people to see the true nature of Communism, and its deadly threat to Civilization, is to demonstrate that Communist philosophy completely abolishes all standards of morality and truth. And yet the Communists have made their position strikingly clear. The basic Communist document, *The Communist Manifesto*, states that "Communism abolishes all truth, it abolishes all religion, and all morality, instead of constituting them on a new basis; it therefore acts in contradiction of all past historical experience."

If only sufficient Western politicians would examine Communist "morality," they would realise that they are wasting their time, and fostering dangerous illusions, by "negotiating" with Communists as if they were normal people.

ALGER HISS STILL ACTIVE

Alger Hiss, the top Communist espionage agent who was at one time a key policy maker in the American Government, did hot hide himself after serving his prison sentence. He has done lecturing tours and last year made an extended trip to England, France, Italy, Belgium, Holland and Spain. A recent report from an expert on subversion in the U.S.A. states that there has been an attempt to bring Hiss back into the Government service. While this appears incredible at first sight, the truth is that many of those associated with Hiss, and whose records leave no doubt about their Communist and pro-Communist records, are still in influential Government positions. Men like the notorious Dr. Oppenheimer have actually been reinstated after being listed as security risks.

FREEDOM TO DECEIVE By D. WATTS

He who abuses a privilege destroys that privilege. That is written in history. He who believes that he has rights that carry with them no responsibilities is at heart an unmitigated despot.

The writer of the leader in the *Sydney Morning Herald*, May 16, is highly indignant about the recommendations made by the South African Press Commission. He is fighting for his own clan, of course. Up the Mac Journalists! It would have sounded a great deal better if, with his defence of a "free; critical Press", he had mentioned, also, the obligation of journalists to recognize that freedom to tell the truth is a right, but freedom to tell lies is not. I cannot call to mind that the *Sydney Morning Herald* has ever done much protesting about the misuse of freedom by the Press.

According to the above-mentioned writer the Nationalist Party of South Africa has "elevated the racial prejudice . . . into a racist philosophy which is both immoral and wildly unrealistic". He asserts that the philosophy has been implemented with a series of enactments monstrously unjust to the African population (to be rectified by enactments monstrously unjust to the white population?) and that the Government has suppressed opposition aroused by these laws by abridging the rights and freedoms of all its citizens—and some more half-truths along those lines.

CALLING THE KETTLE BLACK

Very well, those are his opinions and especially his feelings. It is easy to say that any idea or action is immoral and wildly unrealistic; but those who supported the demonstrably immoral and wildly unrealistic policies that threw up the horrible atrocities of Congo and Angolia and the more recent ones, and the primitive, far from democratic governments of all countries under Negro rule, should not call the kettle black; and they might have the grace to wait and see how a policy different from their own disastrous one works out before mounting the pulpit. When it is pointed out that such countries as Ghana, Kenya, Tanganyika and Guinea are now governed as realists said they would be if ruled by Negroes, the plea is to give them time. Then why not, even if the South African form of government is not democratic according to the egalitarian recipe, give it time? Why is South Africa more damnable from the democratic point of view than countries even less democratic? I should like those whose idea of freedom is Negro tyranny to answer that. I know the answer—"The dear Negroes. The beloved Negroes. The heart has reasons that the mind cannot know."

PERSECUTION OF SOUTH AFRICA

It is romantic love of Idealized Negroes that causes many people, including many journalists, like a contemptible schoolmaster who indulges his personal likes and dislikes by making favourites of some of the pupils and victimizing others, to single out South Africa to execrate and persecute.

Persecute is not too strong a word; and there are those who would like to see the persecution carried to the cruelest extreme, who would rejoice to see inoffensive men, helpless

PROTECTION FOR INDUSTRIES IS NOT A PROBLEM

The Adelaide Advertiser of 25/4/64 carried an article by Mr. C. R. Kelly, M.H.R., pointing out that while a case could be made for "protection" of some industries, it was folly to foster uneconomic industry merely for the sake of "development". Three letters, which did not contribute any light, were published promptly. Another, which up to 12/5/64 had not been printed, appears below. Mr. Kelly seemed to recognize "cost" as the core of the trouble, but was astray on other points. We feel that if he follows up the clues given in the rejected letter, he will soon be in position to see the correct association of the factors involved.

To the Editor, The Advertiser.

Apropos the article "Protection For Industries", by G. R. Kelly, M.H.R., in the *Advertiser*, 25/4/64. It is true that few people think about the subject at all, but the thinkers seem fewer because of lack of opportunity to tell what they know. For the same reason, the solution, which has been known for at least 40 years, has gone unrecognized by the "authorities". It would heed more space than was allotted to Mr. Kelly to state fully the pros and cons of the case. The so-called "problem" is psychological rather than technical, arising from confusion of purpose and means.

The purpose of the human individual is "wisdom in the use of knowledge and skill". The only purpose of production is consumption. So, the sane reason for the economic system, with its machinery and automation, is to enable efficient consumption, that is to say, consumption for the minimum of real cost, which is known as work. There is more scope for growth of knowledge and skill outside of industry than in it. Efficiency of industry should open the door to the more abundant living, but crooked thinking keeps it closed.

Conventional economic theory is a carry-over from the past age of scarcity. Implicit in it is the idea that the purpose of machinery is to provide work for men in the making of it; and the purpose of a man is to work a machine. "Full employment" is the antithesis of "industrial efficiency", or maximum output with minimum of work. If the two were to operate simultaneously there would be a far greater stream of goods than producers and bureaucrats could consume without extravagance and waste. Even if they wanted to use the glut they could not do so because the buying power distributed in respect of it would be far below the total price value. By the same token they would not be able to buy imports in exchange for the exported glut unless there were a way of distributing purchasing power other than wages. A report from Melbourne today (Advertiser, 29/4/64) says that if Australia's manufacturing plant were fully used an extra 100,000 people would be able to produce goods worth £320m annually. For the producers to get the full return from their industry their money incomes would need to average £3,200 a year!

The purpose of export should be to pay for imports, which would have taken more work (cost) to produce locally. The actual purpose, in the present Gilbertian situation, is to make work. Wages received for producing a surplus (which

is a loss if we do not get equal value of imports in exchange) augment the buying power distributed for production of unexported goods. Thus, the money incomes for producing 100 units are required to clear, say, 80 units. At the moment, the exports for which Australia has received nothing are recorded as over £700m. The purpose of "protection" by tariffs is to assist in perpetuating the enslavement of individuals to the "system".

Our Reserve Bank is able to advance credit for roads, education, etc. Let this be done until the flow of credit equals the flow of production as measured by prices. Then, Australians can buy what they want of it including imports of equal value to exports: the excuse for tariffs will be gone. In the worthy aim for utmost self-sufficiency essential industries can be subsidized from the same source of financial credit, thus spreading the real cost, work, fairly. One thing to bear in mind is that within the present set-up financial cost is not a true reflection of real cost, work.
