EDITORIAL

THE INTERNATIONAL CONSPIRACY

The central feature of political and economic developments during this century has been the centralisation of all power at an ever-increasing rate. The logical end of this centralisation is World Government of some type. In the very nature of things, such a Government, irrespective of its label and who ran it, must be tyrannical. It would provide for a relatively small group of men complete power over all other men. Such a group would have reached the goal towards which many have struggled over man's long history: World Domination.

While many will agree that the world is moving rapidly towards a world tyranny, they accept this as an "inevitable trend," or as the result of people being merely ignorant about economic, financial and political policies, which result in centralisation. The suggestion of any type of conspiracy is met with scorn and derision. Those accepting the "conspiratorial theory of history" are paranoiacs who need medical treatment. This question of conspiracy or no conspiracy is the most important one confronting mankind today. How it is answered will decide man's future. If there is no conspiracy, if the disasters afflicting the world have like Topsy, "just happened," then obviously little can be done about the situation. The intelligent thing to do is to try to co-operate with the inevitable. But if there is a conspiracy, then there is hope that the principal conspirators can be exposed and dealt with.

After some 30 years of close study of this question, we have no hesitation in saying that the more we examine the political, economic and financial developments of this century, the more convinced we become that Civilisation is threatened by a long-term, conscious conspiracy. The fostering of the idea of "inevitable trends" is itself a tactic of the conspirators to help paralyse the individual will, and to undermine any belief that the individual may be able to reverse a "trend." We readily agree that there is plenty of ignorance and stupidity about. But the fools are only handy tools to be exploited by the knaves. Ignorance must be removed where possible. However, we beg leave to doubt whether an approach to remove the "ignorance" of Ho Chi Minh, Mao Tse-tung or any other Communist leader, would be of any value. C. H. Douglas has told of how early in his career he met some of the important international financiers in New York. There was no problem about "ignorance." These financiers were interested only in what Douglas proposed to do about his discoveries concerning the power of finance. Douglas also revealed his experiences with the Fabian Socialist leaders, the Webbs, who had their "ignorance" removed concerning the practicability of his financial proposals, but who then said that they did not like their purpose. The reason they did not like their purpose was

because they would place the individual outside the reach of the conspiratorial programme being promoted by the Fabian Socialists.

Three Revolutionary Strands

It is now clear that there are three main strands of the international conspiracy, all much more closely interwoven than was once realised. These strands are International Finance, International Communism and the International Fabian Socialist Movement. There is now available sufficient authoritative literature to prove to those prepared to face truth, that the Communists and the Fabians have consciously promoted long-term conspiracies. They have placed trained agents in key positions in Universities and Government Departments. As shown conclusively in Mr. Eric Butler's booklet, *The Fabian Socialist Contribution To The Communist Advance* (Price 4/6 from The Heritage Bookshop), the Fabians have provided the Communist conspiracy with vital support, particularly in the English-speaking world. The fact that many rank and file Fabians are opposed to the Communists (generally only to their methods) does not alter the fact that the two movements have been closely intertwined for nearly 100 years.

Apart from their agreement on policies for centralising power, the Communists and the Fabians have always been in complete agreement in support of centralising and inflationary financial policies. During the Great Depression they violently opposed any fundamental attack upon financial policy, advocating instead attacks upon limited, constitutional government and free enterprise. Central planning was allegedly necessary to solve the Great Depression, the result of the "unplanned" activities of the "wicked capitalists." Looked at retrospectively, it can now be seen that the Great Depression was a major revolutionary

Attack On Australian Flag: Following the attack upon the Canadian Red Ensign, which includes the Union Jack, we were not surprised when a few kites were flown in Australia suggesting that the time had come to get rid of all signs of our past colonial stature. "We should demonstrate our national maturity," runs the sophisticated argument. But this type of talk is in fact a sign of immaturity. We are reminded of the person who says that now he is grown up, he should make every effort to stress that he owes nothing at all to his parents.

It is most encouraging that there have been some immediate replies to the critics of the Australian flag. The Christian symbolism of the Union Jack has been stressed, one person stating that it is today the most Christian flag in the world. Perhaps that was why Canadian Prime Minister, Lester Pearson, and his associates, decided to haul it down. Every advertising expert knows the value of symbolism. An attack upon a nation's symbols is an attack upon that nation's soul, its traditions. A healthy, balanced nationalism is a splendid thing. But for a nation to become so obsessed about nationalism that it denies its past, prevents that nation from really matured growth.

Worldwide Inflation: Governments everywhere throughout the Western world are at present struggling with growing inflation. It is significant that all Western governments react to the menace in practically the same way; not one of them puts forward one original suggestion for ensuring that the national financial system serves the economic system. All talk about higher taxation and restrictive credit policies if inflation becomes too serious. The only conclusion is that all governments are "advised" by "experts" who are either ignorant, or who are deliberately advocating policies which can only be described as subversive. As first shown by C. H. Douglas, with subsequent events confirming what he said, the present economic system can only be kept operating with a progressive expansion of new financial credits, created by the banking system, for capital production. During periods of military conflict, the rate of credit expansion tends to be increased at a much greater rate than normally. This has been the result of the stepped-up American military campaign in Vietnam. This in turn has intensified the inflation problem. Steelworkers, amongst others, want higher wages in an attempt to maintain a falling standard of living. The Wilson Government in Britain is struggling with the same inflation issue. Everywhere the parrot cry is heard, "Both employers and employees must show more restraint." Restraint is certainly a virtue to be developed, but it is difficult to persuade those whose profits, dividends and wages are progressively losing their value, to practise "restraint."

What is required is a new scientific technique for ensuring that credit expansion does not inflate prices. For example, increasing wages in the usual manner merely

increases wage costs which must ultimately be recovered through higher prices. As these wage increases are generally financed out of new financial credits, it would be elementary to pass the increases on in the form of a National Production bonus *paid outside wages*. In association with this, a policy of national price-subsidisation could also be implemented. Real production costs per each individual item produced are falling with every technological advance. The individual should obtain the benefit as a shareholder in the nation, through lower prices.

Unless present financial and economic policies are modified, the non-Communist nations will progressively take on the characteristics of the Communist nations. We have no doubt that the Fabian Socialist economic "advisers" are well aware of this fact.

Canberra Minister's Totalitarian Outlook: Australia's Minister for Labor and National Service. Mr. W. Mc-Mahon, said in a recent paper of his read at an Adelaide University conference, that women, the disabled, Aborigines, and compulsorily retired people should all be pushed into national service so that Australia's large natural resources can be developed more rapidly. The development of natural resources simply for the sake of development, without any relationship to genuine human requirements or national interest, is a manifestation of the philosophy of economic sabotage which dominates both the Communist and non-Communist world.

We agree, of course, with Mr. McMahan when he talks about letting disabled people engage in useful economic activity. And if women genuinely want to engage in any activities outside their homes, there can be no objection to this, particularly in these days of labour-saving devices. But in far too many cases it is sheer economic pressure, which forces women into economic activities outside the home. And if inflation continues, this will help Mr. McMahan to achieve his objective of getting retired people back into the economic traces. "Full employment" from the cradle to the grave appears to be the ultimate objective. This turns the economic system into one of control, not one for serving the individual.

What About The Rule of Law?: Prime Minister Sir Robert Menzies waxed eloquent at the Commonwealth Law Convention in Sydney, stressing the importance of the rule of law. About the same time one of the Senators of the Prime Minister's own party, Senator R. Wright from Tasmania verbally thrashed the Government in the Senate for the shabby manner in which it had by-passed the Interstate Parcel Express Company (IPEC) when this organisation was preparing to appeal to the Privy Council against the Government's attempt to prevent it importing planes for air freight purposes. The Federal Government violated completely the rule of law, and it was refreshing to see it defeated in the Senate. The new Senate has now become a real force at Canberra, demonstrating its great value.

SIR WINSTON CHURCHILL'S FAMOUS ARTICLE ON THE JEWISH PROBLEM

When Mr. Eric Butler recently met Fabian Socialist University lecturer, Mr. A. Hughes, in a Melbourne TV debate on "anti-Semitism," he caused great consternation amongst his opponents when he quoted the views of Winston Churchill, who wrote in 1920 that there was a "worldwide conspiracy for the overthrow of civilisation," and that Jews had played a major role in this conspiracy. Mr. Hughes weakly suggested that Churchill had been misled by the White Russians concerning the Jewish influence behind the Bolshevik Revolution, and that as Churchill never mentioned the subject again, he had later changed his views. The truth is that Churchill was asked after the last war whether he wished to repudiate the views expressed in his 1920 article, and that he declined to do this. This is not surprising, as Churchill remained a staunch supporter of the Zionist cause, believing that it was a genuine alternative to Bolshevism. The heading of his famous article, which was featured in the "Illustrated Sunday Herald," London, of February 8, 1920, was "Zionism versus Bolshevism," with the sub-heading, "A Struggle For The Soul Of The Jewish People."

In the flood of material published about Churchill since his death, there has been no reference to his 1920 article. Because of this, and the fact that the article is one of great historical importance, we are republishing it. The cross-headings are those used in the original, but all emphases are ours.

Some people like Jews and some do not; but no thoughtful man can doubt the fact that they are beyond all question the most formidable and the most remarkable race, which has ever appeared in the world.

Disraeli, the Jew Prime Minister of England, and Leader of the Conservative Party, who was always true to his race and proud of his origin, said on a well-known occasion: "The Lord deals with the nations as the nations deal with the Jews." Certainly when we look at the miserable state of Russia, where of all countries in the world the Jews were the most cruelly treated, and contrast it with the fortunes of our own country, which seems to have been so providentially preserved amid the awful perils of these times, we must admit that nothing that has since happened in the history of the world has falsified the truth of Disraeli's confident assertion.

Good and Bad Jews

The conflict between good and evil, which proceeds unceasingly in the breast of man nowhere reaches such an intensity as in the Jewish race. The dual nature of mankind is nowhere more strongly or more terribly exemplified. We owe to the Jews in the Christian revelation a system of ethics, which even if it were entirely separated from the supernatural, would be incomparably the most precious possession of mankind, worth in fact, the fruits of all other wisdom and learning put together. On that system and by that faith there has been built out of the wreck of the Roman Empire the whole of our existing civilisation.

And it may be that this same astounding race may at the present time be in the actual process of producing another system of morals and philosophy, as malevolent as Christianity was benevolent, which, if not arrested, would shatter irretrievably all that Christianity has rendered possible. It would almost seem as if the gospel of Christ and the gospel of Antichrist were destined to originate among the same people; and that this mystic and mysterious race had been chosen for the supreme manifestations, both of the divine and the diabolical.

"National" Jews

There can be no greater mistake than to attribute to each individual a recognisable share in the qualities, which make up the national character. There are all sorts of men—good, bad and, for the most part, indifferent—in every country, and in every race. Nothing is more wrong than to deny to an individual, on account of race or origin, his right to be judged on his personal merits and conduct. In a people of peculiar genius like the Jews, contrasts are more vivid, the extremes are more widely separated, and the resulting consequences are more decisive.

A Home for the Jews

Zionism offers the third sphere of the political conceptions of the Jewish race. In violent contrast to international communism, it presents to the Jew a national idea of a commanding character. It has fallen to the British Government, as the result of the conquest of Palestine, to have the opportunity and the responsibility of securing for the Jewish race all over the world a home and a centre of national life. The statesmanship and historic sense of Mr. Balfour were prompt to seize this opportunity. Declarations have been made which have irrevocably decided the policy of Great Britain. The fiery energies of Dr. Weissmann, the leader, for practical purposes, of the Zionist project, backed by many of the most prominent British Jews, and supported by the full authority of Lord Allenby, are all directed to achieving the success of this inspiring movement.

Of course, Palestine is far too small to accommodate more than a fraction of the Jewish race, nor do the majority of national Jews wish to go there. But if, as may well happen, there should be created in our own lifetime by the banks of the Jordan a Jewish State under the protection of the British Crown, which might comprise three or four millions of Jews, an event would have occurred in the history of the world which would from every point of view, be beneficial, and would be especially in harmony with the truest interests of the British Empire.

At the present fateful period there are three main lines of political conception among the Jews, two of which are helpful and hopeful in a very high degree to humanity, and the third absolutely destructive.

First there are the Jews who, dwelling in every country throughout the world, identify themselves with that country, enter into its national life, and, while adhering faithfully to their own religion, regard themselves as citizens in the fullest sense of the State which has received them. Such a Jew living in England would say. "I am an Englishman practising the Jewish faith." This is a worthy conception, and useful in the highest degree. We in Great Britain well know that during the great struggle the influence of what may be called the "National Jews" in many lands was cast preponderating on the side of the Allies; and in our own Army Jewish soldiers have played a most distinguished part, some rising to the command of armies, others winning the Victoria Cross for valour.

The National Russian Jews, in spite of the disabilities under which they have suffered, have managed to play an honourable and useful part in the national life even of Russia. As bankers and industrialists they have strenuously promoted the development of Russia's economic resources, and they were foremost in the creation of those remarkable organisations, the Russian Co-operative Societies. In politics their support has been given, for the most part, to liberal and progressive movements, and they have been among the staunchest upholders of friendship with France and Great Britain.

International Jews

In violent opposition to this entire sphere of Jewish effort rise the schemes of the International Jews. The adherents of this sinister confederacy are mostly men reared up among the unhappy populations of countries where Jews are persecuted on account of their race. Most, if not all, of them have forsaken the faith of their forefathers, and divorced from their minds all spiritual hopes of the next world. This movement among the Jews is not new. From the days of Spartacus-Weishaupt to those of Karl Marx, and down to Trotsky (Russia), Bela Kun (Hungary), Rosa Luxemburg (Germany), and Emma Goldman (United States), this worldwide conspiracy for the overthrow of civilisation and for the reconstitution of society on the basis of arrested development, of envious malevolence, and impossible equality, has been steadily growing. It played, as a modern writer, Mrs. Webster, has so ably shown, a definitely recognisable part in the tragedy of the French Revolution. It has been the mainspring of every subversive movement during the Nineteenth Century; **and now at last this band of extraordinary personalities from the underworld of the great cities of Europe and America have gripped the Russian people by the hair of their heads and have become practically the undisputed masters of that enormous empire.**

Terrorist Jews

There is no need to exaggerate the part played in the creation of Bolshevism and in the actual bringing about of the Russian Revolution by these international and for the most part atheistical Jews. It is certainly a very great one; it probably outweighs all others. With the notable exception of Lenin, the majority of the leading figures are Jews. Moreover, the principal inspiration and driving power comes from the Jewish leaders. Thus Tchitcherin, a pure Russian, is eclipsed by his nominal subordinate Litvinoff, and the influence of Russians like Bukharin or Lunacharski cannot be compared with the power of Trotsky, or of Zinovieff, the Dictator of the Red Citadel (Petrograd), or of Krassin or Radek — all Jews. In the Soviet institutions the predominance of Jews is even more astonishing. And the prominent, if not indeed the principal, part in the system of terrorism applied by the Extraordinary Commissions for Combating Counter-Revolution has been taken by Jews, and in some notable cases by Jewesses. The same evil prominence was obtained by Jews in the brief period of terror during which Bela Kun ruled in Hungary. The same phenomenon has been presented in Germany (especially in Bavaria), so far as this madness has been allowed to prey upon the temporary prostration of the German people. **Although in all these countries there is many non-Jews every whit as bad as the worst of the Jewish revolutionaries, the part played by the latter in proportion to their numbers in the population is astonishing.**

"Protector of the Jews"

Needless to say, the most intense passions of revenge have been excited in the breasts of the Russian people. Wherever General Denikin's authority could reach, protection was always accorded to the Jewish population, and strenuous efforts were made by his officers to prevent reprisals and to punish those guilty of them. So much was this the case that the Petlurist propaganda against General Denikin denounced him as the Protector of the Jews. The Misses Healy, nieces of Mr. Tim Healy, in relating their personal experiences in Kieff, have declared that to their knowledge, on more than one occasion, officers who committed offences against Jews were reduced to the ranks, and sent out of the city to the front. But the hordes of brigands by whom the whole vast expanse of the Russian Empire is becoming infested do not hesitate to gratify their lust for blood and for revenge at the expense of the innocent Jewish population whenever an opportunity occurs. The brigand Makhno, the hordes of Petlura and of Gregorief, who signalized their every success by the most brutal massacres, everywhere found among the half-stupefied, half-infuriated population an eager response to anti-Semitism in its worst and foulest forms.

The fact that in many cases Jewish interests and Jewish places of worship are excepted by the Bolsheviks from their universal hostility has tended more and more to associate the Jewish race in Russia with the villainies which

are now being perpetrated. This is an injustice on millions of helpless people, most of who are themselves sufferers from the revolutionary regime. It becomes, therefore, especially important to foster and develop any strongly marked Jewish movement, which leads directly away from these fatal associations. And it is here that Zionism has such a deep significance for the whole world at the present time.

Zionism has already become a factor in the political convulsions of Russia, as a powerful competing influence in Bolshevik circles with the international communistic system. Nothing could be more significant than the fury with which Trotsky has attacked the Zionists generally, and Dr. Weissmann in particular. The cruel penetration of his mind leaves him in no doubt that his schemes of a worldwide communistic State under Jewish domination are directly thwarted and hindered by this new ideal, which directs the energies and the hopes of Jews in every land towards a simpler, a truer, and a far more attainable goal. The struggle, which is now beginning between the Zionist and Bolshevik Jews, is little less than a struggle for the soul of the Jewish people.

Duty of Loyal Jews

It is particularly important in those circumstances that the national Jews in every country who are loyal to the land of their adoption should come forward on every occasion, as many of them in England have already done, and take a prominent part in every measure for combating the Bolshevik conspiracy. In this way they will be able to vindicate the honour of the Jewish name and make it clear to all the world that the Bolshevik movement is not a Jewish movement, but is repudiated vehemently by the great mass of the Jewish race.

But a negative resistance to Bolshevism in any field is not enough. Positive and practicable alternatives are needed in the moral as well as in the social sphere; and in building up with the utmost possible rapidity a Jewish national centre in Palestine which may become not only a refuge to the oppressed from the unhappy lands of Central Europe, but which will also be a symbol of Jewish unity and the temple of Jewish glory, a task is presented on which many blessings rest.

THE DELUSIONS OF BUSINESSMEN

In a desperate but vain effort to preserve her business interests in Indonesia the United States of America sacrificed honour, pride, dignity, justice and people. She would have saved more of what she valued most had she sacrificed less of that which she considered to be expendable.

The majority of Americans, upright and sincere, is no more to be blamed for this than were decent, kindly Germans for the Nazi atrocities, or the likable, intelligent Russians for the frightfulness of the Stalinist regime; but just as the Germans, speaking of them, not as individuals, but as a people, allowed themselves to be carried away by a quality of mysticism which they found in Nazism, and as communists are by the same quality which they find in communism, so Americans are fascinated by the mystical quality of Business.

Mysticism is communication with a Universal Power through a sense of oneness with it; but whereas the spiritual mystic seeks oneness with a Divine Power, the materialistic mystic comes into oneness with Cosmic Powers. Through this oneness, spiritual or material Power and Possession are sought; and though Germany placed emphasis upon Power and America places it upon Possession while Russia places equal emphasis on both, the two always go together and he who desires one must have the other. Too much power bursts its human vessel and makes a man mad. It induces megalomania. Perhaps this is why the spiritual mystics placed so much importance upon humility.

Astute Financiers, But Poor Politicians

The international businessmen who used the U.S.A. as a tool and a screen have been drawn by their delusions of absolute power into mistaking success in bringing pressures to bear for political acumen, and so into believing that their political ability matches their business

ability, and that they can rule the world by the same methods as they rule their business organisations. Their madness makes a mockery of them. A man may be an astute financier or business executive and yet be a very stupid and ignorant politician; and the state of the world proclaims the political ineptitude of the international financiers who pulled the political strings. They understood money, but they did not understand human nature.

They did understand something about human material wants and human cupidity. Upon that little knowledge they built their policies. They knew that with their wealth they could buy politicians, but they never realised that a corrupt servant is a bad one. They thought that with money they could buy nations, but did not stop to consider that bribery by one party can become extortion by the other.

The reason why those simple facts escaped them is that at the time the financier international group set out, with the devil's prompting, to obtain dominion over all the earth, Soviet Russia's economy was in a bad way, so that it seemed that it was not possible for bribes to play off against the only group that had something to give. That is where these very powerful and very astute businessmen showed that they are, politically, in the infants' class. The Cosmic Universe is one of continual change and all things in it are inconstant. It is said that the Devil cheats those who bargain with him out of even what they were to have received in exchange for the priceless things they give; but it is not so much that the

Devil is a cheat as that the things, which those who have dealings with him ask, are, of their nature, perishable. Only those who are fools enough to imagine that the impermanent can be made permanent would build up their whole policy upon an impermanent situation. Certainly the international financiers were not unaware of the phenomenon of change; but, megalomaniacs as so many of them are, they believed that they could decree the shape of the changes, not realising that in order to bring about the ones that they planned, the basic situation would need to remain unchanged.

Factors Not Understood

The situation, which they planned to exploit, was a weakening, through the world wars, of once strong political governments together with a weakening of individualist influences upon political governments. Judging from events, the plot was to set up an economic world government in place of the political governments, which still had some power in the international sphere. In their stead were to be set up a large number of weak political governments, and these were to be the agents of the businessmen's international government.

Not only was Russia's ability to become a rival underestimated, but the relation between political and economic government was not understood. The two kinds of government, in human organisation, are in unity. When they act in a complementary manner the whole government is sound, but when one starves or crushes the other there is organisational deformity. One government is almost useless and the other is crippled by the helplessness of the supporting member.

Complexity as well as balance is a matter of importance. A highly developed and intricately organised business government cannot be secure or easy with a primitive, political government any more than a civilised political government can endure with a primitive economy.

It seems to have been planned that political governments were eventually to become not much more than helpful bystanders. Hence the setting up, with a great show of morality and idealism, of a large number of petty, independent States in Africa and other places and, at the same time, a determined attempt to destroy, also with a great show of morality and idealism, the independence of strong European governments with which may be classed the South African government.

It is not possible to isolate the political from the economic government; and there cannot be a strong economic government unless it is complemented by a strong political government.

Two Developments

There have been two quite predictable developments in the world. One is, as in Indonesia, the emergence of a political body strong enough to oust an economic government that is not its natural complement; and the other is the appearance of a rival strong enough to be able to

exploit the purposely created weakness of petty, political governments and so eat what the Western businessmen had cultivated for their own enjoyment.

What the politically inept megalomaniacs evidently intended to do next was to bring about a merger with the rival firm before they, themselves, were wiped out; and the concession that they would certainly have been obliged to make would have been to hand over, in fact though perhaps not on paper, the Western political governments to the Communist concern.

It seems that Soviet Russia is inclined to think that a merger with China and an eventual complete wiping out of both the political and economic governments of the West would be a better arrangement; and so it would be for her if she can bring it off. The self-defensive action for the Western business government, now, is quite plainly to strengthen Western political government to give itself support; and this may involve a stricter political government by the stronger Powers over those bawling baby governments that have so recently been set up. Whether the Western financiers are intelligent enough to see that is, in view of past performance, in some doubt.

At all events, the time is coming when particular businesses now dependent upon international organisation will need to take up some of the burden of preserving themselves; and it behoves executives to come out of their business shells and have a look at the big, wide political world.

GOLDWATER'S POPULARITY

An American report says that electoral surveys reveal that Barry Goldwater now commands more electoral support than he did at the Presidential contest last year. The conservative elements in the Republican Party are determined to have another genuine conservative candidate at the 1968 Presidential Elections. The Congressional Elections next year should prove a reliable pointer to how the grass roots upsurge is developing in the U.S.A.

assault upon Western Civilisation. Both the Fabians and the Communists welcomed the opportunity of advancing their programmes. Now, as the Great Depression was worldwide, and the result of a policy of credit restriction initiated by Wall Street and forced upon all the major nations through their central banking systems, there is little doubt that this was a deliberate act by powerful individuals who knew what they were about.

Consistent Financial Policies

While there is adequate documentary evidence concerning the Fabian and Communist conspiracies, similar evidence is not so readily available concerning International Finance. However, certain policies, such as that which produced the Great Depression, can be examined. The very consistency of these policies cannot be explained away by references to "ignorance." The members of the great international banking house of Kuhn, Loeb and Co. surely knew what they were about when they made available enormous sums of money for the Communist revolution in Russia. Members of the same group, some blood relations, dominated the disastrous Versailles Peace Treaty after the First World War, "representing" both the victors and defeated. They supported Roosevelt and his Socialist New Deal. Are we to believe that Ernest Cassel, Rothschild and others who helped to finance the London School of Economics for the Fabian Socialists, did not know what they were doing?

But perhaps the most convincing piece of evidence concerning the nexus between International Finance, International Communism, and International Fabian Socialism, was provided at the Bretton Woods agreements, which resulted in the further consolidation of power by International Finance. The principal architect was top Communist agent Harry Dexter White, assisted by leading Fabian Socialist J. M. Keynes. The Communists and Fabians united in supporting urging all Governments to endorse the Bretton Woods agreements as quickly as possible. Such concerted activity was only possible because of the development of worldwide conspiratorial movements.

As the world is forced towards the ultimate objective of One World, it becomes progressively easier to see the development of a common pattern. This in turn makes it easier to direct people's attention to the fact that behind this common pattern of development is a common policy, and that the very consistency of this policy, in the face of the disastrous results being produced, leaves no doubt that Civilisation is grappling with a diabolical conspiracy. We have no doubt that there are many trials and tribulations ahead, but compared with even a few years ago, it is heartening to note the number of people who understand that International Finance and International Socialism (both the Communist and Fabian varieties) are but the two sides of the same revolutionary coin.

THE CURSE OF SPEED

A London subscriber writes:

"May I draw your attention to a pernicious practice used by the B.B.C. speakers in the method they operate concerning the extracts from weeklies and other information? Some speakers go on for about 15 minutes at high speed without break; also to maintain the speed, by relay of speakers, also without a break. The effect of this method surely must tire and confuse listeners of middle and old age, if subject to this experience long enough. Now the middle-aged specially, and the elderly, who are or should be more sober, experienced and possibly more wise, will suffer from mental indigestion. No doubt our opponents recognise the value of this method of confusion.

"The curse of our times is speed. The physical is devastating in all conscience, but when applied to the mental, it is death to upward progress . . . Our opponents' excuse will possibly be that they have so much to broadcast; they are compelled to operate this method. But surely there is enough bilge broadcast to allow double time for the weeklies, etc."

Not only is there a torrent of spoken words directed at people today; there is also a torrent of written words. The tendency is to drown out what is of value, to turn everyone into a mental moron. Today, more than ever, there is a necessity for people to be more discriminating in what they listen to and read.

THE OMINOUS ROLE OF LEE KUANG YEW

The Prime Minister for Singapore, Mr. Lee Kuang Yew, may only be a "dedicated Socialist" and a "non-Communist," but his every action furthers major Communist strategy in South-East Asia. The major objective is to force the British out of their Singapore base, the most important in the whole Eastern Hemisphere. The Singapore Prime Minister has threatened the British with an end to their base within 24 hours if they engaged in "aggressive wars." Mr. Harold Wilson's Left-wing have immediately reacted by increasing their campaign for Britain to stop all military support East of Suez. Australia and New Zealand would be left to the mercy of the American policy makers who are now attempting once again to increase vital support to Communist tool Sukarno. The suggestion is uranium as an olive branch!
