**EDITORIAL** 

### The Unholy Wall Street — Moscow — Peking Alliance

A recent two-page Soviet advertisement in the "New York Times," the first of its kind, appealing to American businessmen to devote serious attention to exporting their products to the Soviet Union, is the latest example of the Communists insidious exploitation of the export-or-perish fetish which so dominates the non-Communist world. The Communists are also aware that Wall Street and other financial groups in the West are keen to foster increased exports to the Communist Empire. The current development provides further striking evidence of the nexus between International Communism and International Finance. This nexus has existed from the days when the Wall Street group of Kuhn, Loeb and Co. helped to finance Lenin and Trotsky to power in Russia.

One of the world's leading authorities on the Communist conspiracy, Louis Budenz, a top American Communist for many years, who was managing editor of the Communist Daily Worker from 1940 to 1945, has observed that "it is much more profitable in America to side with the Morgan-Rockefeller interests of Wall Street and the general camp favouring a detente without reservations with the Soviet world." At present the Wall Street financial groups are openly advocating increased exports, not only to the Soviet Union, but also to Red China. The viewpoint of these groups, who vigorously organised to defeat Senator Barry Goldwater's bid for the American Presidency in 1964, is always expressed through the New York Times, a journal that consistently preaches "peaceful co-existence." It was not without significance that Hanoi selected the New York Times to send its representative Mr. Harrison Salisbury to North Vietnam so that he could be used to open a new phase of Communist psychological warfare against the non-Communist world.

### THE CAUSE OF THE EXPORT FETISH

In his analysis of the modern finance-economic system, the author of Social Credit, C. H. Douglas, stressed that unless financial policy was drastically modified, the economic system could only work while there was a progressive expansion of new financial credits for capital expansion and a constant drive for a "favourable balance of trade." The intensive campaigns to discover overseas markets are not designed to pay for urgently required imports, but to try to help overcome a deficiency of purchasing power in the domestic market. A "favourable balance of trade" simply means that over any given period more production is exported out of a country than is imported. So long as this fetish is persisted with, it distorts a nation's foreign policies, as witnessed by

the case of Australia exporting vast quantities of wheat and other production to the Red Chinese enemy. This is justified on the grounds that it is "good for business." What would Australia's attitude towards Rhodesia be if Australia had been exporting enormous quantities of production to that country? It would probably be the same attitude which Mr. Harold Wilson has towards South Africa, whose policies Mr. Wilson loathes, but whose markets help Britain in her export drive.

#### THE WEST'S ACHILLES HEEL

The export-or-perish mania, the product primarily of an unrealistic financial policy, is the Achilles heel of the West, and is driving it relentlessly into suicidal policies which, if persisted with, make the arrival of some type

### **NEWS COMMENTARY**

### **Dangerous Pacific Common Market Concept:**

News Weekly of January 18 commends the attitude of the Associated Chambers of Manufactures for its recent appeal to Australian businessmen to make a greater effort to understand their growing Asian customers (a laudable enough object in itself), and then goes on to suggest that this represents "a significant development of thinking in the business community toward a goal originally suggested by the Democratic Labor Party—that of a Pacific economic and defence community, on the lines of the European Common Market, which was first advanced, some years ago, in the columns of News Weekly."

The DLP talks a lot at times about decentralisation, but in supporting the type of Common Market concept operating in Western Europe it is advocating the most vicious form of centralisation, one which concentrates economic and political power and destroys the rights and traditions of local communities. Originally it was suggested that the European Common Market was both a tremendous success economically and a firm barrier against Communist expansion. There has been progressively less talk about the barrier against Communism as the Common Market countries attempted to solve their growing domestic problems by greater exports to the Communist Empire.

So far from the Common Market being an economic success, its economic problems are mounting rapidly. The much-publicised West German economy has experienced inflation and is now suffering from depressed conditions in many sectors. Two out of every three foreign workers who went home from West Germany at Christmas will not be returning. There has been growing friction between German and non-German workers as unemployment grew.

Australia's basic problems will not be solved by becoming part of a Pacific Common Market. But such a policy could lead to a drastic reduction in Australia's sovereignty. And the erosion of the immigration policy, which has ensured that Australia has a homogenous community. It is a great pity that so many DLP policies are so superficial and dangerous from a long-term point of view.

### **Economic Refugees from Communist Empire:**

A Press report states that during 1966, refugees from European Communist countries increased by 350 per cent over 1965. The report states that "most said they had not left their homes in Hungary, Czechoslovakia, Poland or Bulgaria for political reasons, but because inflation was eating away their savings." This is a most revealing piece of information. Compared with the Communist nations, these refugees will, of course, experience material conditions much better in the non-Communist nations. But inflation is not confined to the Communist nations, and these refugees will find

that the West is progressively moving towards the type of society from which they escaped.

### Australia Rejects UN Demands on New Guinea:

It is instructive to note how nations tend to ignore "world opinion" as expressed through the UN when their own vital interests are threatened. Following the UN General Assembly motion—initiated by the African slum known as Liberia—urging self-rule for Papua-New Guinea, the Australian Minister for Territories, Mr. Barnes, said Australia would pay no heed to the motion. He said: "Australia had no obligation to pay regard to resolutions passed by the UN in disregard of the situation in the territory and everything that is known about the wishes of the vast majority of its inhabitants." This is exactly the attitude of Rhodesia towards the UN. As Australia has rejected the UN motion on Papua-New Guinea, why does it feel that it needs to heed this subversive international organisation on Rhodesia? Perhaps the time will come when the UN will impose economic sanctions against Australia because of its failure to introduce self-rule in Papua-New Guinea immediately! Which might not be bad thing, forcing Australians to forget the export-or-perish myth and concentrate upon a realistic development of their own economy.

### World Bank moves into Papua-New Guinea:

A World Bank mission is coming to Australia to discuss loans for development in Papua-New Guinea. After discussions in Canberra, World Bank officials will move to Papua-New Guinea. A press report states that the Federal Government is keen to obtain World Bank support in order to intensify Papua-New Guinea development in the face of mounting criticism at the UN. Such development will not halt this criticism. And development through debt-finance from the World Bank will make a mockery of talk of independence. It would be instructive to know what type of real capital is required for Papua-New Guinea development, which is not available in Australia. Most of the drive to provide capital for the "underdeveloped" nations of the world is based upon the urge to try to find new export markets for the highly industrialised nations. Top Communists have said that this type of development aids their revolution. There have been some appalling results already from

### Zionists smear another prominent Jew:

In 1965, Mr. Moshe Menuhin, father of the famous violinist, Yehudi Menuhin, wrote a very important and informative work entitled The Decadence of Judaism in Our Time. Mr. Moshe Menuhin had become completely exasperated by the activities of the political Zionists amongst the Jewish people. His book was presented very moderately. In a revealing article in the Summer, 1966, issue of *Issues*, a journal published by the American Council for Judaism, Mr. Menuhin writes under the heading, "The Stifling and Smearing of a Dissenter": "I knew very well of the existence of a well-oiled and powerful Zionist network of publishers, editors, religious leaders of all faiths, politicians and hosts of paid and unpaid 'professional Jews.' I also knew that the Zionist machine was devious, omnipresent and seemingly omnipotent. But I still was not prepared for what did happen; in a very short space of time after the publication of my book, a nation-wide assault—invisible, underground and highly organised—stopped my book in its tracks, stifled every move I made and left me isolated, crushed and my character assassinated."

Mr. Menuhin charges the political Zionists with "unconsciously imitating the racist super-nationalism of their oppressors in Czarist Russia and Nazi Germany." Needless to say, Mr. Menuhin is "anti-Semitic."

#### Harold Wilson's real Rhodesian policy:

When Prime Minister Harold Wilson failed to force the Rhodesians to a complete surrender on H.M.S. Tiger in December, he not only then threw the Rhodesian issue to the revolutionaries at the UN, but announced that there must now be "majority rule" in Rhodesia BEFORE he would accept Rhodesian independence. While he was pretending to negotiate with the Rhodesians, the Fabian Socialist Wilson insisted that he had no intention of requiring majority rule immediately, which he admitted would be undesirable and dangerous. But now he reveals his real purpose: to turn Rhodesia into the type of charnel house, which is so familiar in "liberated" Africa.

We do not believe, of course, that Wilson is other than a tool of the revolutionary forces, which understand the great strategic significance of Africa. We would agree with the following summary in *Weekly Review* (England) of December 16: "It is to be doubted whether Mr. Wilson and his government even now fully realises all the implications of the course they have set. If Mr. Wilson seriously hopes that he will be able to control events from now on, this service does not share those hopes.

"The conflict will develop a momentum of its own, and there are more than enough malevolent forces at work in the U.N. and elsewhere to ensure that it is speeded on its way. Nearly seven years ago, Mr. Macmillan delivered his "Winds of Change" speech in Cape

Town. From that moment on the collision course was set.

"One is tempted to despair of the so-called statesmen of London and Washington. They seem incapable of realising that the course of action they have now taken may well involve the southern third of the African continent—and the 30,000,000 people who live therein complete disaster.

"But there are enough evil forces which DO understand the real issues involved—which are far, far bigger than Rhodesia itself and involves not only the future welfare of 30,000,000 people (black and white) but big strategic factors vital to the whole Free World.

"Those evil forces will work night and day to bring about complete catastrophe."

### IN DARKEST AFRICA

At last some first hand evidence is coming out of Southern Sudan. The Arabs in the north initiated a policy of butchery against the Christians and African pagans in the south. It is now estimated that the population of Southern Sudan has been reduced by about one-third in the past two years. This means that something like one million people have either died or fled the country. Burning, looting and wholesale killing has turned large areas into a depopulated wilderness. In Khartoum the politicians maintain their pretence of a "little local difficulty." The Sudan was "liberated" from the British in 1956.

### THE CREATION AND EXPLOITATION OF RACE MYTHS

While there is increasing propaganda insisting that all men and races are equal, and that the world should be run on the basis that this is true, it is becoming more obvious with every day that passes that no satisfactory social and political structure can be erected on what is in fact a falsehood. There is a direct relationship between race and politics, in the same way that there is a relationship between people and the soil on which they live, as observed by C. H. Douglas in his "Land for (the Chosen) People Racket."

Because of the importance of this subject, and the manner in which it has been deliberately confused by what passes for science, we are starting in this issue to publish extracts from Mr. Eric Butler's paper delivered at the 1966 Australian Leagues of Rights seminar.

The term "racist" is today one of the most deadly of the many smear words used by the totalitarians of all types. The term is never defined so that the victim of the charge of "racism" may disagree and defend himself. It presumes automatic condemnation without any argument or trial. The comparatively successful use of the term is a tribute to the effectiveness of a form of psychological warfare which discourages a realistic examination of one of the central dogmas of Communism: that not only all individuals, but also all races are inherently equal. There are large numbers of people who term themselves anti-Communists but who on this subject, as with many others, unconsciously accept the Communist view. To these people the African, for example, is the same as a European—except that he has stayed out in the sun a little longer. All that is necessary is to provide the African with a Cambridge University education, dress him the same as a European, and he will be exactly the same as a European. It is simply a matter of adjusting environment to produce the same type of human being who can be readily fitted into the centrally planned State, and ultimately, into the one centrally planned world.

The equalitarian dogma is the very essence of Communism. If we accept Communist propaganda, Communists visualize a perfect society in which by controlling environment and the educational system, all individuals, being basically the same, will have such perfectly adjusted personalities that they will live in everlasting peace and harmony. The equalitarian dogma insists that any differences between men are primarily the result of environment, not the result of heredity. If the Communist view of man were true, then, of course, it would be immoral and irrational to oppose it. But although, as we will see, it is not true, the collectivists have so successfully presented propaganda on this subject under the guise of science that those who oppose the equalitarian dogma are termed immoral. Those who stress the vital importance of hereditary factors governing, for example, intelligence, are smeared as fanatics allegedly advocating that human beings be bred like stud cattle. But in reality it is the collectivists who downgrade the human being by claiming that by centralised control of his environment, he can be turned out in a common mould like peas from a pod. It is only in a genuinely free society of responsible individuals

that excellence and quality are possible. Equality really means no quality. The free society is also necessary for the preservation of the elite of a civilization, without which civilization cannot be maintained. But to the collectivist those who have succeeded under freedom are "oppressors," while men, races or nations, which have not succeeded, are allegedly "underprivileged." The logical consequence of a philosophy, which denies any natural superiority to those who have succeeded under freedom, is necessary central government control to change the social and economic system so that there is no quality, only equality. Without the dogma of equalitarianism, the Communists and other collectivists would stand openly condemned of being blatant conspirators determined to punish all excellence and to prevent mankind from developing its highest potential. It is much easier to sell slogans about the "equality" and "brotherhood" of man.

In The Great Deceit, by Zygmund Dobbs, the following appears: "The bending and twisting of academic subjects to fit socialist purposes is the prime purpose of all convinced socialists. This has been the case particularly in Social Anthropology, History, Economics, Jurisprudence and Sociology. The socialist dogma requires that all scholastic categories be made to serve socialism and not the cause of scientific truth." This paper is primarily concerned with the twisting which has been done in the field of Anthropology.

Back in 1922, the eminent American sociologist, Lothrop Stoddard, observed in his great classic, *Revolt Against Civilization*, "The ideal of Natural Equality is one of the most pernicious delusions that has ever afflicted mankind. It is a figment of the human imagination. Nature knows no equality. The most cursory examination of natural phenomena reveals the presence of a Law of Inequality as universal and inflexible as the Law of Gravitation."

Stoddard was speaking as an objective scientist, not as a political propagandist. But in recent years political propagandists, masquerading as objective scientists, have sought to further their political objectives by perverting science. This is a serious accusation, but it is supported by an enormous amount of irrefutable evidence. Nathaniel Weyl and Stefan Possony made the accusation as follows in their work, *The Geography of Intellect*: ". . . American psychologists and sociologists have accepted the

dogma of equality and proclaimed, not merely that members of different races should all have the same 'rights' (an entirely separate question), but that they are innately equal in all forms of mental capacity as well. Having placed themselves in the vanguard of an ideological movement proclaiming absolute equality, a very large group of American psychologists and sociologists chose to sacrifice scientific objectivity to their political and propaganda purposes."

#### COMMUNIST BACKGROUND OF FRANZ BOAS

The story of the perversion of the sciences concerning race starts late last century, primarily with one Franz Boas, mentioned briefly in my *Fabian Socialist Contribution to the Communist Advance* (p. 27). Born of Jewish parents, Boas was a product of the influential German Socialist movement. His parents were Socialists and strong supporters of the Communist rebels of the German revolution in 1848. One of Boas's aunts married Dr. Abraham Jacobi, a member of Karl Marx's Communist League. After serving a sentence in gaol for armed revolutionary violence, Jacobi, a medical doctor, migrated to the U.S.A. and lost no time in actively promoting Marxism.

Karl Marx himself had personally prepared the way for Jacobi in the U.S.A. with letters to his U.S.A. agent, Joseph Wedmeyer. Marx used Jacobi to test the loyalty of German migrants to Socialism and their ability as revolutionaries. Boas therefore had many contacts in the U.S.A. to assist him carry on the family Socialist tradition. His career was a remarkable one. He arrived in New York in 1877 and the next year was installed as Doctor of Anthropology at Clarke University. It was Boas who issued the first Ph.D. in Anthropology in the U.S.A., in spite of the fact that there was no evidence whatever that from a formal academic point of view Boas was entitled to describe himself as an anthropologist.

Boas started to make his big impact in the U.S.A. when in 1899 he was appointed to the chair of anthropology at Columbia University, New York, a position he held until 1936. At Columbia University, Boas immediately joined forces with the Socialist sociologist Franklin Giddings, a man termed as a sociologist, anthropologist and political scientist. Columbia University was a hotbed of Socialism. Boas's biographer, Melville Herskovits (1953) wrote of him as follows: "The tenure of his professorship at Columbia gave a continuity to his teaching that permitted him to develop students who made up the significant core of American anthropologists, and who came to man and direct most of the major departments on anthropology in the United States." From his base at Columbia University, Boas not only perverted the science of anthropology to serve his Marxist objectives, but also aided Marxist front organisations like the National Association for the Advancement of Colored People.

### THE USE OF FRONT ORGANISATION TECHNIQUE

Many people believe that the front organisation technique originated with Lenin, but in fact it was an old Marxist technique. The National Association for the Advancement of Colored People was created by a number of Socialists in 1909. Two of the most prominent of these Socialists were Mary White Ovington and William English Walling. Franz Boas readily agreed to assist the N.A.A.C.P. by providing anthropological support, the line being taken by this Socialist-inspired organisation. Boas was not without his difficulties in attempting to prove his teaching that cultural environment is the dominating factor in developing mankind. He was forced to admit, "The anthropologist recognises that the Negro and the white represent the two most divergent types of mankind." He also had to admit that "It is true that the average size of the Negro brain is slightly smaller that the average size of the brain of the while child." However, Boas insisted that these differences could be overcome by race mixing.

As the Boas strategy developed, a series of Socialist fronts were established for the purpose of fostering the concept of environment being basically responsible for any differences between races. One example of this type of activity was a Greenwich House Committee on social investigation, which sponsored a book by the Socialist Mary White Ovington of the N.A.A.C.P. with a foreword by Boas. There were the Du Bois Clubs, formed to offset the work of the great Negro leader, Booker T. Washington, who attempted to show his fellow Negroes that instead of permitting themselves to be led by political agitators into blaming the whites for their lot, should set about developing themselves in accordance with their own innate abilities and characteristics.

The tactics of Boas and his supporters were so successful that under the auspices of so-called science they were able to spread Socialist influence right throughout the U.S.A., and eventually right throughout the world. The publications of the United Nations Cultural and Educational Organization (UNESCO) further the Boas line on race and, of course, naturally meet with the enthusiastic support of the Communists. Like all Socialists, supporters of Boas's teachings have used typical totalitarian methods to destroy and to silence those scientists who insist that there are basic differences between races and that these should be studied in a genuine scientific spirit.

#### ANTI-EQUALITARIAN SCIENTISTS TYRANNISED

The eminent American publisher, Mr. Carleton Putman, records in his book *Race and Reason* of how, after thoroughly investigating the manner in which the Socialists had twisted anthropology to serve their equalitarian dogma, he had approached a number of professional scientists. Putman records that he found plenty of these scientists who agreed with him. "And I discovered

something else. One prize-winning northern scientist whom I visited at his home in a northern city asked me, after I had been seated a few minutes in his living room, whether I was sure I had not been followed. Another disclosed in the privacy of his study he had evidence he was being checked by mulattoes at his lectures. All, when first approached, were hesitant, withdrawn and fearful, and the reason was not far to seek. Their employers on whom their livelihood depended the universities, the museums, and the foundations were either controlled by equalitarians or were intimidated by the race taboo. The scientists, whom these institutions employed, if they ever were to hint at the truth, must do so deviously, under wraps over wraps, half seeming to say the opposite. But as they grew to know me they gave me facts without varnish. In long conversations and letters they provided confirmation I needed. Many were internationally known. Some had received the highest prizes."

One prominent American psychiatrist wrote to Putman as follows: "Where in the U.S. could a psychologist, sociologist, or anthropologist, find employment if he openly and unreservedly espoused the theory of the racial inequality of man?" A Professor of Anthropology from the American South wrote: "It can be documented ad infinitum that the social and biological sciences in Anglo-American countries, for the past half century or so, especially since the 'twenties, have strenuously and studiously avoided any research that could have thrown light on genetic differences between races and ethnic groups. That this avoidance and suppression, this discouragement of graduate students who might have been curious and interested in such research, was done in the name of egalitarian ideology, in full knowledge that it was unscholarly conduct, has been admitted, in print, among themselves, by some of our most prominent social scientists."

### **WARBURGS AND HITLER**

At long last there has come to light in Europe a document which has been discussed amongst knowledgeable people over the years, but which was significantly suppressed at the Nuremberg Trials. The quarterly magazine, *News Digest-International*, No. 3, 1966, published a photo of the document, which reveals the signature of M. Warburg along with that of Hitler on the document appointing Schacht as the German Finance Minister. This document provides further evidence of the association of the Warburg financial group with the National Socialist movement in Germany. The Warburg group was also associated earlier with the financing of the Bolshevik Revolution. It is interesting that the Soviet Union cooperated with the Western powers in suppressing the information about Warburg at the Nuremberg Trials.

### INTOLERANCE AND FLUORIDATION

In Australia we have recently had a graphic demonstration of what can happen when the highly toxic poison sodium fluoride is mishandled.

The three valuable racehorses, which died in Sydney last year as a result of being drenched with sodium fluoride in mistake for a harmless drench, should have an epitaph honouring their contribution towards preventive medicine. No matter how salient the lesson it does not seem to penetrate the thinking of those obsessed with some form of megalomania such as Dr. Proud of the Toorak branch of the Australian Dentists Association.

Following this incident and in commenting on the decision by some Victorian shire and city councils to issue free fluoride tablets to those requiring them, he called for the fluoridating of public water supplies as the only answer to the problem of dental caries. It was evidently not enough for the doctor that even in the "free pill" scheme a cardinal principle of freedom is destroyed when those not in favour of fluoride as a cure-all for dental caries are forced to subsidise those who do.

The following comment from Housewives Today in England indicates they have the same breed operating there.

It is one of today's paradoxes that many of those who proclaim the need for a greater tolerance, when advancing their own peculiar causes such as legalised abortion, homosexuality, subsidised stage pornography and the abolition of hanging, react with the greatest intolerance, when dealing with other people's, perhaps simpler, cherished beliefs. In no field is this more vividly demonstrated than in the current drive by the health authorities to add fluoride to the nation's water supplies.

Many people hold, with every sincerity, that fluoridation is utterly wrong. They believe that mass medication

is quite different from mere purification, and that it is thoroughly objectionable in principle; additionally, in practice, they regard fluoridation as wasteful because less than 1 % of water is drunk, (and of what is drunk less than one-sixth is drunk by the only category supposed to benefit—children up to 10 years old); and dangerous because, first introduced in North America in 1945, twenty years is an insufficient period for proving that this poison has no later, and unsuspected, ill effects to offset the proclaimed benefits.

For that greater majority who take—and have taken—no real interest in the matter, there could be no more useful exercise than to read the Ministry of Health 1965 green booklet "Fluoridation", and also "Fluoride—Facts and Fancy" by the National Pure Water Association. But if they do, and give voice to the conclusion that many previously disinterested folk have reached—that the case for fluoride, to put it at its mildest, is far from convincing—then the fun begins.

Even if they happen to be Dean of a Dental Faculty, Professor of Dentistry, Professor of Pharmacology or Professor of Chemistry, they are liable to be airily dismissed by that notable expert on so many subjects of which his practical acquaintance is scant, Enoch Powell, as constituting "no authoritative criticisms of fluoridation". If they happen to be members of one of the 60 County Councils, cities or boroughs, which have already, firmly said "No" to fluoride, they may be regarded by the present Minister of Health, Kenneth Robinson, as simpletons influenced by vocal groups (who for all we know, may be composed of that despised category of their own electors); and if they take an active part in propagating their views, they will be accused by at least one socialist doctor M.P. as well-meaning purveyors of rubbish, and by the minister as issuing "irresponsible" propaganda.

This intolerance of reasoned opposition has its more ominous side. Not content with all-party abuse—the Tory 'shadow' social services expert, Keith Joseph, pledged his full support to the socialist minister's campaign—efforts are now being made, by Conservative and Labour councils alike, to ride roughshod over all who disagree with them. In London the Committee representing all the Boroughs is canvassing its constituent authorities for support for an approach to the minister, asking for legislation to enable fluoridation of water supplies to be directed nationally. Having failed to persuade by normal democratic argument and free election, these people now want to empower the authorities—unelected, aloof, autocratic—to achieve their end by direction. Some boroughs have already agreed.

In its way, this is as good an example of small-time Hitlerism as any we can find. Douglas Jay's belief that 'the man in Whitehall knows best' has a surprising number of adherents, it seems, in all the parties.

of World Communist State inevitable. Not only Australia, but many other non-Communist nations are adopting what can only be termed a double-standard policy. There is nothing ambiguous about South Africa's anti-Communist foreign and domestic policies. And yet South Africa is sending increasing exports to the Communist Empire. No one will question the anti-Communism of Franco's Spain, but Spain is sending increasing exports to Castro's Cuba. There has also recently been a renewal of diplomatic relations between Spain and the Soviet Union. Reports state that the Spanish hope to gain some benefits from the increasing trade, which the Western nations are now doing with the Communist Empire. Exports from the West to the Communist Empire are impossible without adequate financial credits to finance the operation. Spokesmen for the international financial groups of the West make it clear that they are happy to provide the credits.

International politics are entering what has all the signs of being the final phase of the struggle for the world. Whatever the American policymakers say about President de Gaulle of France, they endorse his policy of "building bridges" to the East by growing economic links. The new West German Government, suffering increasing internal economic problems, is also following the de Gaulle lead towards the Communists. The Americans have been sucked into a struggle in Asia which their policymakers are determined they will not win. Every new emergency, whether real or imagined, is used to further the concentration of power everywhere. The British are told if they are not swallowed in the Common Market monopoly, they will have to be absorbed into an Atlantic Union monopoly. And now there is the proposed Pacific Union monopoly.

### FINANCIAL POLICY AND CENTRALISATION

Behind all this feverish activity is the steady drive towards the centralisation of all power. And closely associated with this drive, whether it is called Communism or, quite often, anti-Communism, is financial policy. Predicting an open alliance between Wall Street and Moscow, Communist economist, Victor Perlo, wrote in *The Worker* of August 30, 1964, that "the change in the balance of world forces towards socialism and national liberation has impelled the more sensible and knowledgeable of the Wall Streeters to move towards limited accommodations with the U.S.S.R."

If what remains of freedom in the world is to be preserved from further erosion, and constructive steps taken to enlarge the arena of freedom in the face of the unholy alliance of International Finance and International Communism, it is certain that the disastrous Western policy of economically subsidising the Communist Empire be halted. This means challenging the false financial and economic premises upon which this policy is based. Perhaps the very international economic boycott of little Rhodesia may force this gallant country to strike yet

another blow for civilisation by developing a financial policy designed to make Rhodesia completely self-sufficient economically, and to forget about the export mania. "Rhodesia will raise own money," reads the headline in a recent Rhodesian publication. This type of talk will not please Wall Street, Moscow or Peking.

### RENEWED HOPE FOR MANKIND

The most hopeful aspect of the world drama is that with each step attempted towards creating the World Monopoly State, the central features of the development, irrespective of whether it is called a conspiracy or a long-term policy, become progressively clearer and much easier to point out to people. The Rhodesian miracle, and the mounting upsurge of effective opposition to the Wall Street-Moscow-Peking alliance, is providing a renewed hope that mankind will yet be spared the threat of the greatest tyranny ever proposed. We appeal to all readers to make 1967 a year of increased activity and greater personal dedication. As Douglas Reed writes in his magnificent book *The Battle for Rhodesia* (compulsory reading at present), "The leaders of Rhodesia and South Africa, by opposing themselves to the sea of sorrows which loomed, have not ended, but staved them off. The world is still a mad one, my masters, but it looks a little better than it did a year ago."
