MASKING CIVILISATION'S DECLINE

Those familiar with classical history will recall how when the famous Roman statesman, historian and philosopher, Cicero, attempted to warn his fellows that the great Roman Civilisation was disintegrating, he was met with scornful disbelief. Outward appearances appeared to belie his claims. Rome, the centre of Civilisation, stood intact. True, there were political problems, and the Roman legions were being withdrawn from the outposts of the Empire. But the record shows that during the later stages of the Roman decline there was a type of feverish material activity. It was this type of activity which tended to mask the reality of disintegration, and which appeared to make the warnings of a Cicero appear merely sensational and without substance.

History is repeating itself, it is now sixty years since one of the greatest minds of Western Civilisation, C.H. Douglas, warned that if policies which centralised power over individual initiative were persisted with, Civilisation must inevitably disintegrate. That disintegration has been masked by the very same material activity which masked the Roman decline — but material activity on an immensely vaster scale.

History is studded with numerous examples of national leaders distracting people from their domestic problems by engaging in external adventures. While it would be unfair to suggest that British Prime Minister Thatcher welcomed the Falklands War, it is indisputable that her firm stand united the British people on an issue to which they could readily relate and that domestic financial problems were temporarily regarded as of lesser importance. As memories of the Falklands War recede and finance — economic problems grow, Mrs. Thatcher's political stocks sag.

It is probably true that the great majority of the British people accepted Winston Churchill as their Prime Minister while the Second World War was being fought, but by the time the general elections of 1945 were held, and it was obvious that Hitler's Germany was defeated, and that Imperial Japan's days were numbered, the British people inflicted a major electoral defeat upon Churchill and the Conservative Party. The Second World War had changed the thinking of millions, creating the impression that a war was necessary to create comparative prosperity. The standard of living of the American people rose spectacularly during the Second World War, even though the nation was producing an enormous volume of production for destructive purposes.

Before the Second World War Hitler had gained the admiration of large numbers of people because his policies resulted in "full employment" and comparative prosperity. This was achieved by the well-known Keynesian technique of "pump-priming" the economy with deficit budgets. New credits were created to take up the slack in productive capacity. The national Socialist planners, not the German people, decided how the new credits would be used. In many cases, it was "guns before butter." But desperate people will always tend to accept some improvement in their material condition, even if the price is a loss of freedom. "Give us Caesar", cried the desperate Romans. The Germans settled for Hitler who, for a period, became a type of Messiah.

operating much more satisfactorily. During a major war, all the contestants have a "favourable balance of trade", hurling vast quantities of production at one another. Financial incomes are distributed and available to buy the production not "exported" by war. Enormous waste takes place. In today's world it is probable that most economic activity, including that of shuffling papers and imposing numerous controls, is both wasteful and soul-destroying. But this is masked by the fact that even the most destructive activity distributes monetary incomes, even though these are progressively diluted by the monetary inflation which, in part, is a measure of unnecessary activity.

As demonstrated by Douglas in his first work, *Economic*

To encourage electors always to record a responsible vote in all elections.

To support all policies genuinely concerned with conserving and protecting natural resources, including the soil, and an environment reflecting Natural (God's) laws, against policies of rape and waste.

To oppose all policies eroding national sovereignty, and to promote a closer relationship between the peoples of the Crown Commonwealth and those of the United States of America, who share a common heritage.

Democracy, the basic problem confronting man in the modern industrial age was not primarily financial, but how to create a situation in which the individual was effectively in control of his institutions, particularly the economic system. Most of *Economic Democracy* is devoted to the question of human associations, and the philosophy under girding those associations. The money system was of primary importance only because it made it possible for power to be progressively centralised over the individual, and to pervert the true purpose of the economic system. As Douglas so succinctly put it, the true purpose of production is consumption, not to provide "full employment", an increasing flood of exports, or to control the individual. This is one of those truths which, to many people, is as shattering as Christ's famous comment to the Pharisees concerning the Sabbath being made for man, not man for the Sabbath. There was a time when economic activity was seen as a means to an end, adequate and desired production in the shortest possible time. The early Christian philosophers like Aquinas stressed that the perversion of means into ends was one of the great sins.

THE DISCOVERY OF ROAST PIG

Those who were fortunate enough to go to school when the classical writers were studied, will recall some of the truths and values these writers dealt with. Robert Louis Stevenson's essay on the importance of leisure is generally unknown today. The great English essayist, Charles Lamb, provided a brilliant picture of economic realities in his essay on the discovery of roast pork. The story concerns how there was a time in China when no one had ever eaten roast pig, and how the son of a farmer accidentally burned the house down and cooked the pigs. Attracted by the delicious smell of roast pork, the farmer's son touched the cooked pig and then licked his fingers. The taste was delightful. He was busy eating when his angry father returned. But after scolding the boy, the farmer also joined in the eating and enjoyed it. But he stressed that they must keep their discovery a secret.

From then on the farmer's neighbours' noticed that every time his sows had piglets, his house went up in flames. Eventually others discovered why and before long there was an outbreak of fires as farmers burned their house down — all to obtain the new delicacy, roast pork. It was, of course, later discovered that it was unnecessary to burn whole houses down to obtain roast pork. All that was required was a fire big enough to roast the pigs. The operation of modern economies reminds one of the Charles Lamb essay, the equivalent of whole houses being destroyed in order to obtain what is really required — goods and services. Those goods and services can easily be produced without what are called "growth economies".

The realities of the plight of the world are further masked by what are admittedly brilliant scientific achievements. But many of these achievements are merely dealing with effects. One of the absolutes of the Universe is that there is an optimum size for any association if the object of the association is individual satisfaction and social harmony. A number of studies over the years, one of the most valuable being *The Culture of The Cities*, by Chase, have demonstrated the bigger cities become the more inefficient and souldestroying they become. Every type of social problem, ranging from crime to health, escalates. Bigger police forces and bigger hospitals are required. There is an enormous real cost of providing services like water, power supplies and transport. sophisticated technology, devoting enormous energies to dealing with effects. Most industrial friction has to do with effects, and those engaged in dealing with the effects, including trade union officials, are as parasitic as bureaucrats filling in forms to assess how many others are also filling in forms. A vast superstructure of unnecessary and destructive activity is only sustained because of those engaged in the basic requirements of life.

It is often claimed that with the use of science, man is demonstrating how to conquer nature. But in making this conquest, man is making a conquest of himself. Science is but the orderly arrangements of discovered truth. It creates nothing. It is the purpose to which science is put which is all important. "What shall it profit a man if he gains the whole world but loses his soul." What is the point of man using vast resources to conquer space while at the same time he is creating a hell on earth. Nothing so graphically illustrates the growing perversions of our times than the enormous effort being devoted to vitro-fertilisation programmes, including the freezing of human embryos, while at the same time hundreds of thousands of lives are terminated by deliberate abortions.

The natural association for the nurture of the young is the stable family, the most genuinely efficient association known to man. The fever of growing material activity, and the neverending steam of new scientific achievements, cannot mask the reality of the disintegration of the traditional family. The financial and economic policies of our times press with increasing severity upon the family. These policies are antilife. The disintegration of the family is an indication of the disintegration of Civilisation. The regeneration of Civilisation will have to start with the regeneration of the family. This requires changes in financial policies making it possible for traditional family life to start flourishing again.

SOCIAL CREDIT AND REGENERATION

The decline of the Roman Civilisation took place over centuries. The decline of Western, Christian Civilisation is taking place at a much faster rate, primarily because the very technology which offered freedom on a scale never before envisaged, also made it possible to destroy both materially and spiritually on a scale which makes Dante's inferno look like a pleasant experience. Nothing can now halt the continuing decline. But that very decline offers the opportunity for preserving that which is true and for encouraging the process of regeneration. The Social Credit Movement is the custodian of those truths without which there can be no regeneration.

PUBLISHED AT LAST! "THE ZIONIST CONNECTION"

MASKING PROBLEMS

But all this tends to be masked by brilliant engineering achievements which keep a basically inefficient organisation operating. And those engaged in dealing with effects do, under present financial rules, obtain that licence to live called money. Growing social stresses and over processed foods, most of them grown on soils over-stimulated with chemicals used by economically hard-pressed farmers, have produced a number of degenerative diseases. These in turn have resulted in a growing army of brilliant surgeons, using highly Page2

THE CONTINUING BETRAYAL OF SOCIAL CREDIT IN NEW ZEALAND

When New Zealanders elected the Michael Savage Labor government in 1935, pledged broadly to implement financial proposals reflecting the widespread impact of Social Credit, many felt that New Zealand, a self-governing Dominion of the British Empire, would set mankind on a new course by breaking the power of the Credit Monopolists. New Zealand was much better placed than the Province of Alberta, Canada, to make constructive changes in financial policy. There is little doubt that this was well understood in the centres of International Finance like Wall Street, New York. And that the full influence of the big Social Credit Movement in New Zealand had been mobilised behind the Australian-born Savage Labor team following an agreement reached between representatives of the Social Credit movement and the Labor Party.

The subversion of the Savage Labor Government is outlined in a book, The Truth About New Zealand, by the well-known writer, A.N. Field, best known for his books, *the Truth About* the Slump and All These Things. Field was not a Social Crediter, but he had a deep understanding of the nexus between Big Finance and revolution. Savage was obviously a pleasant well-meaning man, but he was not a strong leader. And he lacked a firm understanding of finance. Local representatives of the Money Power lost no time in assessing the situation and deciding on the best strategy for heading off the Social Credit challenge. Their main agent was Minister for Finance, Walter Nash, who lost no time in instigating a programme of subversion. Those who knew Nash well pointed out that as young man he had probably been a member of the New Zealand Communist Party. Nash provided a classic example of how the Money Power has time and time again made use of pro-Marxist academics to defeat any threats. Modern Labor parties have been openly taken over by a new breed of academic theorists, some of them even being millionaires. Early Socialists, like Keir Hardie and Robert Blatchford, who were emancipationists, would be dismayed to meet those who today describe themselves as Socialists.

LINE OF PARTY POLITICS

In spite of the break in Social Credit development resulting from the Second World War, the potential for a new attack on the Money Power continued to exist in both Alberta and New Zealand. The subversion of Social Credit in Alberta started with the death of William Aberhart and his replacement by Mr. Ernest Manning. It was ironic that while it was clear that the seeds of subversion were growing vigorously in Alberta, Social Crediters in New Zealand were being misled into believing that they should follow Alberta by creating a political party. Perhaps this was understandable when the Labor Party betrayal of the high hopes of Social Crediters is considered. Generally overlooked was the fact that every political party is readily susceptible to the corruption of power and internal subversion. Apart from those who had thoroughly grasped Social Credit and who had studied Douglas, frustrated New Zealand Social Crediters were attracted like moths to a naked light, by the lure of party politics.

The first excursion into party politics in 1954 demonstrated that there was a substantial electoral support for some type of monetary reform. This resulted into yet one more Royal Commission into banking, during which the Chairman of the Associated Banks made the frank admission that the banking system created the nation's money supply in the form of bank credit. But this admission had also been made before the Second World War by the Macmillan Commission in England. Generally speaking, representatives of the New Zealand Social Credit League who appeared before the New Zealand Commission merely demonstrated their own lack of understanding of Social Credit financial technique and confirmed Douglas's warning about arguments concerning financial techniques. There is little doubt that New Zealand Social Crediters were encouraged to continue pursuing the will-of-the-wisp lure of party politics. A strange assortment of people, including Marxists, were attracted.

A PHILOSOPHICAL FLAW

With the arrival of a charismatic Mr. Bruce Beetham, an academic, and his election to parliament, there was a new surge of wishful thinking. When Mr. Beetham was joined by Mr. Gary Knapp, as the result of a by-election, optimism soared. The polls suggested that the Social Credit party could win a number of seats at the 1981 elections. The total vote was not as great as expected, but Beetham and Knapp were reelected and virtually held the balance of power. Subsequent developments revealed the basic philosophical flaw in the Social Credit party and its political representatives looked more and more like mere political opportunists with little concern for basic principles. It was not surprising that the 1984 New Zealand elections saw a dramatic slump in the vote for the Social Credit party, with leader Mr. Bruce Beetham losing his seat. The big vote for the new party created by millionaire Mr. Bob Jones helped to erode both the National Party and Social Credit party vote, demonstrating that much of the previous vote for Mr. Beetham and his colleagues was a protest vote. The defeat of Mr. Beetham was offset with the election of another party representative who, judging by his reported statements, knows even less about genuine Social Credit than does Mr. Beetham.

The annual Social Credit party conference, held shortly after the elections, further demonstrated the continuing rot inside the party. From a genuine Social Credit viewpoint the best news is that serious consideration is being given to changing the name of the party, a decision to be made at the next conference. If this change is made, the task of presenting genuine Social Credit in New Zealand by the League of Rights will be much easier. In presenting Social Credit at present, it is first essential to stress that this has nothing to do with the party of that name. Social Credit has been cursed with the same problem in Canada.

The shape of things to come with the New Zealand Social Credit party, hopefully to be known in the future as the Social Democratic party, was indicated by many of the statements at the post-election conference in Wanganui. A press report states that "A new politically aware, determined and young

vice-president, Socred research officer Ms. Dianne Davis, was elected in an obvious acceptance from the party floor for her plea for a regeneration of the party....Ms. Davis admitted in the conference that she did not place the same emphasis on Major Douglas as perhaps they did." This is rather like saying that a group calling itself Christian should not pay too much attention to Christ.

Although a fund is being raised to finance Mr. Bruce Beetham to continue as the leader of Social Credit Party, it is no secret that there are underlying stresses concerning the leadership as Mr. Gary Knapp emerges as a type of evangelist with his own version of what his party should be promoting. Mr. Knapp has always been careful to distance himself from the League of Rights, but it is slightly humorous to see that Mr. Knapp and his supporters have taken as their economic bible, People's Capitalism — The Economics of the Robot *Revolution*, by the American engineer, James S. Albers. This valuable work was reviewed favourably some years ago by veteran English Social Crediter and contemporary of Douglas, Dr Geoffrey Dobbs, and has been sold for years by the League of Rights. Albers merely provides an independent confirmation of the Douglas analysis, and points out that the wage system will eventually have to be supplemented with a dividend system. But, unlike Douglas, Albers does not provide a precise financial policy for the implementation of a system of dividends.

ATTACK ON DOUGLAS

Mr. Knapp could have been taking out a type of insurance policy when he told the Wanganui conference that "Antisemitic labels attacked to the Social Credit movement based on the writings of its founder C.H. Douglas have no place in the modern New Zealand Social Credit Party." Mr. Knapp merely demonstrated his own shallow knowledge when he said, "I don't like him (Douglas) in terms of personality. "Probably in an attempt to placate older members of the party, who have some respect for Douglas, Mr. Knapp said that Douglas was a man "of economic vision", but then insulted him by observing that his mother did not like Mohammed Ali "because he talks too much. But he's one hell of a boxer. I look at Douglas like that, I didn't like him much either, and I know a bit about it."

Like Mr. Beetham, Mr. Knapp is always quick to stress that

there is no connection between the Social Credit Party and the League of Rights. But the fact remains that an increasing number of New Zealand electors who have supported the Social Credit Party, have been purchasing literature through the League and hearing League speakers. Although Douglas analysed the "Jewish Question" in the most objective manner, it is insulting nonsense to suggest, as does Mr. Knapp, that Douglas had any sympathy with the totalitarianism of either Nazism or Fascism. Mr. Knapp provided further evidence of his dangerous ignorance concerning Douglas when he said, "In the 20s and 30s the world was rife with grave concerns about the thrust of communism and socialism and his reaction to that was a kind of a more extreme kind of right wing thing — epitomised by the Oswald Moseley's and people like that."

Mr. Knapp condescends to say that he didn't think Douglas was a fascist, but then said that Douglas's writings, particularly towards the end of his life, reflected some capitulation of his mind to those that proposed theories of conspiracy." Compared with Douglas, party politicians like Knapp are, of course, mere political pygmies. As pointed out by the brilliant literary giant, A.R. Orage, events always appeared to be in the pay of Douglas. Events unfortunately continue to conform the predictions of Douglas, and his analysis of basic causes of social disintegration. If the party politicians, including those who exploit the label of Social Credit for their purposes of expediency, really believe that the state of the world, and the openly emerging threat of the World State, is the result of mere chance and not design, then they have little constructive to offer in the battle for the world.

A DEMONSTRATION

The best that can be said about the New Zealand perversion of Social Credit in the interest of party, power politics is that in the long run it will demonstrate what is not possible. The suggestion that Social Credit can be advanced by power politics is like saying that it is possible that figs can be obtained from thistles. As in Australia, it is obvious that in the developing crisis, it is the League of Rights, which has acted as the faithful custodian of the Social Credit idea, which is moving to the centre of the stage of an influence which could prove decisive in the future.

WHO'S SERVANT?

In the following article a veteran of the Social Credit Movement in Australia examines the role of newspaper mogul Rupert Murdoch in today's world. Mr. Harold Hotchkin is one of Australia's oldest active Social Crediters and those attending "The New Times" Dinner on September 28 will be privileged to gain a glimpse of the past from a man who attended C.H. Douglas's Melbourne Town Hall meeting. The title of Douglas's address was "The Monopolistic Idea". As Harold Hotchkin points out, the philosophy of monopoly is still dominant.

When the Bank of New South Wales, in its *Review*, No 27, October, 1978, published an essay, "Sources of Money" containing the following statement, "Today in Australia, as in most other modern economies, all money is a debt of the banking system", the author laid bare the basic fact that is the root cause of the disintegration of modern Civilisation.

of the *Review* statement and pestered their editors to hit the headlines. As this has not happened, there must be a reason. In Australia, as in any modern society, the great mass of the population rely upon the mass-produced publications for their information, those in control of the media have a duty and responsibility to "tell the truth, the whole truth, and nothing but the truth." So whose side are they are on? God's, or Mammon's? Are our press tycoons masters in their own houses, or only the servants of the money power, responsible for the present debt crisis sweeping the world?

As the possession of a sufficient supply of money in a modern society is the basis of an individual's independence, the lack of money, in most cases, deprives the individual of the chance to develop to the full his or her potential. The present state of social friction is entirely due to the "economic rat race" in a desperate effort to obtain money tokens. Those controlling the issue and recall of those tokens therefore have the power of life or death almost to the point of monopoly over modern society.

While the Bank of New South Wales *Review* may not be widely read, one could reasonably expect some of the bright young journalists, or financial "experts" of the financial pages of the mass media, possessed of a medium amount of intelligence, would have grasped the widespread implications Page4

THE CASE OF RUPERT MURDOCH

Let us examine the case of Australia's own Rupert Murdoch, now credited with being the owner and controller of mass publications in Australia, the United Kingdom and the U.S.A. Rupert Murdoch is the son of the late Sir Keith and Lady Murdoch. Recently Rupert Murdoch was the subject of an interview on the Current Affairs programme, "Sixty Minutes". He was described as "the most powerful man in the world", which is surely open to challenge. His enemies accuse

him of a contempt for the truth. His grandfather, the Rev. P.J. Murdoch, was Presbyterian Minister in the Melbourne suburb of Kew.

Mr. Rupert Murdoch has been described as very much his father's son. His father, Sir Keith Murdoch, who obtained, in part, his education at the Fabian Socialist London School of Economics, became Managing Director of the *Herald* and *Weekly Times* in 1929, just prior to the Great Depression. Behind Sir Keith, as Chairman of Directors, was Mr. Theodore Fink, and the National Bank.

In 1929 Australia had entered one of those periodic crisis that are a feature of a system whereby "all money is a debt of the banking system." Debts had to be paid. So the mortgagees, mainly the City of London, sent Sir Otto Niemeyer, a Director of the Bank of England, and his advisor Professor Guggenheimer Gregory of the London School of Economics, to guide Australia on the right path. They sought the assistance of a Professor Douglas Copland, of the Melbourne University School of Economics, to assist in the process. Later the Professor received a knighthood, presumably for services rendered.

The infamous Premiers' Plan was formulated, with *The Herald* and all other mass media journals telling us that we have "lived beyond our means", that we had to "tighten our belts, produce more and consume less" and that we would find that prosperity was just around the corner. Wages were reduced, unemployment was at a record high, banks closed on farmers whose prices for their production was so low they could not pay the interest on their overdrafts. General misery abounded.

A DISCORDANT NOTE

The only discordant note from the politicians came from the Premier of N.S.W., Mr. J. T. Lang, who declared "We'll talk about cutting wages when interest rates are reduced." But Jack Lang was on his own.

We learn from *Rupert Murdoch*, a "Business Biography", by Simon Regan, that Rupert was educated at Geelong Grammar and Oxford. To quote Regan (page 37) "...the schoolboy Murdoch was shy and reserved...on the other hand there was Murdoch the rebel expounding deep socialist principles quite noisily to anyone who would listen." His "nickname" at school was "Red Rupert...people have made great play of his left wing leanings." In fairness to our international press tycoon however, we must further quote his biographer: "But this idealism was tempered at Oxford, and although streaks of radical thinking emerge in the Murdoch psyche every now and then, he is very far removed from that 'red rebel' ". Or is he — By their fruits ye shall know them.

Chapter 1 of Regan's work is more than interesting with the title, "Battle for *The News of The World";* it is quite revealing. This London newspaper reputedly had the biggest circulation of any newspaper in the world. It was right wing and Enoch Powell was its political darling. But like millions of human beings in this world, *The News of The World* was suffering from financial starvation. It was ripe for a take-over.

Our one-time "Red Rupert" was keenly interested. So was Robert Maxwell (born Jan Ludwig Hoch) publisher resources of the Commonwealth Bank of Australia behind him." Which poses the question as to why an Australian government bank should want to back a takeover bid for a London Sunday newspaper

We find that Murdoch's 'relationship with them is more than just business, so that he had personal friends there who were free with their advice about his finances." With the backing of Morgan Grenfell and the Hambros bank Murdoch finally took over control of *The News of The World*. His exploits in the United States, and in particular his loan concessional deals with the American Federal Reserve Bank have been matters for comment.

We gain the impression from the Sixty Minutes interview and Simon Regan's biography, that Rupert Murdoch keeps a tight rein on additional policy. It is claimed he is anti-Establishment. If that is so, and the term Establishment refers to the apex of political and economic power, then Mr. Murdoch must indeed be very naive. For as the founder of the Rothschild dynasty stated, "Permit me the right to create a nation's credit and I do not care who makes its laws."

In this day and age, there is no shortage of "laws", taxes and other imposts that impinge upon the individual's freedom, all necessary to prop up a corrupt system of national accountancy that allows "all money in Australia...to be a debt of the banking system". We have not noticed any great effort on the part of Mr. Murdoch's publications mounting any worth while campaign to rectify this state of affairs for the benefit of his fellow Australians.

THE WONDERFUL WORLD OF FLUORIDE

CASTRO'S JEWISH BACKGROUND

Fidel Castro, Marxist dictator of Cuba, is one of the Soviet Union's favourite tools in promoting global revolution Propaganda has it that the Soviet Union is anti-Jewish. What then, of Castro's alleged Jewish background?

As a young man he met the former Ambassador to Israel, Ricardo Subirana L-Lobo, alias Richard Wolf. Wolf emigrated to Cuba from Germany when Hitler came to power. In Cuba he became a millionaire and met with the young Castro, the two becoming close friends, each admitting their Jewish background. Castro studied as a lawyer and become involved in Marxist revolutionary movements which led to his imprisonment in 1953 by the Batista Government. Released from prison after serving only three years of a fifteen year sentence, Castro fled to Mexico and set in motion the revolutionary movement which eventually led to his return to Cuba and seizure of power Influential papers like The New York Times backed Castro, insisting that he wasn't a Communist, only an "agrarian reformer".

Castro's friend Wolf was the Cuban diplomat to Rome and Peking under the Batista government shortly before Castro's takeover of Cuba, Wolf became Ambassador to Israel where he has since resided as a private citizen in Tel Aviv.

The managing director of a West German engineering company was arrested, to stand trial for helping the government of Pakistan to acquire a nuclear weapon.

It is alleged that the managing director supplied equipment worth \$6 million to a uranium hexafluoride plant in Pakistan.

The only possible purpose of the uranium hexafluoride plant is to convert natural uranium into the raw material for an enrichment plant. The only use for the enriched uranium, according to the British magazine *New Scientists*, is for nuclear weapons.⁸

Yes, the same fluoride ion again used in nerve gas, for atomic bombs, and for your artificially fluoridated drinking water from your household tap.

Responsible government is impossible without responsible voting. Clearly the British people are far from reconciled to losing their sovereignty in the Common Market, which is encouraging evidence that the centralisers are finding it increasingly difficult to impose their programme.

The right of the individual to contract out of any association poses the greatest threat to those who seek to establish the totalitarian State, which is why the totalitarians seek to deny the individual the right to genuine freedom of choice. In recent years increasing numbers of parents in many countries have been so concerned about State-controlled education systems that they have sought to contract out of the system by placing their children in independent schools. most of these Christian based. Canadian developments clearly indicate the shape of things to come in an Orwellian world where UN sponsored Human Rights Commissions are used to deprive English-speaking peoples of rights which, under Common Law, they have enjoyed for hundreds of years.
