# **FAMILY SPIRIT DOMINATES "NEW TIMES" DINNER**

It has become commonplace to hear each annual "New Times" Dinner described as "the best ever." What this comment means is that every Dinner is a manifestation of the rich and growing diversity of this event. Every Dinner has its own special character, and this year there was a stronger feeling of family than ever before. This was highlighted when one of the younger supporters, Miss Mary Jo Renehan, in seconding the toast to "The New Times", said she wished to present a perspective of youth to maturity, calling upon her father, veteran supporter Mr. Michael Renehan, to join her at the podium to provide the mature perspective. As one guest said, "Mary Jo stole the show."

Once again every seat was taken at the Dinner, which was the fortieth. A big percentage of those present had not even been born when the first *New Times* Dinner was held in 1946 at the old Federal Hotel, Melbourne. There was the usual number of messages, from overseas and from around Australia.

Mr. Phillip D. Butler, Assistant National Director of the Canadian League of Rights, was able to be present to bring a personal message from Canada, providing a sobering picture of how far a Common Law country like Canada had been moved towards the complete totalitarian State under the influence of Fabian Socialism. The Conservatives who followed Fabian Socialist Trudeau had continued with Trudeau's policies, domestically and internationally. Book banning was a chilling reality.

Dr. Geoffrey Dobbs of North Wales, phoned through a personal message on the morning of the Dinner. Dr. Dobbs is, we are pleased to report, recovering satisfactorily from a stroke. A following written message is published in this issue.

There was a special round of applause when a message from Lady Cilento, also phoned through, was read to guests. Lady Cilento said that she wanted to be associated "in spirit with my dear friends of the Australian League of Rights. I pray for you every night."

The Loyal toast was proposed by Mrs. Katrina Thompson who, in speaking to the toast, made some telling points concerning the two-way relationship which should exist between the Queen and her subjects. This toast matched the many fine loyal toasts of the past.

Speaking without notes, Mr. Neil Mauritz of Western Australia, attending his first Dinner, gave an outstanding address, one, which summarised the nature of the battle in which *New Times* supporters are engaged. Neil Mauritz demonstrated a special ability to link both the financial and philosophical aspects of Social Credit. This ability was further demonstrated when he presented the first Paper at the Annual National Seminar.

During his Dinner address, Mr. Eric Butler stressed the theme of family and how privileged the members of this family were to share the insights, which C.H. Douglas had provided. Douglas had brought a deeper meaning to Truths, which tended to be taken for granted. He had pointed out that the Christian Law of love was not an example of mere sloppy sentimentalism, but the enunciation of a principle which, when applied to all human associations, resulted in rich rewards.

"There are no power struggles inside the movement we represent", he said, "because we are striving to be servants of

truth."

Mr. Butler said that while the national and international situation was threatening, some would say hopeless, it provided a stimulating challenge to all those who had not lost faith in God. Douglas had made the profound observation that the truths of the Universe transcended human thinking, and that when man humbly sought to discover those truths, and obeyed them, then he would truly enter the Kingdom.

Mr. Butler said that the League of Rights had spear-headed three major campaigns in recent years; Aboriginal Land Rights; the Bill of Rights; and Council mergers in Victoria. These victories, although fought for in defensive actions, had seriously held up the revolutionary advance in Australia. And in fighting these battles, the League had recruited new and most valuable supporters. He stressed that, given time; positive results should come out of what might be termed negative actions. He pointed out that Douglas had said that given time, a homogeneous people could gradually solve their problems. Marx had understood this when he said that the English would never make their own revolution and that foreigners would have to make it for them. Fragmenting a people by bringing in large numbers of peoples of different cultures, made the task of constructive reforms so much more difficult. Immigration was a major threat, which had to be

#### NATIONAL SEMINAR BIG SUCCESS

The new venue for the Annual National Seminar was rated an improvement, particularly from the point of view of parking. For the first time all speakers were League supporters, as were the chairmen of the different sessions. The Seminar was opened by National Director Eric Butler, who outlined the major features of a dying civilisation, one of these being the big increase in juvenile suicides and drug consumption. Mr. Butler said, "A combination of influences, including what is termed the "new education", had cut young people off from their heritage and convinced them that they had no worthwhile future."

In a masterly summing up of the Seminar, Queensland State Director Chas Pinwill moved a vote of thanks to the four speakers, Mr. Neil Mauritz, Mr. Brian Anderson, Mr. David Thompson and Mr. Jeremy Lee. The high quality of all the addresses was widely commented upon. "A most impressive presentation of the face of the League" was a typical comment. All addresses were audio and video taped and are available through the League.

Mr. Eric Butler observed that it was not without significance that all the speakers and the chairmen, and the mover of the vote of thanks, had rural backgrounds.

There was an increased attendance and book sales were, as usual, heavy. Mr. Eric Butler reported at the National Action Seminar on the Sunday, that there had been an increase in literature distribution of at least 40 per cent over the previous twelve months. He stressed the permanency of the printed word.

## LOYAL TOAST

As a young and newly married woman, — little more than a girl — our Queen was thrust into the role of monarch. She has been required to fill this office for the whole of her adult life, and has done so with distinction. Such has been her record that she commands the respect of even some of the republicans.

However, admirable as our Queen's reign has been, it is the institution, which she symbolises, rather than the individual who fills that institution which we toast. While we honour the Queen, we toast her office.

The Monarch, or Crown as Sovereign symbolises the personal sovereignty of each individual subject. Traditionally our system starts from the belief that the individual draws his rights and liberties — his life itself - from God.

The love of God for each individual motivated the structure of monarchy. The Monarchy is the earthly demonstration of the spiritual principle that each person is special in his own right. Therefore the Monarch's realm must be organised on the basis of love and genuine concern for each subject, with the ability to offer tangible protection for the individual's interests.

It is not enough to simply *have* a monarchy. It must be made to *work* for the benefit of all the Sovereign's subjects. This is a two-way contract between monarch and people. The basis of the attack upon the Monarchy is that it is out of date, and has no relevance to the 20th and 21st centuries.

To make the Monarchy work, a proper relationship between Monarch and subjects must be maintained, each with a special role to play. This must be our objective. I am not interested in a monarchy for the sake of having one. I want a monarchy that *works* with a role to play in a stable future for my children. Page 2

## VIDEO TAPES STRESSED AT ACTION SEMINAR

One of the highlights of the Action Seminar was a discussion on the most effective use of videotapes, this following a report by Wimmera Regional Chairman Keith Oldfield, who described how he was successfully using videotapes to operate at the "grass roots". Mr. Oldfield said he ran all meetings, generally held in homes, as if they were League public meetings. He first introduced the League of Rights and the tape, at the end of which there was a period for questioning. He than sold books and, if appropriate, had a collection to defray expenses.

The National Director expressed the opinion that, while the cassette tapes were still an invaluable tool in the League's programme, the videotape opened up a completely new vista of what was now possible. The two cameramen who have been making video films for the League were present and were able to provide valuable suggestions.

Reports were presented on how the campaigns against the Bill of Rights and Victorian Council Amalgamations had been so successfully conducted. There was an in-depth report on the threat of the I.D. Card with all present being provided with an action kit. The last report of the Seminar was provided by Gippsland, Victoria, actionist Mr. Bruce Ingles, what made a strong appeal for an even greater flood of League literature, giving examples of how to use sporting events, shows and similar activities for the quick distribution of thousands of pieces of literature.

One of those who attended the National Weekend said it all as follows: "This has been a major recharging of the batteries for another twelve months of League activity".

# ONE THING AT A TIME

The revulsion against party politics was now strongly apparent in all English-speaking countries, the chairman of the New Times dinner, Mr. Jeremy Lee, said in replying to the toast.

He said there seemed to be a correlation between the ever-increasing frenzy of elections exhibited by party candidates, and the cynical disenchantment of the great majority of electors. The 'bread-and-butter' package of party promises was no longer working, and people were casting round for some alternative to the threat of a breakdown in the democratic process.

Mr. Lee pointed out that a hazy but distinct option was beginning to appear in single-issue politics outside the party structure.

"Over the last eighteen months we have seen the emergence of effective community campaigns in opposition to the excessive side of Aboriginal landrights programmes, the amalgamation of local councils in Victoria and the Bill of Rights," he said. "This has confirmed a truth which C.H. Douglas pointed to many years ago -- that it is easier for people to unite against something they don't want, than in pursuit of positive alternatives. But the negative approach is an essential part of democracy, with positive consequences even if they are indirect."

Mr. Lee quoted the late Mr. L.D. Byrne who, in dealing with this aspect said: " . . . The stark folly of attempting to fight money with money, the party system by organising a new party, the strangling hypnotism of material gain by appeals for social security measures — and so forth, should be evident. All they can achieve is to strengthen the very forces they seek to combat . . . It is not the size of the counter-force which can be mobilised against the forces of evil against the plotters, the planners, the materialists and their fear-dominated human fodder -but the power of Faith which will decide the issue . . . Now it should be evident that any attempt to go out and "organise" men and women to support so-called Social Credit candidates. or to merely unite in demanding better homes, more incomes, and other material advantages, are foredoomed to failure ..."

Unity on one issue at a time, Mr. Lee said, was both possible and demonstrable, where that issue was grounded on basic principles of truth. Social Crediters were guides on how this could be done. The period ahead certainly promised greater opportunities for doing so.


## From Mr. Ivor Benson in the United Kingdom:

# **ROYALTY SPEAKS FOR US**

A Message from Geoffrey and Elizabeth Dobbs.

Since, a few years ago, the Queen's representative in her Kingdom of Australia performed the royal duty of dismissing an incompetent Government and referring the matter to the people in a General Election, which overwhelmingly confirmed this constitutional action, the Monarchy has been under bitterly malignant, and systematically planned assault by those elements in Australian, and indeed, in British society, which worship centralised, bureaucratic, political power based upon coercion, and detest that link of love and loyalty between Crown and people which tends to balance and moderate it.

It is not at all surprising that Mr. Bob Hawke, and those who admire him, should be working with all their force and cunning to get rid of a Christian family as the living spiritual symbol of Australia, and also the flag which shows the Southern Cross combined with the three crosses of the British Connection, and the anthem which calls on God to save the Queen from such politics.

Naturally enough, what they want as a symbol of their philosophy is a Party Boss as President (or else some puppet nonentity nominated by politicians) to represent the coercive bully-power of Party over the 'masses', i.e. the people as reduced to equal and identical numerical units under propaganda control through the media. Naturally also, they will not want an Upper or Revising Chamber to be able to restrain in any way their exercise of the delicious powers of total Boss hood; and in due course, the alternation in power of rival Parties with differing propaganda but substantially the same policy in practice, will be seen as a hindrance to numerical 'democracy' (as they see it) which will achieve their 'ideal' only when there is One Party, supported at every election by 99.9 percent of the units of population. (Thunderous applause! All stand!).

There is one member of our (and your) Royal Family who comes under peculiarly spiteful attack from most of 'the media' because from time to time she tells the truth which we all know about them with an admirable mixture of good humour and asperity. That, of course, is Princess Anne, whose courage and hardihood in doing her royal duty as President of the Save the Children Fund — always going to see for herself whatever the dangers — are much admired, as well as her horsemanship and her 'guts' in saying for us what we all think.

At a banquet held by the Associated Press in London on 17 September she expressed her annoyance with "the amount of unadulterated trivia, rubbish, and gratuitous trouble making that appeared in all sections of the so-called media, in response to a perfectly normal family occasion" (her brother Andrew's wedding). Likewise, she added: "the sheer volume of repeated stories, half-truths and lies" and the audience was reported to have appreciated — as we do — her recalling the days when slanderers had to stand in the market place, holding their noses and proclaiming themselves slanderers, or have their tongues cut out!

Of course, these are selected bits out of a well-

balanced and witty speech which gave praise as well as blame, but they inevitably resulted in more sneer cartoons and snide journalism: "intemperate outburst", "deplorable", "Princess Sourpuss", "Her Royal Haughtiness" and so on, treating journalists as if they ought to serve the public with the truth, instead of manipulating them by the Power of the Press — which thinks it ought to be groveled to, or else!

In voicing for us what the silent majority of normal, sane, loyal citizens think about the corrupt powers that oppress us, the Princess was carrying out one of the most valuable functions of Royalty. We are not silent because we cannot speak. We are not heard because we are drowned by the multi-decibel bellow of the centralised media. But when a Royal person speaks she has to be heard; she cannot be shouted down or given 'the silent treatment, only the sneer treatment.

Why not? Because the Royal Family is a normal family, raised to influence and magnificence by the forces of nature and heredity, and not as the agents of political or financial power, of which it is independent. That is why it represents, and is supported by the enormous force of mutual love and loyalty between them and us, the ordinary people, whom they can serve without ruling or controlling, and which is too formidable to attack directly, but only indirectly, by lies, sneers and innuendos.

Just as in 1980 with the Polish unrest — when it was no longer possible to hide the fact that international banks were deeply involved in supporting the Communist system — the revelation of the conspiracy when it came was almost nonchalantly accepted by the public in the West. Now, in 1986, as Australians find these same international banks are dictating the terms of supposedly resolving our own country's problems - ones that are, moreover, largely attributable in the first place to the concept of a 'global economy' planned by these financiers — so, once again, the whole scenario is unfortunately seen as a quite natural development by the average person.

This anaesthetization of the public to their ultimate fate as simply 'produce and consume' proletarians — or worse — has been the real success of Fabianism. The New International Economic Order is undoubtedly the greatest and most diabolical delusion of the twentieth century leading, inevitably, into the slippery ground of 'extra-national loyalty', formerly called treason!

By a combination of flattery, bluff, bluster and deception, successive political and other leaders in Western nations have taken the path of jeopardising the cherished ways-of-life, the traditional freedoms, and the conventional welfare of their own peoples for the unpredictable hazards inherent in the convergence of all national systems into a monopoly Capitalist-funded, and United Nations/Communist administered universal 'Utopia'. That is, world government!

Government in Australia today, of whatever party, is already impotent. Nevertheless, the pretence of democracy here must be kept alive by allowing people to go through the motions of voting — although it changes nothing.

The moneyed 'establishment', of which the media is part, is now promoting another political distraction — the so-called 'New Right' — as a movement with alternative policies and a programme for economic recovery. Regrettably, its pronouncements have shown it is just another stablemate of international financial orthodoxy. No lasting solutions are going to be found there!

Tonight, at this annual 'New Times Dinner', it is salutary to reflect once again that the only genuine and practical spirit for national regeneration, and the most favourable source for its impetus, resides amongst the type of people gathered here—the Social Crediters.

## SOCIAL CREDIT IN NEW ZEALAND

Developments concerning what was originally known as the New Zealand Social Credit party, but which for cynical reasons changed its name to the Democratic Party, continue to demonstrate the folly of attempting to advance Social Credit through party politics. Modern party politics are power politics and encourage corruption.

When Mr. Bruce Beetham was defeated as leader of the Democratic Party at the recent party Convention, he made a number of public criticisms of his colleagues, at one stage threatening to form a new party. Ironically, Mr. Beetham now says that the Democratic Party under its new leadership is deserting genuine Social Credit! Some of what Mr. Beetham says is correct, but it was Br. Beetham himself who originally repudiated Douglas. Constructive suggestions put to Mr. Beetham when he virtually held the balance of power in the New Zealand Parliament were summarily rejected.

Mr. Beetham made outrageous allegations concerning the League of Rights, demanding that all League of Rights supporters be expelled from the Social Credit Party. One of his most extraordinary charges related to the alleged financing of the League of Rights. Mr. Beetham promised to publicise this financing at the appropriate time. He never has. But a former member of the Social Credit party told Mr. Eric Butler during his recent New Zealand tour, that Mr. Beetham had told him, when challenged on the matter, that the League of Rights was being financed by the Soviet Union!

Over the years hundreds of thousands of dollars have been wasted on the prostitution of Social Credit to party politics in both Canada and New Zealand. There has, of course, been deli-Page 6

berate subversion. With the expenditure of far less money, the League of Rights in New Zealand has done far more to spread knowledge about Social Credit, and to encourage electoral action designed to defeat all policies for centralising power over the individual.

A Social Credit society can only grow as sufficient individuals in that society accept and apply the Christian philosophy. As the author of *Social Credit*, C.H. Douglas pointed out, before the First World War, English-speaking societies were moving towards Social Credit. The increment of association and the cultural heritage were being increasingly passed to individuals. Given time and stability, the major defect of financial policy could have been corrected to ensure the individual's complete access to his social credit. But the First World War saw the eruption into the open of those anti-Christian forces, which had long worked underground to subvert Western Christendom.

Current Social Credit strategy must concern itself with the exposure of those forces and their policies. The formation of "Social Credit" parties, and the stress on "image" and gaining votes, diverts attention away from what has to be done.

## "A DEMOCRACY OF CONSUMERS."

# YOU CAN TRUST A COMMUNIST

Australians will have been gratified to learn that their former Prime Minister is one of the Eminent Persons Group now busily meddling in the affairs of South Africa. Each of the Eminent Persons has conspicuously failed to solve the problems in his own country. Yet they are apparently certain that they can solve the infinitely more complex South African problem. The Chinese proverb that he who failed three times set up as an instructor comes to mind.

Mr. Hawke, of course, holds an honoured place in the affections of his countrymen for unobtrusively setting aside the White Australia policy. It is thanks to him that Australia now has what she never had before: a racial problem caused by large-scale coloured immigration; a problem which as time passes can only become more intractable and more embittered.

The Eminent Persons have somehow convinced themselves that Nelson Mandela is an "African leader"; further, they hold that his release from prison and his attendance at "negotiations" is vital.

From a reading of the media nonsense about Mandela one might well get the impression that he is a liberal lover of "mankind", arbitrarily arrested and imprisoned by a brutal tyranny as he strolled peaceably through a public park picking a few flowers as he went. So a glance at the record might be instructive.

## **RIVONIA TRIAL**

The record shows that Nelson Mandela is a dedicated Communist. He was one of ten accused of high treason at the famous Rivonia trial. He was convicted and sentenced to life imprisonment. Mandela and his friends had assembled huge quantities of explosives, and used some of it. Captured papers showed that provision had been made for Revolutionary Council of State. Mandela admitted that he had planned violent revolution. A document written by him stated that the capitalist system in South Africa should be destroyed and replaced by a socialist state. He declared that the people must be revolutionaries, not reformers. He wrote: "We of the Communist Party are the most advanced revolutionaries in modern history." At his trial this darling of the world's media declared: "I have dedicated my life to end white domination. It is an ideal I hope to live to see realised. It is also an idea for which I am prepared to die.

The Communist African National Congress, to which Mandela belongs, is a member of the Organisation of African Unity. Those who think that the South African blacks want "power-sharing" and a multi-racial democracy might find the following quotation of interest. It is from the published Programme of Action of the O.A.U.: "We cannot compromise with any white government, extreme or liberal, or agree to multi-racial nonsense. We are determined to destroy all traces of white tyrants and their children."

But Mandela will "renounce violence" insists the inevitable man of goodwill. So it is worth asking ourselves just what that renunciation would be worth. A NEW TIMES - NOVEMBER 1986

word or two from Lenin himself might be useful. In his book "The State and Revolution" Lenin wrote: "The strictest loyalty to the ideas of Communism must be combined with the ability to make all necessary practical compromises, to "tack", to make agreements, zigzags, retreats and so on, in order to accelerate the coming into power". If more is needed, let us note his famous dictum that "Promises are like pie-crusts, made to be broken. Truth is a weapon in the class war: any statement that advances Communism is true."

J.V. Stalin would have thoroughly approved this view. He is recorded as saying: "A diplomat's words must have no relation to actions — otherwise what kind of diplomacy is it? Words are one thing, actions another. Good words are a mask for the concealment of bad deeds. Sincere diplomacy is no more possible than dry water or iron wood."

To be fair, Lenin would have disapproved of Mandela's declaration, and the O.A.U. Programme of Action. He held, very sensibly that there was no point in unnecessarily alarming the intended victim; He would have stigmatised such needless frankness as "left-wing communism", which he labelled "an infantile disease".

These quotations and many other similar ones must be part of the working knowledge of professional politicians, political advisers and of thousands of workers in the media. Yet none of them ever sees fit to draw public attention to them. One wonders why?

#### **MEANINGLESS RENUNCIATION**

It seems clear, therefore, that a renunciation of violence by Mandela, or for that matter by Oliver Tambo, the A.N.C. or the O.A.U. would mean precisely nothing. They would break their word the moment it suited them to do so. As good Marxist-Leninists they could do no other. Both Communist teaching and the history of the world since 1920 prove that you can in fact trust the Communists...... to be Communists.

Australians may believe that what happens in South Africa occurs far away and is no concern of theirs. If they ask themselves how they might fare with the Simonstown Naval Base in unfriendly hands it may alter their views. Australians should clearly realise that

as soon as South Africa becomes Azania it is certain that the same forces which have thrown the white man out of his colonies round the world will be focussed on them. Australia will then be put through the same wringer as the South Africans and the Rhodesians before them, by the same people and for the same reasons. It is not intended that when the New International Economic Order comes into being that Australia will continue to be held by the whites. With New Zealand and Australia transformed into Communist fiefs, as it is certain that they will be unless they bestir themselves at once and abandon their lunatic flirtation with multi-racialism, Lenin's dream will have become a fact: the white race will have been confined to Europe. The Anglo-Saxon race, which Lenin accurately saw as the only real obstacle to Communism's conquest of the world, will have been neutralised. An end to which the Communists have dedicated themselves unceasingly since 1920 will be realised. We repeat: you can trust a Communist — to be a Communist.

It will be noticed that the A.N.C. and the O.A.U. do not join issue with the South African Government because they allege that it is brutal, repressive or reactionary. Their sole reason for intending to destroy the South African government is that the South African government is white. They say so.

Mr. Hawke and the Eminent Persons Group, not to mention their advisers, must be aware of the O.A.U. view that multi-racialism is nonsense. This view is, as it happens, undoubtedly correct. Yet the expressed views and intentions of the O.A.U. do not prevent him from urging the South African government to accept multi-racialism, or from imposing multi-racialism in Australia.

## **POWER — SHARING?**

We may be sure that the liberals of the world will spring to Mandela's defence with the unanimity of the Brigade of Guards at drill. They will make two points. The first is that the E.P.G. has defined its task as being: "to encourage the South African government to adopt a genuine approach to power-sharing: an approach which accepts the ending of *apartheid* (separate development of the races) and seeks a negotiated settlement under which a non-racial and truly representative government may be established and the rights of minorities protected." What could be more "democratic", more "statesmanlike", more utterly unrealistic?

The second point which the liberals will urge is that, of course, Mandela will "renounce violence" before his release.

Let us dwell for a moment on that phrase about the protection of minorities. Australians to whom this stipulation sounds fair and reasonable might profitably ask themselves one question. It is this: Precisely what penalties will be imposed, and by whom, on a black government in South Africa which ignored the rights of minorities and proceeded to hammer hell out them? It must be obvious that no penalty will be imposed by anyone at all, no matter to what lengths the new government may go. The phrase is mere verbiage, designed to mislead, and the members of the Eminent Persons Group must know it.

ment" is well worth a second glance as well. It has cropped up round the world ever since 1945, as an inevitable prelude to a Communist takeover. In China, the Americans insisted on "a truly representative government." This, of course, included the Communist Party in the new government. As a result Mao Tse Tung replaced Chiang Kai Shek. The Americans still use it in their meddling in the affairs of South America. The rapid spread of Marxist-Leninist domination in South America is known to us all.

#### UNIVERSAL REPRESENTATION

The British, too, have always insisted that every party — including of course the Communist Party — should be represented in the new government to which they handed over each of their colonies.

The result is always the same: the Communists are the best funded, the best organised, the most brutal and ruthless, and the most skilled in intimidation. Inevitably they take over the new government. British and American politicians and their advisers always profess to be surprised when this happens. They must be the most permanently and thoroughly surprised group of men in the world. What would really be a cause for surprise, of course, would be any other result than a Communist takeover.
