## A NEW PHASE IN THE EMERGING GRAND DESIGN

A major constant in the history of Mankind has been the will-to-power. Irrespective of what label it has operated under, and through what type of organisation it operates — finance, politics, or industry — the will-to-power always feeds upon itself and has an insatiable appetite. And, as Lord Acton said, "All power tends to corrupt, and absolute power corrupts absolutely."

The concept of a World Government is as old as man, the concept being updated in accordance with changing circumstances. The First World War saw the emergence of the concept in the form of the League of Nations. The Second World War, in reality an extension of the First World War, produced the conditions suitable for a consolidation of the concept in the United Nations Organisation and associated international organisations like The World Bank and The International Monetary Fund.

On February 17, 1950, five years after the conclusion of the Second World War, James Paul Warburg of the German-Jewish international banking family which has played a major role in shaping the history of this violent century, told the U.S.A. Senate, "We shall have World Government whether or not we like it. The only question is whether World Government will be achieved by conquest or consent."

What has happened in the succeeding 40 years has confirmed this statement as a type of prediction made by a man who understood what real history was about, not a series of disconnected episodes but, as C.H. Douglas said, "crystallised politics."

Douglas pointed out the limited value of written history, which he described as "five per cent fact, and ninety per cent historian, even at its best. What value it possesses.... depends primarily on the historian, and secondarily, on the equipment of the reader — *on his ability to see the related facts in their true perspective.* "

Music is not created by merely playing a succession of tones; what is called melody emerges in accordance with how those tones are related over a period. Just as an appreciation of music depends upon the capacity of the hearer, so the value of written history depends upon the perception of the reader, to be able to discern if there is the equivalent of a melody running through the events related. But this requires a study of events over an extended period of time. Merely reading one chapter

of a novel will not reveal the plot, without which a novel is meaningless.

### DESIGN BEHIND THE CONVULSIONS

Which brings us to the major changes, which have taken place throughout the Communist world. These

changes must be seen, not as a forerunner to a basic change in the general direction in which the world has been moving throughout this century, but as an opportunity for a long term power policy to be pursued under different labels. Lord Acton observed that behind the smoke and smother of the French Revolution there was *design*. It is essential to look beyond the smoke and smother of the developments in the Communist world to discern a design which is becoming easier to see. This does not mean that those responsible for the design have deliberately created what has been taking place in the Soviet Union and Eastern Europe. Those responsible for what British writer Douglas Reed termed The Grand Design, the operators of International Finance and their various dupes, have over the centuries developed a highly organised intelligence system, and it is elementary that with their long view of history they would have an appropriate programme to advance as they realised it was impossible for the Communist Empire to avoid internal explosions as operated.

### SOVIET REALITIES

Mikhail Gorbachev is a remarkable politician by any standards, and he realised some years back what close observers of the Soviet situation had been pointing out as far back as the early seventies; that in spite of the massive economic blood transfusions from the West it was becoming impossible to sustain both the Soviet economy, the Soviet military machine and the Soviet's massive foreign aid programme to its client States like Cuba, Angola, Ethiopia and Vietnam. As far back as 1948, three years after the end of the Second World War, C.H. Douglas stated that, apart from being a fulcrum for the Wall Street International Finance, the Soviet Union was "finished". It had served its part, in a long-term programme.

As Solzhenitsyn has pointed out, the Soviet system did not develop out of an indigenous revolutionary movement, but was imposed from outside Russia. The German-Jewish International Bankers, with Jacob Schiff of Kuhn, Loeb and Company being prominent, had been preparing the groundwork for the Bolshevik take-over in Russia from early in the century. Only historical illiterates are unaware that the Bolshevik seizure of power in 1917 was financed by Wall Street, as documented by the former Research Fellow at Stanford University, Dr. Anthony Sutton, in *Wall Street and The Bolshevik Revolution*. Sutton made a major contribution to understanding real history with his first major work, *National Suicide*, in which he provided in meticulous detail, evidence of how the West had been used to industrialise the Soviet Union.

### A CONTINUOUS POLICY

A continuous policy of support was maintained over the years. Vital support was provided on three major occasions when disaster threatened: first in the early twenties when Lenin took his dialectical step backwards with his New Economic Policy; second during and after the Second World War: and third, in the seventies when massive Western economic aid was provided under

what was called *detente*.

The Soviet Empire was the creature of the International Money Power, and served the purpose of helping to destabilise the whole world, to poison the West with the totalitarian virus, and to direct vast economic resources to defence which otherwise would have been used for activities which would have increased pressure for financial changes to permit individuals access to mountains of production. The peoples of the world have been conditioned to believe that some type of a World State is inevitable. This is exactly what Trotsky and other Communist leaders taught. But what of Gorbachev, now hailed as a great "reformer"?

According to former President Reagan's wife, Nancy, she became bored with Mrs. Gorbachev's constant praise of Communism (comparing her unfavourably with the Queen as a person). What then does Mikhail Gorbachev mean by what is now widely proclaimed as 'the death of Communism'? Gorbachev has on numerous occasions described himself as a Leninist and a Marxist. He is, therefore, a self-proclaimed totalitarian attempting to shelter behind "Socialism with a human face".

### A NEW-LOOK SOCIALISM

Under the heading, GORBACHEV BACKS "HUMAN SOCIALISM", the Associated Press of November 17, 1989, carried the following dispatch:

"Mikhail Gorbachev declared solid support Sunday for reform in Eastern Europe by endorsing Socialism with a 'human face' - the slogan used by the Czechoslovakian progressives toppled by the Soviet-led invasion of 1968. With the East bloc in upheaval, the Soviet Communist Party daily Pravda published a 2½-page compilation of Gorbachev's thoughts on the future of Socialism. 'The new face of Socialism is its human face, this fully corresponding to the thoughts of Marx', Gorbachev said. 'Because its creation is the chief goal of restructuring, we can with full justification say we are building humanitarian socialism'.

But in order to build "humanitarian socialism" the new leaders of the Soviet and Eastern Europe have openly admitted that they wish to work closely in alliance with the International Money Power. Already a programme of joint economic ventures is well under way. The rapid expansion of this programme may be judged by the fact that during the two year period between 1987—89, 191 such ventures were signed, while during the first nine months of last year the number had expanded to 890. Multinationals like IBM are listed among those who have moved into the Soviet. Federal Reserve chairman Greenspan has visited to pave the way for the Reserve Board advice on the restructuring of the Soviet financial system. Sir Peter Abeles, the international transport monopolist, is moving in to assist Socialism with "the human face", as is his friend, the international media mogul, Rupert Murdoch. Top Zionist Isi Leibler of Jetset Travel, Australia, has signed a contract with Soviet Aeroflot and will train Russians on Jetset's computers in Australia. The New International Economic Order is taking shape.

## THE MERGER PROGRAMME

Moves to merge the "restructured" Communist economies with the Common Market are being openly discussed. However, in case there is any reluctance in the West to finance the flood of consumer goods so desperately needed in the Soviet Union and the Eastern European countries, the threat is constantly made that unless Gorbachev is supported by the West, he may be swept away. This point was made at the top-level "Chatanauqua Conference" held in the U.S.A. from October 30 to November 3. Over 250 Soviet officials and delegates were present. The central theme at this conference was how to have closer economic and political co-operation between the Soviet and the United States. One subject was "The Environment: Co-operation of the United States and the Soviet Union in Solving Global Problems." All this has a familiar sound to those who have studied the programme for establishing the World State.

There may be a deeper significance than appears in the White House statement issued just prior to Mikhail Gorbachev and President Bush meeting in the Mediterranean. White House spokesman Marlin Fitzwater said that 'we do not intend to have this emerge as a second Yalta.' It was at the infamous Yalta Conference of 1945 that Eastern Europe was betrayed by the Western Allies, left to be taken over by Stalin. The Yalta betrayal was endorsed by both Churchill and Roosevelt. The question is now being asked by those with long memories. "Is another Yalta in the making? Does the much-publicised 'reconstruction' programme mean surrendering to the global manipulators as they strive to create the World State? Is it a case of jumping out of the frying pan into the fire?"

## THE SHAPE OF THINGS TO COME

Already the shape of things to come is emerging in Poland, where the Socialists "with a human face" are imposing draconian measures in an attempt to meet the demands of the International Monetary Fund. There has already been a sevenfold increase in domestic coal prices, a doubling of liquid fuel prices, and a big increase in road taxes. The Polish standard of living, already low, is to be reduced by at least 20 per cent. According to the financial 'experts' advising the government, the austerity programme is essential to curb high inflation and to force "restructuring". Ironically, this is the type of programme Romanian Ceausescu imposed on the Romanians in order to wipe out its massive external debt. It is estimated that up to 80 per cent of Romanian food production was being exported while the Romanians went short.

The forces unleashed by developments inside the Soviet Union and Eastern Europe are not going to be controlled by the type of International Banker-imposed "reconstruction" policies of which Mikhail Gorbachev is a leading exponent. With the Lithuanian Communist Party declaring itself independent of Moscow, the first open crack has developed in the Soviet Union. Not even a flood of consumer goods from the West can prevent the growing ethnic conflicts inside the Soviet Union.

There are good reasons for believing that these conflicts have been much worse than reported.

It is foolish to attempt to predict the future in any detail, but what can be predicted is that while the current phase of the programme to advance the Grand Design is being intensified, it will produce violent reactions. As Douglas pointed out, the whole concept of an internationalism leading to the World State runs completely contrary to reality, with every attempt to advance the concept leading to greater disasters. It is now obvious that the U.S.A. is in a state of economic, political and moral decline. A new power grouping, ironically similar to that visualised by Hitler, may emerge in Europe and Russia under a united Germany.

## THE ANSWER TO THE POWER THREAT

The only long-term answer to the problem of the will-to-power is the effective decentralisation of all power, financial, economic and political. The old British world, developing organically from a philosophy of decentralisation, was the biggest threat to the World State concept, and was therefore the target of a campaign of destruction using both subversion and Money Power. Drawing the United Kingdom into a United States of Europe, masked originally as a Common Market, was a major feature of the Grand Design. But while the erosion of British sovereignty has been deep, the final surrender has yet to take place with the acceptance of a monetary union. At the very moment that the events inside the Soviet and Eastern Europe have created conditions for a major attempt to advance the Grand Design, British Prime Minister Thatcher has decided that she is not prepared to make the final surrender. She also displays a sensible caution concerning any reduction of British defence. Her Achilles Heel is, of course, financial orthodoxy. But she is a major factor in the current situation.

As in the past, the future of the world depends to a great extent upon the character of the Anglo-Saxon peoples everywhere, who traditionally have always been a stumbling block to power-lusters. Hopefully, the current dramatic plight of the world will inspire them to go back to their roots and regenerate that process of diverse and decentralised growth, which offered the future of Civilisation such a rich future. An appropriate financial policy is essential for this to happen. Social Credit is that policy.

### BASIC FUND CRISIS

# ZIMBABWE REAPS THE WHIRLWIND

Mr. Arthur Mutambara was arrested on October 4th after trying to escape from the Zimbabwean riot police by jumping from a second floor window.

He is President of the Students' Representative Council of the University of Zimbabwe: a left-winger and a vocal and provocative advocate of democracy and "academic freedom."

Mr. Mutambara had challenged President Mugabe's governing Zimbabwe African National Union (Patriotic Front) saying:

"The fact that ZANU has fought for this country does not justify them to loot, plunder and wreck the economy of Zimbabwe. ZANU has a worse human rights record than the government of South Africa or Ian Smith."

To speak such truths in Zimbabwe today is to court trouble. The students' protests led also to the arrest of the General Secretary of the Students Council, Mr. Enoch Chikweche. They led, too, to the closure by Mr. Mugabe's government of Zimbabwe's only university.

The police effected the closure with guns, dogs, batons and tear-gas, and the 8,000 students were sent home. At no time during the bush war did Mr. Ian Smith have to close the university!

## CLAMPDOWN

Soon afterwards Mr. Morgan Tsvangirai, General Secretary of the Zimbabwean Congress of Trade Unions, was arrested too. Since then there has been a stream of imprisonments, mostly of activists of Edgar Tekere's opposition party, the Zimbabwe Unity Movement. This latter has been denied meetings and locked out of stadia by the police prior to the recent by-elections.

Mr. Edgar Tekere is not an attractive character. He was responsible for the murder of Mr. Bill Adams and for the invasion and desecration of the Anglican Cathedral at Mutare. Regrettably his is the only effective opposition party left in Zimbabwe today.

Although Zimbabwe is still technically a multi-party state and theoretically opposition is still allowed, in practice the country is a one-party tyranny, and criticism of the leadership is suppressed.

Next April Zimbabwe will be celebrating the tenth anniversary of its 'uhuru' or freedom. But the freedom is a fake, and such liberty and well being as survive in Zimbabwe are due to huge western aid.

Zimbabwe and its people need our prayers now as they have never needed them before. Nothing but prayer and Christian concern stand between Zimbabwe and the misery of Mozambique and Angola — though, thank God, signs of improvement are now appearing in both these unhappy states.

## CHRISTIAN RESISTANCE

Those who fought so long and courageously for Rhodesia — more of them black than white — have been proved abundantly right. Over half the white population of Rhodesia is gone, and the once-proud Matabele have suffered unimaginably.

A manipulated "world opinion" is now hell-bent on reducing South West Africa (Namibia) and South Africa to a like fate. But Christians, unlike communists, do not give up. Marxism is in retreat.

Meanwhile legislation is being pushed through in Zimbabwe to abolish the Senate, to increase the size of the House of Assembly to 150 members and prevent MPs crossing the floor of the Assembly.

The proposed changes would also ensure that ZANU PF would need to win only 48 of the 120 contested seats to secure a

simple majority. This would be achieved with the aid of 12 members appointed by the President, surely which makes a mockery of democracy.

Measures are proposed which will, in effect, expropriate the white farmers upon whom the country depends for its own food and for the food it exports.

I have no space to write in full of Zimbabwe's growing unemployment problem, of the increasingly draconian application of the nine-year old state of emergency or of Zimbabwe's involvement in Mozambique's civil war. Nor can I describe the AIDS plague, which is devastating the population.

Christians inside Zimbabwe are doing much, though we hear little of their witness. Christians outside Zimbabwe must try to understand the reality of what is happening. And we must both pray and help.

## HOW TO ALLEVIATE SUFFERING

There are two practical ways in which we can help, apart from supporting active Christian work within the country.

Victims of the Rhodesian disaster are scattered throughout the world. Many have made good in other countries, but others have been deprived of life-savings and pensions: sickness and advancing age have made it impossible for others to fend for themselves.

In the face of this vast problem the efforts of the Rhodesian Christian Group are, indeed, small. But they do not seem small to men coming out of gaol with little more than the clothes in which they stand.

They are far from trivial to Rhodesians in dire financial straits, or even to those not very well off elderly Rhodesians whose all has been wiped out by the political changes and who are glad to receive a gift at Christmas.

We extend our heart-felt thanks to all those who have made donations over the past years.

Yet the smallness of our funds to help so many in need is a disgrace. What has happened to those men and women around the world who showed such generosity in the war years?

There are Rhodesians in desperate need now, while some of us — some of you — are living in relative comfort. We are not appealing to those who are struggling to make ends meet.

We are appealing to those of you who are looking forward to a comfortable Christmas, asking that you share that comfort with less fortunate Rhodesians.

## THE MENACE OF FEDERALISM

As the debate over the future character of the European Community heats up, so the identities and disposition of the opposing forces become clearer. The total spectrum extends on the one hand from those who wish to see Britain retrace its steps and come out of the Community altogether to those on the other hand who advocate total commitment to it, even including full acceptance of all the fundamental conditions for political, economic and monetary union spelled out in the Delors Report.<sup>1</sup>

Mrs. Thatcher's rejection at Bruges of the concept of a European superstate has both sharpened the divisions and, for the present at least, has narrowed the main issue to the retention of a Europe of sovereign states or the creation of a federal Europe with the inevitable diminution of national sovereignty implicit in that concept. At the very heart of this argument lies the question of control over monetary policy and the extent to which, *if any*, this can reside within a national government in the face of the drive by the international money power to enforce further centralisation. A good illustration of how this crucial issue cuts across party lines (with the Labour Party as yet strangely muted and divided on it) is afforded by the recent exchange in *The Independent* between Mr. Alan Haselhurst and Mr. William Cash, Conservative M.P.s respectively for Saffron Walden and Stafford.

Urging acquiescence in further federation, Mr. Haselhurst (2nd October) declared "Proposals for economic and monetary union are just another phase of the journey . . . . In an interdependent world, the inability of a national state to exercise effective control of its own affairs has long been apparent." He continued, "Mr. Cash and his Friends of Bruges seem to want to fight a battle against federalism today which may not have to be fought at all. In any case, what is inherently undemocratic about federalism? The Americans manage quite well."

Disputing this "wait and see" approach as "wholly unreal", Mr. Cash replied (4th October) that "The real problem is that, unless resisted, the vigorous pressure for federalism by some leaders in Europe will become an assumed part of our involvement in the European Community. We did not agree to this on accession in 1972, nor again in 1975 in the Referendum, nor in the acceptance of the Single European Act in 1986. Mr. Haselhurst claims that he is 'not aware of any preconceived plan' but seems unaware that Michael Rocard, Prime Minister of France, describes himself as 'a complete federalist', and of the recent advocacy by the five Christian Democrat leaders in Europe of Single European Government and a Single European Parliament. That is what convinces me where they would like to take us. This would inevitably imply the end of our Westminster Parliament in any real sense and the loss of our freedom to decide our political, economic and social priorities and, with it, the loss of our hard won democratic system."

That surely is the very nub of the argument and we can bring to bear on it just two of many historical examples of centralised government exerted against the wishes of the governed.

Remember Alberta? In August 1935, the first Social Credit government in history came into being in Alberta, having won 57 of the 63 seats in the provincial legislature. Despite great difficulties, it proceeded to enact legislation designed to introduce a Social Credit system of administration for the Province. But all these necessary Acts were either disallowed by the Federal Government or declared unconstitutional by the Supreme Court of Canada. Thus the democratically expressed will of the overwhelming majority of Albertans was totally frustrated by powers enshrined in the federal constitution of Canada.<sup>2</sup>

Let us now turn to the United States of America, another federal constitution. Despite its enormous natural resources and inexhaustible reservoir of human skills, its federal government is in debt to the tune of one trillion dollars, i.e., over \$1,000,000,000,000. U.S. taxpayers have to pay over \$100,000,000,000 in annual interest charges on this debt, money "borrowed" by successive federal governments from or through the Federal Reserve Board. This official-sounding name disguises the fact that the Board is not a department of the federal government but is actually a cartel of private banks constituted by the Federal Reserve Act of 1913. This Act is now claimed by the Committee to Restore the Constitution to have been passed in violation of the Constitution of the United States. The Committee is campaigning for its repeal and the restitution to the Congress of the sole power to control and regulate the issue of American money in accordance with the original provisions of the Constitution.

Under the heading "A Nation in Hock", the Bulletin of the Committee (September, 1988) lists the individual banks, which hold the controlling interest in the Federal Reserve System. According to Swiss and Saudi Arabian sources, reports the Bulletin, the Class A stockholders of the Federal Reserve are: Rothschild Banks of London and Berlin; Lazard Brothers Banks of Paris; Israel Moses Sieff Banks of Italy; Warburg Bank of Hamburg and Amsterdam; Lehman Brothers Bank of New York; Kuhn, Loeb Bank of New York; Chase Manhattan Bank of New York; Goldman, Sachs Bank of New York.<sup>3</sup>

The Bulletin further names 11 States whose State Legislatures have voted for repeal of the Federal Reserve Act. Other States are also claimed to be supporting this

move. Like the Albertans, however, their wishes will be frustrated by the federal constitution of the United States unless and until they can command the assent of the majority of the 50 States in the Union.

The parallel with the recommendations of the Delors Report is too obvious to miss. Paragraph 32 of that Report postulates the establishment "in a federal form" of a European System of Central Banks (E.S.C.B.) and says, "This new system would have to be given the full status of an autonomous Community institution". Its functions would include being "responsible for the formulation and implementation of monetary policy". Its "federative structure" would include "the establishment of an E.S.C.B. Council (composed of the Governors of the central banks and the members of the Board . . .)" and "national central banks, which would execute operations in accordance with the decisions taken by the E.S.C.B. Council" (our emphasis). On the status of the E.S.C.B. Council, the Report states, "the E.S.C.B. Council should be independent of instructions from national governments and Community authorities". Paragraph 33 spells out provision for the sanctions to be applied to any member State not complying with economic policy laid down by the Council of Ministers, thus "In the event of non-compliance by member states, the Commission or another appropriately delegated authority as envisaged in paragraph 31 would be responsible for taking effective action to ensure compliance; the nature of such action would have to be explored".<sup>1</sup>

In other words, the natives might not always remain quiescent and might have to be brought to heel. Truly we have been warned.

In the aftermath of the Alberta experience, C. H. Douglas made the following comment: "If the Social Credit Government of Alberta had done nothing — and it has done many things — to justify its existence, the demonstration afforded by its enemies of one fundamental factor in the world situation would still have made it a landmark in human history. That factor, completely demonstrated by the actions of the Canadian Federal Government in disallowing every Act of the Provincial Legislature directed to the inauguration of Social Credit, is that the Secret Government is determined to keep the world in turmoil until its own rule is supreme, so that one uninformed mob may be mobilised against another should either become dangerous. I do not think that anyone who will take the trouble to consider the actions of the Canadian Federal Government can fail to apprehend exactly why centralisation, Federal Union, and other 'Bigger and Better' governments are the most deadly menace with which humanity is faced today . . ."2

## **ZIONIST PROPAGANDA LOSING GROUND**

After dominating the propaganda field for many years, Zionists have in recent years been increasingly losing ground. The Leuchter Report, the first scientific study of the alleged Auschwitz gas chambers, demonstrates that no such gassing could have taken place, a devastating blow which finally resulted in British historian David Irving accepting that the mass gassing of millions of Jews was a hoax.

Probably the world's greatest authority on documents of the Hitler era, Irving had said previously that there was no record of any instruction by a German leader for the systematic destruction of the Jewish people.

The latest contribution to the progressive revision of much of the generally accepted history of the Hitler era, comes from the distinguished Jewish historian, Arno J. Mayer, who holds a chair in European history at the prestigious Princeton University, U.S.A. In his recently published work, *Why Did the Heavens Not Darken? : "The Final Solution" In History*, Mayer claims that the "Final Solution" simply meant the re-settlement of the Jews, once the Soviet Union had been defeated. Local, haphazard killing of Jews had taken place, but not because of any systematic destruction plan.

Mayer argues that at Auschwitz "more Jews were killed by 'natural' causes than by 'unnatural ones'. While accepting that some gassing took place, Mayer writes that "ultimately the execrable living, sanitary and working conditions in the concentration camps and ghettos took a greater toll of life than the willful executions and gassings in the extermination centres."

But while accepting that some gassing took place, Mayer admits that the studies of the gas chambers are rare and unreliable. Mayer's bibliography is interesting, and includes *The Hoax of Twentieth Century*, by Dr. Arthur Butz, a meticulously documented work, which completely demolishes the myth about the six million Jews allegedly gassed at Auschwitz.

Mayer also lists Rassinier, the former Communist interned in a German concentration camp, who subsequently exposed Zionist propaganda.

Critically reviewing Mayer's work in the October, 1989, issue of the journal *Commentary*, Jewish author Lucy S. Dawidowicz, concludes by saying, "That his (Mayer's) book has met with a generally cordial reception is a sign of the casual, or worse, ignorant and indulgent standards prevailing these days in the historical profession."

Which means that there is a growing challenge to the Zionist interpretation of history.

# EISENHOWER'S DEATH CAMPS

In our December issue we published a brief review of a disturbing book, *"Other Losses"*, by Canadian author James Bacque, which claims that General Eisenhower, later to become President of the United States, deliberately allowed one million German prisoners of war to die of starvation and disease in American and French camps at the conclusion of World War II.

As yet we have not been able to obtain copies of the Bacque book, although we have our own copy. Clearly every effort is being made to give the work the silent treatment. But reports of the book have resulted in some of those who survived coming forward with supporting evidence. The following article appeared in the September 24 issue of the *"Montreal Gazette"*.

On the sunny porch behind her elegantly appointed Beaconsfield home, Ruth Schnauss thumbed through two thick binders of typed notes and a sheaf of yellowed documents.

'My husband was a very meticulous man,' she said.

Her husband, Dieter Schnauss, died in 1975. Thirty years before that, in October 1945, he was a private in the defeated German army and a prisoner in a camp near Marseille.

In three remarkable letters to his mother — who had heard nothing from him for five months — he described the events since his capture by American troops that spring.

He wrote of days without food, of months without shelter or a change of clothes, of four-day train rides where 40 men squeezed into one train car, where the only 'toilet' was a hole in the cars floor.

And he wrote of deaths — in one camp, "seven per day, sometimes eight, never fewer than four."

Schnauss's letters are part of a rapidly growing body of evidence that supports at least some of the allegations in Toronto author James Bacque's new book *Other Losses*.

Bacque claims that American and French troops, led by Supreme Allied Commander Dwight Eisenhower, deliberately caused the deaths of a million German soldiers in camps after the Second World War was over.

## DOCTOR HAD NO ASPIRIN

In Montreal, Toronto, Ottawa and elsewhere, dozens of people are saying they saw those camps or suffered in them.

While some scholars and reviewers question Bacque's numbers or his motives, a growing number of Canadians are saying the camps he describes were real.

Werner Borrmann, 69, who now lives in St. Hubert, can describe in detail his term in the American camps at Bad Hersfeld and Bad Kreuznach, near Frankfurt.

At Bad Kreuznach, "there was one tent . . . where there were very, very sick prisoners. I went because I had a wound in my leg that was pussing. The German doctor there said, "I'm sorry, I don't have any aspirin."

"I could not walk. I was in very, very bad shape."

Borrmann said he heard that at one camp, desperately ill prisoners were forced to walk until they collapsed. French guards would tell the prisoners their suffering would be over if they signed papers volunteering for service in the French Foreign Legion.

Bacque's book, which Borrmann said he had not read, tells the same bizarre tale of French guards forcing prisoners to volunteer for overseas service. Many of the "volunteers", Bacque wrote, ended up with the French forces in Vietnam during the early days of the conflict there.

In the camps, Borrmann said, 'people were dying like crazy.' At night, "they lined the bodies up and then the dump truck came and the guards put them on the truck."

Another survivor of the camps is Wolfgang von Richtofen, 80, who lives in Toronto.

Von Richtofen, an army captain, was captured in a German field hospital on May 1, 1945. He and thousands of others were made to stand overnight in an orchard in the Hartz Mountains, then taken to the Buderich camp near the Dutch border. Von Richtofen went to two other camps before his final destination,

Wickrathburg, and was transferred from American to British control at the end of June.

"The British released me - the next day, as a matter of fact," von Richtofen said in a brief telephone interview.

But in the two months that von Richtofen was held by the Americans, "people were dying, unfortunately, quite a number every day."

Heinz Boldersen, now living in Longueuil, wasn't in the camps. But as a 10-year-old living near the Kulnbach camp in northeast Bavaria, he saw some of the effects.

His landlady's son was in the camp, which Brodersen said held between 1,000 and 3,000 men. The landlady used to take young Brodersen near the camp, because the American guards there wouldn't let civilians closer than 50 yards to the barbed-wire fences and Brodersen was able to throw boiled potatoes that far to the starving prisoners.

The prisoners had no shelter.

"Why were they in an open field?" Brodersen asked.

## FOOD BURNT AT NEARBY MESS

"Two hundred yards away, there was an abandoned truck assembly plant. There was a brewery beside that."

His landlady's son was released in August.

'He looked like my uncle, who came back from five years in Siberia," Brodersen said. Four months later, the 20-year-old man died.

McGill University history professor Peter Hoffman was 15 years old, visiting his grandparents in Ulm, when he saw the camp there.

"I saw thousands of soldiers who were sitting on the ground and had no food, no room, nothing," Hoffman said.

"There was an American officers mess across from the camp, where they burned their thrown-out food."

Conditions for civilians in the area were 'a little unsettled', Hoffman said, 'but we lived. You could buy flour and noodles and the like, not in unlimited quantities, but it was available.'

But the prisoners, he heard, were starving, and the local rumour-mill said 'the Red Cross could do nothing for the Germans.'

Bacque's book, which Hoffman read in manuscript form, claims that trainloads of food and supplies sent by the International Committee of the Red Cross were turned away on Eisenhower's orders.

As remarkable as the eyewitness descriptions and the Schnauss letters are, the most detailed account of the camps to come to light so far is *In Der Pferchen* (In the Furrow), a diary published in Munich 24 years ago and written while its author, Benno Tins, was a prisoner in four camps along the Rhine River.

Tins's book, of which Bacque was unaware, says that on one day in the Welda camp, 500 prisoners fainted from the heat. The camp held prisoners as young as 12 years old, and as old as 70.

In the camp at Sinzig, Tins had a 40-degree fever, but received no food for three days. At the Koblenz camp, a prisoner was beaten to death for stealing milk powder.

At Koblenz, Tins write, 'they talk of 20 to 30 deaths a day in the camp hospital.'

In a passage written after the bulk of the diary, Tins laid the blame for the camps on Eisenhower — just as Bacque has in his

new book.

"I hear there a as a system in the constant change of camps,' Tins wrote.

"Eisenhower is supposed to have said, 'We shall not torture them as in the concentration camps, but we shall move them from base to base, camp to camp. That should do it,' It did."

Inevitably Bacque faces at least one accusation of "sinister motives" in writing his book.

In a review of Bacque's book in the September issue of the B'nai B'rith Covenant, Rich Kardonne writes:

. "There are only scant references to the Jewish Holocaust in this book. Is a possible motive behind the writing of this book an attempt to belittle the Holocaust by concocting a similar genocidal catastrophe directed against Germans, so that somehow, the Jewish Holocaust loses its uniqueness? . . . .

#### CRITICISM CALLED IGNORANT

"Is this book merely another form of Holocaust denial?"

In a telephone interview from Paris, where he is researching his new book, Bacque called the review "a very ignorant article and it'll do damage to B'nai B'rith but not to me."

Asked if he was trying to belittle the Holocaust, Bacque laughed.

"What a ridiculous question. Really."

## DEBT AND RURAL DESTRUCTION

Temporary increases in prices for rural production, such as wool prices in Australia tend to mask the progressive destruction of rural communities throughout countries like Australia, New Zealand, Canada and the U.S.A. The relentless increase in financial costs more than offset price rises. The cost-price squeeze fuels the drive to abolish the smaller family farm in favour of large-scale corporate farming, this claimed, of course, to be more 'efficient'.

In the distant past the National Party of Australia advocated a policy of long-term, low interest rates as a policy designed to help produce stability throughout the nation's rural communities, and the local towns, which serviced them. But today the same party endorses the programme for de-regulating banking, making it possible for 'the big international banks to move in. Allegedly the increased competition would result in lower interest rates.

High interest rates are one of the most crippling burdens rural producers have to bear. While suburban Australians are complaining about high mortgage rates of 17.5 per cent, interest rates to farmers and small rural businesses are approximately 24 per cent. Relatively higher wool, wheat and beef prices have allowed many farmers to cope, even if with difficulty, with high interest rates over the past four years. Even so, farm indebtedness to the banking institutions has continued to rise, reaching \$8.4 billion last year. This is an increase of \$1.3 billion since 1985.

But now with falling rural prices further rural disaster is inevitable, unless there is a change in financial policy. An example is provided by Mr. Hartley Pederick in the small West Australian wheat town of Wagin. The Pederick family has run the engineering project for the past 60 years, manufacturing a wide range of rural equipment and providing employment for workers whose families help to sustain the local business community and professional services. Mr. Pederick warns that Wagin and tens of thousands of other towns like it around Australia are threatened with a major financial crisis. He is reported as saying, "The cost on a town like this of high interest rates is many fold. Farmers reduce their buying power that adds pressure on shops, which also have loans borrowed on high interest rates. Many of the shops around here will not be able to survive the next downturn that is coming."

Rural communities not only produce food and textiles; they also nurture the type of people who as far back as the days of the Roman Empire have been the best type of citizens. The destruction of the rural communities of the Free World can even produce a situation where adequate food supplies will no longer be available. Abundance is always a threat to the debt creators. Poverty amidst plenty has historically produced revolt against Money Power. The Money Power's answer is to make every endeavour to ensure that plenty of what people really want, primarily food, clothing and shelter, is not readily available. Artificial shortages are an excellent excuse for implementing rationing mechanisms.

It only seems like yesterday when desperate farmers were marching on Canberra protesting against the intense rural crisis of the time. It was argued that the farmers needed a stronger rural organisation in the shape of the National Farmers' Federation, which given adequate money could provide protection. Many farmers increased their overdrafts to contribute to a Fighting Fund, which possibly reached \$15 million. But the end result has been that thousands more farmers have been forced off their properties while interest rates have soared to record heights, with a coming Federal Election producing the only suggestion that they will be reduced, however marginally. We cannot recall the National Farmers Federation launching any national campaign against a financial policy destroying those the NFF is supposed to represent.

A growing rural crisis is going to be one of the major factors in the Battle for the World.
