WHAT COMES AFTER COMMUNISM?

While it is clear that the peoples of the Soviet Empire are breaking free of the worst features of the totalitarian system under which they have suffered for 70 years — mainly the system of terror directed by the feared K.G.B. — it is far too early for hats to be thrown into the air with the joyful acclamation that a new and better era is arriving for mankind. Consider the plight of the Eastern European peoples, only yesterday caught up in the euphoria of developments like the tearing down of the Berlin Wall. Solidarity hero, Lech Walesa, presides over a Poland in deepening crisis as it attempts to follow the financial advice of the International Monetary Fund. Unless the victims of Communism can now challenge financial orthodoxy, they, along with the rest of the world, are doomed to never-ending convulsions.

Events are moving with such rapidity that it is impossible to predict with any certainty detailed developments concerning the break-up of the Soviet Empire. But we can be sure that International Finance, with its intelligence services, has been carefully monitoring the situation with a careful eye to the future. Of special interest is the fact that the Ukraine and other republics are moving towards creating their own currency. Even before the abortive coup, Gorbachev had entered into an agreement with nine of the Republics, granting them greater financial independence in an attempt to get their co-operation for his proposed reforms of the Communist Party. The central feature of this policy was that the Republics would remit money from taxes to help finance the central government in Moscow. Significantly, the Bush administration, with Dr. Kissinger as one of the main advisers, expressed great concern about this development.

GORBACHEV FAVOURED BY INTERNATIONALISTS

OUR POLICY

The tumultuous developments, which have followed the coup attempt, have proved both a serious rebuff for Gorbachev, possibly ending his political career, and a disturbing development for the International planners.

It is important to recall at this time that the imposition of Bolshevism upon Imperial Russia was financed by the International Money Power which dominated the Versailles Peace conference at the end of the First World War, which left behind it a legacy of problems which have been exploited in furthering the To encourage electors always to record a responsible vote in all elections.

Without the backing of the International Money Power, the Soviet Empire could never have been sustained as long as it was. But the Soviet defeat in Afghanistan, coinciding with the serious growing deficiencies in the Soviet economy, forced Gorbachev and other senior members of the Soviet Politburo to realise that they were faced with a threat of disintegration. A major dialectical step was essential in an attempt to maintain a secure base from which the long-term Marxist-Leninist objective could be pursued. Following the lead of Lenin with his New Economic Programme of the early twenties, Gorbachev had to turn to the West for economic assistance.

THE RUSSIAN FEDERATION

But Gorbachev unleashed developments, which eventually he could not control. Universal hatred of Communism as practised in the Soviet Union, combined with the forces of nationalism, has resulted in massive revolts. But important realities remain. One is the Russian republic. Far-sighted observers have always stressed the tremendous political importance of Russia in world affairs. In his classic work, Democracy in America, French writer Alexis de Tocqueville predicted as far back as 1835, that Imperial Russia had the potential to become a major world power for the same reasons that he saw the United States emerging as a great power: a big geographical base, abundant natural resources and a growing population. De Tocqueville wrote before the American Civil War, a conflict that basically had nothing to do with slavery, but was the result of the Northern States insisting that the Southern States must not be allowed to secede from the Union. Whatever virtues Lincoln may have had, he was the instrument of the forces of centralisation. The question of power is the basic issue which is going to determine the future of Russia and policies concerning the constituent parts of what was originally Imperial Russia, and later the Soviet Union. Just as Hitler took over and consolidated the centralised Germany created by Bismarck with the support of the Socialists, Lenin and his Bolsheviks imposed their tyranny on the foundations of Imperial Russia.

Whatever finally emerges from the current situation in the former Soviet Union, the Russian Federation will be the biggest single State, with a population of 150 million, easily the largest population on the European continent, with a vast territory dwarfing in size any other European nation. The second biggest nation in size, France, is only a thirteenth of Russia. Already Boris Yeltsin is causing concern in neighbouring Republics, with the suggestion that there will have to be a "re-adjustment" of borders where there are sizeable numbers of Russians living in those Republics. Such a move must encourage movements for the realignment of present borders, which have resulted in large ethnic minorities in European, Central and Southern Russia, with its big and fast-growing Muslim communities.

As in Eastern Europe, the millions of hard-line Marxists in the vast bureaucracies, which ran the Soviet Union, are not going to go away. Irrespective of what they call themselves, the Marxists and their influence are going to remain. Free market policies cannot, in the absence of a change of financial policies, solve the basic problems confronting those who have lived under Communism for 70 years. And there remains the problem of the massive armoury of nuclear missiles, the bulk of these to be located in the Russian Federation.

A CHANCE TO DECENTRALISE


Any Western economic help to Boris Yeltsin and his colleagues should be linked with insistence that the current decentralising developments throughout the former Soviet Union continue and be stabilised. But such a programme would run contrary to the centralising philosophy of the New World Order advocates. That philosophy has been badly dented by developments in both the former Soviet Union and Yugoslavia. Now is the time for the peoples of the English-speaking world to redouble their efforts to oppose all aspects of the New World Order and to press for decentralisation, particularly concerning the creation of financial credit. It is possible that a new era is about to open in the world drama.

"THE MONOPOLY OF CREDIT"

By C.H. Douglas

In an Introduction to the Centenary Edition, 1979, Dr. Geoffrey Dobbs points out how world events have continued to demonstrate the central theme of "The Monopoly of Credit." The inflation, which Douglas warned about, has become the most destructive social factor threatening Civilisation.

Without a study of this book, no one can express an intelligent opinion on the deepening crisis now afflicting what is left of Civilisation. It opens the door to real understanding of world politics.

THE WILL-TO-POWER

"The danger which at the moment threatens individuals liberty far more than any extension of individual enterprise is the Servile State; the erection of an irreversible and impersonal organisation which the ambition of able men, animated consciously or unconsciously by the lust for domination, may operate to the enslavement of their fellows....

"In attacking capitalism, collective Socialism has largely failed to recognise that the real enemy is the will-to-power, the positive complement to servility, of which Prussianism, with its theories of the supreme state and the unimportance of the individual (both of which are the absolute negation of private enterprise) is only the fine flower; and that nationalisation of all the means of livelihood, without the provision of much more effective safeguards than have so far been publicly evolved, leaves the individual without any appeal from its only possible employer and so substitutes a worse, because more powerful tyranny for that which it would destroy

"Because the control of capital has given power, the effect of the operation of the will-to-power has been to accumulate capital in a few groups, possibly composed of large numbers of shareholders, but frequently directed by one man; and this process is quite clearly a stage in the transition from decentralisation to centralised power. This centralisation of the power of capital and credit is going on before our eyes, both directly in the form of money trusts and bank amalgamations, and indirectly in the confederation of the producing industries representing the capital power of machinery. It has its counterpart in every sphere of activity: the coalescing of small businesses into larger, of shops into huge stores, of villages into towns, of nations into leagues, and in every case is recommended to the reason by the plea of economic necessity and efficiency. But behind this lies always the will-to-power, which operates equally through politics, finance or industry, and always towards centralisation. If this point of view be admitted, it seems perfectly clear that to the individual it will make very little difference what name is given to centralisation."

FABIANISM

"Fabian Socialism is a formulation of Marxism, which in turn is a formulation of a conspiracy whose documental existence goes back more than a quarter of a millenium. This genealogy of Fabianism guarantees the use of force in the last resort. The idea of world government has for those who entertain it the force of religious conviction. The idea of dialectical materialism is a metaphysical idea, in which history is conceived as a force bringing about events inevitably but through the agency of beings under a supra-national necessity to carry out its dictates. Thus, Professor Laski again: '... *The main issue the Left has to decide is when it will co-ordinate its forces for the victory which is its historic right.... ' (New Statesman, June 5, 1943)*. Laski envisaged a full understanding with the leaders of the Soviet Union, to give to the revolution 'a creative power against which the forces of reaction will hurl themselves in vain'. "

THE MERGER OF PEACE AND WAR

The following article appeared in "Home", a British quarterly providing "A Review of Policies As Seen From The Home". "Home" is edited by Mrs. Elizabeth Dobbs, Bodifyr Lonpobty, Bangor, Gwynedd, LL 57 1HT, United Kingdom.

"War is nothing but the continuation of politics with an admixture of other means."

This is the full translation of the much-quoted dictum of the Prussian general Karl von Clausewitz. Usually the 'nothing but' and the 'admixture' are left out. Either way, it has a corollary, namely that *what we call 'Peace' is the continuation of war by means other than military;* although nowadays there is an increasing admixture of violent, sub-military means such as bombterrorism and rioting, tending towards the merging of the states of 'peace' and war.

It requires only the briefest reminder of the history of this century of wars interspersed with economic crises, revolutions and famines to illustrate the point. The century itself started with the Boer, or South African war, which is being continued to this day by economic means. Viewed in this light we have had a continuous World War by one means or another from the Great War of 1914-18, through the Great Depression, the Soviet. Nazi and Fascist Revolutions, Phase II of the military World War, followed by the disintegration of the British. French and other Empires, the vast Communist Revolutionary conquest of China, the reduction of Africa to a misery of endemic wars, rebellions and famines, and the successful conquest of Europe by monetary and economic means, starting with a Common Market. And this, of course, is to mention but a few examples.

It is safe to say that not one of these disastrous events was desired by 95 percent of the common people who were subjected to them.

As we write this the latest phase of world political warfare includes a monetary recession, a dire economic situation in the disintegrating USSR with reversion to 'tank politics,' in Africa mass-starvation threatening in war-torn Ethiopia, Sudan, Liberia, Mozambique and Angola; and a new and unique form of warfare in the Middle East.... (We regret that at this point one line of Mrs. Dobb's article was lost in transmission. The meaning, however, is clear — emphasising the difference between the Gulf and Falkland wars. — Ed.) Falklands, but there patriotism and kinship were involved in the war, in Kuwait and the Gulf the interests are commercial and financial. Indeed, with the war scarcely fully engaged there was already public bargaining about what share we shall get in the rebuilding of Kuwait.

WHOSE NEW WORLD ORDER?

The major economic interest in the whole region is of course oil, without which most of our rush-about civilisation would grind to a halt. Iraq, which was armed and supported by half the World in its unsuccessful invasion of Iran, was now equipped after eight years of grim warfare to take over all the other 'oil States' in the region. This threat was bound to be met in some way. But we are not being told that our men were out there to fight for Queen and country, for British interests, or even for oil, but for the New World Order as represented, at least in embryo, by the UN and its Security Council. We, and they, were not asked if we wanted a New World Order, let alone perhaps to kill and die for it, but we now have an opportunity to see what it would be like in practice since this is widely claimed to be the first major demonstration of its multinational world power. of governments by attacking the people under their rule, it may be said that the primary war is the direct attack by propaganda on the minds of the people, then follows the economic assault on their health, comfort and nutrition, and the final admixture is the military assault designed to maim or kill their bodies, but even this is only as a means of breaking the will. With this war we are assured that the mind of one man, Saddam Hussein, has to be changed. Has it been?

In former times there was little opportunity for the mental assault then limited by the carrying range of the human voice and eye. Today the extent and power of the mental weaponry are even greater than those of the physical armaments. In all modern wars this weaponry is directed *mainly* at the 'home' population, only secondarily and to a minor extent at the enemy who does, in any case, hear or see and study it all. It was mainly the 'home' media, which defeated the USA in the Vietnam War. But in this Gulf War the propaganda contest is quite unprecedented.

JOINT IRAQI-ANGLO-U.S. PROPAGANDA

On the American side we had, at the outset, almost continuous, repetitive non-news, going on and on about the tremendous blasting the Iraqis were getting from the air, well calculated to arouse sympathy for them, at least among that quarter of the European population who can remember being at the receiving end of such assaults. We had endless speculations and opinions about the results; the same repeated every half-hour or less *ad nauseam*.

But from the Iraqi side we received, astonishingly, the familiar accents of our own nationals — not of abhorred traitors and quislings, but of named journalists and broadcasters such as Alan Little of the BBC. At the start we had the Iraqi News from the same US agency (CNN) as the American News. Later, foreign journalists were expelled from Iraq, but then invited back again for a short stay, to do a splendid job of describing, in censored but most moving and effective terms, the horrors and pitiful effects of Allied bombing on women and children in Baghdad. Whether it was a trap or a blunder, the worldwide broadcasting

It has become virtually a State in itself and far more powerful than most States. Though some editors, broadcasters and journalists may be patriots, their work and careers are ruled, through owners and advertisers by *money*, which is worldwide and without national or cultural allegiance. Hence the wielders of money-power are automatically inclined to the promotion of a World Order, of which they are already a sort of advance guard, controlling much of public opinion, politics, economics and armament. The bloodless conquest of the nations of the E.G., after Hitler's temporary New Order had 'softened' them is their major achievement to date.

humanity itself, is under bitter attack in what remains of Christendom — the instinct to defend the family, the clan, the territory, the nation, the group of our own sort, against the alien and the firm in the faith, which we have received and which alone, if unforeign invader who attempts to 'unify' us with his power-group. will turn out. There is no need to add to the innumerable speculations about it; but the underlying conflict of religions and their expression in policies is much more our concern.

Much is made of the Islamic religion of Iraq, and Saddam Hussein has been trying to make his warfare into a *jihad* or Moslem holy war. In fact, he is a Ba'athist, a mixture of Marxist and Pan-Arab imperialist and has no right to call a jihad, far less so than, for instance, Saudi Arabia. THE WORLD POWER-RELIGION

On the other side we have the UN Security Council, dominated by the Super-Powers, USA, USSR and China, plus at present, two middle-sized ex-colonial nations, Britain and France, due, no doubt, to be replaced by another Super-Power, the EC, as soon as it can be consolidated. If one looks for a common faith, which binds these powers and the many nations of the UN together, there is only one: the worldwide loan-credit system, which is not usually recognised as the religion it is.

But along with this is the much-promoted new One-World religion that attempts to merge all other beliefs, and is corrupting Christianity into a Unitarian Judaeo-Christianity — quite compatible with the failing atheistic Marxism of the Communist Super-Powers — and with almost anything else. The only great religion, which has challenged this Merger, is the Islamic faith (though by no means unaffected). So it seems that, at a deeper level, the removal of a powerful Ba'athist Iraq will but clarify the fundamental conflict between Islam and the World Order ideology.

On which side are we? Neither! We want a World dominated of power. 
FROWNS FOR ISRAEL

A startling number of young Jews are suffering from anorexia and other nervous disorders, the first national conference on mental health in the Jewish community, held in Leeds last month, was informed. Ms. Marilyn Lawrence, a senior clinical lecturer at London's Tavistock Clinic said that she was surprised by the very high proportion of young Jewish anorexia patients. Other psychotherapists, she said, were reporting that up to 50 percent of referrals were Jewish.

There may be some connection between this phenomenon, reported in the London *Jewish Chronicle* (May 17), and the highly invidious situation in which Jews in general find themselves as a consequence of recent developments in Israel and the occupied territories.

Commented the London *Daily Telegraph* on May 24: "Israel is looking more beleaguered than ever these days. Its more candid friends are openly criticising it over the impasse that has befallen Mr. James Baker's four attempts at Middle Eastern peacemaking'. President Bush, the paper pointed out, had endorsed his Secretary

More surprisingly, the outgoing Chief Rabbi, Lord Jacobovitz, had criticised Israel's policy towards the Arabs as a 'stain on humanity'.

Sharp criticism has been coming from some unexpected quarters. Sir Yehudi Menuhin, the violinist, in Jerusalem to collect this year's Wolf Prize, was listened to in stony silence as he said from the podium: 'One fact is surely abundantly clear, namely that this wasteful government by fear, by contempt for the basic dignities of life, this steady asphyxiation of a dependent people, should be the very last means adopted by those who themselves know all too well the awful significance, the unforgettable suffering of such an existence.'

Asked why he had chosen to make a political speech at a prize-giving ceremony, Menuhin replied: 'where else could I have made this speech? I came here to deliver this speech.'

One of the speakers at the conference on mental health remarked that the high incidence of nervous disorders among young Jews 'could have links with the Holocaust'. That could be so but in what way? It seems unlikely that young Jews today would be more acutely disturbed by events of the World War 2 period than their elders. A more likely explanation is that historical revisionism, which has been fast draining all credibility out of the gas-chamber story, has deprived many young Jews of a framework of beliefs, which helped to harden them against all criticism of the community. In other words, as Lord Jacobovitz suggests, the moral factor, one of life's great imponderables, is beginning to weigh heavily on them.

Words used by Churchill about the Soviet Union, 'a riddle wrapped in a mystery inside an enigma' are equally applicable to Israel — a 'national homeland' from which Jews who arrive there from the Soviet Union escape just as soon as they can find somewhere else to go. Recently, according to the London *Jewish Chronicle* (May 17), two hundred such migrants, rather than stay in Israel, travelled on to South Africa, where they have become a burden on that country's dwindling Jewish minority.

Anxious to maintain their numbers against an increasing Arab population, the Israelis, usually so strict about Jewish identity, are now ready to accept Jews of whatever cultural completion, from anywhere, and air-ferried some 18,000 'Black Jews' or Falashas, from Ethiopia. And about 18 months ago they flew in 50 Peruvian Indians, having, as Christopher Booker remarked in the *Sunday Telegraph*, 'found some extraordinary theological reason for designating them as Jews'. To such lengths are the architects of a planned New World Order prepared to go to preserve the illusion of a Jewish national home which they need as an Archimedean point of political and military leverage in an area regarded as strategically of vital importance.

All this must be very confusing for young Jews trying to make sense of the rapidly changing mental world in which they find themselves.

TAXATION REFORM

All schemes for taxation "reforms" are based upon the false premise that governments must have taxation in order to operate. Taxation has long since been the only means by which governments finance their activities. Recent Australian Federal and State budgets have included major deficits, which almost certainly will be even greater than budget estimates. Where do these thousands of millions come from? They are, of course, created by the banking system. They will increase the total indebtedness of both Federal and State governments, this in turn increasing interest charges. "Opposition" politicians invariably criticise governments' budgets, but never raise any questions about how much taxation is used to meet debt charges. They endorse the view of C.H. Douglas, that in reality there is only one party, the Financial Party.

Modern governments operate a form of subtle dictatorship through the taxation system. For every dollar taken from the taxpayer, they give him back, in various ways, a fraction of what they have taken, with conditions imposed. Special interest groups such as those involved in the multicultural growth industry are given favoured treatment with an eye to potential voting support.

Any genuine reform of the taxation system would start with a drastic reduction in total taxation, instead of attempting to juggle the impact. Collection should be simplified to the point where everyone knows the total amount of taxation being paid. But this would cause such a shock that a major tax revolt would occur. The present system is designed to ensure that the individual is not fully aware of what he is surrendering to governments. All forms of taxation like a General Services Tax are designed to ensure as far as possible that no one escapes the taxman's net. The false argument is advanced that a GST-type tax will ensure that taxation is "fairer", the inference being that taxation would be lower under such a system. No one can point to any country where total taxation has been reduced as a result of consumption taxes.

The real purpose of the modern taxation system is to control the individual, not to provide necessary government revenue. A spokesman for the Australian taxation department has recently expressed concern about the rapid growth of different kinds of barter systems. Barter systems are expanding for the one basic reason: people are desperately short of purchasing power because of the current restrictive financial system. Those engaged in bartering systems are not interfering in any way with the alleged purpose of the present financial policy, one major objective being to keep the inflation rate low. But the barter system increases the purchasing power of the people without contributing in any way to price rises. And it helps to increase the living standards of those engaged in this form of economic activity.

Irrespective of the type of taxation "reform" imposed, with the majority of people finding the total level of taxation repressive, they will seek to minimise its impact. Attempts to make taxpayers conform leads inevitably to the totalitarian State.

schoolgirl, after watching the Gulf War on television, remarked how marvellous it was that war could now be conducted without killing people!

The big loser in the Gulf War was the wretched Palestinian people and the Iraqi civilians, who in spite of smart bombs, were killed by the thousand. The video films being carried by American bombs were carefully sanitized before being shown on the world's television screens. The mass destruction of Iraqi civilians has only become known later. Conditions in Baghdad are a frightening testimony to what can be done with modern hi-tech destructive power. With the whole infrastructure of Iraq destroyed, it is not surprising that there is widespread disease and near-starvation, except for Saddam Hussein's ruling group.

Was it really necessary to inflict such barbaric destruction on Iraqi civilians in order to achieve the alleged objective of forcing Saddam Hussein's troops out of Kuwait? These troops were defeated, not by the mass killing of Iraqi civilians, but by the superior military power used against Iraqi troops in Kuwait. But when these demoralised Iraqi troops sought to flee the carefully sanitized pictures showing on the world's television screens did not show what became mass slaughter. Reporters have now revealed how they arrived too early at one scene of destruction before the scene had been sanitized for television audiences. Tens of thousands of Iraqis were piled in heaps ready to be bulldozed into mass graves by American troops, some of these sickened by the task.

As more evidence emerges, it is not surprising that many British and American pilots also became sickened by what was virtually a programme of mass killing of defeated and demoralised Iraqi troops.

In the meantime, there is no democracy emerging in Kuwait, while the whole of the Middle East is now more destabilised than it was before the Gulf War. The West was also the big loser, and will pay a stiff price for the Gulf "victory" in the years to come.

WAR VIA TELEVISION

CHRISTIE ''ON THE LINE

On Saturday, May 4th, Doug Christie appeared on the C.B.C's news network's national television open line show called "On The Line". It asked the question, "Should there be special rules for teachers?" Ironically, that so-called defender of liberty, Alan Borovoy the Jewish General Counsel for the Canadian Civil Liberties Association said definitely "yes" to the question! His reasoning was that teachers like Malcolm Ross set a role model and must be free of discrimination or minority children will be disadvantaged. He maintained that a teacher who held views, which were so extreme as to create a reasonable apprehension of bias, could not remain a teacher even in a school district where no such minority children were students because they must be open to such students.

The videotape is interesting and shows Mr. Christie being calm and rational while Mr. Borovoy is extremely agitated and hostile. He could not shake hands with Mr. Christie at the outset of the show.
