Next month Kevin Rudd flies to Copenhagen to help seal a United Nations deal to cut the world's emissions – and to make Australia hand over part of its wealth. So keen is the Prime Minister to get this new global-warming treaty signed that he's been appointed a "friend of the chairman" to tie up loose ends.

THE GREAT IMMIGRATION NON-DEBATE CONTINUES by James Reed: Immigration continues to dominate the headlines. The opinions expressed by the chattering class are interesting and deserve analysis and critique. Greg Sheridan, foreign editor of *The Australian* in an article "Europe Looks Down Under for Answers on Immigration" (*The Australian*, 24-25/10/09, p.23) gets off to a good start by saying: "Uncontrolled Muslim immigration into Europe has been a public policy failure, if not an outright disaster. This is the view of most Europeans as measured by opinion polls and of a large number of European officials and politicians. Having spent a month in Europe, talking to dozens of officials, politicians and immigrants, it is a view I reluctantly share."

Sheridan is worried that the illegal Islamic boat people coming into Australia represent the thin-edge-of-the-wedge and once established will result in a flood. Indications are though that this has already happened. The likes of Sheridan represent the sentiments of "big immigration" which says to the world that Australia needs people to grow, that we want to expand our population without end. For the likes of Sheridan, there are seemingly no ecological limits to Australia's growth. This sends a clear message to the illegals to come here: why shouldn't they? It is the same pro-growth sentiments that led to Europe's immigration disaster which Sheridan described. Consequently Sheridan's position is logically inconsistent.

Tim Soutphommasane, a rising intellectual star of multiculturalism and author of "Reclaiming Patriotism", argues in his piece "Human Rights Can Thrive Alongside National Values" (*The Australian*, 21/10/09, p.14) that the asylum-seeker debate "exposes conflicting ideas of citizenship". Asylum seekers (illegals) aim to start a new life in Australia.

Cosmopolitan values mean that when "push comes to shove, [cosmopolitan rights] should trump any right of nations to territorial integrity." For the cosmopolitan, there are no real moral distinctions between nationals and strangers. To his credit, Soutphommasane recognises that a "world in which borders no longer count remains a distant dream" and that most Australians oppose open borders cosmopolitanism. But he thinks that a "fair go" should be given to boat people and he takes the middle ground of there being a more "liberal approach to asylum seekers".

Even this approach essentially dooms Western civilisation to a *Camp of the Saints* tragedy of the commons scenario as one wave of asylum-seekers leads to another and in turn to endless chain migration. The middle-of-the-road position is essentially the Whitlam-Rudd position, which has put Australia on the immigration treadmill. Rudd himself in an interview with Kerry O'Brien said that he believes in a "big Australia": "I actually think it's good news that our population is growing". But also being a trendy, Rudd accepts that Australia faces massive ecological problems. He never concludes that it would help the environment by ending immigration because big business wants it. And what big bad business wants, big bad business gets. Unless – unless, we organise a fight them politically on this one.

IMMIGRATION: IS THIS HOW OUR WORLD ENDS? by James Reed: Again *Camp of the Saints*-style boat people scenarios of invading refugees fill the papers.
