IN THIS CORRUPT TECHNOLOGICAL AGE

The third paragraph in 'Thought for the Week' came out the day the US elections took place. It is from a financial adviser's newsletter and we thought worth reporting – not for the financial advice, but for what many Americans are concerned is happening to the US electoral system, and at the same time it reveals the underlying philosophy that is so typical of the 'right' of American politics.

Over the last 80 years, the United States of America has shown itself to be the most productive nation in recorded history – and yet it has continually had a section of its people living in poverty.

Stephen Lendman on *Veterans Today Network* summed the results up well, "Money Party Wins US Election". (<http://www.veteranstoday.com/2012/11/07/money-party-wins-us-election/>) He writes, "The same party wins every time. Duopoly power rules. America is a one party state with two wings. Each replicates the other. On major issues mattering most, not a dime's worth of difference separates them. The late Gore Vidal explained it as well as anyone. Some of his best comments included:

- "Apparently, a democracy is a place where numerous elections are held at great cost without issues and with interchangeable candidates."
- "Any American who is prepared to run for president should automatically by definition be disqualified from ever doing so."

"By the time a man gets to be presidential material, he's been bought ten times over."

What Gore Vidal said about American politics applies to most countries in this corrupt age, certainly including Australia.

The world seems to be tottering on the edge of a precipice. No, not the earth, not the global sphere upon which we humans precariously live and move and have our being, but the organised systems and institutions man has devised and built up over the centuries in order to govern the peoples who live within the organised whole.

The earth, that global sphere, is part of God's created order and moves and acts according to His (some people would say 'natural') laws. All that mankind can, in reality, do, and has only ever been able to do, is seek out those laws and work in harmony with them - if he wants to live the good life.

There are natural laws and there are moral laws, but we don't hear much, if anything, about the moral laws these days, but they are just as absolute as are the natural laws and the chaos we see all round us are the 'fruits', the results, of ignoring those laws.

The late social creditor Victor Bridger wrote: "Whilst there

is a growing awareness for the need to rectify the banking system, there still remains the demand for wrong objectives, like providing "employment" and then later he wrote: "on the one hand we have people being made aware of the problem of the banking system's control on the creation of credit (debt-credit-money) and on the other, people being misled as to the correct policy required to bring about changes and the philosophical reasons behind them".

What is 'Democracy' according to social credit teaching?

You know the word gentle reader - that never defined word the demagogues like to use, "democracy" - which easily rolls off the tongues of western politicians but has a hollow ring to it.

Social credit teaches that true realistic 'democracy' is not 'majority rule (Might is Right) but is the self-determination of the individual within the framework of the Moral of the social body.

And that is the nub, it is a policy! Social Credit will not be understood without a good grasp of the philosophical foundation. Social Credit itself is not a philosophy - it is a policy. In his early Social Dynamics Training Course, Eric D. Butler cautioned eager students not to race ahead, but get a firm grasp of the foundational principles upon which the proposals being presented were based. To reinforce the point he quoted C.H. Douglas:

"As I conceive it, Social Credit covers and comprehends a great deal more than the money problem. Social Credit involves a conception; I feel a true conception of the relationships between individuals and their association in countries and nations, between individuals and their association in groups".

What did Douglas and Butler conceive that many find so hard to grasp? First, Social Credit proposals stem from the Christian philosophy. Is that important? Yes. Why? Christianity teaches it is at the individual, personal level that God deals with each and every one of us. We are each, individually, morally responsible and accountable for our own actions, our own behaviour towards our families and neighbours (and neighbouring nations).

Faith, the Proof of the Unseen: Now faith is the substance of things hoped for, the evidence of things not seen Hebrews 11:1.

"Upon that turns the life of every man," observed the 19th century clergyman and author George MacDonald. In "Faith: the Proof of the Unseen" he wrote:

"We have been talking about faith ever since the Lord came. It is not exhausted yet; and God forbid that I should know what faith is, although I know a little what it is. I think the meaning of the phrase is this: "Faith is the foundation, the root, the underlying substance of hope. If you have any hope, it comes from some faith in you. Hope, you may say, is a bud upon the plant of faith, a bud from the root of faith; the flower is joy and peace. Now the 'evidence of things not seen' it is the trial or the proving of things not seen, upon that turns the life of

every man, especially, perhaps, in the present day.

This thing of faith means the whole recognized fellowship of man to God and his fellows; it is the right position of the human soul which is made to understand the truth - the right position of that soul towards the truth; that is faith, partly taking it in its simplest, original development, it is the highest effort of the whole human intellect, imagination, will, in the highest direction..."

Let's ask ourselves: what do we want, what do 'we the people' want from the society, the human association, in which we all live and move and have our being?

Don't people want the same things you and I want for ourselves, for our children, for our families? The means to live as we choose? Peace, with security from want and war? What about the love and warmth of husband and wife, mother and father? What about nourishment within and for our families? What about the need for the freedom (to think, to speak, to associate, to choose or refuse one thing at a time) to encounter reality - and the extension of each and every individual in the process in all the directions it allows? Surely that is what 'organised society' is for? What is an economic system for? Surely production and goods and services are to give people a choice as to the ends they individually choose.

This is the vision towards which the Social Credit policies aim. *That is FAITH: it is the doing and being of life.*

SOLAR POWER AND SOARING SKY-HIGH POWER BILLS

"Households will soon be slugged \$240 annually to pay for the power produced by rooftop solar systems. New modelling has revealed that **by 2015-16, almost 15 per cent of the total household power price will fund the solar feed-in tariff.**

The Newman (Queensland) Government has already cut the tariff for home-produced power to 8 per kilowatt hour for all solar systems bought after July 9. However, the new figures exposing the huge burden being carried by all consumers to pay those who produce solar power may prompt the Government to also reduce the 44/kWh tariff paid to those who previously installed photovoltaic systems.

The Government is investigating ways to reduce network costs - the price of moving electricity from the power generators to people's homes - which account for about 50 per cent of all electricity prices.

THE rush on solar power that saw more than 100,000 Queenslanders sign up for panels could end up costing households extra on their electricity bills." (Emphasis added)

MISPRISON OF FELONY vs SEXISM: SEXISM WINS!

Could the Liberals be working on something? Julie Bishop is question time has been attacking Julia Gillard on Gillard's role in an alleged union slush fund. It's been the battle of Julie versus Julia. Bishop has challenged Gillard's claim that Gillard did not know about the workings of the AWU "slush fund" that she as a lawyer set up for her 1992 boyfriend.

It seems that Gillard as a lawyer signed power of attorney for said boyfriend on February 4, 1993 and that Gillard still had "involvement in the AWU slush fund, the year after she claimed she had no involvement". (*The Australian* 2 November 2012 p.1)

Gillard responded to Bishop by saying that she had done no wrong and stood by her August 23, 2012 press conference. But Bishop's new evidence shows that there are matters not dealt with at that conference, namely the signed power of attorney.

Where is all of this leading? As Bishop said: the relevant law involved in the registration of an association "specifically precluded the registration of an association for the purpose of providing personal profit or benefit to individuals". (*The Australian* 30 October 2012, p.13) As well, the law through the notion of misprison of felony requires that people who are aware of the commission of a serious crime, report it. Legal professional privilege is not defence. So there are two possible offences here: the specific WA registration offence and misprison of felony. Is there good evidence?

Bishop's new piece of evidence does not of itself prove either offence but it is highly suggestive evidence, and if further evidence comes up, it could prove highly relevant. But meanwhile the Labor Party chugs away at politically correct causes of the week: sexism one news cycle, then the Asian Century, and who knows what next, as bread and circuses are fed to the asses-masses.

THE GREAT CALWELL MYTH

Usually when John Pasquarelli (Pauline Hanson's former advisor before she formed One Nation) writes an article on immigration he favourably mentions Labor immigration minister Arthur Calwell. Pasquarelli does so again in a recent article "What if Rudd and Turnbull Return?" *The Australian* 19 October 2012, p.12. Pasquarelli seems to think highly of Calwell, even though this article describes him as a "socialist". He says: "Calwell the socialist in 1972 was more conservative than the present day Coalition and that is cause for concern. Calwell was our greatest immigration minister".

That line of thought is popular with conservative Mediterranean's and Eastern Europeans who Calwell admitted *en masse* into the country. As an Irish Catholic socialist he had a dislike of the WASP culture he existed in and responded to change it. He also, apparently supported some version of race hate legislation long before it was brought in by the Keating government. Calwell gave lip service in his autobiography "Be Just and Fear Not" (1972) to the White Australia Policy but did nothing to oppose its abandonment. That is the acid test. Calwell was thus the "greatest immigration minister" for promoting what would become multiculturalism and Asianisation. Relative to his time he was more radical than Paul Keating. Keating seems to be an explicit globalist and Asianist, whereas Calwell held to Fabian socialist ideals until the end.

US ELECTION: WHITE MALES ARE DISENFRANCHISED OBSERVES MACDONALD

Dr. Kevin MacDonald, American author of ** "Culture of Critique" and "Cultural Insurrections" has posted the following observations of the elections in the US.

He begins: My impression is that in 2008 the mainstream media was basking in the glow of multicultural heaven with the election of Obama. There was very little commentary on the racial pattern of the results and what they portended a difficult time ahead for the Republicans. This time around, one hears nothing but

commentary on how the Republicans are doomed if they don't pander to Hispanics (Hispander, as VDARE has it).

The racial fault lines are more apparent than ever. Whereas in 2008, the official version was that 58% of Whites voted Republican, this year, according to the CNN exit poll data, it split 59%–39%. Of course, the White population includes Jews and Middle Easterners classed as Whites but who do not vote like other Whites and do not identify with the traditional

and culture of America. (70% of Jews voted for Obama, down from ~80% in 2008, perhaps because Obama didn't immediately bomb Iran at Israel's behest. As a critical component of the new hostile elite, Jewish voters are mainly motivated by their identification with the non-White coalition of the Democratic Party, assuming [correctly] that support for Israel is sufficiently bi-partisan to carry the day.)

THE SECRET LIFE OF THE WORKING MUM

Julia Gillard has stopped, for the moment, squawking about sexism, so this gives us time to take a walk down memory lane. In 1983 Gillard was elected president of the now-defunct Australian Union of Students. (AUS). That was the year the AUS, in its "wisdom", declared 1983 to be the International Year of the Lesbian. It also had a policy on prostitution that made mums prostitutes: "Prostitution takes many forms and is not only the exchange of money for sex. Prostitution in marriage is the transaction of sex in return for love, security and housekeeping". (*The Australian* 30 October 2012, p.13) One wonders if Julia dear old Dad was proud of this one? What did her Mum think?

Speaking of mums, almost half of all mothers in two-parent families are back at work before their child has turned one. Stay-at-home mums are fast becoming a thing of the past as women commit themselves to their new gods – work and money. I know, it's the mortgage and cost-of-living pressures. But in all the families I know of, the real reason is the desire for more consumerism, a better house, home improvements, and not living modestly.

Across Europe, Asia and even the Muslim world, a population crash is occurring. David Goldman in "How Civilisations Die (and Why Islam is Dying Too)" (Regnery Publishing, 2011) has some astonishing statistics about this. For example, given Germany's present fertility, the German population will fall by 98 per cent over the next 200 years and two out of three Italians and three out of four Japanese will be elderly dependents by 2050. The population dearth is worse, surprisingly enough, in Muslim countries where fertility has fallen two or three times faster than the world average.

Goldman makes much about Israel having a fertility rate over replacement of 2.77 and the United States being at replacement of 2.1 children per female. Goldman gets excited in his book and sees all of this as something of a divine blessing

of the Jews. But Goldman himself has a graph in his book "It's Not the End of the World: It's Just the End of You" (RVP Publishers 2011) page 376, comparing the total fertility of Israel and various Muslim countries, from 1950 to 2010, and all of the curves are crashing downwards. It's a bit too soon for him to be dancing for joy, especially since he recognises that a crushing Muslim population could lead to lashing out at the world, perhaps with nuclear weapons.

Goldman's books are basically an argument for Judaism with a nod to Christian fundamentalism. He doesn't probe deeper, being religious himself. However sociologically both world views have a place for women, support stay-at-home motherhood, and are anti-abortion. These are in my opinion good things: Australia's abortion rate is about 100,000 per year and rising. Most of these abortions occur because of casual sex, or if in marriages, because lifestyles will be affected by the child. That is, Mum won't be working).

Goldman's material better supports a critique of feminism and women's liberation than a theological argument, although a support for traditional religion against modernism is well welcomed. The argument shows that women are playing their part in the collapse of civilisation. But before that occurs our psychotic economic system would have broken down (something Goldman doesn't discuss, he is an economic crisis type, not an economic doomster). Switch off the mind control and we will return to reality fast.

Jewish thinker and writer James Howard Kunstler in "Too Much Magic: Wishful Thinking, Technology and the Fate of the Nation" (*Atlantic Monthly* Press, 2012) says that he got a lot of complaints from feminists about his two 'collapse' novels, "World Made by Hand" and "The Witch of Hebron", because the worlds he depicted did not show the "arc of history" to lead only "to more and better feminism"! (p.229) He is not convinced that it will. Indeed, if the collapse of modernity occurs, as Kunstler and others predict, feminism will be the first ideology to go in the spring-cleaning of history's garbage.

As usual, the White percentage of the electorate continued to decline, from 74% to 72%. And as usual, the Republican Party received over 90% of its votes from Whites.

Non-Whites voted overwhelmingly for Obama—80% on average. Asians have become like Jews in their voting—focused not on their economic position so much as their identification with non-White America. Indeed, a higher percentage of Asians (73%) voted for Obama than did Latinos (71%) and Jews (70%).

Whites of both sexes voted Republican, with only 35% of White males voting Democrat and only 42% of White women. Even Whites in the youngest age category (18–29 years)—those most influenced by Sumner Redstone's MTV

and by the school system whose main purpose now is to pound the benefits of diversity into the brains of captive young audiences—voted Republican (51% to 41%). So the Republican Party is the White people's party. The media is screaming now that the party reach out to Latinos to become competitive again. I suppose that is what they will try to do. But it is very unlikely to work.

It's not just about immigration. In order to appeal to the vast majority of non-Whites, the Republicans would also have to be the party of entitlements for minorities and high taxes for their White base. Consider the situation in California. In a Wall Street Journal article ("California's Greek Tragedy"), two Stanford professors, Michael F. Boskin and John F. Cogan, note that from the mid-1980s to 2005, California's

population grew by 10 million, while Medicaid recipients soared by seven million; tax filers paying income taxes rose by just 150,000; and the prison population swelled by 115,000.... With 12% of America's population, California has one third of the nation's welfare recipients.

And as a result of the most recent election, the Democrats have a 2/3 majority in the State Legislature, meaning that they can raise taxes as much as they please. This new supermajority will now see White Californians as a cash cow, to be milked at will until we see the light and leave. California is a harbinger of what the entire nation will look like soon.

So in order to appeal to Latino

MURKY DERIVATIVES SCAMS COMING BEFORE THE COURTS IN OZ

Standard & Poor's misled investors, Australian court says November 2012

"An Australian court has ruled that S&P and ABN Amro Bank should pay damages.

Australia's Federal Court has ruled that credit ratings agency Standard & Poor's (S&P) misled investors before the global financial crisis. S&P gave its safest credit rating, AAA, to complex and risky securities, which later lost most of their value.

In what is regarded as a landmark ruling, the court ordered S&P and the bank which arranged the product, ABN Amro, to pay damages to investors. S&P said it planned to appeal against the decision. "We are disappointed with the Court's decision, we reject any suggestion our opinions were inappropriate, and we will appeal the Australian ruling, which relates to a specific CPDO rating," S&P, one of the world's big three ratings agencies, said in a statement.

The ruling is the first of its kind on a rating agency's liability for investors' losses. Federal Court Justice Jayne Jagot said that S&P was "misleading and deceptive" in its rating of two structured debt issues in 2006, which she described as "grotesquely complicated".

The case was brought against S&P and ABN Amro Bank by several Australian local governments which lost millions when the value of the investments was virtually wiped out during the financial crisis. Judge Jagot said S&P and ABN Amro would have to pay 30m Australian dollars (\$31m; £19m) in damages to the authorities.

IMF Australia, a company listed on the Australian Stock Exchange which funds legal claims, said the ruling was "likely to have global implications and be felt hardest in Europe and the US, where similar products were sold to banks and pension funds". The firm said this could pave the way for investors in Europe to recover significant losses from both S&P and ABN Amro, which is now owned by Royal Bank of Scotland. It estimates that 2bn euros (\$2.6bn; £1.6bn) of the same sort of financial products, called CPDOs or constant proportion debt obligations, were sold in Europe.

"Today's court ruling will enable the councils to recover a

significant proportion of their losses that will now be available to provide services for their communities," said IMF Australia director John Walker. "It is welcome news and a relief for the tens of thousands of Australians who make up these local communities as they rely on the range of services provided by their local council."

John Sununu, R-N.H., criticized the award at the time, pointing out that it had "nothing to do with Fannie Mae's charter, nothing to do with making mortgages more affordable." It wasn't about mortgages. It was about greenbacks. The patent, which Fannie Mae confirmed it still owns with Cantor Fitzgerald subsidiary CO2e.com, gives the mortgage giant a lock on the fledgling carbon trading market, thus also giving it a major financial stake in the success of cap-and-trade legislation. Republicans will have to not only agree to let more Latinos in, they also have to be gung ho on raising taxes and jacking up benefits. There are even a few comments in the press from 'Their Side' of politics saying that the vision of Asia in the White Paper is "too optimistic" and ignores the danger raised by the 2009 Defence White Paper.
