ABORIGINAL LAND RIGHTS AND AUSTRALIA'S SOVEREIGNTY

The following information was published by the Australian League of Rights in the May 1984 edition of the Intelligence Survey, in an effort to warn the Australian people what, and who, were behind the push for 'land rights' for the Aboriginal folk. Australians continued about their everyday affairs not recognising the dangers to our national sovereignty. Over thirty years later the screws are being tightened as we are being forced tighter and tighter in the New World Order vice. Australia's Aboriginal folk are being used for purposes other than their own wellbeing - the truth is they are but 'meat in the sandwich' when it comes to the real political agenda of the world elites.

Remember the following was written in 1984 - over thirty years ago:

"The Commonwealth Government, under the zealous hand of Aboriginal Affairs Minister Clyde Holding, has embarked on a policy for "Aboriginal Land-Rights" which will not only take it into a constitutional minefield, but will, if taken as far as possible, threaten the Australian continent with a type of balkanisation into racial "ghettos", and also compromise Australia's Federal system, its communications, its defence and its relative lack of racial disharmony.

To achieve this package of disasters the Government will rely not so much on the considered constitutional will of the Australian people - a process amply provided for in the Constitution itself - as on a series of premises derived by the United Nations Organisation and its agencies. These premises, or, as High Court Justice Wilson described them in 1982, "international arrangements", will be imposed on all Australians, including the Aboriginals, by a radical mis-use of Section 51(29) of the Constitution, which gives the Commonwealth Government power over "external affairs".

If this policy is consummated, the ultimate decision on what happens inside Australia will be determined not by elected parliaments within constitutional limits, interpreted where necessary by a High Court which uses the expressed will of the Australian people as its criterion. It will be determined by the International Court of Justice, which sits in the Peace Palace in the Hague, which is owned by the Carnegie Endowment for International Peace.... The West Australian (August 22, 1983) carried the following article, under the heading "Aboriginal Call to Adopt U.N. Policy": "The Federal Government would be urged to ratify a United Nations agreement and make Aborigines' rights an international issue, an Aboriginal spokesman said yesterday on his return from Geneva. Mr. Paul Coe, one of a fourman delegation to a meeting of a working party of the United Nations Commission on Human Rights, said that the delegation would attempt to meet the Prime Minister,

Mr. Hawke, and the Minister for Aboriginal Affairs, Mr. Holding, next week. He said that Australia had signed U.N. Convention 107, which guarantees self-determination and rights to indigenous peoples in all signatory nations, but had not ratified it. The delegation would ask for immediate ratification and an assurance that Aboriginal rights would be respected in all States. The Franklin Dam decision had put paid to arguments that this could not be done because of states' rights, Mr. Coe said. The delegation said in its submission to the U.N. working party: 'We consider that violations of human rights by wealthy countries such as Australia are especially reprehensible'. The submission dealt with wide-ranging Aboriginal discontent, from State Government inaction on racism to health care, employment, education, mining, land rights and social justice, and quoted from a World Council of Churches report compiled in 1981. The U.N. has no direct say in the internal policies of member nations, but it can exert significant moral pressure on governments seeking a good international image. The group's submission condemned mining as the major single threat to Aboriginal communities across Australia." (Emphasis added) The background to this submission requires the attention of all thinking Australians.

CHINA'S DEBT TO SIR ISAAC NEWTON by Brian Simpson

At present it is academic chic to claim that China invented almost everything, and the West, nothing of significance. It is therefore interesting to come across N. Kollerstrom's article: "How Newton Inspired China's Calendar," <u>A&G</u>, October 2000. Sir Isaac Newton published in 1702 his <u>Theory of the Moon's Motion</u>, which gave a way of finding the Moon's longitude, which could be used to find universal time and in longitude at sea.

The theory had been extensively used in the 18th century in Europe, but had been neglected in the 20th century. The reason for this was that the theory of the moon did not make use of his gravitational theory. Contrary to the China worshippers in the West, the Chinese regarded a theory of universal gravitation as "ideologically unsound" and the Chinese, even as late as the 18th century, accepted a geocentric world view, believing that the Earth was stationary and that the Sun revolved around it. This alone should challenge the school of thought that holds that China invented all science. Consequently, not wanting to accept Western ideas beyond necessity, Newton's theory of the moon's motion was used by the Chinese for eclipse prediction and in the construction of its calendar which was used well into the 20th century.

FROM MY FILES: ANGLO-AUSTRALIAN MATHEMATICAL EXCELLENCE by Brian Simpson

Readers may be aware that even those who write on 'Race and IQ' promote the idea that East Asians are intellectually superior to "Whites"; such as the so-called "race realist" school. Jared Taylor is one example of this. Actually their statistic is that the mean of White IQs = 100, the mean of East Asian IQs = 105. But that in itself (which I believe is mistaken) says nothing about IQs to the right of the bell curve.


Berries polluted by this toxic river: Frozen berries recalled from Australian supermarkets freezers were grown and packed in one of China's most polluted provinces.

WAITING FOR US TO PASS by John Ferguson

Two letters appeared in *The Weekend Australian Magazine*, February 7-8, 2015 (i.e., section 18D defence, good faith comment on published source, etc., etc., for the nervous) stating that it was a wee bit odd that all of those peaceful Muslims were not taking to the streets or whatever, protesting about the atrocities performed in the name of Islam. FIDDLING WITH TEMPERATURE DATA BIGGEST SCIENCE SCANDAL EVER

New data shows that the "vanishing" of polar ice is not the result of runaway global warming. When future generations look back on the global-warming scare of the past 30 years, nothing will shock them more than the extent to which the official temperature records — on which the entire panic ultimately rested — were systematically "adjusted" to show the Earth as having warmed much more than the actual data justified.

Two weeks ago, under the headline "How we are being tricked by flawed data on global warming", I wrote about Paul Homewood, who, on his Notalotofpeopleknowthat blog, had checked the published temperature graphs for three weather stations in Paraguay against the temperatures that had originally been recorded. In each instance, the actual trend of 60 years of data had been dramatically reversed, so that a cooling trend was changed to one that showed a marked warming. This was only the latest of many examples

of a practice long recognised by expert observers around the world – one that raises an ever larger question mark over the entire official surface-temperature record.

Following my last article, Homewood checked a swathe of other South American weather stations around the original three.

In each case he found the same suspicious one-way "adjustments". First these were made by the US government's Global Historical Climate Network (GHCN). They were then amplified by two of the main official surface records, the Goddard Institute for Space Studies (Giss) and the National Climate Data Center (NCDC), which use the warming trends to estimate temperatures across the vast regions of the Earth where no measurements are taken. Yet these are the very records on which scientists and politicians rely for their belief in "global warming".

Rise in sea levels is 'faster than we thought' 14 Jan 2015

Homewood has now turned his attention to the weather stations across much of the Arctic, between Canada (51 degrees W) and the heart of Siberia (87 degrees E). Again, in nearly every case, the same oneway adjustments have been made, to show warming up to 1 degree C or more higher than was indicated by the data that was actually recorded. This has surprised no one more than Traust Jonsson, who was long in charge of climate research for the Iceland met office (and with whom Homewood has been in touch). Jonsson was amazed to see how the new version completely "disappears" Iceland's "sea ice years" around 1970, when a period of

extreme cooling almost devastated his country's economy.

One of the first examples of these "adjustments" was exposed in 2007 by the statistician Steve McIntyre, when he discovered a paper published in 1987 by James Hansen, the scientist (later turned fanatical climate activist) who for many years ran Giss. Hansen's original graph showed temperatures in the Arctic as having been much higher around 1940 than at any time since. But as Homewood reveals in his blog post, "Temperature adjustments transform Arctic history", Giss has turned this upside down. Arctic temperatures from that time have been lowered so much that that they are now dwarfed by those of the past 20 years. Homewood's interest in the Arctic is partly because the "vanishing" of its polar ice (and the polar bears) has become such a poster-child for those trying to persuade us that we are threatened by runaway warming. But he chose that particular stretch of the Arctic because it is where ice is affected by warmer water brought in by cyclical shifts in a major Atlantic current this last peaked at just the time 75 years ago when Arctic ice retreated even further than it has done recently. The ice-melt is not caused by rising global temperatures at all.

Of much more serious significance, however, is the way this wholesale manipulation of the official temperature record – for reasons GHCN and Giss have never plausibly explained – has become the real elephant in the room of the greatest and most costly scare the world has known. This really does begin to look like one of the greatest scientific scandals of all time. (Emphasis added...ed)

THE POPE AND THE 'CAMP OF THE SAINTS' by James Reed

Now wait a minute those out there in 'social credit' land, excited about the relationship between social credit and Catholicism! for their own interests. The message of Christianity should be about spiritual salvation, soul-saving, not some feel-good Marxist politically correct worship of immigration, the religion of global capitalism.

If Catholicism wants to play it that way I suggest that Catholics concerned about their race and communities leave the church and form home-groups for worship as many good folk already do. The hierarchy may 'get the message' if people vote with their feet.

THE LEFT, THE RIGHT - AND THE TRUTH

I am sure Joanne Nova did not realise just how well her article "Study shows, skeptics know more about climate science than believers", 14 February, 2015, demonstrated the strategy used by the mainstream media and political parties for their very own purposes. It is a strategy they use time and time again to 'divide and rule'.

Joanne writes: "So much for the theory that skeptics are dumb or uninformed. Fox News reports that a new study shows that when people are quizzed about climate science, the skeptics outscored the believers. Dan Kahan at Yale did the study on 2,000 people, but with only nine questions, so there is limited insight here, but it fits with his previous study which found people who knew more about maths and science were more likely to be skeptical. Readers of skeptical blogs (who chose to respond to surveys and list their qualifications in comments) are likely to have hard science degrees. The world is slowly waking up to the fact that the skeptics are more knowledgeable about science.

In a proper science quiz, the gap would probably be even larger. On two of the nine questions, skeptics got the science right. But believers "outscored" skeptics at repeating the propaganda (which shouldn't be a question in a survey about scientific knowledge). I'd like to see all nine questions (can anyone find a preprint or the paper?)

Skeptics get science right:

One question, for instance, asked if scientists believe that warming would "increase the risk of skin cancer." Skeptics were more likely than believers to know that is false.

Skeptics were also more likely to correctly say that if the North Pole icecap melted, global sea levels would not rise. One can test this with a glass of water and an ice cube – the water level will not change after the ice melts. Antarctic ice melting, however, would increase sea levels because much of it rests on land.

Believers (including believers who design surveys) get propaganda right, but science wrong:

Liberals were more likely to correctly answer questions like: "What gas do most scientists believe causes temperatures to rise?" The correct answer is carbon dioxide...."

The Left/Right Conflict is a Divide-and-Rule Strategy

The battle of words between the two groups is a very good example of what Geoffrey Dobbs wrote of in "What is Social Credit": The Left/Right conflict is a divide-and-rule strategy, and it is remarkable how closely it has succeeded in spitting the population down the middle... The two sides are at one on their evil policy, they differ only on the truth, which they divide between them and so render impotent..."

He asks: Why not consider Trinitarian Terms?

Writing on Science and Religion: "...When we bear in mind that science in the modern sense could never have left the ground until men had learnt to think of space, time and matter in trinitarian terms, it seems odd that so many theologians shy away from any suggestion that the divine revelation to men embodied in the Incarnation and the Holy Trinity may well have practical applications throughout the whole of human life, including politics, economics and natural science.

Why must it always be restricted to a special, 'holy', churchyemotional, or even an abstract, 'philosophical', way of looking at it? Might there not, for instance, be some religious justification for seeking the stability of a three-in-one political constitution, provided the powers remain in balance; or might it not be at least contemplated that possibly a trinitarian resolution of the wave/quantum duality might have advantages over a simple unitary one; and what of the relentless drive for a unified Field theory, and for that matter for a Unified World, and for unification of the churches, with the suggestion that the diversity of nations and peoples, of churches and (by implication) of individual beings generally is a blasphemy against the Unitarian God?...

It would be well if the many theologians, nowadays, who want to adapt their religion to the progress of science, should take note that science does *not* proceed by the *convergence* of views or of theories, though it depends greatly on the *interplay* of and insights and techniques. Actual progress is achieved by leaps of inspiration by individuals, which then have to prove themselves in practice, by experiment and observation of the real world, *against* the consensus of established opinion..."

There he says that Australia would not be the globalist, multicultural society we are today if the White Australia Policy had not been dismantled (no consideration of the "Yellow China" or "Yellow Japan" policies). As well, if Australia had not undertaken non-Anglo immigration in the post World War II era by Arthur Calwell, that dismantling would not have been easy.
