In 2013, Senator Glenn Lazarus was selected to head the Palmer United Party (PUP) Senate ticket in Queensland at the 2013 Australian Federal Election and was elected on 9.89% of the primary vote and a favourable preferential tally from group

## THE GLOBALIST HUMAN RIGHTS COMMISSION by Ian Wilson LL.B.

The Federal government has written to the president of the Human Rights
Commission stating its "fundamental disagreement" with its jurisprudential methodology of using foreign rulings that are not binding on Australia, adopting an "expansive reading" of its own jurisdiction and especially ignoring the Australian legislative underpinnings of law. (*The Australian* January 27, 2015, p.1) This has all been brought to a head by the Human Rights Commission's decision that Indonesian killer John Basikbasik be

compensated. The decision was based on use of an international treaty which is not binding on Australia. In more detail, the International Covenant on Civil and Political Rights is a treaty to which Australia is a state party, but its provisions have not been incorporated into domestic law.

It gets worse. In a Northern Territory case four Aboriginal men with disabilities had been imprisoned in a Northern Territory gaol. Three had been found unfit to stand trial, and one had been found not guilty by way of mental impairment. The Federal government accused the Human Rights Commission of claiming that it was responsible for the situation, and in doing so it ignored the Constitutional underpinnings of the commonwealth, states and territories.

I am not surprised: this is a globalist organisation which is seeking to go beyond Australian law and to implement the rule of international law. Now is the time to abolish the Human Rights Commission.

## SHAKING THE MEDICAL ESTABLISHMENT UP - AND SCIENCE

The ever-interesting health website NaturalNews.com (February 15, 2015), reports that an interesting experiment was conducted by Harvard University's Dr. Mark Shrime, MD. This experiment, which I detail shortly has a parallel in the humanities, where back in the 1990s some physics researchers created a completely nonsense postmodern article and got it published in a postmodern cultural journal. The idea was to show that any nonsense with the right politically correct sounding terms could get into print.

Dr. Shrime used

RandonTextGenerator.com to produce a nonsense health paper, "Cuckoo for Cacao Puffs: The Surgical and Neoplastic Role of Cacao Extract in Breakfast Cereals". There are many medical journals that advertise to publish a paper at a flat rate of US\$500.

Dr. Shrime submitted the nonsense paper to them and got 17 acceptances out of

37. This is a very high acceptance rate. The article was co-written with "Pinkerton A Le Brain" and "Orson Welles". If that was not enough of a giveaway the first non-grammatical sentence of the paper was: "In an intention dependent on questions on elsewhere, we betrayed possible jointure in throwing cocoe." Some journals went ahead and typeset the article and had produced a review endorsing the study! It seems that fake journals are common in medicine and more will be forthcoming with globalisation, with journals being set up in Asia to take publication for flat-sum rates. Beyond this, there is the larger problem of fraud in the established journals which get through peer review, and the even bigger institutional problem of suppression of novel results or experimental data which conflicts with a received paradigm.

In physics, for example, Albert Einstein's special and general theories of relativity

are regarded with religious awe, even though both conflict with quantum mechanics. However, there is a cosmological problem of the rotation of spiral galaxies. Some global clusters, such as Omega Centauri orbit so fast that according to general relativity they should spin off into intergalactic space. The outer part of spiral galaxies spin ten times faster than general relativity predicts. To account for the extra gravitational pull, it has been hypothesized that "dark matter"/"energy" exists. So far this mysterious dark matter has not been found. Further, the energy of empty space appears to be zero, but quantum mechanics plus relativity predicts opposite. (Nature, vol.431 2004, p.519) The moral of this story is to take everything which science says with a pinch of salt – even that a pinch of salt is bad for you.

## SO MUCH FOR THE LIGHT OF LEARNING by Richard Miller

This one needs to be put in the 'please explain' box. Professor Paul Fritjers, of the University of Queensland did research showing that Brisbane bus drivers are more likely to give free rides to white people than coloured people. (*The Australian* February 27, 2015 p.5) Such research should be of interest to authorities wishing to deal with fare evasion. On the face of it, there is nothing 'politically incorrect' about this research. It showed "racists tendencies among Australian bus drivers".

Yet, according to *The Australian* Professor Fritjers was "demoted last year for failing to obtain sufficient clearance for pursuing the controversial research". Again, why was the research "controversial"?

Apparently the demotion decision was reversed on review but Fritjers says that he is still under threat of dismissal. Fritjers said that "We followed the procedures of the School of Economics. The university thus funded the research and signed off on it".

The only thing that I can find is the claim by the Brisbane City Council that the research was not "authorised" by it. But does a public body have the right to require this? After all, the research involved both white and dark skinned students boarding buses with empty bus cards and asking drivers for a free ride. It was found, shockingly, that bus drivers were twice as likely to give free rides to white-skinned students than dark-skinned

students.

Now readers will know that I am no "antiracist", but, I for one accept that white students should be given a free ride. This research is thus important for our rich and diverse, multiculturally wonderful, vibrant, exciting, tasty and nutrient-full, Asian society, and should not be "banned". It sends the wrong message to "the world" who are out there, ready to judge and condemn our every move and breath. Even as you read this, the international community is there, looking over your shoulder, judging, judging and judging, eternally searching for even a grain of "racism". Well, it looks like it is there - "on the buses".

Professor the Hon. Dame Marie Bashir touched on a very important point in her recent address to an international women's group in Sydney. #### **Farmers of Forty Centuries**

Dame Marie's reference to China reminded me of F.H. King's 1911 book "Farmers of Forty Centuries". As was explained in the Preface by Dr. L. H. Bailey:

We have not yet gathered up the experience of mankind in the tilling of the earth; yet the tilling of the earth is the bottom condition of civilization. If we are to assemble all the forces and agencies that make for the final conquest of the planet, we must assuredly know how it is that all the peoples in all the places have met the problem of producing their sustenance out of the soil. We have had few great agricultural travellers and few books that describe the real and significant rural conditions... but for the most part, authorship of agricultural travel is yet undeveloped. The spirit of scientific inquiry must now be taken into this field, and all earthconquest must be compared and the

results be given to the people that work.

Dr. Bailey continues: This was the point of view in which I read Professor King's

manuscript. It is the writing of a well-

trained observer who went forth not to

find diversion or to depict scenery and

common wonders, but to study the actual conditions of life of agricultural peoples.

We in North America are wont to think that we may instruct all the world in agriculture, because our agricultural wealth is great and our exports to less favoured peoples have been heavy; but this wealth is great because our soil is fertile and new, and in large acreage for every person. We have really only begun to farm well. The first condition of farming is to maintain fertility.

This condition the oriental peoples have met, and they have solved it in their way. We may never adopt particular methods, but we can profit vastly by their experience. With the increase of personal wants in recent time. the newer countries may never reach such density of population as have Japan and China; but we must nevertheless learn the first lesson in the conservation of natural resources, which are the resources of the land. This is the message that Professor King brought home from the East. It could not be other than a matter of the highest industrial, educational and social importance to all nations if there might be brought to them a full and accurate account of all those conditions which have made it possible for such dense populations to be maintained so largely upon the products of Chinese, Korean and Japanese soils. Many of the steps, phases and practices through which this evolution has passed are irrevocably buried in the past but such remarkable maintenance efficiency attained centuries ago and projected into the present with little apparent decadence merits the most profound study and the time is fully ripe when it should be made. Living as we are in the morning of a century of transition from isolated to cosmopolitan national life when profound readjustments, industrial, educational and social, must result, such an investigation cannot be made too soon..."

So there you have it. The truth is that after four thousand years of productive farming and feeding her dense populations, China has ruined her environment, chemically polluted her farmlands, reduced her farmers and peasants to a life of wage-slavery in the great industrial ant-heaps, and all at the cost of becoming a great 'economic' power.

But the story doesn't end there. We

Australians have yet to learn some more of those lessons.

I can remember the dust storms of the late 1980s coming from the west coast of South Australia – the result of drought, uncovered soil and, dare I say it, dry land wheat farming. American farmers in the 1930-40s were in the same predicament as the following report shows.

## Library of Congress website tells the story:

"Between 1930 and 1940, the southwestern Great Plains region of the United States suffered a severe drought. Once a semi-arid grassland, the treeless plains became home to thousands of settlers when, in 1862, Congress passed the Homestead Act. Most of the settlers farmed their land or grazed cattle. The farmers ploughed the prairie grasses and planted dry land wheat. As the demand for wheat products grew, cattle grazing was reduced, and millions more acres were ploughed and planted. Dry land farming on the Great Plains led to the systematic destruction of the prairie grasses. In the ranching regions, overgrazing also destroyed large areas of grassland. Gradually, the land was laid bare, and significant environmental damage began to occur. Among the natural elements, the strong winds of the region were particularly devastating. With the onset of drought in 1930, the over-farmed and overgrazed land began to blow away. Winds whipped across the plains, raising billowing clouds of dust. The sky could darken for days, and even well-sealed homes could have a thick layer of dust on the furniture. In some places, the dust drifted like snow, covering farm buildings and houses. Nineteen states in the heartland of the United States became a vast dust bowl. With no chance of making a living, farm families abandoned their homes and land, fleeing westward to become migrant labourers.

In his 1939 book "The Grapes of Wrath," author John Steinbeck described the flight of families from the Dust Bowl: "And then the dispossessed were drawn west--from Kansas, Oklahoma, Texas, New Mexico; from Nevada and Arkansas, families, tribes, dusted out, tractored out. Car-loads, caravans, homeless and hungry; twenty thousand and fifty thousand and a hundred thousand and two hundred thousand... In all, 400,000 people left the Great Plains, victims of the combined action of severe drought and poor soil conservation practices."

## TROUBLE IN THE WEST AUSTRALIAN CAMP

A West Australian graingrower has been left traumatised, a community is outraged and a hire car is missing after police were forced to intervene when receivers appointed by the ANZ Bank tried to forcibly repossess a wheat farm. Cuballing farmer Bruce Dixon claims two men from receivership firm RSM Bird Cameron arrived on his 2000ha wheat, oats and canola farm 200km southeast of Perth last Friday without warning or explanation, less than a day after the ANZ -imposed deadline to pay back his \$4.7 million defaulted loan had expired. A distressed Mr Dixon said he was threatened in his kitchen, told locksmiths were on their way to change all the locks, and that if he didn't leave his farm quickly and quietly, the police's Tactical Response squad would be called.

"They said because I had defaulted (on my loan) that the ANZ had taken possession of my property and that I had to get off; they didn't show me any paperwork and I didn't know legally if that was right or not," he said yesterday. "But I wasn't giving up 60-odd years of work or five generations of farming without a fight.

"I said I wasn't leaving — I was shaking by this stage and feeling sick — and that's when they started threatening me and saying the banks would be very harsh on me, very harsh."

But the incident turned even uglier when the receivers went outside with Mr Dixon, only to find their car blocked in by hay bales weighing half a tonne each. Friends of Mr Dixon who had arrived to help their mate, including nearby Williams farmer and rural action militant Rod Culleton, denied all knowledge of the hay bale drop.

Police were called, but when they found the RSM Bird Cameron receivers lacked the court documents or legal warrants needed to take possession of Mr Dixon's farm, they drove the men into town, leaving their hire car stranded under the hay. Now the car has gone missing — Mr Dixon says he has no idea where it is — and a stolen car report has been made to police.

Mr Culleton, speaking on Mr Dixon's behalf, said yesterday that his case would now become part of a court action to be mounted in the Federal Court alleging that the ANZ Bank forced farmers into "engineered defaults" and had entrapped them into signing changed loan contracts when it bought out the loan book of the Landmark group in 2009.

An ANZ spokesman said the bank had been working closely with the Dixon family since 2011 and had reached a "mutually agreed" outcome last year, which involved selling one of his two farms. This did not occur. "Taking possession of a farm is always the last option," the spokesman said.

Mr Dixon said he was still on the farm and would not budge. The Dixon case has ignited fears a second avalanche of farm foreclosures is under way across Australia as major banks seek to claw back risky rural loans; claims repeated in a Senate

hearing yesterday into rural debt. But the depth and severity of the problem is disputed, with the Australian Bankers Association contending that despite a \$60 billion farm debt load nationwide, 55 per cent of farms carry no debt or loans of less than \$50,000.

"The ABA does not agree that there is a rural debt crisis; we do not believe that there is a systemic nationwide problem facing rural Australia that warrants the proposed government intervention," the ABA's paper to the Senate committee considering the merits of a new Rural Reconstruction and Development Board said.

But the chairman of the former Labor government's rural finance roundtable, graingrower and evicted Condamine farmer Rowell Walton, contends from anecdotal evidence that dozens more farmers are in serious trouble and properties teetering on the brink of bankruptcy and receivership than the 20 cases in Queensland claimed by the ABA yesterday. "It's terrible what people are going through; in some places, like north Queensland, the WA wheat belt, and fruit and vegetable farms along the Murray, this is a very serious financial, community and mental problem," Mr Walton said yesterday after speaking at the Senate committee hearing. "But it seems that the figures given by banks don't stack up ... in parts of WA and the Gulf, 60 per cent of places are estimated to be wiped out by debt. Something is clearly not



We urban dwellers need to grasp just how important our soils and 'food bowls' are. It is easy to search the internet for enlarged/magnified photos of some of the strange creatures that inhabit the soil beneath our feet. That is where I came up with the photo above, with the following summary: "Soil as a Living Ecosystem"

What lives in soil near plant roots? From tiny to huge:

- bacteria and archaea
- fungal hyphae (tubes) growing in all directions
- single-celled algae
- protozoans, especially the shelled amoebae
- rotifers
- nematode worms (microscopic)
- arthropods such as barely visible springtails and mites; insect larvae, beetles; earthworms, millipedes, snails and slugs Relatively enormous animals such as pocket gophers, moles, mice and voles play a role in aerating and loosening soil. Soil is a kind of crucible where organic materials such as leaves are shredded by detritus feeders such as snails, and finally decomposed by fungi and bacteria. The result is humus, source of much of a soil's fertility and its capacity to hold water.

### THE END OF MEN? By Mrs. Vera West

Two topics that conservative groups, of the so-called "far right" groups avoid discussing are the issues of Nordic (northern European) deracination and genocide and the destruction of manhood. On the first issue, immigration and multiculturalism had led to people in freedom groups being either non-Nordic, or having non-Nordic family and friends, so they are unwilling to take a stand on this issue. On the manhood issue, this is a hot potato for conservative groups, even Christian ones because to deal with feminism and how it has been permitted to destroy men would involve some criticism of women (even for passively allowing it to happen). That could offend female readers, who have absorbed more of the received culture than they may care to admit. That is why here, at this site, you get the bad news from this ageing granny and as I write I do it surrounded by photographs of my sons and grandchildren.

It is somewhat sad when the hard facts about the plight of men, what has been called in one book, "The End of Men," can be more readily found in *The Australian* than in the freedom movement. The article by Tanveer Ahmed, "Men Forgotten in Violence Debate," *The Australian* February 9, 2015 p.12, has some facts worth citing. The context is the domestic violence debate, which is conveniently stuck in a 1970s feminist victimology mind-set, with no consideration of "male disempowerment". The focus is on "male villainy, denial of biologically based sex differences and a cult of victimhood".

Feminism itself "defines normal maleness as a risible kind of fatuous and reactionary behaviour". Ahmed refers to US anthropologist Lionel Tiger who has said about our present anti-male regime: "We have a psycho-prejudice, in which the norm is the female norm and what boys (and men) do is seen as socially disruptive".

Another important passage from Ahmed: "Just as women are now more likely than ever to enter university, be breadwinners and have affairs, they are more likely to commit family violence against partners, children or relatives. But the anti-feminists who focus on the female perpetrators of family violence... forget the growing social and economic disempowerment of men is increasingly the driver of family based violence".

The modern western economy is "feminised" with traditional male manufacturing jobs being replaced by robots or transferred by the global capitalists to Asia. Work that remains is in the service industries. Affirmative action has mutated and gone mad, so that some sectors, such as universities, law, etc., means being male is now a disadvantage and it is hard to get work however qualified one is.

Where does this go? Have the elites thought this one through? The breakdown of male institutions has led, in the US, to many young men joining gangs, committing crimes, going to prison, where they find radical Islam, not gentle Jesus. The Islamist State, the world's largest manhood gang has no problem getting recruits. If this is all part of a conspiracy then it must be a suicidal one, aimed for the destruction of not only the West, but of modernity itself. And how is that good for "business"?

Methodist leader, the Rev, Dr. A. H. Wood speaking of American use of gas in Vietnam, is reported in "The Age" of March 28 as saying: "If Chinese and other Asians used disgusting weapons of this kind against white troops one could imagine the outcry." Dr. Wood's sensitivity would be more convincing if it occurred at other times than during Communist reverses. We do not recall his protests over the Communist inspired horrors and the cannibalism of the Congo; nor the torture and mutilation of his own and other Churches in China; nor the genocide in Tibet; nor the atrocities of Soekarno.
