EASTER AND CHRISTIAN REALISM by James Reed

This is a time of great tempest, trouble and concern for traditional Christians, who are not part of the SJW (Social Justice Warrior) mentality that has now gripped the Church. Especially at this time of the Christian calendar when it has been a time for reflection on what has been lost and how we may seek to get it back, with the grace of God.

No-one, I believe, was aware of the threats to the Church posed by the New World Order and its ideologies as much as C.H. Douglas. Douglas said in "The Realistic Position of the Church of England" (1948) that we need to get in touch again with fundamentals. What then is fundamental to Christianity, and over the recent Easter period what should our minds and prayers have been directed towards?

Douglas summed it up neatly in saying: "With some hesitation, I suggest that the question arising out of the Christian Church is not the same, either in nature or degree, as that involved in the acceptance of what is vaguely called Christianity which for the most part is merely Liberal

Judaism. It is the Doctrine of the Incarnation."

"At bottom, what we have to make up our minds upon is whether human political action is subject to the same kind, or some kind, of compulsion to be "right" as we accept in doing a multiplication sum, and if so, whether the Christian Church, the Mystical Body of Christ, is the living incarnation of that "rightness."

Douglas did not mince words when he said:

"It must be insisted that Christianity is either something inherit in the very warp and woof of the universe, or it is just a set of very interesting opinions, largely discredited, and thus doubtfully on par with many other sets of opinions, and having neither more nor less claim to consideration."

This, in a nutshell, sums up the situation today. Much of Churchology consists of the preaching of a social gospel to make

Christianity politically correct and consistent with the ideologies of today. All that though, puts the cart before the horse. If Christianity is inherent in the very fabric of the universe, it is this society and social order which should be judged by Christian principles, not the other way round. If people have souls, and are not mere meat machines existing solely to serve social Darwinist masters of the money power monopoly, then their dignity as soul-carrying people should be preserved by the economic system. That orthodox economics does not do so is clearly evident, so it must be condemned as wrong; wrong in fact and morally wrong by social credit, an economic philosophy consistent with what Douglas saw, was the central question arising out of the Christian Church.

The triumph of Christ over death and the miracle of Easter should serve as inspiration for us all to carry on the flame, fight the good fight and keep the faith.

NO NEED TO CHANGE CONSTITUTION: THE CASE AGAINST SHAYNE NEUMAN

Shayne Neumann, Shadow Minister for Indigenous Affairs in "Just Like 1967, It's Time for Change," develops the Labor Party style position on the Recognition Referendum. The Constitution, he says, contains "racial references, which in the 21st century have no place in a modern Australia." By that illogic, the Racial Discrimination Act, which also has racial references, would have no place either. Much of multiculturalism is also about racial references as well, as is a whole host of affirmative action measures.

Neumann says that this referendum is like the 1967 one and that the Churches should again be leading the charge. However Neumann goes on to lay the blame on the Christian churches for the plight of the Aboriginal: "Often with ignorance and sometimes with inadvertence, the Churches contributed to Australia's conduct, shame and tragedy with respect to its Indigenous peoples." He also sees Christians as contributing to the success of the 1967 referendum.

The whole article begs the question about whether the aims of the 1967 referendum

and the forthcoming Recognition referendum are the same. Even by the standard dialogue, Aborigines are now equal and in fact receive many affirmative action benefits to enforce equality. The 1967 referendum was promoted as giving Aborigines the right to vote and cuttings from newspapers at the time ("Aborigines are human"; "Aborigines still unequal under Constitution") confirm this. There was no "No" case presented to the people and the political class are likely to play this card again. The 1967 referendum, as Neumann recognises was to include indigenous people in the census and for the Commonwealth government to make laws for indigenous people not to give them the vote.

The last point is important, I believe because it shows the Commonwealth government was NOT using a "racist" Constitution but rather needed further powers so as to begin an era of affirmative action.

The Christian churches have been involved in a multitude of politically correct civil

rights campaigns over the decades which have proved to be a disaster. The undermining of Apartheid was, for example, seen as a big human rights victory, but many articles published at this site have shown that both blacks and whites in the rainbow disintegrating "nation" of South Africa are even worse off today. The possible genocide of the Boers will be on those CSJW (Christian Social Justice Warriors) hands. The tortures, rapes and murders of white farmers and their families don't seem to register or feature on the minds of CSJW today.

Christians concerned about the type of article published in Christian magazines and newspapers need to begin to embrace some "real politics" about the church today, which like the universities and other institutions in society have been "taken over" and are now "occupied". The American freedom movement sees this clearly and is willing to practise the Christian faith outside of the establishment. That too will have to be done in Australia. Meanwhile, resist, and spread the word.

THE NORDIC ORIGIN OF THE ALPHABET by Andrew Ryan

Stratford Caldecott in "Beauty in the Word" p.144 Endnotes writes: "The alphabet was invented, (Rabbi Jonathan) Sacks says by the Semitic peoples of the Middle East, in the age of the biblical Patriarchs? [1] The story goes that these Semitic people living near or in Egypt invented the original alphabet based upon ideas already developed by the Egyptians, and from there it passed to the Phoenicians and Hebrews. The Phoenicians then spread it to the Greeks.

Even on the received view there is room for doubt. For example at "History of the Alphabet," <http://en.wikipedia.org/wiki/History-of-the-alphabet>, there is debate based on what one means by an "alphabet": "Some modern authors distinguish between consonantal scripts of the Semitic type, called "abjads", and the "true alphabets"" in the narrow sense, the distinguishing criterion being that the true alphabets consistently assign letters to both consonants and vowels on an equal basis, while in an abjad each symbol usually stands for a consonant. In this sense the first true alphabet was the Greek alphabet, which was adapted from the Phoenician. Latin, the most widely used alphabet today, in turn derives from Greek (by way of Cumae and the Etruscans)." The Assyriologist I.J. Gelb in "A Study of

Writing" (University of Chicago, 1952) essentially advanced the above argument that the term "alphabet" is not correctly applied to West Semitic writing and Egyptian uniconsonantal signs and thus the first true alphabet was that of the Greek where signs designate phonemes (speech sounds distinguishing one sound from another). On this position uniconsonantal signs, in say the West Semitic sign systems, do not constitute an alphabet at all being merely syllabic signs. Commenting on this, Barry Powell ("Who Invented the Alphabet: The Semites or the Greeks?" Biblical Archaeology Society Online. Archive, at <http://www.hasarchive.org/sample/bswbBrowse.asp?...>) says:

"West Semitic writing, then, was a great invention – one had to learn only about 22 signs to record speech in writing – but it was not based on an alphabet. Only a native speaker could resolve the enormous phonetic ambiguities that arose in reading Phoenician, Edomite, Hebrew or any other West Semitic language. Greek alphabetic writing, on the other hand, can be pronounced without the reader's knowing what the sounds mean."

Who Were the Greeks?

The ancient Greeks were a Nordic people, generally blond/fair haired and blue/light eyed, ultimately with a Mediterranean

mixture, before that gene pool was bred out of existence. An excellent article dealing with this topic is "The Face of Classical Europe I: Were the Greeks Blond and Blue -Eyed?" at

<https://cienciologia.wordpress.com/category/were-the-greeks-blond-and-blue-eyed/>.

The evidence is extensive; Homer's "The Iliad" describes Achilles as blond; artwork depicts a golden-haired Apollo, blond maidens and fair-haired youths. Greek literature has not a single depiction of the gods who is not "blond", "golden" or "white". The word "iris", of Greek origin, describing the colour of eyes only makes sense in a people who were not "predominately swarthy" and who had light coloured eyes as the article notes.

Consultation of Greek statues and artwork shows a predominantly Nordic people. If the Greeks at the time did not look like that, but were more typically Mediterranean as we understand it today, then it is hardly likely that their artists would misrepresent their people: that is something that we would expect in the deracinated world of the West whose elites long for the extinction of their own kind.

WADDELL, ARYANS AND THE ALPHABET by Brian Simpson

L.A. Waddell, "The Makers of Civilization in Race and History" (1929), had contributed much to the issue of the origins of the alphabet. Central to the origins of civilisation is what he called the "Aryans", the race now generally called Nordic or Northern European" (p.1). He quoted at the beginning of his masterwork from T. Huxley, "The Aryan Question," Nineteenth Century, November 1890: "There was and is an Aryan Race, that is to say the characteristic modes of speech termed Aryan were developed among the Blond Longheads alone, however much some of these may have been modified by the importation of Non-Aryan elements".

Waddell working in a time before the age of political correctness argued that the Sumerians, the oldest of the civilised peoples were a Nordic or Nordic-like

people as indicated by the evidence of remaining statues and engraved portraits on their seals. Waddell said: "This disclosed them to be preponderatingly of the longish-headed, broad-browed and large-brained Nordic type; and they were obviously fair in complexion as attested by the blue eyes of white shell inlaid with lapis lazuli stone inset in some of their statues, as also by the darkish colour of much of their jewellery; and of fair hair, as their general term for their subject people was "the black-headed (haired) people". (p.3)

This was no eccentric view of Waddell; he quoted from the great biologist Sir Arthur Keith who in 1927 has examined Sumerian skulls and said "They (the Sumerians) certainly belong to the same racial division of mankind as the nations

of Europe, they are scions of the Caucasian stock... There is no evidence of the presence of any people of Mongol affinities, nor any showing the characteristic Armenoid form of head". (p.4)

Waddell showed that the Sumerian language was Aryan in its structure, as shown in his Sumer-Aryan Dictionary. In his Aryan Origin of the Alphabet he showed that our alphabet derived from Sumerian picture-writing which had the same phonetics. All this, though, is too much of an inconvenient truth for our Establishment and is ignored and discounted. It would not do for a people ear-marked for annihilation to gain a sense of identity and historical pride.

Natural News.com (March 8, 2015), reports that almost four in 10 clinical trials in the United States are based on false information, according to a study recently published in JAMA Internal Medicine. Further, the US Food and Drug Administration (FDA) does nothing about the problem. Various research "violations" involve scientific misconduct, violations of protocol and various guidelines, as well as an under-reporting of adverse events. "Examples of uncategorized violations

include cases where the investigators used experimental compounds in patients not enrolled in trials, delegated tasks to unauthorised personnel, or otherwise failed to supervise clinical investigations properly." The author of the Natural News.com article Ethan Huff quotes from the JAMA article: "The FDA has repeatedly hidden evidence of scientific fraud not just from the public, but also from its most trusted scientific advisers, even as they were deciding whether or not a new drug should be

allowed on the market. For an agency devoted to protecting the public from bogus medicine science, the FDA seems to be spending an awful lot of effort protecting the perpetrators of bogus science from the public." Reports such as this make me wonder just how evidence-based leading Big Pharma drugs actually are, and what other dark secrets there are 'out there' that we don't know about.

CAN A SOCIAL CREDIT WORLD BE BUILT ON A NATION OF BRAIN-DAMAGED NARCISSISTS? By Peter 'the outsider' West

While most other writers at this site get praise, I seem to cop a wee bit more criticism, and it probably began almost 12 months ago when one of my book reviews of an anti-Zionist work was taken to be anti-Christian because I quoted arguments from archaeology indicating that historical Jewish figures (e.g., David, Moses, etc.) and events (the walls of Jericho tumbling down), probably didn't occur because scientific evidence for them is lacking. Recently one reader asked whether I even knew what a "community" was, as Douglas conceived of community as being "organic". A good question indeed. Certainly what we have today in Australia is not, from the ethnic mix to culture. One only has to have been alive 50+ years to

see that the West is undergoing a rapid process of decomposition and disintegration, which is celebrated by our elites as "progressive". Thus lovers of "organic" societies should be disturbed by trends such as the decline of religion and breakdown of the traditional family. But most of us seem to be struck dumb from the trauma of change. Consider a recent article "A Nation of Narcissists," *The Australian* March 23, 2015, p.10, which speculates about the neurological ramifications of the present cult of narcissism. Consumerism since the 1960s and especially information technology is creating a generation of self-obsessed youth, who, according to British neuroscientist Susan Greenfield may not be getting adequate synoptic connection development to their pre-frontal cortexes. Empathetic centres in their brains may not

adequately develop. This problem alone has apocalyptic dimensions because it means that younger generations are going to be even less concerned with issues that concern us such as social credit. Social... what? But, of course, my job now, my critics tell me, is to look to the future, give an answer and inspire optimism in readers that all will be well and we will win this war and establish a land of plenty on Earth. However more realistically the best we can do is to outline the nature of threats and be aware of how and what damage these may do. I think more in military terms: it is nonsensical to underestimate the threat posed by enemy forces merely because the grunTERS and groanERS may be made uncomfortable. How much more uncomfortable will it be when reality does catch up to us?

CRACKS IN THE FOUNDATIONS OF THE "CHINESE CENTURY" by James Reed

For the record, so that material does not disappear in the new memory hole of information overload, writers at this site seek to record significant pieces which attack or in some way criticise ideologies that we oppose. One such ideology is the "China will rule the world," "China will be No.1" dogma. John Lee, "The Chinese Century is Built on Shaky Foundations," *The Australian* 25 March 2015 p.12, gives a good refutation of this ideology. Remember the "Japan will be No.1" dogma and the frantic desire by our elites to marry Japan into projects like the MFP (Multi-Function Polis), a supposed high tech Japanese city to have been built at Gillman, Adelaide? The project collapsed and the South Australian

government has unloaded the land at fire sale prices. China has exhibited high growth as Japan did, but this is non-sustainable. China's growth has been based on capital inputs from fixed investment (building things) rather than from total factor productivity, using inputs more efficiently and productively. These high capital inputs have resulted in an explosion of corporate debt levels from 147 percent of GDP at the end of 2008 to over 250 percent at June 2014. This is a growth in debt from \$US9 trillion - \$US10 trillion in 2008 to \$US20 trillion - \$US75 trillion in June 2014. This, Lee says, is even bigger than the US commercial banking system, and unsustainable.

In short, China seems to have caught Japan's disease, and its authoritarian communist system will make it even more difficult to change course. "Concealed bad debts arising from the enormous capital waste are estimated to be 70 percent to 140 percent of GDP." Lee does not say this, but the downturn of Japan because China has locked itself into a massive spending on defence (15 percent of the budget) and unfunded pension liabilities over the next two decades, could reach \$US10.8 trillion. This, I think raises the good possibility that the failure of expectations could create enormous social stress in China, perhaps tearing the country apart. What do you think will happen to Australia?

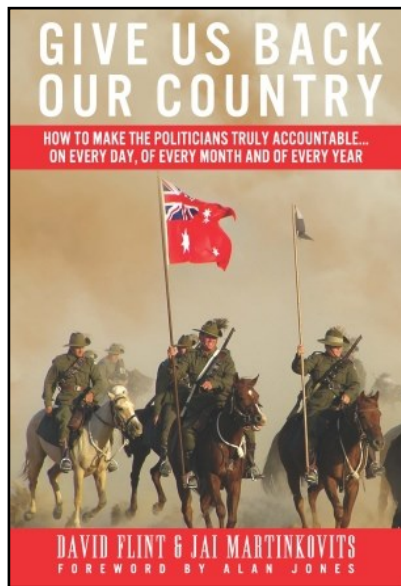

The targets of these pre-emptive strikes—Russia and China—know it, because Washington proudly proclaims its immorality in public documents describing its war doctrine.

The result is to maximize the chance of nuclear war. If you were Russia and China, and you knew that Washington had a war doctrine that permits a surprise nuclear attack, would you sit there waiting while Washington cranks up its anti-Russian and anti-Chinese propaganda machine, demonizing both countries as a threat to “freedom and democracy”?

The fools in Washington are playing with nuclear fire. Noam Chomsky points out that in a less dangerous time than currently exists, we came very close to nuclear war. {https://philosophynow.org/issues/107/Noam_Chomsky_on_Institutional_Stupidity}

“An Iraqi Holocaust” by Gideon Polya <http://www.countercurrents.org/polya230315.htm> and “Genocide In Iraq” <http://www.countercurrents.org/polya150315.htm> provide abundant

According to Baidu Maps, the building is also home to the government office that manages the affairs of retired party cadres and government officials.
