In what is probably the silliest comment on climate since a Ukip councillor blamed floods on gay marriage, a green journalist opined of the refugees dying in the Mediterranean: "This is what climate crisis looks like . . . We know there is evidence that the violence triggered by the Arab Spring uprisings of 2011 were in part fuelled by protests over soaring food prices."

The soaring prices were actually exacerbated (as the Food and Agriculture Organisation of the UN confirmed) by the diversion of much of the world's farmland into making motor fuel, in the form of ethanol and biodiesel, for the rich to salve their green consciences. Climate policies were probably a greater contributor to the Arab Spring than climate change itself.

Many refugees are fleeing Islamist persecution in Libya and the Sahel but as Dr Kandeh Yumkella, UN undersecretary-general, told the BBC, the "long-term push factors" that are driving people to make the "miserable journey" include the lack of energy in sub-Saharan Africa.

Without abundant fuel and power, prosperity is impossible: workers cannot amplify their productivity, doctors cannot preserve vaccines, students cannot learn after dark, goods cannot get to market. Nearly 700 million Africans rely mainly on wood or dung to cook and heat with, and 600 million have no access to electric light. Britain with 60 million people has nearly as much electricitygenerating capacity as the whole of sub-Saharan Africa, minus South Africa, with 800 million.

As the International Energy Agency recently put it in a recent report, "increasing access to modern forms of energy is crucial to unlocking faster economic and social development in sub-Saharan Africa". Africa is awash with fossil fuels - but not the capital to build plants to turn them into electricity. Just to get sub-Saharan electricity consumption up to the levels of South Africa or Bulgaria would mean adding about 1,000 gigawatts of capacity, the installation of which would cost at least £1 trillion. Yet the greens want Africans to hold back on the cheapest form of power: fossil fuels. In 2013 Ed Davey, the energy secretary, announced that British taxpayers will no longer fund coal-fired power stations in developing countries, and that he would put pressure on development banks to ensure that their funding policies rule out coal. (I declare a commercial interest in coal in Northumberland.)

In the same year the US passed a bill prohibiting the Overseas Private Investment Corporation - a federal agency responsible for underwriting American companies that invest in developing countries - from investing in energy projects that involve fossil fuels.

There is a growing backlash against this policy. The Republicans want to reverse it. Yvo de Boer, head of the Global Green Growth Institute, says: "You really have to be able to offer these countries an economically viable alternative, before you begin to rule out coal." And Donald Kaberuka, president of the African Development Bank, says it is hypocritical for western governments, made rich by fossil fuels, "to say to African countries, 'You cannot develop dams, you cannot develop coal, just rely on these very expensive renewables'. African countries will not listen."

The Center for Global Development calculates that \$10 billion invested in renewable energy technology in sub-Saharan Africa could give 20-27 million people access to basic electricity, whereas the same sum spent on gasfired generation would supply 90 million.

Meanwhile, China's new Asian Infrastructure Investment Bank is stepping in as the Americans and Europeans step back. Its willingness to fund coal projects is one of the reasons other Asian countries are rushing to join the project, to the irritation of Washington. The Australian government is joining forces with Japan to push for the construction of "clean coal" plants in the developing world - power stations that burn coal more efficiently.

Some greens argue that rural parts of Africa may be able to eschew giant power grids and leapfrog into off-grid solar-powered electricity, a bit like Kenya has with mobile banking. But that costs more and it won't power factories. The continent needs both, and those who advocate no support for coal are effectively saying that the adoption of renewable energy is more important than alleviating African poverty.

The evidence suggests that investing in affordable energy in Africa will not only achieve great good in itself but will equip Africans better to cope with dangerous climate change if it happens: weather-related mortality correlates with poverty. A survey of more than two million Africans finds that climate change comes dead last of 16 concerns they were asked about.

So far, the African climate has not changed significantly, anyway: dangerous weather is no more frequent and a recent analysis by Euan Mearns found that temperatures in southern Africa, outside cities, are no higher than in the 1930s. (He also found evidence of "shocking, mass manipulation of temperature records", a charge that is now to be investigated on a global level by a panel chaired by Professor Terence Kealey.)

Meanwhile, satellite images show a spectacular and beneficial greening all across the Sahel, caused partly by better land management and partly by higher carbon dioxide levels in the air, which encourage plant growth. A German study projects that this may continue for most of the current century.

Freedom and Vaccination By Mrs. Vera West

Katie Attwell, "Community Counts the Cost of Non-Vaccination", The Australian, April 17, 2015, p.12, puts the pro-vaccination case that vaccines eradicated smallpox (rather than public health measures and the disease itself waning) and "The scientific evidence of vaccines' efficacy is unequivocal and vaccines are extremely safe, made even more so by improved practices of surveillance and feedback". At this site Richard Miller in "The Vaccine War" has given the case against this. Notable is the British government in 2014 offering compensation of £60 million for children who received the swine flu vaccination. (See http:// www.ibtimes.co.uk/brain-damaged-ukvictims-swine-flu-vaccine-get-60-millioncompensation-1438572) All medications, even aspirin have some risk for some people and it is nonsense to suppose otherwise. Doctors have in their office a "Mims" or on-line, which lists all the likely side-effects from all known drugs.

Attwell says that the vaccination skeptics "have attained wide exposure for a range of spurious arguments against vaccines. These include unsupported links to ill health and disorders and claims about vaccine ingredients that ignore the maxim that the size of the dose determines the poison". So is this an admission that there may be small, but allegedly safe doses of otherwise poisons, such as mercury (as a preservative) in vaccines? The Miller paper gives evidence that Mercury is in vaccines and that there really is "no safe level", especially for poisons that accumulate in the body.

Interestingly Attwell notes that the financial benefits stick will not prevent wealthy parents from still choosing not to vaccinate and "This is a concern to some vaccination researchers, who worry about the social justice consequences of such a policy". Rather than address this issue, which essentially undermines her case (i.e. they're still will be children escaping the vaccination drag-net), she goes on to make the point that there is a message from the Abbot policy that vaccination is a social (I would say "economic") practice with costs for not vaccinating. She even says that there should be a government run no-fault compensation scheme for the "extremely rare cases of vaccine injury". Rare? Like with the swine flu injuries in the UK?

The vaccination issue is a fundamental human rights issue. The risks from vaccines, even accepting the standard line that vaccines do work, is non-zero, as with any medical treatment. People have a natural right to autonomy and individual responsibility, and informed consent. These rights with respect to medical practice are also articles 5 and 6 of the Universal Declaration on Bioethics and Human Rights and long incorporated into medicine. Coercion of parents through the Centrelink stick is a clear violation of these rights and the matter should be pursued via international law.

Sitting on the near horizon is mandatory vaccinations, or coercive/Centrelink-based vaccinations for all people. What will you do when they come with a needle for you?

Freedom, the ICAC and Common Law Rights By Ian Wilson LL.B

Even though many of us are skeptical about the anti-Federalist tendency of the High Court of Australia, on many issues of common law rights, the High Court has delivered right decisions. For example, the NSW corruption watchdog, the ICAC (Independent Commission Against Corruption) was investigating State prosecutor Margaret Cunneen SC over remarks it was alleged she said to her sons girlfriend at a traffic accident. This led to a raid and property seizure. Ms Cunneen was not supported in her bid for justice by any publicly funded human right legal

centerss or by the media. It was only the High Court which pulled the ICAC's horns in.

And what horns these are, as Chris Merritt, the legal affairs editor for *The Australian* (April 18-19, 2015, p.18), notes, The rules of evidence, such as hearsay, are relaxed, and there is only a limited ability to crossexamine ICAC witnesses. Originally the ICAC was limited only to matters affecting the probity of public officers, but since 1988 the ICAC has interpreted its powers more widely to extend to all matters that could affect the efficacy of such officials. Hence their interest in the Cunneen case. Fortunately the High Court decided rightly.

The human rights lobby were revealed as the shallow politically correct ideologues that they have been said by many to be, for their failure to defend Ms Cunneen. It was just as well that as a top legal mind she was able to handle the matter herself, and win. We all owe her a debt of gratitude. It was a great victory for common law rights and she deserves praise.

The Vaccination War By Richard Miller

Mahatma Gandhi (NaturalNews.com, February 28, 2015) was strongly critical of vaccinations saying: "Vaccination is a barbarous practice and one of the most fatal of all the delusions current in our time. Along with the Abbot proposal to take away family Tax benefits from those who are doing as Gandhi recommended, California's SB277 mandatory vaccination bill has now passed the Senate committee, after votes have been "rigged" and "public testimony silenced". According to Mike Adams over at the Naturalnews.com site (April 22, 2015), there was a public outcry over the mandatory vaccination bill, so the "pro-vaccine mafia machine" rigged voting by replacing seats on the committee with pro-vaccine supporters, and a replacement Democrat senator's vote was enough to strip Californians of their once vaccinationexemption rights. No public testimony was allowed. Adams alleges that most of the "sell-out senators" "received campaign finance donations from vaccine manufacturers".

Swine flu

Vaccine fraud

That is only one story. Also back in 2014, CDC whistleblower William Thompson issued a statement saying the following: "I am a Senior Scientist with the Centres for Disease Control and Prevention, where I have worked since 1998. I regret that my co-authors and I omitted statistically significant information in our 2004 article published in the journal Paediatrics. The omitted data suggested that African American males who received the MMR vaccine before age 36 months were at increased risk for autism. Decisions were made regarding which findings to report after the data was collected, and I believe that the final study protocol was not followed". (See Naturalnews.com, August 27, 2014) Natural News published emails that were instrumental in getting this story out.

Vaccination toxins

These examples are clear counterexamples to the dogma pushed by the vaccination lobby and Big Pharma that vaccines are "safe". There is evidence that more people have been harmed than the medical mafia are prepared to openly admit. Further, as Mike Adams pointed out back in October 24, 2012 (Natural News.com), the US Centres for Disease Control's vaccine additives page states that the following are vaccine additives: aluminum, antibiotics, formaldehyde, monosodium glutamate (MSG) and thimerosal (a methyl mercury compound). Pro-vaccinators say that the quantity of mercury is too low to matter, but there is no safe dose of an accumulative poison such as mercury. Adams quotes from the National Toxicology Programs which admits that vaccinations "may produce small but measurable increases in blood levels of mercury"; "thimerosal was found to cross the blood-brain and placenta barriers"; "hazards of thimerosal include neurotoxicity and nephrotoxicity" (i.e. brain and kidney toxicity); "similar toxicological profiles between ethyl mercury and methyl mercury raise the possibility that neurotoxicity may also occur at low doses of thimerosal"; "there are no existing guidelines for safe exposure to ethyl mercury, the metabolite of thimerosal". It was also stated that "thimerosal is still present as preservative in some vaccines given to young children,

as well as certain biological products recommended during pregnancy". Mercury is added as a preservative in multi -dose vaccines. Big Pharma could produce single-dose vaccines without thimerosal and hence mercury but find the production of multi-dose vaccines more profitable.

Is Vaccination a "Conspiracy"? Mike Adams thinks that the global elites are using vaccines to "dumb the population down so that nobody has the presence of mind to wake up and start thinking for themselves". That may or may not be so. However Adams (Natural News.com, February 28, 2015) is right in saying that we are living under a regime of scientific and medical extremism, a "bone fide scientific dictatorship" where those who reject the delusions of the cult of modern "science" are vilified, verbally assaulted and threatened with arrest and imprisonment by a fanatical class of mentally ill media operatives who claim to represent "science".

Beans, Berries and Dementia by Peter West

Here's something positive worth noting. Researchers publishing in the journal *Alzheimer's and Dementia* (lead author, Prof Martha Morris) have tested a diet that promises to reduce the risk of developing Alzheimer's disease. Called the MIND diet, the diet is largely plant-based with a focus on green leafy vegetables and berries. The study was not randomised or controlled, so it didn't meet the "gold standard" of statistical proof, but the observations made were suggestive. Basically consuming a vegetable rich diet, with nuts, beans and fruit, especially berries, is the key to weight loss and controlling high blood pressure. It seems to me that many of these modern diseases are products of junk life styles, which tend to gear people towards junk diets. The key is to get quality back into one's life and to remember that we are what we eat.

breach of natural justice and procedural fairness is addressed. The days of the New South Wales Anti-Discrimination Board rubber stamping through the complaints of its most prolific customer are over.

For those who are interested, my legal challenge against the Chief of Defence Force's decision to terminate my commission is also continuing.

The latest piece of home-grown terrorism seems to be the "teen terror" of five teenagers who allegedly planned a terrorist attack on Anzac Day. There is not much information on the planned attack, but it may have involved the use of edged weapons on police officers. Fortunately the Victorian and Australian Federal Police were on top of the matter and nipped this in the bud.

Written before that item hit the news, Jennifer Oriel, "Political Correctness Shackles the War on Terror", The Australian, April 14, 2015, p.12, argues that the "culture of the political Left has enabled terrorism". Not only are, or were, 96% of Australians who enlisted in the Islamic State on Centrelink benefits, but

the Left fails to admit, as Oriel puts it that "the problem is Islamism itself". She quotes counter-terrorist expert Patrick Poole who said referring to the Boston bombings as having "A full scale campaign of political correctness... under the Obama administration against any attempt to link jihadi terrorism with anything remotely connected to Islam of any variety (the most radical versions included)". Oriel concludes: "The findings from empirical research and analysis of failed deracialisation programs demonstrate jihadism is produced by the culture, religion and community of radical Islam. In plain terms, Western jihadism is an Islamic problem. As with any religion, Islam exists on a continuum from fundamentalism to apostasy. But unless we get the balance right, the Islamist core will destroy the freedoms for which our ancestors laid down their lives so that the children and our children's children could be free". Be that as it may attention needs to be directed to our failed so-called "nondiscriminatory" immigration programme which created this problem in the beginning.
