Can Social Credit Policies Help?

Domestic violence: Victorian Government launches family violence index to track scale of crisis By Stephanie Anderson, ABC, 17th May 2015

The Victorian Government has launched a world-first family violence index to better understand the scale of the crisis. Family violence is the leading cause of death or disability in women under the age of 45 in Australia. Minister for the Prevention of Family Violence, Fiona Richardson, said one woman a week was killed by her partner last year. This year, it is tracking as two every week. "We know we have a crisis on our hands, but what we don't know is the full extent of the harm caused by family violence," the Minister said. "So take the crime statistics for example: they've been a good indicator over time. But we know that family violence is a massively under-reported crime".

Social Credit Economics and Social Problems

Since many of the social problems with which we are faced: poverty, drug and alcohol abuse, child abuse, physical illnesses, mental illnesses, vandalism, illiteracy, delinquency,

## MINISTRY OF MISINFORMATION

On the same day as Mr Newman's revelations, an article appeared on page 2 of the same edition of *The Australian* stating that there are now record carbon dioxide levels in the atmosphere. The

much-feared 400ppm has been reached, according to the US National Oceanic and Atmospheric Administration. If the global warming hypothesis was correct then one would expect a substantial rise in the global average temperature, which has not occurred due to the so-called "pause" or "hiatus" in temperature rises. Mr Newman cuts through all of this scientific teeth chattering and says it straight: "the real agenda is concentrated political authority. Global warming is the hook". He quotes from Christiana Figueres, executive secretary of the UN's Framework on Climate Change who said, as Mr Newman paraphrases, that "democracy is a poor political system for fighting global warming. Communist China, she says, is the best model". Forget about science, logic, and debate: "It's about a new world order under the control of the UN".

#### Is 35 Years Ago Long Enough?

**League Hits the Target:** Writing in *The Australian* of December 28th, (1978) Rural Writer Alan Goodall states that while Australian farm leaders (these not mentioned by name) reject the League of Rights' warnings concerning the New International Economic Order proposal to establish international marketing boards, they "were annoyed that the National Farmers Federation, due to unite 200,000 farmers on Monday and now facing delays, might be set back

further by the League's propaganda."

The nation wide distribution of the special issue of "Electors' Voice" has already had a major impact, not only in the rural community but also in urban communities. Surveys indicate that the full impact of "Electors' Voice" has not yet been achieved, one reason being that farmers generally have been so busy with seasonal activities that they have not yet had the opportunity of grasping the far-reaching implications of the New International Economic Order proposals. Distribution of "Electors' Voice" must be intensified. Those who have already participated in the distribution campaign can now see that they have struck a major blow for the future of a Free Australia. While the League of Rights' anti-N.I.E.O. campaign was causing growing concern in Australia, Prime Minister Fraser and Foreign Minister Peacock left for Jamaica and the U.S.A. to attempt to further the grand design for the Brave New World they envisage. But they are finding there are problems, one being that the Carter Administration, under heavy pressure from American rural lobbies, is not being as cooperative as Mr. Fraser had hoped. However, he did meet with the leading One Worlders before leaving Washington.

He had talks with World Bank President, Mr. Robert McNamara, one of the power

men who bluntly states that the New World Order can only be built by shifting resources from the wealthier nations to the poorer ones. The poorer nations include Communist nations like Vietnam. The World Bank makes credits available for the purpose of shifting resources. Mr. Fraser also attended a private luncheon given by Mr. David Rockefeller, President of the Chase Manhattan Bank, and addressed the Economic Club of New York. Mr. Fraser again took up the theme of the New International Economic Order. One press report states that in talks with the Jamaican Prime Minister Mr. Manley, before going to Washington, Mr. Fraser stressed the need for "all efforts to be made to set up a common fund to stabilise world commodity prices. Progress toward this has been moving slowly, with negotiations among the developed and developing nations, deferred until early next year."

Our confident view is that as the exposure of the real meaning of the New International Economic Order becomes more widespread, progress towards the agreements sought by Prime Minister Fraser and Mr. Peacock, will become more difficult to obtain.

Now it's up to us to pick up the ball and point out that hypocrisy of the sacred taboo — only a certain class are allowed to discuss “world-government” (that's the class who like the idea).

If you fantasize of a Global Democracy or an Earth Parliament you are a Saint of the Poor. Let us cheer your insight! But if you aren't sold on the biggest of big-government ambitions, namely a global bureaucracy or A Single World Government, you are a rabid conspiracy theorist – park your brain in the cone of silence, while we laugh at you!

If Maurice Newman has talked of global bureaucracy or an earth democracy his article might have been ignored. His words would not have been repeated all over the lamestream media, but left leaning journalists and editors salivate over the chance to mock someone they love to hate. But by using this obvious bait, he reaches more readers and gives rational people the chance to talk about important things like the dangers of big-

government, and the lack of polite debate. There is no intelligent discussion of the risks and benefits of One Giant State. There is only inane name-calling “conspiracy theorist”. Those who throw it, hope to hide that they have no argument, only abusive weak name-calling.

“Conspiracy theorist” is the mindless term used to beat down a rational discussion.

It's a kind of hyper-hypocrisy and nobody bothers to hide it. When Christina Figueres, executive secretary of the UNFCCC, (United Nations Framework Convention on Climate Change) says she wants to transform the global economy, or praises Chinese dictators, she's cheered as a visionary. When Bob Brown dreams of a global democracy and parliament, he gets a standing ovation. When Maurice Newman talks about the same thing, people say he should be sacked.

When anyone points out the ambitious, self-serving goals of personal power, it's time to break out the “conspiracy-theorist” smoke machine, lest anyone start to talk about the dark side of the mini “World Government” called the UN, and that turns the public off the idea of a bigger darker version.

We've discussed this issue many times here. David Evans mapped out the theme and made the connections years ago, in *Climate Coup — The Politics*. The greatest loss of sovereignty in the history of the planet almost occurred in 2009 at Copenhagen, where most of the countries of the world planned to cede control over energy and parts of their economy to a global bureaucracy. In the event the Chinese balked and others followed. We knew then that anyone who uses the term “world government” would get called a conspiracy theorist:

If you oppose the regulating class, you will get called an “extremist”, a “nut”, a “conspiracy theorist”, “right wing”, and every variation of “stupid” and

There is no secret “conspiracy”... There is just the bleedingly obvious systematic problem that big-government players have an incentive to make government bigger and competition smaller.

## **As Evans said: Global Warming: What's At Stake for You**

If you are an economic member of the regulating class, a global bureaucracy instigated by the alleged need to regulate CO2 emissions would be terrific: more jobs, power, and money for bureaucrats and their allies. You would be part of what would effectively become a ruling class, free to tax a captive population whatever they could bear and pay yourselves whatever you “know” you're worth.

For everyone else, what's at stake is freedom from the demands of a hostile ruling class, as well as more disposable income, more choice, less red tape, and a better quality of life. The new regulating class—bureaucrats, academics, and greenies—look down on others as stupid and morally inferior, they don't like people who make real stuff, and they don't like the private sector or the marketplace. They would be happy for everyone else to compete in the marketplace to make them stuff, but they themselves won't have to compete. Their regulations would be global so there would be no escape, and competition between nations vying for our services and taxes would shrivel. Maurice Newman is flying direct into the Flak. Bravo. Let's not shy away, but head straight in to discuss the way they use name calling, insults, and denigration to silence a debate they really don't want to have. (Predictably, on the ABC site *The Drum* free speech is vital but only when the topic is “allowable”. ## The Myth of Scientific Peer Reviews by Brian Simpson

---

We are told constantly by the Establishment to trust scientists on matters such as climate change and vaccinations because science is objective. The objectivity of science is allegedly achieved by peer review, the so-called "gold standard of quality scientific research".

However, Dr Richard Norton, editor of a leading British medical journal *The Lancet* said in a recent editorial "much of the scientific literature, perhaps half, may simply be untrue" due to "studies with small sample sizes, researchers' conflicts of interest" and "an obsession" among scientists for pursuing fashionable trends of dubious importance". Dr Norton wants reform of the peer review process.

Dr Richard Smith, former editor of the *British Medical Journal* however saw peer review as a "sacred cow" that deserved to be slaughtered. Peer review in his opinion was not a good error detection method and "most of what is published in journals is just plain wrong or nonsense". Peer review was also a slow process, and expensive, further, during his time as editor of the *British Medical Journal* a paper having eight deliberate errors was sent to 300 reviewers. No reviewer found more than five and 20% detected none at all. The median error detection was two. Dr Smith concluded thus: "If peer review was a drug it would never get on the market because we have lots of evidence of its adverse effects and don't have

evidence of its benefits".

Peer review also tended to prevent innovative papers being published. Dr Smith favoured publishing papers and allowing the scientific community to assess them.

Such criticisms are a step in the right direction, but still the issue remains of the conservatism of mainstream scientific journals which tend not to publish criticisms of established paradigms. There needs to be journals devoted to "conjectures and refutations", falsification as Sir Karl Popper conceived of it allowing the establishment ideologies to be challenged.

## The Rottenness of the Universities by James Reed

---

There has been debate in the media recently about the appointment of climate change critic Bjorn Lomborg to lead a policy centre at the University of Western Australia. Critics of Lomborg allege that he has a poor "h-index", a measure of the number of peer-reviewed academic articles. The index is a sacred cow to academics, but is very limited, being based towards scientific publications. Media, newspaper, and book presentations, so essential to public policy debates, are not considered. Hence, it is an academic "snob index". Interestingly enough, Julia Gillard, who has published little academic work, was given a professorship without the same level of controversy as Lomborg. Lomborg, you see, is a private enterprise thinker whose ideals of optimism and economic progress deeply offend the pessimistic rhetoric of the Left.

That though is but the tip of the vast garbage pile that the Australian universities have become. The main problem, beyond the failure of maintaining any freedom of thought in the

stifling politically correct environment of Leftism is that of intellectual corruption produced by "dollar degrees". In 2011, the Victorian ombudsman in a report expressed concern about corruption in the universities as has, more recently, the NSW Independent Commission Against Corruption. *Four Corners*, one of the ABCs better programmes, in mid April 2015, aired a report alleging "corruption, plagiarism, widespread cheating and exploitation". Even the international education lobby have admitted that there are problems.

Much of the material about academic corruption is kept under a lid. Speaking to the few contacts that I have on "the inside" tells a story that to get the International student dollar, universities while strongly enforcing plagiarism and anti-cheating measures on Anglo-Australian students, largely go softer on international students. In fact, many academics violate their own University ethical standards in either supplying help for international students for allowing paid editorial help that goes far beyond

"peer review". The problem is that many international students really struggle with the level of English required to write a passing essay, even in the sciences without vast amounts of help, many can't pass. Yet the level of help often needed in editorial work can cross the line into essential re-writings.

Beyond even this, the ICAC and ABC have identified that universities are turning a blind eye to plagiarism and forms of cheating, are applying pressure on lecturers to change grades, or mark soft, or that there is bribery of staff by wealthy foreign students.

All this to my mind constitutes a reduction to absurdity of the present system which treats education as just another market-based good to flog off, rather than a vital part of nation-building. Australia has sown foul winds in its university system since the 1960s and is now reaping a whirlwind. It is time to end the International education racket and return to sanity.

## Trust the Government on Vaccines? Never, after the Polio Vaccine Conspiracy!

A blast from the past that we all should remember ("Millions Given Infected Polio Vaccine", *The Sydney Morning Herald*, October 23, 2004). The article begins: "A federal government agency knowingly released polio vaccine contaminated with a monkey virus in the 1960s that has been linked to a range of cancers, including mesothelioma".

The simian virus SV 40 contaminated about 3 million doses between 1956 and 1962, with two batches being released after testing positive for contamination. A

release of 700,000 doses of contaminated vaccine in 1962 was done by the Commonwealth Serum Laboratories and "justified" on the grounds that "much vaccine issued in the past was probably similarly contaminated".

Traces of SV 40 had been found in human tumour cells of people who had at that time been given the polio vaccine. Australia has the world's highest incidence of mesothelioma (lung lining cancer) and the contaminated vaccine could be one of the causes of this.

It was known at the time that SV 40 was the cause of cancer in humans, but the government went on to vaccinate 6 million Australians, with 9 out of 10 Australian children between the ages of 5 and 14 being given the vaccine.

So, why exactly should we trust the government on the vaccine issue or anything else for that matter, as surely they are the fountain of the "ministry of misinformation"

## MEXICO SUSPENDS INFANT VACCINES AFTER TWO BABIES DIE AND 29 FALL ILL

Infant vaccinations suspended and investigation begun after six of the 11 babies received injections for tuberculosis, rotavirus and hepatitis B. Mexico's public health system has suspended infant vaccines and begun an investigation after two babies died and 29 became ill in an impoverished community in southern Mexico.

The Mexican institute for social security says six of the 29 babies are in grave condition after receiving vaccinations for tuberculosis, rotavirus and hepatitis B. The cause of the adverse reactions is not known, the institute said Sunday. It had stopped vaccines across the country on Saturday.

Father Marcelo Perez, a Catholic priest, said families of the babies said they became sick within hours. The adverse reactions began on Friday and the babies were taken to a hospital in Simojovel, Chiapas, where 93% of the people live in poverty, according to government statistics.

# TURNING ON THE WHEEL OF HEALTH: EXPOSING THE DIET LIES

G.T. Wrench, "The Wheel of Health: The Sources of Long Life and Health Among the Hunza" was originally published in 1938. The book presents a study of the Hunza people who lived nestled in a region where India meets Afghanistan and China and close to what was then the Soviet Republics. It is a rugged mountainous region and these are rugged people, and even old people traverse great distances, for walking is part and parcel of the culture. Thus they get plenty of exercise. As well their diet was based around fruit and vegetables: "nothing before going out in the early morning to the fields; after two or three hours of work, bread, pulses and vegetables with milk; at midday fresh fruit or dried apricots needed with water;

in the evening these same foods, with meat on rare occasions". (p.18) Wrench's book discusses the lifestyle of these people in detail, a people who may have some European blood. Wrench speculates: "the majority of the Hunza in Hunza are distinguished by their fair skins, and they themselves scoff at being of the same blood as the smaller, dark Nagins". (p.19) The cover photograph of the 2006 edition features a Hunza woman with distinct European features - further evidence of an ancient European interaction with Asia. Recent works confirm the insights about health that the Hunza had long ago. Canadian psychiatrist Norman Doidge author of the 2007 bestseller "The Brain that Changes Itself" has now released a

new book "The Brain's Way of Healing". In it he has a chapter "A Man Walks Off His Parkinson's Symptoms". One man dealt, successfully with Parkinson's symptom simply by walking. A study is quoted that shows that walking "was a key contributor to a very simple program that eradicated the risk of dementia by... 60%". The Hunza must smile at that one. Even humble herbs such as turmeric are being tested as anti-cancer agents. Turmeric has great anti-inflammatory properties and may also aid in the fight against other diseases of our most unhealthy age. ## Uncle Len's Amazing Downtime by Len the Reader

Each week Uncle Len gets bags of fan mail from hundreds of happy far right wingers and extremist rightist conspiracy folk from across the globe. Indeed, being homeless, suffering from psycho-political psychosis and other afflictions of the "dark night" of the soul, letters help me get through the days. Most of the letters I can barely understand, being functionally illiterate, but I don't let that stand in the way of a good read. My fans often ask me "Uncle Len, have you read any good books lately?" I am pleased to say that I have finally finished Jennifer Worth's "The Midwife Trilogy". All three books: (1) Call of the Midwife; (2) Shadows of the Workhouse and (3) Farewell to the East End. These books deal with Jennifer Worth's experiences as

## 800<sup>th</sup> MAGNA CARTA ANNIVERSARY COMING UP by Betty Luks

It comes as quite a revelation the amount of material the Australian League of Rights has on its website library and archives on the famous English document the Magna Carta or Great Charter.

Magna Carta, the Great Charter of English liberties, was first issued by King John at Runnymede in June 1215AD. Immediately after John's death in October 1216, it was reissued in the name of his successor, Henry III, with substantial excisions and alterations. Two subsequent reissues in 1217 and 1225 incorporated further revisions. In the form of the third and final revision of 1225, it was confirmed in 1297 by Edward I and a copy of this confirmation was afterwards placed on the first or 'great roll' of English statutes.

Eric D. Butler in his booklet "The Essential Christian Heritage" explained the background events leading to the rebellion of the Barons against their King:



### MAGNA CARTA

"One of the most famous, and important, landmarks in English constitutional history was the signing of the Magna Carta in 1215. When the Caesar of the day, King John, attempted to combine both power and authority in his own person, he violated constitutional principles which had grown out of the climate created by the Christian Church. There were three sovereignties represented at the historic event on the isle of Runnymede: the Crown, the Church, and the Barons, who claimed to speak for the people.

Although the Barons provided the physical sanctions, these in turn were modified by the spiritual sanctions of the Church, which in the person of Archbishop Langton, played a decisive role in the formulating of Magna Carta. Here was the Christian Church insisting, not that complete power should be taken from one man and given to another group of men, but that power should be divided and subject to God's laws. As the famous English historian, Sir Arthur Bryant, writes in his "History of England":

*"It was not Langton's wish to see the Crown overthrown, the law ignored, the realm divided, the Barons petty tyrants. What he wanted was that the King should preserve the law his predecessors created. And it was to the law that the Archbishop appealed, not only of man, but of God. For it was the essence of mediaeval philosophy that God ruled the earth, and that man, and king above all men, must further His ends by doing justice or it was not in Christian eyes justice at all." ..."*

Magna Carta came to be regarded by Englishmen, and by all who have adopted English laws, as their chief constitutional defence against arbitrary or unjust rule. Its two most famous clauses (§§ 39 & 40) express and gave warranty to some of the Englishman's most deeply held political beliefs.

### Translated from the original Latin they read:

- No free man shall be seized or imprisoned, or stripped of his rights or possessions, or outlawed or

exiled, or deprived of his standing in any other way, nor will we proceed with force against him, or send others to do so, except by the lawful judgement of his equals or by the law of the land.

- To no one will we sell, to no one deny or delay right or justice.

In these and other clauses, seventeenth-century lawyers were to find a basis for such fundamental English privileges and rights as trial by jury, *Habeas Corpus*, equality before the law, freedom from arbitrary arrest, and parliamentary control of taxation. For such reasons Magna Carta could be described by William Pitt, earl of Chatham, in 1770 as forming, with the Petition of Right (1629) and the Bill of Rights (1689), the 'Bible of the English Constitution'.

### Continuing Eric Butler's comments:

The modern concept of what is called the Rule of Law is far removed from the concept of English Common Law. A realistic examination of this subject requires that first we ask, "Whose law?" Like every other human system, a system of law must, if the Christian view of reality is to be accepted, seek to serve the individual, to ensure that his natural rights are protected, that his sovereignty as a free and responsible individual is ensured, and that the Courts exist to enable him to seek the protection of an independent judiciary. In a Christian society, it is essential that members of the judiciary also accept the Christian basis of English Common Law, and are not afraid to pronounce against governments when they are violating the Common Law. The suggestion that the world can be subordinated to a rigid Rule of Law implies that the relationship of every individual in the world to the Law must be exactly the same. William Blake, the English poet and mystic grasped the necessity of any system of law being related as far as possible to reality when he said that "One law for the lion and the lamb is oppression".

Shakespeare also understood this issue. Justice as seen by Shylock demonstrates the unsuitability of the strict, rigid legal process to anything but a purely static situation. There can be a vast difference between the letter of the law and the spirit of the law, a difference which Christ attempted to demonstrate to the Pharisees of His day..."

### Two current issues of contention immediately come to mind:

The right to Trial by Jury which Mr. John Wilson is battling for, more or less fighting a lone battle and another is the threat of Compulsory Vaccination which Tony Abbott is seeking to impose by the carrot and the stick method. "No Jab – No Social Welfare".
