# THE ISSUES CANNOT BE 'COMPARTMENTALISED' by Betty Luks

The following reports remind me of a 1937 book written by then director of the Bank of England, Sir Josiah Stamp. Geoffrey Dobbs wrote a review of the book: *"The Science of Social Adjustment"* published by MacMillan.

Geoffrey noted the 'double-speak': 'The first chapter, "The Impact of Science upon Society," will be fresh upon the minds of many readers. Put as briefly as possible, the gist of these 70 pages of impressive "polysyllability" is that scientific innovation creates a disturbance which is often "a high price to pay for progress".'

"The injuries to labour . . . are regarded as equitably a charge to be borne by society in general through taxation," i.e., observes Geoffrey: 'Every increase in leisure is to be debited instead of credited to society. It follows that, to comply with this ridiculous concept of the economists, both science and man must be regulated so as to reduce the effect of innovation to a minimum.'

'About one-third of the way through the book we find the following sentence, which sums up its contents admirably: "I have so far discussed modification of impact to meet the nature of man. (!) Now we must consider modifying the nature of man to meet impact."

'Apparently this second task is not so easy, "for human wills in the aggregate are behind distribution and consumption and they can never be regulated which are so potent in mathematics, chemistry", etc.

Our scientists "have to learn to do with wills," and other human characteristics, with a view to their regulation.' "A great draft on the highest mental ability for such social studies is essential."

Hence, one presumes, the tireless activity of this Director of our Central Bank in addressing scientists. Sir Josiah stands out..."

Whether we write about the illegal invasion of 'immigrants' or the 'unemployment' question, or the sell-off of our valuable agricultural lands to Chinese businessmen, the issues 'interlock' and will affect our children's and grandchildren's future.

# **BE WARNED!**

Andrew Bolt's Blog 13 October 2015: *Germany already pay a price for the immigrant invasion*. Nick Cater wrote on what the mainstream media tends not to mention about the invasion of Germany by illegal immigrants:

The internet also reveals that the proportion of crimes committed by asylum-seekers in Germany has doubled in three years from 3.3 per cent to 7.7 per cent. There has been a sharp rise in personal injury, from 3,863 to 9,655. Shoplifting cases have risen from 4,974 to 13,894.

And where are the jobs for the 1 million illegal immigrants expected this year alone?

A 2010 study by the Institute for the German Economy found the unemployment rate for those without a German passport is 14 per cent. Among those from Islamic countries it was even higher: 55 per cent for Lebanese migrants, 46 per cent for Iraqis and 28 per cent for Afghans.

**The same is true here:** A study of 8500 entrants under the humanitarian resettlement program conducted by the Gillard government in 2011 found that more than six out of 10 refugees had failed to get a job after five years. Eighty-three per cent received Centrelink payments. As in Europe, those from Islamic countries fared worse. Fewer than one in 10 Iraqi and Afghan refugees had found work; 94 in every 100 were receiving welfare.

How will that work out, do you think?

"The conference, a one-day event organized by the World Technology Network, was not directly about basic income.

The main topic was the labor market effects of automation, but nearly all of the participants who discussed policy responses to automation endorsed basic income. "Leading economists and business people discuss Basic Income at the World Summit on Technological Unemployment" http://goo.gl/bGoKr2, and the incentive to attend the conference was directed because "Our social peace, education system, industrial forecasting, social welfare system, tax policy, geopolitical alignments, and so much more are all at play."

"Most of the participants agreed that automation is a good thing with negative side effects. People lose their jobs; sometimes they can only find jobs and lower incomes; sometimes they do not find new jobs at all. At the rate at which jobs are being automated now many participants were concerned that the need for human labour in the production process is permanently declining. In a world where most people are dependent on their jobs for their livelihood, it can lead either to permanently lower wages or permanent unemployment..."

Harvard President, Lawrence Summers, mentioned the observation by the Nobel Prize winning economist, Wassily Leontief, "The role of humans as the most important factor of production is bound to diminish in the same way that the role of horses in agricultural production was first diminished and then eliminated by the introduction of tractors."

For many of the participants, basic income was the obvious solution. If everyone received an unconditional cash income sufficient to meet their needs, everyone would share in the benefits of automation even if they were unable to find jobs in the new economy. Speakers endorsing Basic Income at the conference included: James P. Clark, chair of the World Technology Network, who argued forcefully for basic income in his opening remarks; Scott Santens, a journalist for the Huffington Post; Martin Ford, author of Rise of the Robots: James Hughes, a sociologist and bioethicist at Trinity College in Hartford, CT..."

Now while it all sounds good so far, the Big Question is "How would these people finance such a Basic Income policy?" And this is where the philosophy that drives them and the policies they recommend become clearer. C.H. Douglas provided the answers long ago.

#### HOW TO SHUTDOWN AN ENTIRE CAR INDUSTRY? - DIESEL EMISSIONS ROW

*Create a problem and provide only "one" difficult to accept answer - ed.* 

Mercedes-Benz, Honda, Mazda and Mitsubishi's cars are shown to emit significantly more NOx (Nitric Oxide) pollution on the road than in regulatory tests. Mercedes-Benz, Honda, Mazda and Mitsubishi have joined the growing list of manufacturers whose diesel cars are known to emit significantly more pollution on the road than in regulatory tests, according to data obtained by *The Guardian*.

In more realistic on-road tests, some Honda models emitted six times the regulatory limit of NOx pollution while some unnamed 4x4 models had 20 times the NOx limit coming out of their exhaust pipes.

"The issue is a systemic one" across the industry, said Nick Molden, whose company Emissions Analytics tested the cars. *The Guardian* revealed last week that diesel cars from Renault, Nissan, Hyundai, Citroen, Fiat, Volvo and Jeep all pumped out significantly more NOx in more realistic driving conditions. NOx pollution is at illegal levels in many parts of the UK and is believed to have caused many thousands of premature deaths and billions of pounds in health costs.

All the diesel cars passed the EU's official lab-based regulatory test (called NEDC), but the test has failed to cut air pollution as governments intended because carmakers designed vehicles that perform better in the lab than on the road. There is no evidence of illegal activity, such as the "defeat devices" used by Volkswagen....

"These new test results [from Emissions Analytics] prove that the Volkswagen scandal is just the tip of the iceberg. What we are seeing here is a dieselgate that covers many brands and many different car models," said Greg Archer, an emissions expert at Transport & Environment. "The only solution is a strict new test that takes place on the road and verified by an authority not paid by the car industry."...

Friends of the Earth air pollution campaigner Jenny Bates said: **"With further manufacturers implicated, this is yet more evidence that this scandal goes way beyond VW, and should cause decision-makers to question the very future of diesel vehicles on our roads. This is a massive public health disgrace and the failure to prevent vehicles breaking pollution rules will have cost lives."**

# ANOTHER DAY OF INFAMY FROM THE HISTORICAL RECORD by Louis Cook

October 24<sup>th</sup> marks 70 years since the execution by firing squad of Vidkun Quisling, former politician of Norway. What did he do to warrant his prompt execution after the end of hostilities in Europe?

He understood the Bolshevik-Jewish mindset sweeping across Europe from the east and he had to be silenced quickly.

My interest in Quisling stemmed from reading "*I Was Quisling's Secretary*' by Franklin Knudsen, back in the early 1970s. A 'Quisling' search of the Internet today will find many references to 'right wing' 'fascist' and other political swear words in connection to him; but was he or is it true?

"You will be my historical witness. The day will come when I will need it," said the Norwegian Prime Minister Vidkun Quisling to his secretary, Franklin Knudsen. The national leader's words were spoken with great solemnity as the two men sat in a room of Oslo's Grand Hotel on the 18th April 1940. Nine days earlier their country had fallen to the forces of the Third Reich.

The story of Quisling demonstrates beyond doubt there are 'dark forces' with tremendous power and influence abounding in this world and graphically illustrated by the use of the word '*quisling*' to forever mean traitor or betrayer of one's native land. Very powerful forces indeed!

In his youth, Quisling proved academically talented in humanities, particularly history, and natural sciences; he specialised in mathematics. In 1905, Quisling enrolled at the Norwegian Military Academy, having received the highest entrance examination score of the 250 applicants that year. Transferring in 1906 to the Norwegian Military College, he graduated with the highest score since the college's inception in 1817, and was rewarded by an audience with the King.

On 1 November 1911, he joined the army General Staff. In March 1918, he was sent to Russia as an attaché at the Norwegian legation in Petrograd, to take advantage of the five years he had spent studying the country. When the legation was recalled in December 1918, Quisling became the Norwegian military's expert on Russian affairs.

In September 1919, Quisling departed Norway to become an intelligence officer with the Norwegian delegation in Helsinki, a post that combined diplomacy and politics. In the autumn of 1921, Quisling left Norway once again, this time at the request of explorer and humanitarian Fridtjof Nansen, and in January 1922 arrived in the Ukrainian capital Kharkov to help with the League of Nations humanitarian relief effort there. Highlighting the massive mismanagement of the area and the death toll of approximately ten thousand a day, Quisling produced a report that attracted aid and demonstrated his administrative skills, as well as his dogged determination to get what he wanted.

Having left Ukraine in September 1922, Quisling returned to Kharkov in February 1923 to prolong aid efforts, with Nansen describing Quisling's work as "absolutely indispensable".

The harder line now developing in Russian politics led Quisling to distance himself from Bolshevism. The Soviet government had rejected outright his Armenian proposals, and obstructed an attempt by Nansen to help with the 1928 Ukrainian famine. Quisling took these rebuffs as a personal insult; in 1929, with the British now keen to take back control of their own diplomatic affairs, he left Russia.

He was appointed a Commander of the Order of the British Empire (CBE) for his services to Britain, an honour revoked by King George VI in 1940. By this time, Quisling had also been awarded the Romanian Crown Order and the Yugoslav Order of St Sava for his earlier humanitarian efforts

From 1942 to 1945 he served as Minister-President, heading the Norwegian state administration jointly with the German civilian administrator Josef Terboven. His pro-Nazi puppet government, known as the Quisling regime, was dominated by ministers from Nasjonal Samling, (National Unity) the party he founded in 1933. The collaborationist government was alleged to have participated in Germany's Final Solution. Quisling was put on trial during the legal purge in Norway after World War II and found guilty of charges including embezzlement, murder and high treason.

As in all of the victors' show trials Quisling was allowed neither defense counsel save one chosen for him by the state, nor defense witnesses or defense evidence. The judge, Eric Solem, was handpicked as a veteran political opponent of the Nasjonal Samling's leader. He was almost certainly Jewish.

Quisling was executed by firing squad at Akershus Fortress, Oslo, on 24 October 1945. The word quisling has since become a synonym for collaborationist, an allusion to the very poor light in which Quisling's actions was seen both at the time and after his death.

More to the point was his rejection of communism and socialism as he spurned their advances to be rewarded with hate and enmity.

#### **CO-EVOLUTION: SOCIAL CREDIT BIOLOGY by Brian Simpson**

The original article has a somewhat intimidating title: M. Nagasawa (et al.), "Oxytocin-Gaze Positive Loop and the co-evolution of Human-Dog Bonds", Science, vol. 348, 2015, pp. 333-336. The article postulates that Europeans and modern dogs evolved together, with the modern dog evolving from the mega-faunal wolf about 18,000 years ago in Europe.

The researchers investigate the fact that dogs understand the social world of humans even better than allegedly more intelligent creatures such as apes, especially gaze direction and the use of other communication markers. This quality was selected by humans in dogs, for only those dogs which were "social" were ultimately kept. And for the dog, domestic life meant greater food security and mating opportunities. These social co-evolutionary qualities are not found in wolves, which ignore the social cues that modern dogs pick up in social interaction.

Although most writers on social credit seem to focus, naturally enough, on human "association" and cooperation, social credit concepts also carry over to human-animal interactions. Living in a world of machines we tend to forget how important animal association (e.g. horse power) has been for the development of civilisation. And with global economic collapse just around the corner, we may return to not only a "world made by hand", but a world made by animals.

# THE LIES OF THE UN by Brian Simpson

One common thread to all freedom movement traditions is fear of the UN, and rightly so. Thus when a mainstream publication says "there is something rotten in the heart of the United Nations"; it is worth noting this, for the record.

# **GOOGLE DEGENERATES TO MINISTRY OF TRUTH** All knowledge must now be pre-approved by search algorithm

(NaturalNews) Gone are the days when you could search Google and pull up neutral, relevant content appropriate to your search query.

The search engine giant is reportedly pioneering a new search algorithm that will tailor search results not based on popularity or accuracy, but rather on what Google itself deems to be truthful or untruthful.

The world's new "Ministry of Truth", Google believes that screening and censoring information requested by its users will help avoid "websites full of misinformation" from showing up at the top of the search list.

Known as the "Knowledge Vault," the novel algorithm is described by *The New American* as "an automated and super-charged version of Google's manually compiled fact database called Knowledge Graph."

Google's Knowledge Graph, in case you didn't know,

was the search engine's first attempt at becoming a purveyor of *knowledge* rather than just *information* -- a "smart" search tool, if you will, designed to enhance the relevancy of search results by analyzing various facts, figures, and other data appropriate to a user's intended query.

The Knowledge Vault builds upon this concept, but takes it another step further.

By sorting through the actual content of websites to determine whether or not they fit the official narrative for the particular idea or concept presented, the Knowledge Vault will act as a type of knowledge gatekeeper in censoring out information and content deemed to be "false."
