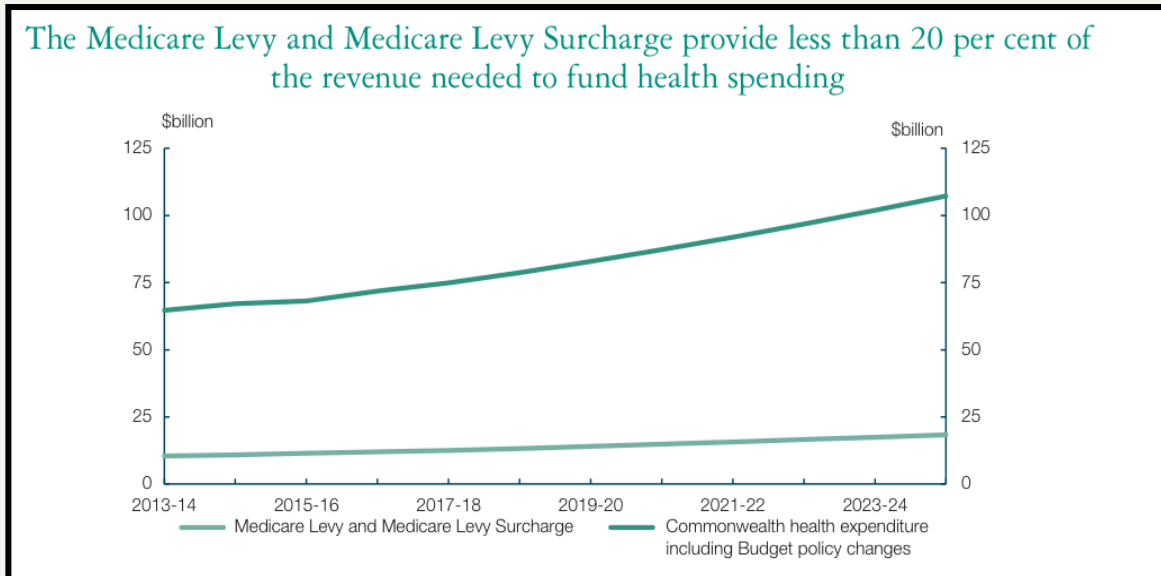

## DRUG FIRMS PREPARE FOR WAR

Drug companies are on the brink of war with the Abbott government over proposed cuts in next week's budget, which they warn will restrict access to new medicines.

The government is proposing a 5 per cent cut in what it pays for some leading medicines, including the latest cancer drugs, in a bid to save the Pharmaceutical Benefits Scheme \$3 billion from the innovative medicines sector alone in the next five years. The savings are understood to be part of government

plans to cut as much as \$5bn from the PBS over the next five years.

Sources have told The Australian that total savings from the health budget will exceed \$7bn in Tuesday's budget.

Medicines Australia, which represents the innovative medicines industry, is said to be considering a public campaign against the cuts and has called in leading lobbying firms, including Liberal Party pollster Crosby Textor.

Medicines Australia chairman Martin Cross wrote to Tony Abbott yesterday rejecting

the cuts. "We simply cannot support the proposals put forward by the Department of Health on behalf of the government and seek your intervention in order to achieve a much better reform for all concerned," Dr Cross wrote.

He said the Health Department had advised Medicines Australia last week about the proposed savings measures and warned that there was "unprecedented concern in our industry".

## VACCINATION AND HERD IMMUNITY by Brian Simpson

One of the principal arguments for mass vaccination is the idea of "herd immunity". The idea here is summarised at [vaccines.gov](http://vaccines.gov) "your best shot at good health" Community Immunity ("Herd Immunity") it is stated: "When a critical portion of a community is immunised against a contagious disease, most members of the community are protected against that disease because there is little opportunity for an outbreak. Even those

who are not eligible for certain vaccines - such as infants, pregnant women, or immuno-compromised individuals - get some protection because the spread of the contagious disease is contained". Given this idea it follows that the relatively low numbers of conscientious objectors; the allegedly herd immunity would still exist for the community. After all, unvaccinated people are not a threat to vaccinated people, given standard

vaccination assumptions. There will be, allegedly a break in the chain of infection and hence a lower probability that those not immune will be exposed to disease-carrying individuals. Hence, the very idea of "herd immunity" counts against the Abbot proposals of coercive vaccinations based on the Centrelink "stick".

## TPP PILL DIFFICULT TO SWALLOW FOR PHARMACEUTICALS

The conflict between intellectual property protection and cheap medicine has lasted for decades. Should the Trans-Pacific Partnership be passed, it's an issue that will suddenly come into sharp focus for Australians.

The TPP is a trade treaty involving 12 Pacific Rim countries, including Australia and the United States.

What the pharmaceutical industry is proposing as part of the TPP is 12 years of monopoly after the release of a new treatment. During this time, companies will be able to charge whatever the market will bear for the new drug. That period is seven years longer than the current data protection period in Australia, after which competitors can develop and sell cheap generic alternatives. And for someone suffering a serious illness who needs affordable medicine, that seven years literally could be a life-and-death

difference.

Yes, many life-saving drugs are subsidised by the Australian government's Pharmaceutical Benefits Scheme and the PBS could choose to subsidise the costs of these expensive new drugs. Of course, that merely shifts the problem around. Each year of extra monopoly protection could cost the PBS hundreds of millions of dollars, in a very tough budgetary environment. Future federal governments would be faced with the tough choice of drastically lifting spending on the PBS, cutting subsidies for patients who need the new drugs, or leaving many new drugs off the

scheme altogether. Moreover, the oft-asked question would be repeated: what price a life?

Of course, the pharmaceutical industry has a sound response to all this. The extra profit generated by protected medicine will drive investment in research and development, allowing drugs to be developed that would otherwise have stayed locked in the minds of scientists. Yes, people might complain about a drug that is very expensive for 12 years. But the alternative, the industry says, would have been no drug at all.

## UN CALLS FOR SUSPENSION OF TTIP TALKS OVER FEARS OF HUMAN RIGHTS ABUSES

UN lawyer says tactics used by multinationals in courts outside of public jurisdiction would undermine democracy and law

A senior UN official has called for controversial trade talks between the European Union and the US to be suspended over fears that a mooted system of secret courts used by major corporations would undermine human rights. Alfred de Zayas, a UN human rights campaigner, said there should be a moratorium on negotiations over the Transatlantic Trade and Investment



Partnership (TTIP), which are on course to turn the EU and US blocs into the largest free-trade area in the world.

Speaking to the *Guardian*, the Cuban-born US lawyer warned that the lesson from other trade agreements around the world was that major corporations had succeeded in blocking government policies with the support of secret arbitration tribunals that operated outside the jurisdiction of domestic courts.

He said he would be compiling a report on the tactics used by multinationals to

illustrate the flaws in current plans for the TTIP.

De Zayas said: "We don't want a dystopian future in which corporations and not democratically elected governments call the shots. We don't want an international order akin to post-democracy or post-law."

The intervention by de Zayas comes amid intense scrutiny in the US, Europe and Japan of groundbreaking trade deals promoted by Barack Obama. The European commission, which supports the talks, believes an agreement that

would lower tariffs and establish basic health and safety standards would boost trade and add billions of euros to the EU's income. UK ministers estimate Britain could benefit from a rise in GDP of between £4bn and £10bn a year. Under the proposed agreement, companies will be allowed to appeal against regulations or legislation that depress profits, resulting in fears that multinationals could stop governments reversing privatisations of parts of the health service, for instance.

## ARE VACCINATED CHILDREN HEALTHIER? By Mrs Vera West

The vaccination industry is a multi-billion dollar producer for Big Pharma and vaccines are one of its fastest growing sectors. With countries adopting mandatory and punitive approaches riding over free choice considerations, it is important for the question to be continuously asked: are vaccinated children healthier than unvaccinated children?

Established medicine does not investigate this question because, arguing with circular and question-begging logic, they maintain that it would be unethical to have a control group of unvaccinated children. However the German website [impfshaden.info](http://impfshaden.info) and [vaccineinjury.info](http://vaccineinjury.info) have conducted their own comparison of the health of vaccinated versus unvaccinated children. Over 12,000 responses have been made from the USA, Canada and Australia, comparing the health of vaccinated versus totally unvaccinated children. Most parents who did not vaccinate did so because of concern over the contents of vaccines, their effectiveness, and side-effects. These statistics cited at [The Healthy Home Economist.com](http://TheHealthyHomeEconomist.com), clearly indicated that

based on the survey results, unvaccinated children are healthier than vaccinated children:

- Less than 10% of unvaccinated children suffer from allergies of any kind. This compares with 40% of children in the USA aged 3-17 reporting an allergy to at least one allergen and 22.9% with an allergic disease.
- 0.2% of unvaccinated children suffer from asthma. This compares with 14-15% of vaccinated children with asthma in Australia, 4.7% in Germany, and 6% in the USA.
- 1.5% of unvaccinated children suffer from hay fever. This compares with 10.7% in Germany.
- 2% of unvaccinated children have neurodermatitis. This auto-immune disorder affects over 13% of children in Germany.
- ADHD was present in only 1-2% of the unvaccinated children. This compares with nearly 8% of children in Germany with ADHD and another 5.9% borderline cases.
- Middle ear infections are very rare

in unvaccinated children (less than 0.5%). In Germany, 11% of children suffer from this problem.

- Less than 1% of unvaccinated children have experienced sinusitis. This compares with over 32% of children in Germany.
- Only 4 unvaccinated children out of the 7600+ total surveys reported severe autism. In all 4 cases, however, the mother tested very high for mercury. In the USA, approximately 1 in 100 children suffer from this neurological illness and 1 in every 38 boys in the UK.

In the United States a mysterious virus, EV-D68 swept across the country, hospitalising hundreds of children. There was no vaccine against the virus.

An article at [sheepnomore.net/](http://sheepnomore.net/) noted that those becoming infected had all been vaccinated with MMR vaccines, Influenza vaccines and Polio vaccines and the illness was not observed to occur in unvaccinated children. This is something that vaccination sceptics should follow up to see if EV-D68 did, ultimately only affect vaccinated children.

## BILL GATES, VACCINES AND INDIA by Mrs Vera West

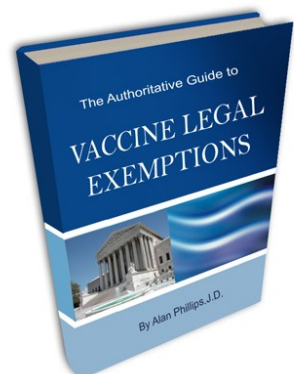
Here is another contribution to vaccination scepticism. As we know, Bill Gates of Microsoft fame is Mr Vaccination. But not all countries are as accepting of his vaccination promise as the West. The Supreme Court of India, according to a report by Christiana Sarich from Global Research, is to consider a writ of petition by Kalpana Mehta, Nalini Bhanot, and Dr. Rukmini Rao, which states that the Bill and Melinda Gates Foundation and to organizations funded by the Gates foundation – PATH (Programme for Appropriate Technology in Health) and GAVI (Global Alliance for Vaccines and Immunisation) “were criminally negligent trialling the vaccines on a vulnerable, uneducated and under-informed population school administrators, students and their

parents, who were not provided informed consent or advised of potential adverse effects or required to be monitored post-vaccination”.

For example, according to the *Economic Times of India*, 16,000 young tribal girls were given the Gardasil HPV vaccine. Within a month, many of the girls were ill and five had died. In Vadodara, Gujarat, 14,000 girls were vaccinated with the HPV vaccine Cervarix, and another two died. Consent forms to administer the HPV vaccine were illegally signed by youth hostel wardens. Many of the vaccinated girls receiving the Gardasil vaccine are now infertile. Vaccination sceptics can find much material to support their case by looking outside of the media closed circle of the West and consulting Indian and non-Western sources.

# KEY CDC SCIENTIST WHO DOWNPLAYED VACCINE-AUTISM CONNECTION IS NOW FLEEING FROM JUSTICE By J. D. Heyes

(NaturalNews) A leading scientist with the Centers for Disease Control and Prevention whose noted "Denmark Study" ostensibly disproved any link between vaccines and autism as well as additional neurological disorders is now fleeing justice with nearly \$2 million he allegedly was to spend on research.

As first reported in April 2011 by Natural News Editor Mike Adams, the Health Ranger, Dr. Poul Thorsen was indicted by a federal grand jury in Atlanta on charges of wire fraud, money laundering and defrauding research institutions of grant money.

That report came after a May 2010 report in *The Huffington Post* noting that Thorsen fled with the money as Danish police launched an investigation into alleged fraud involving millions of taxpayer dollars over time.

Adams noted that Thorsen "is a scientist who formerly worked for the CDC, and over the last several years, he oversaw millions of dollars in grant money that was used to conduct research to 'prove' that vaccines have no link to autism." One of Dr. Thorsen's research papers is the famous "Thimerosal and the occurrence of autism: negative ecological evidence from Danish population-based data" study.

## Theft raises doubts about validity of his research.

Adams said the paper concluded that thimerosal, the mercury-based preservative that is used in vaccines globally, has no statistically significant link to autism. Thorsen's piece was a key paper used by vaccine proponents who argued that thimerosal is safe to inject into

children.

Adams noted that the fact that Dr. Thorsen's "credibility is now being called into question by a federal indictment of fraud and money laundering will, of course, have ripple effects throughout both the vaccine industries and autism support groups."

Regarding his autism-vaccine "research," HuffPo added:

His study has long been criticized as fraudulent since it failed to disclose that the increase was an artefact of new mandates requiring, for the first time, that autism cases be reported on the national registry. This new law and the opening of a clinic dedicated to autism treatment in Copenhagen accounted for the sudden rise in reported cases rather than, as Thorsen seemed to suggest, the removal of mercury from vaccines. Despite this obvious chicanery, CDC has long touted the study as the principal proof that mercury-laced vaccines are safe for infants and young children.

## Hiding the vaccine-autism link.

According to the indictment, Thorsen was given millions in grant money dating back to the 1990s. In 2002, he moved to Denmark and became the "principal investigator" for the grant money, responsible for administering the research money that the CDC awarded. Between 2000 and 2009, he received some \$11 million in awards. Adams cited the Justice Department's indictment that said Thorsen allegedly skimmed money by submitting fraudulent expense statements that were falsely tied to the Denmark study. As Huffington Post further noted, Thorsen wasn't even a research scientist or

toxicologist - he was a psychiatrist.

Nevertheless, he parlayed his initial autism study into a taxpayer-funded cash cow in the form of a long-term relationship with the CDC.

He managed to build a research empire of sorts called the North Atlantic Epidemiology Alliances, or NANEA, which boasted a close relationship with the CDC's autism team. It was a relationship that "had the agency paying Thorsen and his research staff millions of dollars to churn out research papers, many of them assuring the public on the issue of vaccine safety," HuffPo reported.

Thorsen's shenanigans have forced leading independent scientists to question the CDC's judgment, his research in particular, and why the agency has gone to some effort to conceal the vaccine-autism link in mercury-laced injections beginning in 1989 with the epidemic of autism and other neurological disorders that have affected generations of American children....

For its part, Aarhus University sought to sever its ties with Thorsen in 2011.

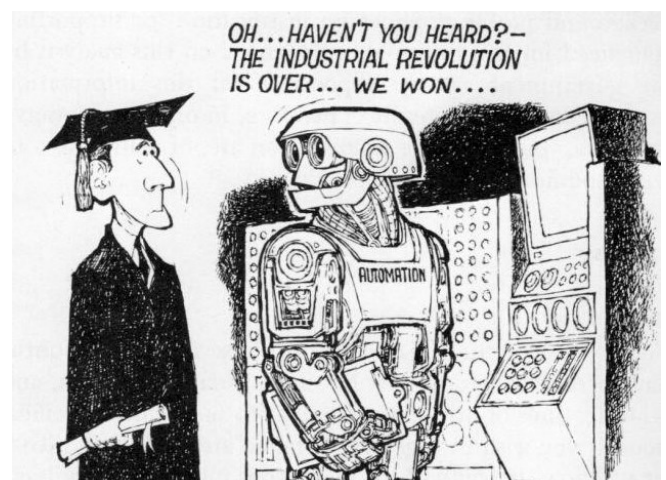
"Unfortunately, a considerable shortfall in funding at Aarhus University associated with the CDC grant was discovered," the university said in a statement. "In investigating the shortfalls associated with the grant, DASTI and Aarhus University became aware of two alleged CDC funding documents as well as a letter regarding funding commitments allegedly written by Randolph B. Williams of CDC's Procurement Grants Office which was used to secure advances from Aarhus University. Upon investigation by CDC, a suspicion arose that the documents are forgeries."

## CHINA BUILDS CITY'S FIRST ALL-ROBOT FACTORY REPLACING HUMAN WORKERS

# SB 277 – CALIFORNIA'S VACCINE VIOLENCE TARGETS GENETICALLY VULNERABLE CHILDREN WHO CAN'T ELIMINATE THE HARMFUL TOXINS

(NaturalNews) California's SB 277 mandatory vaccine law will unleash a wave of vaccine violence against children, posing a grave risk of permanent neurological injury to genetically vulnerable children who can't efficiently eliminate the many toxins found in vaccines.

Vaccines given to children in America today are admitted by the CDC to contain aluminium, mercury, monosodium glutamate and formaldehyde - all known neurotoxins. While healthy people with the right genetic makeup might eliminate these toxins relatively quickly, there is a subgroup of genetically susceptible children and adults who cannot. These individuals are genetically "hyper-susceptible" to vaccine damage. In effect, they are "genetic ticking time bombs" of vaccine damage.

SB 277 makes no mention of this genetic susceptibility, nor does the law require the state to conduct genetic screening of children before subjecting them to the potentially dangerous medical intervention of vaccines. SB 277 also refuses to require vaccine makers to clean up their vaccines and remove all the toxic chemicals and heavy metals that damage vaccine injury victims. Those children who suffer from these genetic vulnerabilities are being deliberately sacrificed by the California government in its aggressive, corporate-constructed effort to coerce all children into being vaccinated.

## Learn about MTHFR polymorphism.

### (methylenetetrahydrofolate reductase (NAD(P)H))

The medical industry's answer to all this is denial. The science of genetics is cast aside when it suits them... even though they hilariously scream that vaccine safety is backed by "SCIENCE!" But the real science reveals that a common genetic polymorphism (gene variation) affecting the MTHFR gene makes children especially vulnerable to vaccine damage (i.e. "Adverse Events"). SB 277 does not require any genetic screening at all before mandatory vaccination, meaning that the new law will force children who are likely to be harmed by vaccines to be injected with vaccines against their parents' consent. Not only is this a gross violation of medical ethics, parental choice and human rights; it's also a violation of medical science which reveals some children are more vulnerable to vaccine damage than others. The genetic basis for vaccine damage in children. Take a look at the published medical study Genetic Basis for Adverse Events after Smallpox Vaccination, which says:

*Genetic polymorphisms in genes expressing an enzyme previously associated with adverse reactions to a variety of pharmacologic agents (MTHFR) and an immunological transcription factor (IRF1) were associated with [Adverse Events] after smallpox vaccination in 2 independent study samples... All of the vaccinia virus-naive subjects who were enrolled in the study developed pock formation at the vaccination site, and a subset experienced systemic reactions that included fever, rash, or regional lymphadenopathy.*

*...Three variant genotypes were confirmed to be associated with AEs in the second study. These included 1 SNP in the methylenetetrahydrofolate reductase gene (MTHFR) ( $P < .01$ ) and 2 SNPs in the interferon regulatory factor-1 gene (IRF1) ( $P = .03$ ). The strong significance of the association in the replication study suggested a high level of plausibility that the gene products were involved in the pathogenesis of the [Adverse Events].*

This study confirms that vaccines caused a spike in adverse events among those with the genetic predisposition. Vaccine damage, in other words, can be correlated with a child's DNA. A genetic test, conducted before vaccinating, could alert a parent or a doctor to a heightened risk of vaccine injury. Armed with this information, a parent might rationally decide to avoid vaccinating that child and thereby prevent that child from becoming brain damaged or even made autistic by the vaccine's toxic adjuvants and additives. The vaccine industry, however, doesn't want anyone to be aware of this genetic correlation with vaccine damage. Why? Because vaccine manufacturers and the CDC are pushing... those vaccines, harm no children at all. Any discussion of a genetic predisposition must involve the acknowledgement that vaccines can and do damage some children... and that idea simply isn't allowed to surface in the mainstream media because it would contradict (and expose) all the decades of outright lies, scientific fraud and criminal conspiracy between the CDC and Big Pharma. # THE TESLA BATTERY HERALDS THE BEGINNING OF THE END FOR FOSSIL FUELS

*Amid the fanfare over the launch of the Powerwall, has Tesla's Elon Musk struck a decisive blow for renewable energy?*



While wind and solar power have made great strides in recent years, with renewables now accounting for 22% of electric energy generated, the issue that has held them back has been their transience. The sun doesn't shine at night and the wind doesn't blow year-round – these are the mantras of all those opposed to the progress of renewables.

Now the renewable power billionaire Elon Musk has just blown away that final defence. Last Thursday in California he introduced to the world his sleek new Powerwall – a wall-mounted energy storage unit that can hold 10 kilowatt hours of electric energy, and deliver it at an average of 2 kilowatts, all for US\$3,500.

That translates into an electricity price (taking into account installation costs and inverters) of around US\$500 per

kWh – less than half current costs, as estimated by Deutsche Bank. That translates into delivered energy at around 6 cents per kWh for the householder, meaning that a domestic system plus storage would still come out ahead of coal-fired power delivered through the conventional grid. What's more, Musk is going to manufacture the batteries in the United States, at the "gigafactory" he is building just over the border from California in Nevada. He is not waiting for some totally new technology, but is scaling up the tried and tested lithium-ion battery that he is already using for his electric vehicles.

## Not just for homes

Now the fossil fuel companies – from fuel suppliers such as coal miners to coal-burning electric power utilities – will be on the defensive, fighting the new normal of cheaper renewable supplies and storage. Instead of asking "can we have our own energy system?" communities will be asking "why can't we have it?"

The Tesla Energy system launched last week is comprehensive, with global ramifications. The Powerwall system offering 10 kWh is targeted at domestic users. It is complemented by a commercial system termed the Powerpack offering 100 kWh storage, and a stack of 100 such units to form a 10 megawatt hour storage unit that can be used at the scale of small electricity grids.

Whole communities could build micro-

grid power supply systems around such a 10 MWh energy storage system, fed by renewable energy generation (wind power or rooftop solar power), at costs that just became super-competitive. At his launch last week, Musk maintained that the entire electric power grid of the US could be replicated with just 160 million of these utility-scale energy storage units. And two billion of the utility-scale units could provide storage of 20 trillion kWh – electric power for the world.

## The revolution begins

It is instructive to put these numbers in context. There are already around 2 billion cars and commercial vehicles on the world's roads, and nearly 100 million new vehicles are being added every year.

If it's feasible to build these exhaust-pumping complex machines, it's certainly feasible to build the storage units that will help to make them unnecessary. What's more, Elon Musk has just announced that he intends to do so. Musk is a Henry Ford-style figure who takes others' innovations and scales them up, taking the breathtaking entrepreneurial leaps that others can only dream about. Suddenly the world of renewable energy just moved to become the new normal – because when combined with cost-effective storage it becomes unbeatable.... This is capitalist competition – and its propagation is what makes Tesla's announcement the start of the real renewables revolution.

Washington continues to drive Europe toward one or the other of the two most likely outcomes of the orchestrated conflict with Russia. Either Europe or some European Union member government will break from Washington over the issue of Russian sanctions, thereby forcing the EU off of the path of conflict with Russia, or Europe will be pushed into military conflict with Russia. In June the Russian sanctions expire unless each member government of the EU votes to continue the sanctions. Several governments have spoken against a continuation. For example, the governments of the Czech Republic and Greece have expressed dissatisfaction with the sanctions.

US Secretary of State John Kerry acknowledged growing opposition to the sanctions among some European governments. Employing the three tools of US foreign policy—threats, bribery, and coercion—he warned Europe to renew the sanctions or there would be retribution. We will see in June if Washington's threat has quelled the rebellion.

Europe has to consider the strength of Washington's threat of retribution against the cost of a continuing and worsening conflict with Russia. This conflict is not in Europe's economic or political interest, and the conflict has the risk of breaking out into war that would destroy Europe.

Only after a court order did Monsanto reveal that it had provided assistance towards Baxter's legal defense, refusing to disclose exactly how much the corporation contributed.
