UN MIGRANT PUSH By James Reed

Get ready for the next assault on the West as the UN plans a new global mass movement of migrants to the West, of course, through the UN global compact on migration. Here is the standard justification for this, which we have all heard before:

“This year, governments will negotiate a global compact on migration through the United Nations. This will be the first overarching international agreement of its kind. It will not be a formal treaty. Nor will it place any binding obligations on states. Instead, it is an unprecedented opportunity for leaders to counter the pernicious myths surrounding migrants, and lay out a common vision of how to make migration work for all our nations. This is an urgent task. We have seen what happens when large-scale migration takes place without effective mechanisms to manage it. The world was shocked by recent video of migrants being sold as slaves.

Grim as these images were, the real scandal is that thousands of migrants suffer the same fate each year, unrecorded. Many more are trapped in demeaning, precarious jobs that border on slavery anyway. There are nearly six million migrants trapped in forced labour today, often in developed economies.

How can we end these injustices and prevent them recurring in future? In setting a clear political direction about the future of migration, I believe that three fundamental considerations should guide discussions of the compact. The first is to recognise and reinforce the benefits of migration, so often lost in public debate. Migrants make huge contributions to both their host countries and countries of origin.

They take jobs that local workforces cannot fill, boosting economic activity. Many are innovators and entrepreneurs. Nearly half of all migrants are women, looking for better lives and work opportunities. Migrants also make a major contribution to international development by sending remittances to their home countries. Remittances added up to nearly \$600bn (\$445bn) last year, three times all development aid.

The fundamental challenge is to maximise the benefits of this orderly, productive form of migration while stamping out the abuses and prejudice that make life hell for a minority of migrants. *(continued on next page)*

Second, states need to strengthen the rule of law underpinning how they manage and protect migrants – for the benefit of their economies, their societies and the migrants themselves. Authorities that erect major obstacles to migration – or place severe restrictions on migrants’ work opportunities – inflict needless economic self-harm, as they impose barriers to having

their labour needs met in an orderly, legal fashion.”

THE DEATH OF BEES By Brian Simpson

the honey bee is facing extinction:

“For many years now, scientists have been warning us of the decreasing honey bee population. A new research reveals that honey bees could soon go extinct due to the increased uses of chemical pesticides and the severely low amount of food supplies for these poor creatures. A University of California, San Diego study shows that chemical pesticides, as well as a lack of food for honey bees, are threatening their already low population.

Clothianidin and thiamethoxam are two of the neonicotinoid pesticides that are killing off these vital insects. Researchers found that these chemicals, combined with low nutrition, highly impact the life span of honey bees, and severely increased the number of bee deaths by 50 percent.

The effect of both these lethal factors are the same as giving poison to a person suffering from malnutrition – both are lethal individually, but together accelerate mortality. The chemicals as mentioned above affect honey bees by decreasing their hemolymph (bee blood) sugar levels and cause the insect to lose energy.”

The situation is grim and getting grimmer, as the bee is very much the canary in the coal mine of the modern world. I do not know enough about bees to suggest what can be done, given that the little fellows seem highly sensitive to a wide range of agricultural chemicals. This is probably a good argument for organic farming and permaculture, but we still have the problem of modern farmers making the transition to this, without going bust in the process. It is not an easy one to solve. Yet, solve it we must because time is running out, and the horseman of famine can still come riding in. ***

In the West, professing Christ is set to become a hate crime:

"Most recently, the British government 'refused to say whether telling people about the Christian faith could be a hate crime'. Lord Pearson of Rannoch, a UKIP peer, asked the House of Lords if they would 'confirm unequivocally that a Christian who says that Jesus is the only son of the one true God cannot be arrested for hate crime or any other offence, however much it may offend a Muslim or anyone of any other religion?' Government spokesperson Baroness Vere of Norbiton responded equivocally, adding that the legal definition of 'hate crime' has been the same for the past 10 years. But as Pearson explained in a later interview, the current definition of 'hate crime' is subjective and revolves around whether the 'victim' feels offended—thus leaving the door wide open to charging those who proclaim Christ and the Trinity of committing a hate crime, especially vis-à-vis Muslims, who adamantly object to the claim, as Pearson himself acknowledged: "Certainly the stricter Muslims do feel offended by Christianity and our belief in Jesus being the only Son of the one true God."

Pearson also pointed to a double standard in how 'hate crimes' are applied: 'You can say what you like about

the Virgin Birth, the miracles and the Resurrection of Jesus Christ, but as soon as you say 'come on, Islam really the religion of peace that it claims to be,' all hell breaks loose'."

ALIENS AT THE AIRPORT? By Brian Simpson

"At approximately 16:15 CST on Tuesday, November 7, **2006**, federal authorities at Chicago O'Hare International Airport received a report that a group of twelve airport employees were witnessing a metallic, saucer-shaped craft hovering over Gate C-17.

The object was first spotted by a ramp employee who was pushing back United Airlines Flight 446, which was departing Chicago for Charlotte, North Carolina. The employee apprised Flight 446's crew of the object above their aircraft. It is believed that both the pilot and co-pilot also witnessed the object.

Several independent witnesses outside of the airport also saw the object. One described a 'blatant' disc-shaped craft hovering over the airport which was 'obviously not clouds'. According to this witness, nearby observers gasped as the object shot through the clouds at high velocity, leaving a clear blue hole in the cloud layer. The hole reportedly seemed to close itself shortly afterward.

According to the *Chicago Tribune's* Jon Hilkevitch,

"The disc was visible for approximately five minutes and was seen by close to a dozen United Airlines employees, ranging from pilots to supervisors, who heard chatter on the radio and raced out to view it'."

NARCAP has published a 155-page report, suggesting a presence of the object in account over O'Hare and has called for a government inquiry and improved energy-sensing technologies.
