SENATOR FRASER ANNING KICKS THE IMMIGRATION HORNETS' NEST By James Reed

“Senator Fraser Anning of the right-wing Katter's Australian Party (KAP) found himself in hot water over his inflammatory anti-Muslim maiden speech he delivered in the parliament. Claiming that Muslim Australians are unable to integrate, he said adherents of Islam “do not work and live on welfare,” and bring the threat of terrorism. Fanning fears of Muslim immigrants “stealing jobs” and “sympathizing with Islamic State [IS, formerly ISIS],” Anning offered: “The final solution to the immigration problem is, of course, a popular vote. We don't need a plebiscite to cut immigration numbers; we just need a government that is willing to institute a sustainable population policy.” The words used by Anning usually refer to the Nazi policy of genocide carried out against the Jews during the Holocaust. At that time, ensuring the “final solution” (Endlösung) of the so-called “Jewish question” was the backbone of the Third Reich's actions on occupied lands. Unsurprisingly, local politicians produced a range of angry statements lambasting Anning's language.

“Australia is the most successful multicultural society in the world built on a foundation of mutual respect. We reject and condemn racism in any form,” Australian Prime Minister Malcolm Turnbull said on Twitter. Minister for Multicultural Affairs, Alan Tudge, said Senator Anning's comments did not reflect the views of the Government or the views “of fair-minded Australians.” The country “will always maintain a non-discriminatory immigration program, he tweeted.”

“As governments raise taxes to cope with their unending spending habits, people are increasingly being forced to supplement their own income with loans. And according to most financial experts, this debt problem is so big that it will usher in a global economic collapse of epic proportions. According to the Institute of International Finance’s latest Global Debt Monitor, the amount of debt held in the world rose by the biggest amount in two years during the first quarter of 2018. It grew by \$8 trillion to hit a new all-time high of \$247 trillion, up from \$238 trillion as of December 31, 2017. And that’s up by \$30 trillion from the end of 2016. “The influx of refugees from the Middle East in 2015 has resulted in significant friction in many European countries, as citizens increasingly express their displeasure at the need to spend tax money on migrants, as well as concern over security issues. This has led to growing support for right-wing parties across Europe, including Austria. Aras Bacho, a Syrian refugee living in Austria, has suggested in an open letter published in the daily newspaper OE24 that ordinary Austrians and Germans should participate in the integration process of migrants. According to him, integration requires “both sides to work,” meaning that Germans and Austrians should take refugees into their homes, as well as to live and go out with them.

“Austrians have to take refugees into their own homes — this benefits both sides. [Integration] works when refugees live with Austrians. They can talk, or an Austrian can read an official letter to a refugee and then explain it in simpler language. [...] They can go outdoors or to a swimming pool together,” Bacho wrote, adding that the same goes for Germans.

The man added that communication like that helps refugees to “get smarter” and learn the language. However, in his opinion, communication is not the only thing that Germans and Austrians can help migrants with. He notes that taxes paid by citizens to support refugees are not donations, as they are mandatory. Bacho believes that Germans and Austrians should pay voluntary donations to be truly humane.

“To state the obvious, Jeong is hardly alone in colorfully expressing anti-white sentiment, and it is this broader phenomenon I find most interesting. The people I’ve heard archly denounce whites have for the most part been upwardly-mobile people who’ve proven pretty adept at navigating elite, predominantly white spaces. A lot of them have been whites who pride themselves on their diverse social circles and their enlightened views, and who indulge in their own half-ironic white-bashing to underscore that it is their achieved identity as intelligent, worldly people that counts most, not their ascribed identity as being of recognizably European descent. One reason I’ve been disinclined to take this sort of talk seriously in the past is that it has so often smacked of intra-white status jockeying. It is almost as though we’re living through a strange sort of ethnogenesis, in which those who see themselves as (for lack of a better term) upper-whites are doing everything they can to disaffiliate themselves from those they’ve deemed lower-whites. Note that to be “upper” or “lower” isn’t just about class status, though of course that’s always hovering in the background.

“Facebook has been asking banks in the United States for their customers’ financial data, including account balances and transactions, according to a report. *The Wall Street Journal* revealed that the social network has been asking major banks to “share detailed financial information about their customers, including card transactions and checking account balances, as part of an effort to offer new services to users.” The banks asked by Facebook included JPMorgan Chase, Wells Fargo, Citigroup, and U.S. Bancorp, while one “large U.S. bank pulled away from talks due to privacy concerns.”

Rather, it is about the supposed nobility that flows from racial self-flagellation. And, simultaneously, it allows Asian Americans who use the discourse to position themselves as ethnic outsiders, including those who are comfortably enmeshed in elite circles.”

Here we need to remember a wise Asian, Lee Kuan Yew, former Prime Minister of Singapore, who saw America’s embrace (and by implication, the rest of the West), of multiculturalism and multiracialism, as leading to its ultimate destruction. MORE ON CURCUMIN AND CANCER By Mrs Vera West

Today's writing has been devoted to aspects of cancer. First up is more good news about the wonders of a good curry, for curcumin, the active ingredient in curry, has been found to suppress head and neck cancers:

“Peer-reviewed studies have found that there are natural ways to fight cancer – including cancers of the head and neck. One such study, conducted by researchers from the UCLA Jonsson Comprehensive Cancer Center, and published in *Clinical Cancer Research*, the peer-reviewed journal of the American Association of Cancer Research back in 2011, found that curcumin – the main component of the spice turmeric – can suppress a cell signaling pathway implicated in the growth of head and neck cancers. The researchers obtained saliva samples from 21 patients both before and after chewing two tablets containing a total of 1,000 milligrams of curcumin. An hour later, an additional saliva sample was taken, and other tests were conducted. UCLA's newsroom explained: Eating the curcumin ... puts the chemical in contact not only with the cancer but also with the saliva, and the study found that the curcumin reduced the level of cancer-enhancing cytokines. An independent lab in Maryland was sent blind samples and confirmed the results: The pro-inflammatory cytokines in the saliva that help feed the cancer were reduced in patients who had chewed the curcumin, and the cell signaling pathway driving cancer growth was inhibited. “This study shows that curcumin can work in the mouths of patients with head and neck malignancies and reduce activities that promote cancer growth,” said Dr. Marilene Wang, the study's senior author. “And it not only affected the cancer by inhibiting a critical cell signaling pathway, it also affected the saliva itself by reducing pro-inflammatory cytokines within the saliva.”

I use curry whenever I can in meals, adding black pepper which is needed to increase absorption, for there is an absorption problem with curcumin. One can get supplements at the health food shop where bioactive forms of curcumin, but in the case of this study contact with the cancer, say in the mouth or throat was needed. Still, the tablet can be crushed up. I swear that my arthritis is not so bad since taking it. ***

“The federal Food and Drug Administration (FDA) has contracted with Advanced Bioscience Resource (ABR) – a biomedical company referred for federal criminal investigation – to provide “fresh” aborted baby tissue to engineer humanized mice for drug experimentation. A new report from CNSNews.com quotes an FDA notice dated June 13 to the U.S. Department of Health and Human Services (HHS), which oversees the FDA: The Government intends to solicit and negotiate directly with Advanced Bioscience Resources (ABR) Inc. and no solicitation will be issued. The objective is to acquire Tissue for Humanized Mice. ABR is the only company that can provide the human fetal tissue needed to continue the ongoing research being led by the FDA. Fresh human tissues are required for implantation into severely immune-compromised mice to create chimeric animals that have a human immune system. This human immune system allows us to test biological drug products for safety and efficacy. According to the Congressional Research Service, “Fetal tissue used in research is obtained from elective abortions.”

The US abortion industry is a big business, and it is no wonder that it fears a challenge to Roe v Wade. Even “our” ABC is interested in this question. It is going to be interesting to see how the abortion issue plays out in the US. Whatever happens, we can be sure that there will be kick on effects here. ***
