SOCIALISM AND THE INTELLECTUALS By James Reed

Over a glass of "turps" I was contemplating why intellectuals are socialists. The wisdom of the drink aided me to conclude that there is probably no singular reason, but rather a multitude of reasons ranging from being uniformed/ignorant useful idiots, to being at the low level of the global conspiracy. Those at these upper levels usually work for various think tanks, doing things like getting immigration information and producing propaganda to be used by the globalists in the media. They write the books and textbooks that educate the next generation; we don't.

Common though to all of these critters, is a sense of hatred and resentment, a rejection of the society and its traditions that gave them everything. Their education is used to destroy the society that produced them, and perverse as it is, they are not put on trial for treason, but given the highest rewards, while those foolish enough to oppose them, are rendered unemployed. THE CHRISTIAN FOUNDATIONS OF THE COMMON LAW: PASSING OF A GREAT TRADITION By Ian Wilson LL. B

Augusto Zimmerman has just published a very solid piece of jurisprudence, *Christian Foundations of the Common Law, Volume 2, The United States*, (Connor Court Publishing, 2018). It is excellent that in these dark and degenerate times, there are still scholars, and publishers investigating the Christian traditions that gave us the modern world, and the liberties that unfortunately are disappearing by the day. But, unless we have some idea of what the truth is, we will live forever in a world of unending error.

The book covers a vast array of American historical material, which may not be necessary to summarise for our readership, since the fundamental argument would be accepted by most of us. The textual evidence from the writings of the American founding Fathers, such as Benjamin Franklin, George Washington, Thomas Jefferson, Alexander Hamilton, James Madison and John Adams, indicates that Christian faith motivated these men to do what they did and write what they wrote.

A good example to take here is Thomas Jefferson, whom the atheists claim as one of their own. But, Jefferson was not opposed to the belief in God, but only to the establishment of a national church, being committed to individual liberty. It is shown that Jefferson was in fact a Christian, and not an atheist.

The American constitution is also shown to be founded upon Christian moral principles, which refutes the idea that this document is a secular document because, unlike other nation's constitutions, it does not explicitly mention God. But, Christian principles are woven into the basic philosophical foundations of the document, in expounding the moral values of freedom, justice and the common good.

All of this is excellent, but, if this was the examination of a student thesis one would ask: where is the detailed examination of the common law, the way law is regarded by courts, that part of law derived from custom and judicial precedence rather than statute? There is some mention in the text, but the book only gets its teeth into this question in the last chapter, “The Threat of Judicial Activism,” a brief chapter, pp. 206-216. It is clear from *Roe v Wade*, which justified abortion on demand via the constitution, to the same sex marriage decision in *Obergefell v Hodges* (2015), the US Supreme Court is making up the law as it goes, according to politically correct ideology. Simply reject the constitutional principle of originalism, finding meaning according to the original intention of the Founding Fathers, and substitute a living interpretation, that the values of today rule, and the elites get what they want. Ultimately, anything goes. The bitter battle in America at the moment over the appointment of Brett Kavanaugh, an originalist, reflects this battle, perhaps America's final one before an inevitable Civil War 2.0.

The problem only touched on in this otherwise fine book, is that the takeover of the courts, like the universities and other institutions of society by the cultural Marxist elites, has led to the virtual abandonment of the Christian common law tradition. This is seen most evidently in the astonishing cases coming from Europe, where not only has the rule of law seemingly broken down, but what remains of the system is used against critics, usually white, who are imprisoned for speaking out. No good will come from this. ***

cells, and the human beings whose lives were taken to provide those cells become irrelevant and with time forgotten. In other words, we should not get on the utilitarian train in the first place. Doing so, and accepting these alleged benefits begins the desensitising process to how the original tissue arose, and that is the real moral point, which is, opposing abortion. ***

"Analyzing medical death rate data over an eight-year period, Johns Hopkins patient safety experts have calculated that more than 250,000 deaths per year are due to medical error in the U.S. Their figure, published May 3 in *The BMJ*, surpasses the U.S. Centers for Disease Control and Prevention's (CDC's) third leading cause of death — respiratory disease, which kills close to 150,000 people per year. The Johns Hopkins team says the CDC's way of collecting

national health statistics fails to classify medical errors separately on the death certificate. The researchers are advocating for updated criteria for classifying deaths on death certificates.

"Incidence rates for deaths directly attributable to medical care gone awry haven't been recognized in any standardized method for collecting national statistics," says Martin Makary, M.D., M.P.H., professor of surgery at the Johns Hopkins University School of Medicine and an authority on health reform. "The medical coding system was designed to maximize billing for physician services, not to collect national health statistics, as it is currently being used."

Then it is settled; the Left must drop their concerns with gun banning and embrace alternative natural health, and go after allopathic medicine. We dream on. ***

Or is it a sexist insult to her strength and competence? Social psychologists who describe this behavior as “benevolent sexism” firmly favor the latter view. But researchers have also revealed a paradox: Women prefer men who behave in ways that could be described as benevolently sexist over those who don't. How could this be? Some say that women simply fail to see the ways benevolent sexism undermines them

because they're misled by the flattering tone of this brand of kindness. Psychologists have even suggested that benevolent sexism is more harmful than overtly hostile sexism because it is insidious, acting like “a wolf in sheep's clothing.”

As social psychologists, we had reservations about these conclusions. Aren't women sophisticated enough to be able to tell when a man is being patronizing?”

Mortality rates have skyrocketed for groups such as infants, pregnant mothers, and the elderly as clinics have shut down and medicine grown scarce.
