## THE TRIUMPH OF THE NOMADS? By Brian Simpson

Americans have more freedom of speech than we do in Australia, at least for a few more moments. Hence, if you are interested in reading a critique and deconstruction of "our greatest historian' Geoffrey Blainey's Triumph of the Nomads by Spencer Quinn look no further than: https://www.counter-currents.com/2018/10/triumph-of-the-nomads/

Our side of politics tends to look up to Blainey for stating that Asianisation was proceeding faster than public opinion. My apologies if my memory is letting me down, but I do not recall Blainey actually saying that Australia should not be Asianised at all, that the country as is, had a right to autonomous existence. His 1984 statement was about the pace. Of course, it was his right to advance and defend what position he did, but he is no racial realist. His comments back in 1984, were meek and mild, but still quite reasonable, compared to what is said today. All for Australia, is not a book like the fantastic book by Alan James, New Britannia: The Rise and Decline of Anglo-Australia, (Renewal Publications, 2013), which explicitly defends Anglo-Australia, as an ethnic group with rights. That said, Blainey is to be commended for pointing out the civilisational destroying aspects of multiculturalism, and for taking a stand against the fanatical "intellectuals" who immediately worked to destroy his reputation, for saying things which are now common place. Here is a sample of wisdom from All for Australia (1984):

- Every nation has the right to control its own immigration. To shape sensibly an immigration policy is to influence nearly every facet of life, now and for generations to come.
- Democracy is not like a long-term loan of property to be entrusted by the people to the government and its small group of advisors. And yet in recent years a small group of people has successfully snatched immigration policy from the public arena, and has even placed a taboo on the discussion of vital aspects of immigration.
- Our immigration policy is increasingly based on an appeal to international precepts that our neighbours sensibly refuse to practise. We are surrendering much of our own independence to a phantom opinion that floats vaguely in the air and rarely exists on this earth. We should think very carefully about the perils of converting Australia into a giant multicultural laboratory for the assumed benefit of the peoples of the world.
- An immigration policy in any country is based more or less on discrimination. A minister of immigration is a minister of discrimination. If he isn't, he is not carrying out his responsibilities.
- On the immigration issue the suspicions towards democracy and the distrust towards free speech have come largely from the Left. The distrust of free speech has been especially noticeable amongst a small scatter of academics, members of a profession that by its very nature depends on freedom of inquiry and speech.
- Whereas the old White Australia Policy, in its extreme form, kept out all Asians, the new policy could be moving towards the opposite extreme. In calling for a strong, long-term flow of Third World migrants, it foreshadows the sacrificing of vital Australian interests on behalf of vague international creeds. It is also forsaking our historical experience for the sake of a nimble dream. (continued next page)

- Again and again Australia is depicted as a bonanza ready made that was snatched from the Aboriginals. But the Australia of the Aboriginals, distinctive as were its achievements, was not a bonanza. Generations of Australians since 1788 have developed this land and its resources, applying sweat and grit and ingenuity. Asian immigrants had the opportunity to come, several hundred years ago, but they had no incentive to come. Australia then was not worth colonizing.
- Immigration is everyone's business: it is one of the most important national issues. The idea that it is too dangerous to be debated is a mockery of democracy. It is too important not to debate.
- The ethnic composition of the population and the particular mixture of nationalities, languages and cultures is a matter of importance to all nations. The selection of immigrants should not be seen primarily as a test of which nationalities are best. It is more important to select immigrants with an eye to the collective effect on the nation. An immigration policy is not a symbol, a banner, of a nation's attitude to other peoples or races; and to reject potential immigrants is in no way to doubt the worthiness of their nationality or culture.
- The multicultural policy has, at times, tended to emphasize the rights of ethnic minorities at the expense of the majority of Australians, thus

- unnecessarily encouraging divisions and weakening social cohesion. It has tended to be anti-British, and yet the people from the United Kingdom and Ireland form the dominant class of pre-war immigrants and the largest single group of post-war immigrants.
- Recent governments emphasize the merits of a multicultural society and ignore the dangers. And yet the evidence is clear that many multicultural societies have failed and that the human cost of the failure has been high.
- There are dangers in the increasing belief that toleration can simply be imposed on people by a variety of new laws and by a bureaucracy specializing in ethnic affairs, cultural relations and human rights. Unfortunately, the laws and regulatory bodies, introduced in the hope of promoting toleration, can be invoked to attack freedom of speech, freedom of assembly, and those principles on which minority rights must, in the last resort, depend. A sensible humane immigration policy is more likely than most of these new agencies and laws present or proposed to maintain and foster racial toleration.

### JUST IMAGINE ... THE COLLAPSE OF CHINA By James Reed

Won't the money class, and the parasitic university class get a shock, when, not if, China collapses, because what goes up, according to economic gravity, must come down:

- 'Analysts have begun to look more deeply into the Chinese stock market, and what they have found is "a ticking five trillion share ticking time bomb," Zero Hedge reports. One analyst, Kinger Lau, a China strategist for Goldman Sachs, has done a comparison of China's markets today and the "bubble and bust" cycle of 2015. What he found is some good news, particularly because what is currently happening in Chinese markets is "less systemic" than what occurred three years ago:
- Margin financing by brokers is down significantly;
- Hidden leverage (not seen on balance sheets) is less prevalent;
- In sum, the exposure of retail investors to equities is still low.

For one, if the Chinese markets fall by an additional 10-30 percent, which could happen, there will be 1.2 trillion and 1.7 trillion yuan facing margin calls or risks of liquidation. Lau believes that most borrowers

facing these kinds of margin call pressures would be able to meet them by offering up cash, equity, or even properties as collateral. The news site noted further: Even for those who couldn't secure additional collateral and stock prices fell below liquidation levels, forced selling by brokers has seldom happened, because:

- there are many restrictions on major shareholders disposing shares in China A;
- brokers tended not to liquidate the positions as doing so would trigger more selling pressure and deplete the value of other collateralized shares,
- brokers don't want to damage the relationship with their corporate clients; and
- in some cases, regulators gave window guidance to brokers to avoid forced selling.

Fair enough, but the very same kind of margin call Lau and Goldman said isn't likely happened last week though it was not supposed to.

"Would it, perhaps, indicate that borrowers have run out of more collateral to pledged [sic]?" Zero Hedge reported. "And if so, just how long until the next major market selloff triggers the remainder of China's ticking 5 trillion yuan pledged stock time bomb?" \*\*\*

### THE POVERTY OF AUSTRALIA By James Reed

To appreciate what poverty can do to your spirit, it helps to be poor, not being able to pay bills, and not even getting decent food. Today the poverty line is set at \$ 433 per week for a single adult, but for the same single adult, New Start only pays \$ 275.10 per week. How then does one survive? As I see it, one does not, and is expected to go away and quietly rot, for they will replace you.

"MORE than three million Australians are living in poverty, including 739,000 children, according to a new report. That means about one in eight adults and one in six children are living below the poverty line. About half (53 per cent) of households living in poverty are relying on social security as their main source of income, the research by the Australian Council of Social Service and UNSW Sydney also shows. The report sets the poverty line as living on less than \$433 a week for a single adult, or \$909 for a couple with two children. On average, those living in poverty in Australia are missing that mark by \$135 a

week. While the majority are relying on social security, more than a third of households in poverty (38 per cent) are relying on wages. ACOSS chief executive Dr Cassandra Goldie says the findings should sway Prime Minister Scott Morrison to make ending poverty in all its forms his top priority. "The government argues that poverty in Australia is not the problem. They are wrong," she said.

The solutions offered rely on ever increasing taxation. In this age of industrialisation and automation, we social credit offers a much better alternative, in particular the National Dividend and Consumer Price Subsidy. This would balance the financial system and avoid debt as a political weapon that causes poverty. When enough individuals are ready to listen and social creditors act upon that ready-ness, freedom from poverty will return to our land. See M. #### **EUROPE'S CRISIS OF SURVIVAL By Richard Miller**

'GENERAL GOMART, HEAD OF MILITARY INTELLIGENCE, WHO LEFT THE ARMY IN MAY 2017, EXPLAINS: "THIS INVASION OF EUROPE BY MIGRANTS IS PLANNED, CONTROLLED AND ACCEPTED."

And "nothing of the migratory traffic in the Mediterranean is ignored by the French authorities, military and civil". Lieutenant General Christophe Gomart, head of the DRM (Directorate of Military Intelligence), was responsible for gathering all the information likely to help France to make its military decisions. At the opening of the symposium GEOINT (Geospatial Intelligence), held at the Geographical Society of Paris, on September 11 and 12, 2018, he explained how migratory traffic in the Middle East and the Mediterranean escaped intelligence.

The Military Intelligence Directorate, leader in France on satellite imagery intelligence (ROIM) provided by military spy satellites, inaugurated on January 19 a very discreet center of expertise, the Joint CRGI (Intelligence Center) geospatial. Multidisciplinary, it integrates about thirty civil, military and high-level reserve specialists whose main function is to merge the information collected by DRM from a multitude of sensors (interceptions, satellites, open sources, cybersurveillance, etc.). . .

Thus, the DRM can present to the French government a precise situation concerning the presence of sub-Saharan migrants in Libya, as well as the exact identities, the operating methods and the strategies

of the "smugglers" of migrants. This information is transmitted by France to the headquarters of the European mission in the Mediterranean (Eunavfor Med) launched last May. At the symposium, General Gomart said that the French army had identified the main entry points for human trafficking routes into Libya, including from the three-border zone (Libya, Sudan, Egypt). The French intelligence services know where the smugglers exchange their human cargoes, where they host them. He sees them preparing departures in Europe from the beaches of Tripolitania and Cyrenaica, imposing on migrants an immutable process. Before any departure at sea, smugglers call the Italian Maritime Rescue Coordination Center. This is how European boats collect the migratory masses directly at sea and transport them to the port for fear of not doing so on the African coast. . . GEOINT has become "the ideal tool for exploiting geolocalised massive data, and it plays a decision accelerating role by giving a clear and complete vision to the military leaders and the political decisionmakers". The invasion does not advance at random So, there is no mystery, everything is known. We know where the "smugglers" will stock up on boats. Turkey is deemed to have issued false passports and the recipient authorities are turning a blind eye. The French intelligence services are able to see the migratory traffic in Africa in every detail, and he could see it also in Europe."

This, in turn is producing Europe's 'crisis of survival," as Giulio Meotti of the Gatestone Institute solemnly reflects. (continued next page)

(continued from previous page) "In facing this existential challenge — a downward spiral in which Europeans seem to be slowly dying out by failing to reproduce — it seems that Europe has also lost all confidence in its hard-won Enlightenment values, such as personal freedoms, reason and science replacing superstition, and the separation of church and state. These are critical if Europe truly wishes to survive. The first to understand that the current deadlock in which the continent finds itself goes far beyond economics. The point is that the days of European strength are over. Because of low birth rates, Europe is dramatically

shrinking. If current trends continue, Laqueur said, a hundred years from now Europe's population "will be only a fraction of what it is today, and in two hundred years, some countries may have disappeared."

This suicide of the West has been manipulated by the elites, who have, presumably some demonic plan. Yet, one wonders if, whatever plan it is, cannot but result in their own destruction too? # **HUMAN GENES IN RICE: SCIENCE OUT OF CONTROL By Brian Simpson**

Science and technology constitutes the magic of our age, and given that it produces effects, it is funded by the ruling class who use it to consolidate their power and control the plebs. A few crumbs fall from the festive table that the masses can eat, to keep them extra docile. Consider human genes now in rice; look mum, I am soooooo clever:

'Rice that has been engineered with actual human genes is on its way to a supermarket near you. In Junction City, Kansas, this human gene-tainted rice is being grown on 3,200 acres by the biotechnology company Ventria Bioscience. Ventria began cultivating this rather horrifying product in 2006 with human liver genes. What exactly was the purpose of this, you ask? Their intention was to harvest the artificial enzymes produced by the rice and use them in pharmaceuticals. Ventria has taken one of the most widely grown and consumed crops and turned it into the base for new prescription drugs — all with USDA approval, of course. Their decision to allow plants intended for pharmaceuticals to be grown outdoors has not gone without protest. Ventria initially wanted to plant their "crops" — if you can call them that anymore — in Missouri. However, they were met with staunch opposition from Anheuser-Busch and others, who promptly threatened to boycott all rice from the state if the biotechnology planted their GMO rice within the state's borders. Eventually though, Ventria found a place to settle in Kansas. In 2007, Jane Rissler from the Union of Concerned Scientists (UCS) told the Washington Post, "It is unwise to produce drugs in plants outdoors."

The threat of contamination and cross-pollination between this genetically-modified rice species and natural rice is of utmost concern. While it may seem rather basic, widespread contamination of unmodified rice could lead to chronic disease. Bill Freese, Science Policy Analyst at the Center for Food Safety (CFS), who published a report back in 2007 about the dangers of Ventria's GM rice, states, "These genetically engineered drugs could exacerbate certain infections, or cause dangerous allergic or immune system reactions"."

It would be just too bad if this is the way the long-awaited zombie apocalypse starts. It is exactly the sort of thing that we would expect in a world where science is out of control, or at least, out of the control of people, and in the hands of the money elites, where healing or harming is one and the same as long as the business model is based on future profits.
