**THOUGHTS OF THE WEEK:** “The Shape of Things to Come - *The Australian* of Feb 12, 1982, carried a headline: “Free-hold Land Rights at Last”. The story by Mr. Peter Ward is highlighted with a photograph of an Aborigine holding aloft a leftist invention, claimed to be the Aboriginal flag of red, black and gold. The Australian flag is no longer to be flown over one tenth of the State of South Australia — or so the leftist movement hopes. Mr. Ward writes:

“... the Pitjanjatjara . . . own one tenth of the State's territory, equivalent to the combined area of Austria and Hungary . . . The Act puts South Australia in the vanguard of a movement which is profoundly affecting the issue of who owns Australia . . .

“According to Federal Government figures, Aboriginal land in some form now extends over 738,032 sq.km. of the 7,686,584 sq.km. total land area of Australia. “This vests 9.6 per cent of land in 1.2 per cent of the population, and the national total could rise even further . . .

“Fines for illegal entry on the land range from \$200 for people entering unintentionally to \$10,000 and \$1,000 a day for illegal mining operations.

“Following the passage of the legislation in March, 1981, the Federal Minister for Aboriginal Affairs, Senator Baume, hailed it as 'a milestone in the history of Aboriginal affairs'. “He said he hoped the initiatives could be used as a model for other States’. “The Premier has said his Government intends to hand over lands in the Maralinga area to people now living at Yalata, west of Ceduna . . .”

Here is the shape of revolutionary things to come. As the leftist flag indicates — it will be Red OVER Black.”

## ON EXTERMINATING THE HUMAN RACE: DARPA By Brian Simpson

DARPA, Defense Advanced Research Projects, is now gloating that it has the capacity to engage in genetic warfare, and you know that is not going to be good:

‘One of the most dangerous experiments that mankind has ever embarked upon is DARPA’s desire for gene-drive technology. Scientists now have the knowledge and the tools they need to create and deliver “Doomsday genes” which can selectively target and exterminate an entire species. According to *Sputnik News*, and as previously reported by *SHTFPlan*, the United States highly-secretive and advanced military research body DARPA (Defense Advanced Research Projects Agency) announced that it will invest tens of millions of dollars into genetic extinction research. While the official aim of this research is said to be fighting harmful insects, like mosquitos which carry Malaria, there are significantly darker implications and speculations surrounding the possible use of such a tool. Joe Joseph of *The Daily Sheeple* said a quick Google search would give you enough information to let you know how horrific this kind of technology can be. “...and you’ll find it fascinating just at how unbelievable a weapon this could be, how unintentionally mistakes can be made that can cause irreversible damage...irreparable damage...to the human race. And I mean, FAST!” Joseph said. “A gene drive...if let’s just say there’s a mistake, you could feasibly wipe out the human race in a very

very short period of time. It’s an unbelievable tool at the disposal of madmen.” Emails released under the Freedom of Information Act (FOIA), suggest that the U.S.’s uber-secretive military body, DARPA, has become the world’s largest funder of this “gene drive” research. Silvia Ribeiro, Latin America director of the ETC Group, an international organization dedicated to the conservation and sustainable advancement of cultural and ecological diversity and human rights, said: “When it is developed under an umbrella of military research, you get a clear notion that there can be a dual purpose of this research.”

Jim Thomas, a co-director of the ETC group which obtained the emails, said the US military’s influence in furthering this technology would strengthen the case for a moratorium. “The dual-use nature of altering and eradicating entire populations is as much a threat to peace and food security as it is a threat to ecosystems,” he said. “Militarization of gene drive funding may even contravene the Enmod convention against hostile uses of environmental modification technologies.” But while we are on the subject of UN bans, the sanctions they placed on North Korea are being willfully ignored by the rogue regime. It stands to reason that should a military seek the use of this technology, they will also defy the UN’s “authority.” Humanity is known for making mistakes, but we can’t come back from an extinction of our own making. “You can call it a ‘tool’ all day, [but] it’s a weapon,” says Joseph.’ \*\*\*

‘Populist leader Marine Le Pen and her Rassemblement National (National Rally, or RN) have triumphed over sitting French president Emmanuel Macron in the European Parliament elections, according to exit polls. Ms Le Pen declared victory following exit polls showing the RN winning around 24 per cent of the vote, compared to Macron’s La République En Marche! (LREM) who, according to projections, has come in second with 22.5 percent of the vote, French newspaper *Le Figaro* reports.

Declaring victory, the RN leader said, “The trust we have been given by the French in designating us as the first party in France but especially as that of the future alternation is an immense honour.”

She went on to call for Macron to dissolve the French parliament, saying “it is up to the President of the Republic to draw the consequences” and calling for fresh elections, stating that Macron put his own presidency on the line in the vote.”

Of course, this slick trickster former banker will not resign, but will have to be kicked out of office. More good news from Europe is that the Brexit party took the lead in the EU elections

“Nigel Farage has led the Brexit Party to victory while the establishment parties are left assessing the damage after their historic losses, with the Brexiteer declaring: “This is just the beginning.” With almost all regions counted, the Brexit Party is in the clear lead after

winning around one-third of the vote and projected to have gained 29 seats. In a distant second, the pro-Remain Liberal Democrats won 15 seats, while the new Change UK (CUK), established solely to stop Brexit, failed to gain a single seat.

“Never before in British politics has a party just 6 weeks old won a national election,” Mr Farage posted to Twitter Monday morning. “If Britain does not leave the EU on October 31st, these results will be repeated at a general election.

“History has been made. This is just the beginning.”

Media reports that the Tories suffered their worst election result in two centuries, dropping to just nine per cent of the vote and winning only four seats — losing 15 — while the Labour Party is said to have had its worst election result in 100 years, halving its presence in the European Parliament from 20 to just ten seats. Speaking to *Good Morning Britain* on Monday morning, Mr Farage warned that the establishment political parties will suffer in the next General Election, scheduled for 2021, if they fail to take the UK out of the EU by October 31st, saying: “That date will become a bigger factor in peoples’ minds as these five months go by. If we don’t leave on the 31st of October, then the Brexit Party will go on to a General Election and stun everybody there, too.’

Naturally the globalists snapped back, with the Pope rattling on about racism, racism, racism and even more racism. ‘I can’t tell Jews to wear the kippah everywhere all the time in Germany,” announced that country’s commissioner for anti-Semitism, Felix Klein, on Saturday. Depressing advice, but honest: Wearing a yarmulke makes you a target for violent haters, and the country has seen a rise in out-of-nowhere assaults on Jews. Interior Ministry stats show anti-Semitic offenses up by nearly 20%. Klein’s superiors, including Chancellor Angela Merkel, spent days walking back the statement, but they had to admit that Germany has a growing problem — a wrenching development for a nation that has spent decades dealing with its guilt in the Holocaust.

Awkwardly for Merkel, the source of the rise in attacks on Jews looks to be the huge wave of Muslim migrants that she allowed in starting in 2015, who carried hate with them from their homelands. # WHO? TRANSGENDER NO DISORDER

Many will be pleased about the news that the World Health Organization no longer classifies transgenderism as a mental or behavioural disorder, clearly showing that everything is a social construction, including medicine, the biggest social construction of them all:

‘Transgender health issues will no longer be classified as mental and behavioural disorders under big changes to the World Health Organization's global manual of diagnoses. The newly-approved version instead places issues of gender incongruence under a chapter on sexual health. A World Health Organization expert said it now understands transgender is “not actually a mental health condition”. Human Rights Watch says the change will have a “liberating effect worldwide”.

### 'Outdated diagnosis'

In the latest manual, called the ICD-11, gender incongruence is defined as a marked and persistent incongruence between a person's experienced gender and assigned sex. In the previous version - ICD-10 - this was considered a gender identity disorder, in the chapter entitled mental and behavioural disorders.

Dr Lale Say, a reproductive health expert at the World Health Organization, said: “It was taken out from mental health disorders because we had a better understanding that this was not actually a mental health condition, and leaving it there was causing stigma.

“So in order to reduce the stigma, while also ensuring access to necessary health interventions, this was placed in a different chapter.”

Commenting on the revisions, Graeme Reid, lesbian, gay, bisexual, and transgender rights director at campaign group Human Rights Watch, said the changes would have a “liberating effect on transgender people worldwide”. He added: “Governments should swiftly reform national medical systems and laws that require this now officially outdated diagnosis.”

Meanwhile, nine organisations working on gender identity said in a joint statement: “It has taken us a long time to get here. Until a few years ago, removing pathologising categories affecting trans and gender diverse people from the ICD-10 list of mental disorders seemed impossible.

“Today, we know that full depathologisation can be achieved and will be achieved in our lifetime.”

The statement added: “Although placement in this chapter is an improvement, it is by no means perfect. For example, it is somewhat reductive to define trans health as related only to sexual health.” \*\*\*

## TARGET FOR THE WEEK

Readers who have not yet offered congratulations to Coalition MP's on being re-elected are reminded to do so. An item on page 4 of last week's OT raises an important matter which can be included in your message of congratulation. Of course readers who have already sent a message should take this matter up as well. The Morrison Government has commissioned the Australian Law Reform Commission (ALRC) to undertake a comprehensive review of the framework of religious exemptions in anti-discrimination legislation across Australia. It is reported that, “It is essential that Australia's laws are nationally consistent and effectively protect the rights and freedoms recognised in international agreements, to which Australia is a party. This particularly applies to the right to freedom of religion and the rights of equality and non-discrimination.”

The ALRC review will consider what changes should be made in order to:

**limit or remove altogether** (if practicable) **religious exemptions to prohibitions on discrimination**, while also guaranteeing the right of religious institutions to conduct their affairs in a way consistent with their religious ethos.....

**Comment:** Reference to any changes needing to be consistent with international agreements will probably expose the stupidity of committing to rules which ultimately prevent Australia legislating for matters we desire. Make the point to your MP that, for example, Christian schools should be guaranteed of the right to employ teachers of their choice, even if that means discriminating in favour of a Christian teacher. These fundamental issues must be supported by Government, especially one with considerable community support. -ND
