GOVERNMENTS CREATED THIS MURRAY-DARLING CRISIS By Alan Moran

The Murray-Darling is the only major region where irrigation plays a prominent role. Water availability there has the urgent attention of politicians because locals, unhappy at measures that have deprived farmers of water, have helped displace Nationals representatives in favour of those from the Shooters, Fishers and Farmers Party. Drought Minister David Littleproud is to meet farming representatives on (8th October) to discuss a fivefold increase in prices of Murray-Darling water. The minister attributes this to speculator hoarding together with another villain, climate change, which he says "is leading to hotter days, meaning droughts". Neither of these factors are the cause of the farmers' discontent. Although the Murray-Darling, like much of Australia, is in serious drought, this is not unusual. Other areas are seeing record rainfall; for Australia as a whole, rainfall has increased during the past century.

As for the minister's attack on speculators, he targets an ever-convenient and populist scapegoat. Independent ownership of water was facilitated when the rivers' water was formally made tradeable in 2014 (before which trades were informal and ostensibly water could be owned only by the landowner). Unless they are monopolists — and the sheer number of water owners makes this impossible — speculators simply respond to market opportunities. In this way, speculators perform a useful function in ironing out supply and demand imbalances and selling scarce supplies to those whose willingness to pay shows they need them most. The real reasons behind the distress of irrigated agriculture are government policies that have reduced water availability. Across the course of the 20th century, irrigation had transformed the Murray-Darling Basin from an arid region to one that produced more than 40 per cent of the nation's agricultural output. The basin's irrigators have long seen rival claims to the water from those at the Murray mouth, where allocated flows have created artificial permanent freshwater lakes.

But, alternative uses were claimed in the 1990s by activists, calling themselves the Wentworth Group, whose members included Tim Flannery, David Karoly and Mike Young, the author of a column (Oct 4, 2019) in *The Australian* ("Drought of good ideas has drained water policy"). In addition to claims that irrigation was depriving natural vegetation of water, the Wentworth Group sought to wind back irrigation use on the basis of salinity with bloodcurdling claims such as "Salt destroying our rivers and land like a cancer". The fact is the Murray-Darling has become a working river. It experiences highly irregular annual flows of between 7000 and 118,000 gigalitres within an average 34,000GL. *(continued next page)*

(continued from previous page) By 1997, dams along the system had allowed about 12,000GL a year to be granted to irrigators under levels of accessibility that vary with each year's water availability. This not only brought the region's agricultural bounty but converted a highly irregular river into placid waterway for tourists.

Wentworth Group activists recruited the ABC and other media as supporters in its agenda to reallocate the water flows from agriculture. In response, the Howard government bought up water from farmers for environmental purposes and, in doing so, set in place bureaucratic machinery that could readily expand the reallocation. This was tailor-made for the election of the Rudd government when climate change psychosis became the catalyst for further reducing irrigation water. The 2008 Garnaut report, which was written by Steven Kennedy, who recently was appointed Treasury secretary, claimed that climate change meant the Murray-Darling area would be faced with permanent drought.

The report argued that we should start now to reduce water use generally in preparation for the period under which no irrigation would be possible.

Under Rudd's radical environmentalist water minister, Tony Burke, the stakes were raised and 2750GL were to be bought from irrigators or created (by water-saving expenditures). At a cost of \$13bn, this meant taking 20 per cent of a vital input into farming. Inevitably, reduced output as well as higher prices, have been caused by this government-induced scarcity. Ironically, the reduction in farmers' water availability took place when the government was proclaiming a new dawn in demand for farm produce from the burgeoning Asian economies. While making minor revisions, today's federal government has accepted the thrust of the policy set up by its predecessor.

Blaming twin bogeymen of speculators and climate change is no solution to the problems governments have created. The Murray-Darling water policy has been a disaster for the region and the nation.

The solution is to accept the reality that the river system, before recent years' reallocation of irrigation water, was in good condition. The more regular flows that the dams have allowed contributed to this as well as creating a thriving agricultural province. The only way of repairing the damage must start with the government selling back to irrigators the stocks of water that it now owns. ***

THE MINISTER FOR WASTING WATER, DAVID LITTLEPROUD, MUST RESIGN By Ron Pike

The Saltbush Club today called for the immediate resignation of Mr. David Littleproud from his position as Minister for Water on the grounds of incompetence in his management of the Murray-Darling Basin Authority. The call was made by Mr Ron Pike, the Saltbush Club Water Adviser with a lifetime of experience and information on Murray Darling Basin water supply, storage and use. "Under Mr. Littleproud's stewardship this Authority has grown to be a law unto itself and is repeatedly lying to both the people and the Government. As an example; 'we had to drain Menindee Lakes, or the water would have been lost to evaporation.' "We now have the wicked and unjust situation where this out of control Authority is denying available water to desperate end users by claiming that they are compelled by law to release this fresh water to the sea, while farmers and Municipalities are left without water.

"In a worsening drought no one in their right mind would condone wasting fresh water to the sea, while denying the people the water they desperately need. But Mr. Littleproud is. "This is not only unjust it is a crime against the people perpetrated by a Federal Minister. "Given that Mr. Littleproud has several advisors, he should have been aware that the MDBA were fabricating stories, just as they now are about releases from Wyangala Dam. "Not only are the actions of the MDBA leaving the Government with little credibility they are exposing the Government to billions of dollars in compensation for lost businesses, especially the death of permanent plantings; something that has never happened since we built the dams on our western rivers. "David Littleproud is responsible for a Government Authority that is denying the people their most basic of rights; that is access to water. Mr. Littleproud has broken his oath of office "To well and truly serve the people of Australia." "David Littleproud you have broken that vow and the people no longer trust you. You must resign now". ***

The whole river system managed by the MDBA is a very different one today. It can no longer be called a 'natural' system. Man's ingenuity has transformed it to be a magnificent asset whereas previously parts of it in drought times were reduced to a series of connected lagoons. Storage dams, locks and barrages now maintain water at higher levels. In addition, hundreds of kilometres of pipelines and open channels have delivered water for irrigation to productive land.

The barrages near the mouth of the Murray control the flow to the sea and thus by keeping the river level higher than the sea, the seawater cannot penetrate the lower lakes which results in a vast quantity of useful freshwater being available. I must stress that no extra water flow is needed for this advantage - the barrages are simply like the locks further upstream where water is held to a higher than normal level.

For a number of years the river flow has been so little that virtually zero amount of water passes the barrages to the sea. This would have caused closure of the mouth unless sand pumps were employed to discharge sand to the ocean. The cost of \$6m per annum is shared by member States of the MDBA. Both Mr Alan Moran and Mr Ron Pike do not appear to have an accurate view of the above matter.-ND

'After nearly two decades of having been declared "polio free" by the World Health Organization (WHO), the Philippines is now experiencing its first polio outbreak in 19 years – and authorities are actually admitting that the cause was the polio vaccine itself! Health Secretary Francisco Duque III announced at a recent press conference that at least one person, a three-year-old girl in the southern Lanao del Sur province, has contracted the virus, which has also been detected in waterways throughout the southern Davao region, as well as in sewage in Manila. These three vector points are enough to declare an official polio outbreak, officials say, which is creating something of a panic as polio was previously thought to have been completely eradicated.

"As long as one single child remains infected, children across the country and even beyond are at risk of contracting polio," added UNICEF Philippines representative Oyun Dendevnorov in a statement. In a joint statement, both the WHO and UNICEF admitted that the type of poliovirus that's currently spreading is vaccine-derived poliovirus type 2, which once again means that vaccines are the source and cause of this first-in-nearly-20-years polio outbreak.

"The weakened virus used in vaccines replicates for a short time in children's intestines and is excreted in their feces," writes Carley Petesch for the *Associated Press* (AP). "In rare instances ... the weakened virus can strengthen in areas with poor sanitation and hygiene.'

In any such method, where genes are edited, deleted, or added to living organisms, there are always "unintended consequences." These vaccines will permanently alter your DNA. Once injected, there's no going back either. The reference is the New York *Times*, 3/15/15, "Protection Without a Vaccine." It describes the frontier of research—the use of synthetic genes to "protect against disease," while changing the genetic makeup of humans. This is no longer science fiction: By delivering synthetic genes into the muscles of the [experimental] monkeys, the scientists are essentially re-engineering the animals to resist disease. "The sky's the limit," said Michael Farzan, an immunologist at Scripps and lead author of the new study. The first human trial based on this strategy— called immunoprophylaxis by gene transfer, or I.G.T.---is underway, and several new ones are planned. [That was three years ago.] I.G.T. is altogether different from traditional vaccination. It is instead a form of gene therapy. Scientists isolate the genes that produce powerful antibodies against certain diseases and then synthesize artificial versions. The genes are placed into viruses and injected into human tissue, usually muscle.
