THE REPUBLIC AND THE END OF THE STATES By James Reed

It is interesting how the Australian Republicans are mostly globalists, support the Asianisation of Australia, are crazy about multiculturalism, yet argue that with respect to the republic, well “we” need our own Australian head of state. It is simply inconsistent, since their general globalism, undermines their selective nationalism on this issue. So, there must be a hidden agenda.

‘Leftists and radicals hate, or at least oppose, federalism because, like monarchy, it is a block stopping their plans to impose all power and a uniform culture. The same people who wish to abolish the checks and balances of the monarchical system, wish to abolish the checks and balances of federalism—the Senate, which Paul Keating notoriously called “unrepresentative swill”—the states and the High Court in its role as interpreter of the Constitution. They see Australia as a giant “social laboratory”—a place for social engineering on a grand scale. We had something of a foretaste of this with Gough Whitlam, who tried to bypass the states with the Australian Assistance Plan, and to replace the states with “regions” which would be nothing more than the agents of Canberra.’

The problem for Republicans is that the possibility exists that there could be a Commonwealth abolition of the constitutional monarchy, with the states still having the constitutional monarchy survive. Colebatch quotes from the ALP’s F. E. Chamberlain (<http://adb.anu.edu.au/biography/chamberlain-francis-edward-joe-12304>):

“But caution needs to be exercised in considering a republic because the Australian federal system involves sovereign states with ties to the British Monarchy. Thus we could finish up with the confusion of a “Commonwealth” republic made up of states still retaining a Constitutional monarchy under the British Crown. No better argument exists for their abolition. Thus my centralist and republican sentiments form a dichotomy in which both branches complement each other ...’

Colebatch goes on to point out that leading republicans have expressed admiration for dictators perhaps because, “something in their psychology makes them yearn to control other people’s lives.” It is true; the globalists are obsessed with planning and central control, whither they are from the Left or the Right. Eliminating the states is a key part of the ALP’s policy agenda. But, be sure the degenerate Libs would go along for the ride. Overall, an excellent paper warning us of the dangers of the republic, something which the ALP will be championing, sooner than we might think.

‘More than 10,000 asylum-seekers, who arrived in Australia under the open-border policies of the Rudd and Gillard governments and are still being processed almost a decade later, would be given permanent protection and a pathway to citizenship under a Shorten government. The pledge to end Labor’s boat arrivals hangover by offering the remaining asylum-seekers permanent residency through the abolition of the government’s temporary protection visa system came as *The Australian* established that the cost of managing the ongoing caseload of applicants had reached more than \$2 billion. Figures obtained by *The Australian* through the Department of Home Affairs

showed that, at the end of last month, 10,600 asylum-seeker cases, of the 30,000 inherited by the Coalition in 2013, remained pending.. Bill Shorten’s office said that under the Opposition Leader’s policy, which is expected to be reconfirmed at next week’s ALP national conference in Adelaide, the “legacy caseload” of asylum-seekers would be granted permanent protection under a Labor government. This would give immediate permanent residency with full work and welfare rights to the remaining asylum-seekers — regarded by the Morrison government as illegal arrivals because they travelled by boat. It would also end the last remnants of Labor’s 2008 policy, which has been widely recognised — even within party circles — as a policy and humanitarian disaster.’

See, Australia is fast catching up with the US and Western Europe in its immigration disasters, but we do have a little way to go. I am sure an APL government will deliver, beyond our wildest nightmares. ***

‘December’s jobs report, widely hailed because of strong employment growth, also revealed a massive immigration influx, far in excess of estimated legal inflow. And native-born American worker displacement remains close to record highs, continuing an Obama-Era trend that the Trump Administration has totally failed to break. The strong economy is muffling the impact. But what when the next cyclical downturn arrives? American worker replacements are entering the country in near-record numbers: the immigrant

population of working age (16 years plus) increased by 1.439 million in December, the fifth consecutive month of 1 million+ growth. There are seasonal trends at work here, of course, so it is particularly alarming that the year-over-year increase this December was larger than in any December since 2008. With legal immigration running at about 1 million per annum, this figure implies a net illegal worker influx potentially in the hundreds of thousands. (In contrast, immigrant working age population actually shrank in the last five months of 2017 when the now-vanished “Trump Effect” seemed to be really taking hold.)’

President Trump, still a big America elite, is doing what John Howard did when he accelerated the immigration replacement program, focus public attention on illegal immigration, while ramping up so-called legal immigration to keep the capitalist superclass happy. When will people wake up to this? Ever? ***

“Scientists have invented a new way of measuring gender equality and claimed it shows men are more disadvantaged than women in most developed countries. Researchers from the University of Missouri and University of Essex in the United Kingdom said previous ways of measuring inequality are ‘biased to highlight women’s issues’. Their Basic Index of Gender Inequality (BIGI) instead measures three factors: educational opportunities, healthy life expectancy and overall life satisfaction. The academics calculated scores for 134 nations and used the results

to suggest men are more disadvantaged than women in 91 nations. They discovered that the most developed nations in the world came ‘closest to achieving gender equality, albeit with a slight advantage for women’. However, in the least developed countries, women fall behind men because they don’t have access to education. Using the index, Bahrain was named as the top nation for gender equality followed by the UK and the Netherlands. The US was ranked in position 34, with men falling behind in education as well as life expectancy and satisfaction. Most European countries with the exception of Italy were deemed to be better for women than men.”

The fine print said that for most developed countries, there was near gender equality, with a “slight advantage for women.” That plays havoc with your paradigm, since you feminists rely upon eternal discrimination to justify the endless demands for affirmative action, special places for women and the like. Probably this will continue long after the last man has died and rotted in the dust. ***

“Two sociology professors from across the country teamed up last year to publish a book on “victimhood culture.” The book, entitled *The Rise of Victimhood Culture*, was published in 2018 by Professor Bradley Campbell of Cal State Los Angeles and Professor Jason Manning of West Virginia University. The book addresses the “victimhood culture” trend that is especially popular on college campuses. Young Americans now proudly exploit their minority statuses for personal gain. Those who support this new cultural development believe that there is something noble about belonging to a minority group. As a result, some young people use their minority status to destroy others for minor and even accidental slights.

The book was highlighted by a recent report by *The College Fix*. The two professors argue that “victimhood culture” is the new source of cultural pride for American youth. In previous eras, pride was derived from one’s financial status, honor, or dignity.”
