THOUGHT OF THE WEEK: “The ways in which people try to explain what is happening in the world around them, whether in politics or economics, can be divided roughly into two classes. Or, as some would put it, there are two theories of contemporary history. The one held by the majority of people hardly deserves to be called a theory, but if that word must be used, then let us call it ‘The Idiot Theory’. Why ‘The Idiot Theory’? Because it insists that no one is to blame for the way history unfolds; things just happen. Likewise, the actions and policies of politicians, when they produce results we don’t like, are simply the product of mistaken ideas, misunderstandings, lack of sufficient information.”

“The late President Roosevelt, possibly in an unguarded moment, made a simple statement of the rival theory when he remarked: “Whatever happens in politics, you may be sure there is someone who wanted it to happen and made it happen”. He would have had much to answer for if that test had been applied to all that happened while he was President of the United States. Douglas Reed was foremost among those who declared, with Roosevelt, that when things happen in the world of politics and economics, especially when they continue to happen with marvellous consistency, then they are being made to happen and are meant to happen.”

THE GRAND DESIGN OF THE 20TH CENTURY By Douglas Reed (1977)

The first puppet-president, Wilson, died, the stomach of America having revolted against his ‘League to Enforce Peace’ (obviously, by war!) and its amended version, the League of Nations, the first trial world-government. The world owed a debt to the America of that period, still with its healthy love of country. Wilson was followed by three Presidents, Harding, Coolidge and Hoover, who were non-Illuminist, as far as one now can tell, and then the *Gadarean* slide was resumed with the choice and election of Mr. Roosevelt, who hastened from the nomination convention to Mr. House in Massachusetts, from whom, evidently, he received the same instructions about his duty to his “sponsors” as “Rockland” (Wilson) received in *Philip Dru*.

Mr. House told his biographer in the 1950’s that he “was still very close to the centre of things, although few people suspect it.” He was (for the second time) “close to the movement that nominated a president” (Roosevelt), and this new president gave him a “free hand in advising the then Secretary of State”. Such was the ominous sponsorship of a most ill-omened presidency.

THE ROOSEVELT ERA

Now followed the disastrous fourteen Roosevelt years. Briefed (as were “Rockland” and Wilson) by Mr. House, what Mr. Roosevelt was told to do became clear as soon as he entered the White House. He recognised the Soviet Union forthwith and resumed the financing of the Soviet, which Wilson began. This continued throughout his fourteen years and parallel with it went infiltration of Soviet agents into the American Administration, at all levels.

Roosevelt, a crippled man, was evidently as putty in the hands of his “sponsors”: when a repentant Communist informed him that a Soviet agent held a high post in the government, he told his informant to “go jump in the lake - but only in much cruder language”. The man he protected was the traitor Hiss, who “managed” the Yalta Conference to abandon half of Europe to the Soviet plague and was a founding father of the United Nations, the second trial world government.

To *The Age* There is a different and truer way to view the national sovereignty of Australia (vested in the Australian Crown) than that of Jacob Saulwick ("A true voice on torn land rights", 15/3). This begins with the affirmation that the 1825 British Crown claim of sovereignty over what is now the Northern Territory proved successful in history and still stands valid for today's Australian Crown, partly on the grounds that the Aboriginal tribes failed to defend their territory successfully and partly owing to the lapse of time, which extinguishes former sovereignties after a reasonable number of years.

The High Court Mabo decision can properly be seen as an unjustified act of legal adventurism, as was pointed out by competent authorities at the time. Subsequent decisions by that court flowing from that decision can be seen, logically, as invalid also. The decisions were manifestly against the interests of Australians as a whole. That has become glaringly clear by the latest High Court decision, whereby huge amounts of taxpayers' money are

to be handed out to persons and groups whose claim to Aboriginality are suspect and whose right to be recipients of such moneys can be shown to not exist.

In this situation the Australian Government should pass appropriate legislation to bring to an end this fraudulent milking of the moneys of the great majority of Australians. This does not look likely to happen, partly because popular opinion has been manipulated by ongoing propaganda published by the mainstream media and not contested by the major political parties, and partly (one surmises) because of secret pressure behind the scenes by a well-financed elite that operates in an international context (also using the UNO for its purposes).

It is only within this overall context that Aboriginal claims of a spiritual kind, concerning attachment to the land, should be assessed. True spirituality, no matter what the land or people concerned, does not demand attachment to earthly goods. Rather it recommends the opposite.

SALVINI SHOWS THE WAY! By Richard Miller

With immigration being the big thing this week, there is more good news to report from Italy, which is moving under Salvini to finally control its borders:

“Italy has seen a radical drop in migrant arrivals in January under the migration policy of populist interior minister Matteo Salvini, down around 95 percent compared to January 2018. The interior minister compared the approach of the previous government under the left-wing Democratic Party of January 2018 with the populist coalition of the Five Star Movement and the League with Salvini saying, “the data shows that the Democratic Party had not blocked arrivals,” *Il Giornale* reports. The official data showed that 3,176 illegal immigrants arrived in Italy in January 2018 under the leadership of the Democratic Party which had told Italians they were actively working to reduce the number of landings and had reduced the number somewhat compared to 2017.”

Socialist Spain has become a magnet for illegals, which shows that socialism in the West is a recipe for social chaos:

“The number of migrant sea arrivals in populist Italy, so far in 2018, is down 80 percent compared to last year, whilst surging by over 350 percent in the same period in socialist Spain. Over 57,500 illegal migrants and asylum seekers have arrived in Europe by sea so far this year, compared to 112,375 over the same period last year, the UN Migration Agency said in a paper Tuesday. And as the number of clandestine crossings fell, deaths in the Mediterranean Sea more than halved, falling from 2,240 to 1,111. The significant fall is likely to be partly thanks to Italy’s new, populist government, which is fighting to end illegal crossings and to protect their borders. There were just 18,392 migrants arriving in Italy so far this

year, 80.6 percent less than the same period last year. However, Spain, which has a new socialist government, has become the new main arrival-by-sea country in the Mediterranean. More than 22,800 migrants have arrived there since the beginning of the year, with 1,866 since the 25th of July alone.”

China does not have an illegal migration problem. We need to be debating why that is so. Here is a sensible article from a Chinese journalist, that if written in Australia would produce howls of protests, even though Mr Chugani is spot on:

“Give me your tired, your poor, your huddled masses yearning to breathe free.” Anyone who’s been to the Statue of Liberty would have seen these famous words. The statue has long stood tall in New York Harbour as an icon of freedom for immigrants. But, as welcoming as the words are, they now belong to a bygone era. Can we, with all honesty, apply those words to the migrants sneaking illegally into the United States from the Mexican border? I think not. Why don’t those sailing to Australia head instead to Japan, the Philippines, Singapore, or China? Why don’t those crossing from Mexico to the US head south instead to Brazil, Argentina or Chile? And why don’t those sailing to western Europe go instead to the Ukraine, Russia or Poland? The short answer is they don’t want to live in those places and they know they will be shown the door anyway. It may be politically insensitive to say this but the migrant crisis has become a white man’s burden. Liberal democracy made it a moral duty for Western nations to do the right thing. Germany alone has taken in more than one million migrants in the past few years. These nations no longer want to shoulder the burden even if those fleeing are tired, poor, or yearning to be free. Their moral duty to be compassionate has long passed its sell-by date.”

To *The Advertiser* Australia has been a nation of migrants since Governor Phillip arrived. My ancestors were among them. Early migrants came predominately from England, Scotland and Ireland and this pattern continued until after WW2 when many new settlers came from Eastern and Western Europe. In all cases, these people shared a common heritage - they were Europeans from countries practising democracy with Christian roots. The minor differences in foods, clothing styles and accents were soon overcome. In our more recent history, both Labor and Coalition Governments have deliberately accepted people with very different values to traditional Australia and they have ignored public opinion in the process. Repeated calls for a poll

on immigration have been declined by all major party politicians. Multiculturalism was the pleasant sounding catch-phrase but reality around the world could not quote one example of its success in the long term. The horror of Christchurch cannot be condoned. Such actions will never fix what is wrong. Our problem is not with the migrants here because they arrived within the rules. The problem is the rules! “Stopping the Boats” was appropriate but the jumbo-jet loads still arrived, largely without notice. Let us rebuild Australia. It is not too late to halt immigration and conduct a stringent programme for recent migrants to adopt the Australian values and traditions which presumably attracted them to come here.

JAPAN AND THE STERILISATION OF TRANSGENDER PEOPLE By Mrs Vera West

“Should transgender people be sterilised before they are recognised? Earlier this year Japan’s Supreme Court decided that the answer is yes. Takakito Usui, a transgender man (i.e., someone who was born female but identifies as male), had sued over a requirement that, to be officially designated a man, he has to have his ovaries and uterus removed (as well as have surgery to make his genitals look male, be over 20, single, have no minor children and have been diagnosed as suffering from “gender-identity

disorder”). He argued that all this violated his right to self-determination and was therefore unconstitutional. The court disagreed. Human-rights groups say demanding irreversible surgery is outrageous. Although several Asian countries, including South Korea, have similar laws, Western countries that once also used to require sterilisation, such as Norway, France and Sweden, no longer do. In 2017 the European Court of Human Rights called for the change in all 47 countries under its jurisdiction. Sweden has started to compensate transgender people who underwent mandatory sterilisation.”

Yes, hopefully the world will rise up in anger against this terrible, terrible thing, that still accepts that sex is biological, and not a totally socially constructed category, like race, matter, the sun, time, energy, entropy, and other social fictions. ***

“A witness to violent brawls between two groups in Melbourne's CBD has described how teenage Pacific Islander girls beat up African boys in chaotic scenes. Events planner Blagoja Stajkojic was on his way home from the Moomba Festival with friends when he came across a tense stand-off between two opposing groups. The Melbourne man claimed 100 African youths had staked their territory on the steps of Flinders Street Station and were playing rap music while a group of Pacific Islanders stood nearby. 'It was all really territorial. The Islanders were on the steps of Federation Square and groups of them just kept getting closer and closer. I could tell something was about to happen,' he told Daily Mail Australia. Mr Stajkojic, who managed to snap a photo of the two 'gangs' squaring up against each other, claimed things kicked off after glass bottles were thrown. He said there was only one winner in the crazed fighting, which rolled on for about three hours as dozens of riot squad officers roamed the city. 'Pound for pound the Pacific Islanders dominated the Africans. They were just bigger guys - three African guys got knocked unconscious,' he said.

He also revealed the Pacific Islander girls were beating up the male African youths as well as their female adversaries, none of whom looked over the age of 18.”
